(57) **CLAIM**

The ornamental design for a front positioned carrier, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a front positioned carrier showing our new design as it appears on a human subject with an object positioned within the carrier;

FIG. 2 is a left perspective view thereof showing the article removed;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is rear view thereof;

FIG. 6 is a bottom plan view thereof;

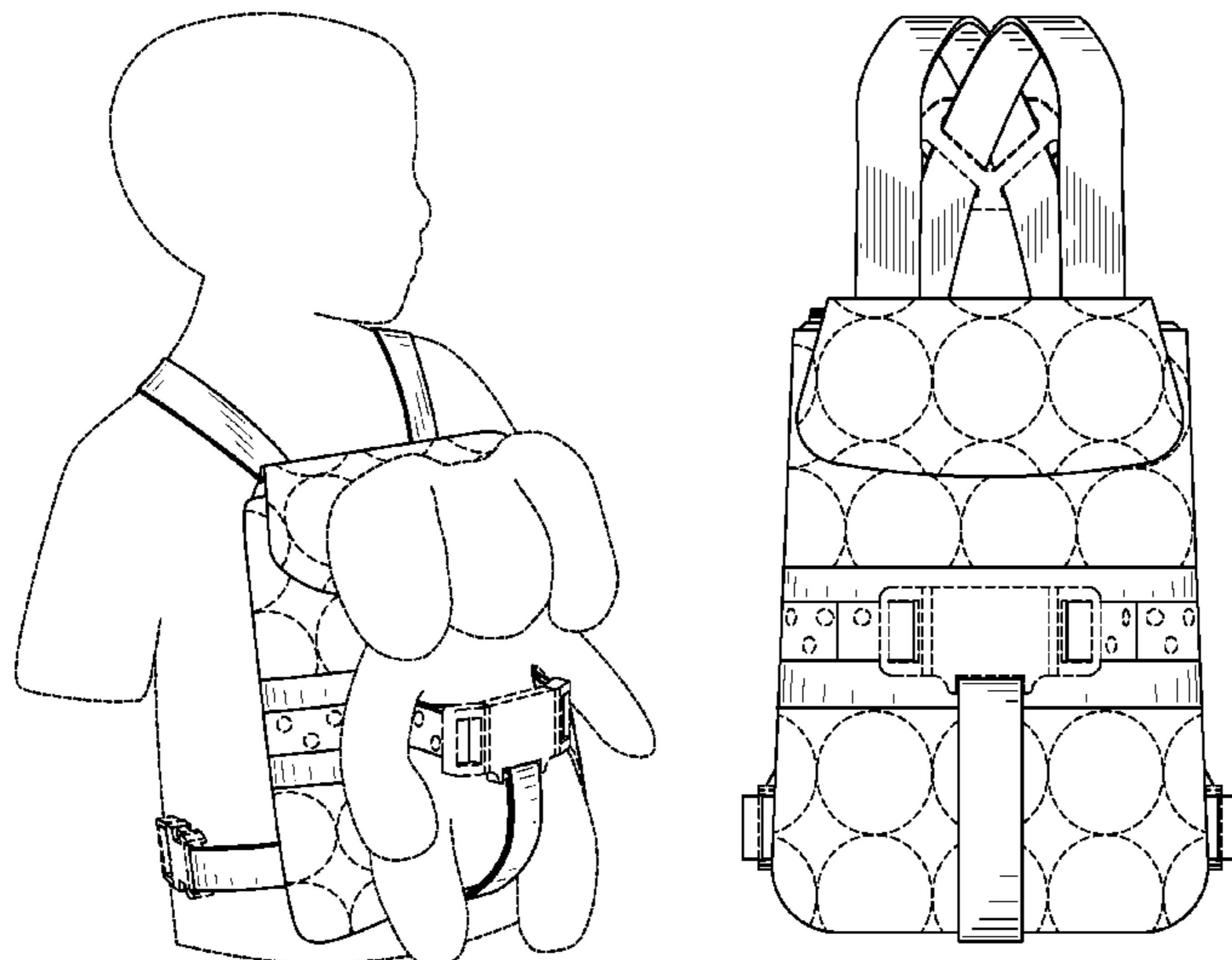
FIG. 7 is a right side view thereof; and,

FIG. 8 is a left side view thereof.

The broken lines showing an animate bearer and stuffed toy in FIGS. 1 & 2 illustrate the use of the claimed article without forming any part of the claim. In addition, the hardware features shown in broken lines throughout the views; along with the small details in FIGS. 7 & 8, represent the portions of the article that form no part of the claim. The dashed lines showing large and small circles on the surface throughout the views represent unclaimed surface patterns.

The doll and the animate bearer, both shown in broken lines, illustrate the use of the article, and form no part of the claimed design.

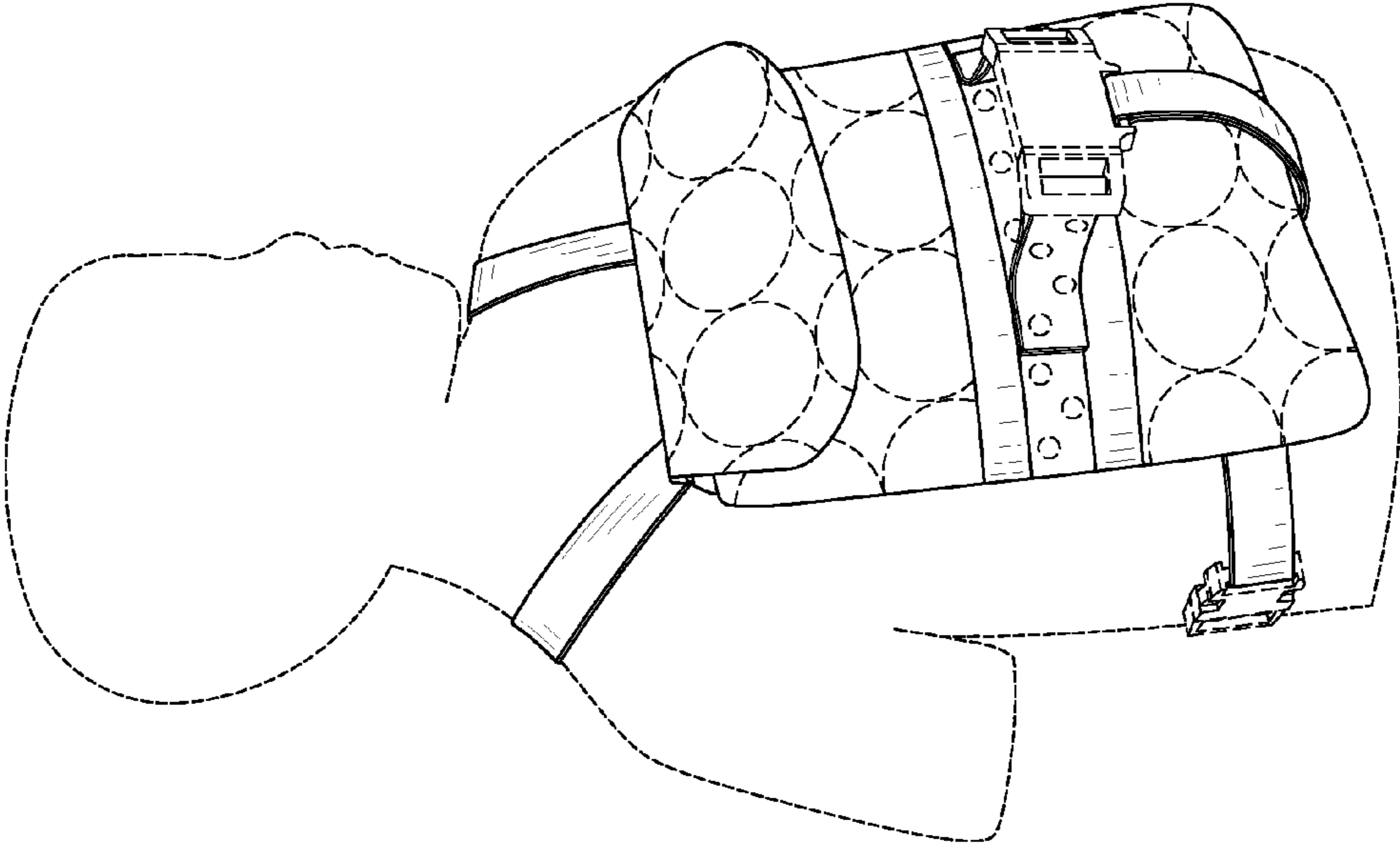

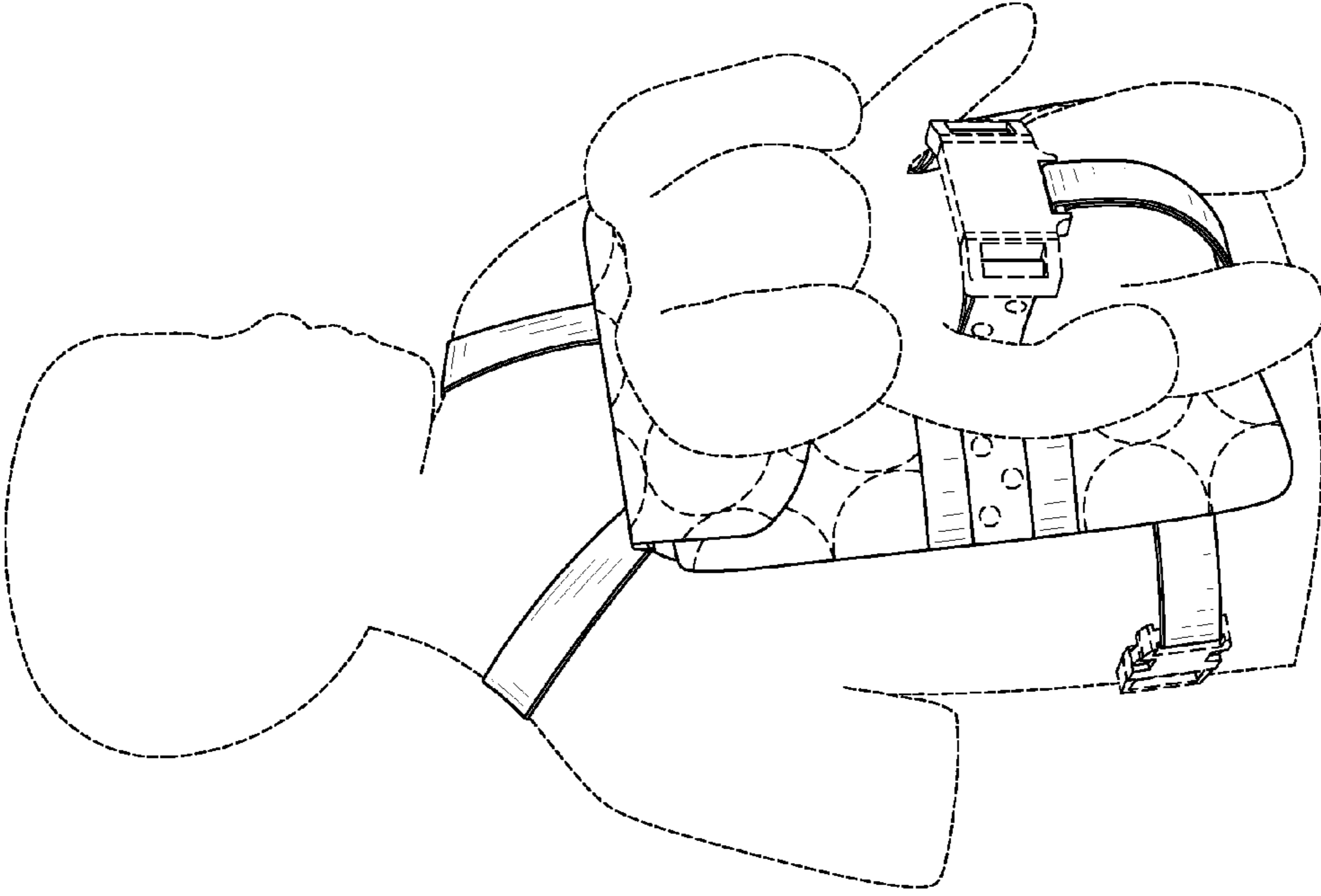

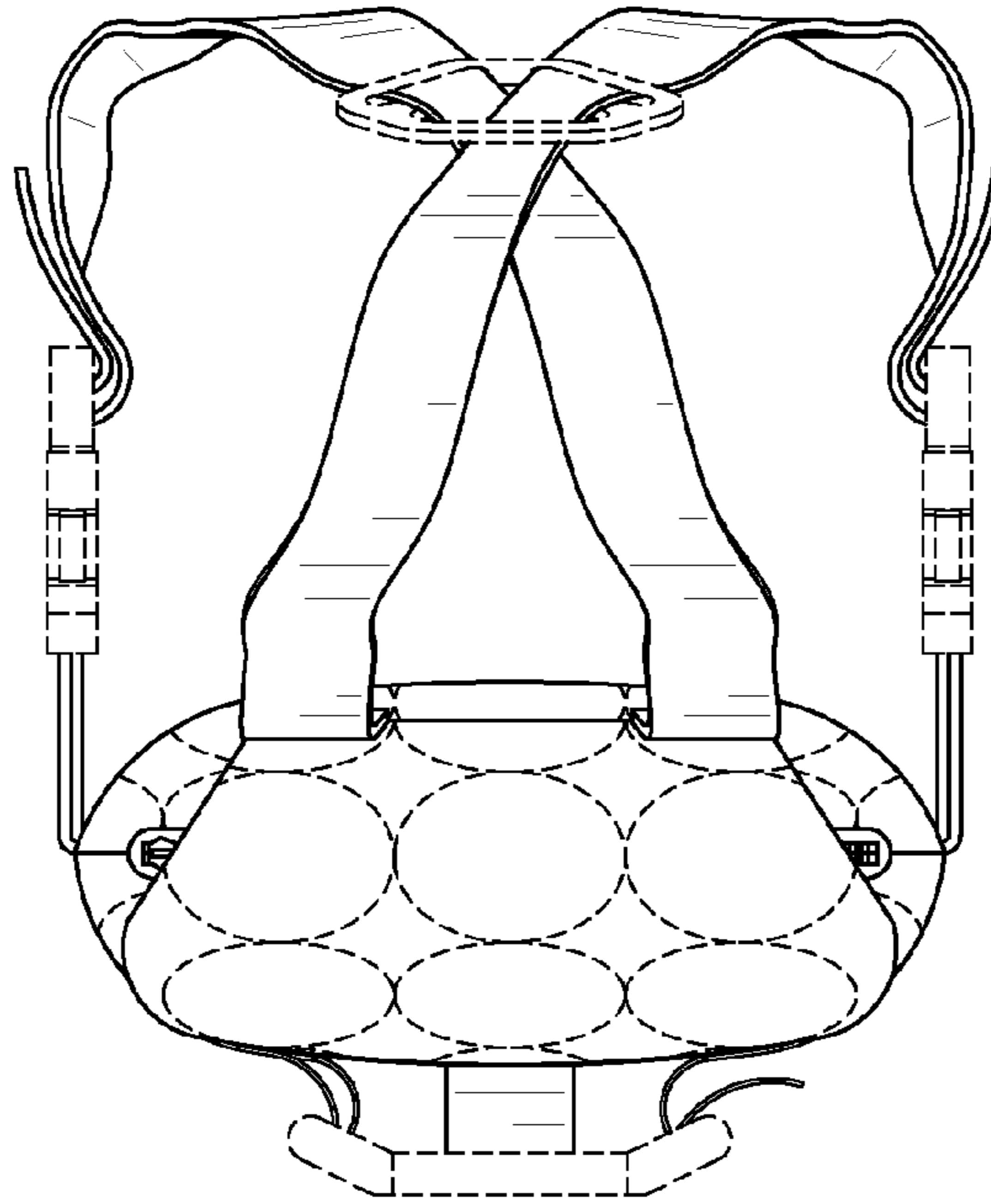

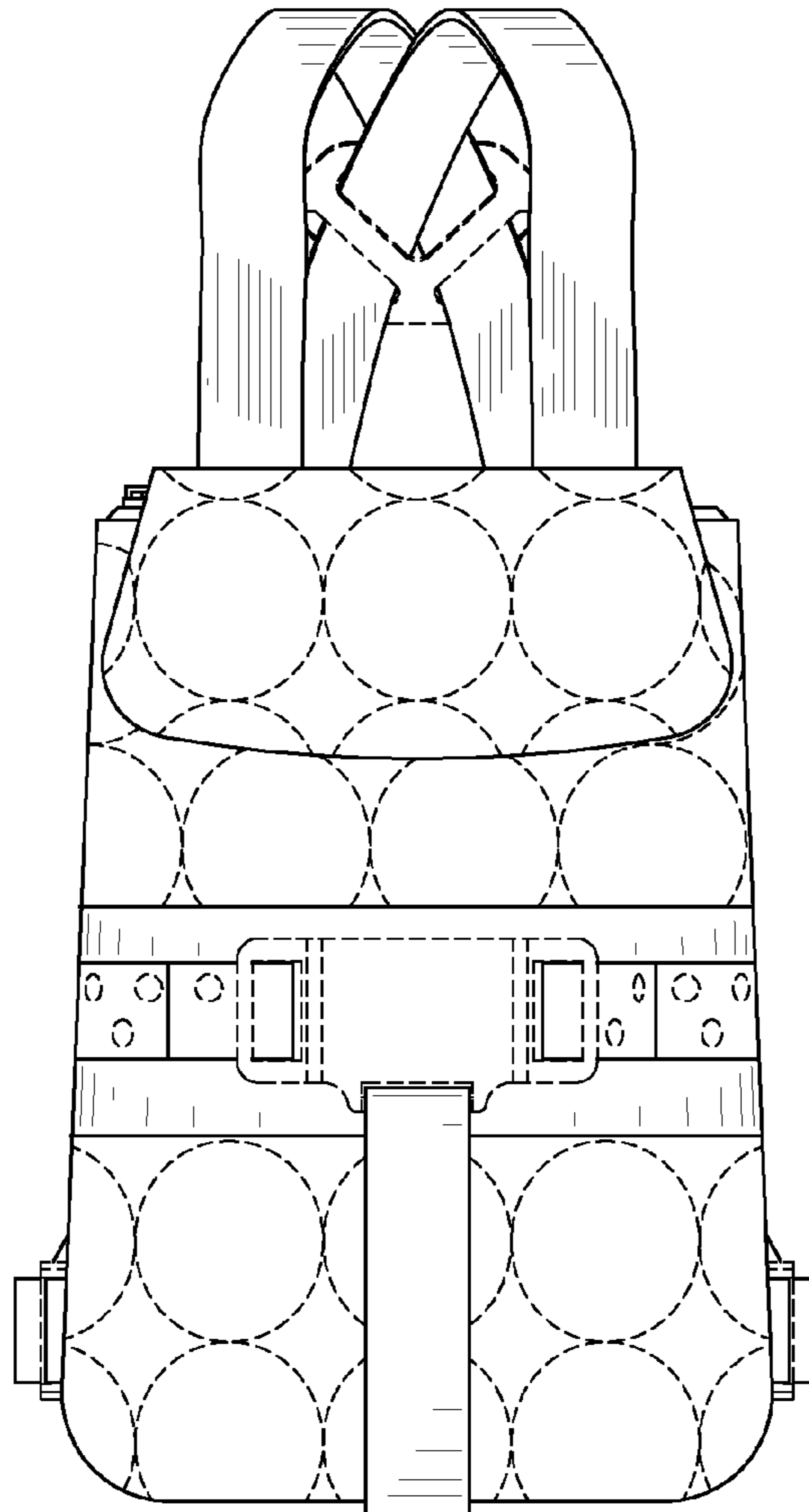

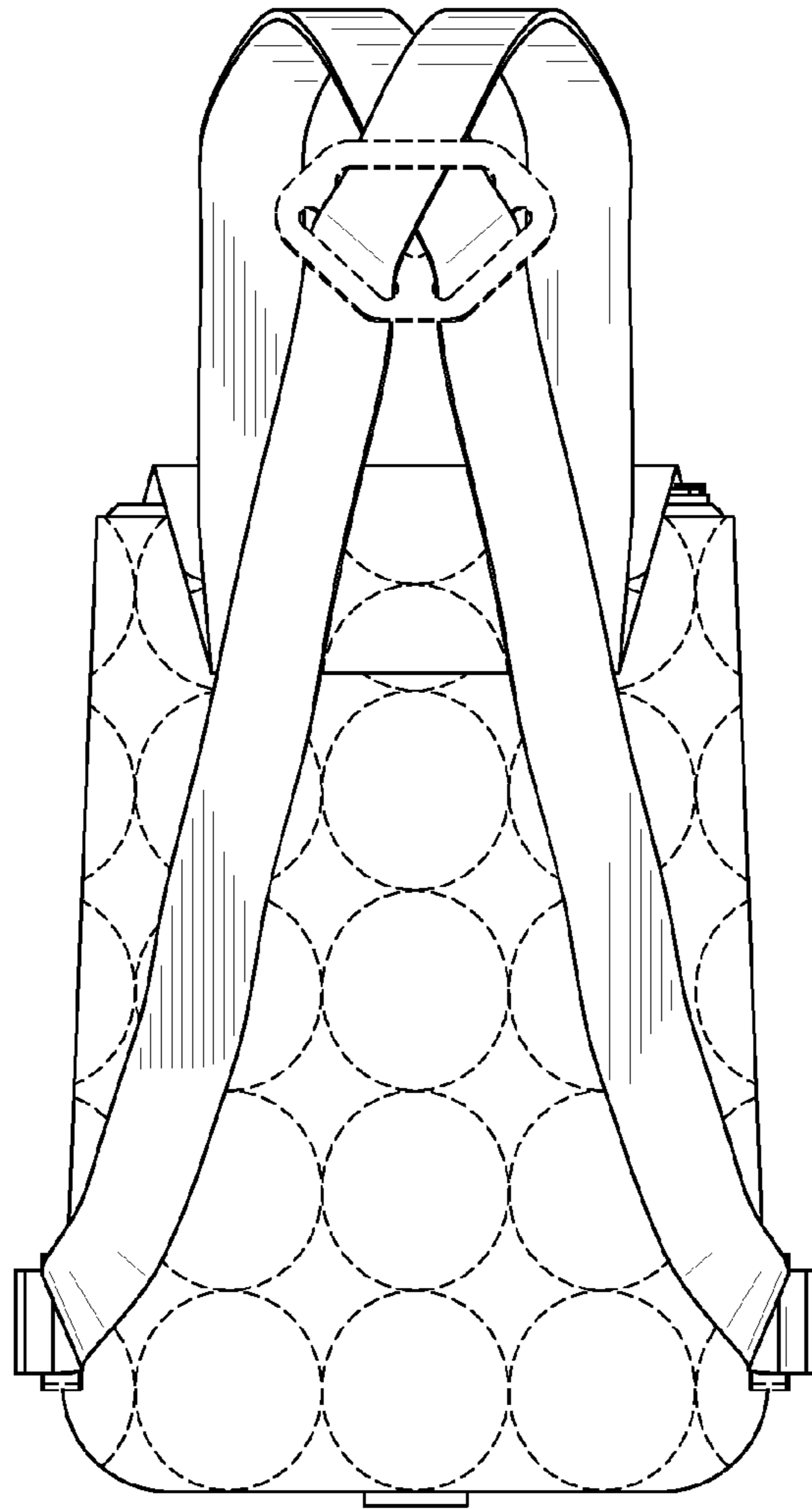

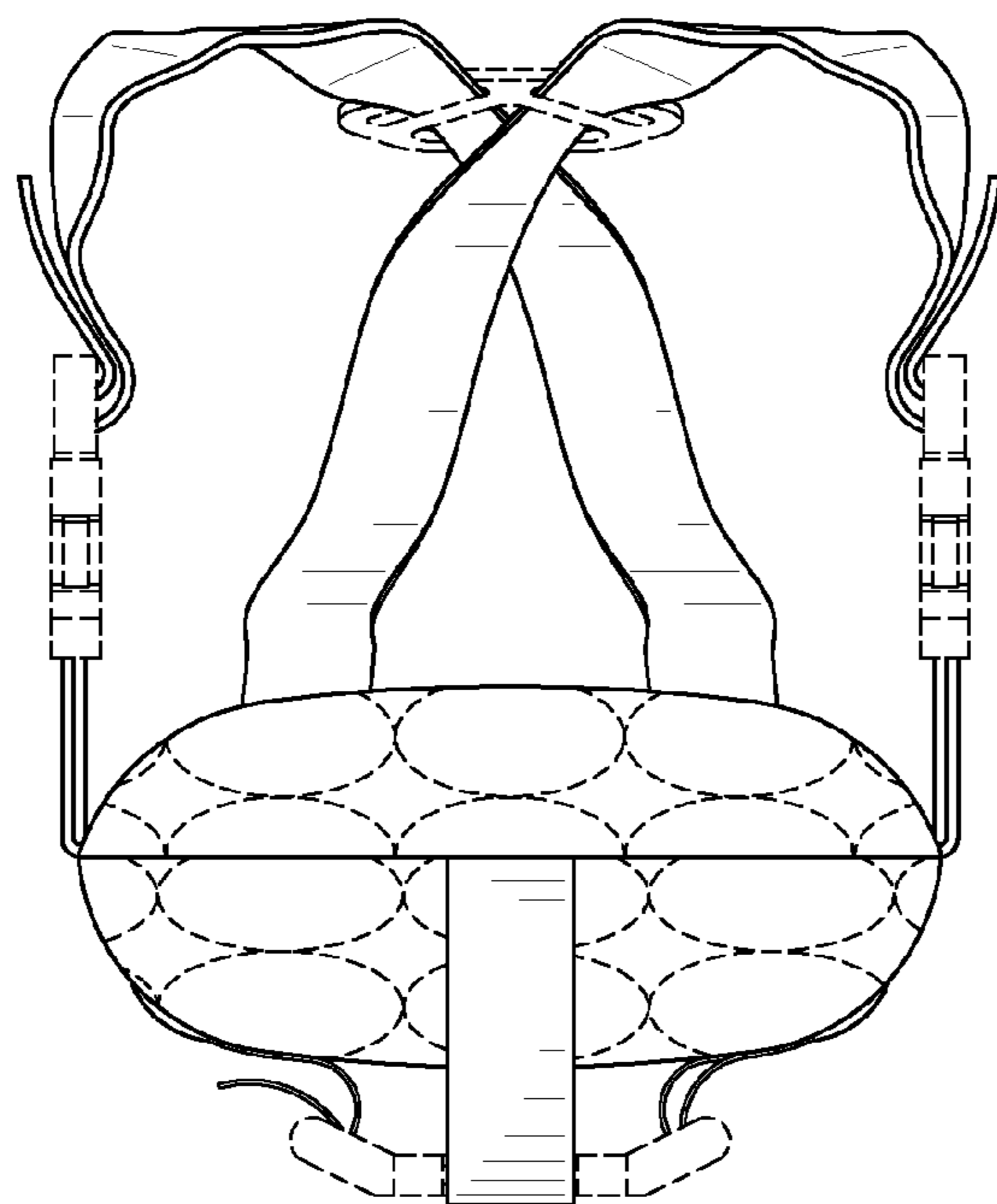

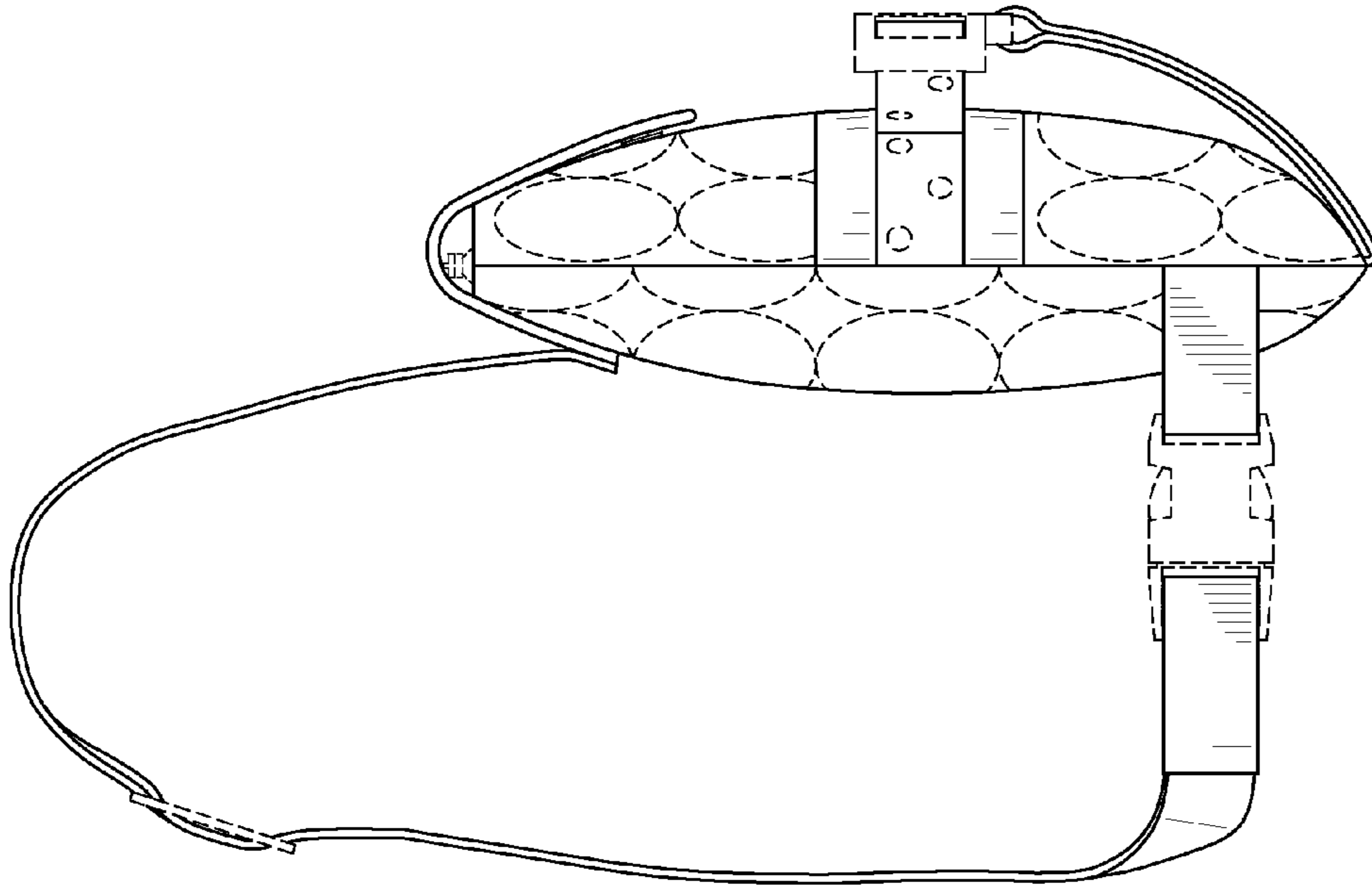

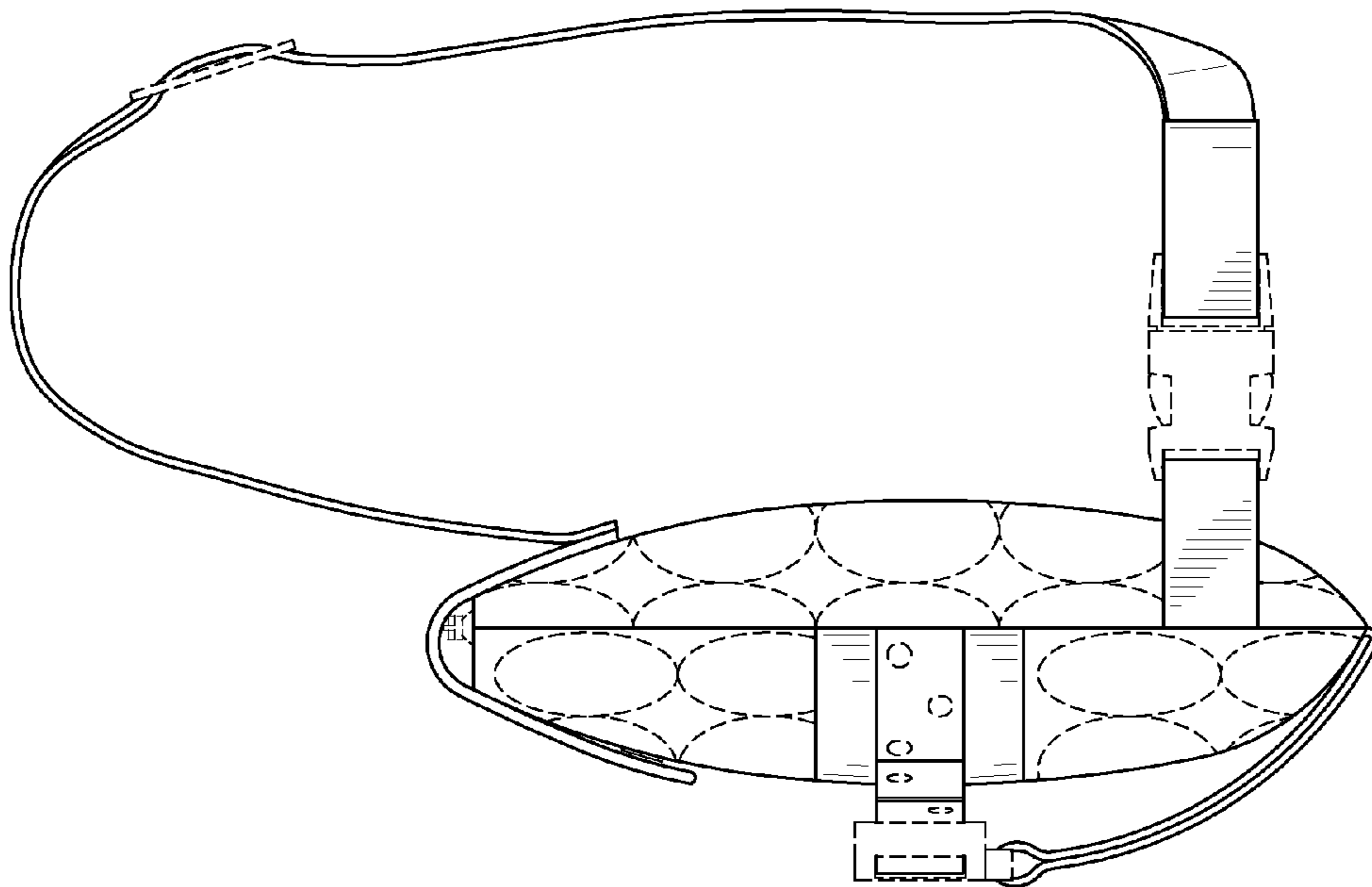
