DESCRIPTION

FIG. 1 is a perspective view of a pitcher illustrating our new design;

FIG. 2 is a side view of the design of FIG. 1;

FIG. 3 is a front view of the design of FIG. 1;

FIG. 4 is a rear view of the design of FIG. 1;

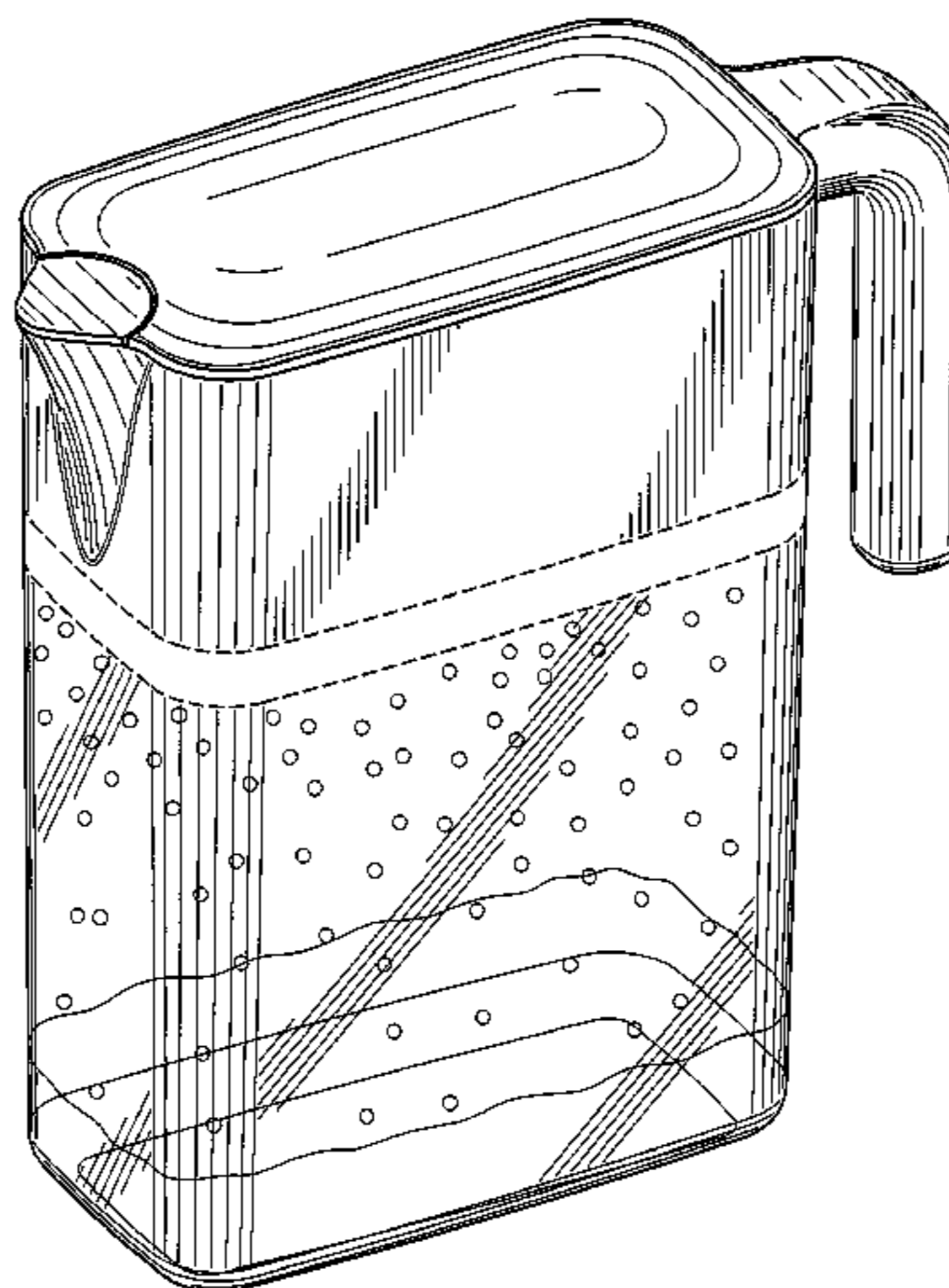
FIG. 5 is a top view of the design of FIG. 1; and,

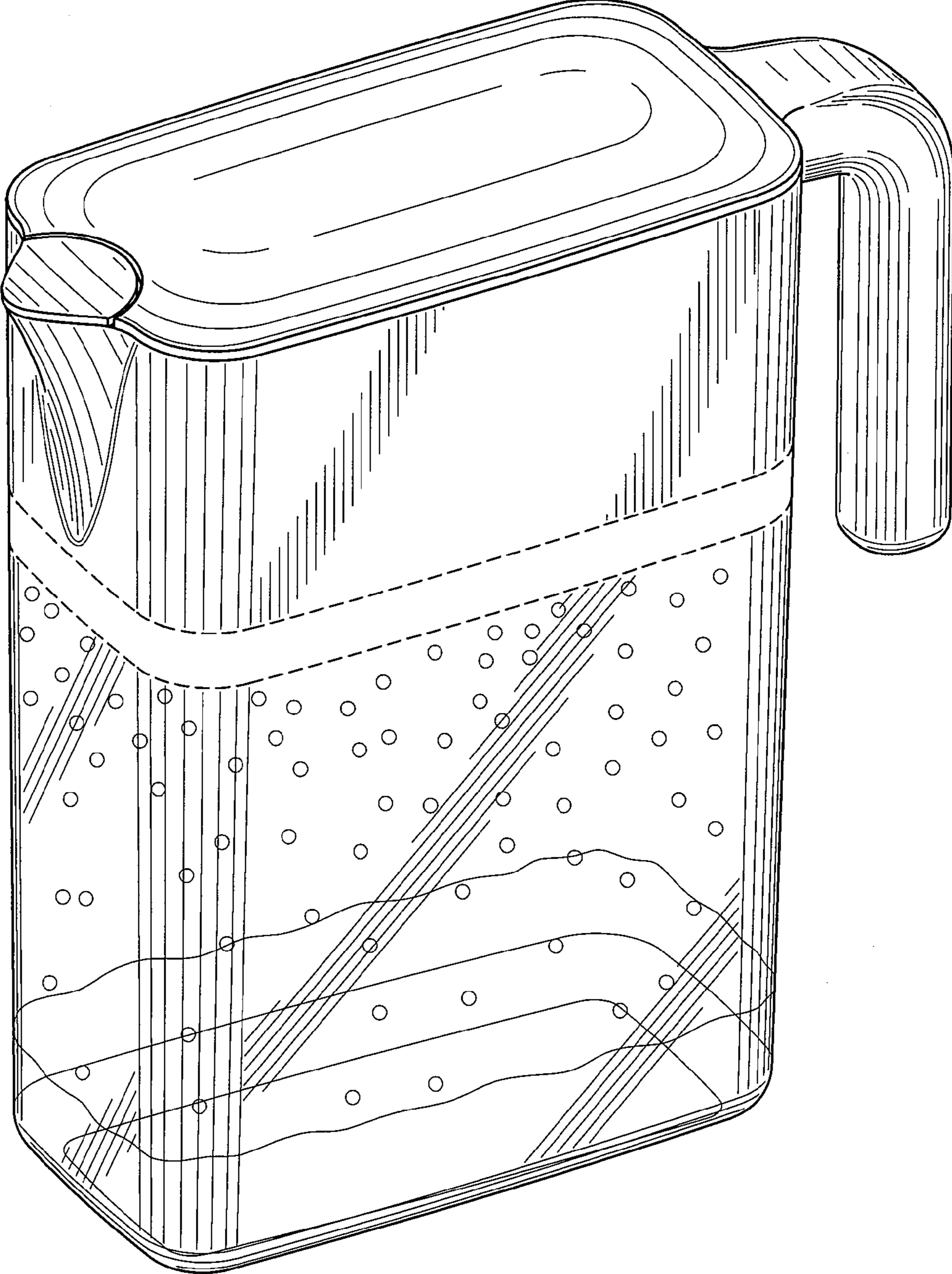

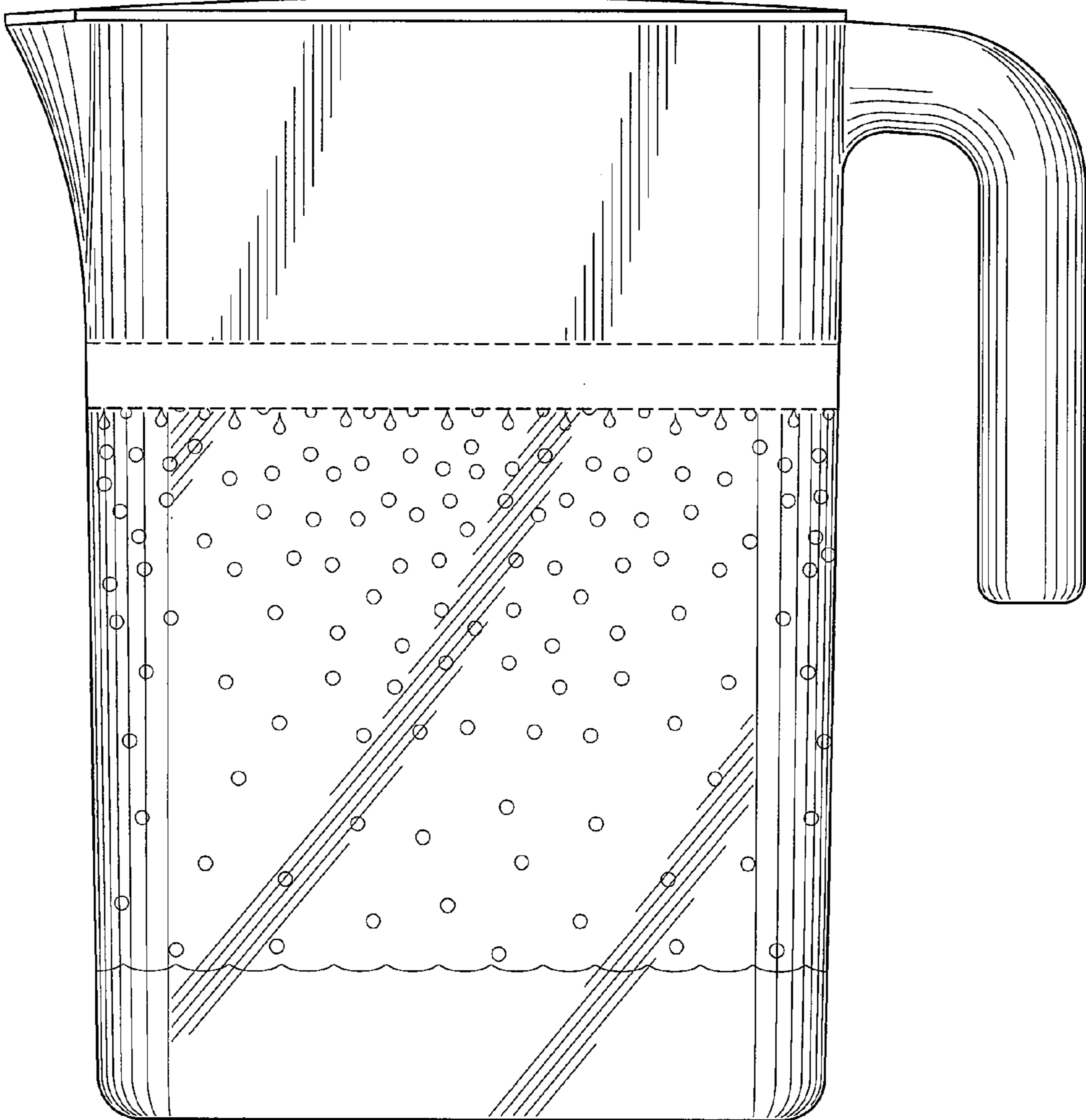

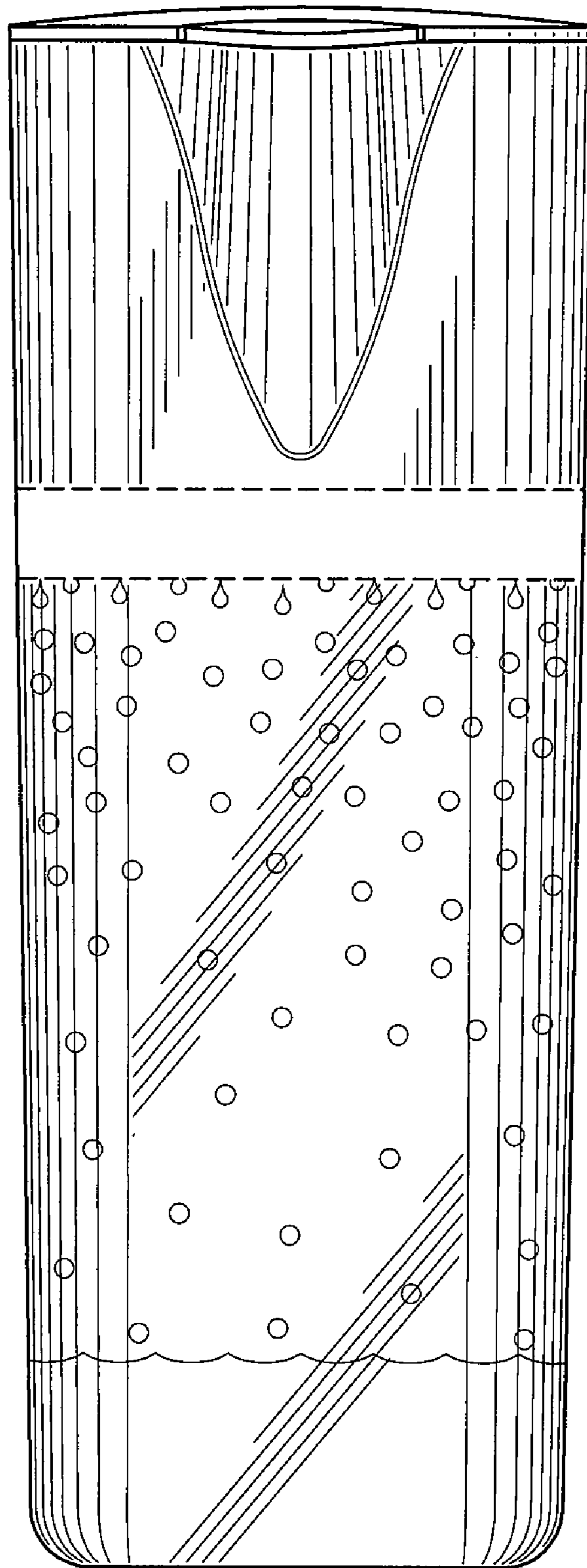

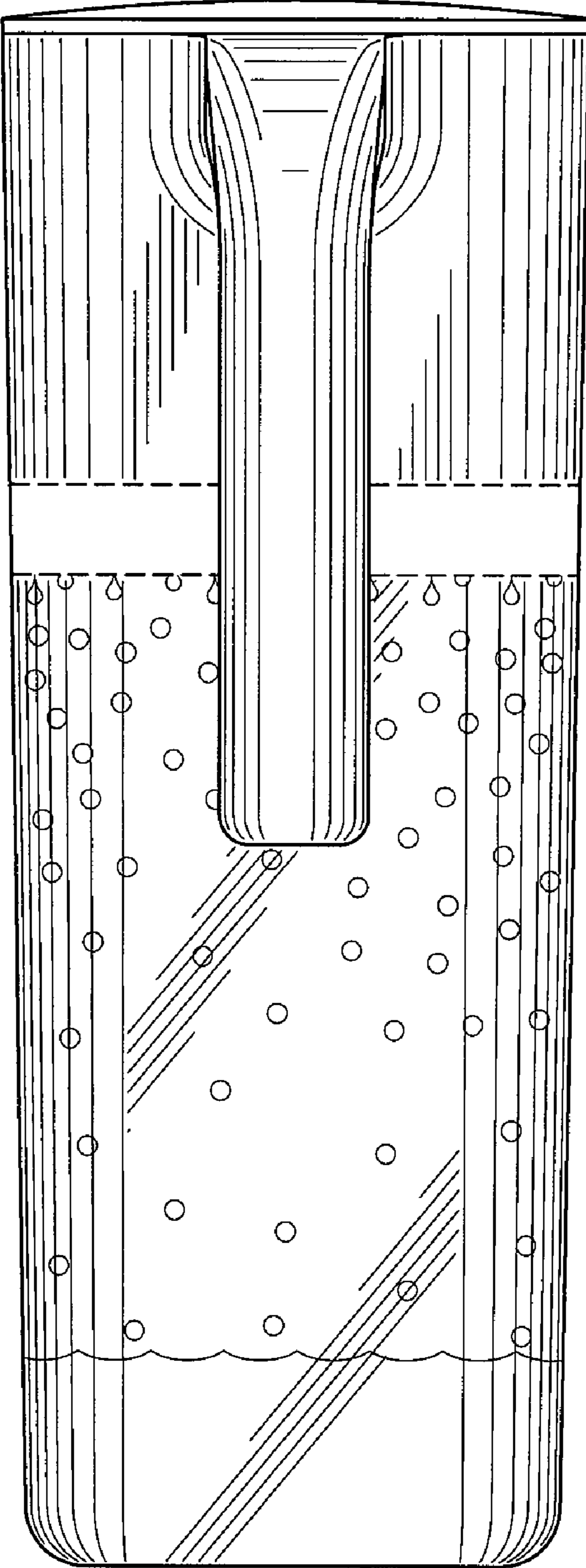

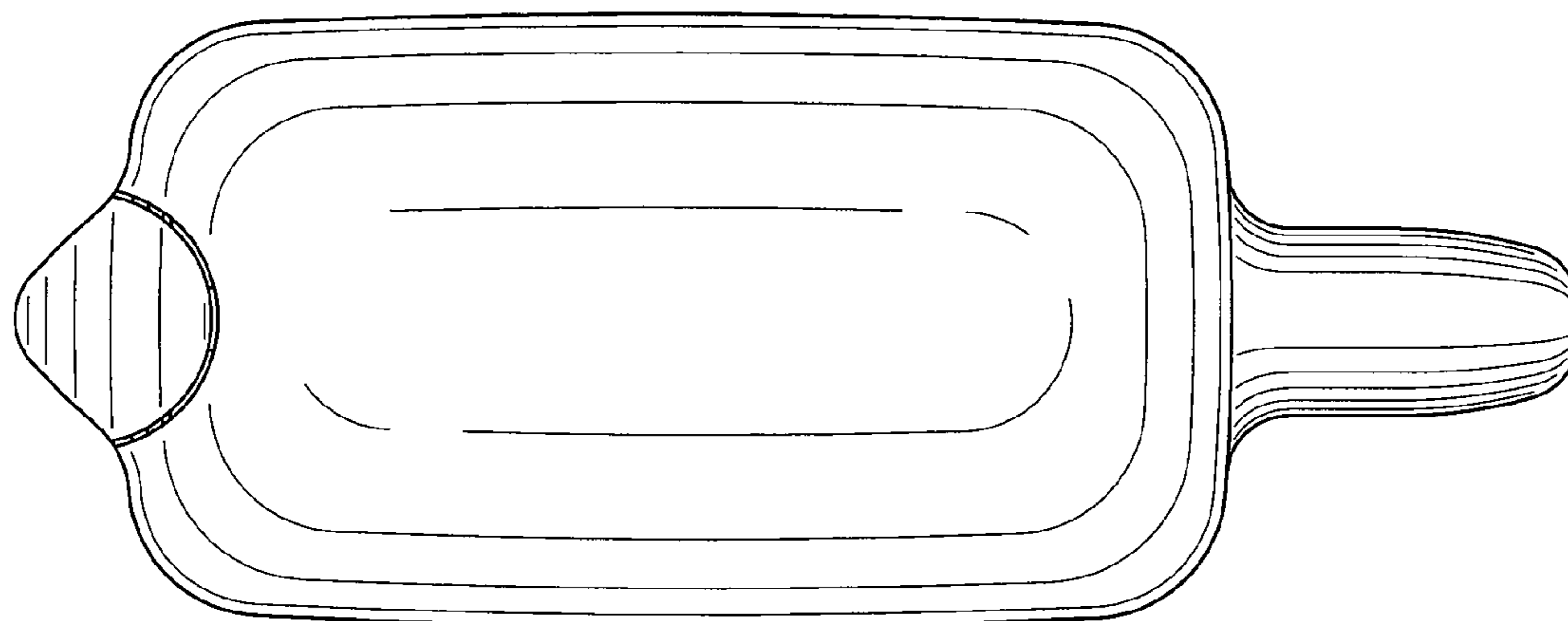

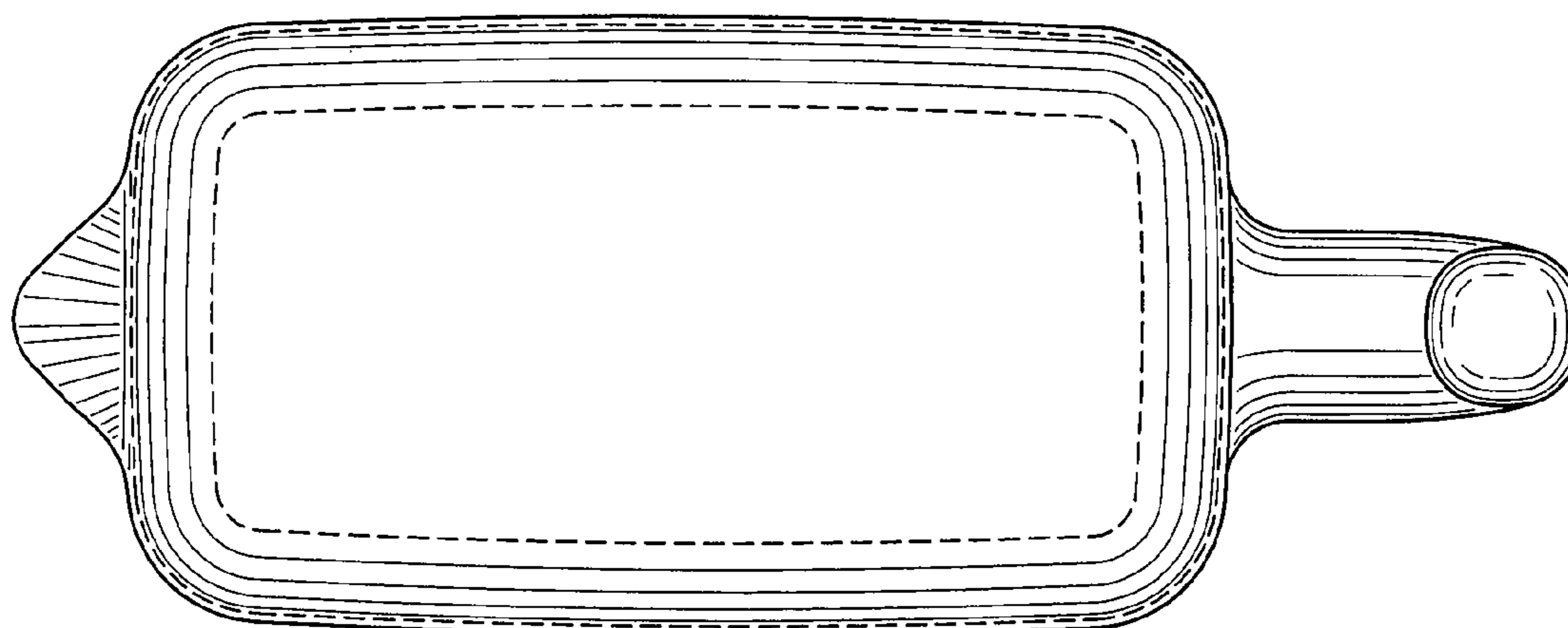
