The ornamental design for a utility hook, substantially as shown and described herein.

**DESCRIPTION**

FIG. 1 is a front perspective view of the utility hook showing our new design;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;

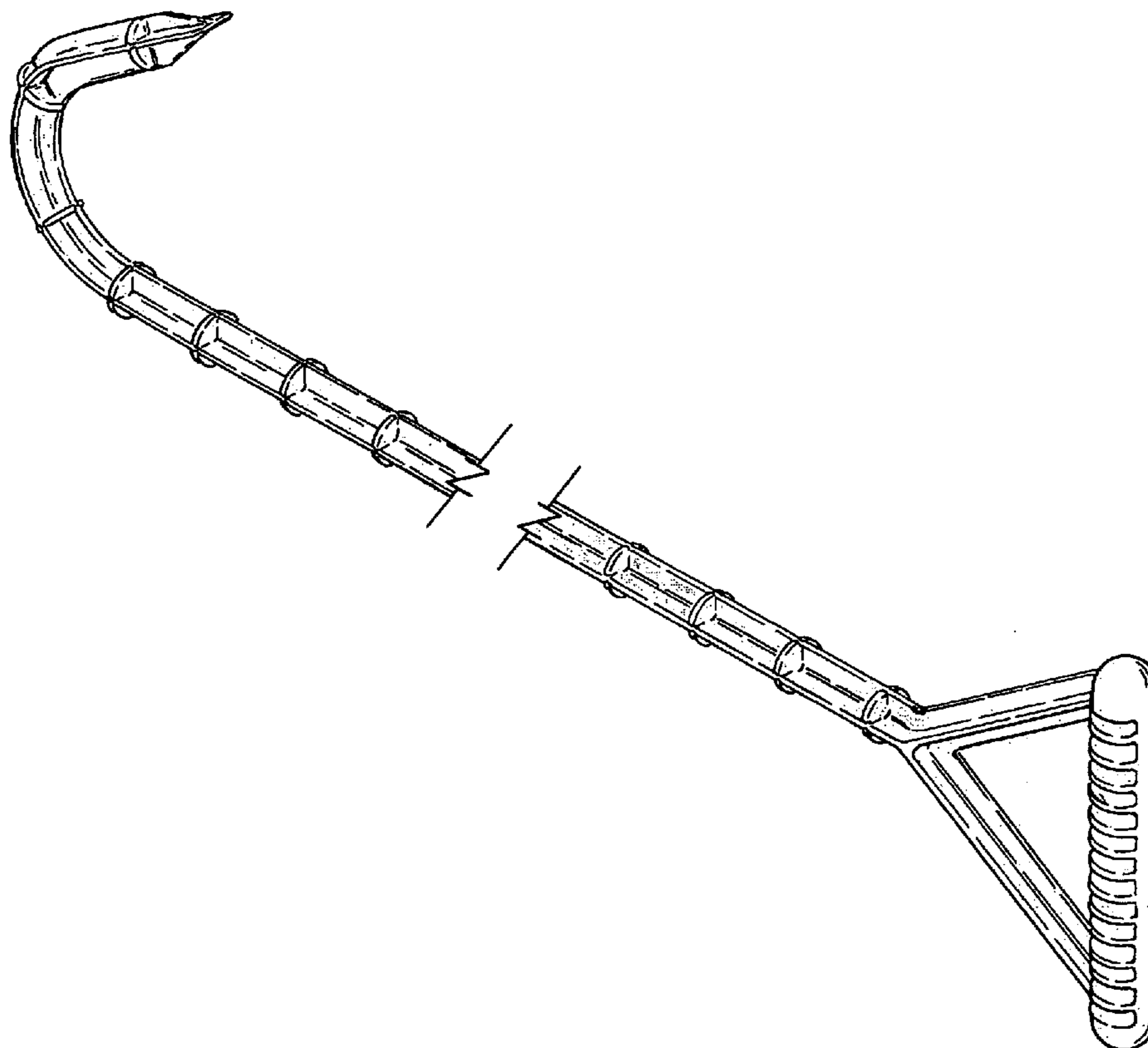
FIG. 5 is a bottom view thereof;

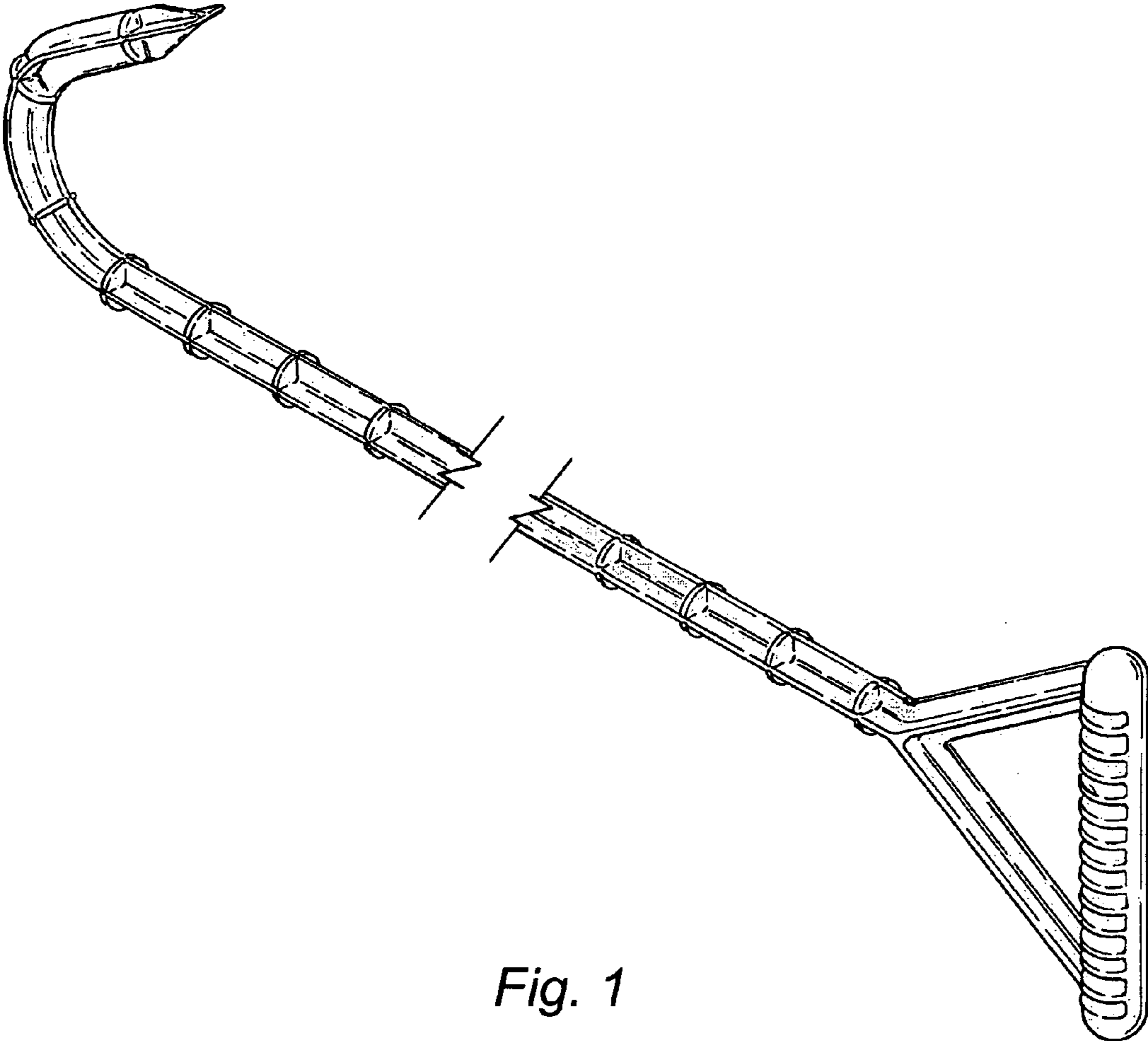
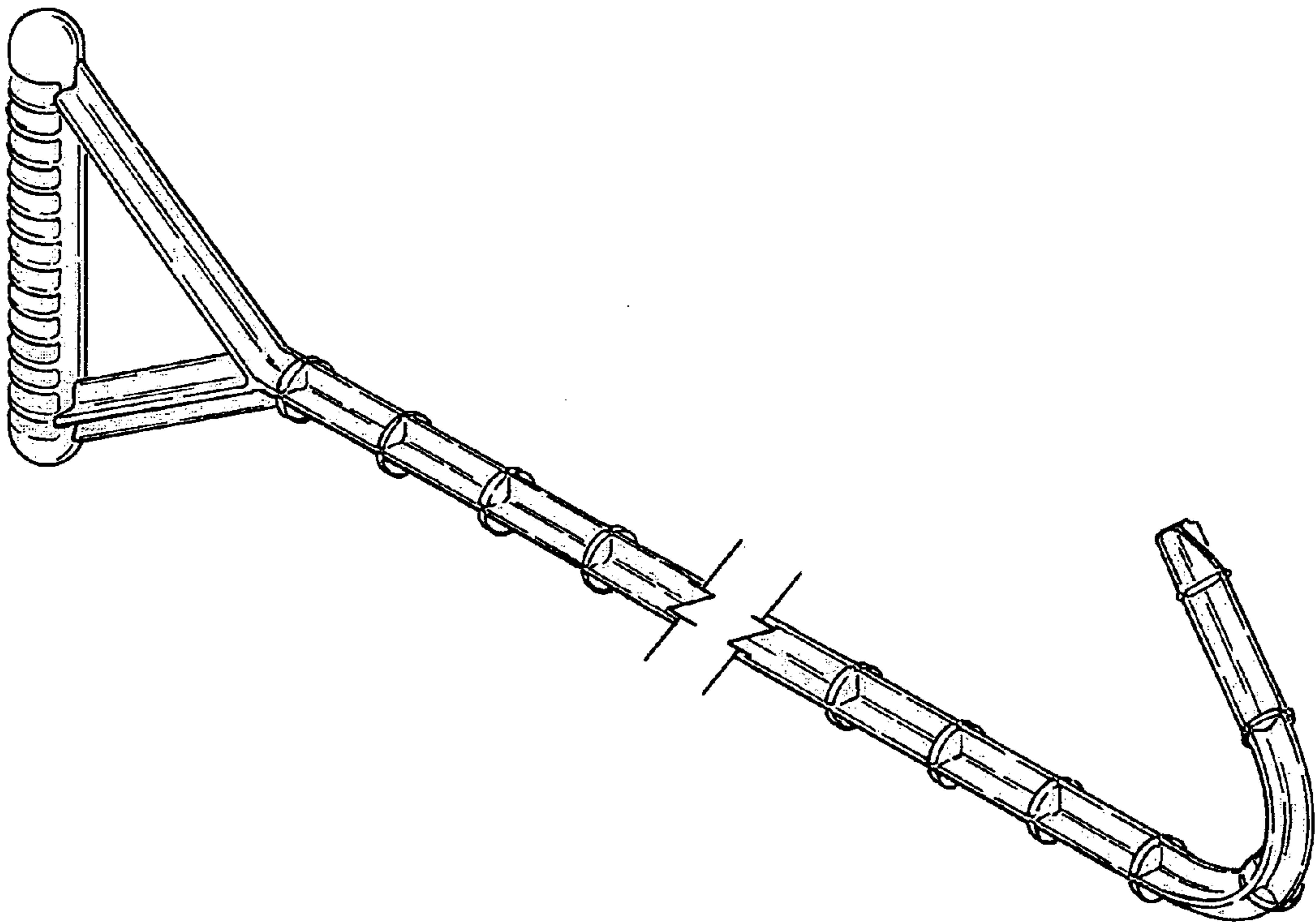
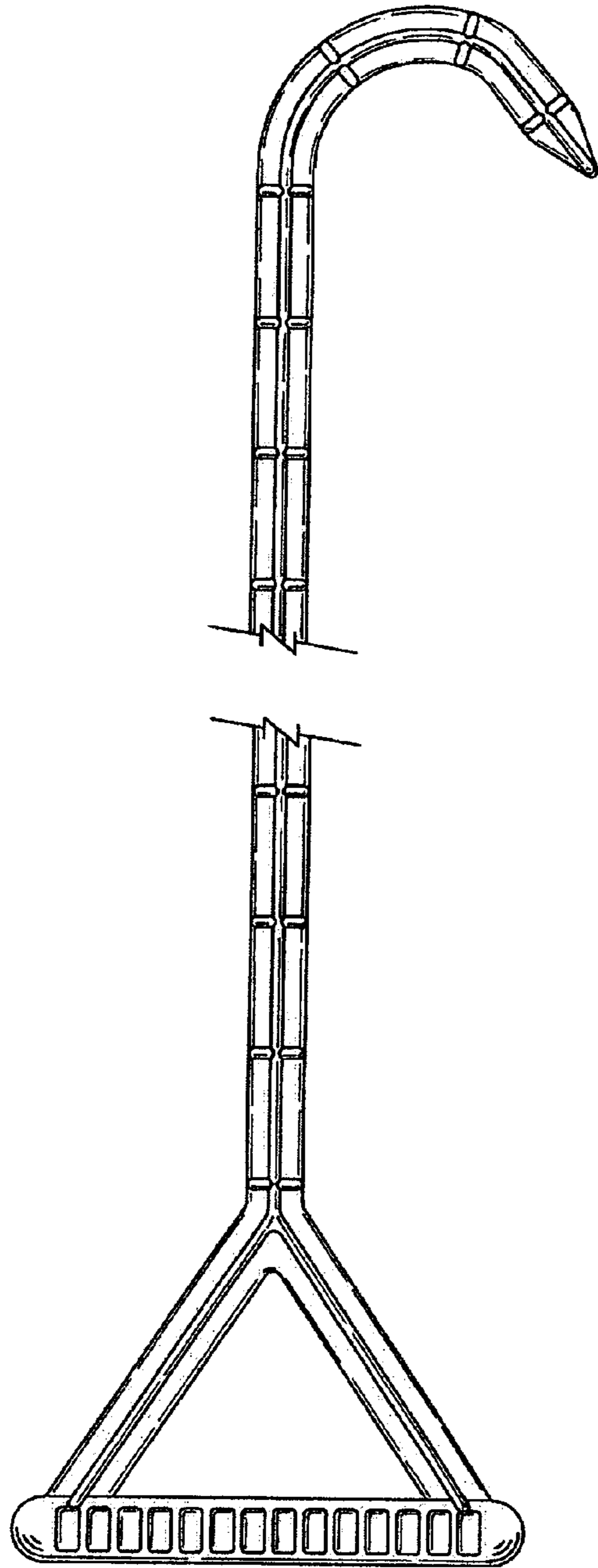


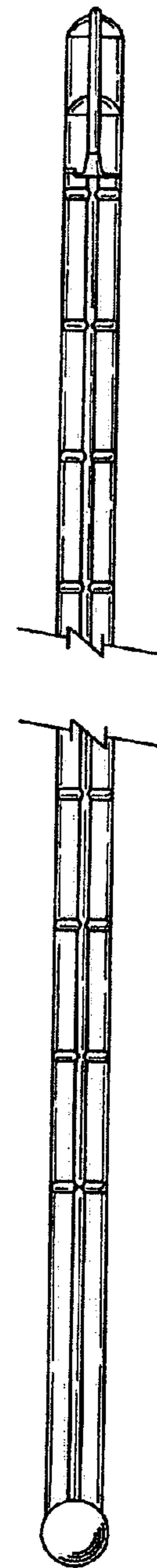

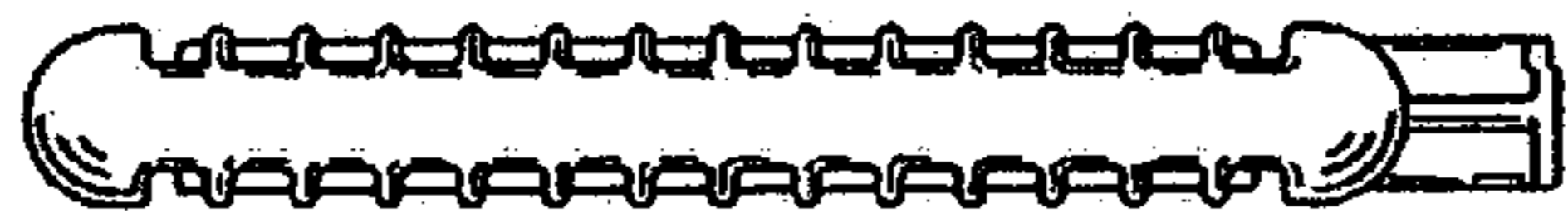

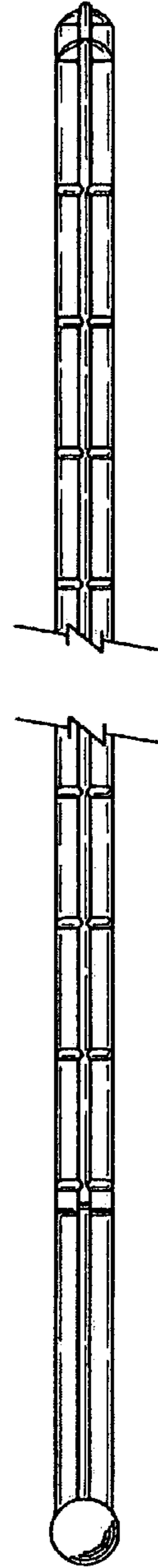
