FIG. 5 is a right side thereof;

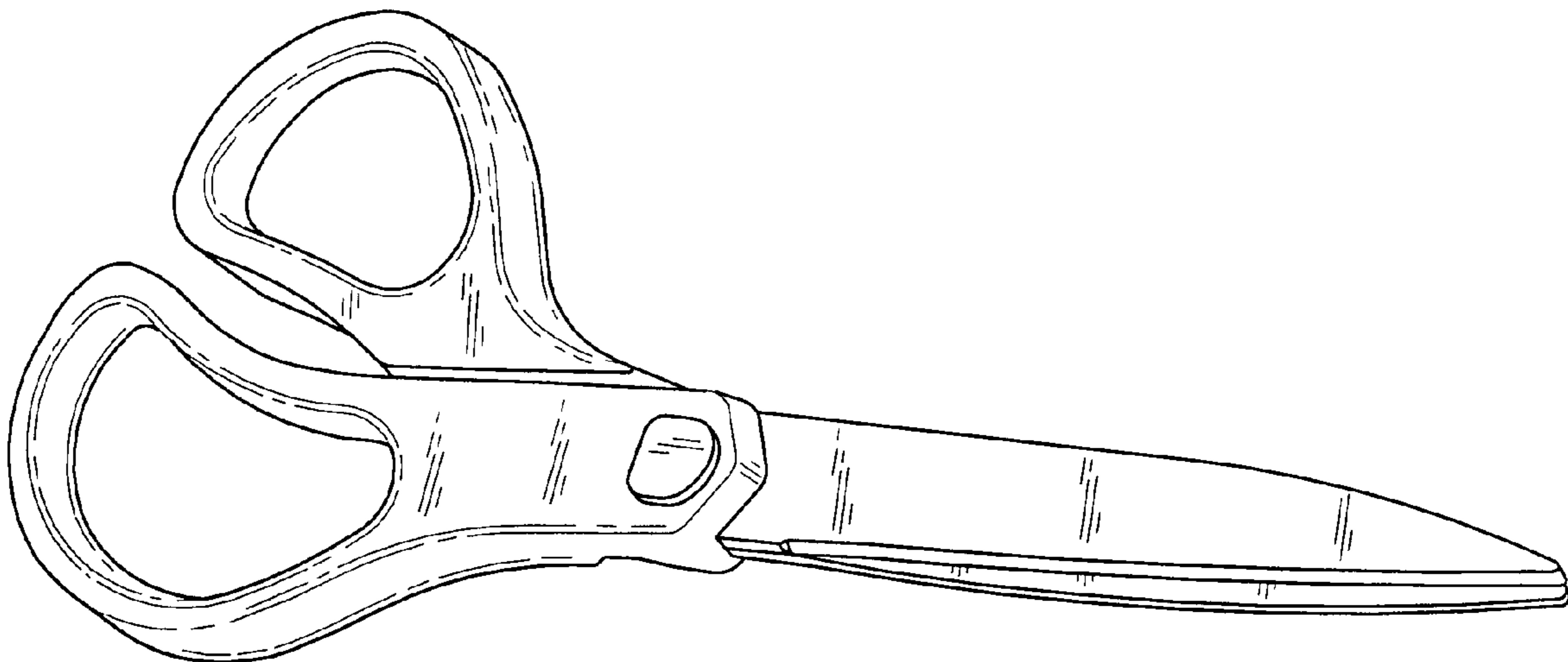
FIG. 6 is a left side thereof;

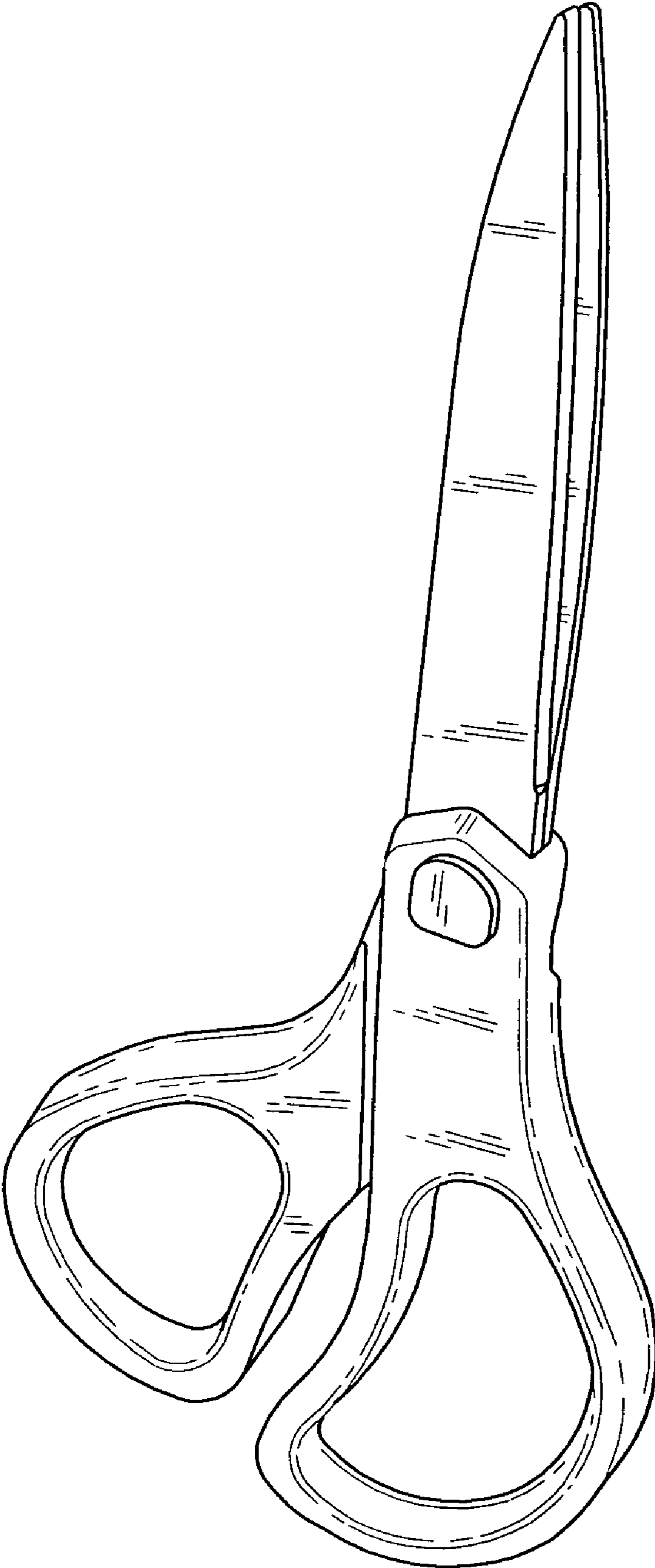

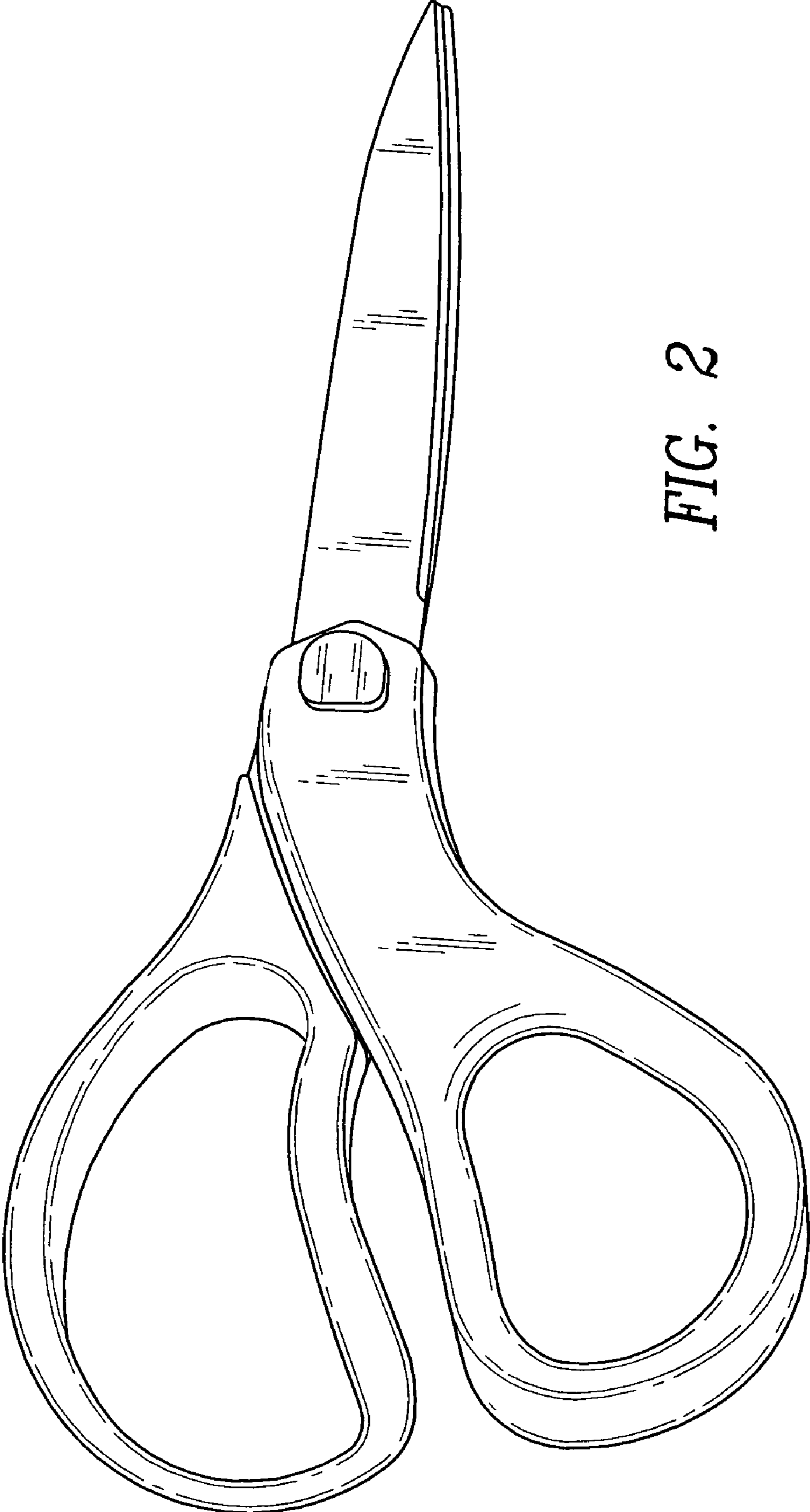

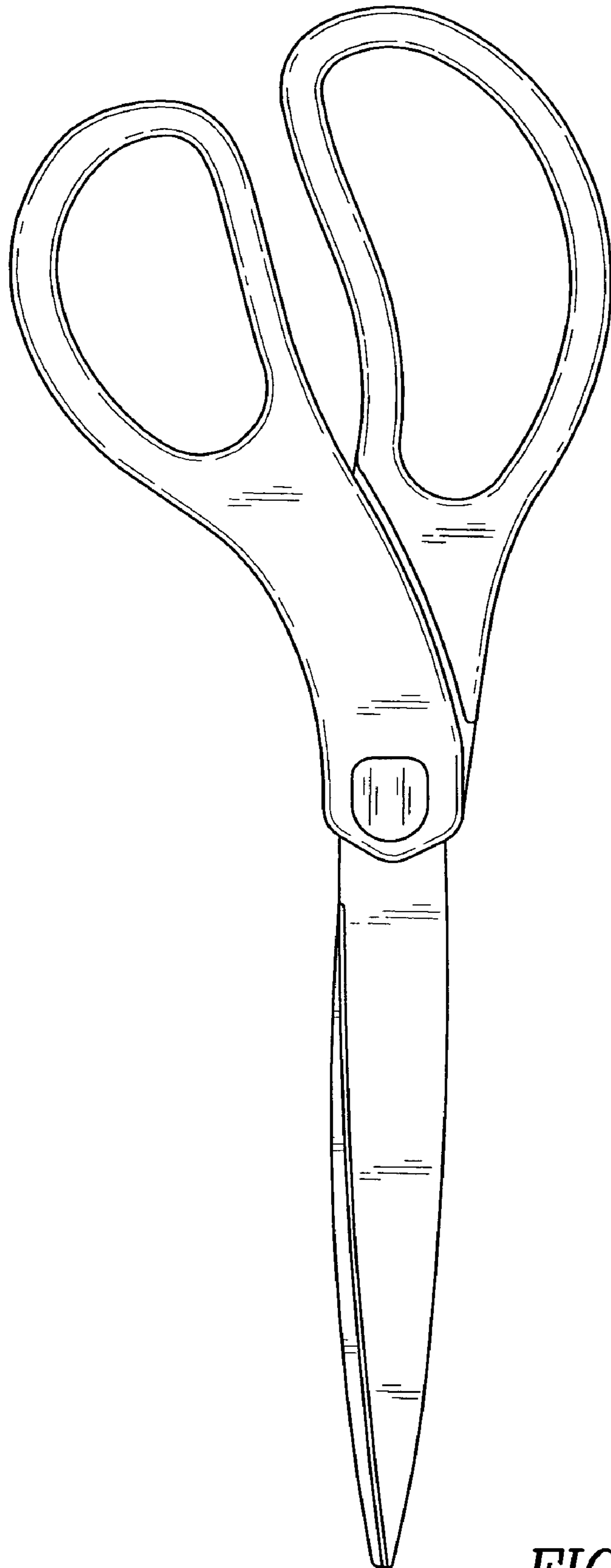

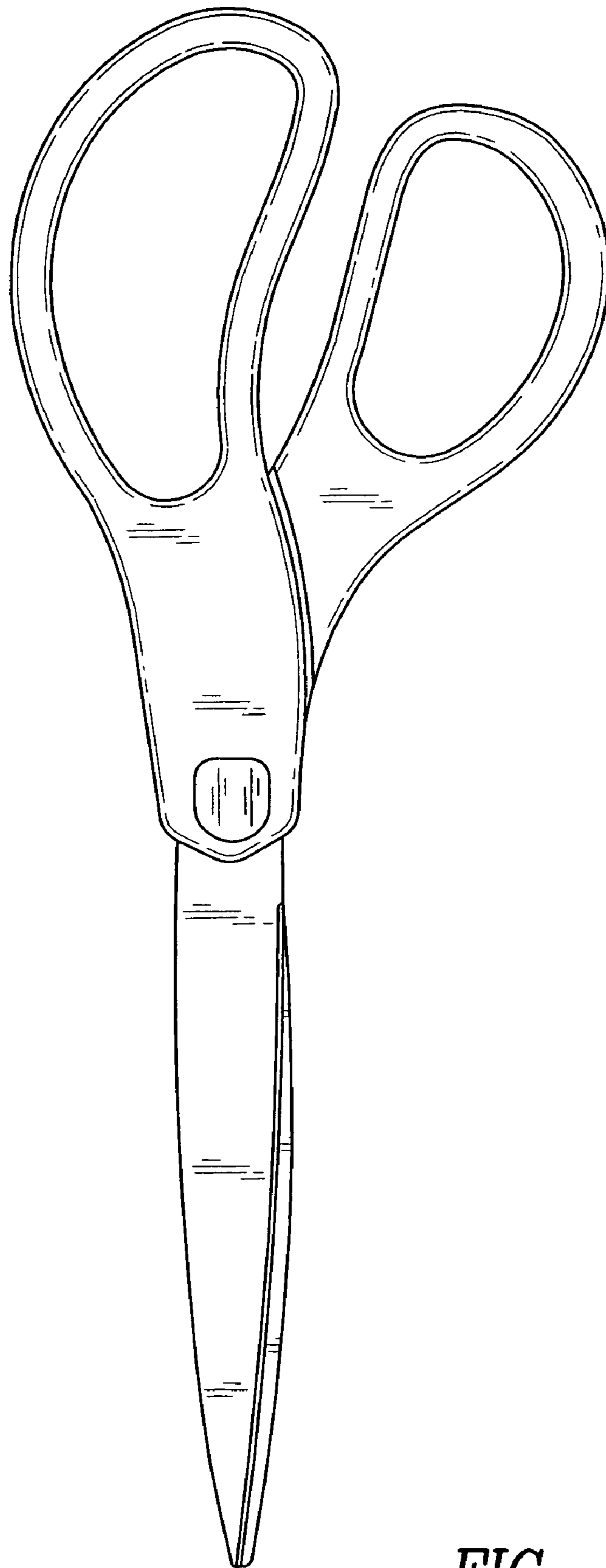

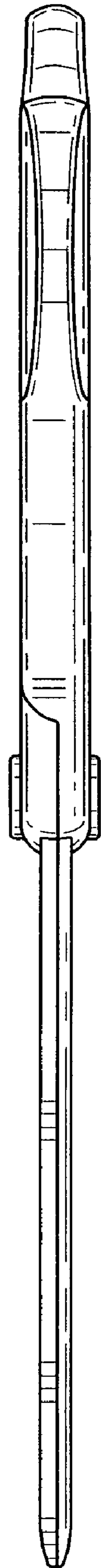

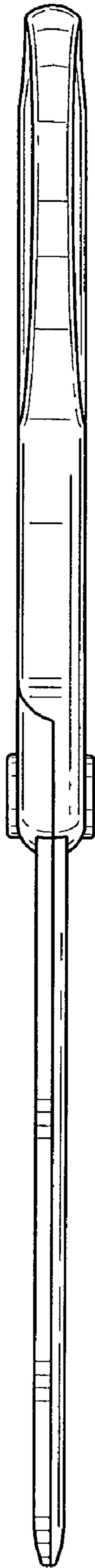

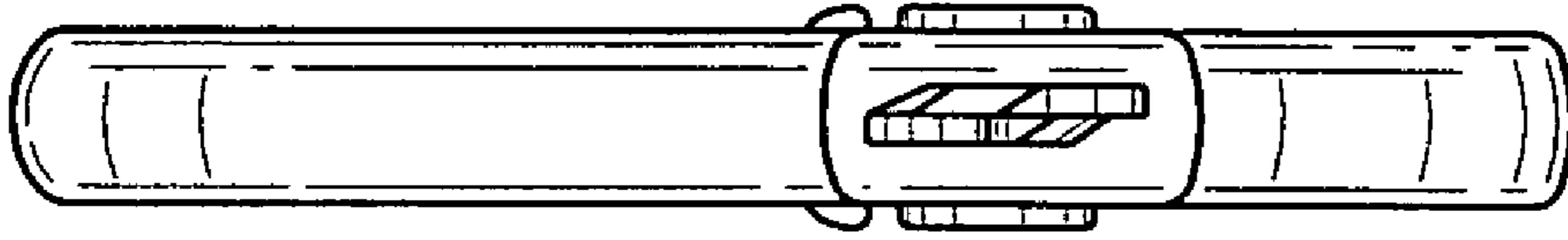

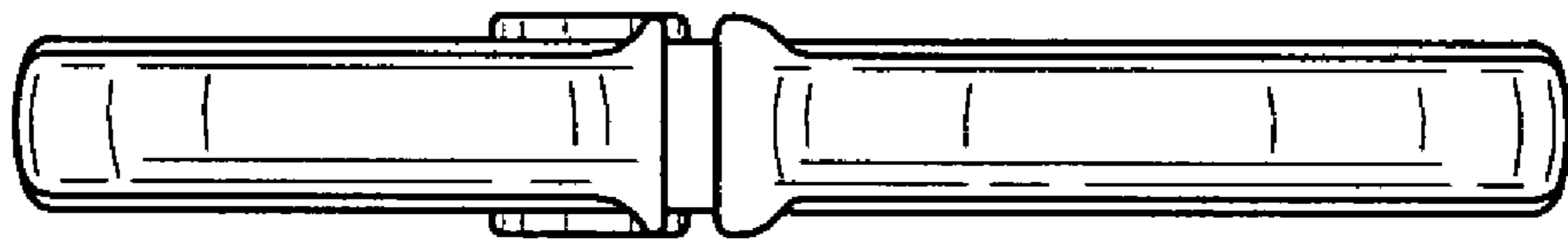

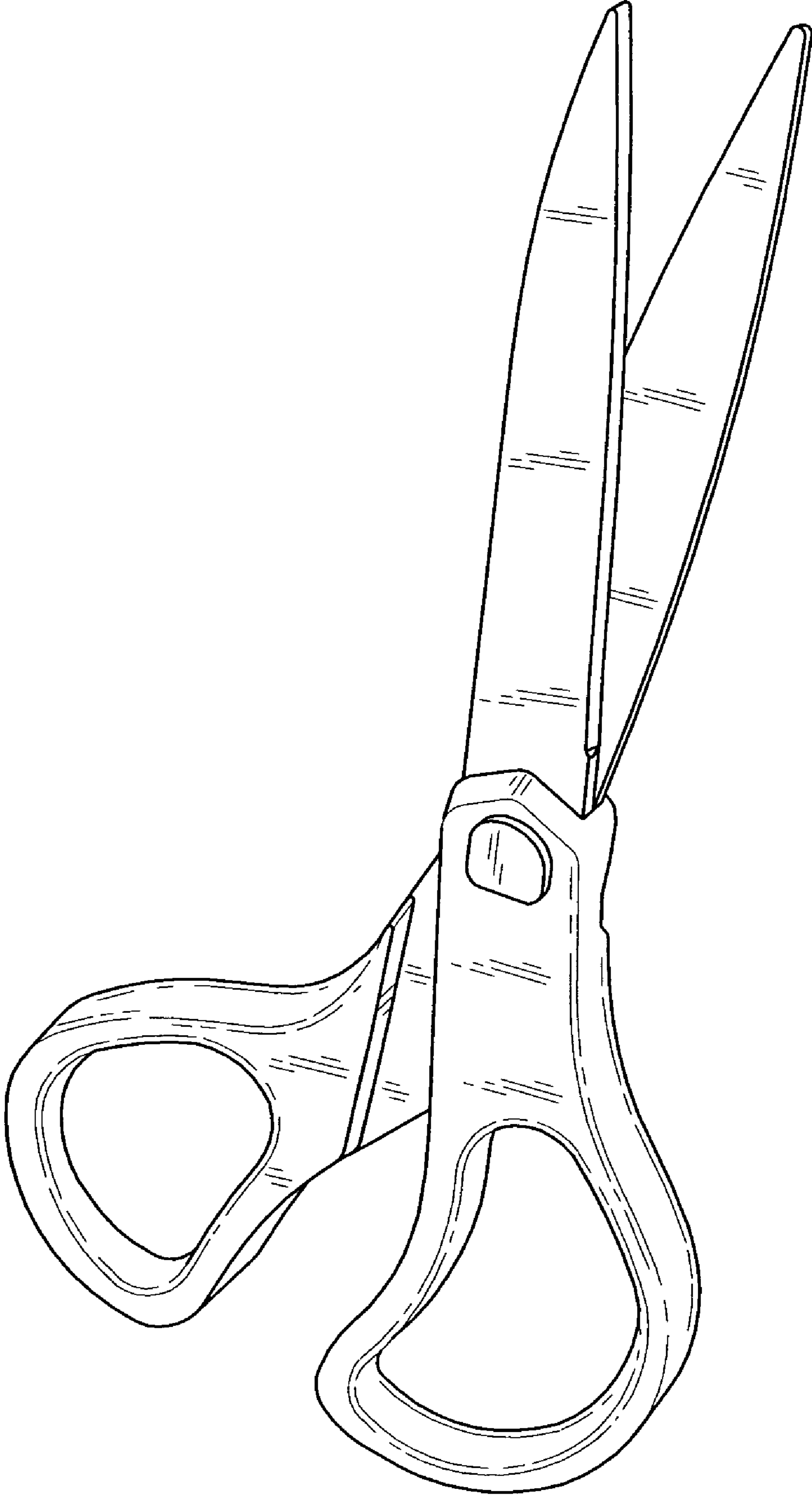
