The ornamental design for a tri-fold drug card, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing my new design for a tri-fold drug card, the portion shown in dotted lines is for illustrative purposes only,

FIG. 2 is a front view thereof, the portion shown in dotted lines is to illustrate perforation lines,

FIG. 3 is a rear view thereof, the portion shown in dotted lines is to illustrate perforation lines,

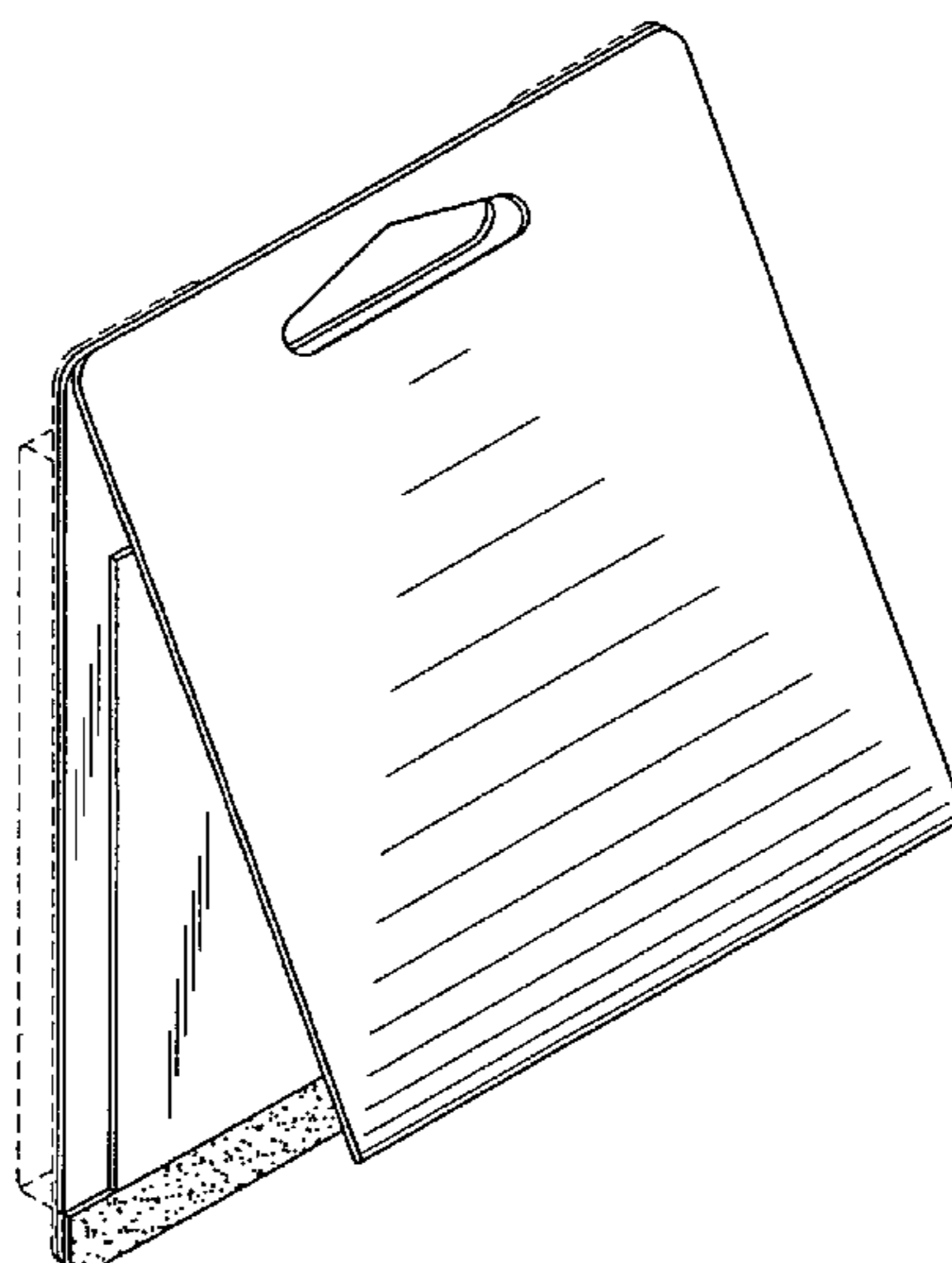
FIG. 4 is a left side view thereof,

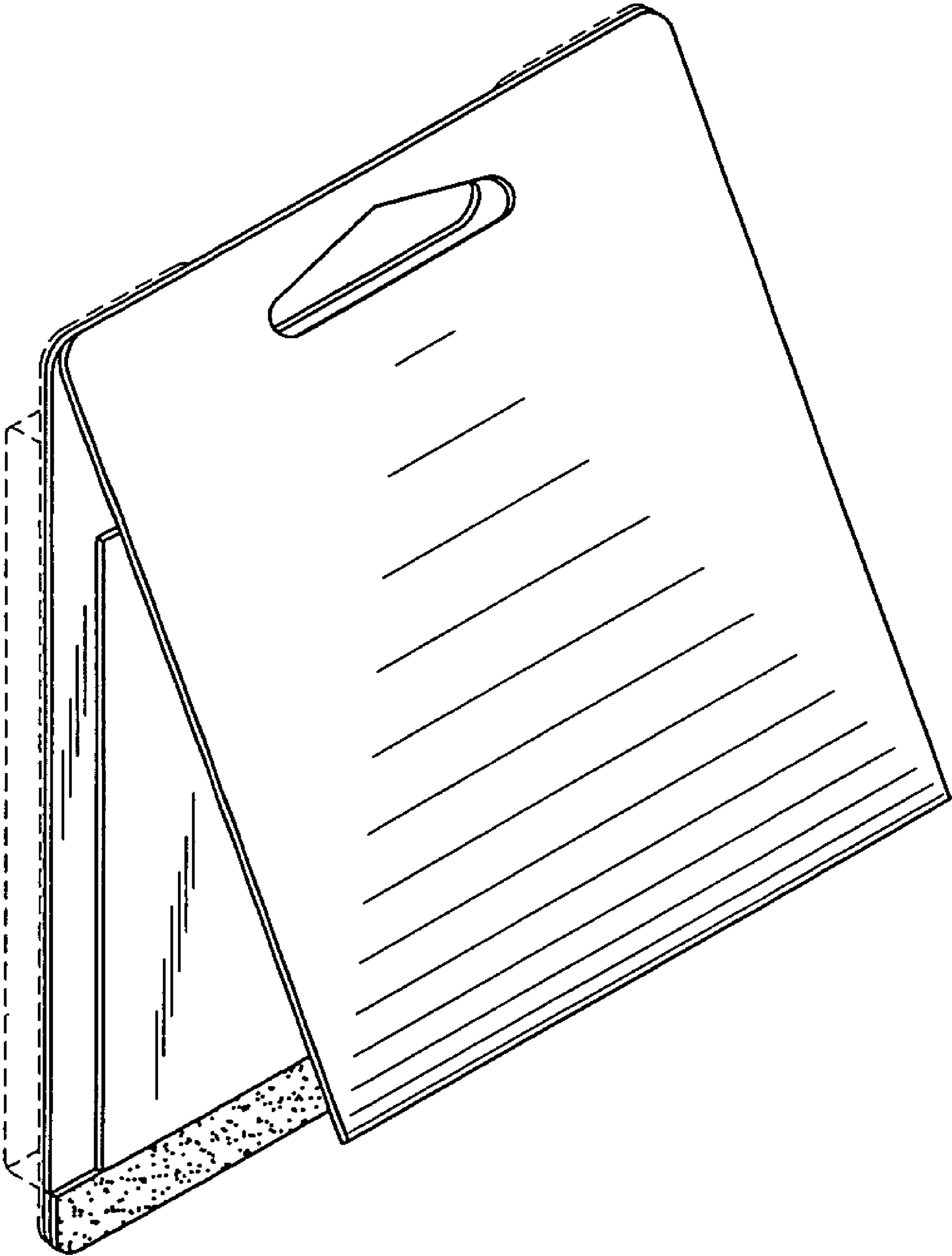

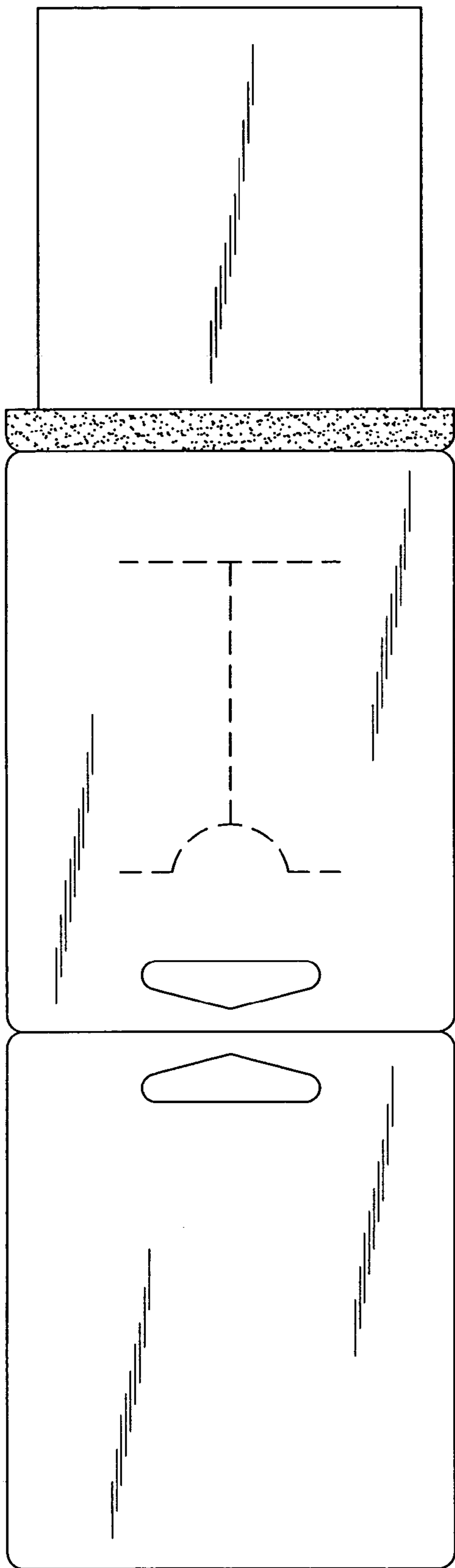

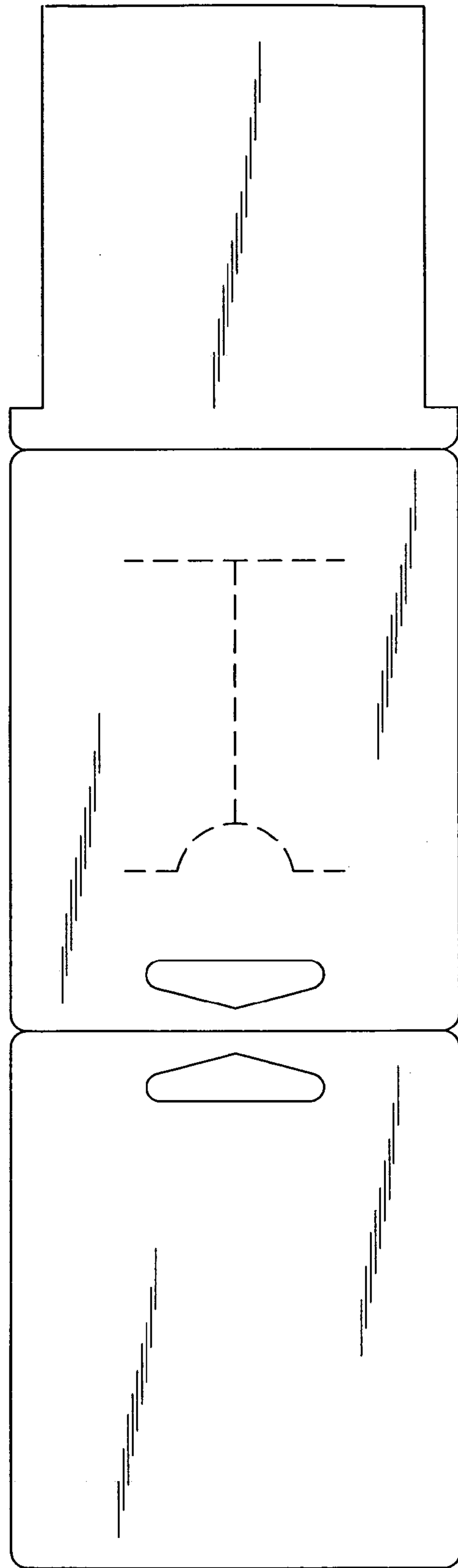
