view being identical;

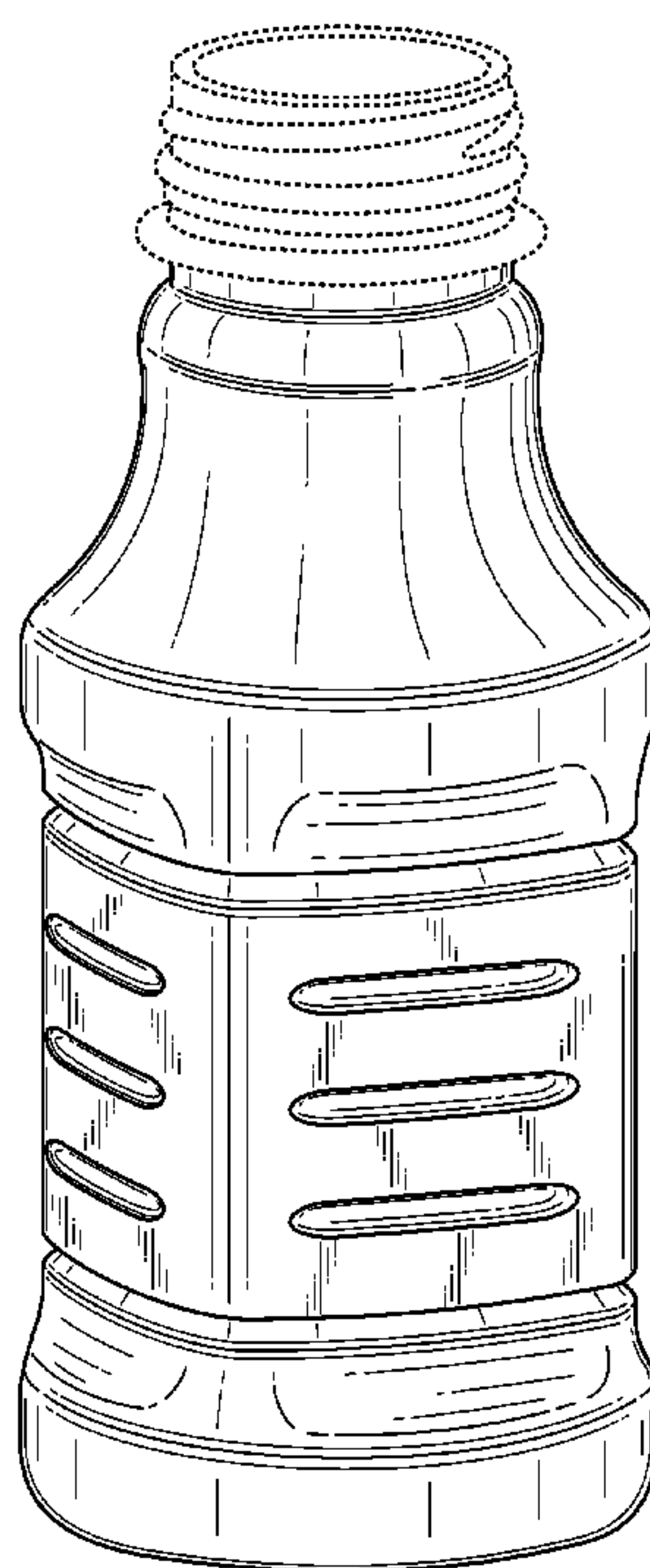
FIG. 3 is right side elevational view thereof, the left side

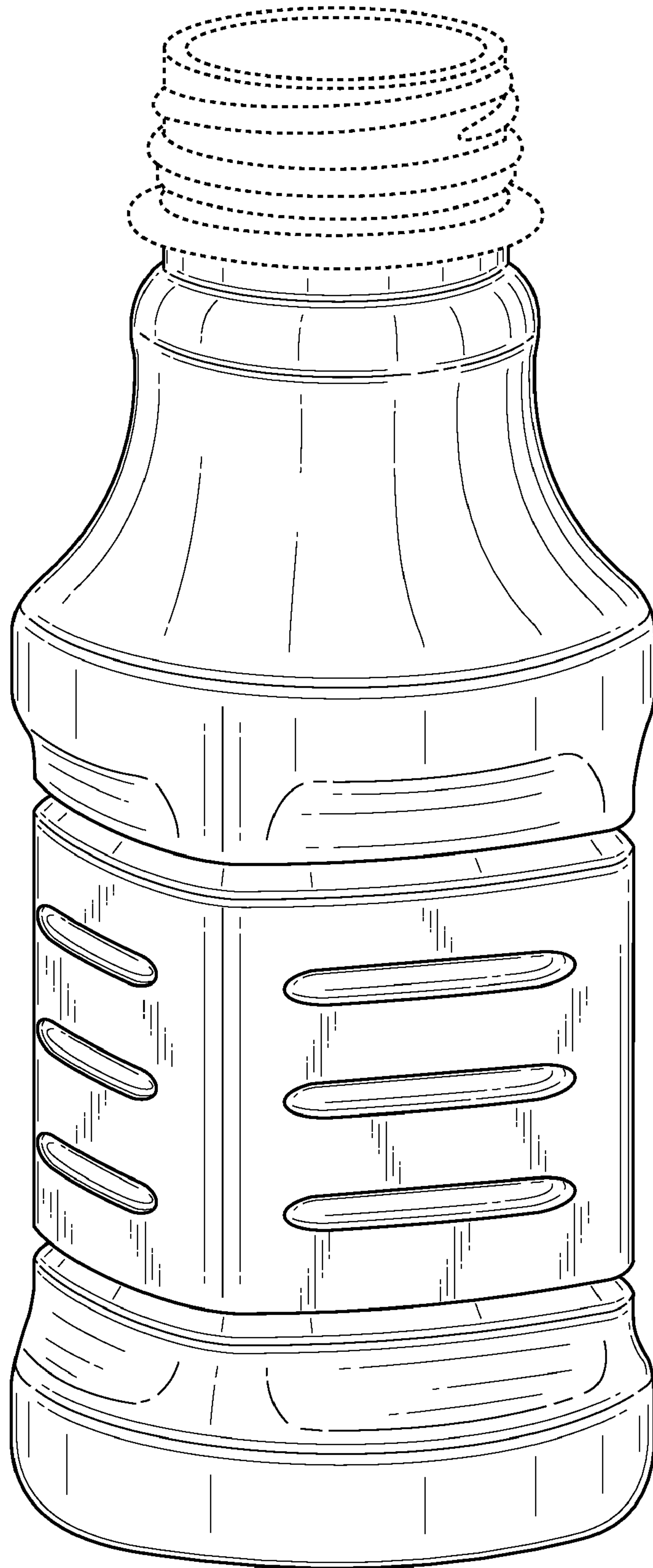
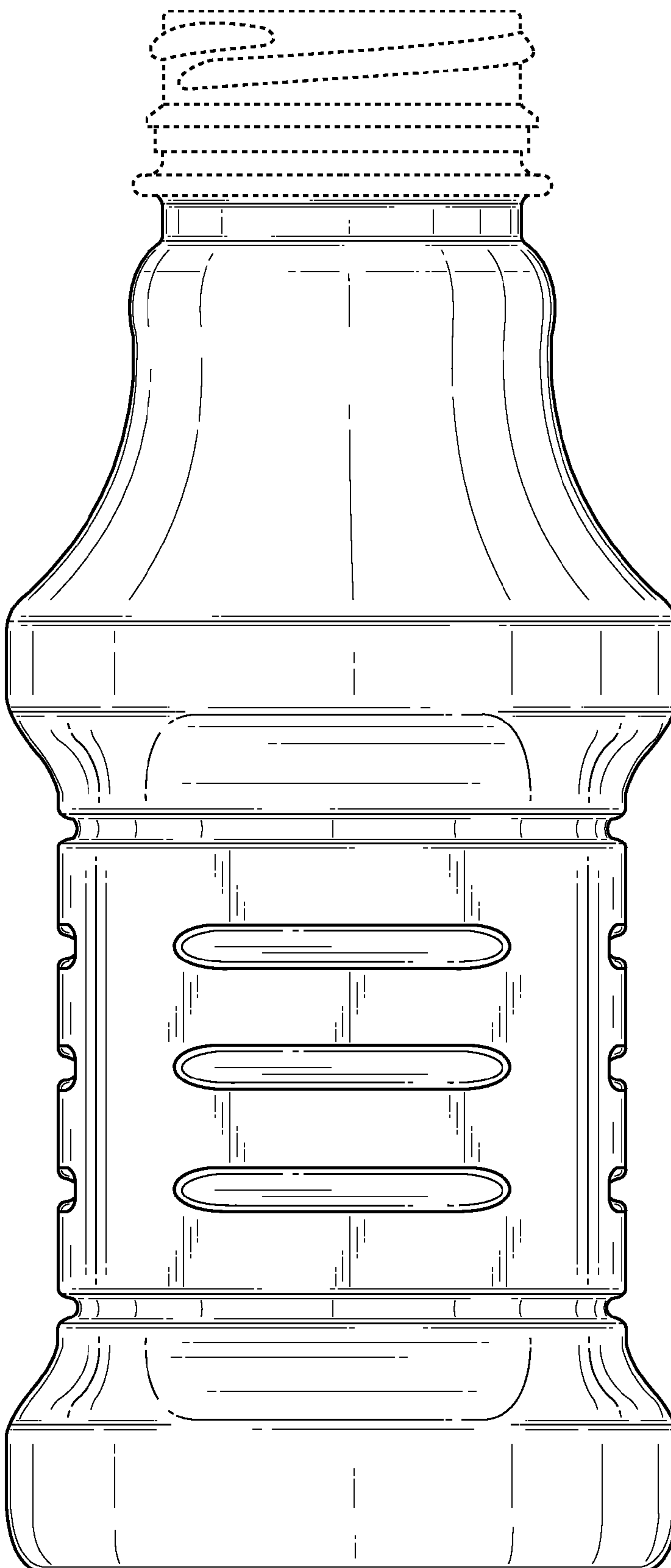

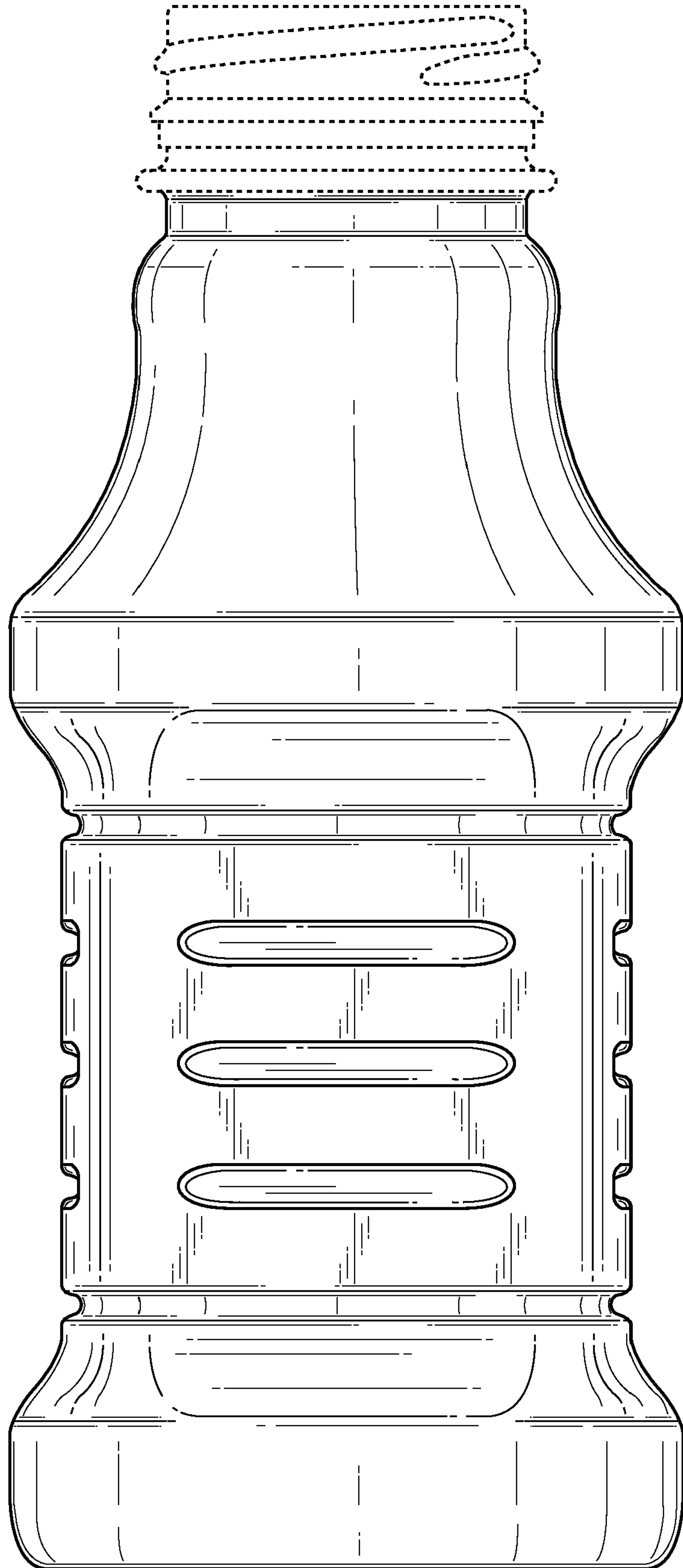

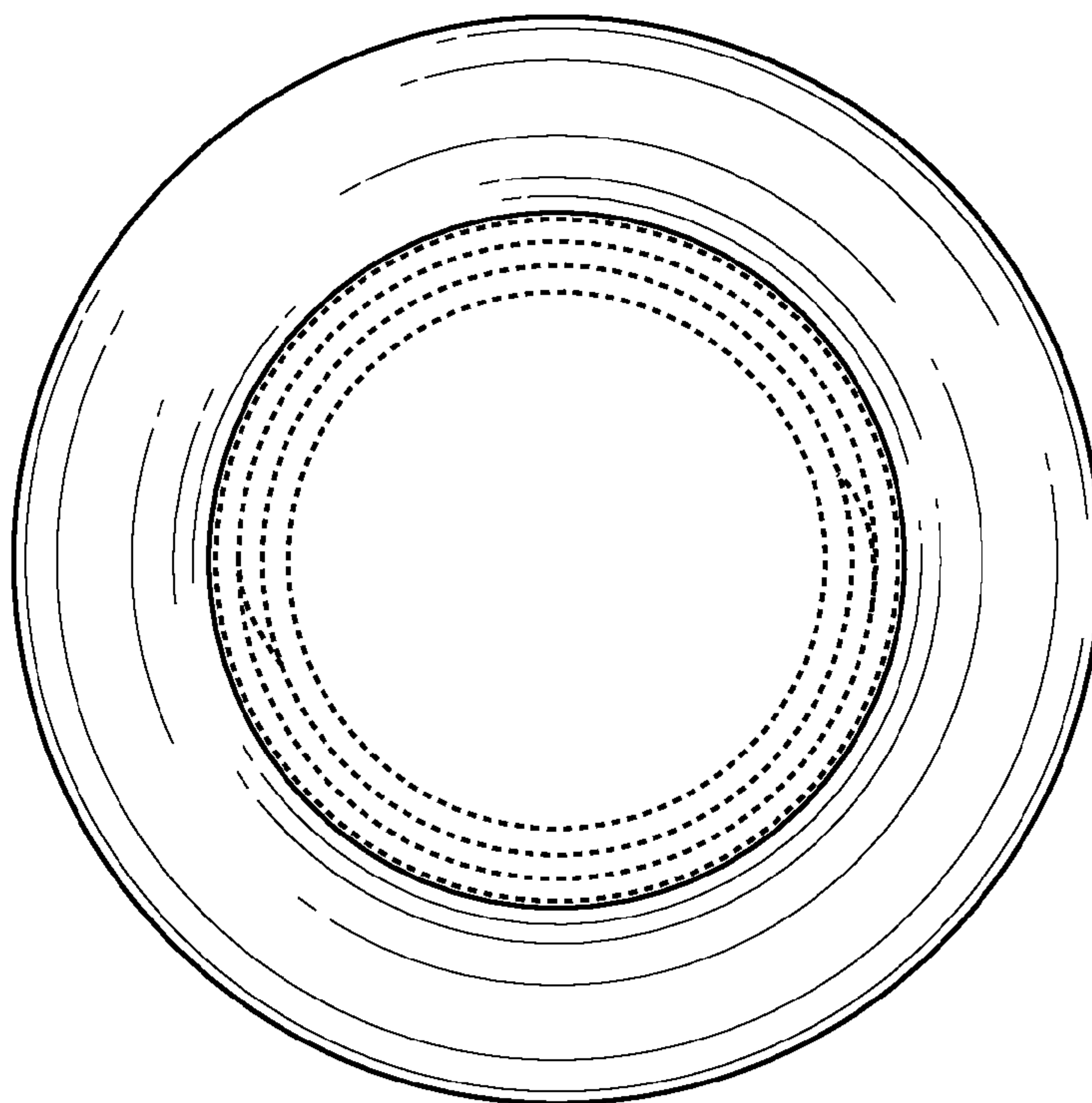

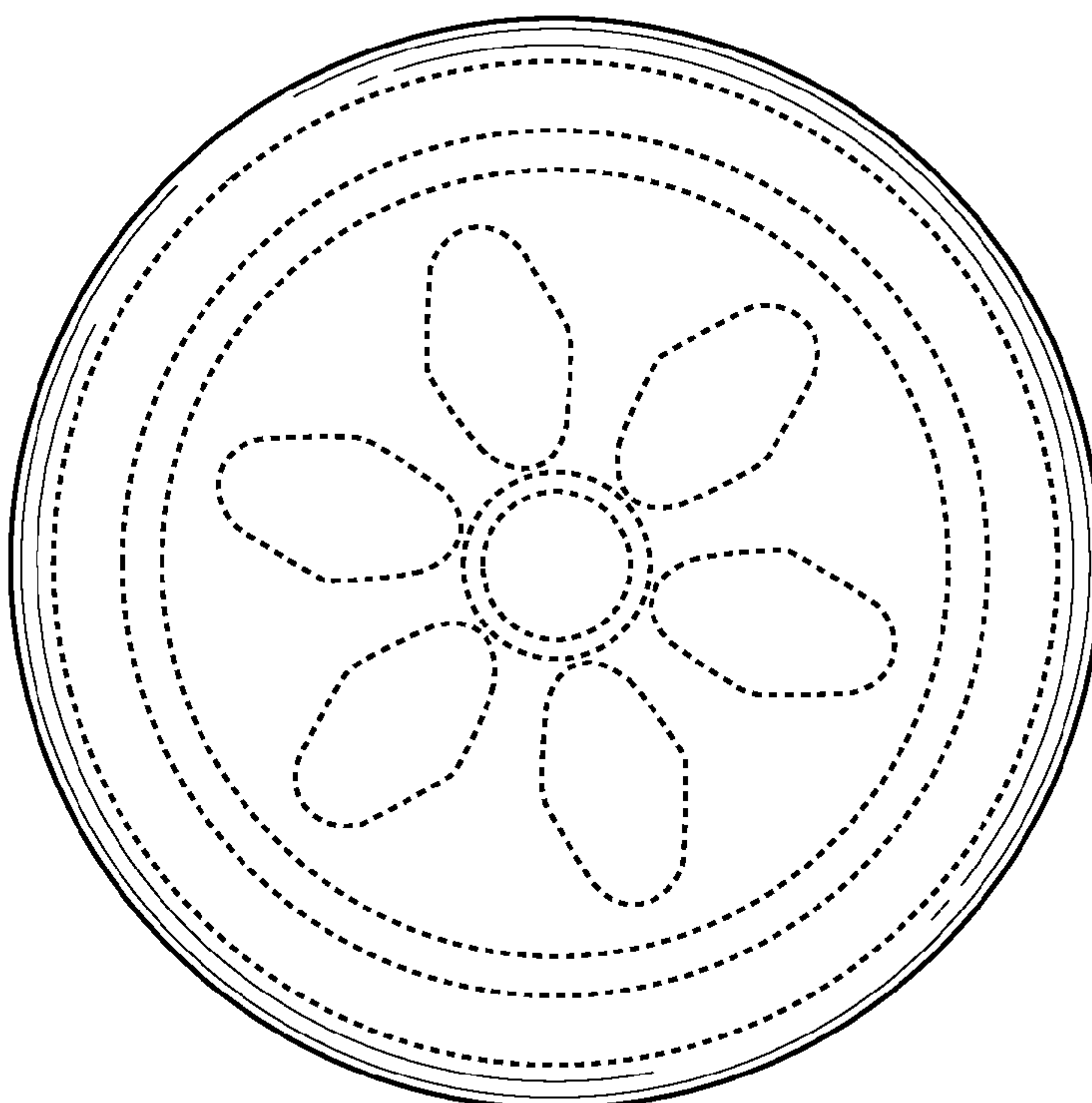
