DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a television receiver showing our new design,

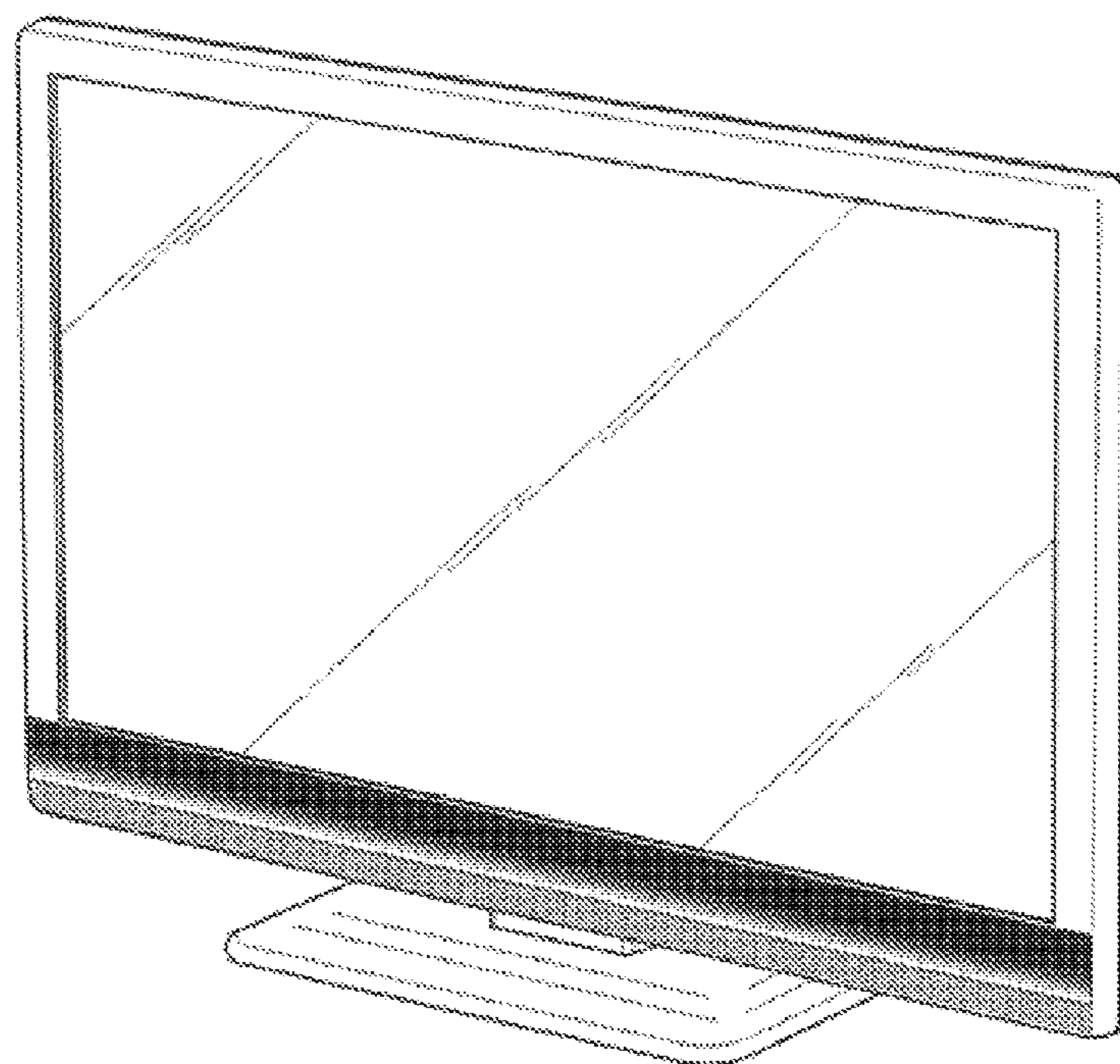

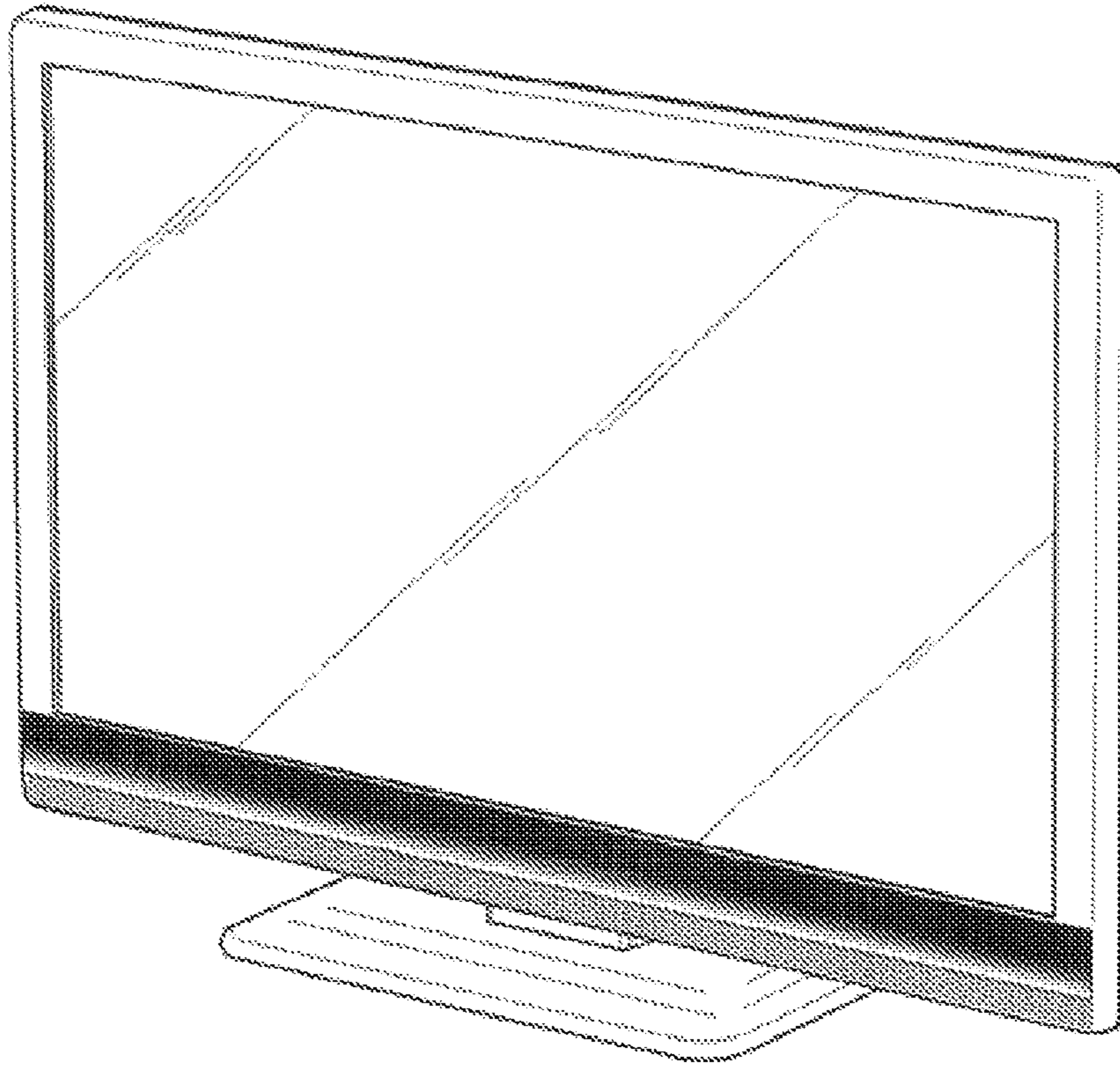

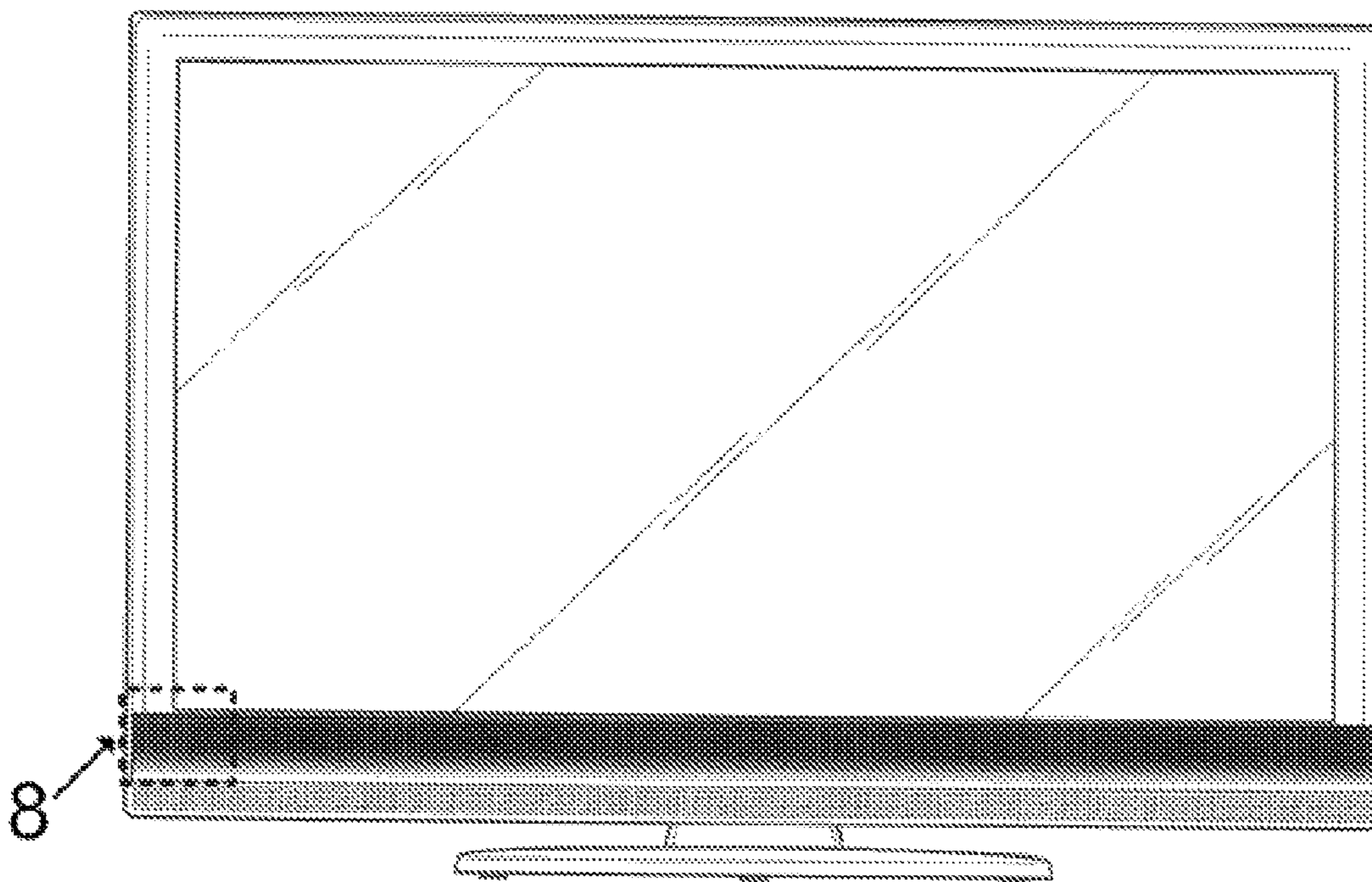

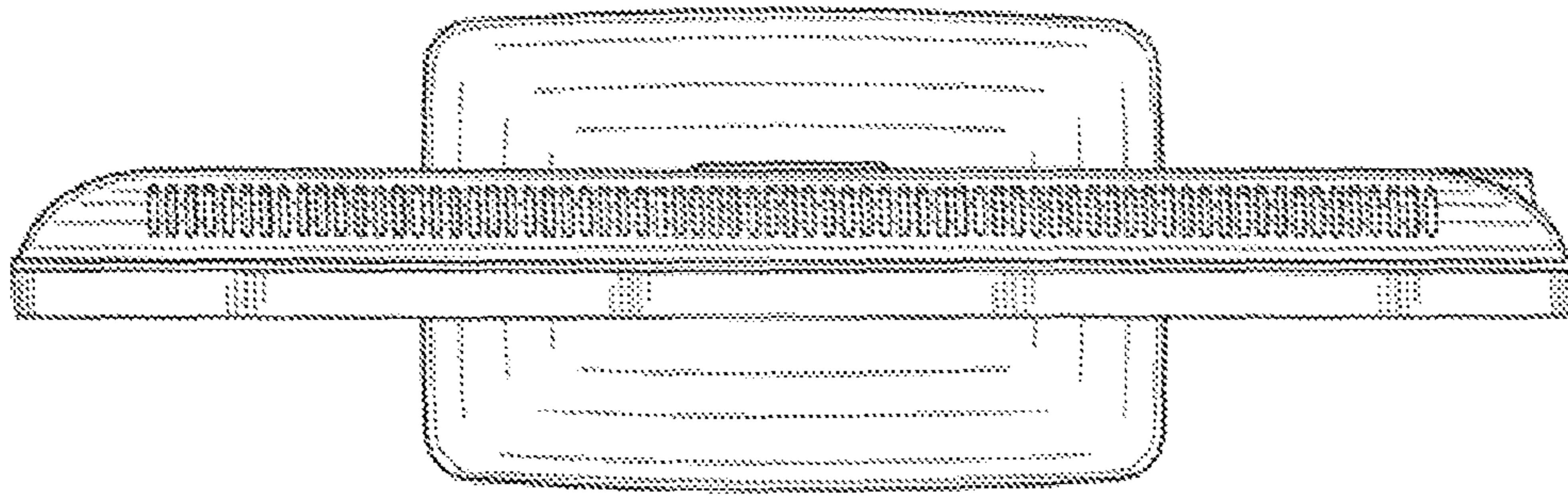

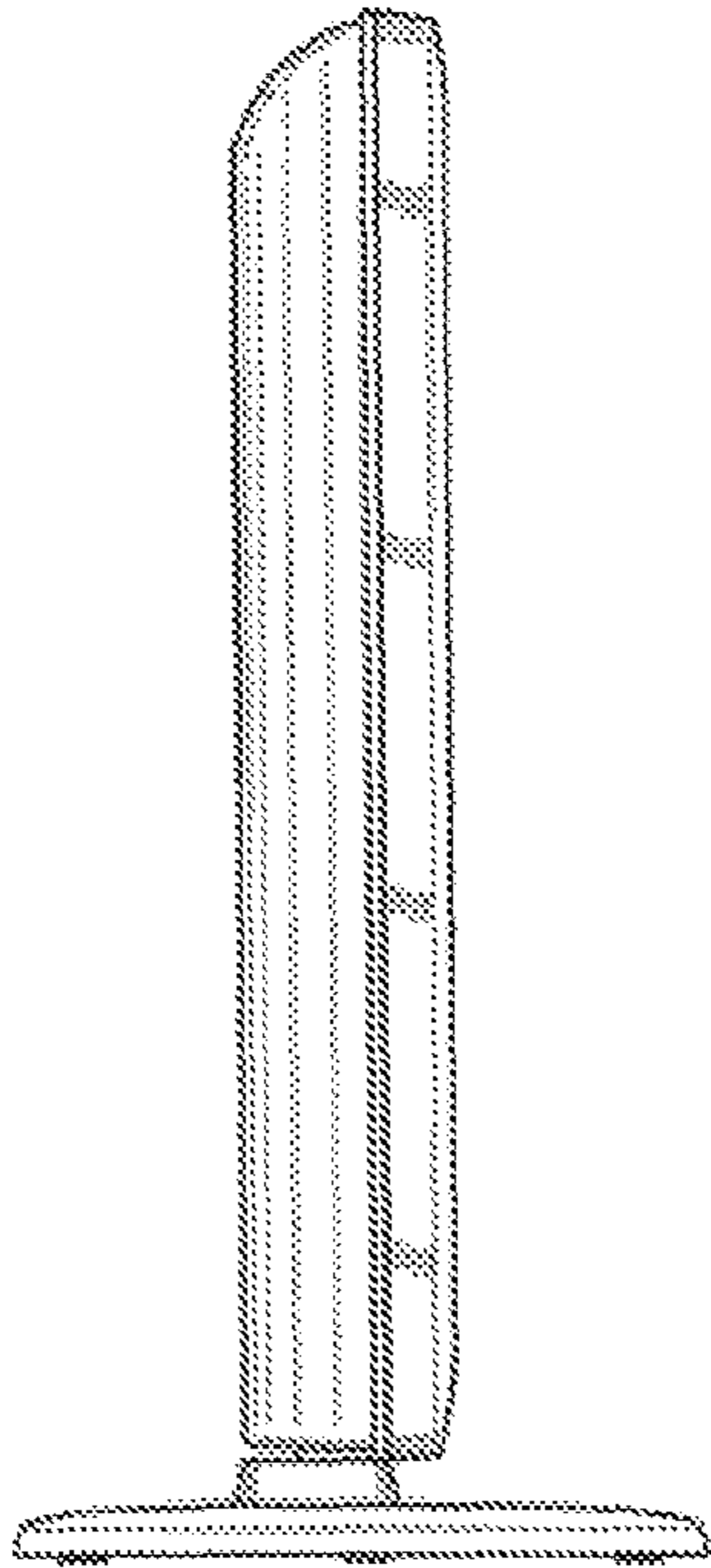

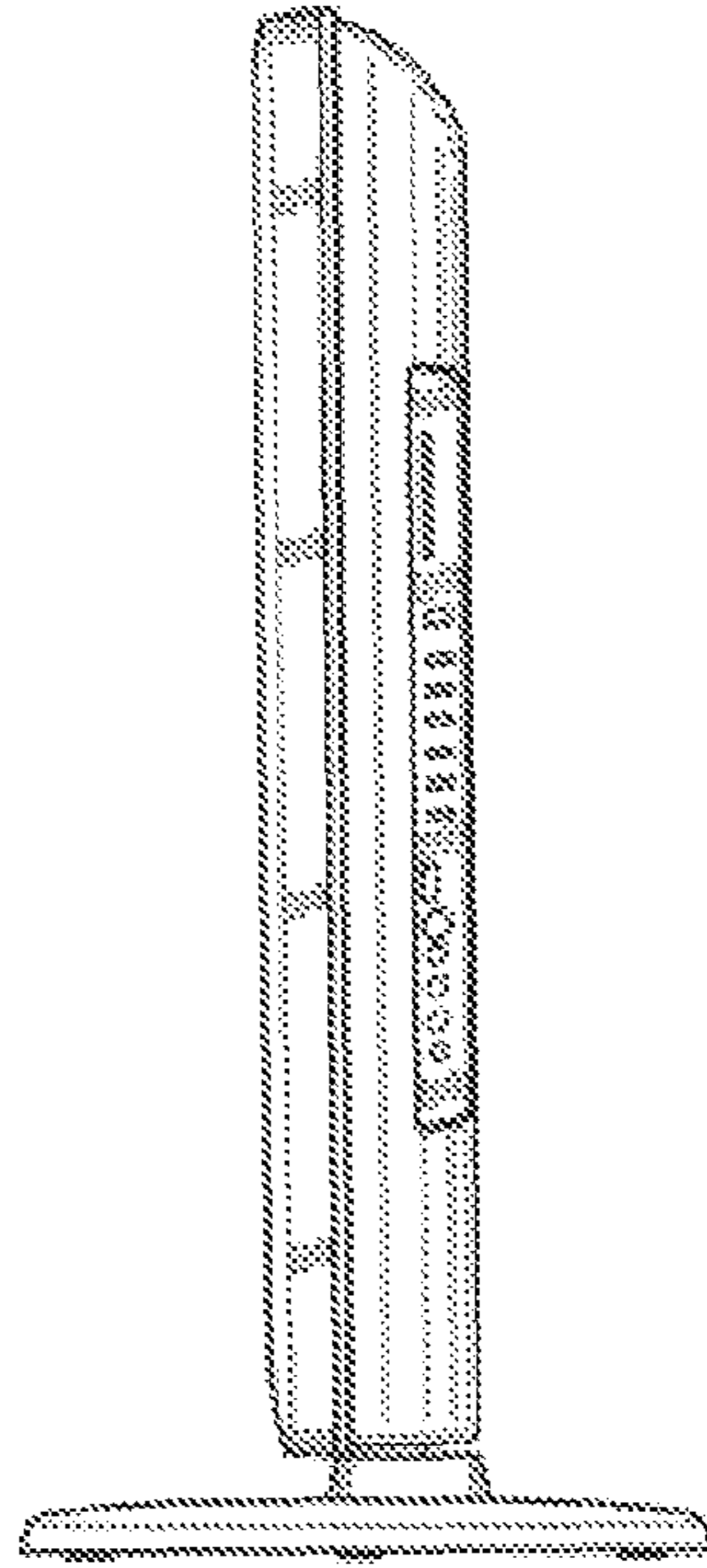

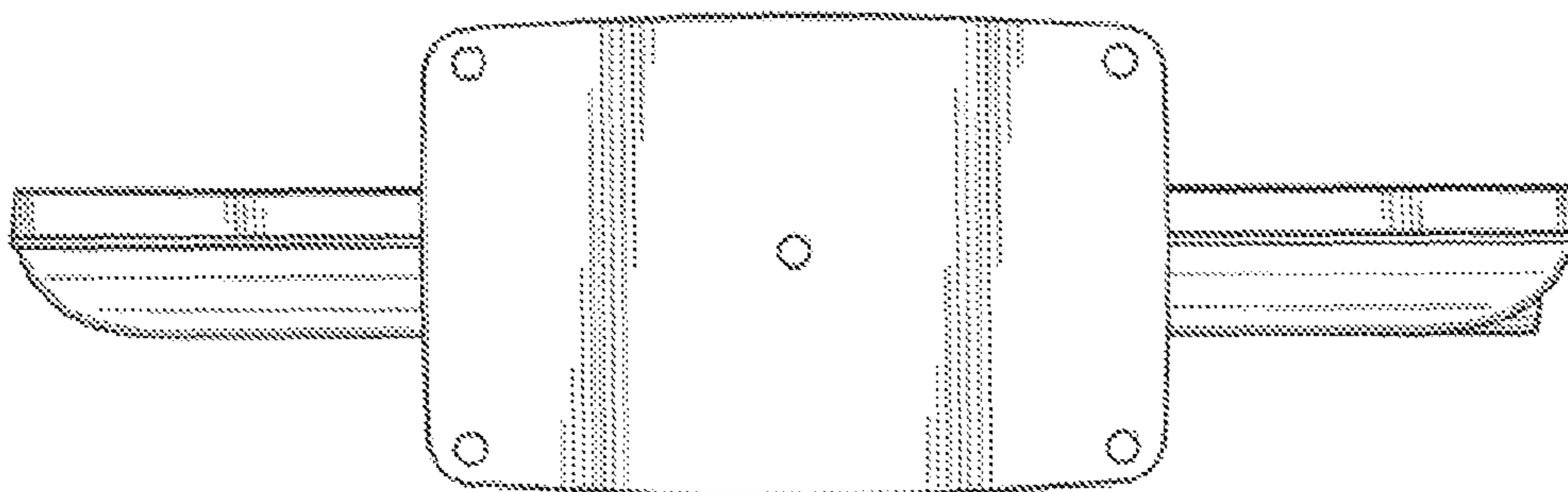

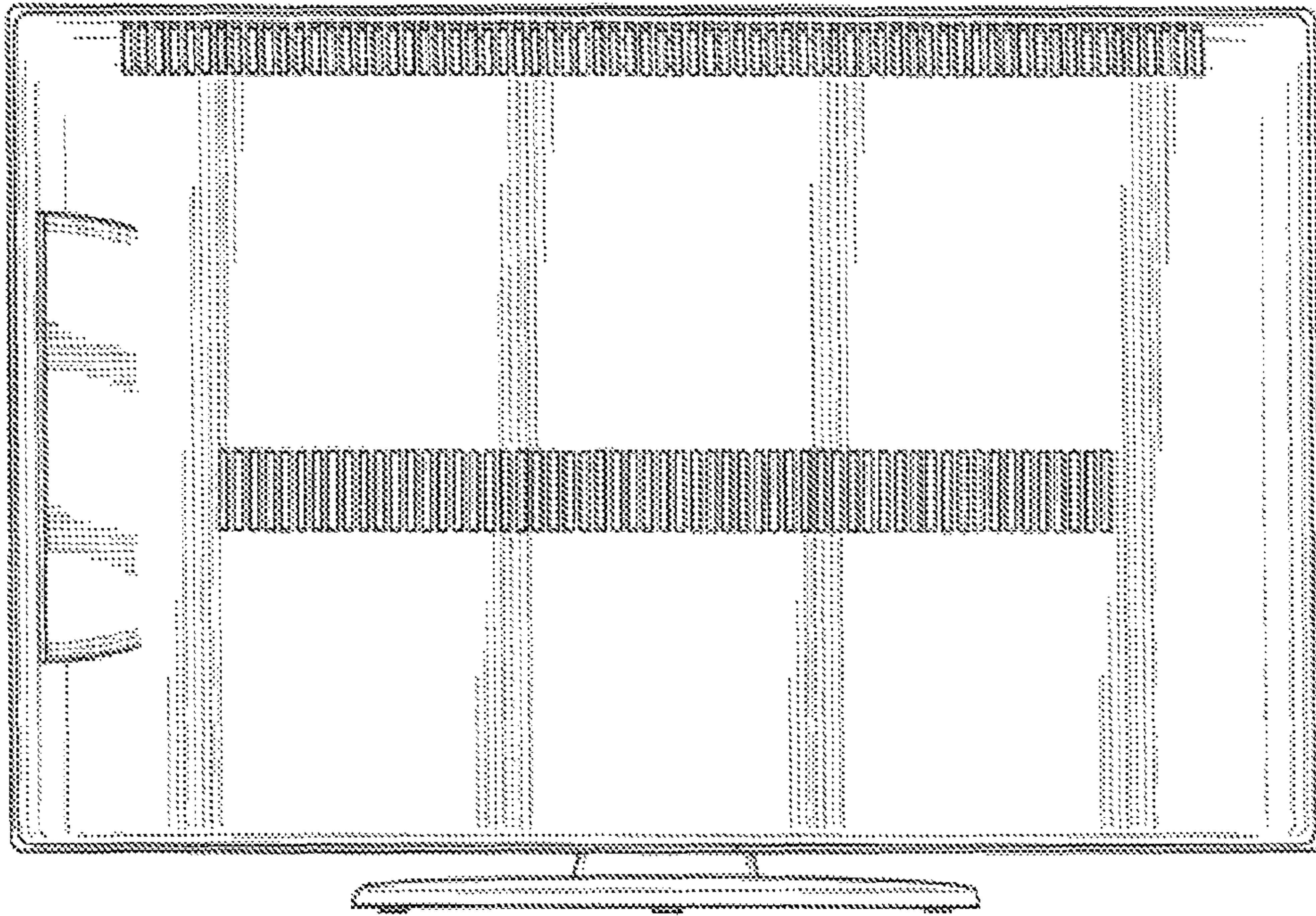
