DESCRIPTION

FIG. 4 is a back elevation view thereof;

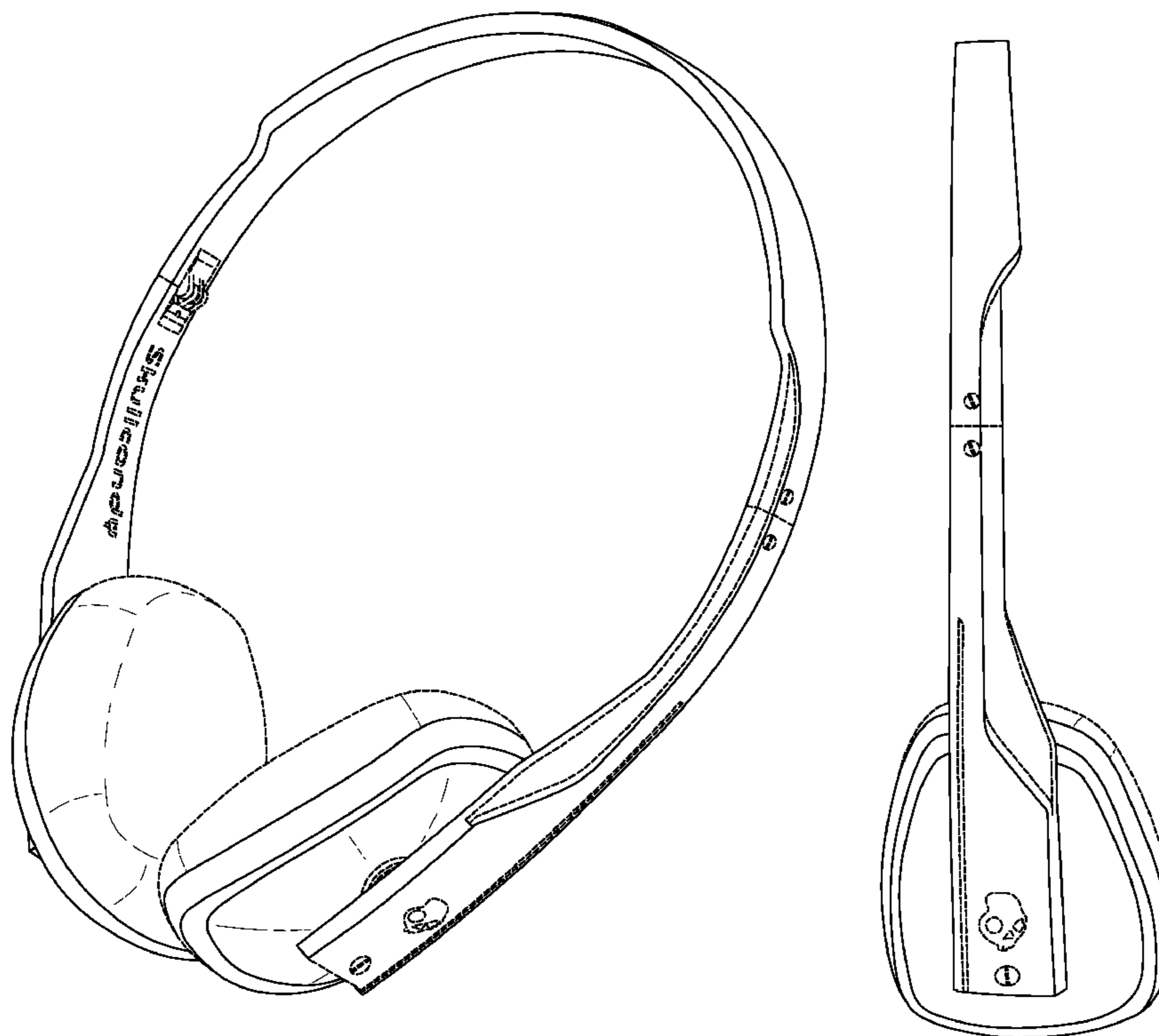
FIG. 5 is a right, side elevation view thereof;

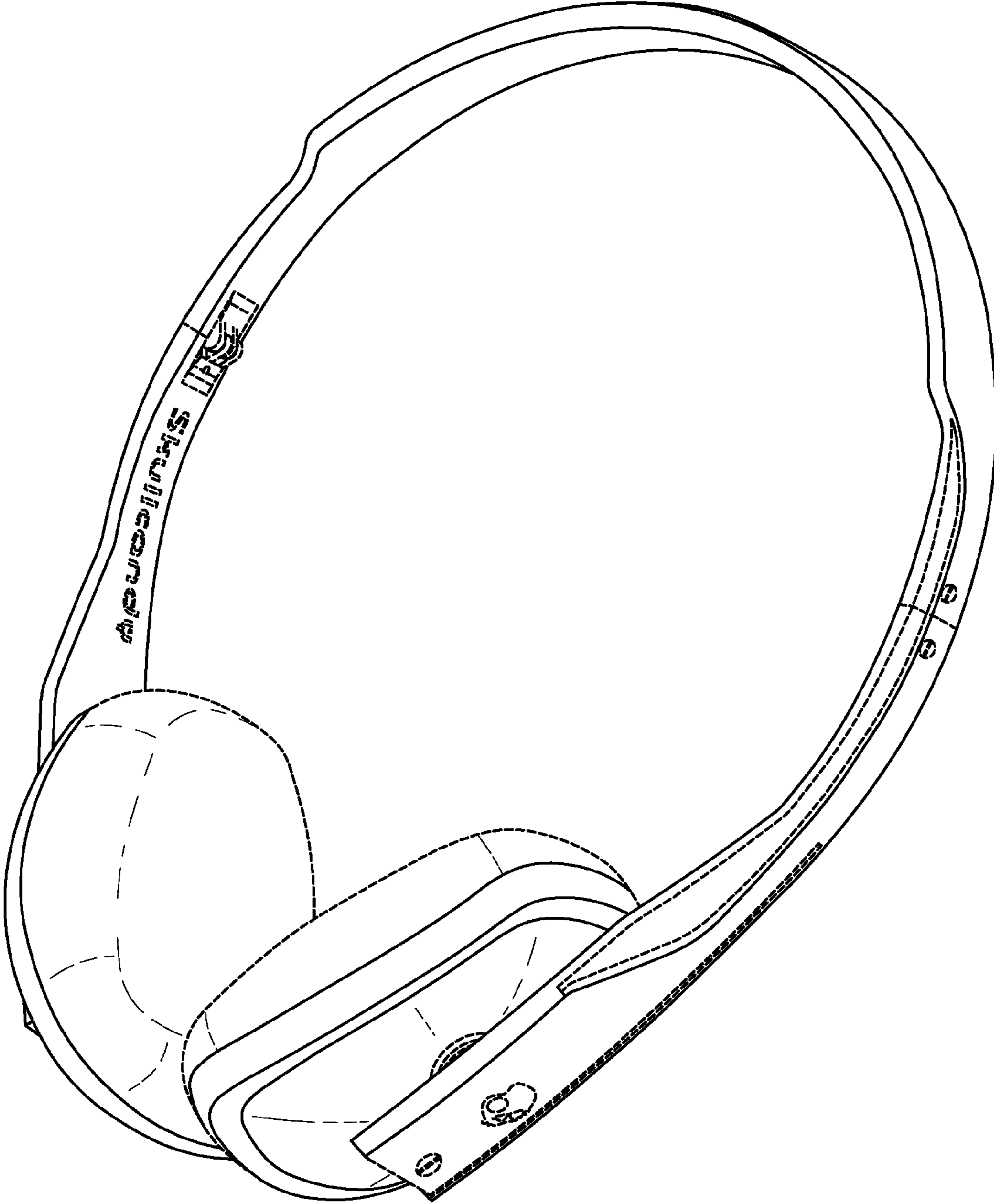

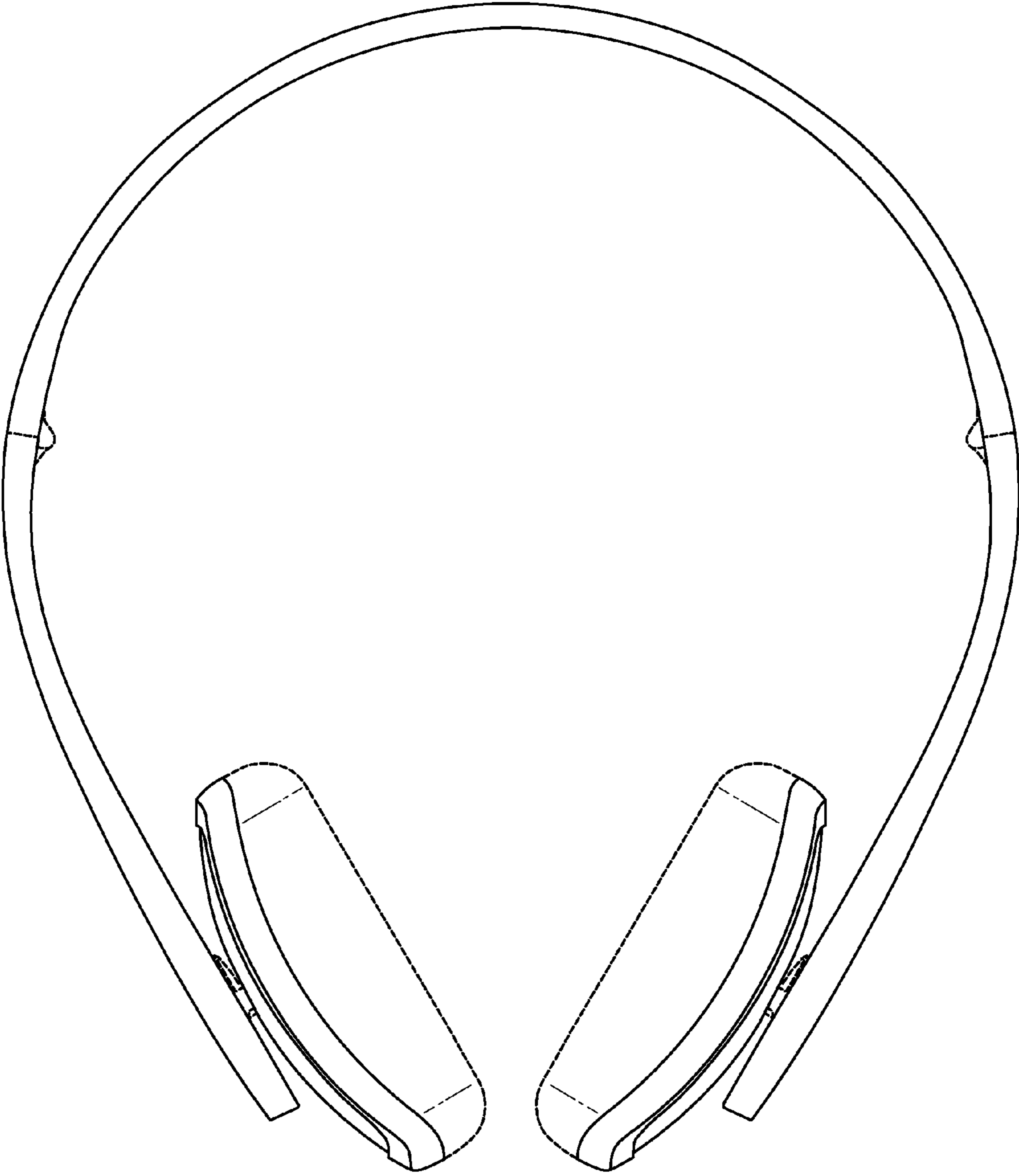

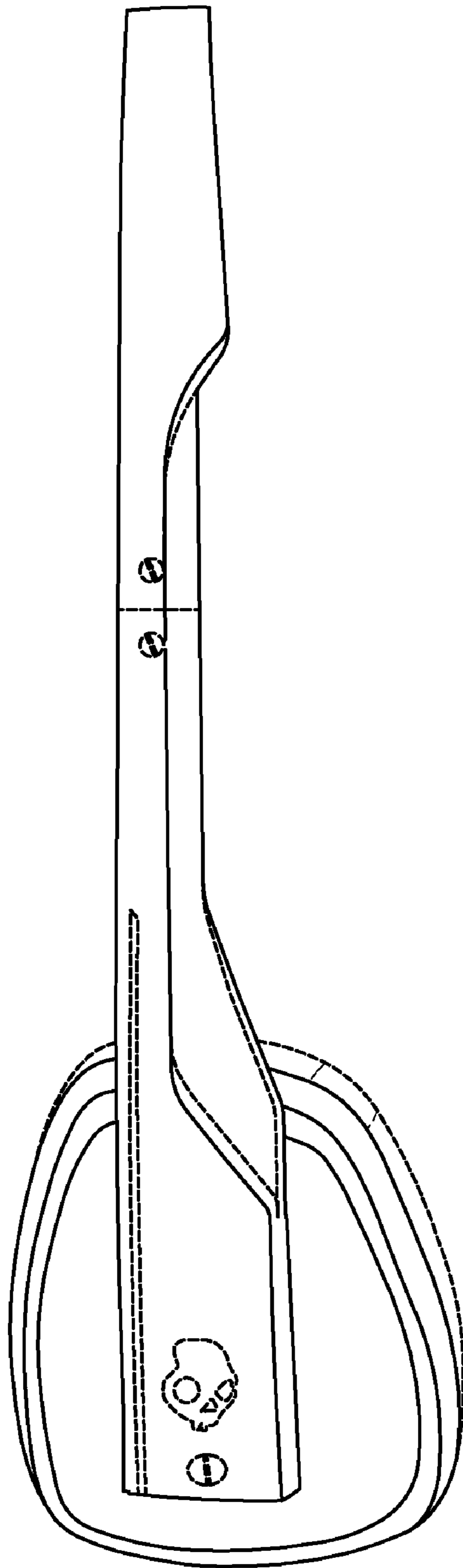

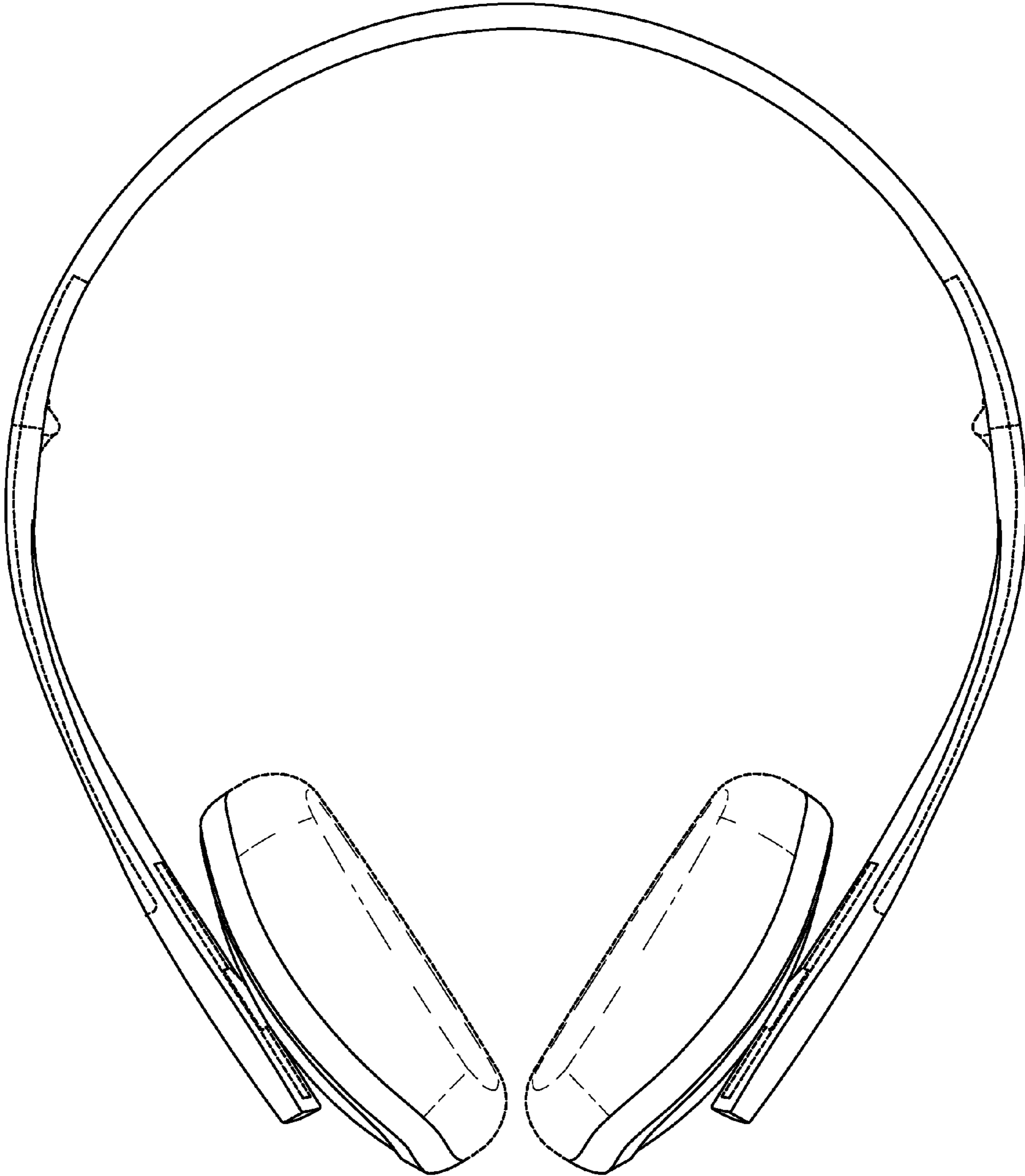

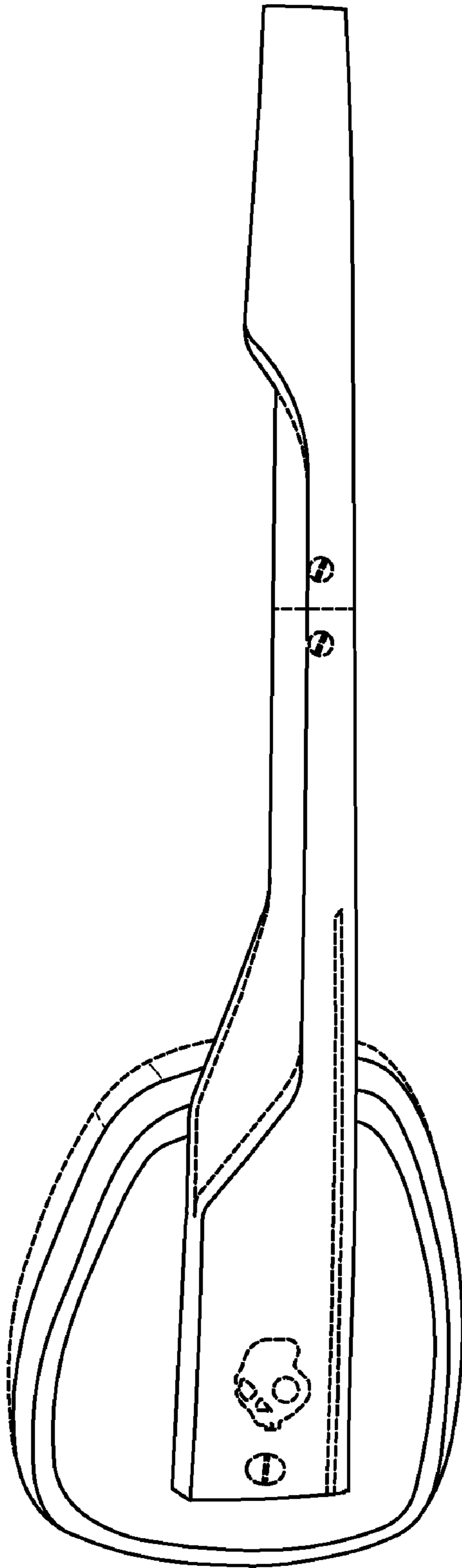

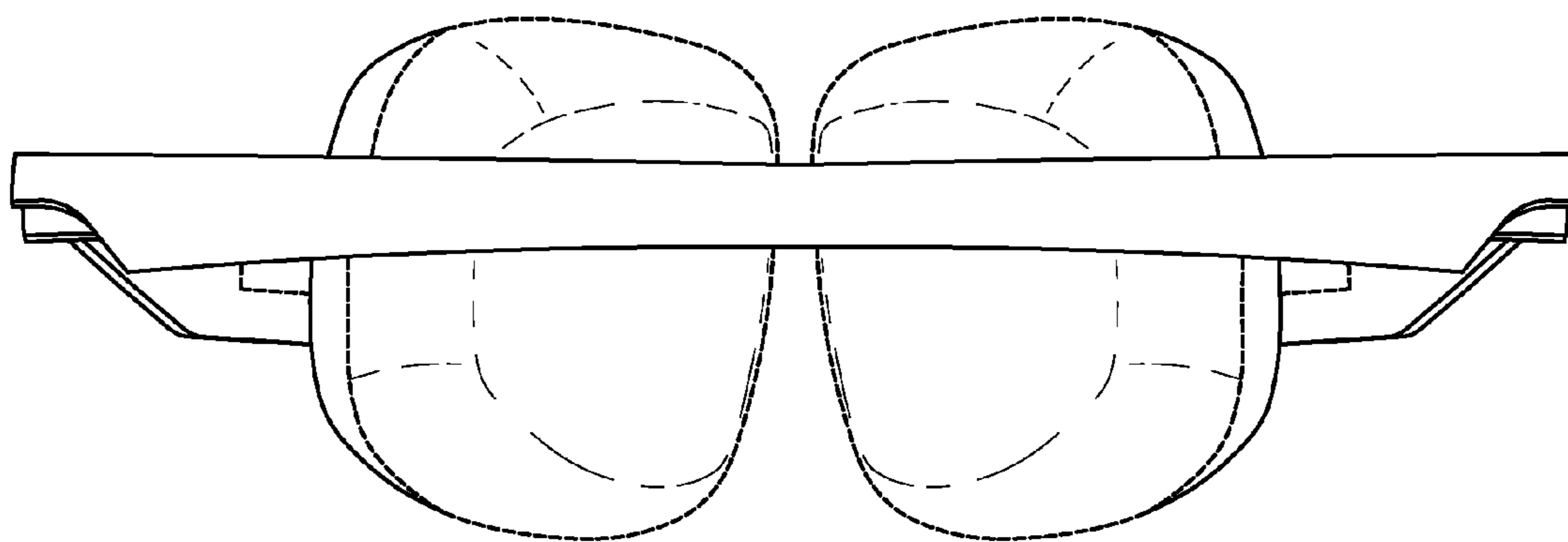

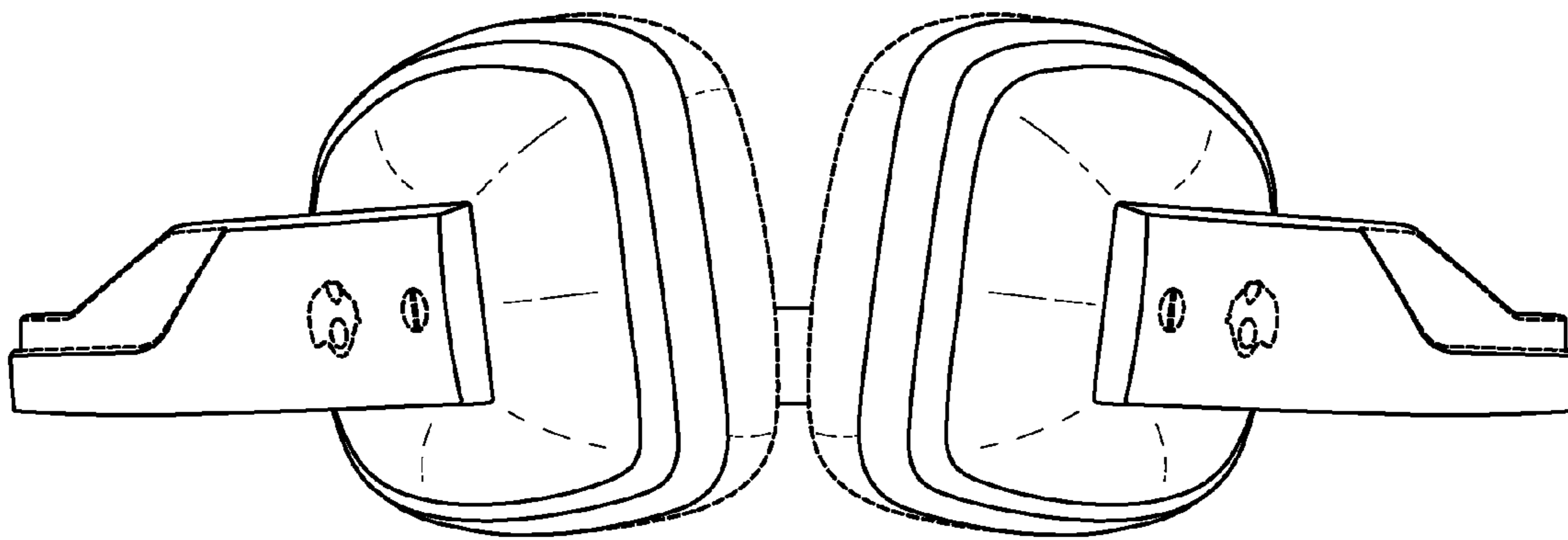
