The ornamental design for a case for a medical inhaler, as
shown and described.

DESCRIPTION

FIG. 1 is a front view of a case for a medical inhaler showing
our new design.

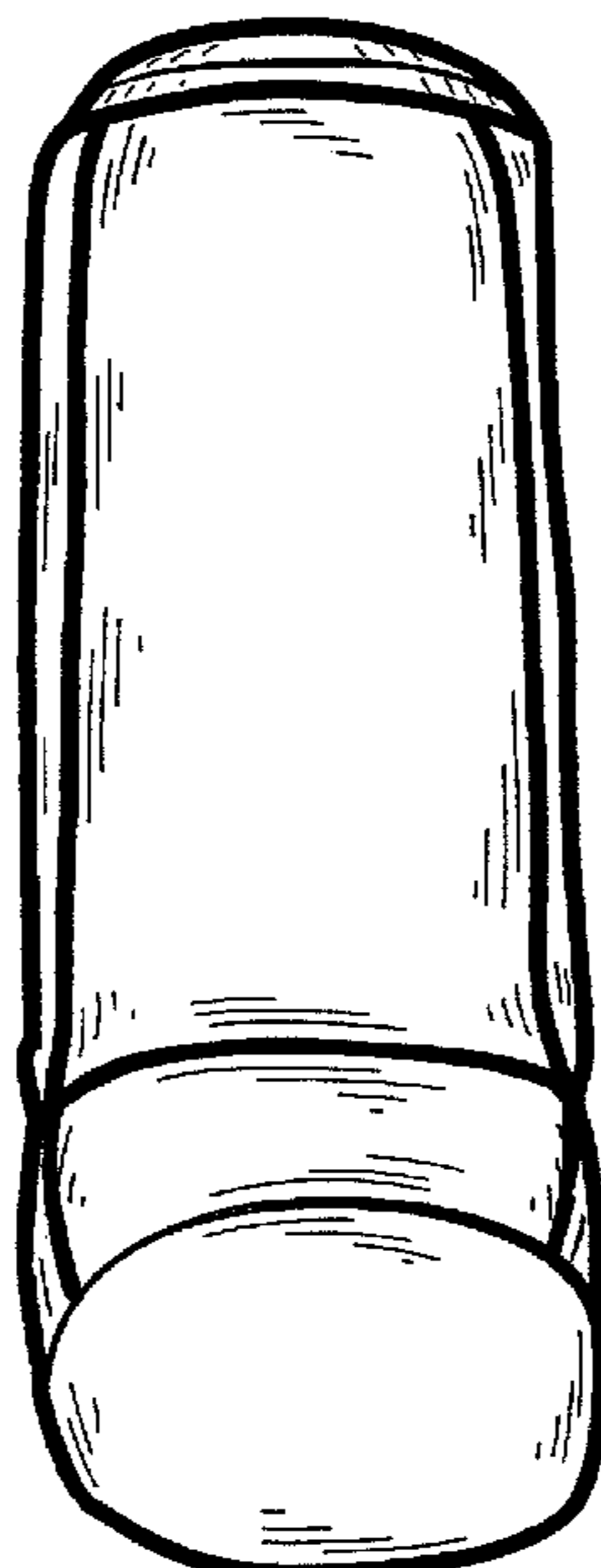
FIG. 2 is a left side view of the case for a medical inhaler, the
right side view being a mirror image thereof; and,

FIG. 3 is a front view (in open configuration) of the case for a
medical inhaler.

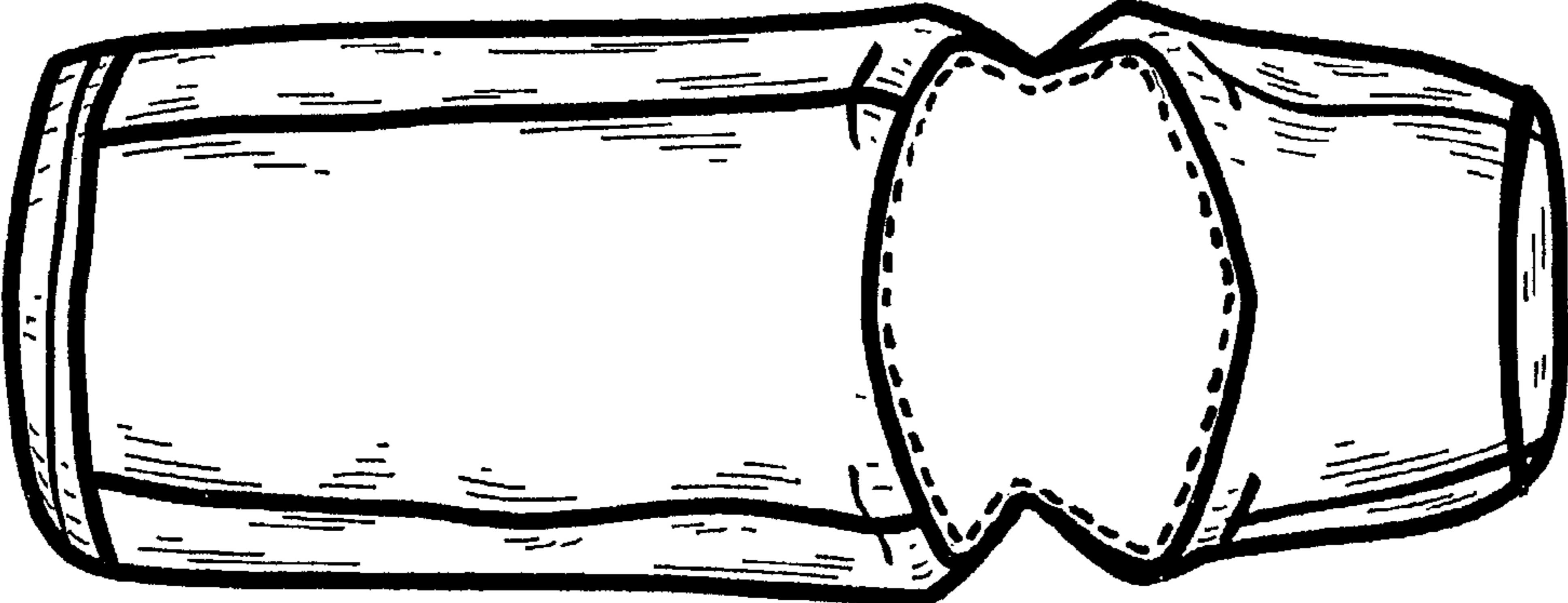

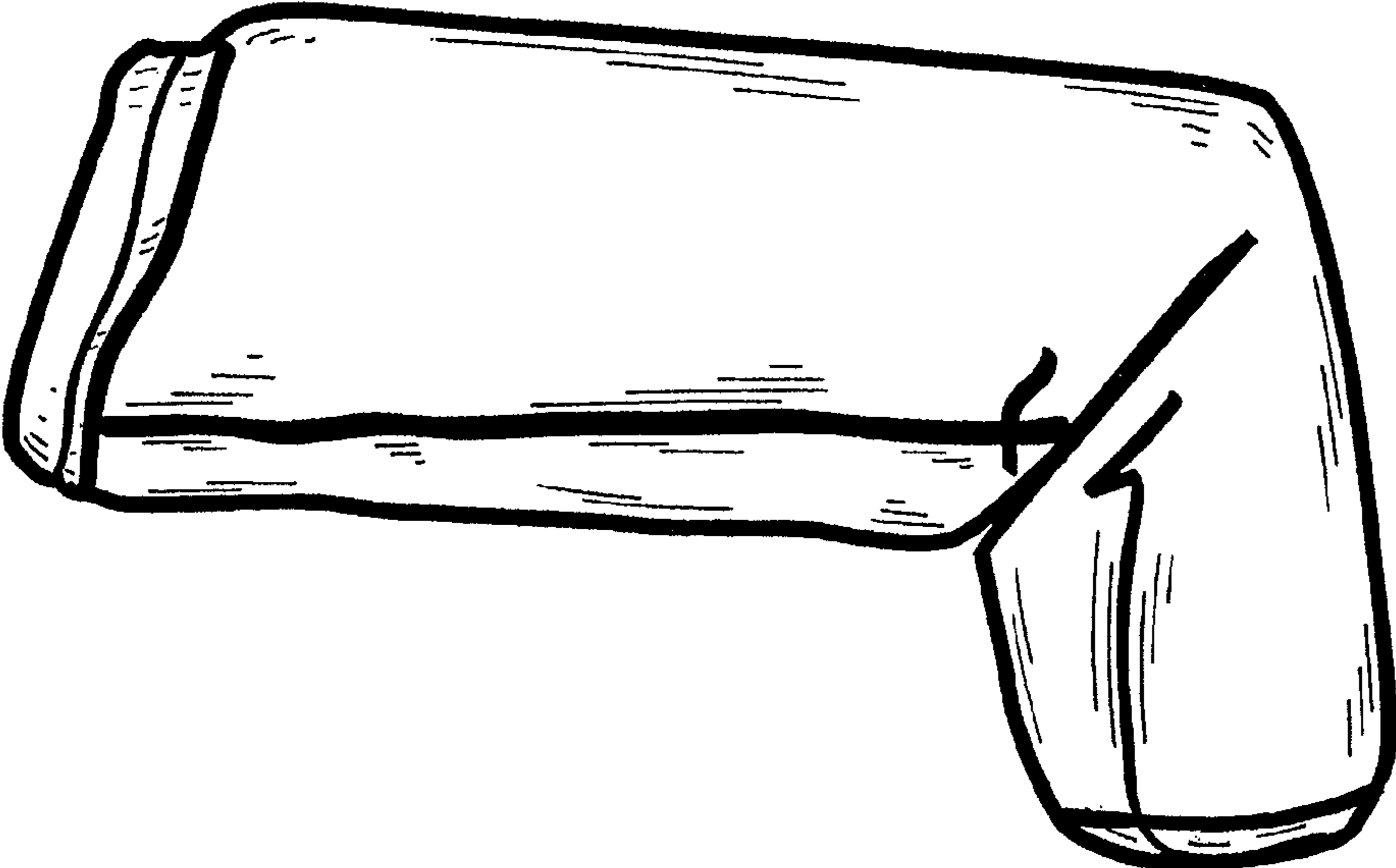

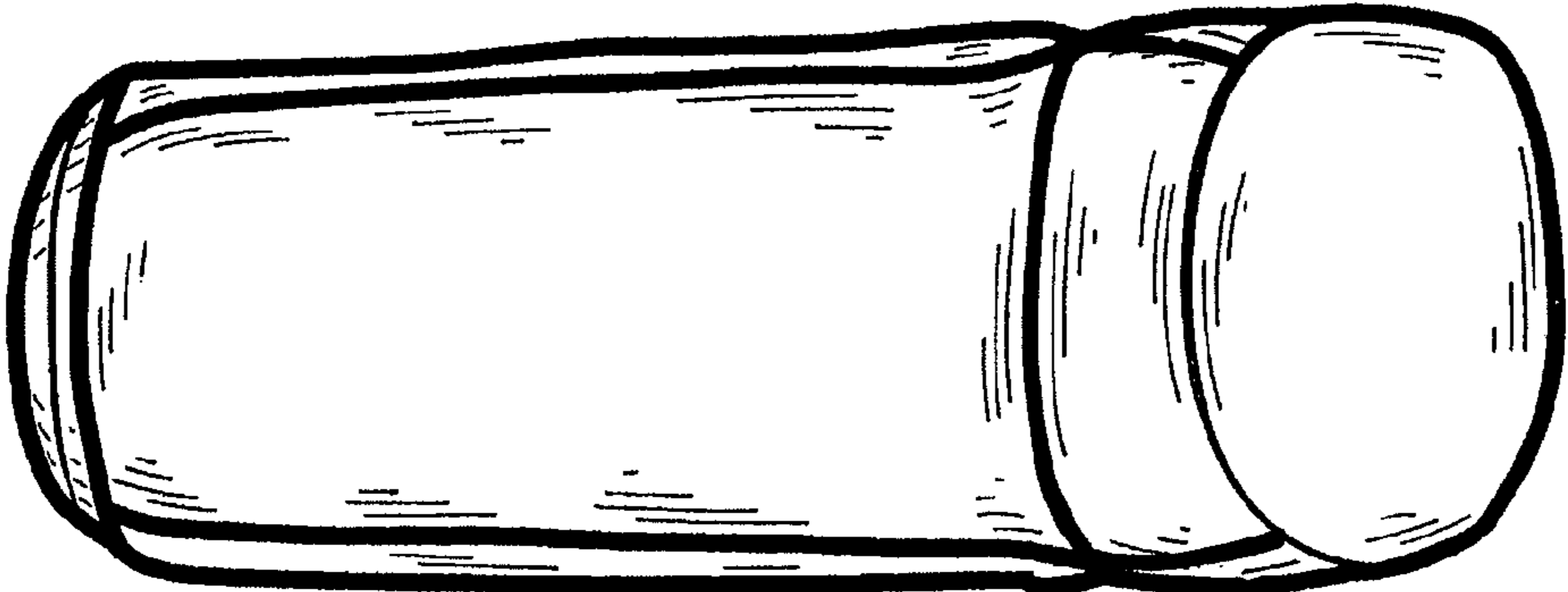
