FIG. 3 is a front perspective view of the dilator of FIG. 1.

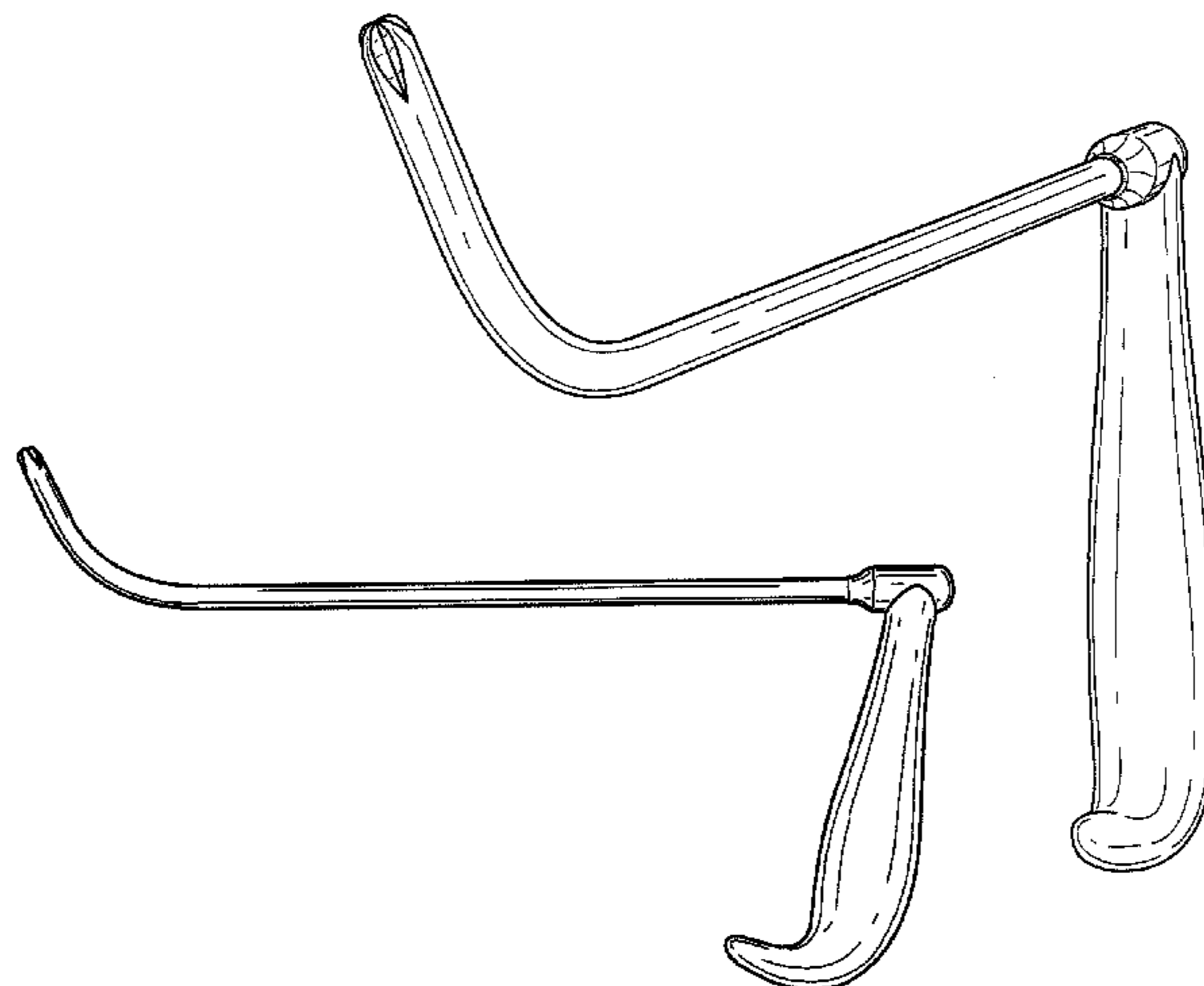
FIG. 4 is a rear perspective view of the dilator of FIG. 1.

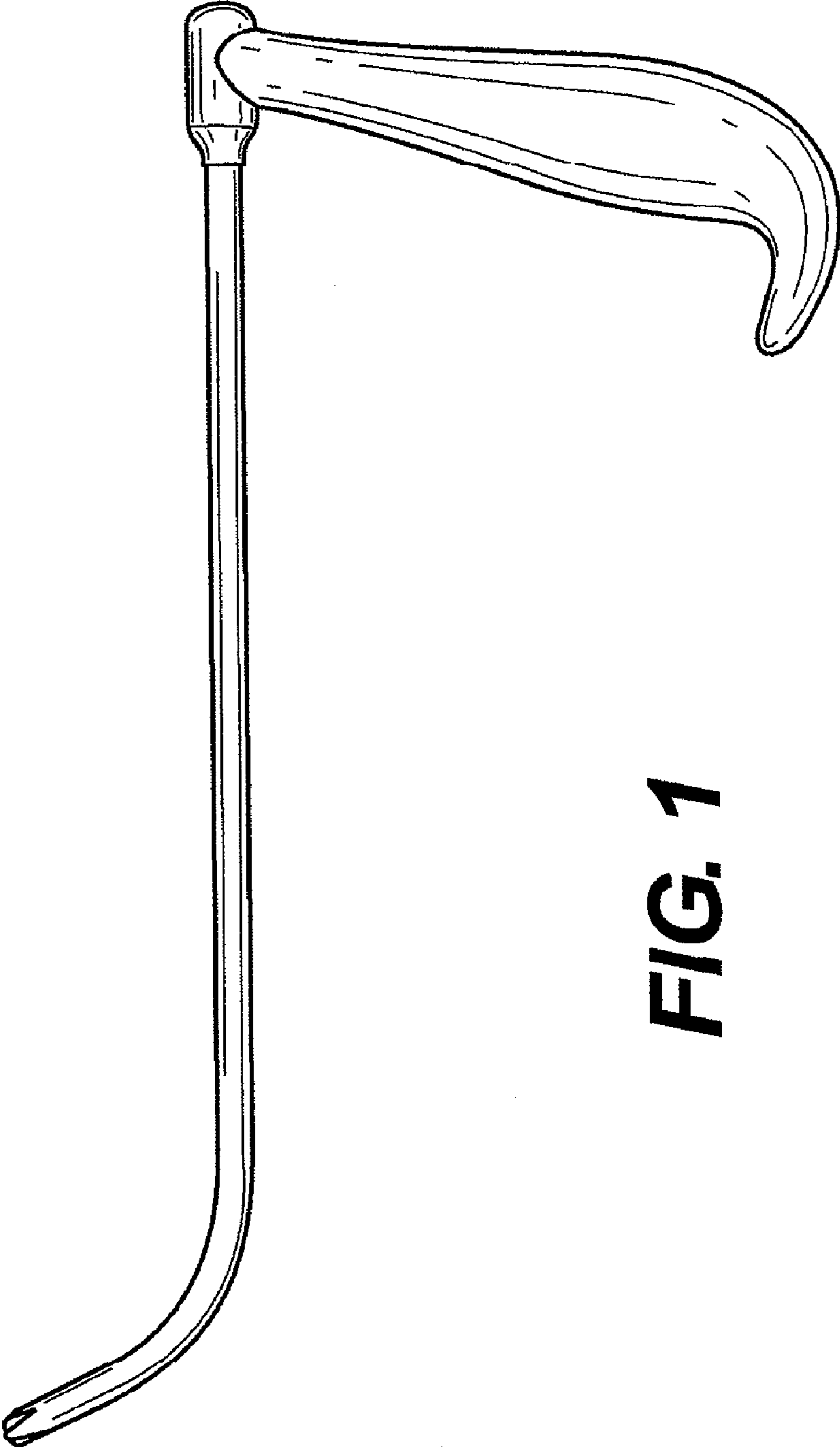

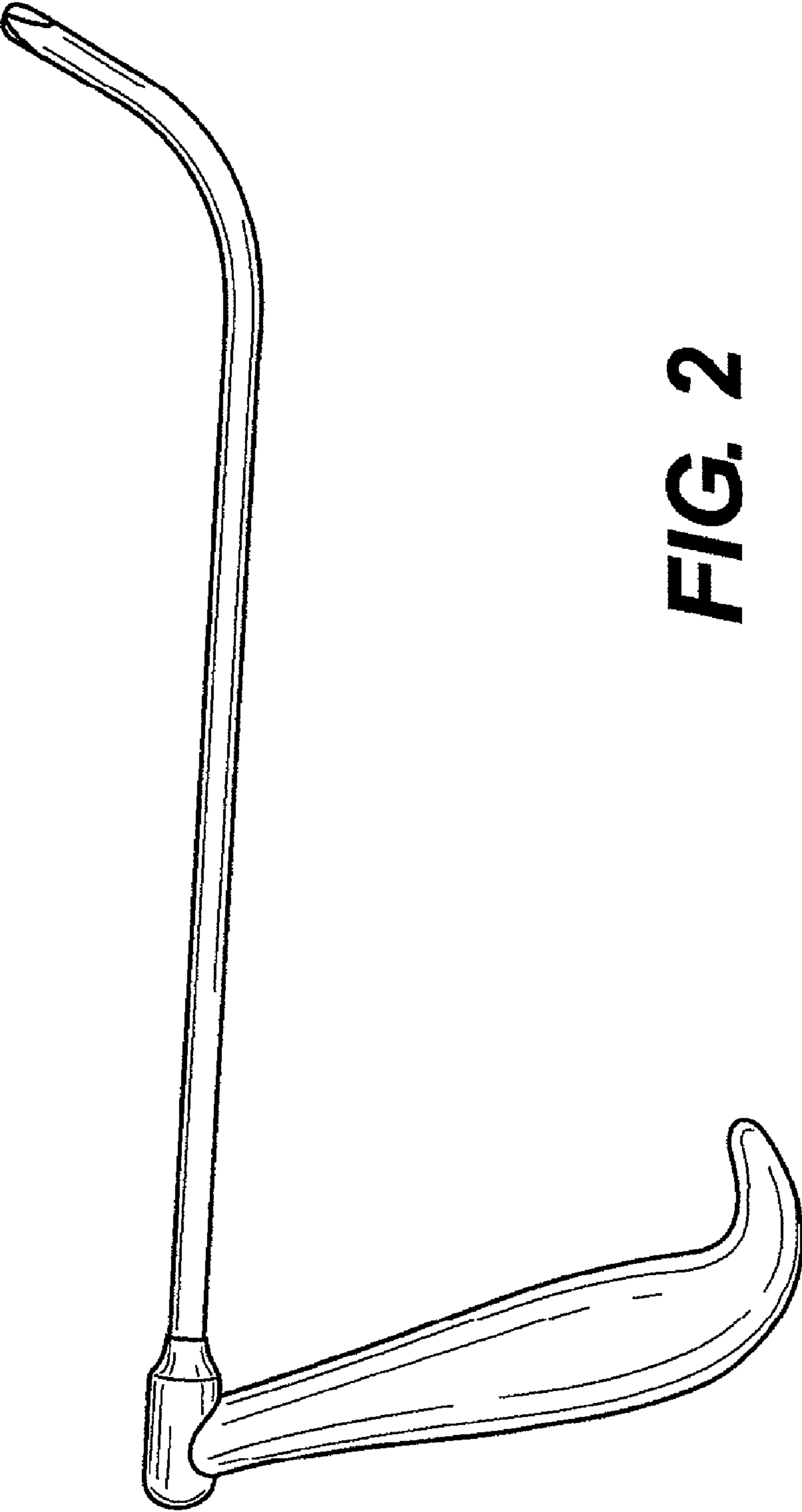

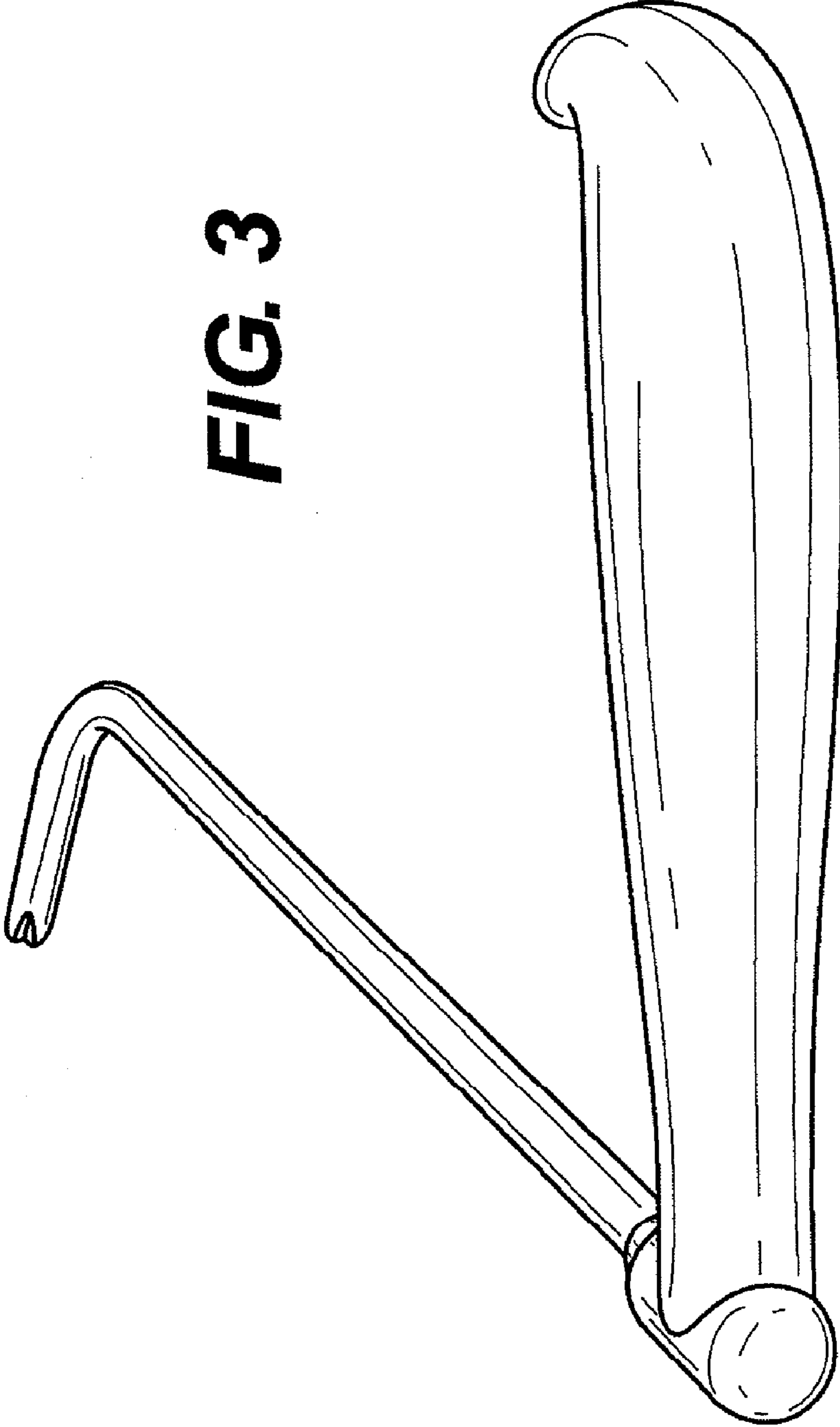

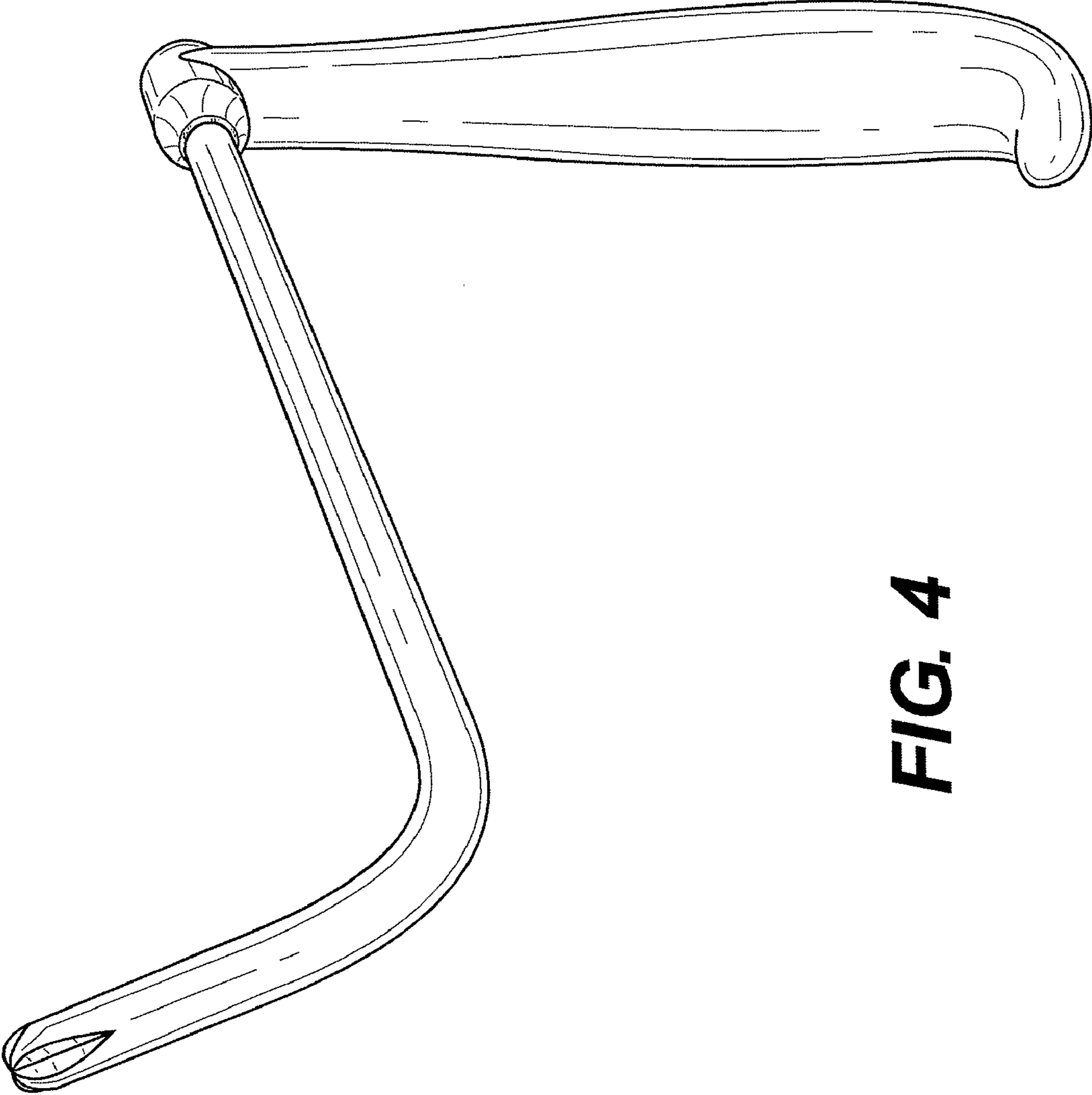

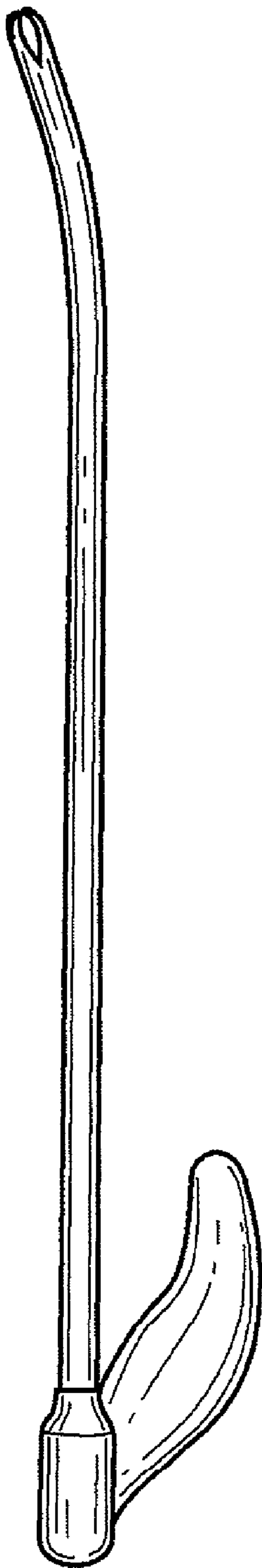

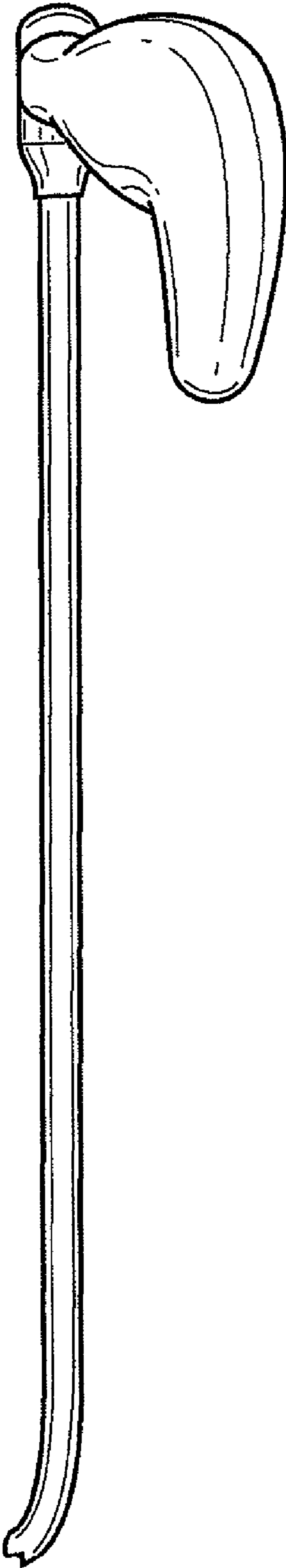

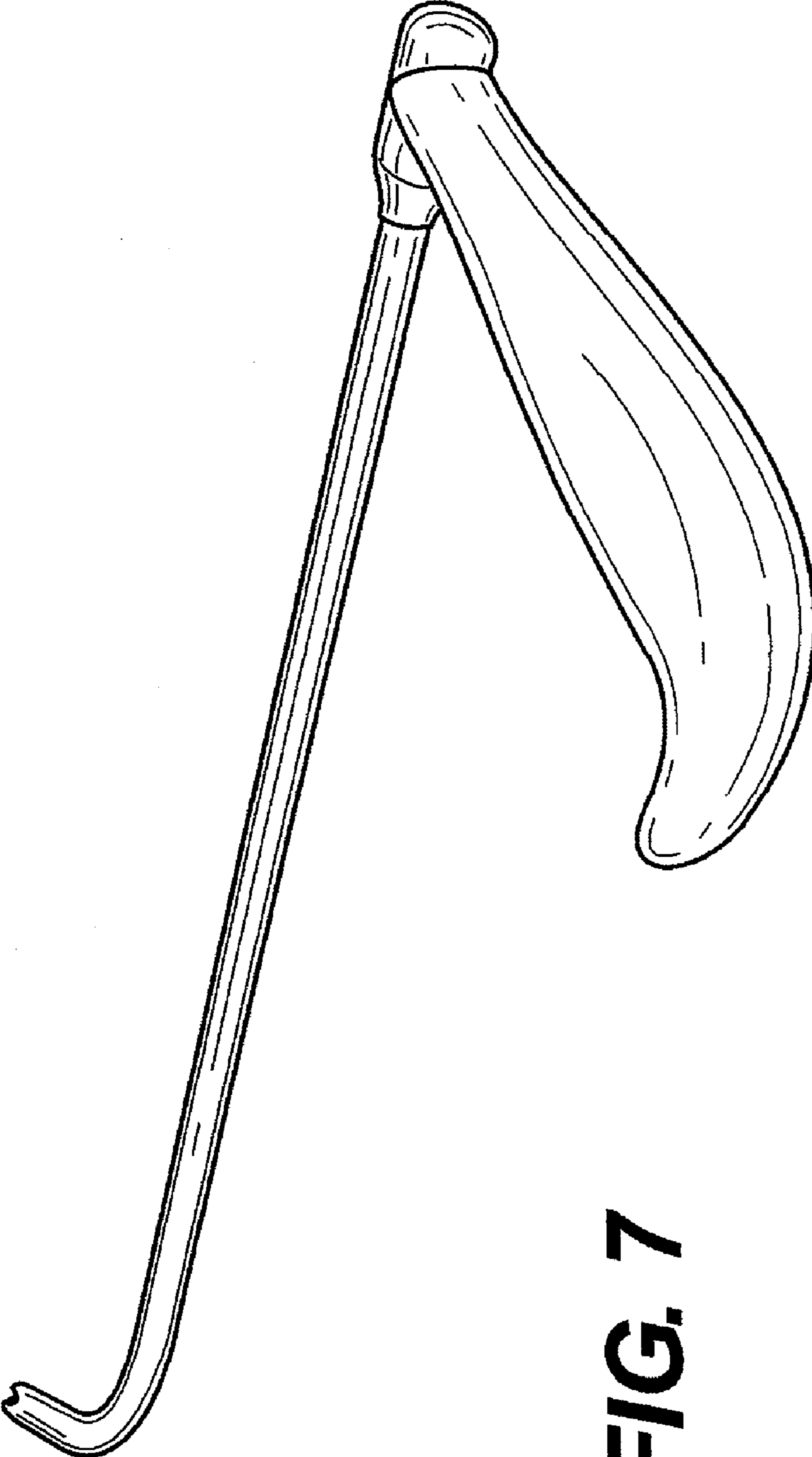
