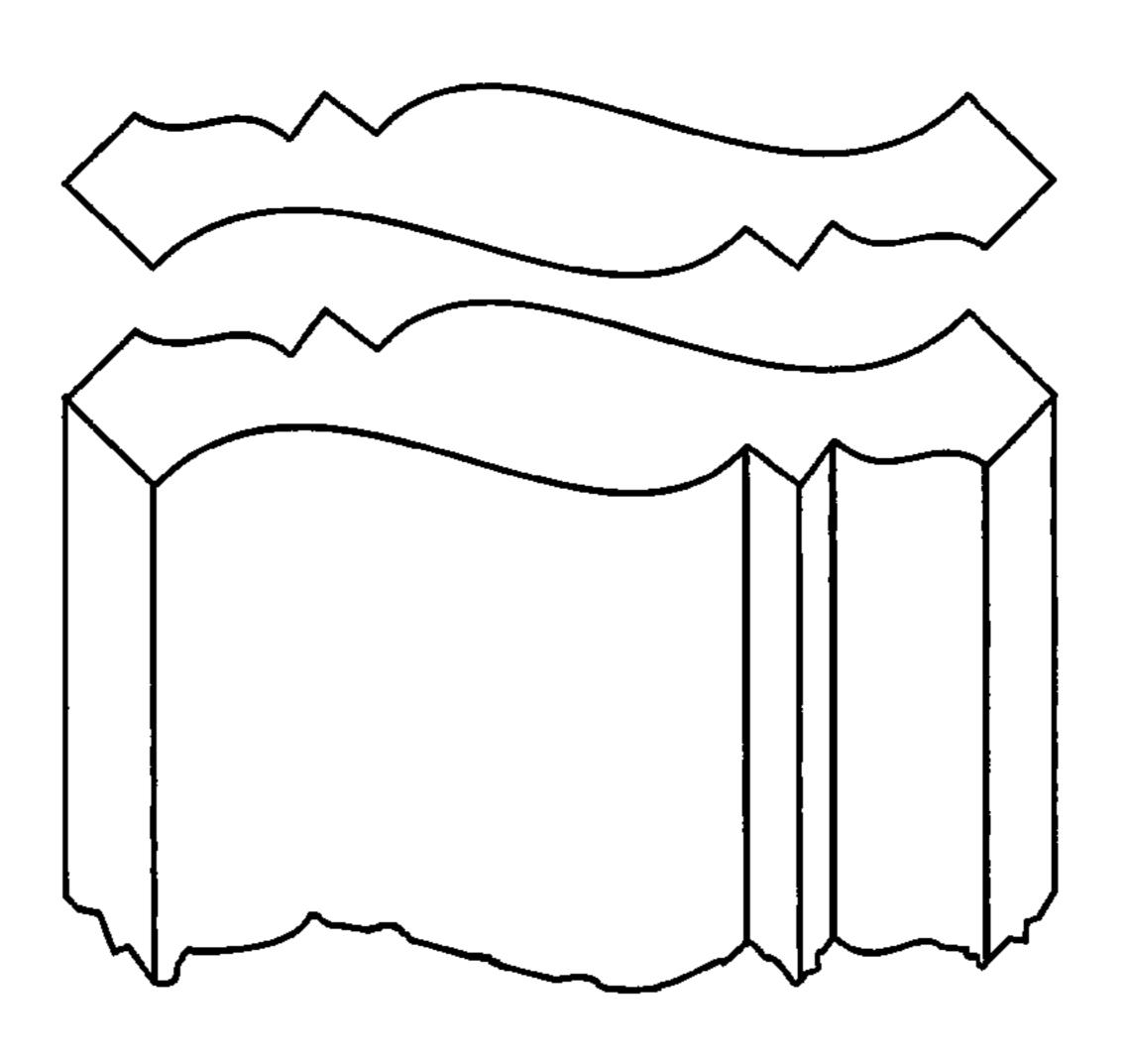

(57) CLAIM

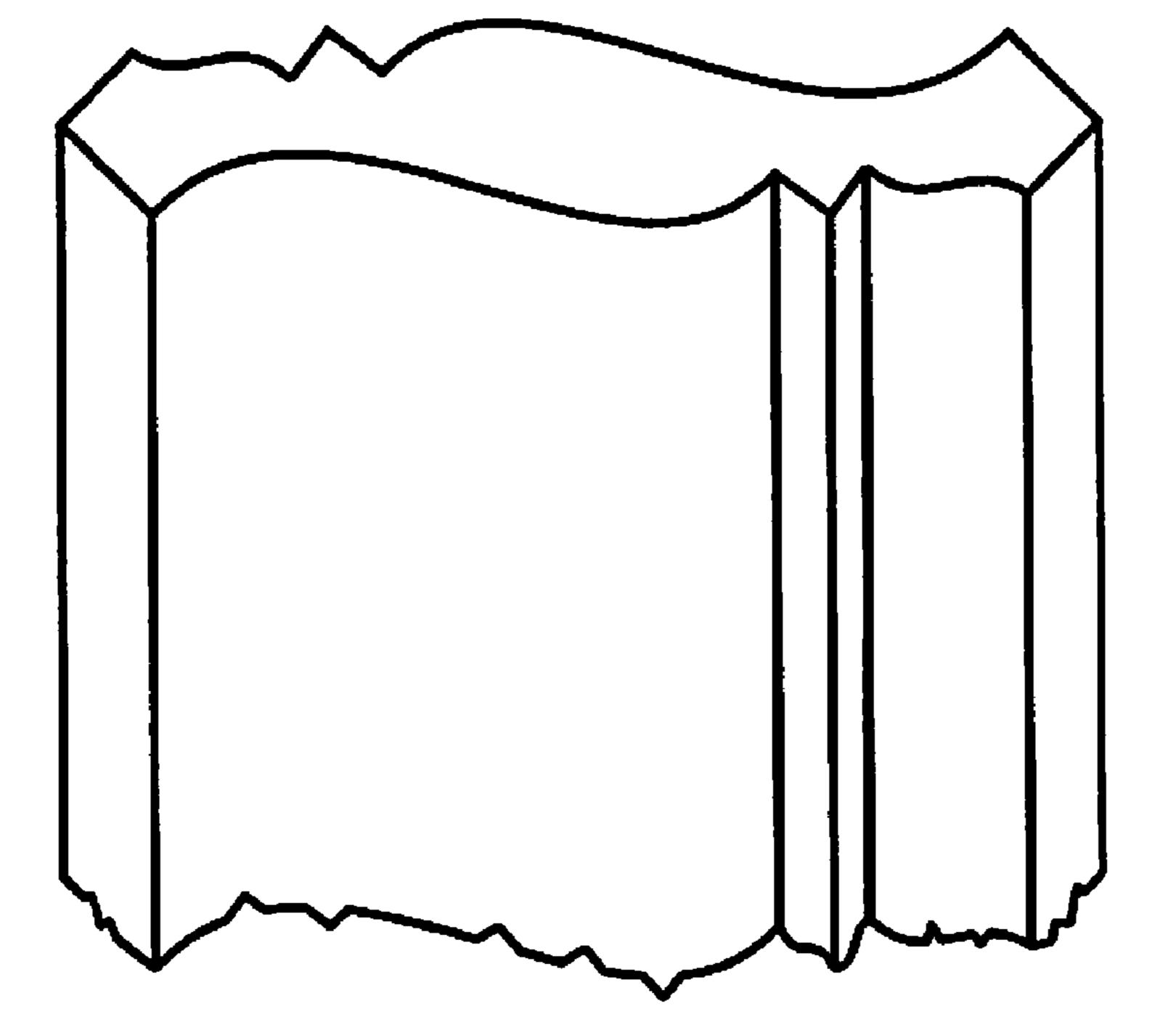
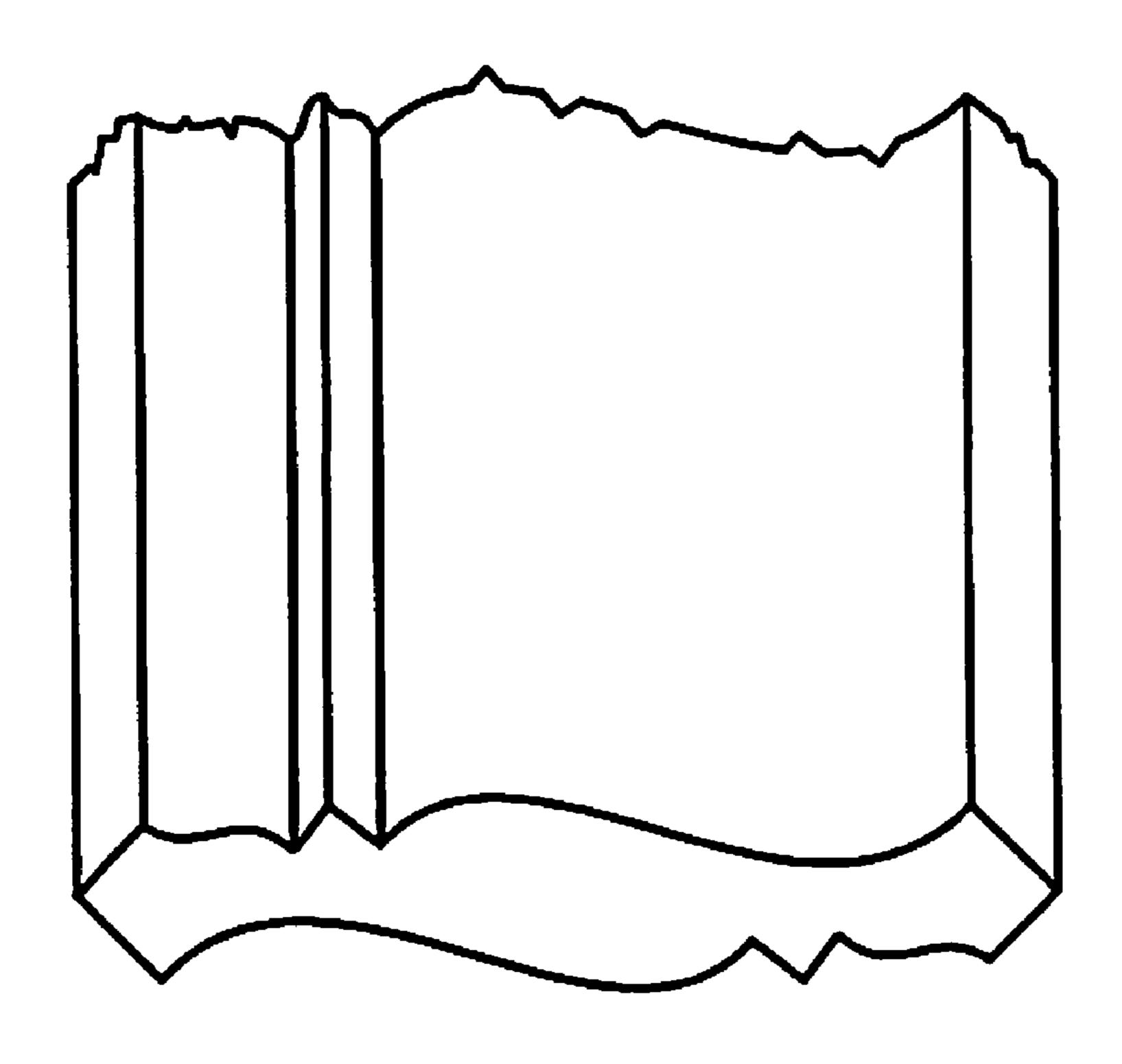
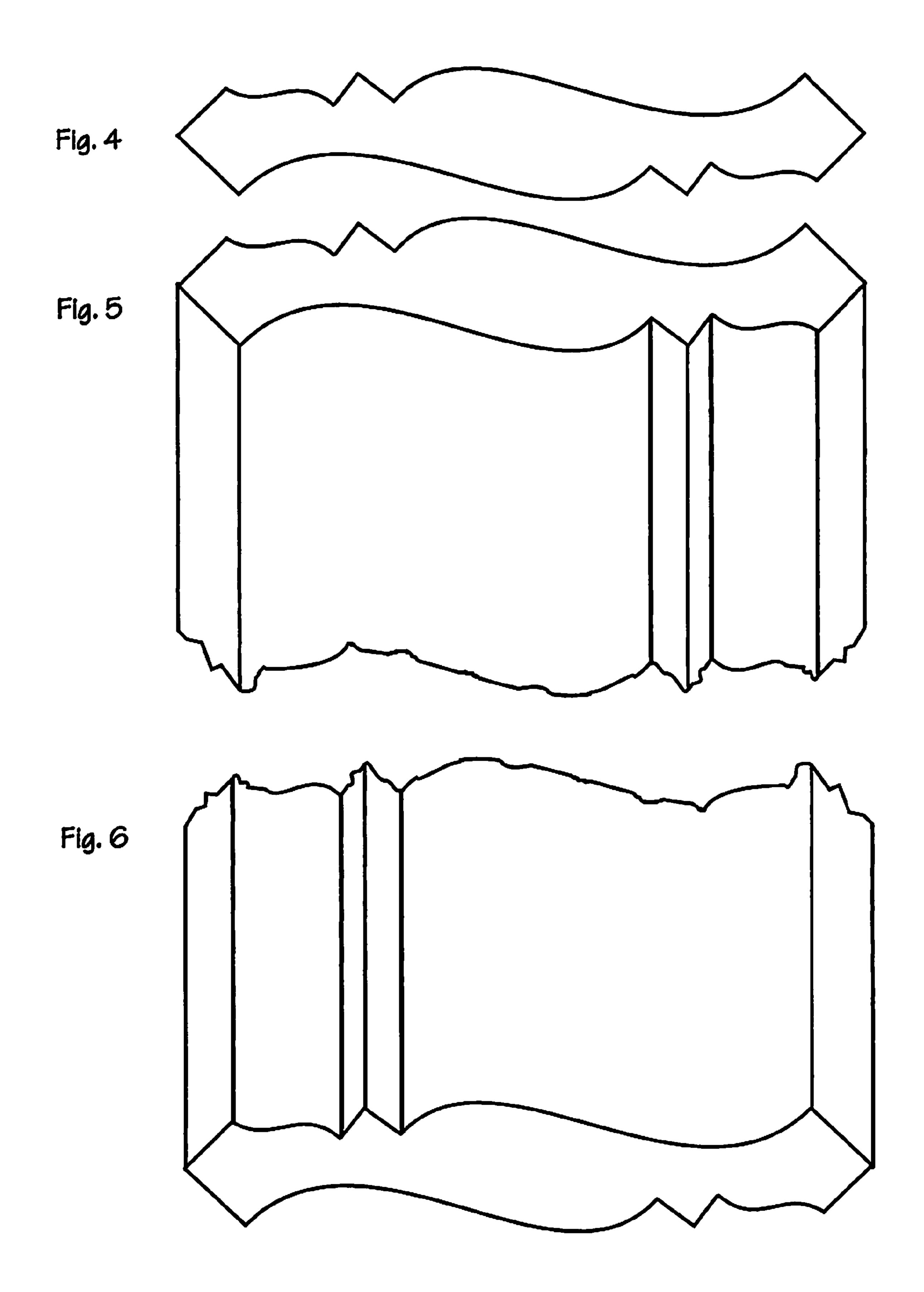
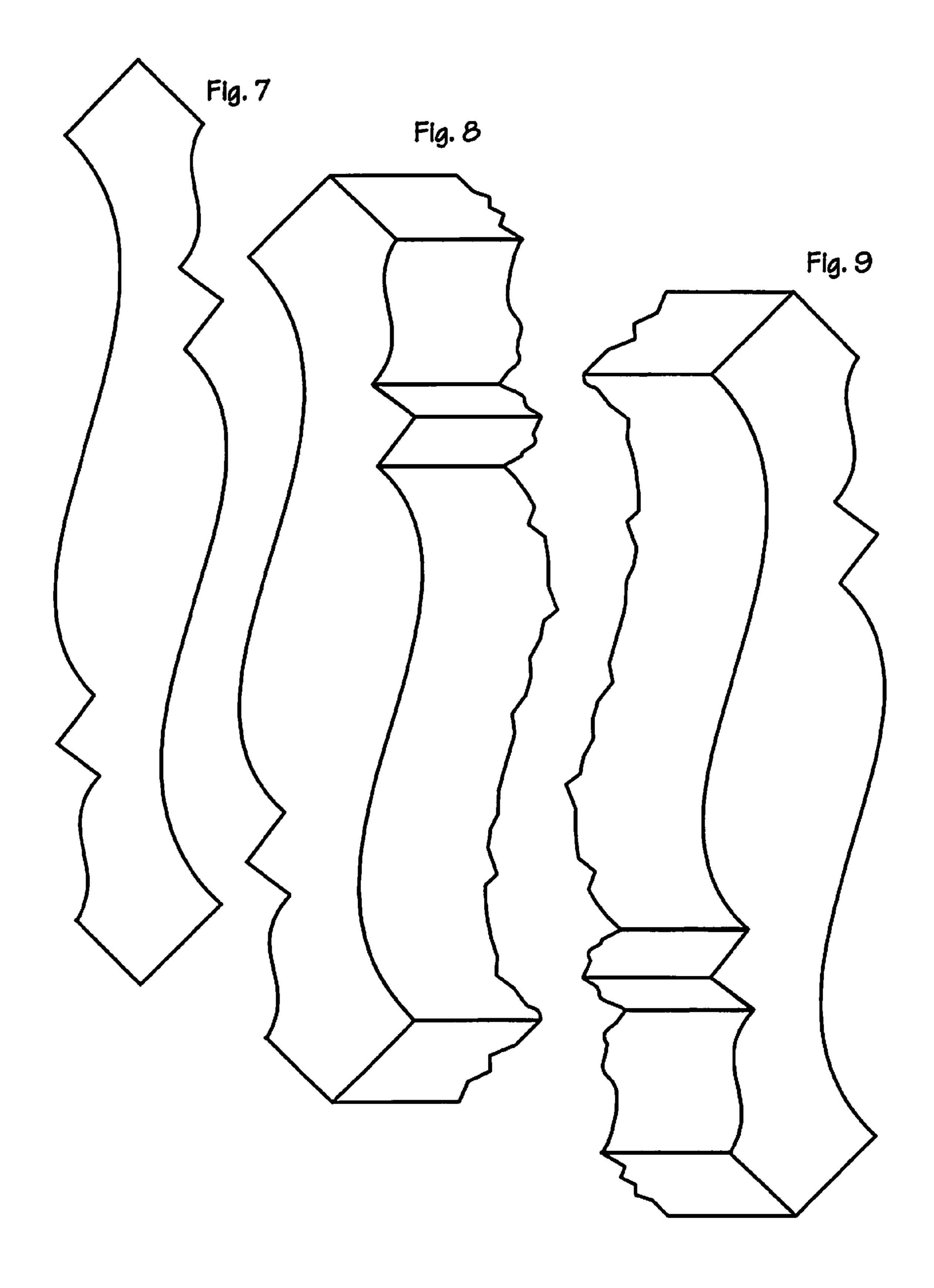


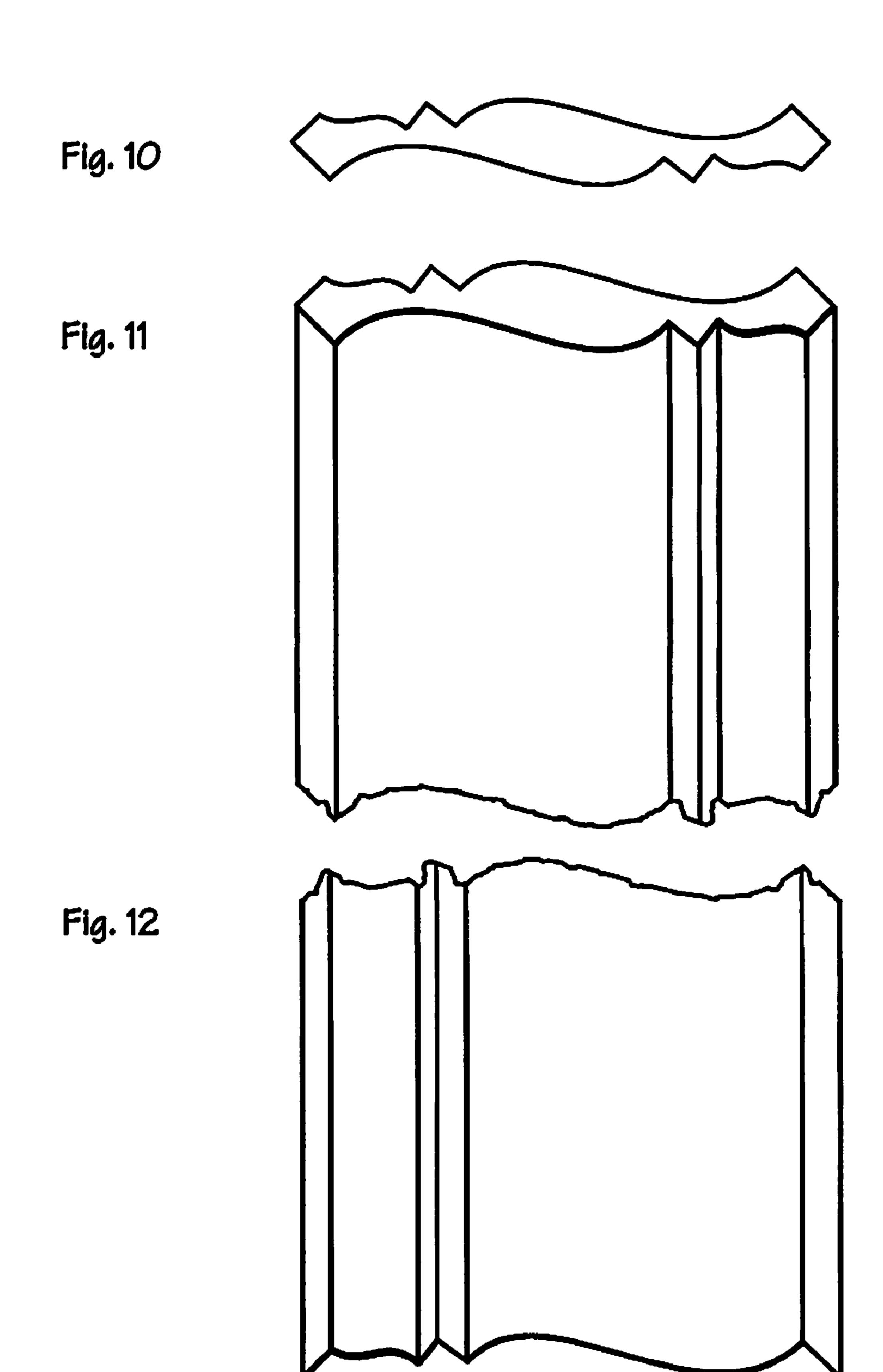

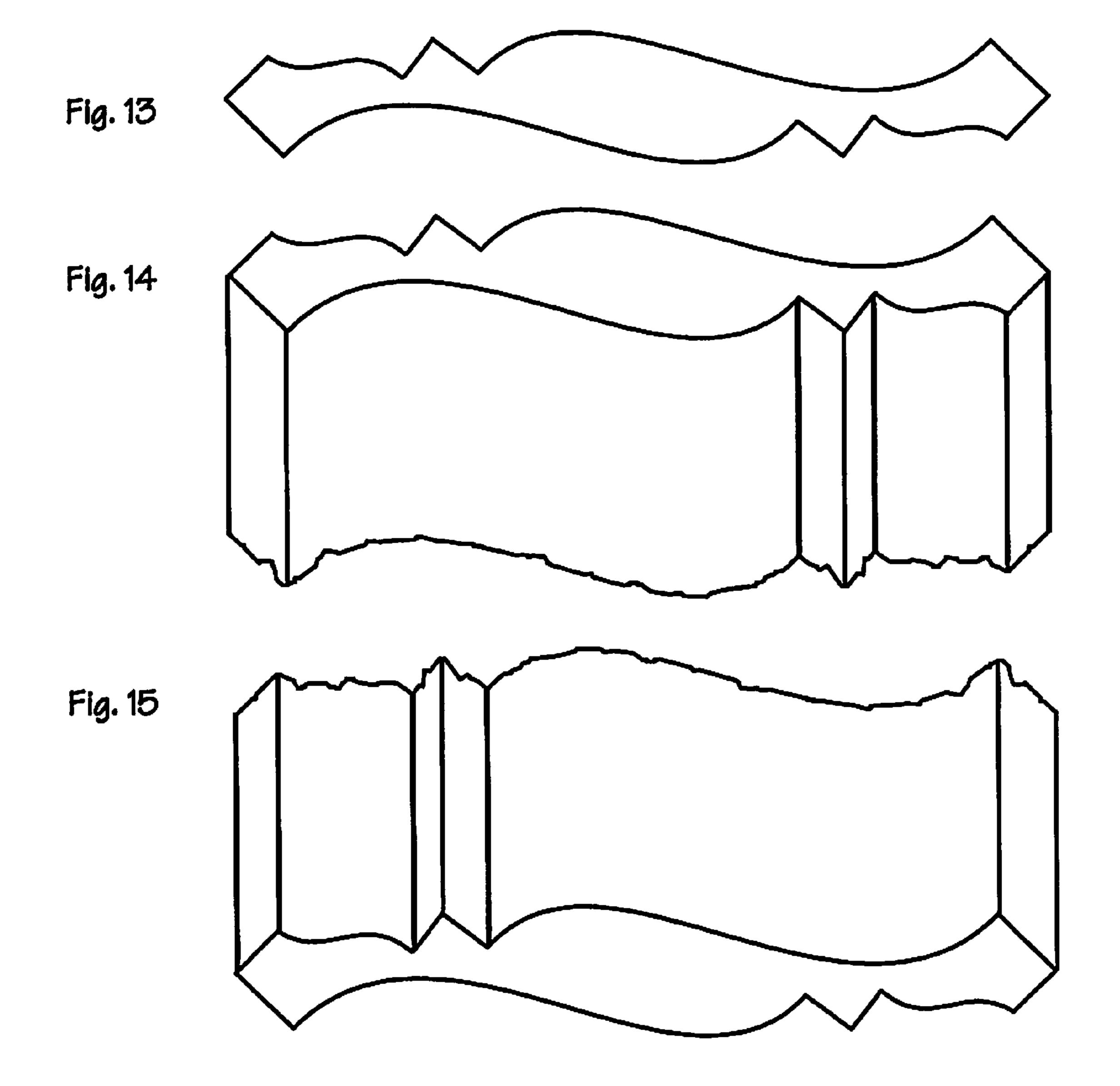












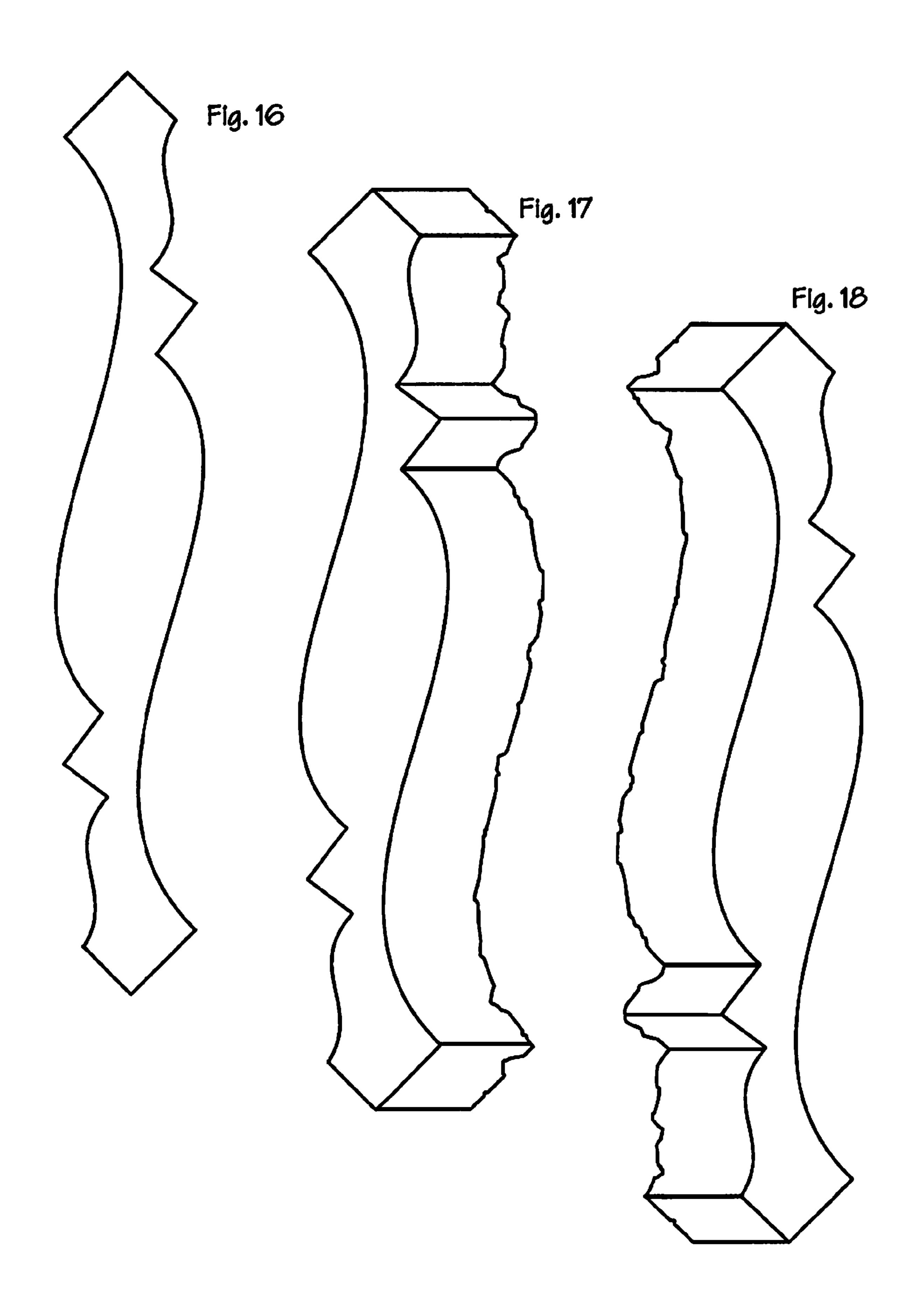

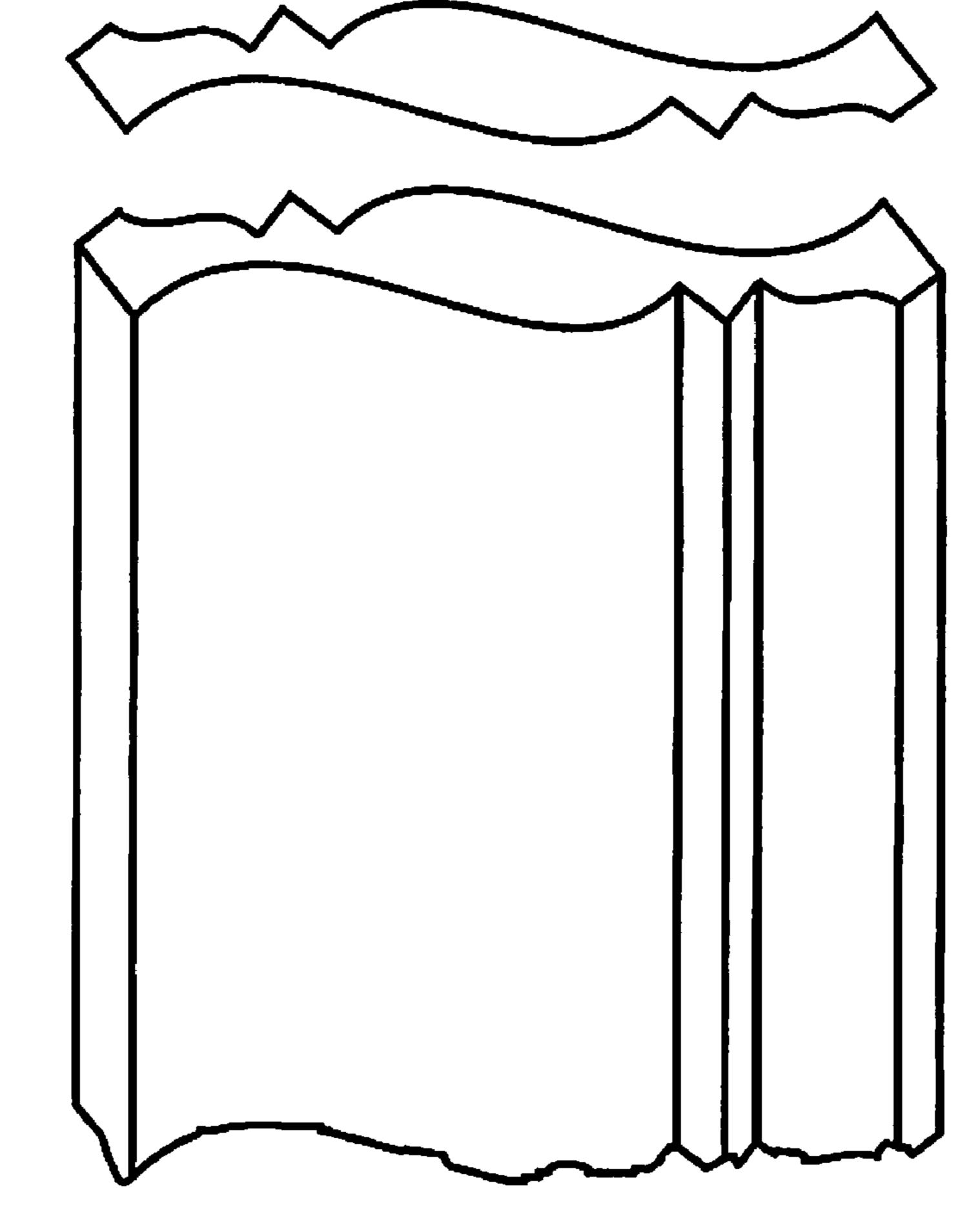
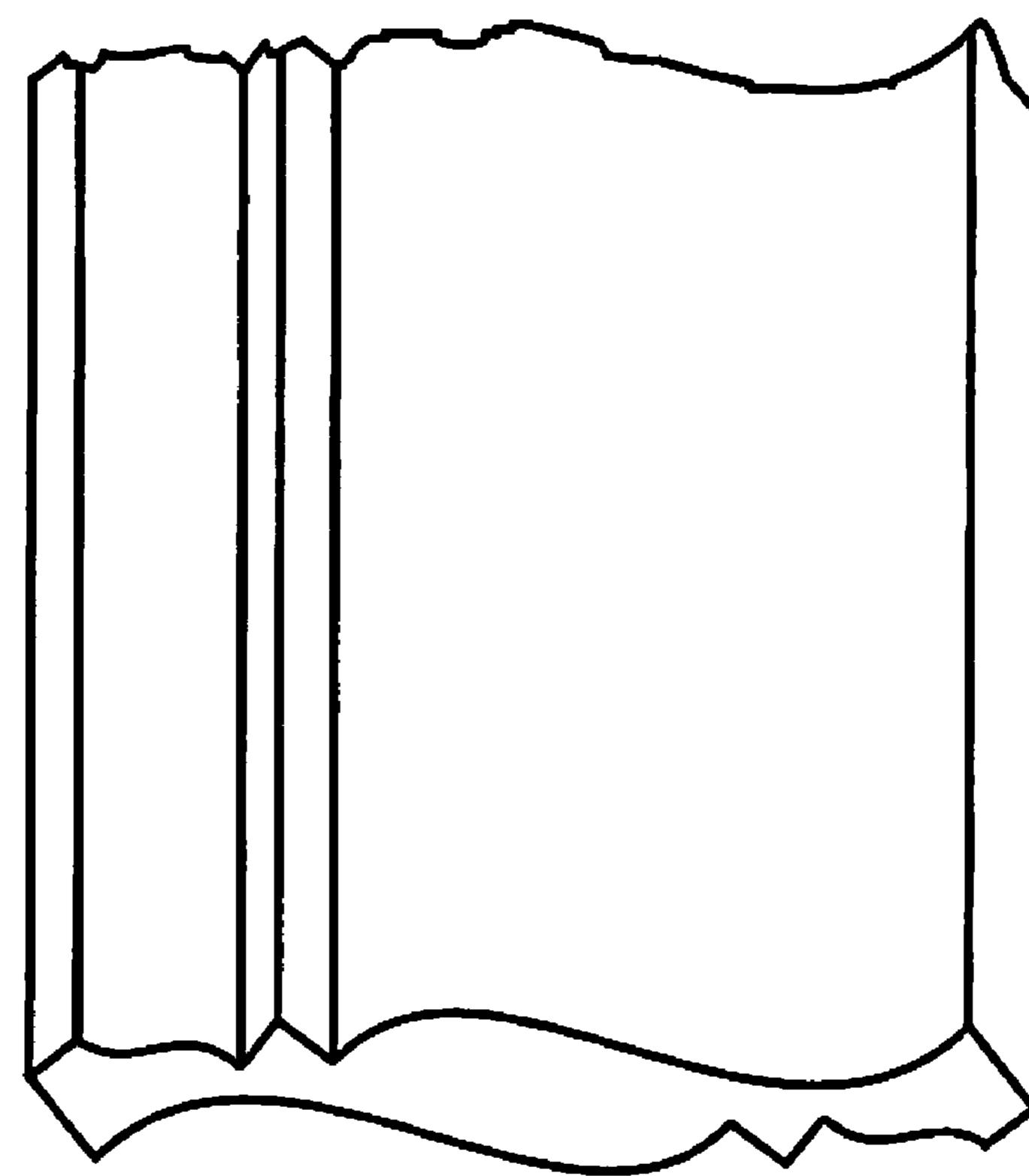
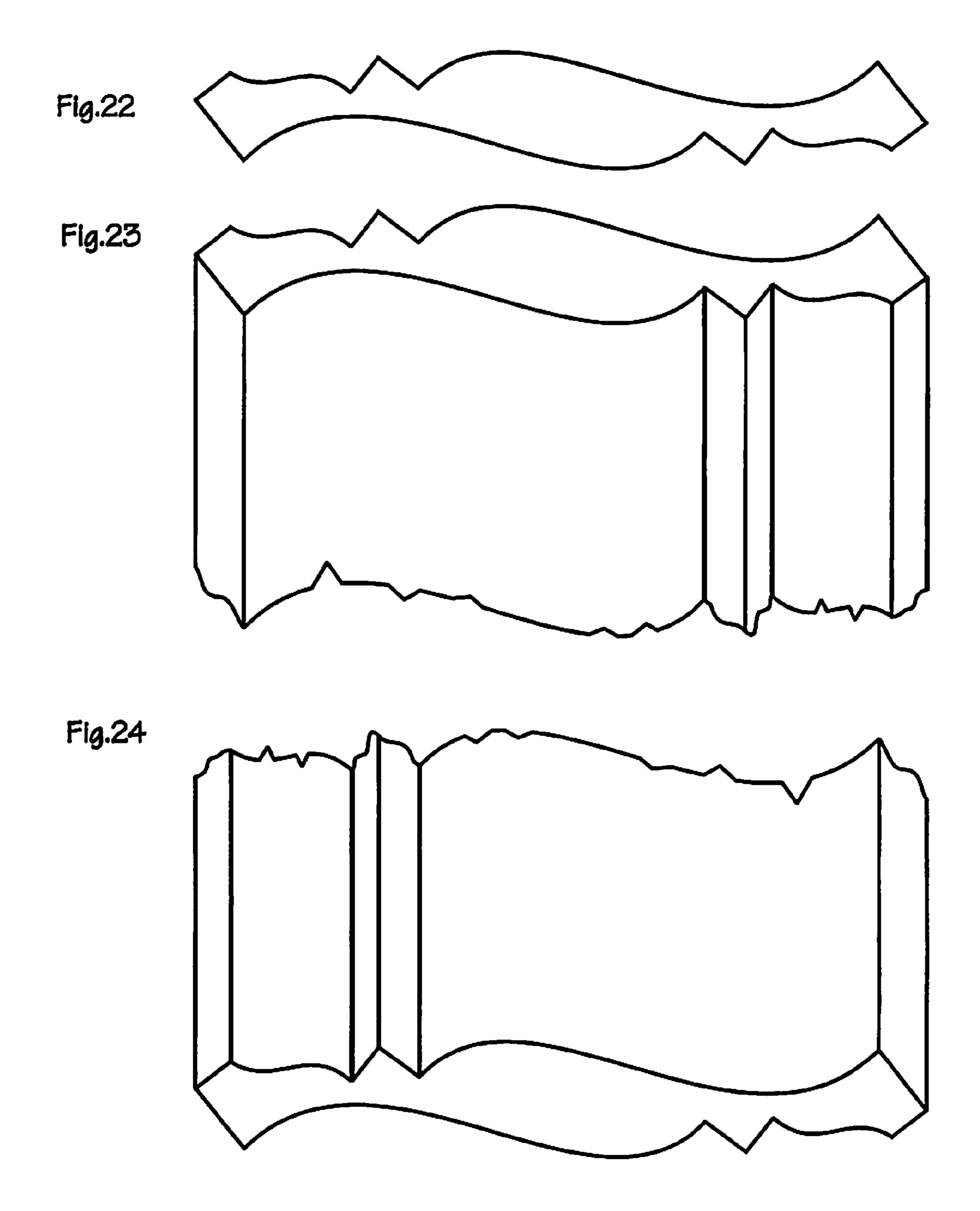

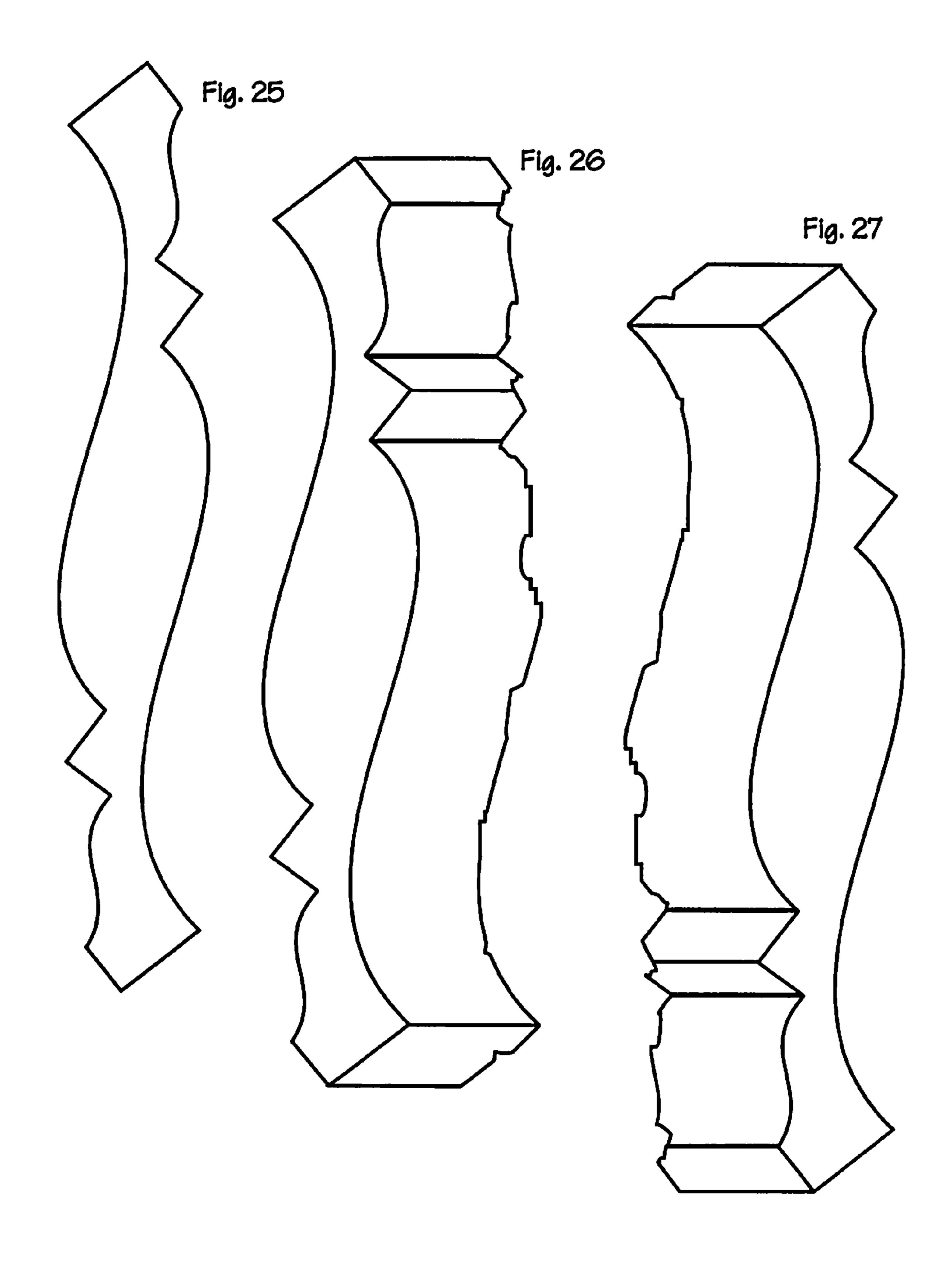

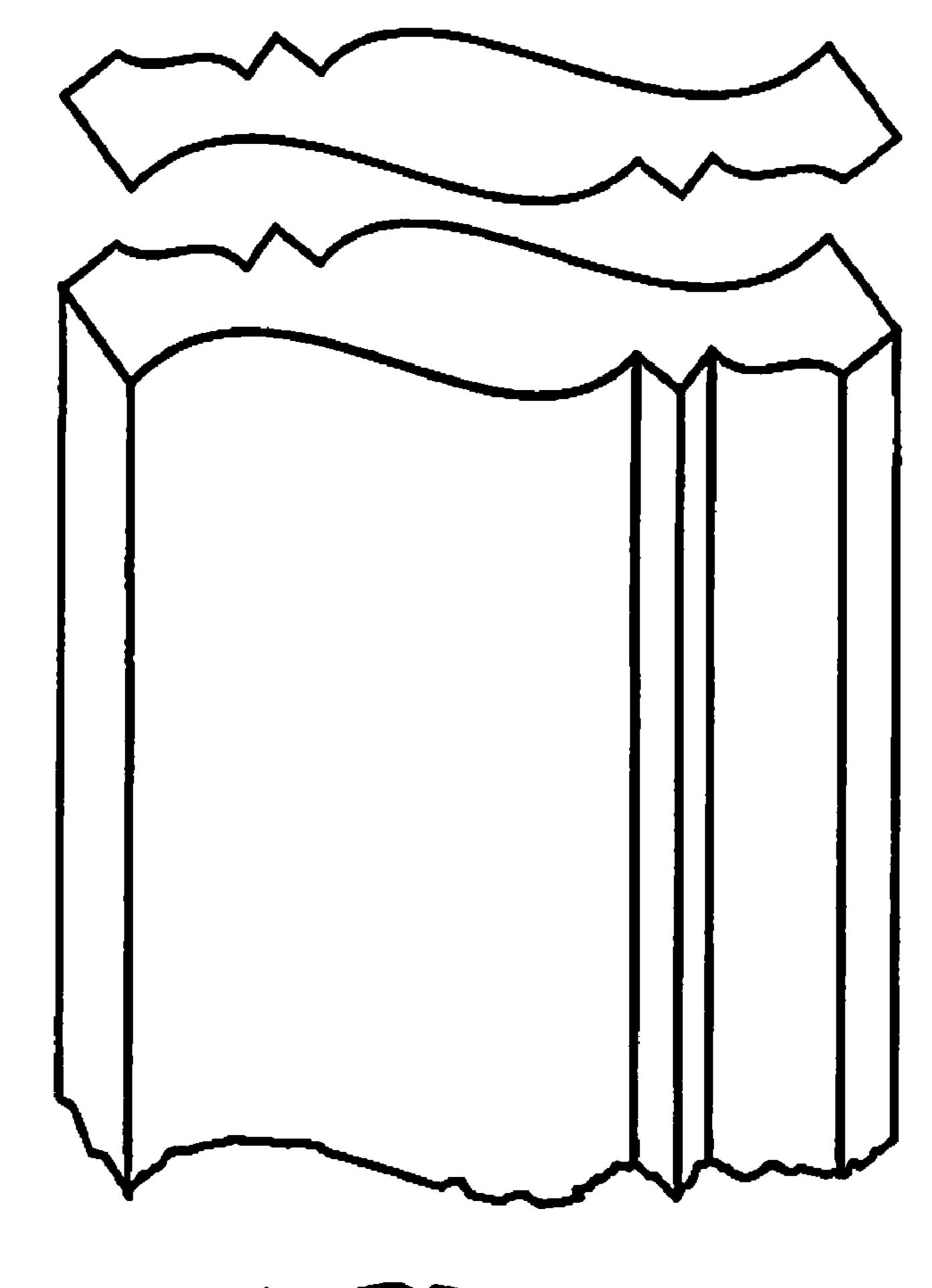
