(57) **CLAIM**

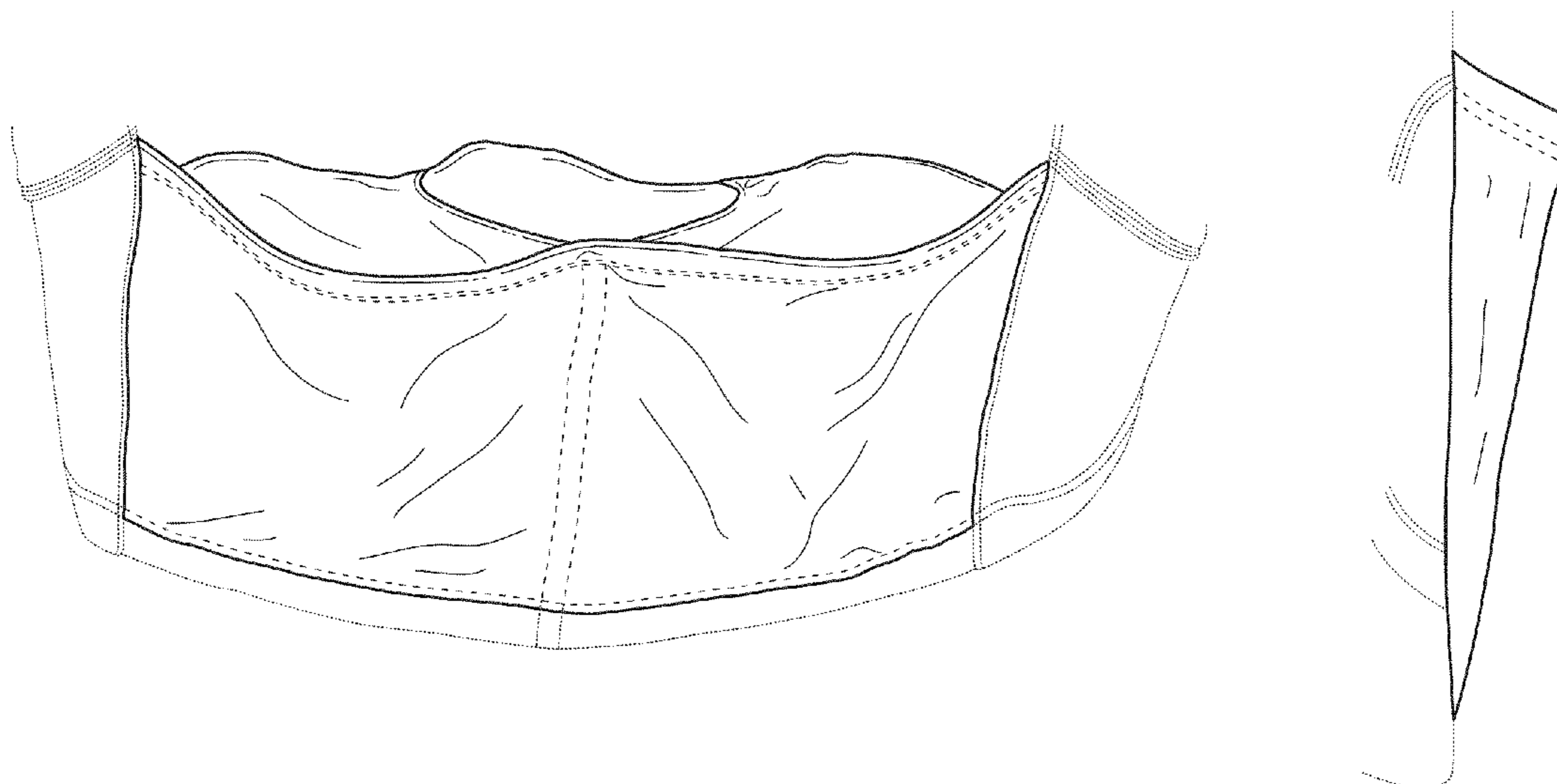
The ornamental design for jersey pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view;
FIG. 2 is a front view;
FIG. 3 is a left side view;
FIG. 4 is a right side view;
FIG. 5 is a front and top left side perspective view; and,
FIG. 6 is a front and top right side perspective view.

The portions of the inside of the pocket not visible in the accompanying drawings form no part of the claimed design. The broken lines on the surface of the pocket, in FIGS. 1-6, represent stitching. The remaining broken lines, shown throughout the views, illustrate environmental structure and form no part of the claimed design.

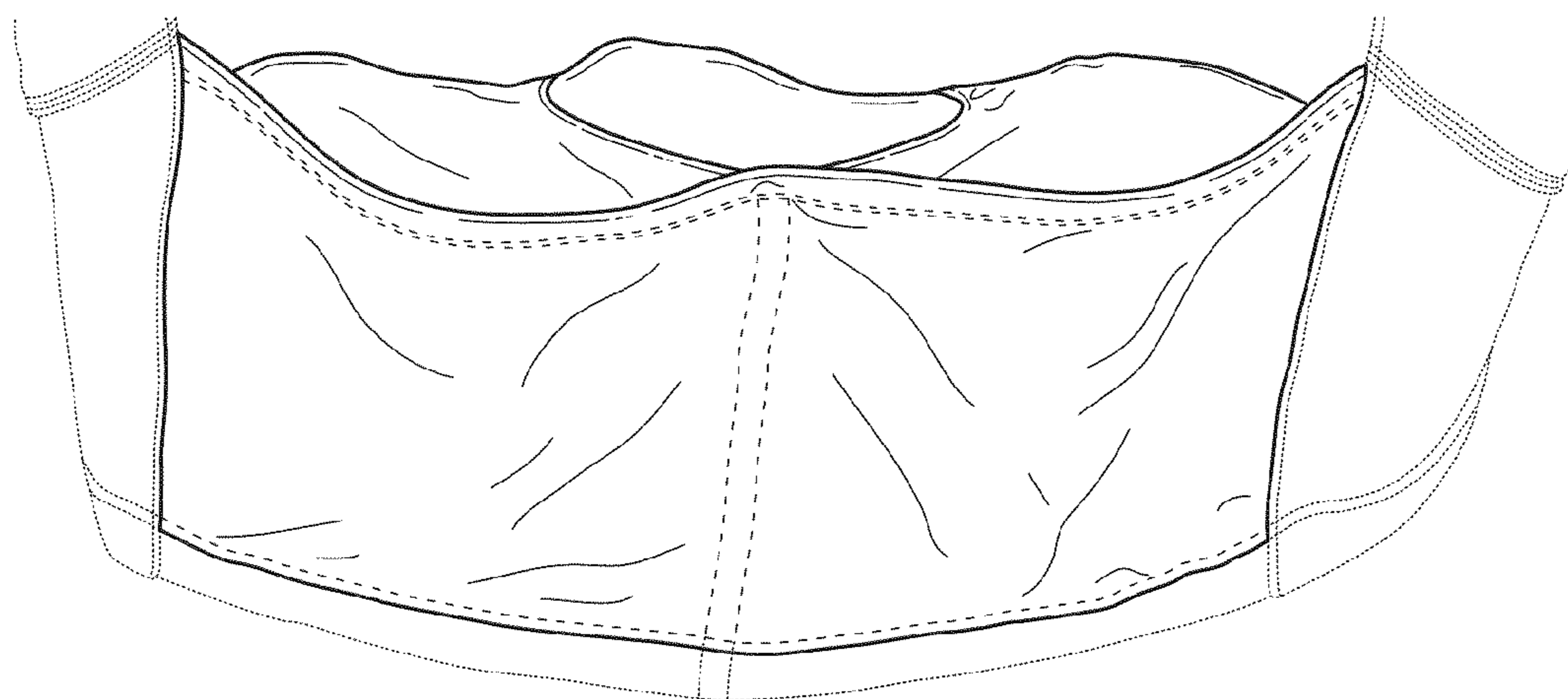

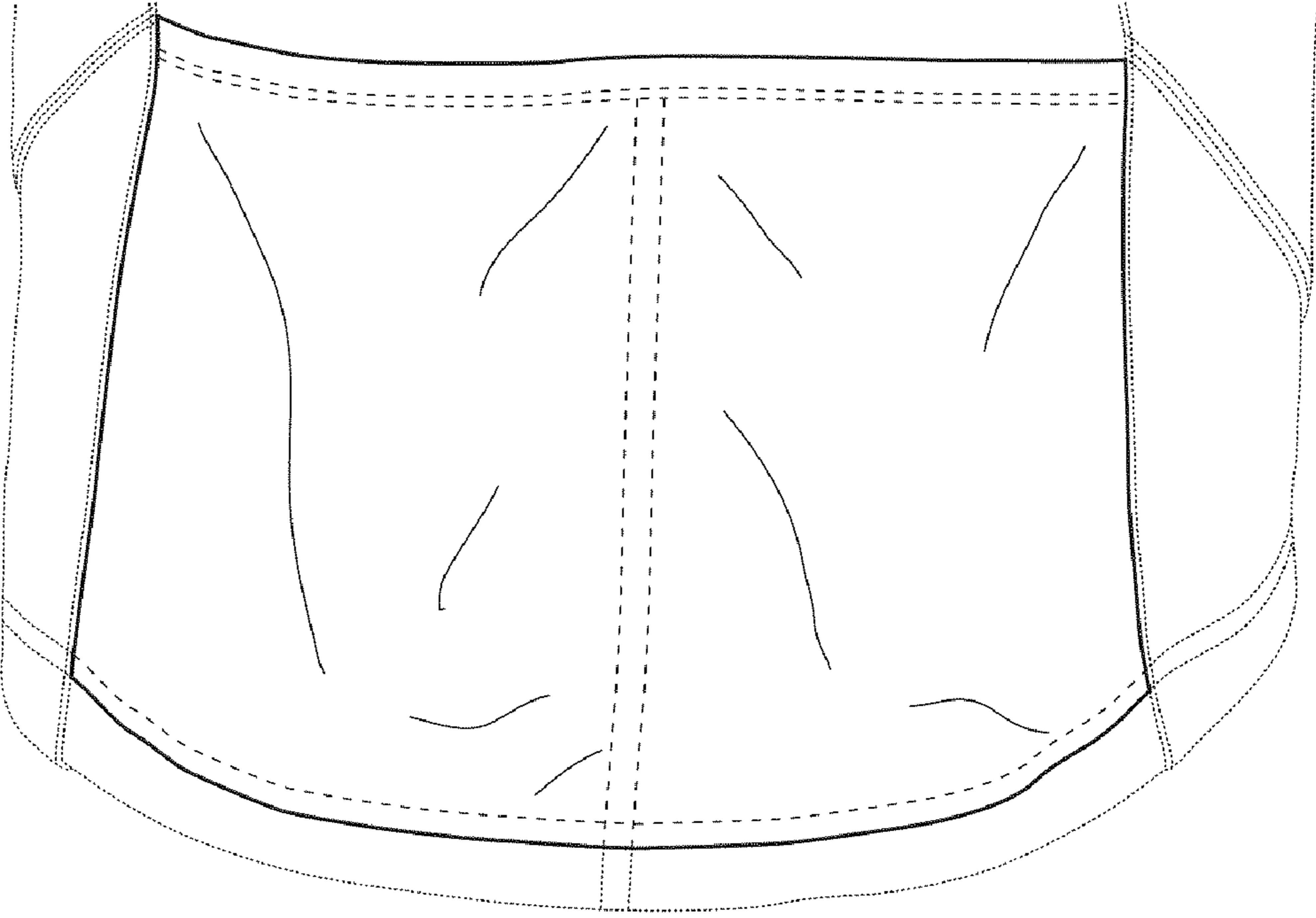

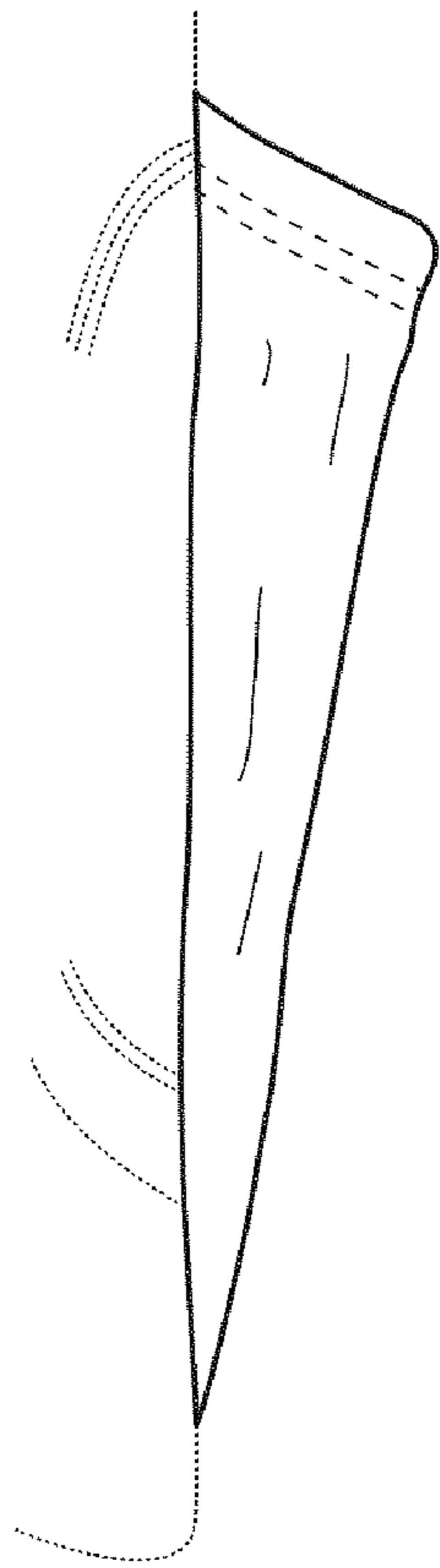

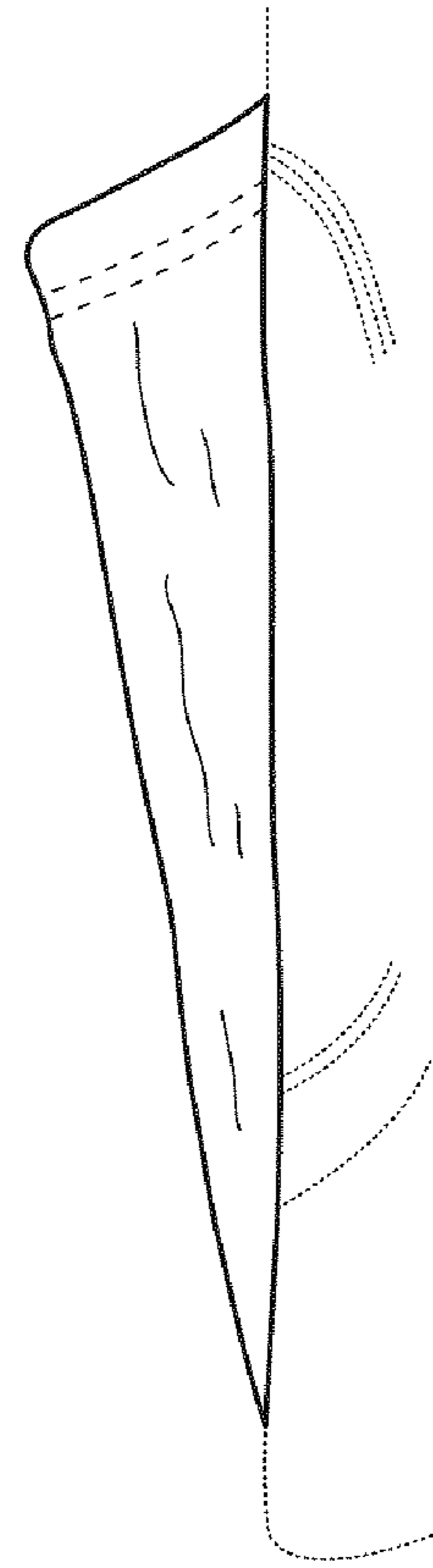

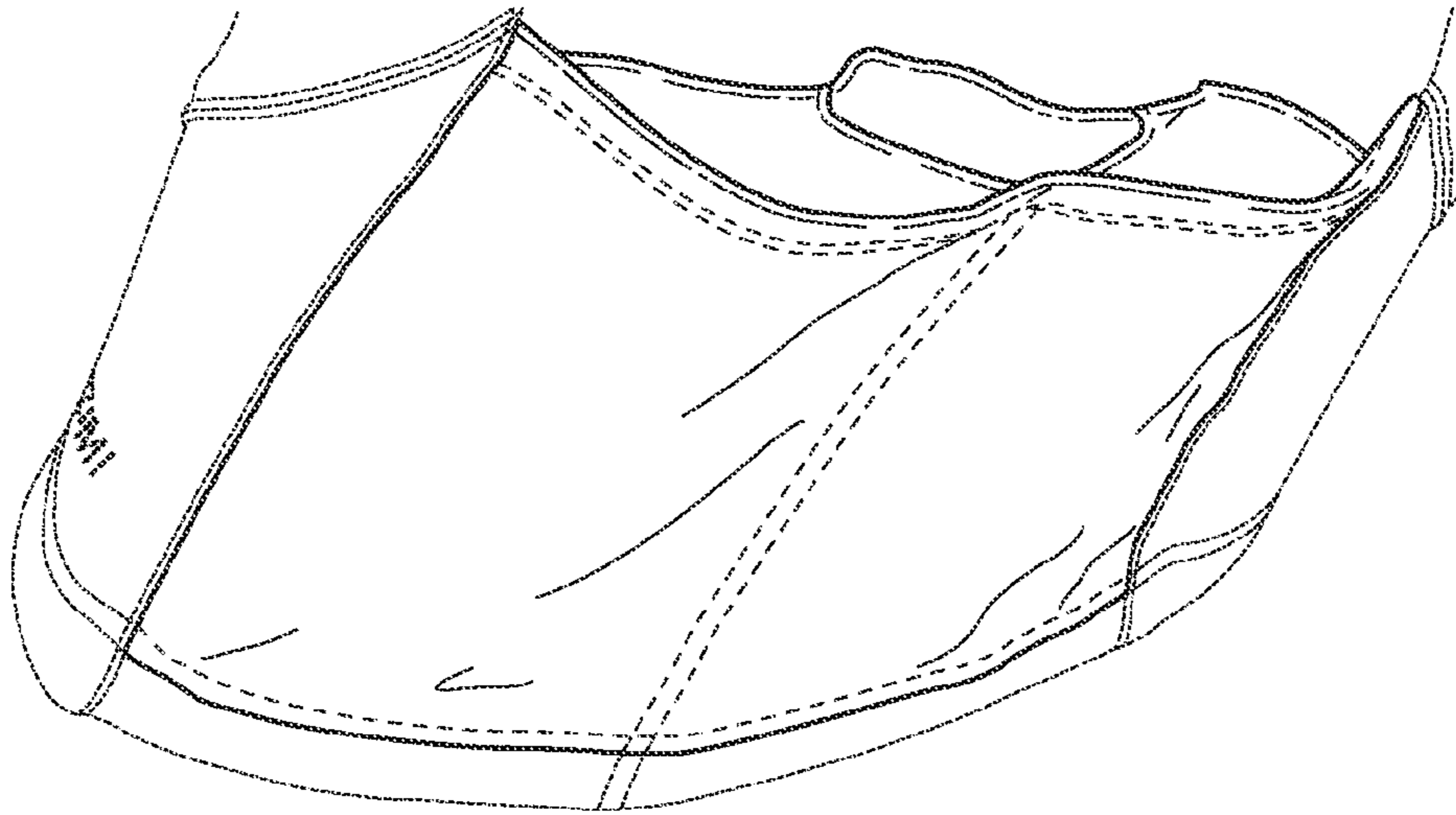

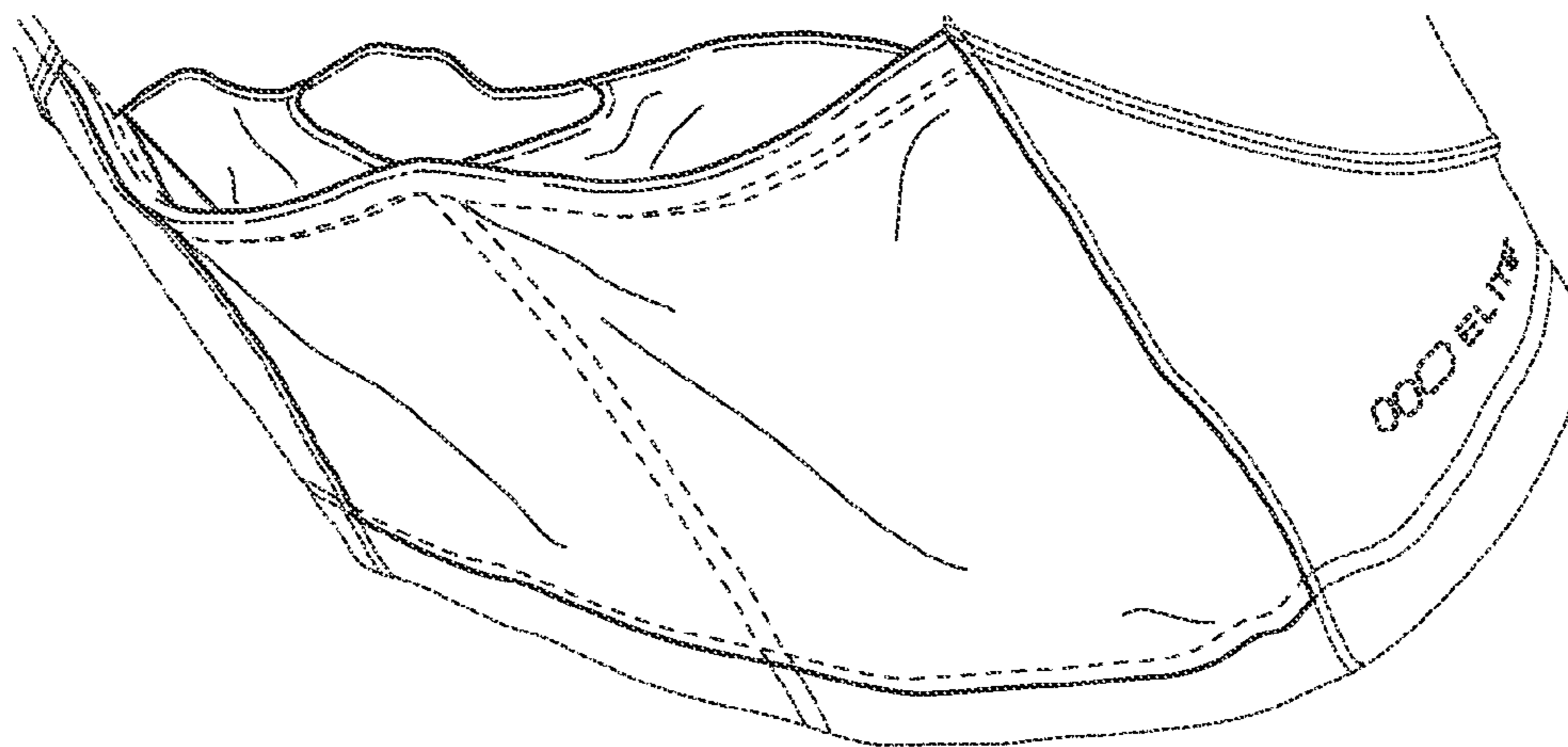
