FIG. 2: Left side elevation (the right side is identical except without the side handle);

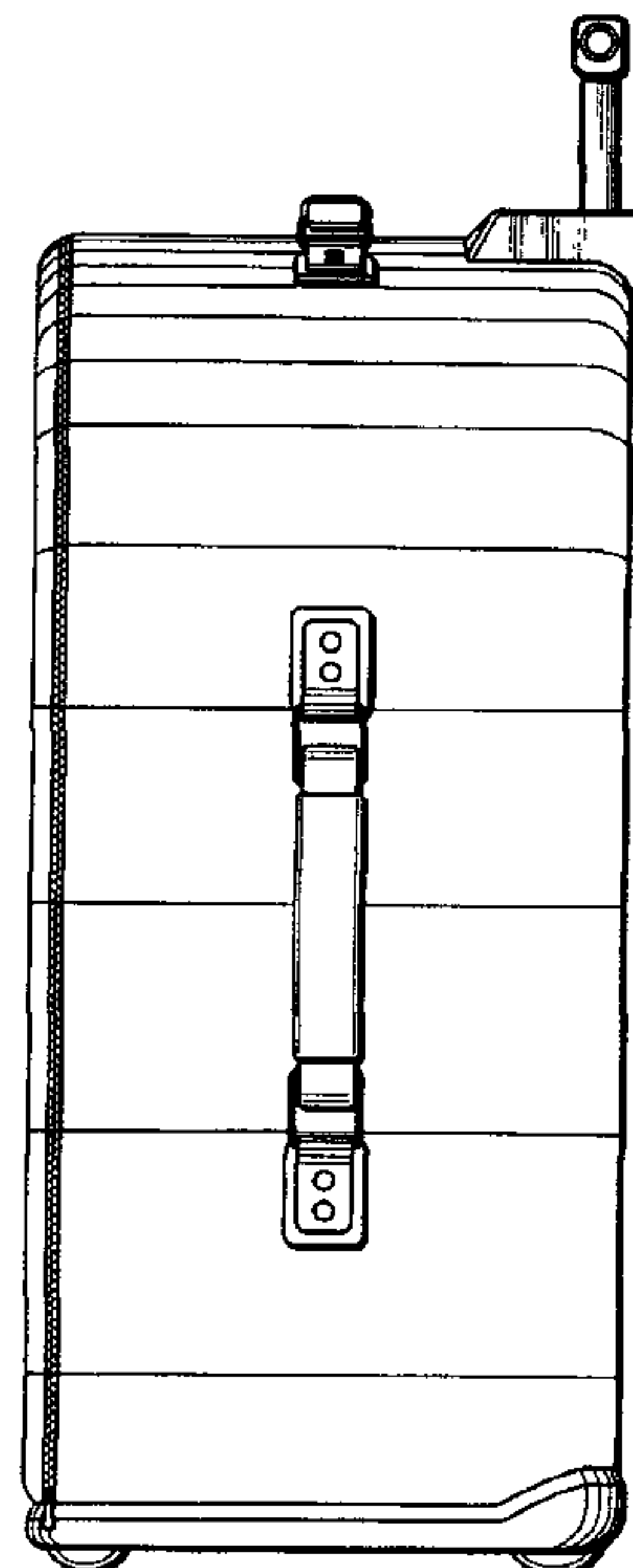
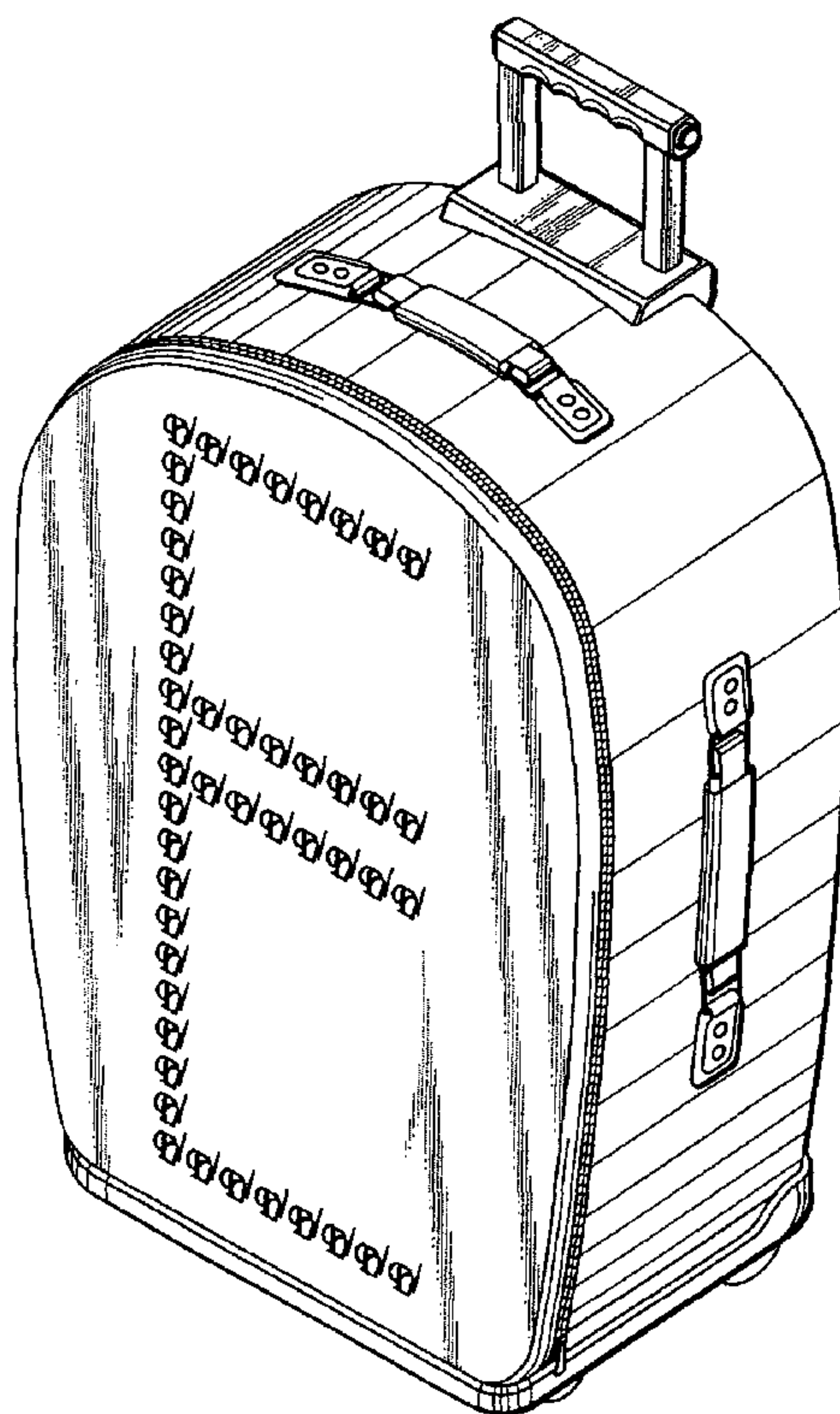
FIG. 3: Front elevation;

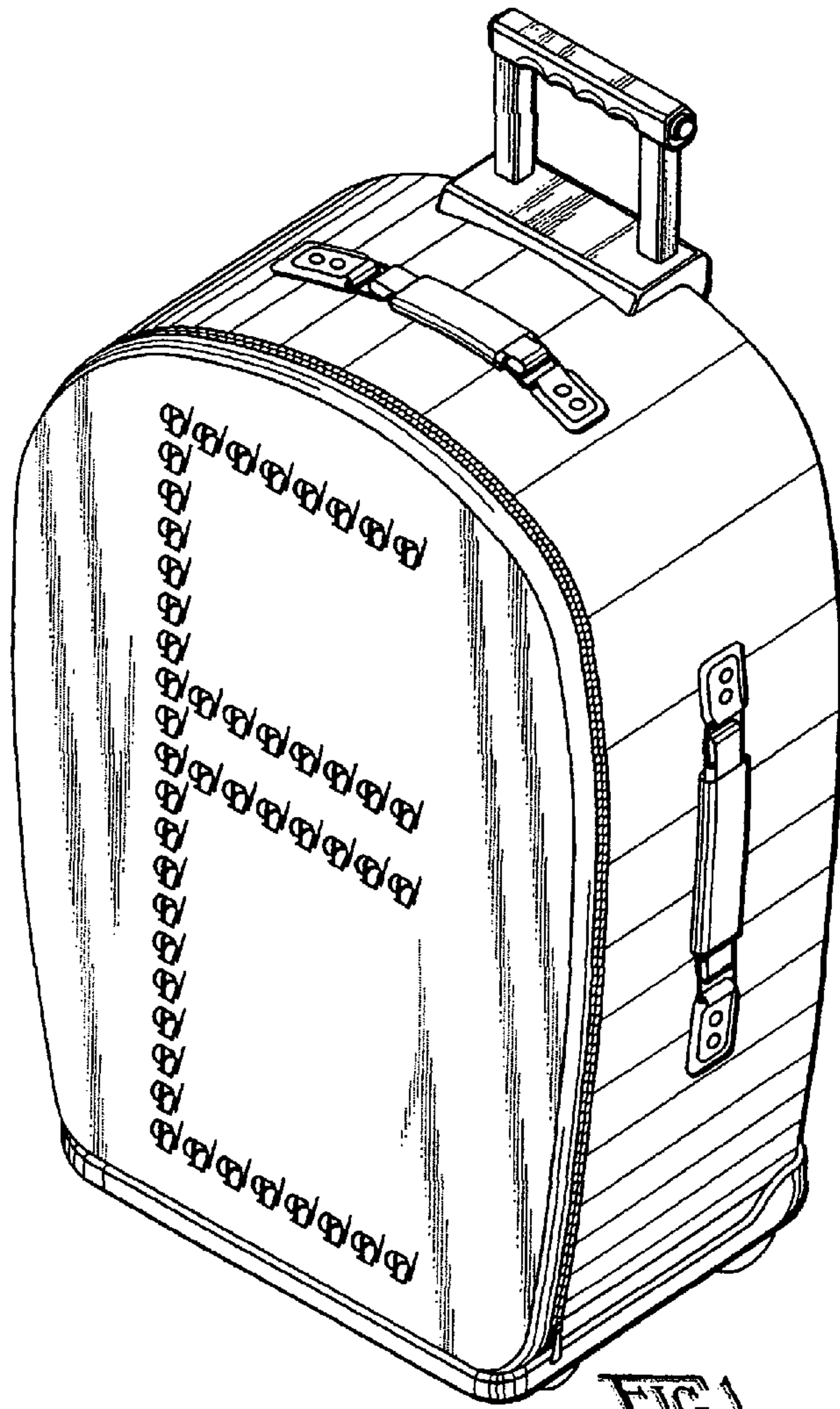

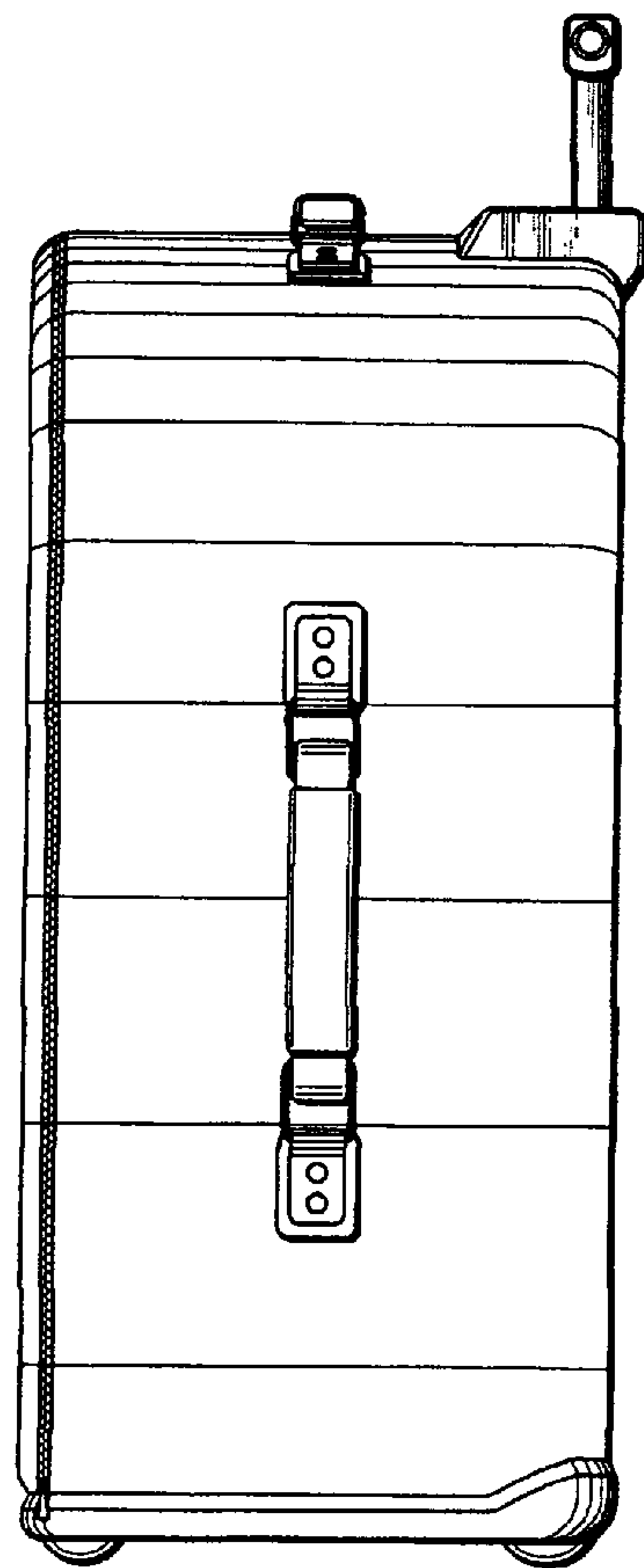

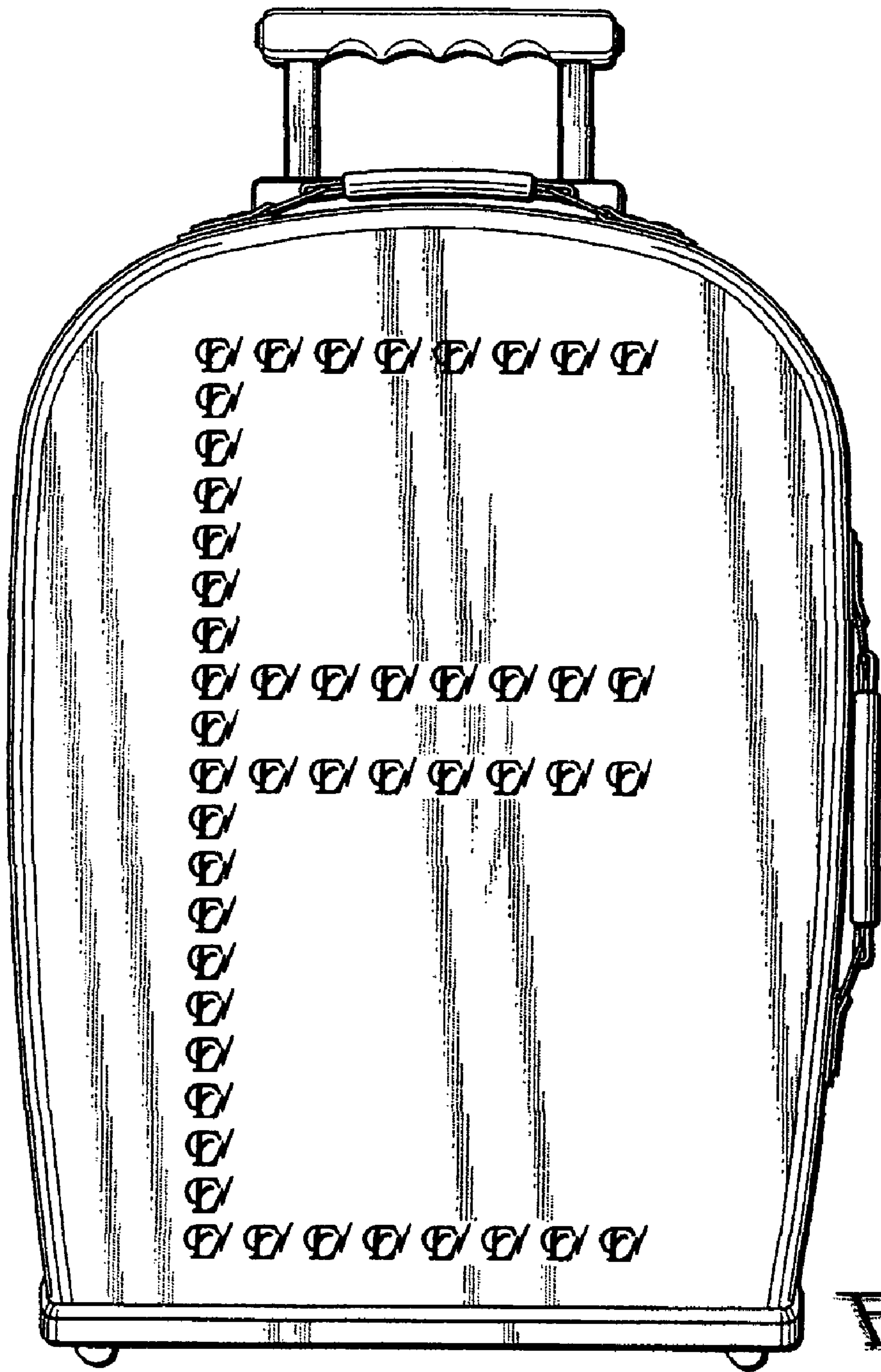
