The ornamental design for a paint brush sleeve, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view of a paint brush sleeve, as shown and described covering a paint brush;

FIG. 2 is a front view of the paint brush sleeve;

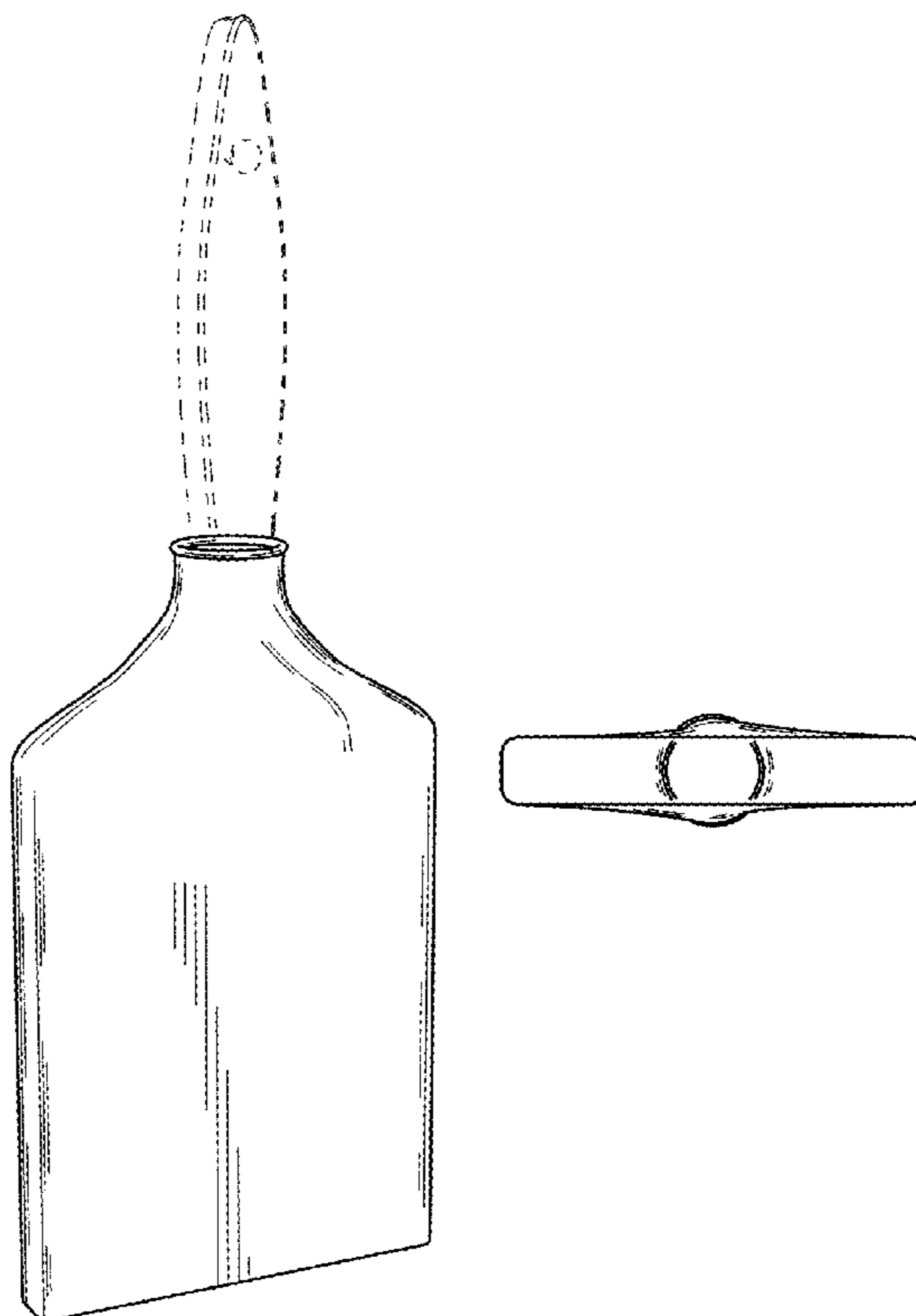
FIG. 3 is a side view thereof;

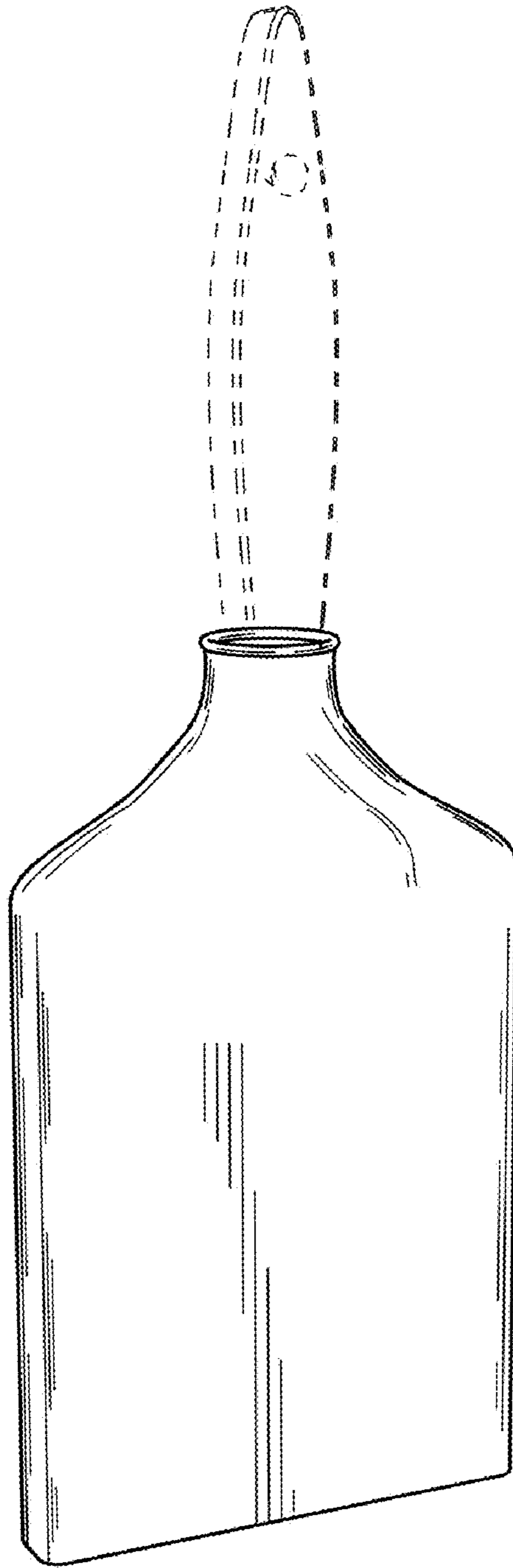

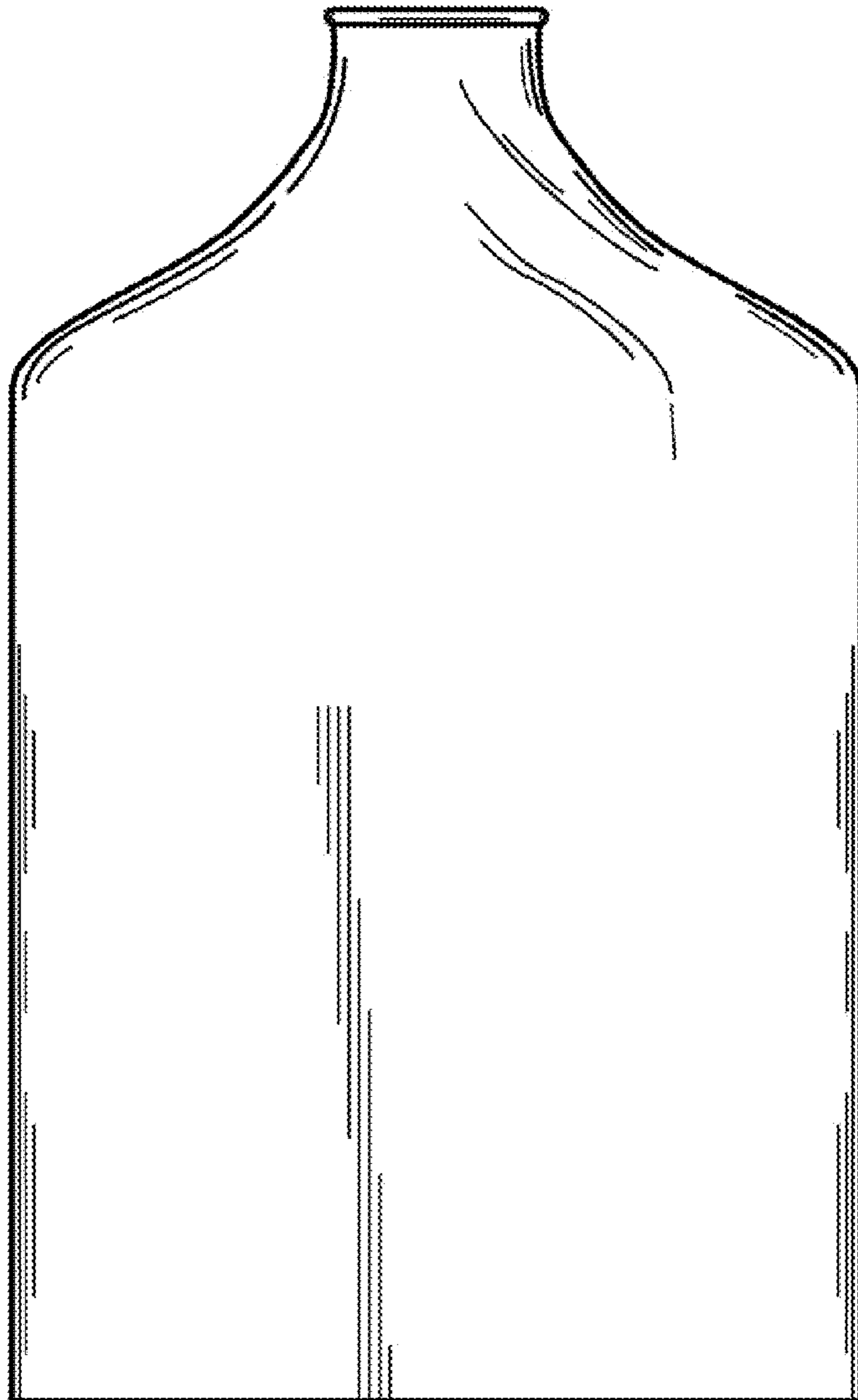

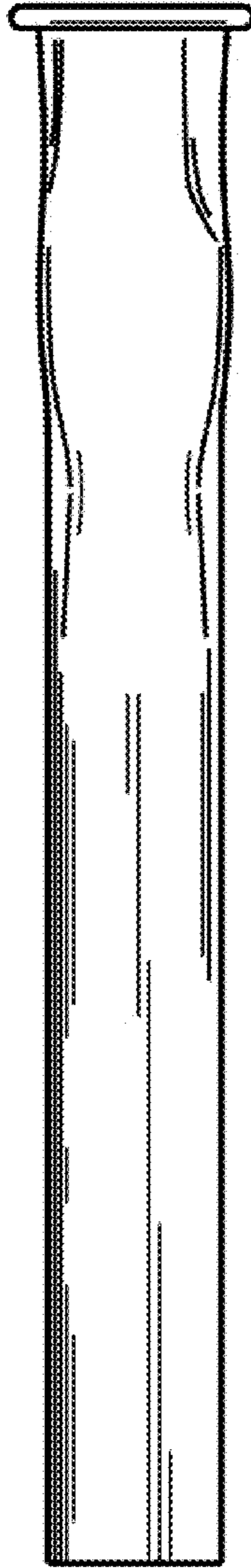

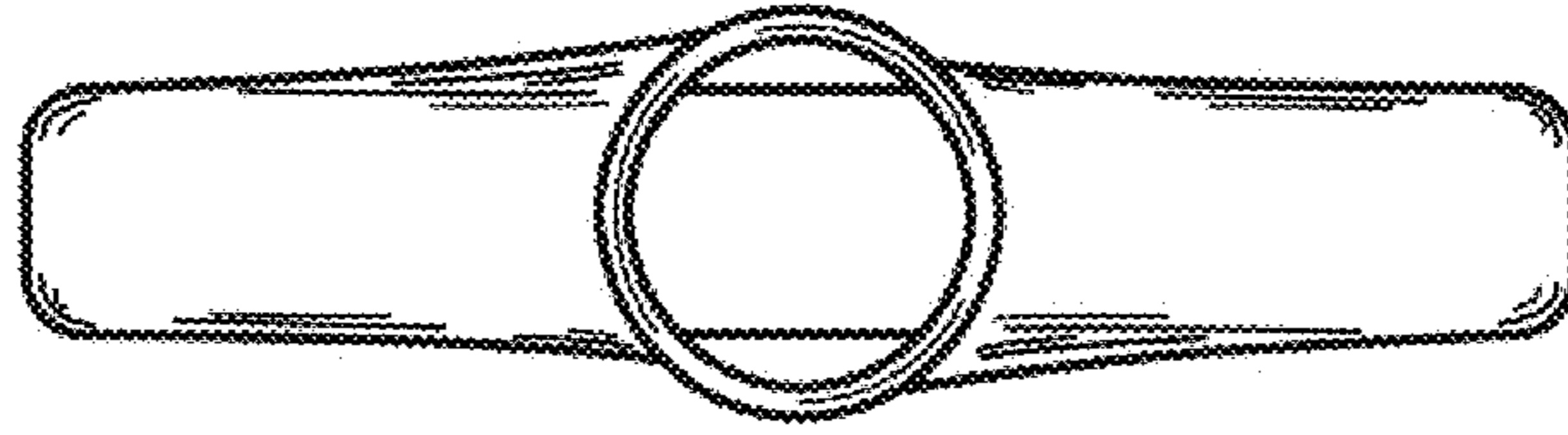

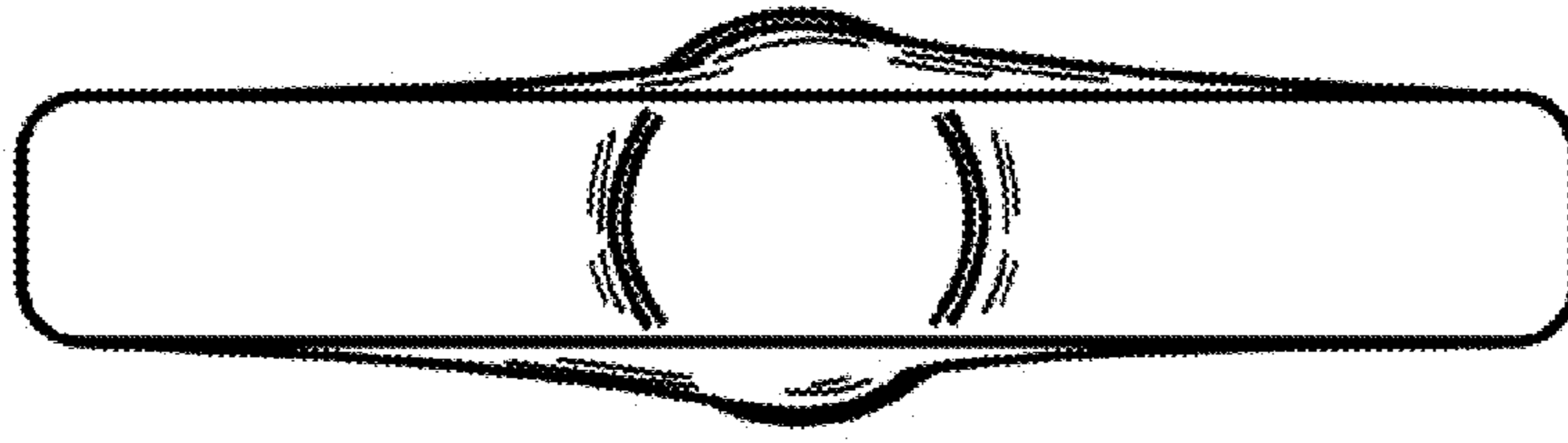
