The ornamental design for scissors, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of scissors showing our new design;

FIG. 2 is a left side elevational view showing the design for the scissors of FIG. 1;

FIG. 3 is a right side elevational view showing the design for the scissors of FIG. 1;

FIG. 4 is a front elevational view showing the design for the scissors of FIG. 1;

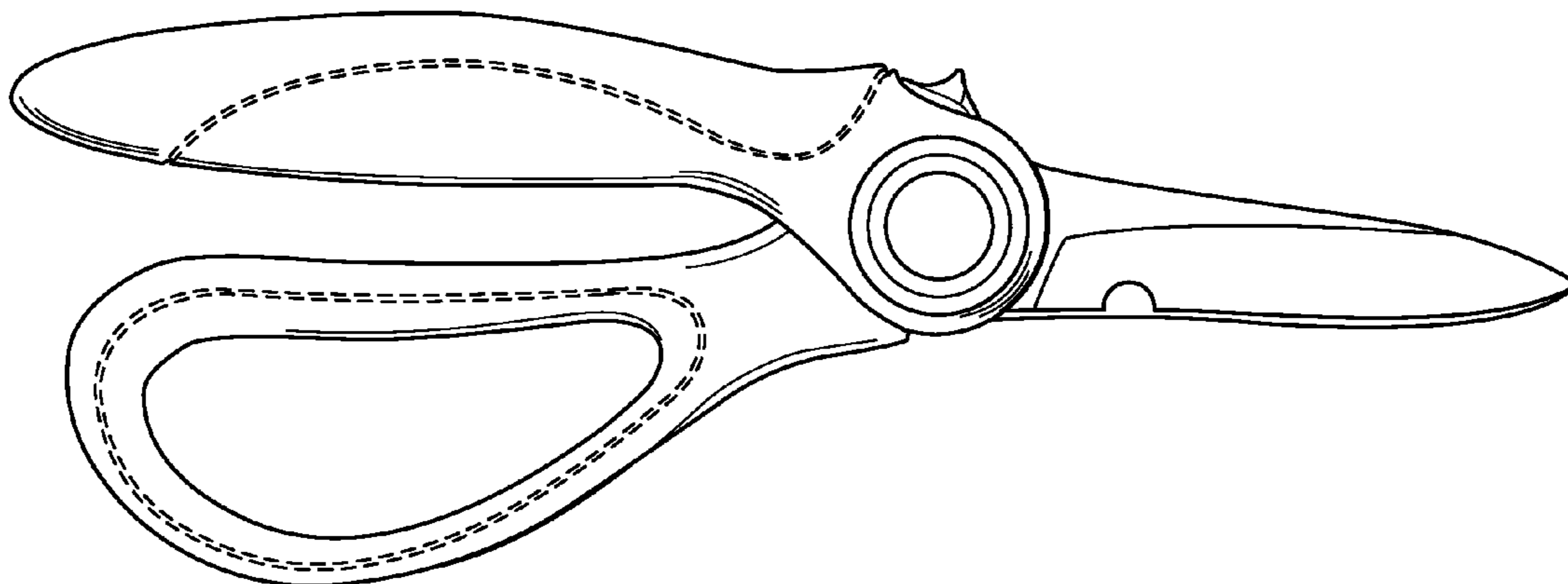
FIG. 5 is a rear elevational view showing the design for the scissors of FIG. 1;

FIG. 6 is a top elevational view showing the design for the scissors of FIG. 1; and,

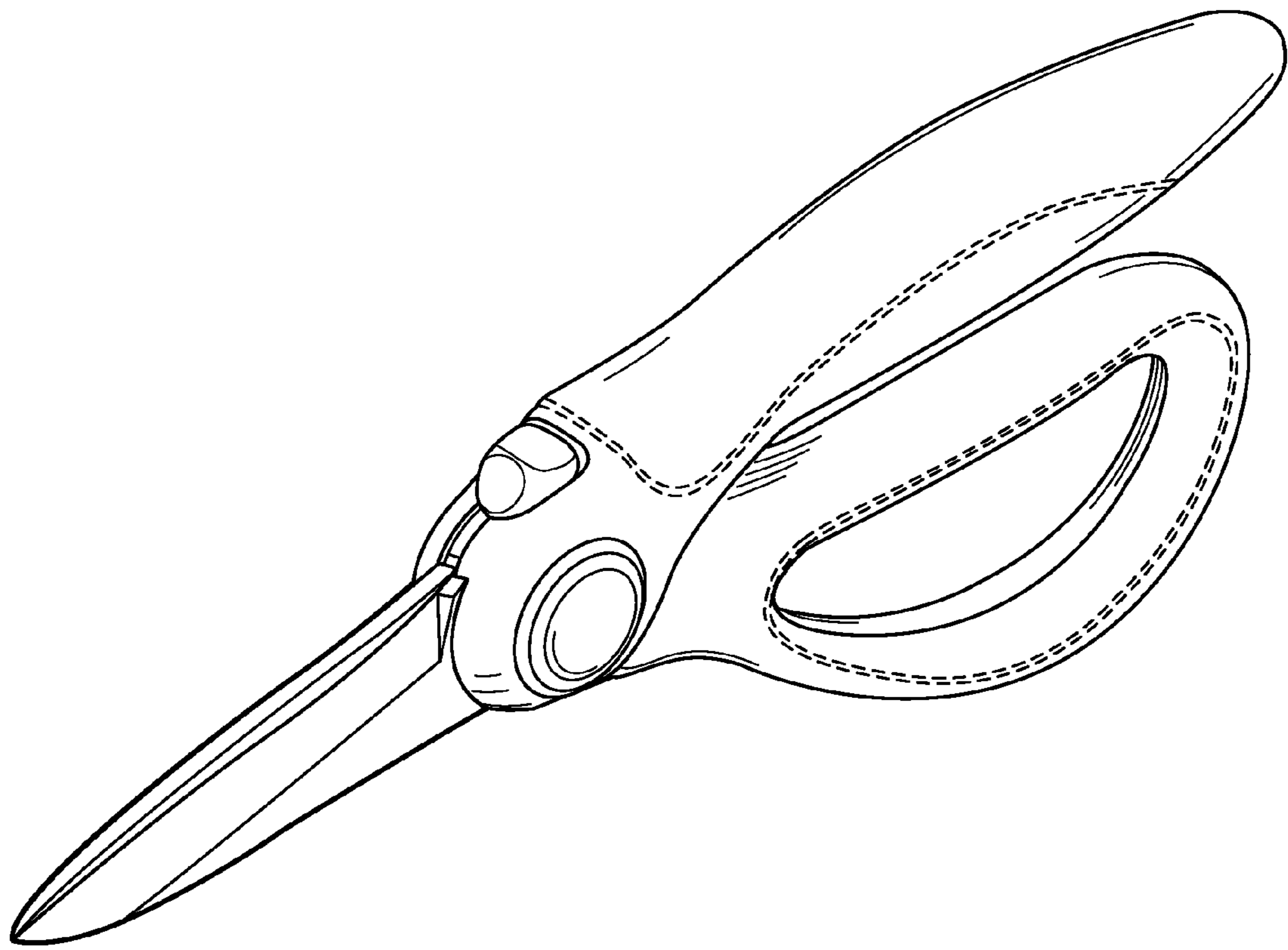

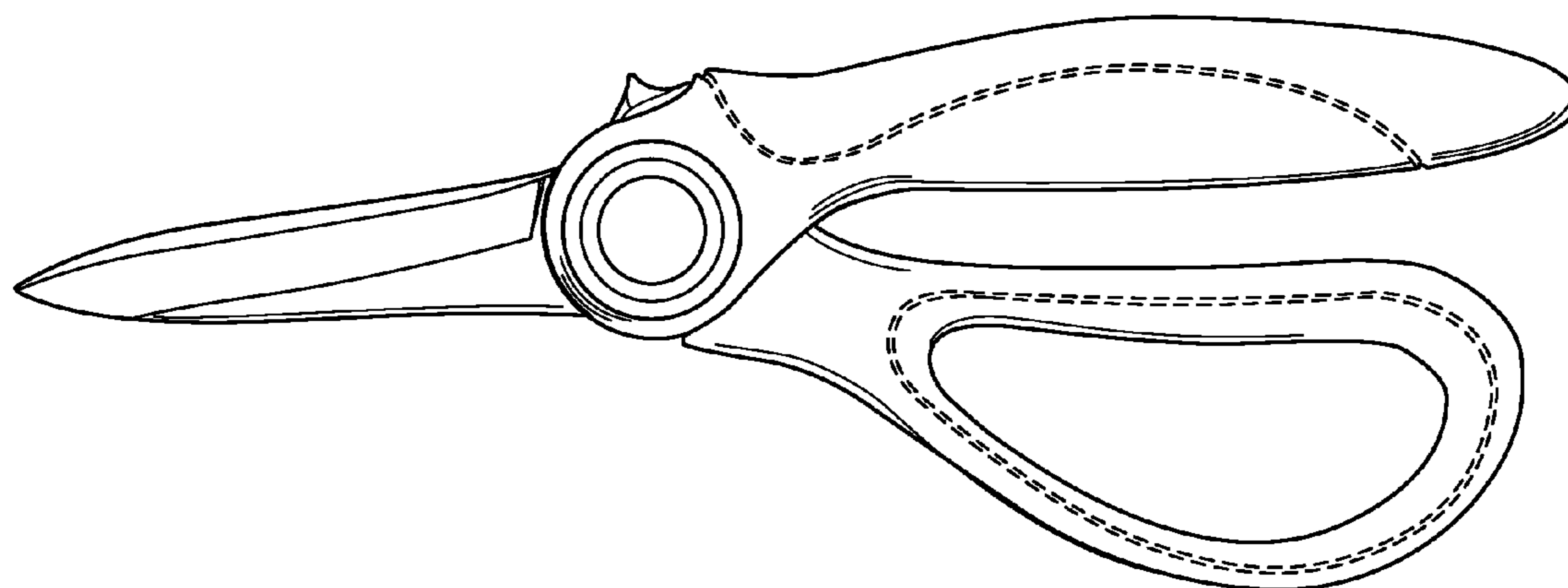

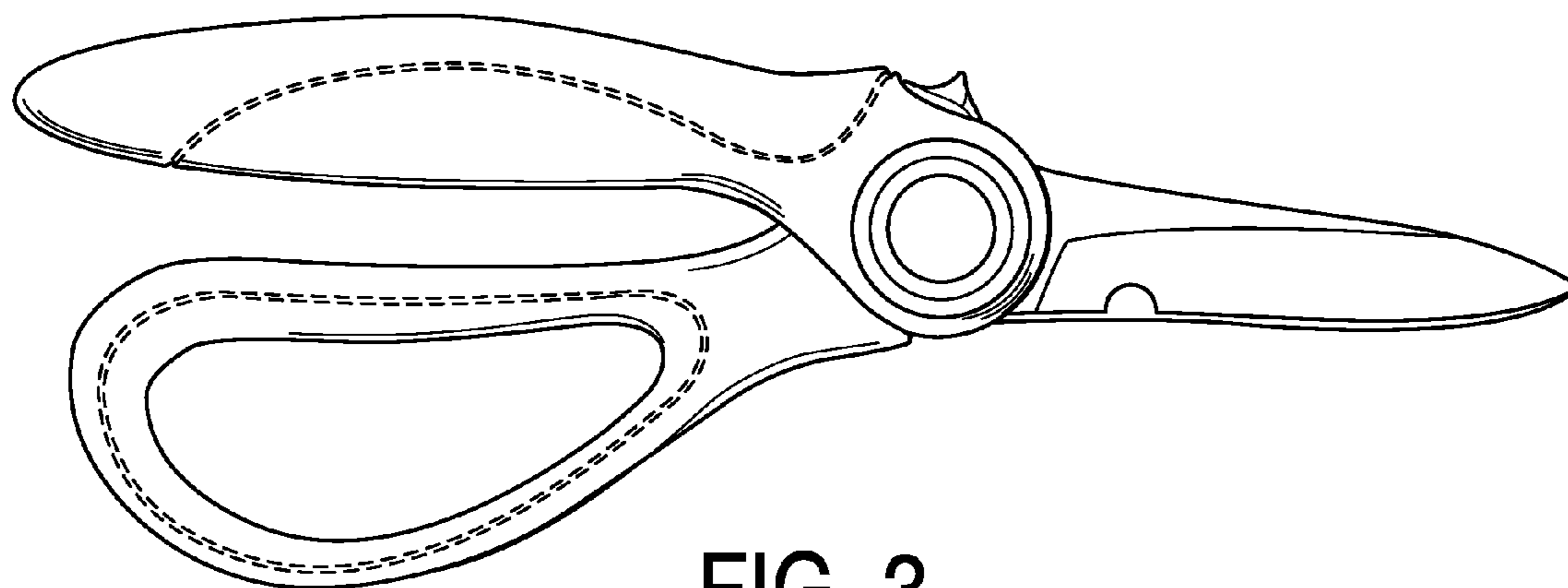

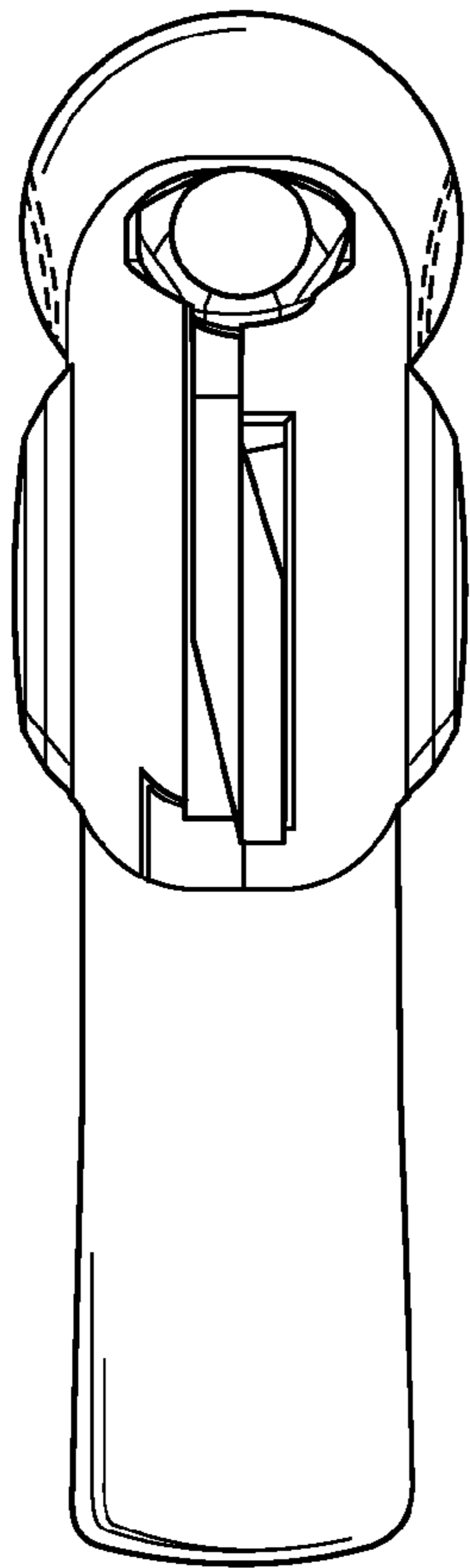

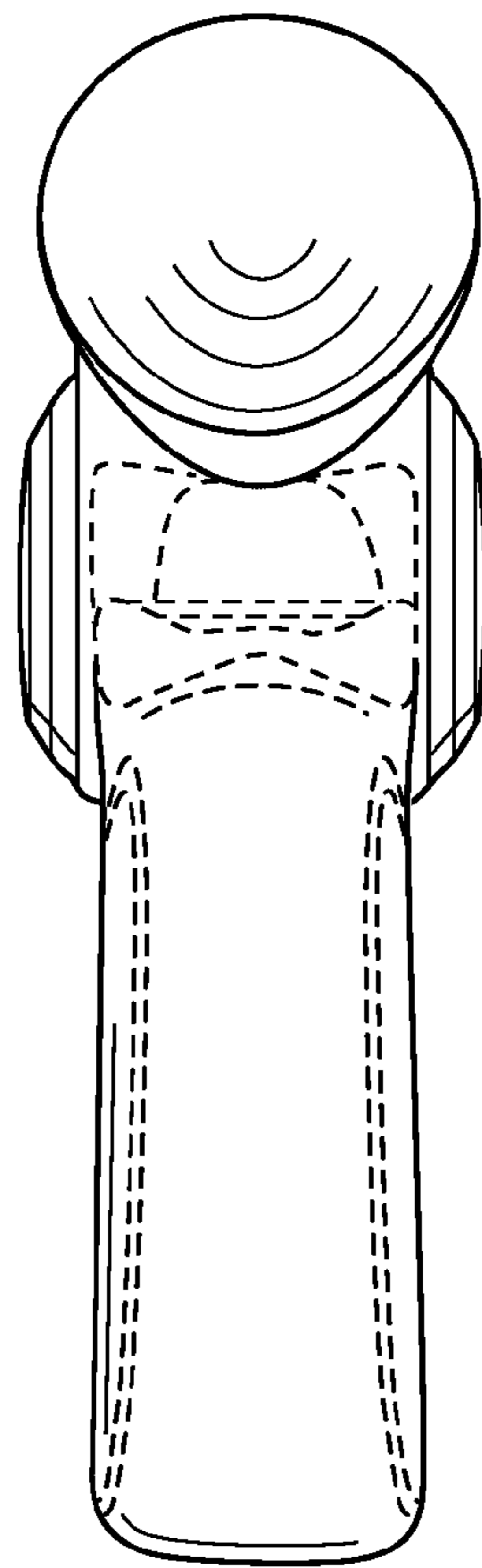

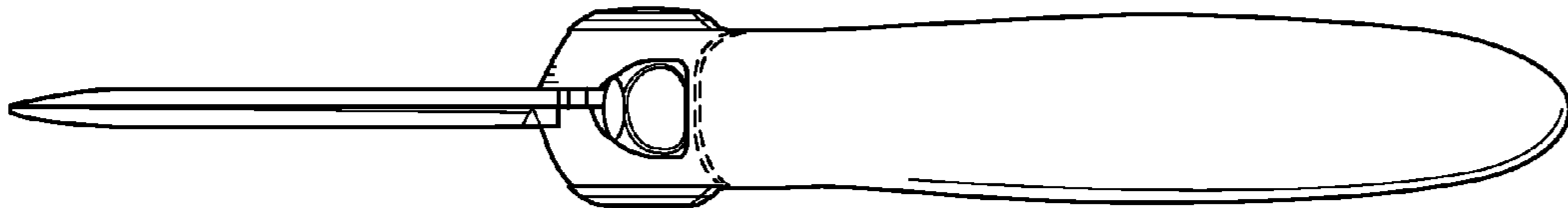

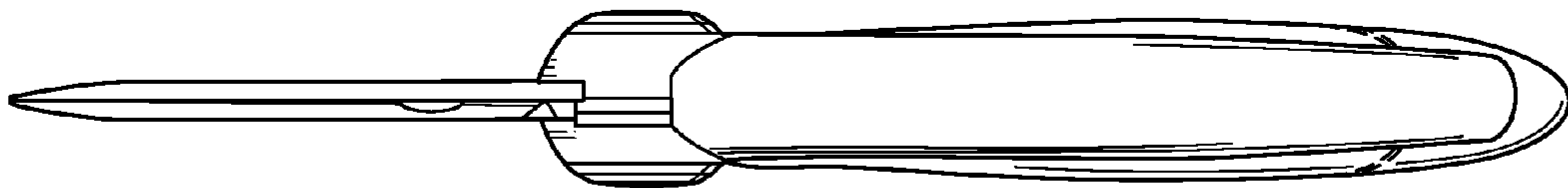
