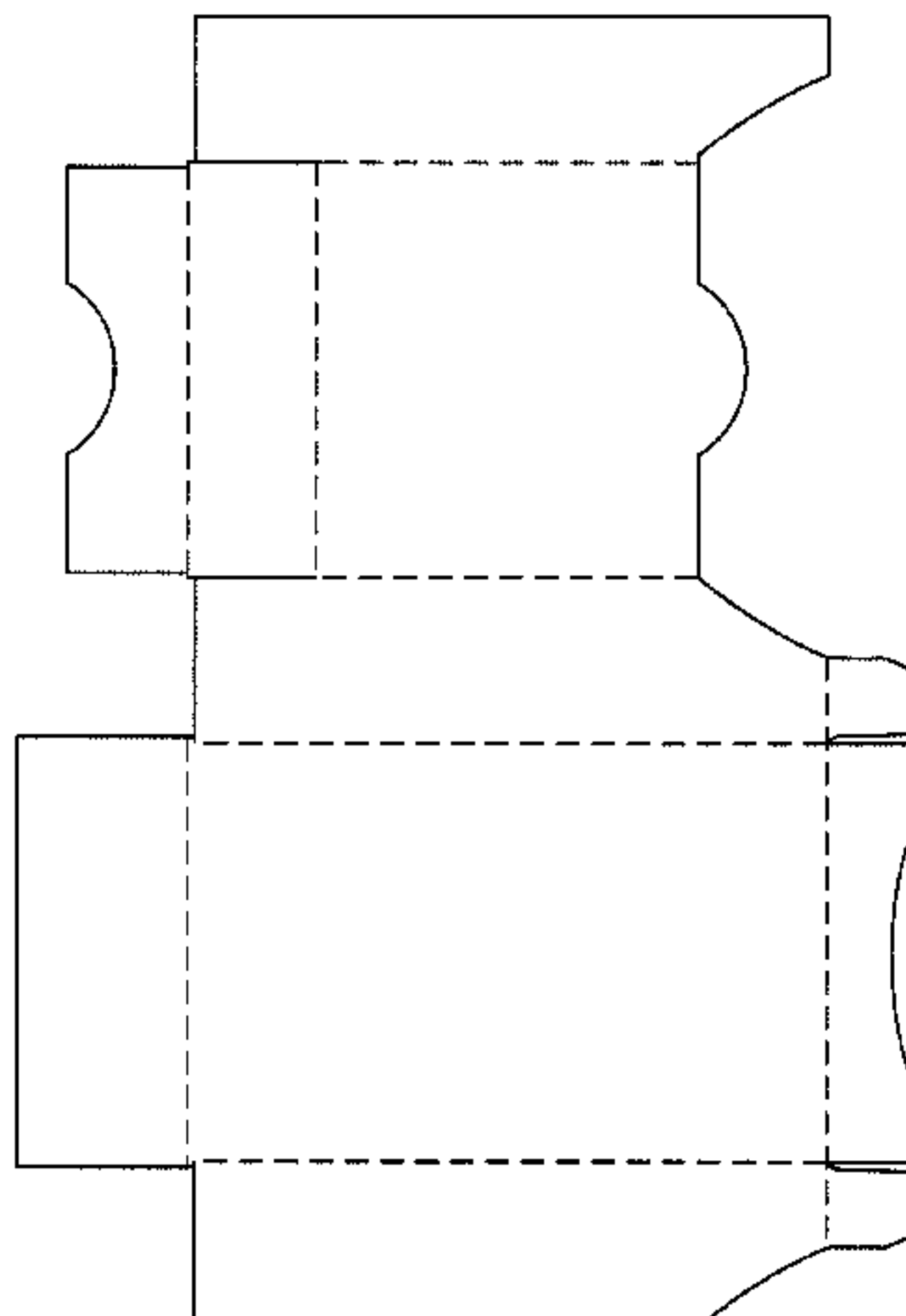
The ornamental design for a blank for a box, as shown and described.
