The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a top rear right perspective view of a bottle showing a first embodiment of our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a top view thereof, wherein features of the unclaimed base visible through the throat of the bottle have been omitted;

FIG. 7 is a bottom view thereof;

FIG. 8 is a top rear right perspective view of a bottle showing a second embodiment of our new design;

FIG. 9 is a front view thereof;

FIG. 10 is a rear view thereof;

FIG. 11 is a right side view thereof;

FIG. 12 is a left side view thereof;

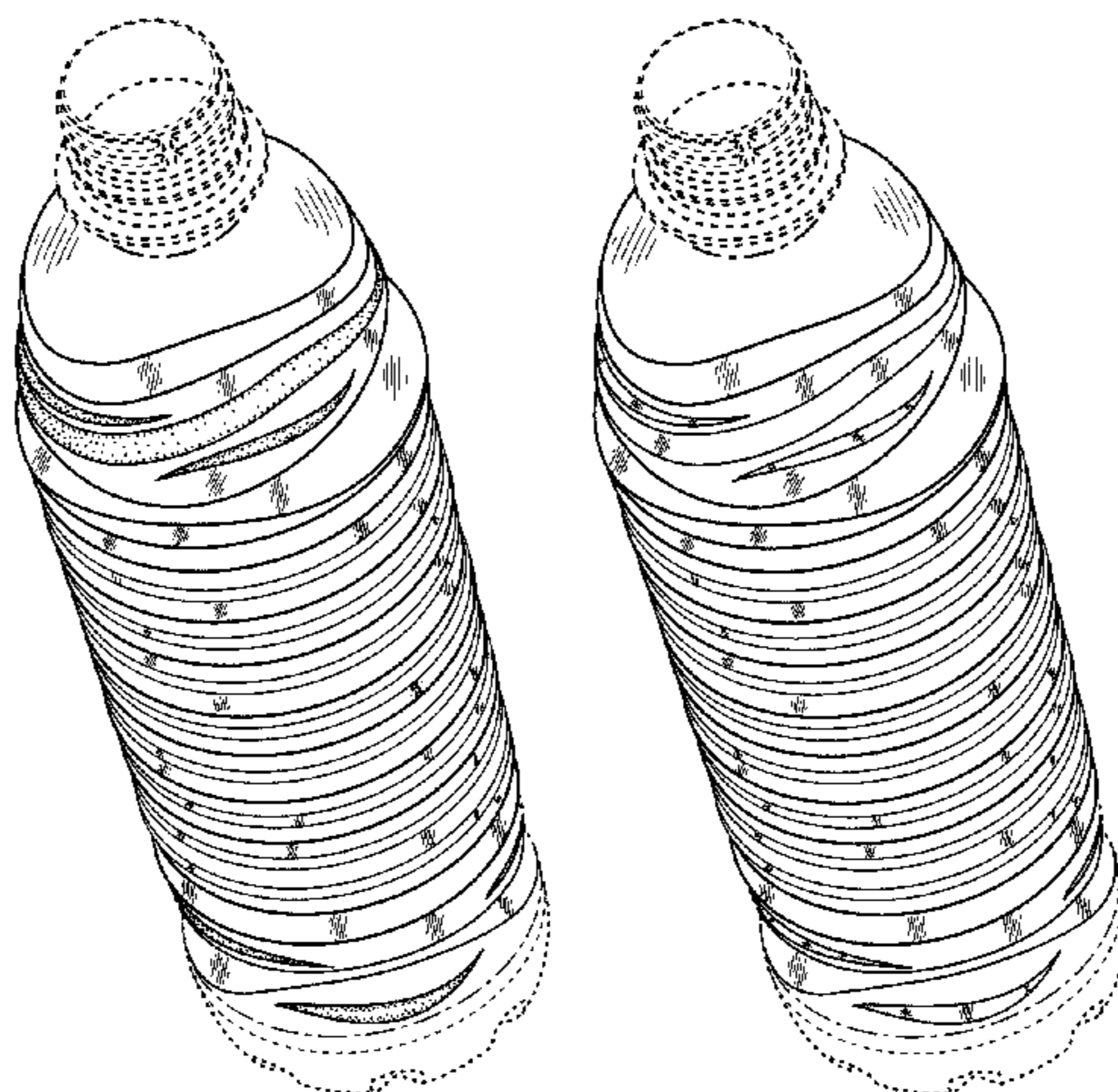
FIG. 13 is a top view thereof, wherein features of the unclaimed base visible through the throat of the bottle have been omitted; and,

FIG. 14 is a bottom view thereof.

The dot-dash broken lines immediately adjacent the shaded areas represent the bounds of the claimed design, while all other broken lines are included for the purposed of illustrating environment; the broken lines form no part of the claimed design.

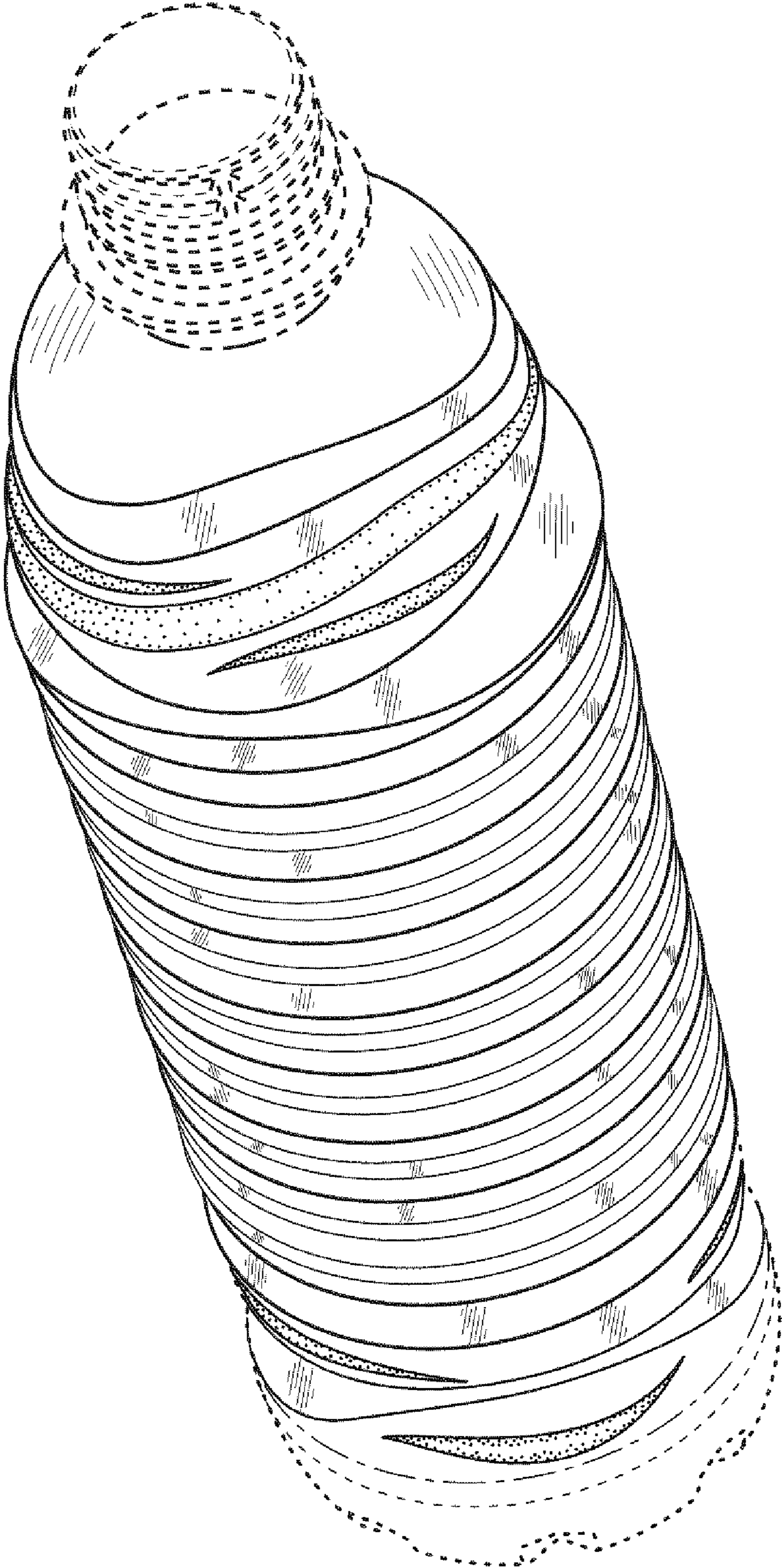

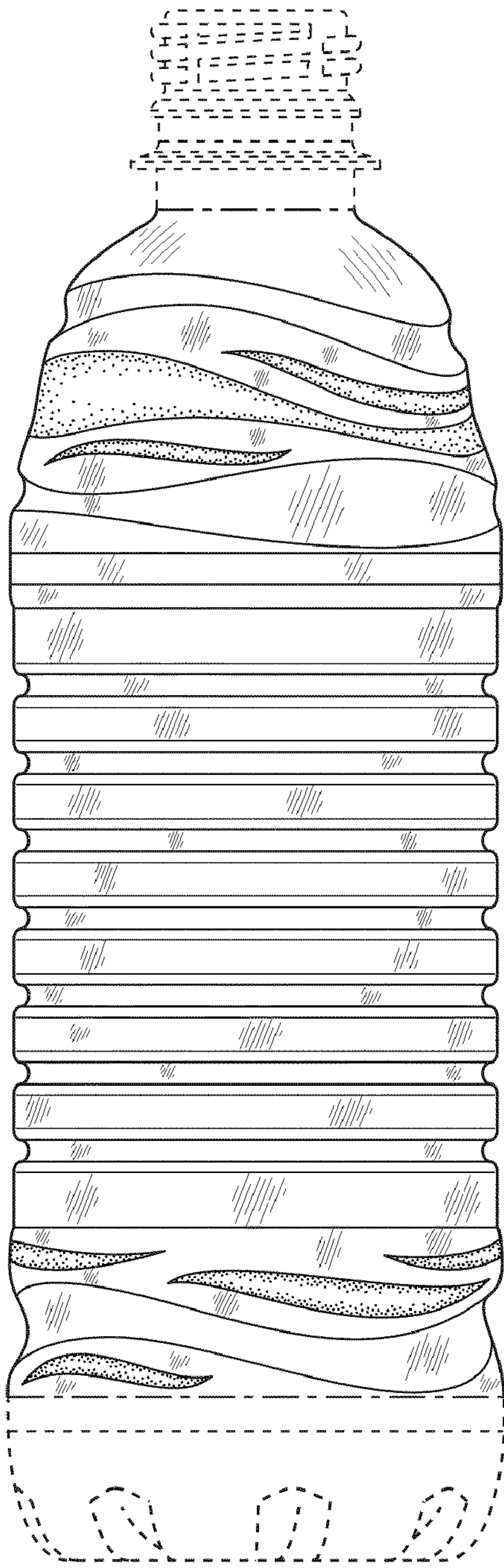

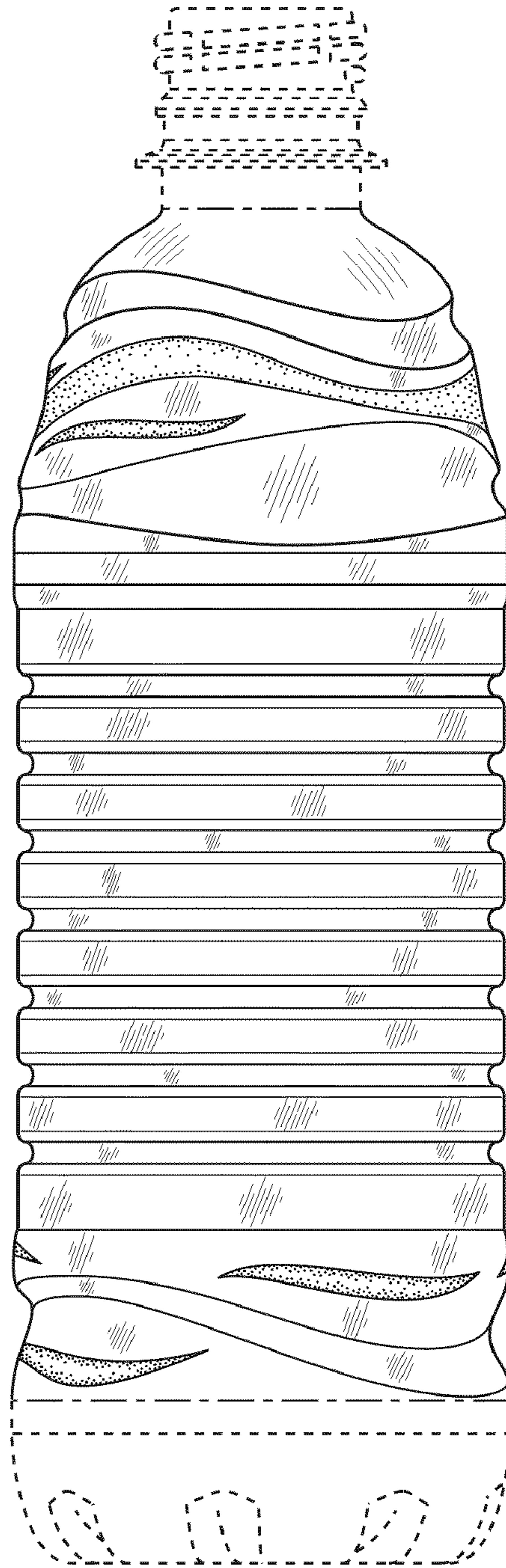

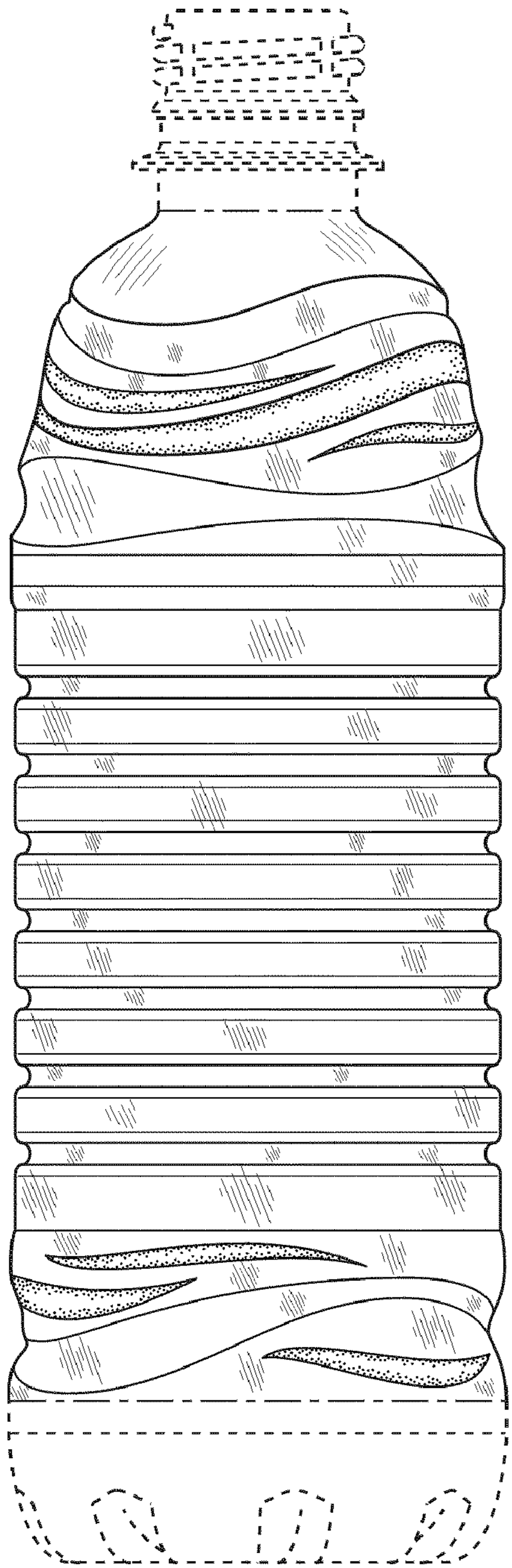

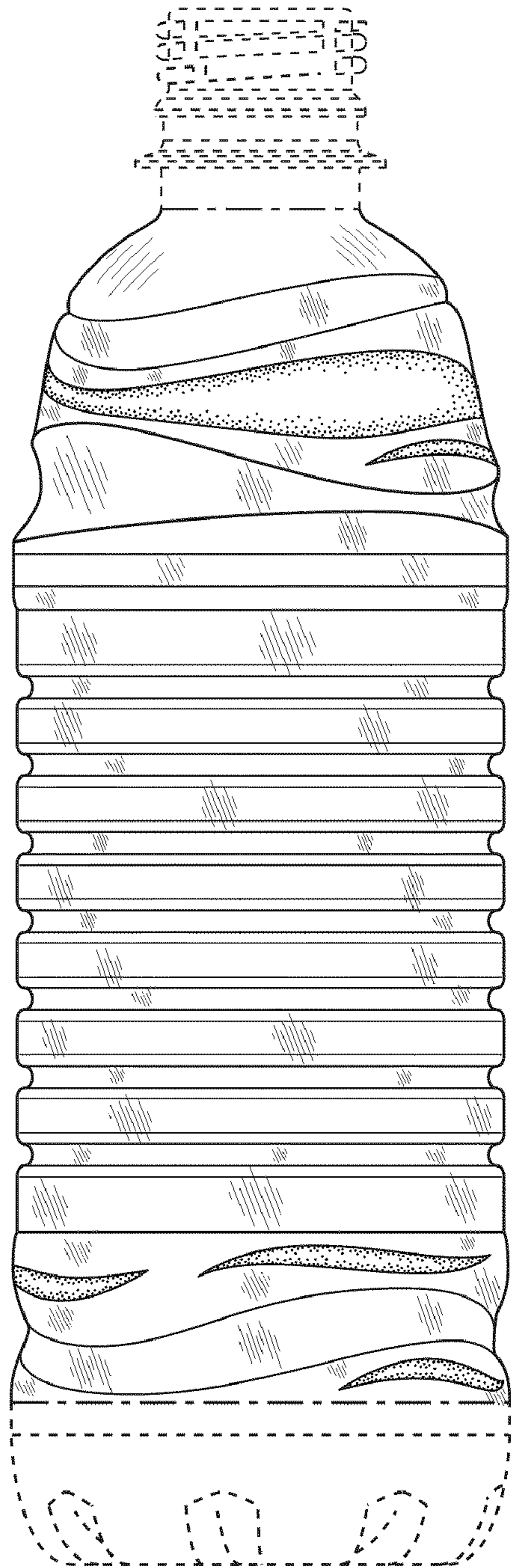

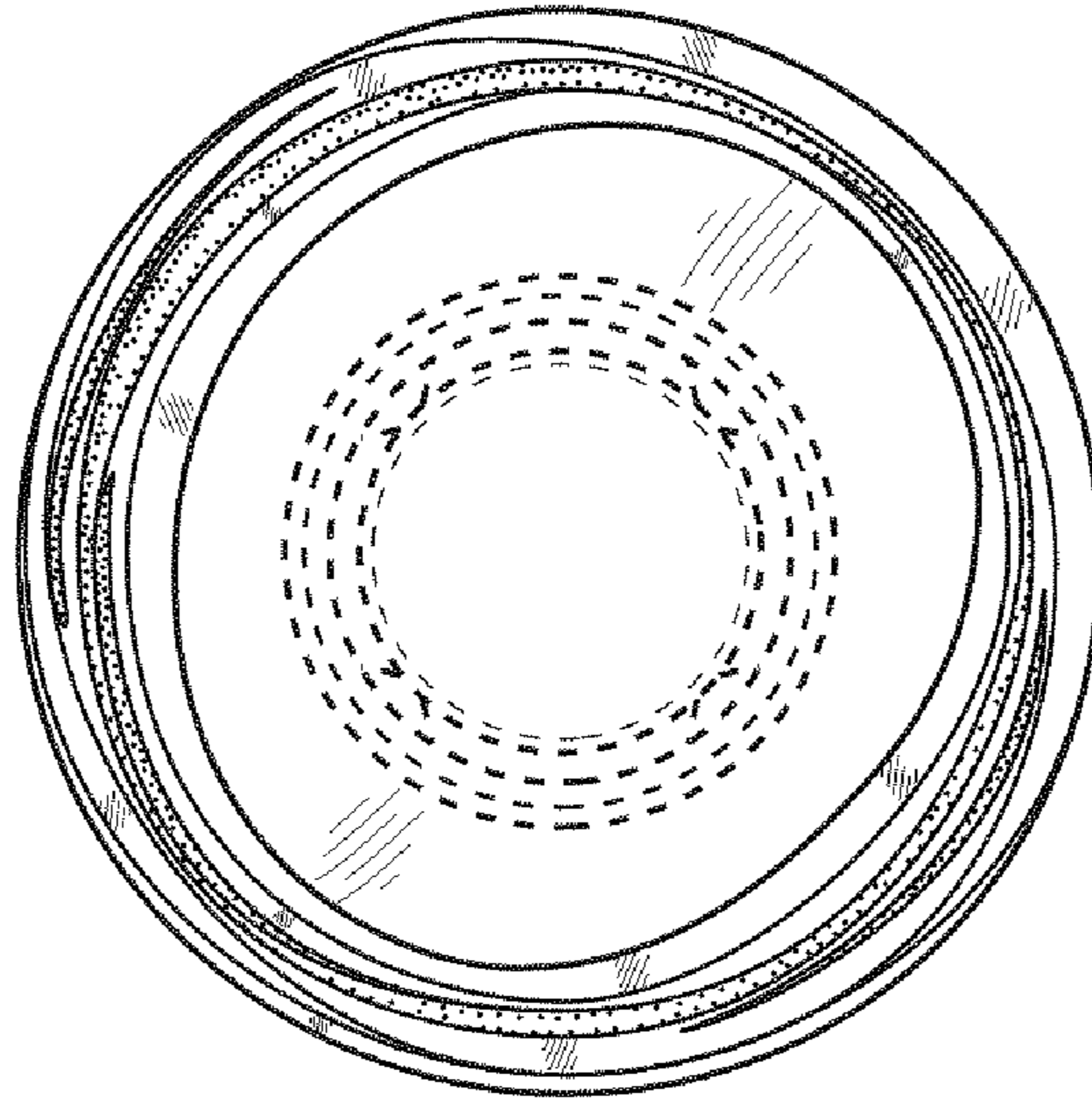

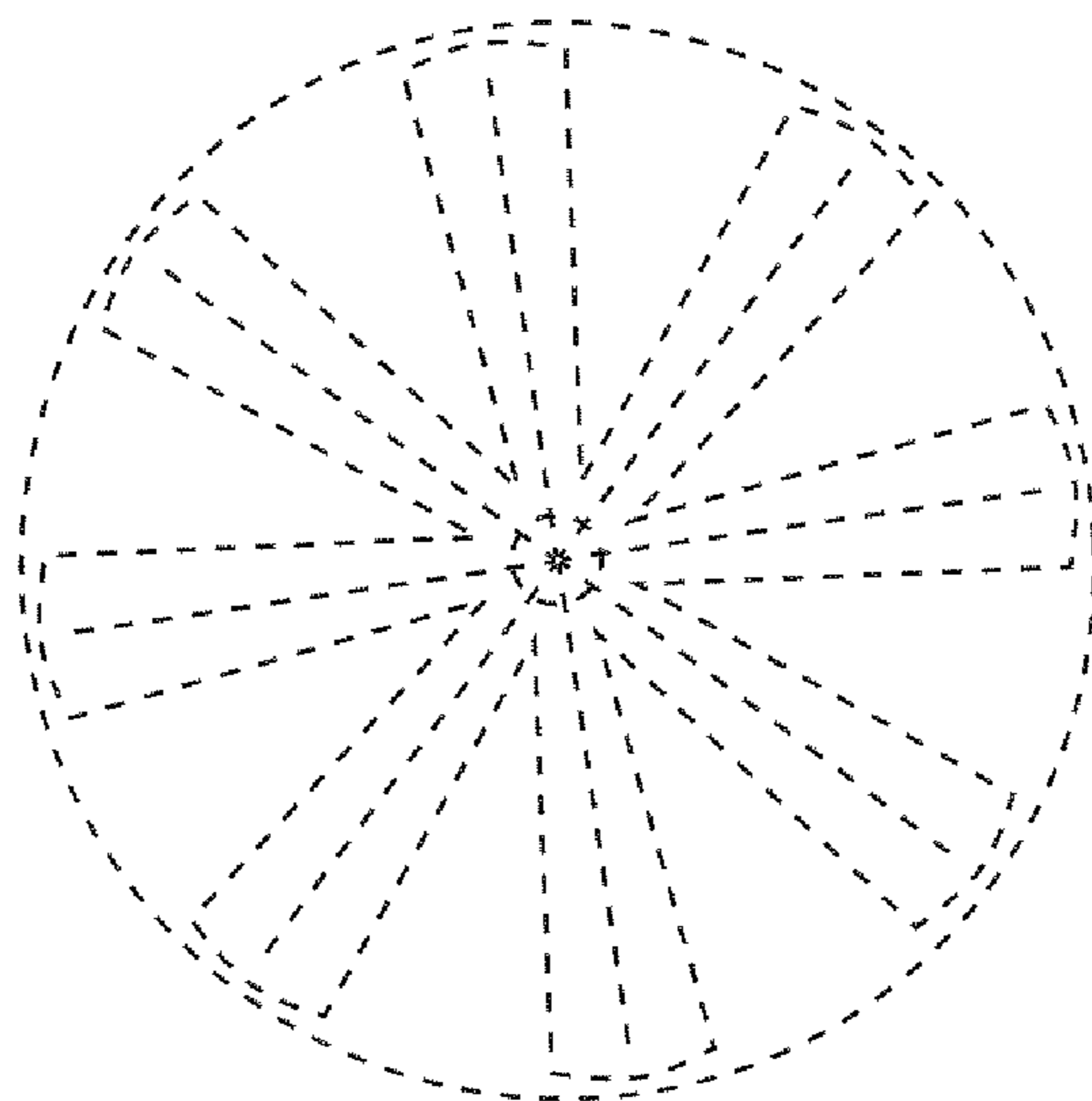

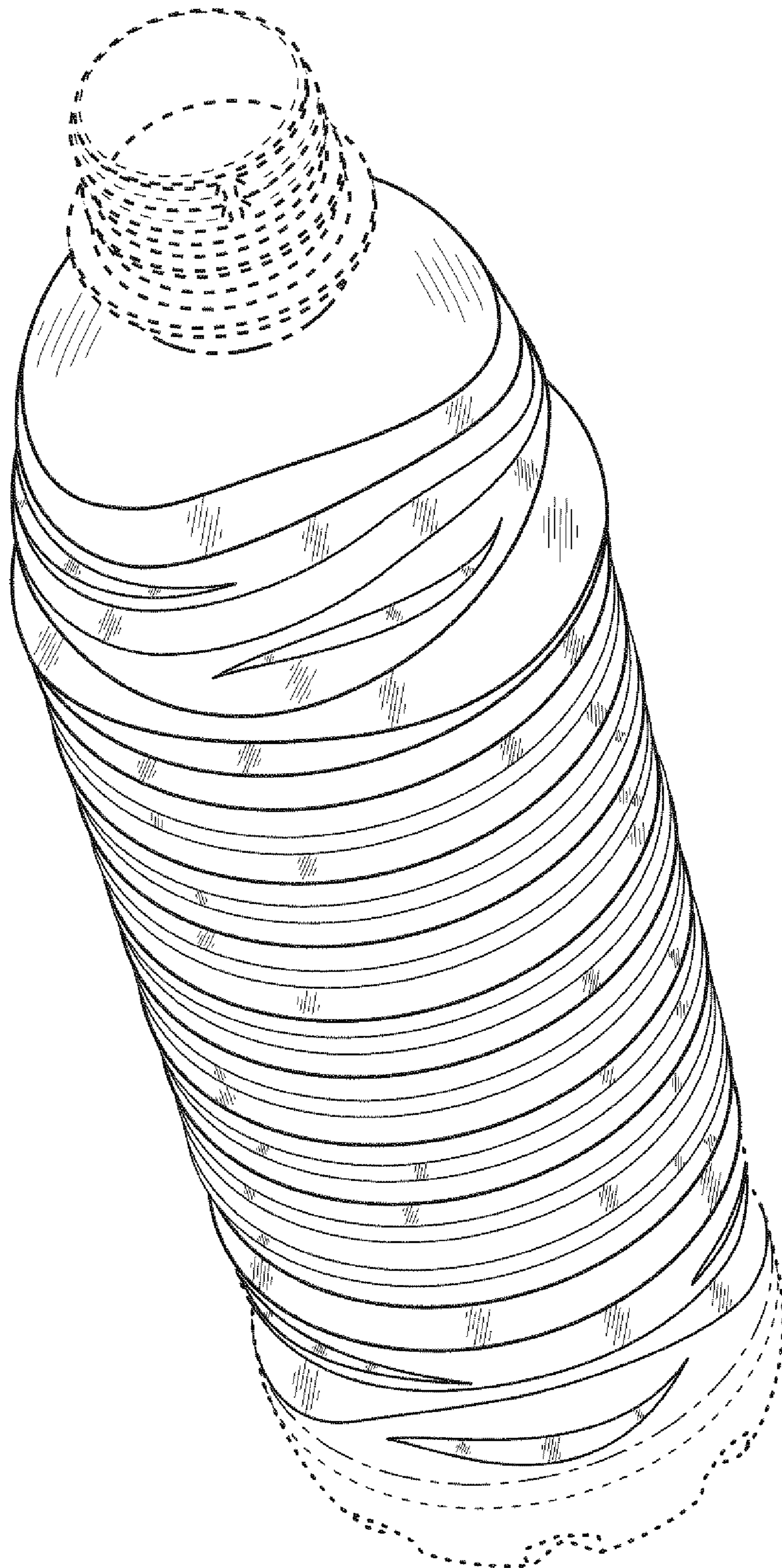

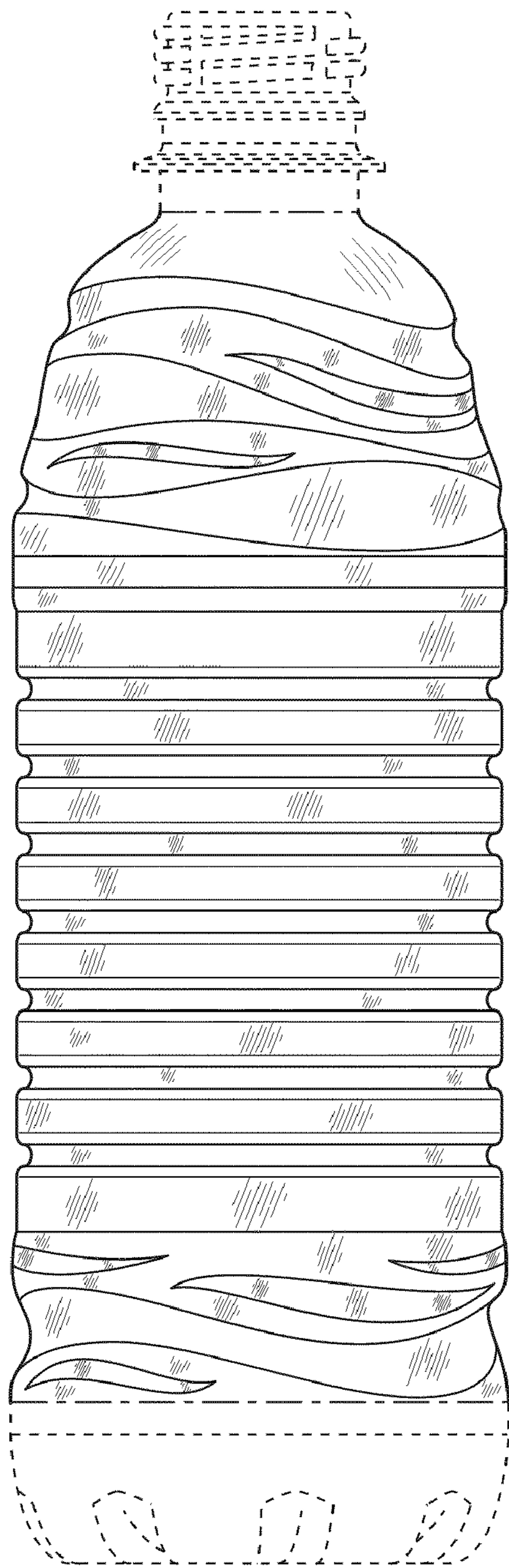

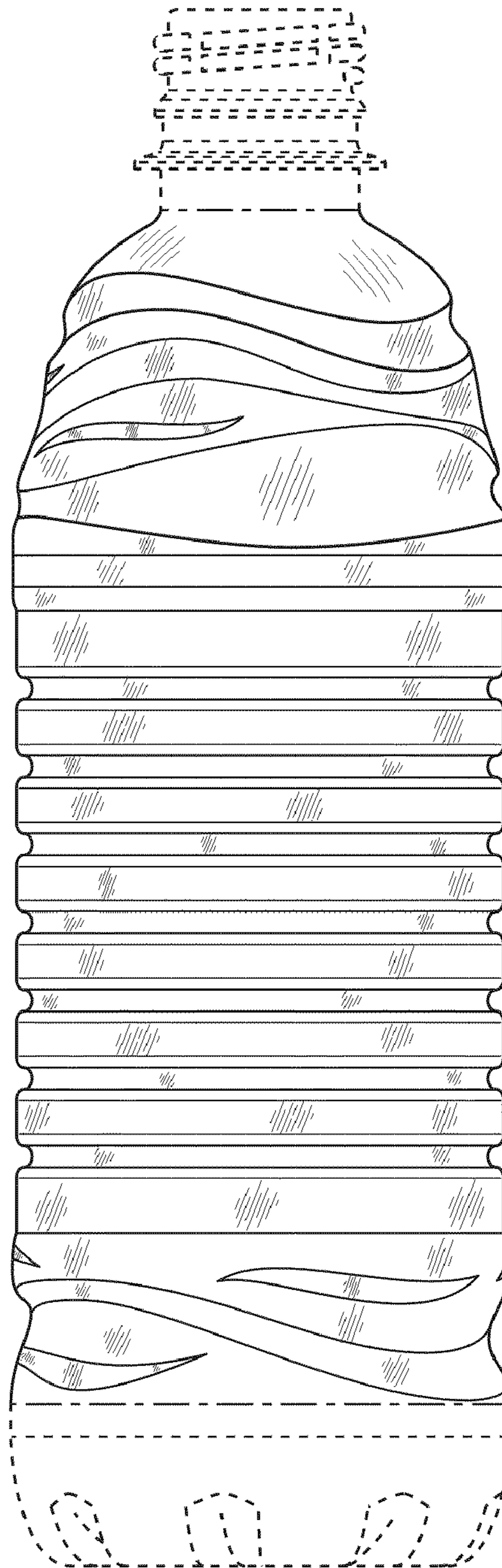

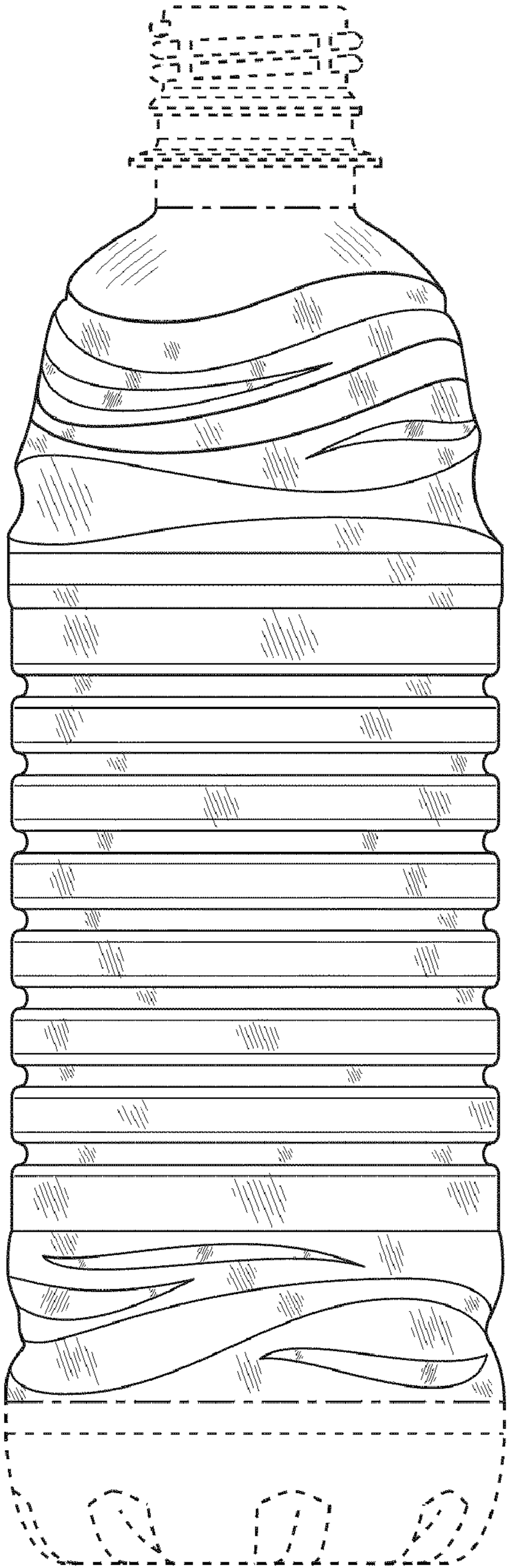

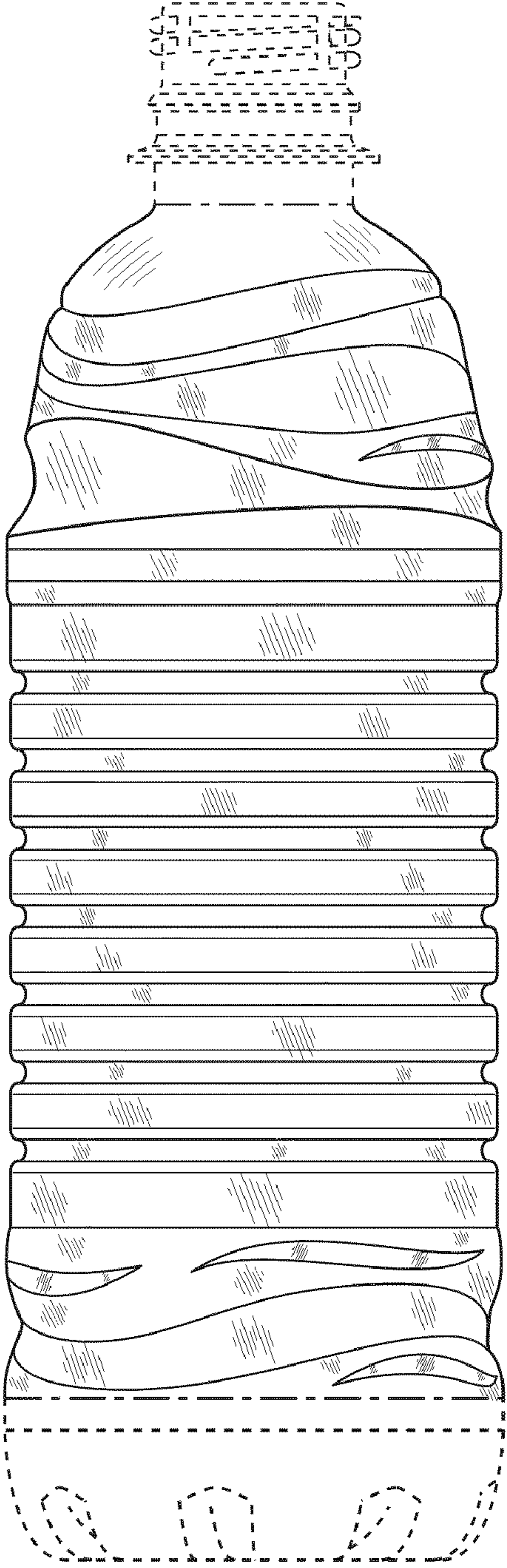

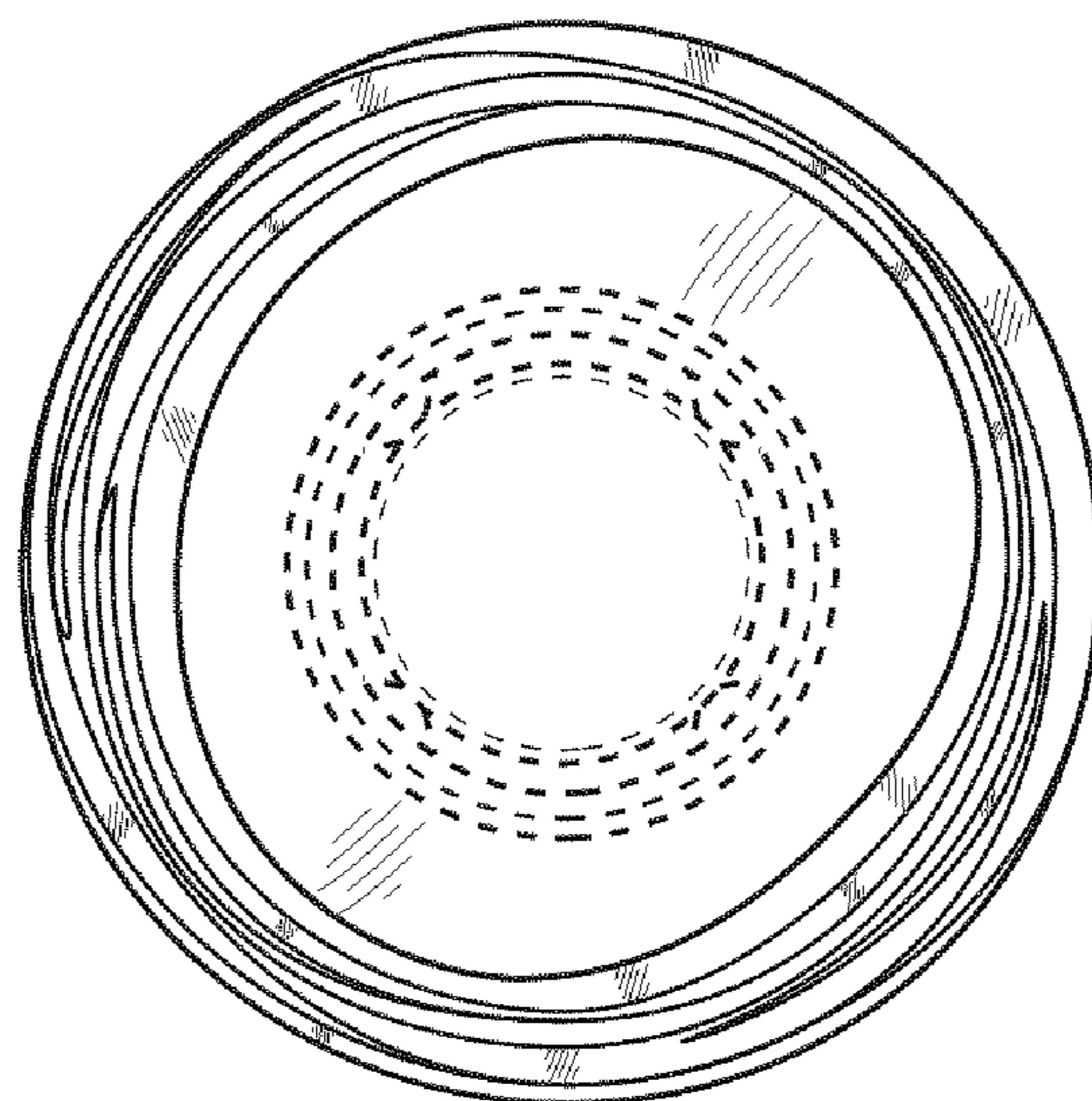

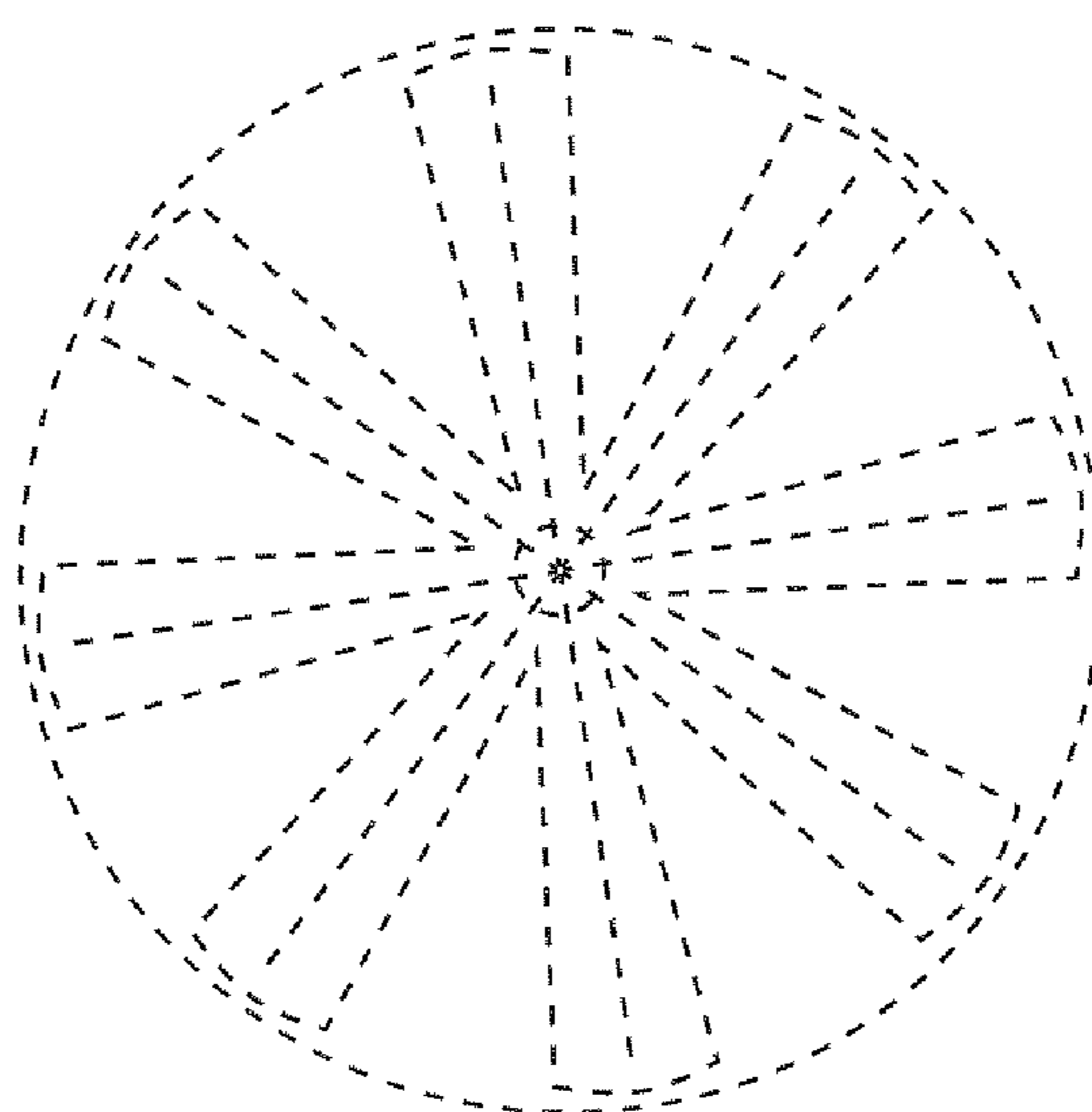
