FIG. 4 is a bottom view thereof.

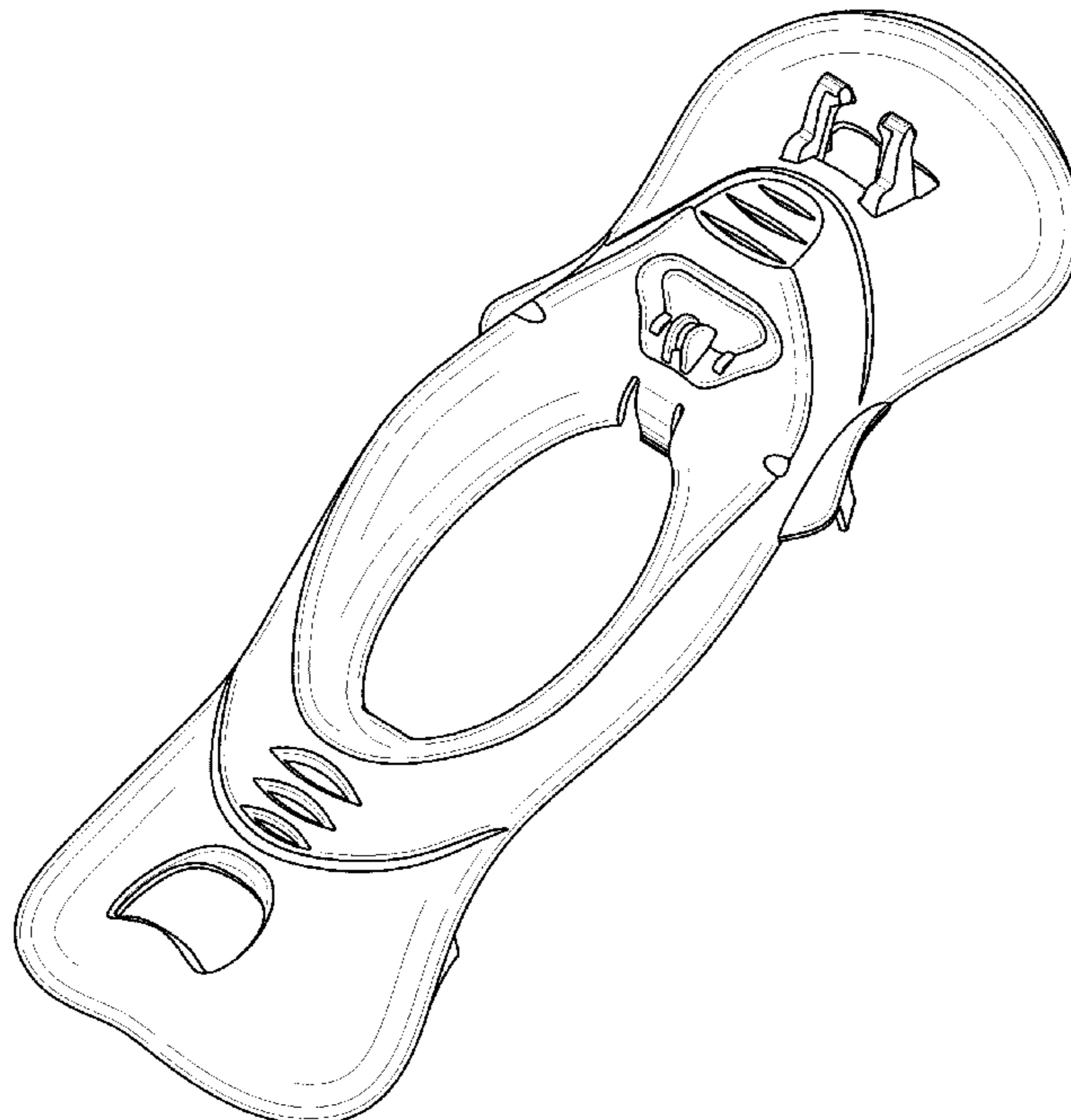
FIG. 5 is a left view of FIG. 3.

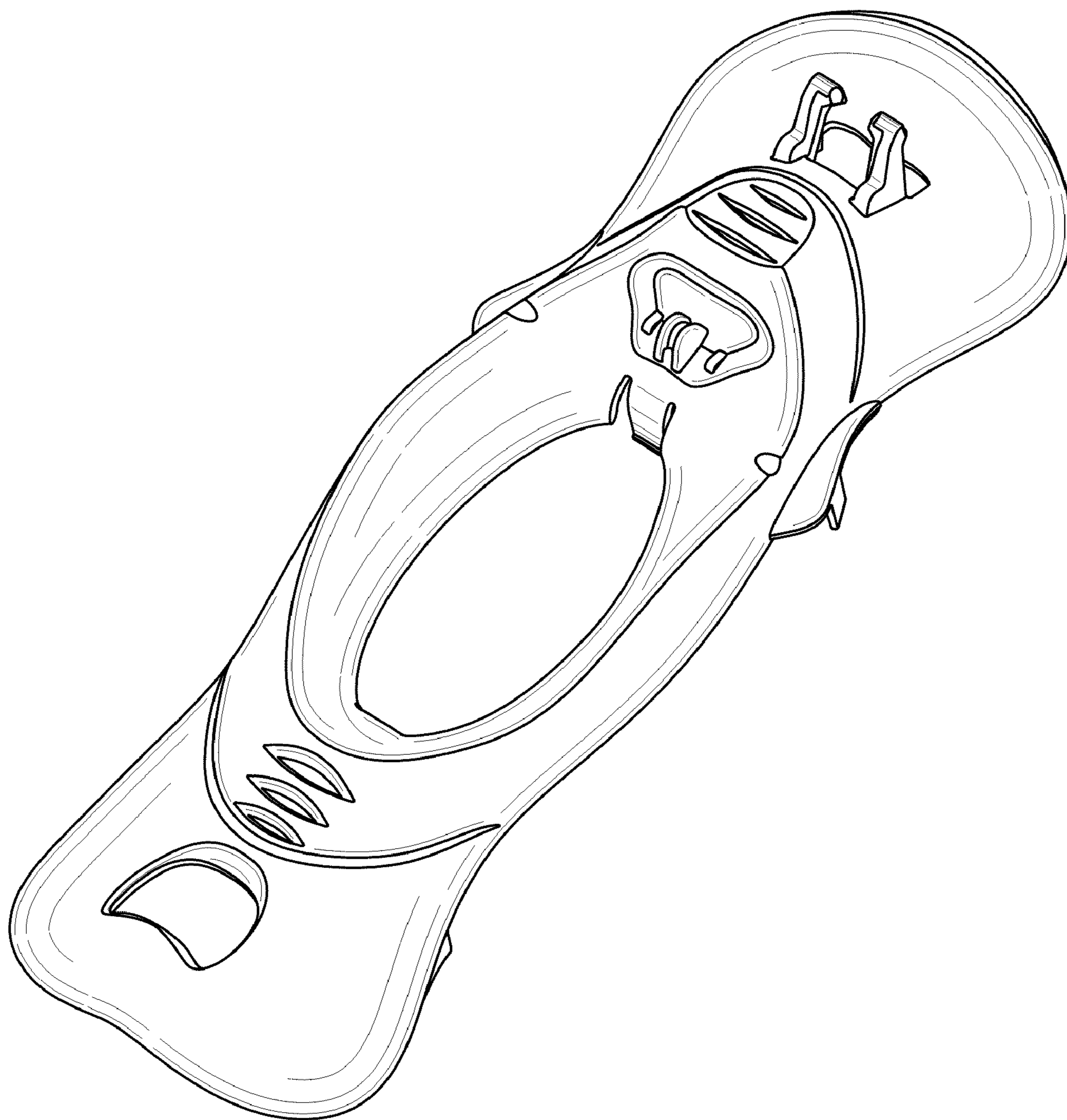

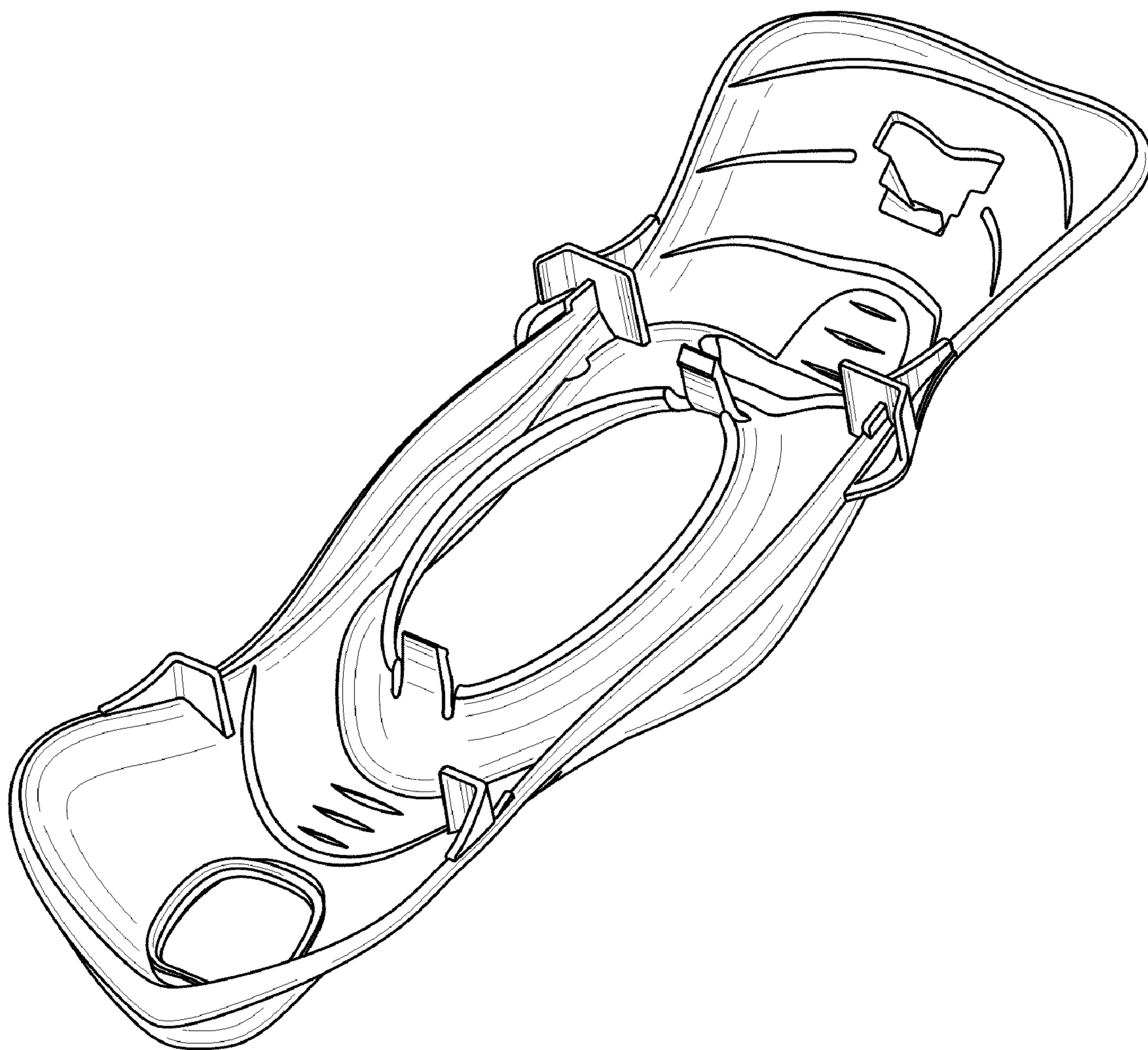

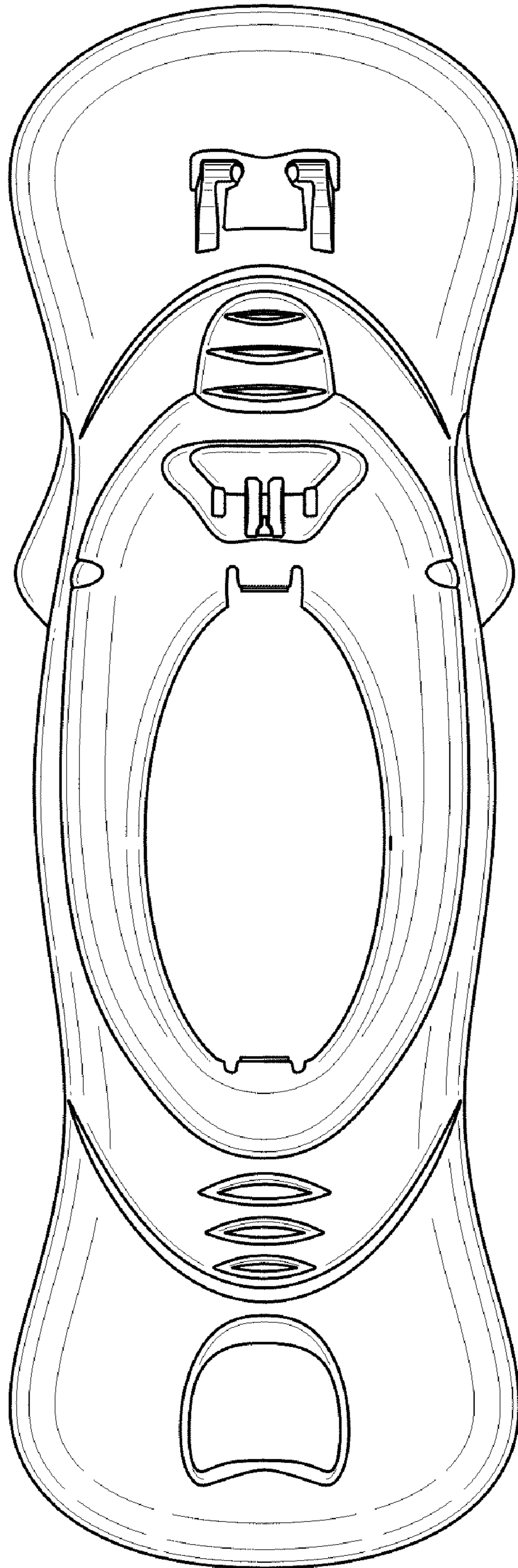

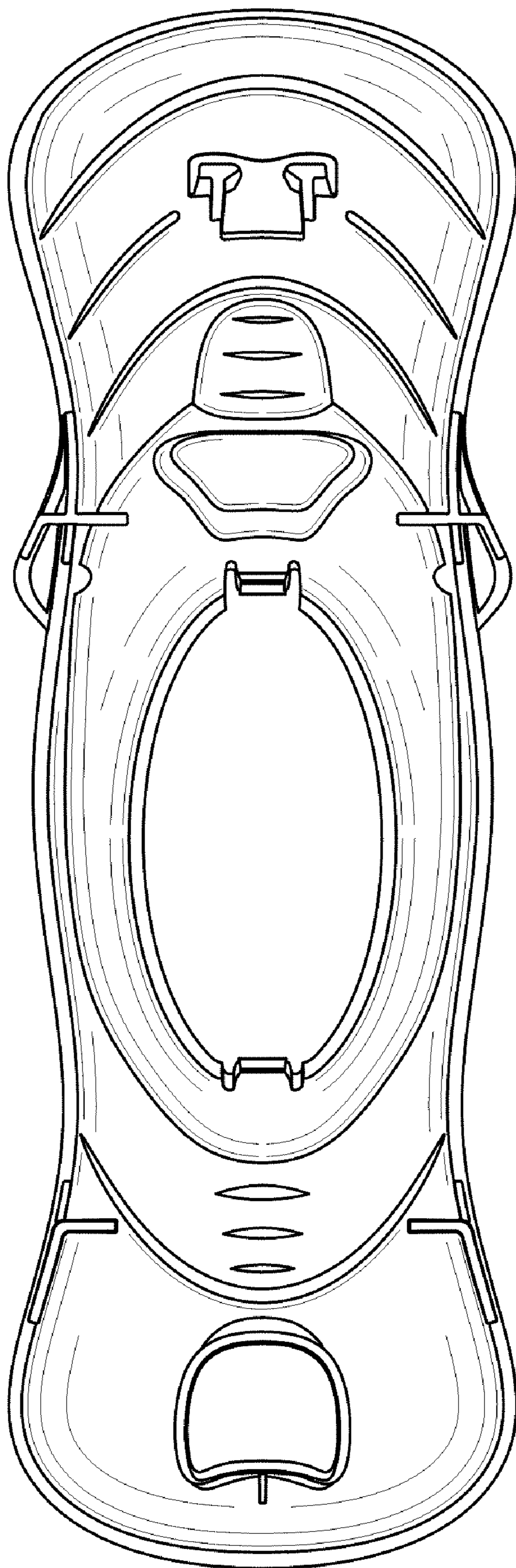

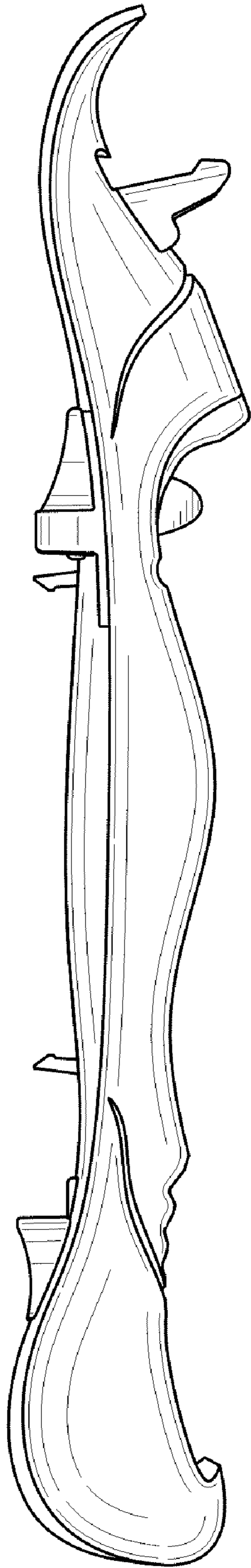

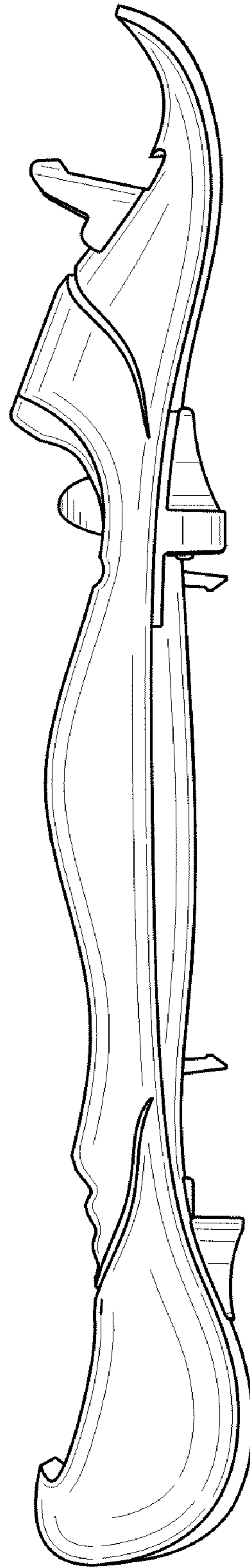

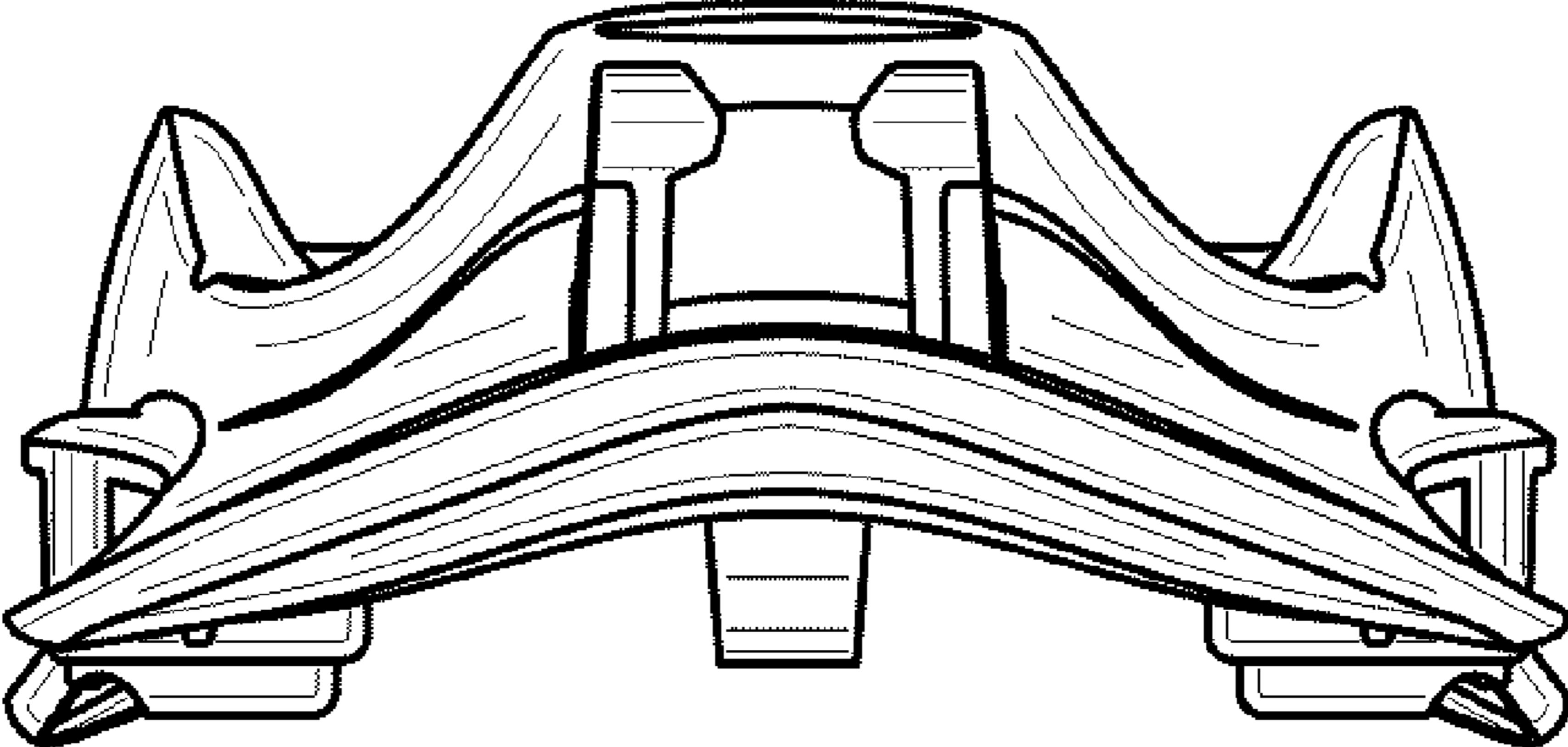

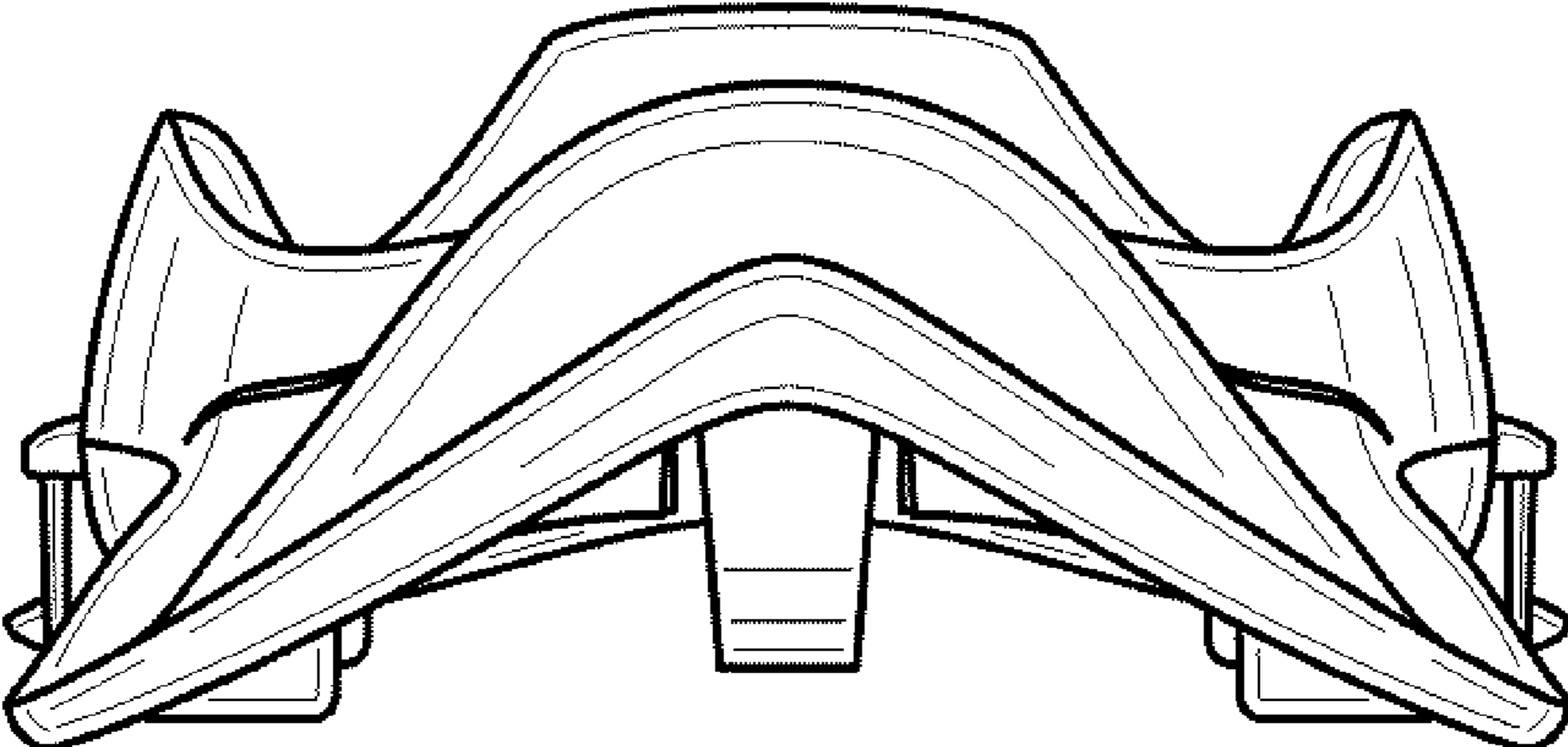
