(57) **CLAIM**

The ornamental design for a necklace, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a necklace showing my new design;

FIG. 2 is a front view of the necklace shown in FIG. 1;

FIG. 3 is a side view of the necklace shown in FIG. 1, with the other side being a mirror image thereof;

FIG. 4 is a front view of the necklace shown in FIG. 1, with the closure shown in an open position, with reference to FIGS. 5 and 6;

FIG. 5 is a sectional view of the loop portion of the closure of the necklace shown in FIG. 1; and,

FIG. 6 is a sectional view of the ball portion of the closure of the necklace shown in FIG. 1.

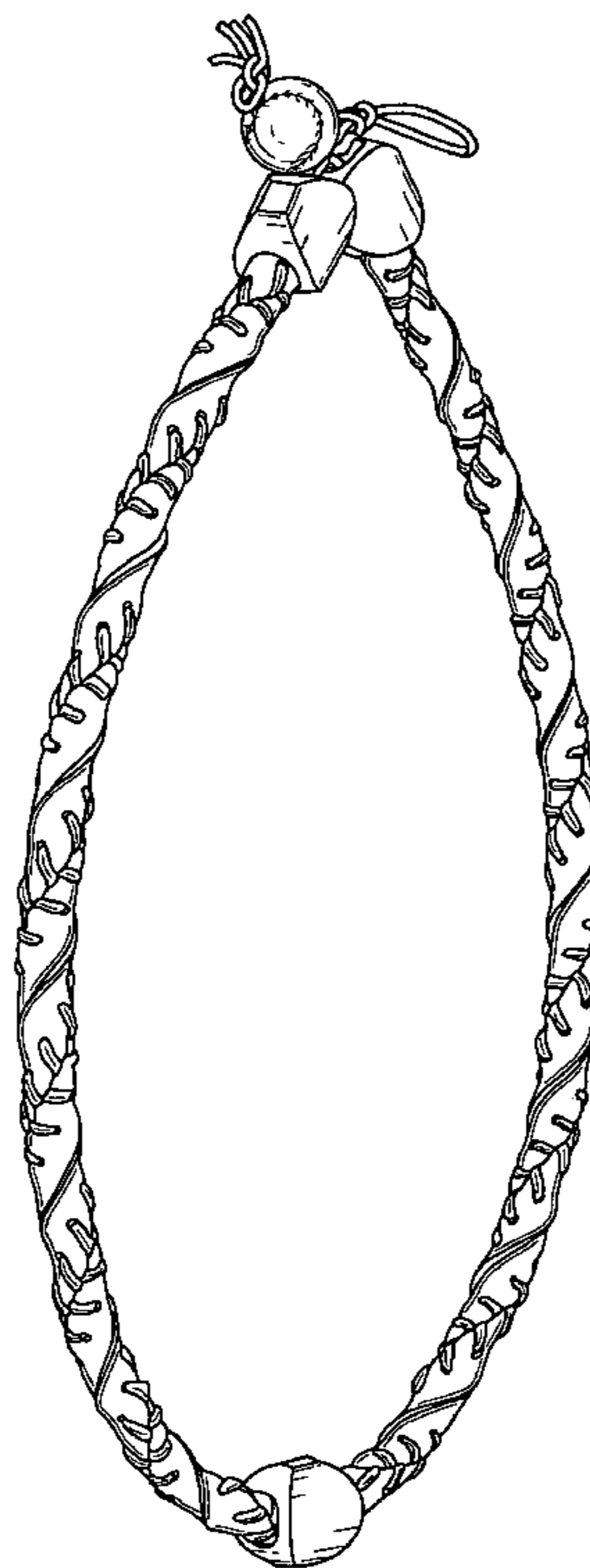

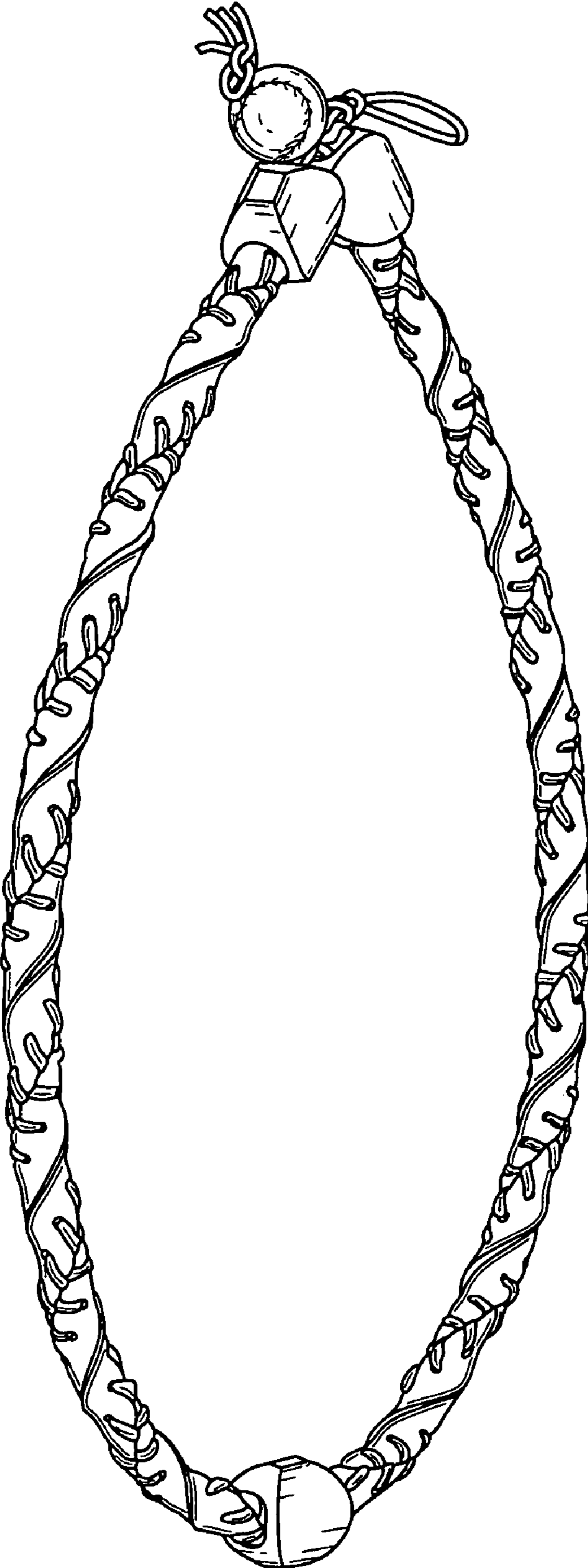

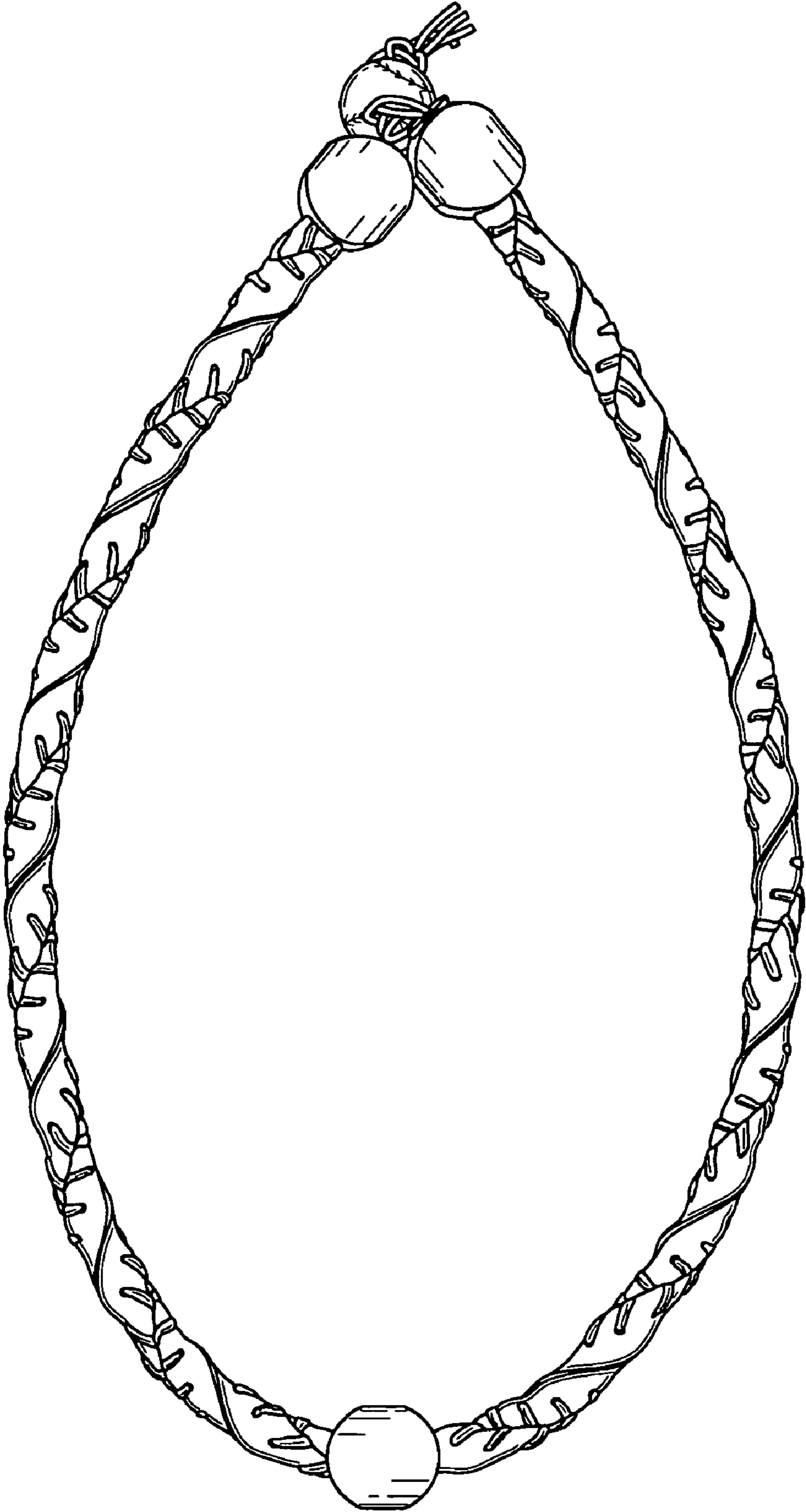

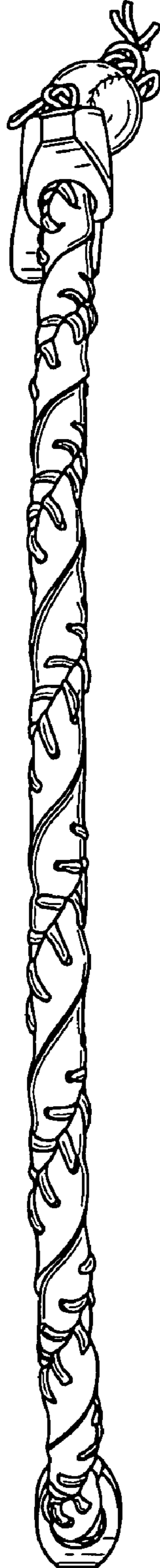

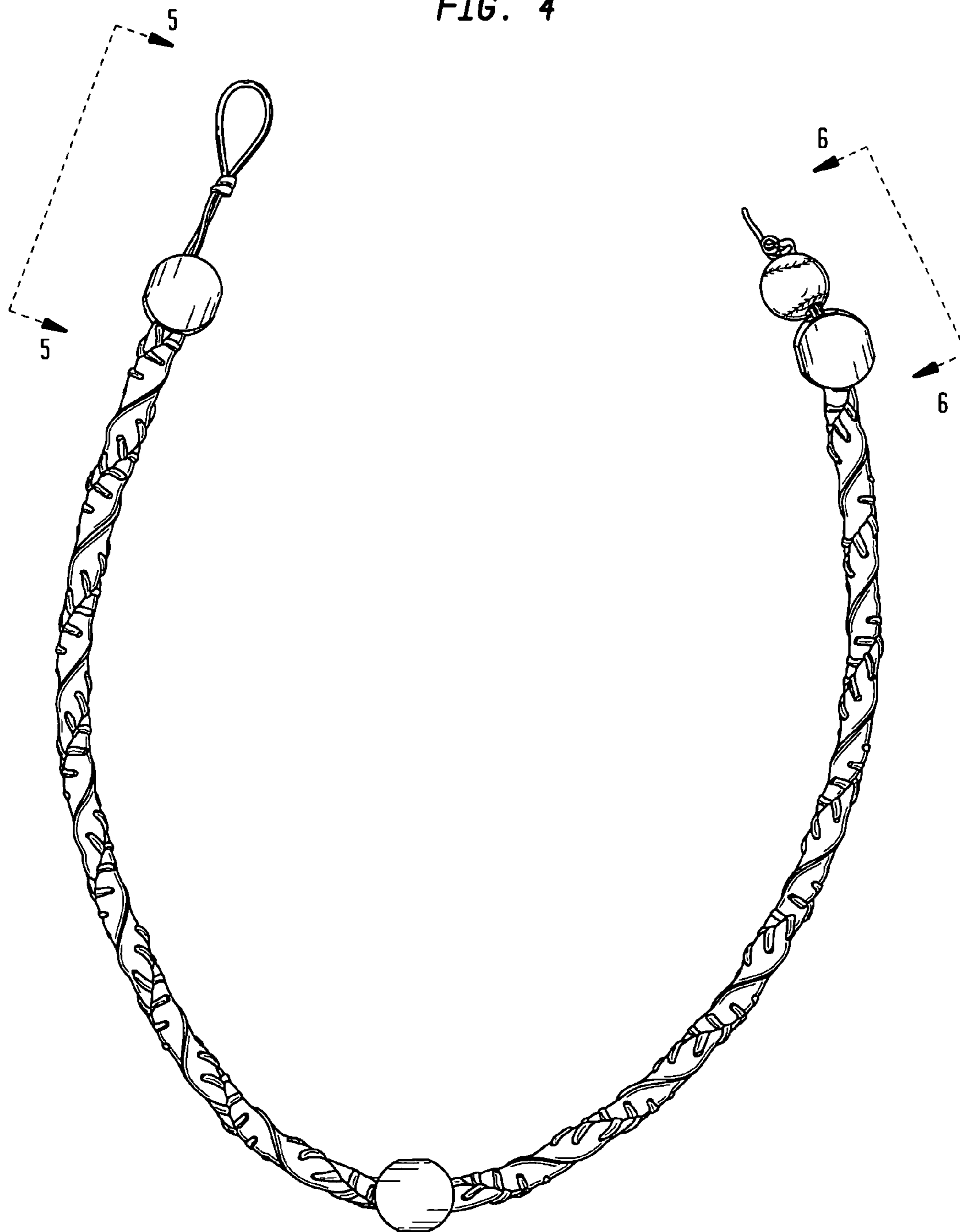

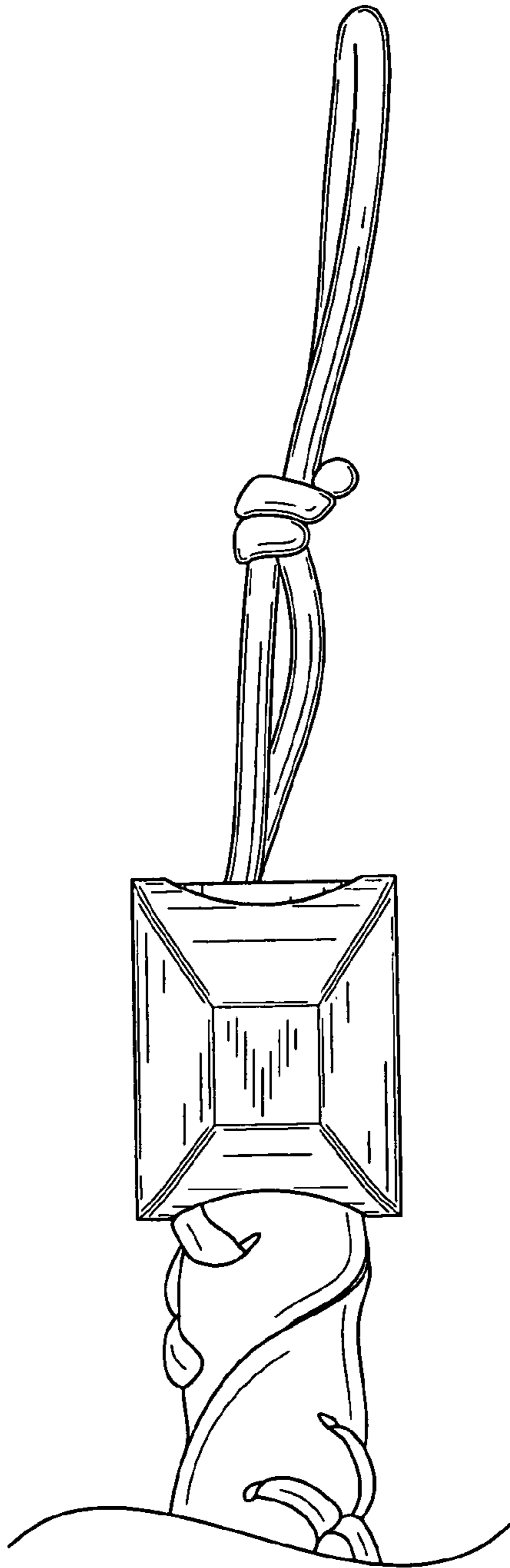
