(57) **CLAIM**

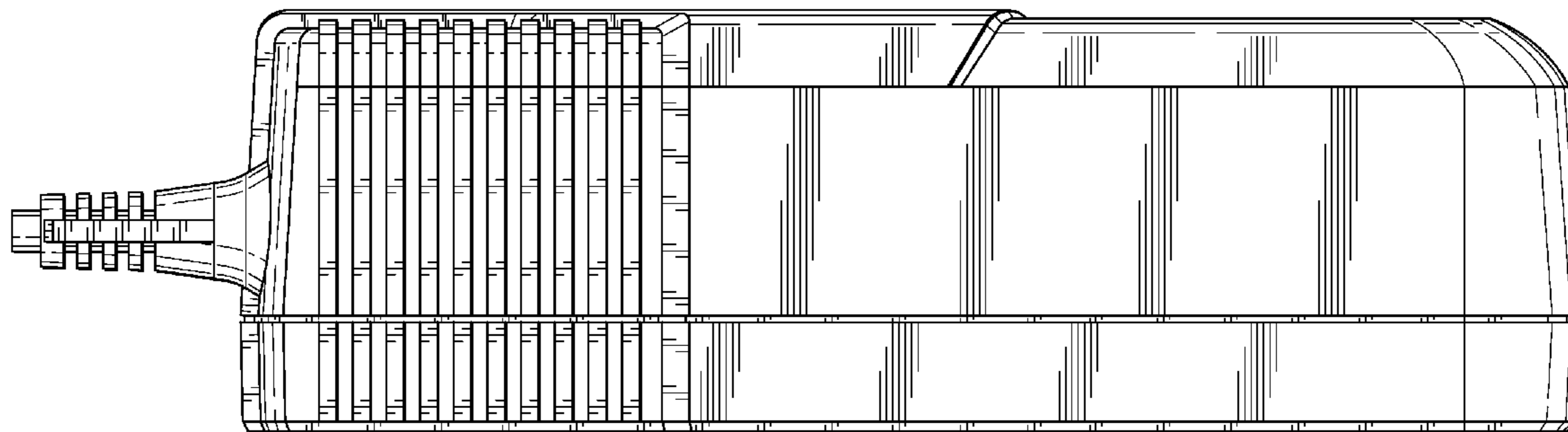
The ornamental design for the battery charger, as shown and described.

**DESCRIPTION**

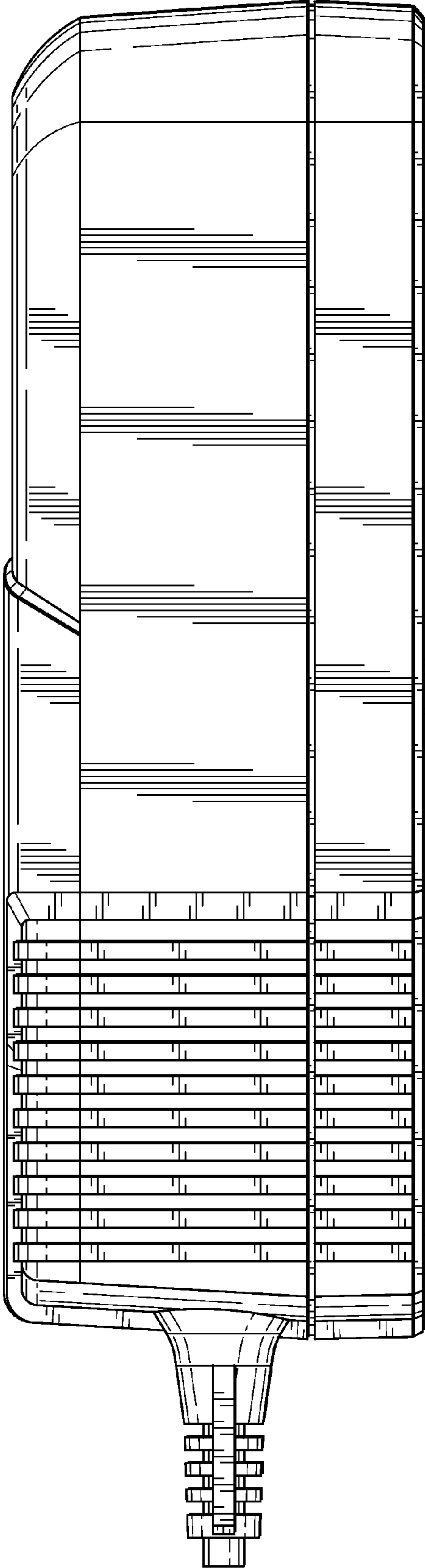

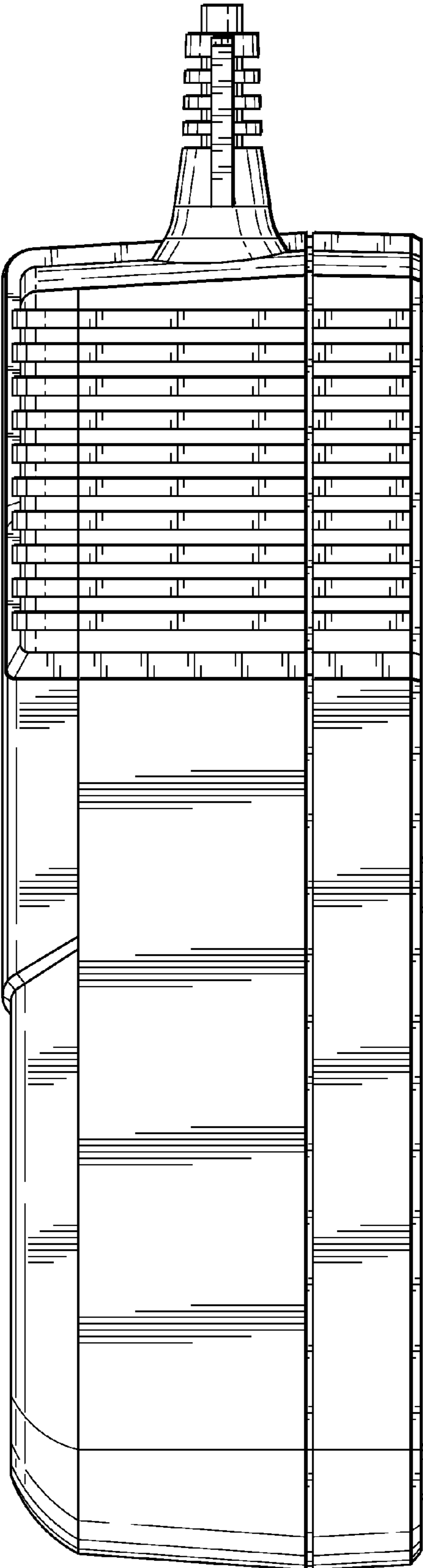

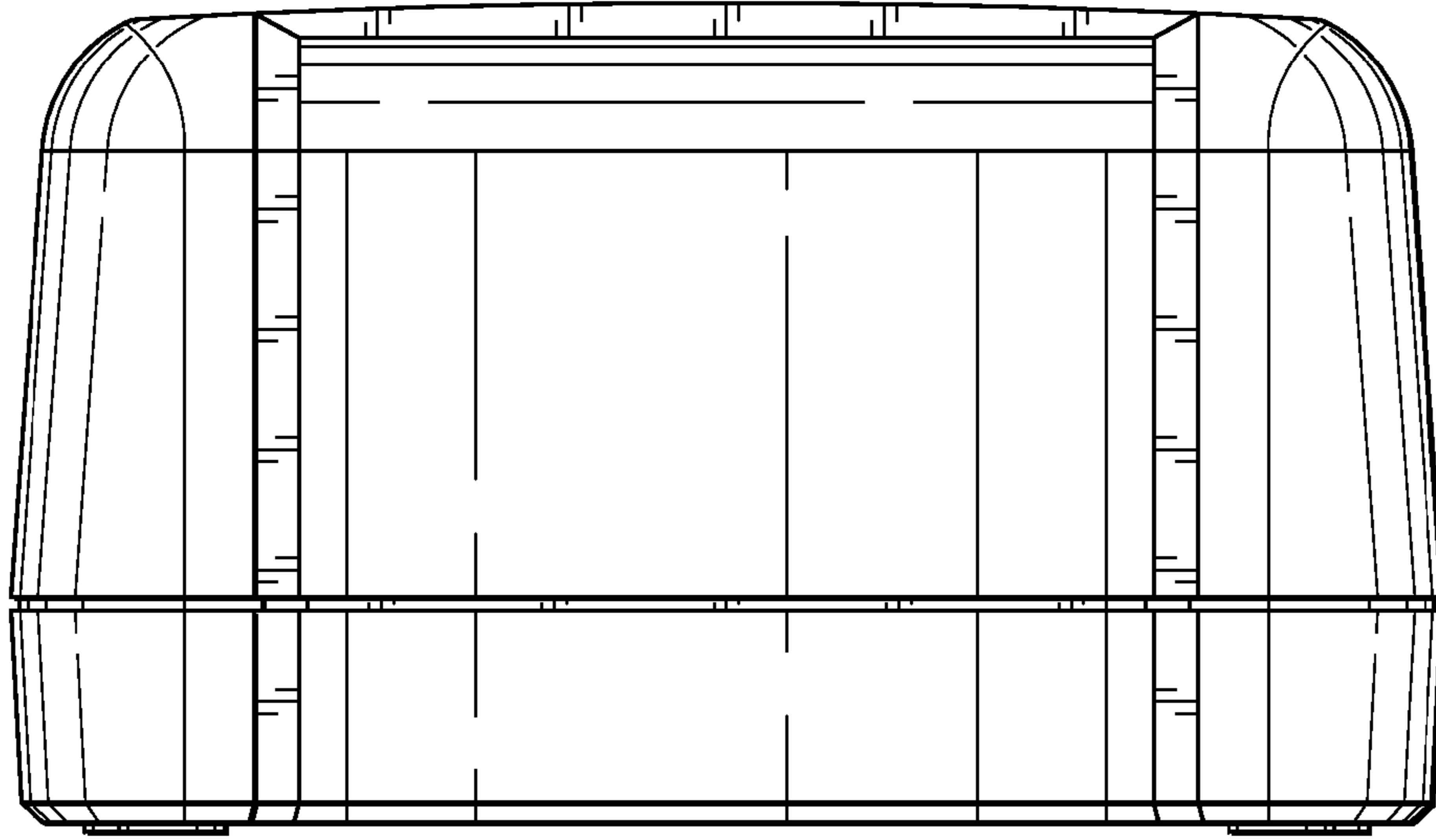

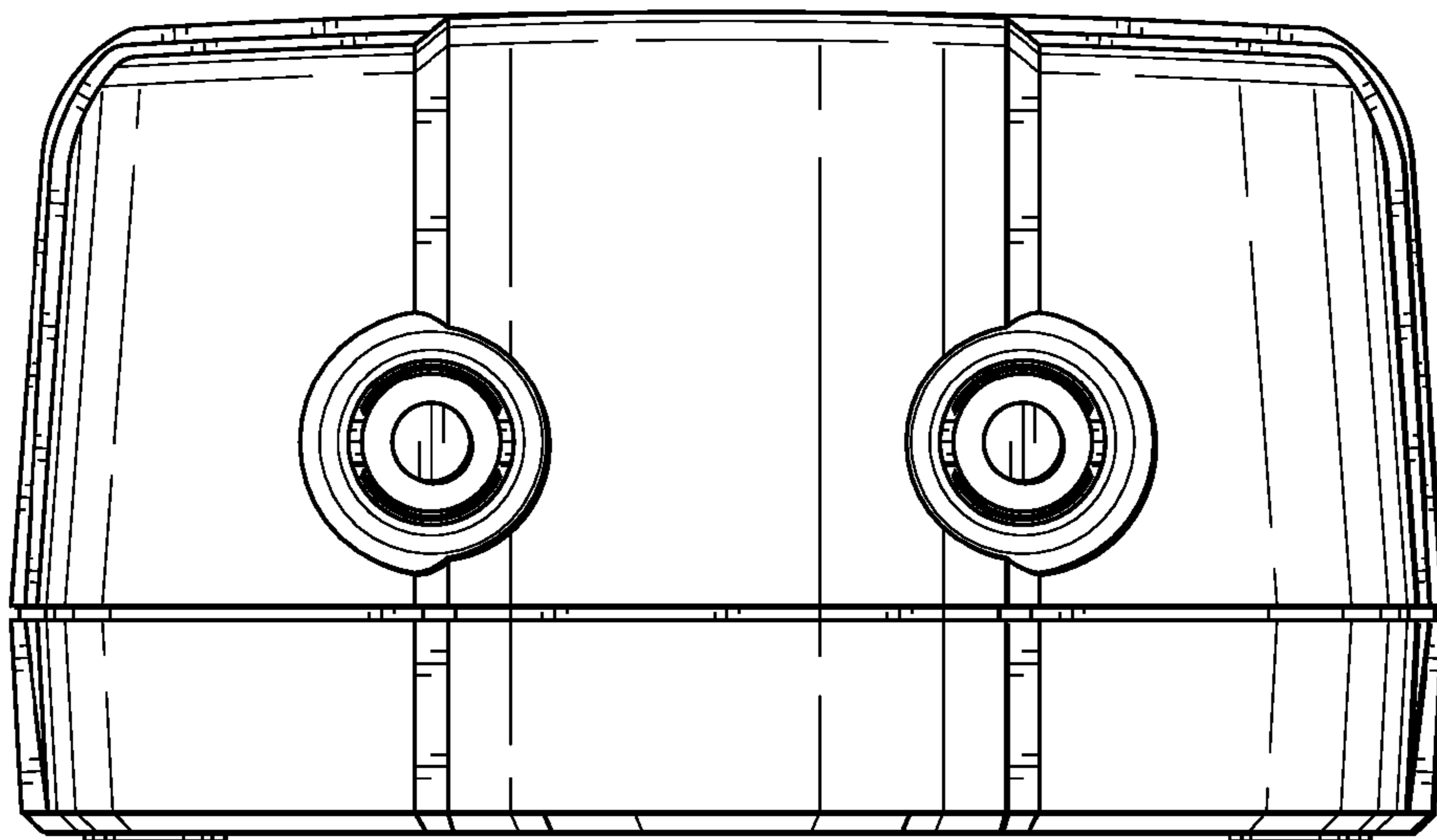

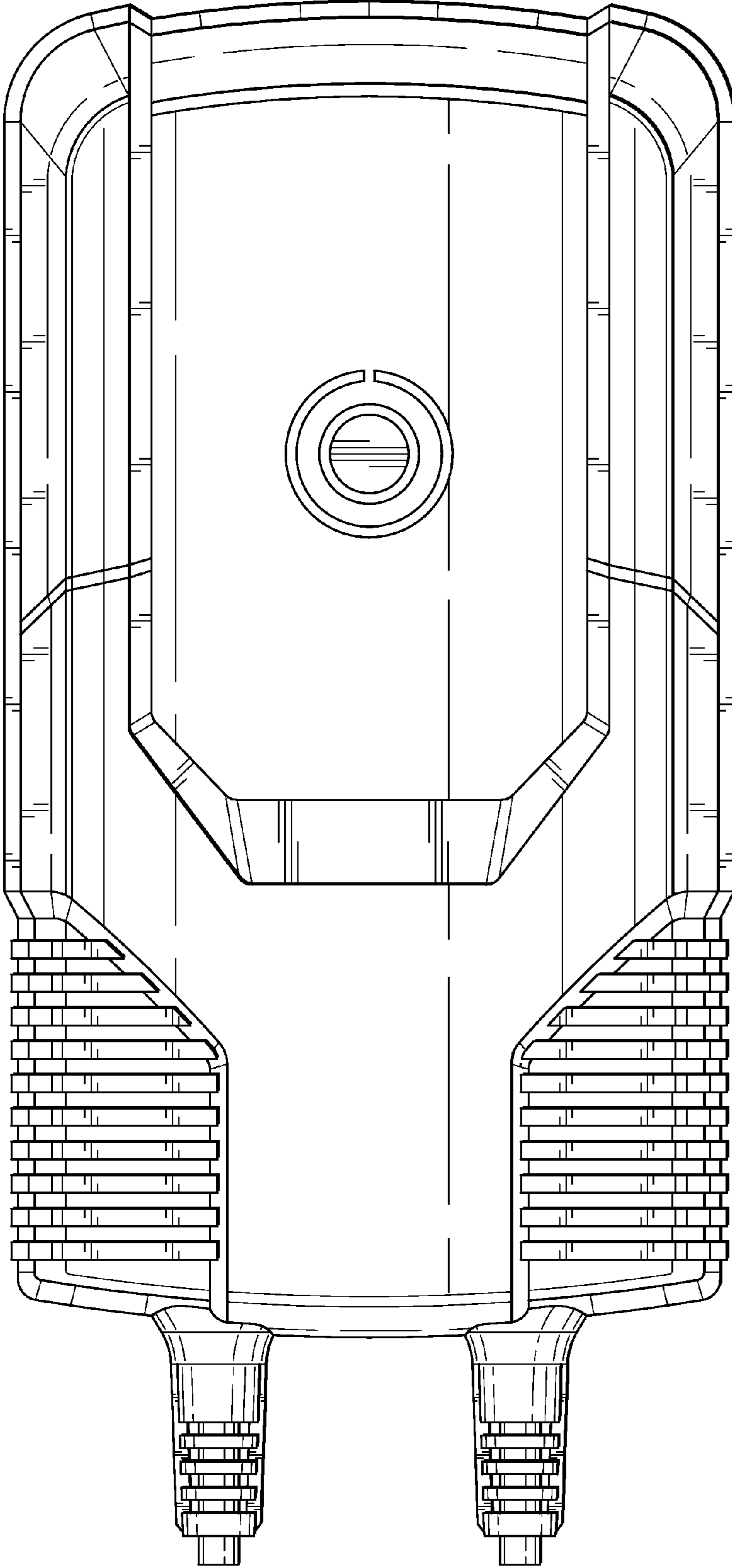

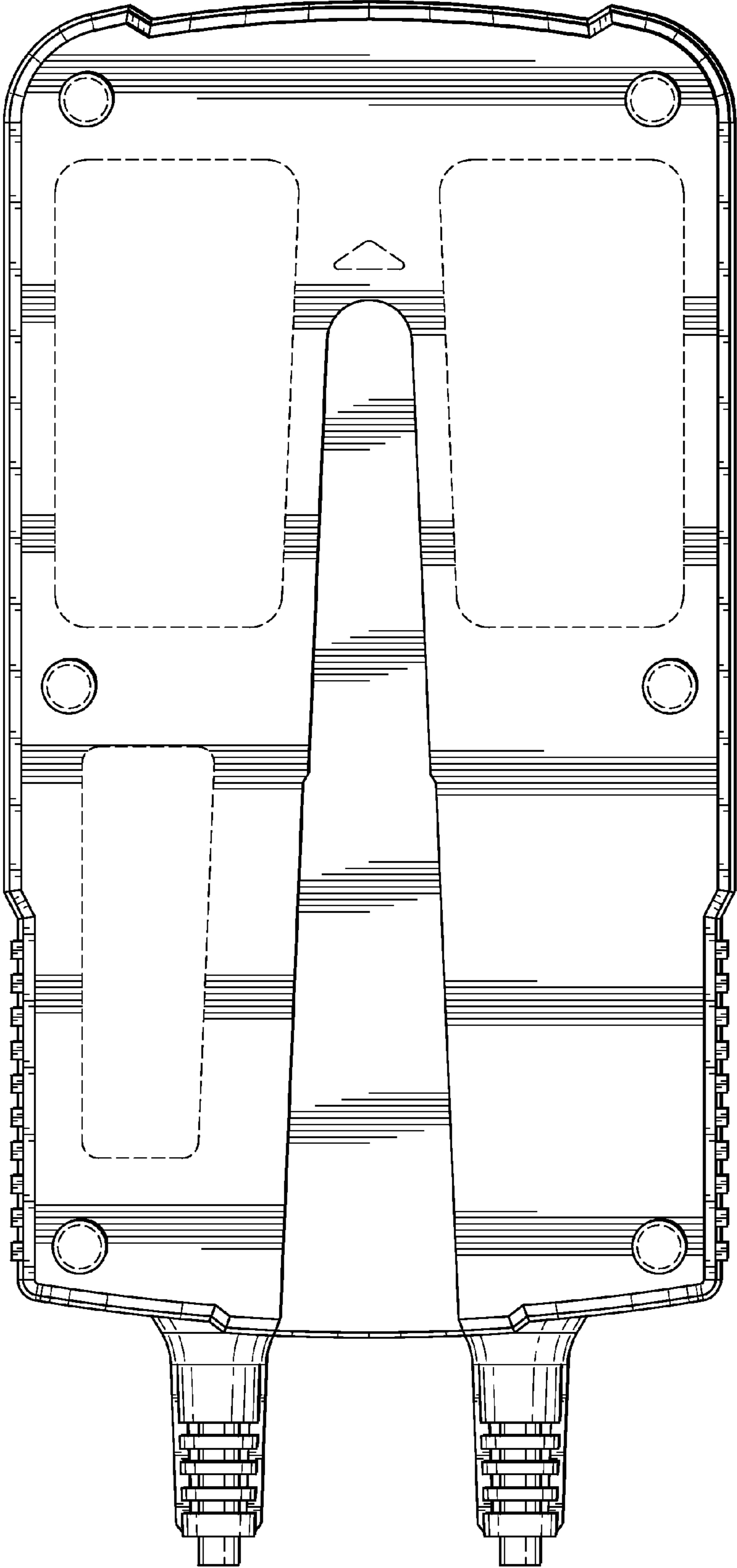
