The ornamental design for an audio ear bud headphone with extended curvature, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of an audio ear bud headphone with extended curvature showing our new design

FIG. 4 is a left, side elevation view thereof;

FIG. 6 is a right, side elevation view thereof;

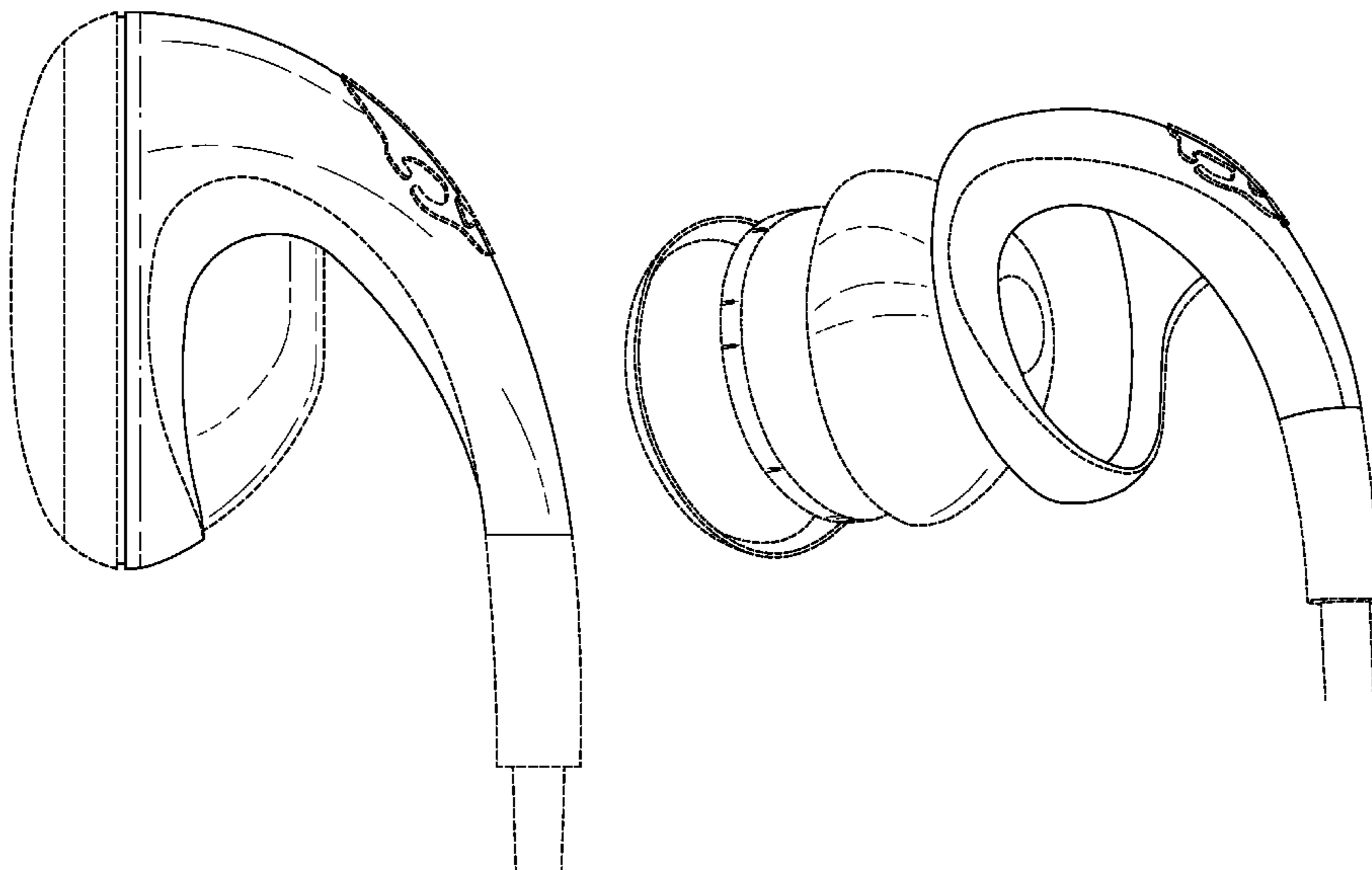
FIG. 7 is a top plan view thereof;

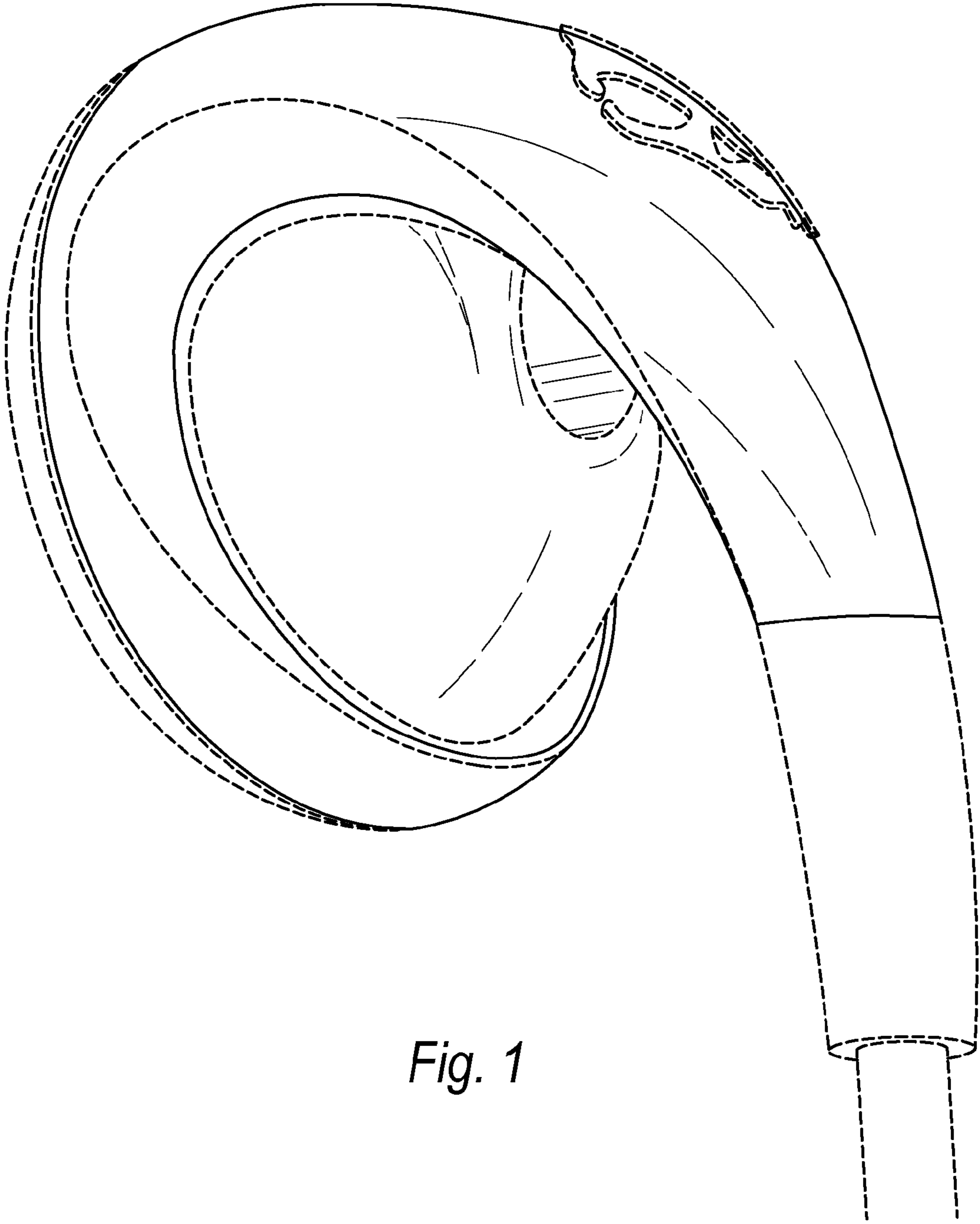

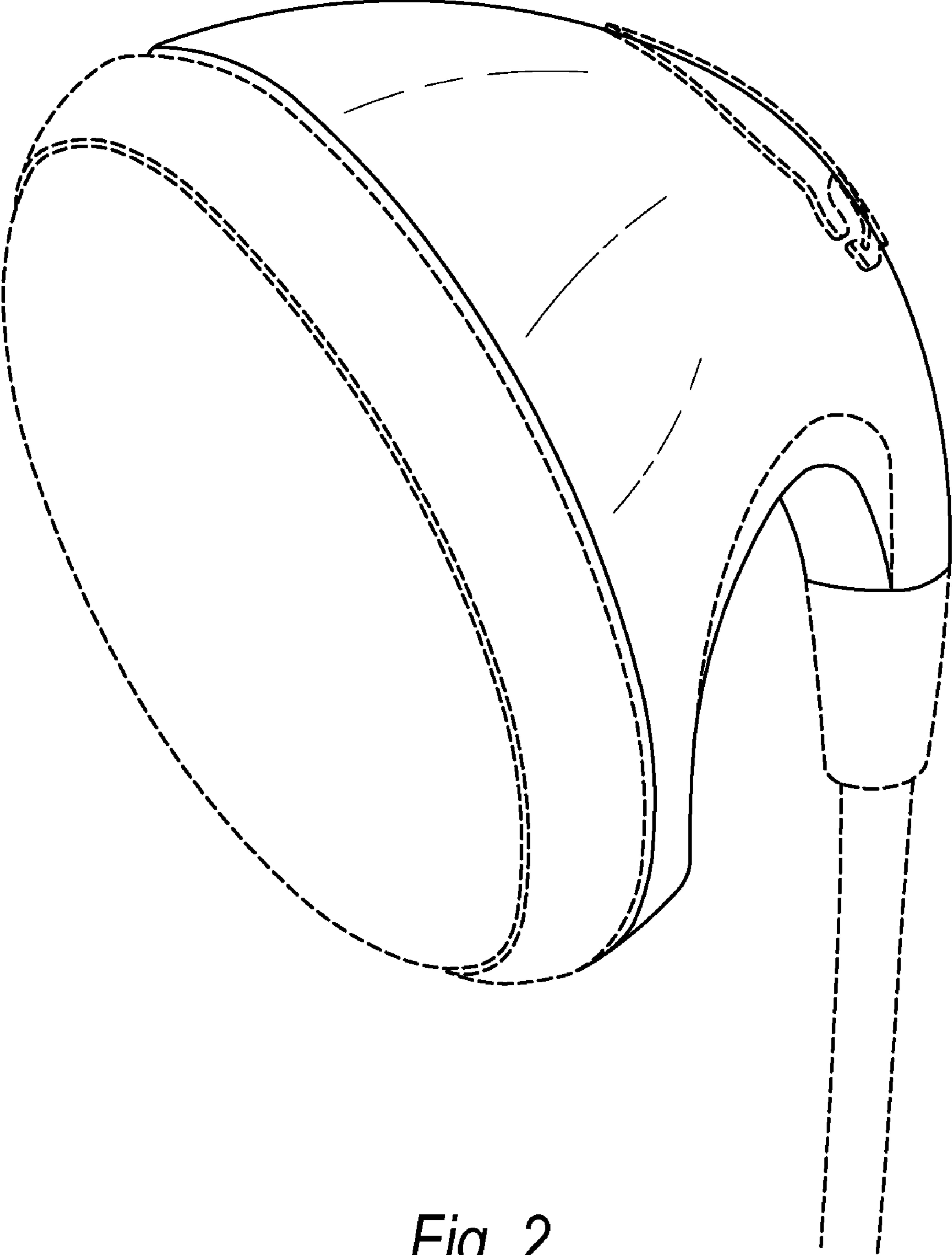

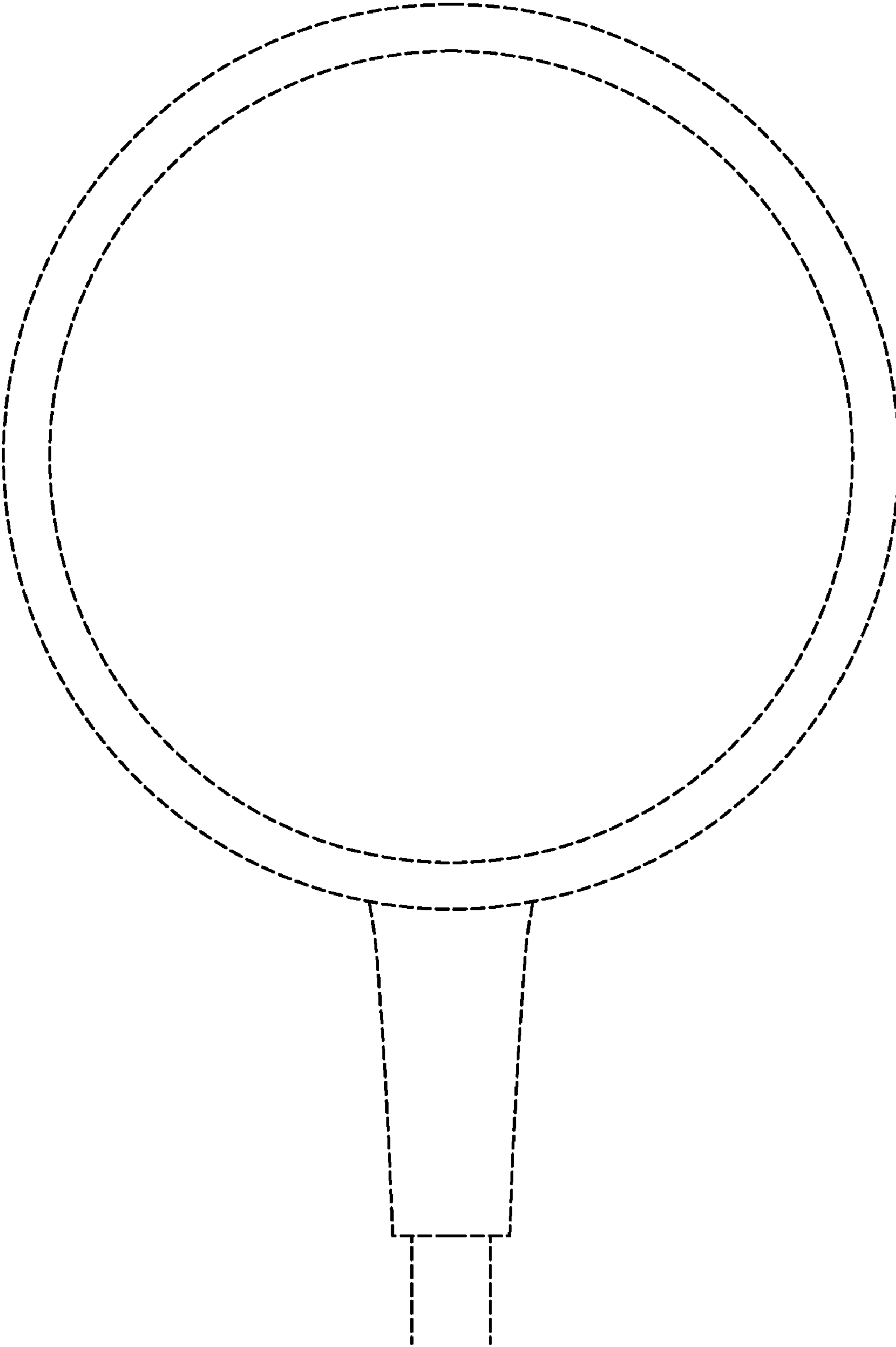

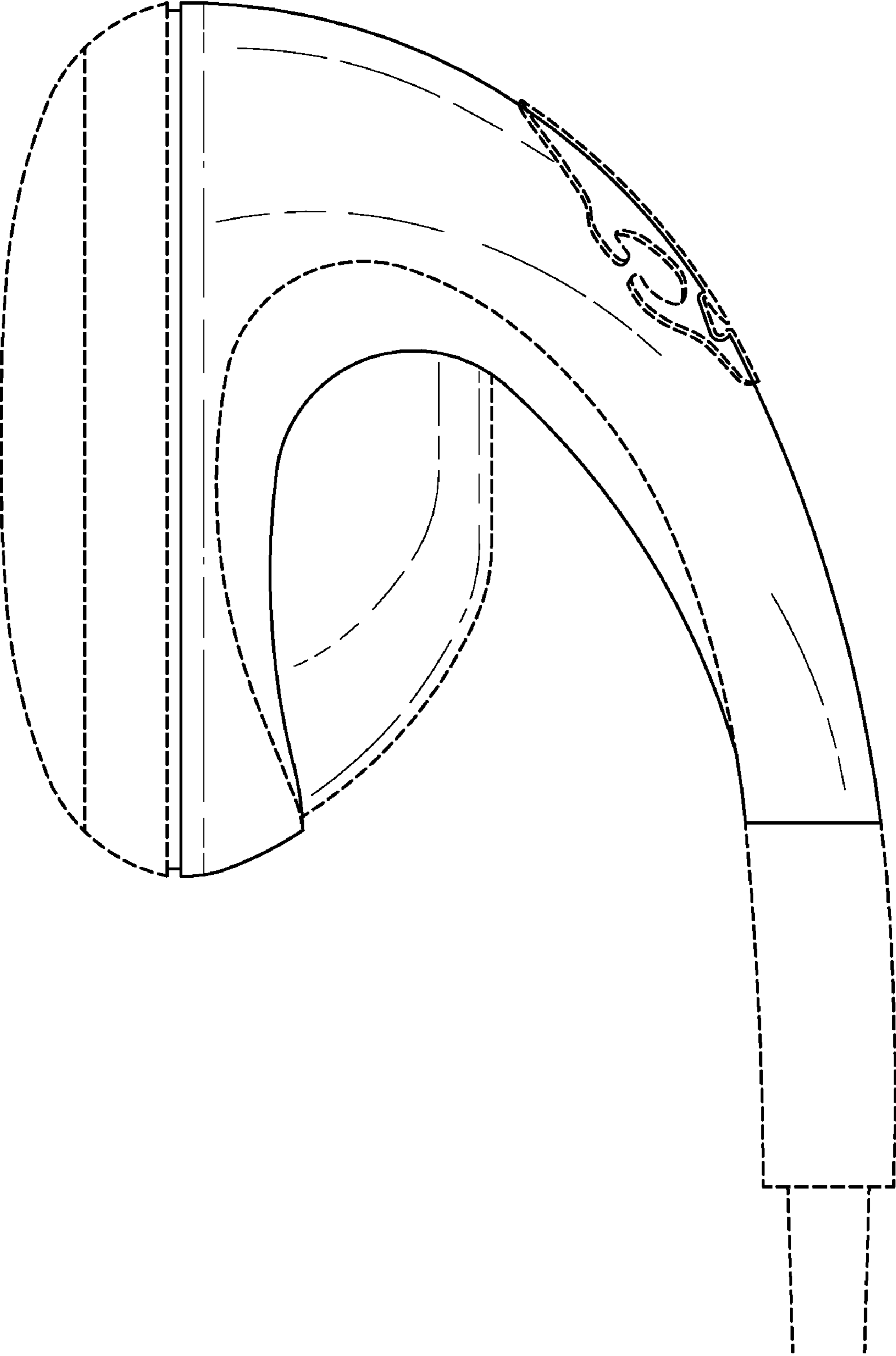

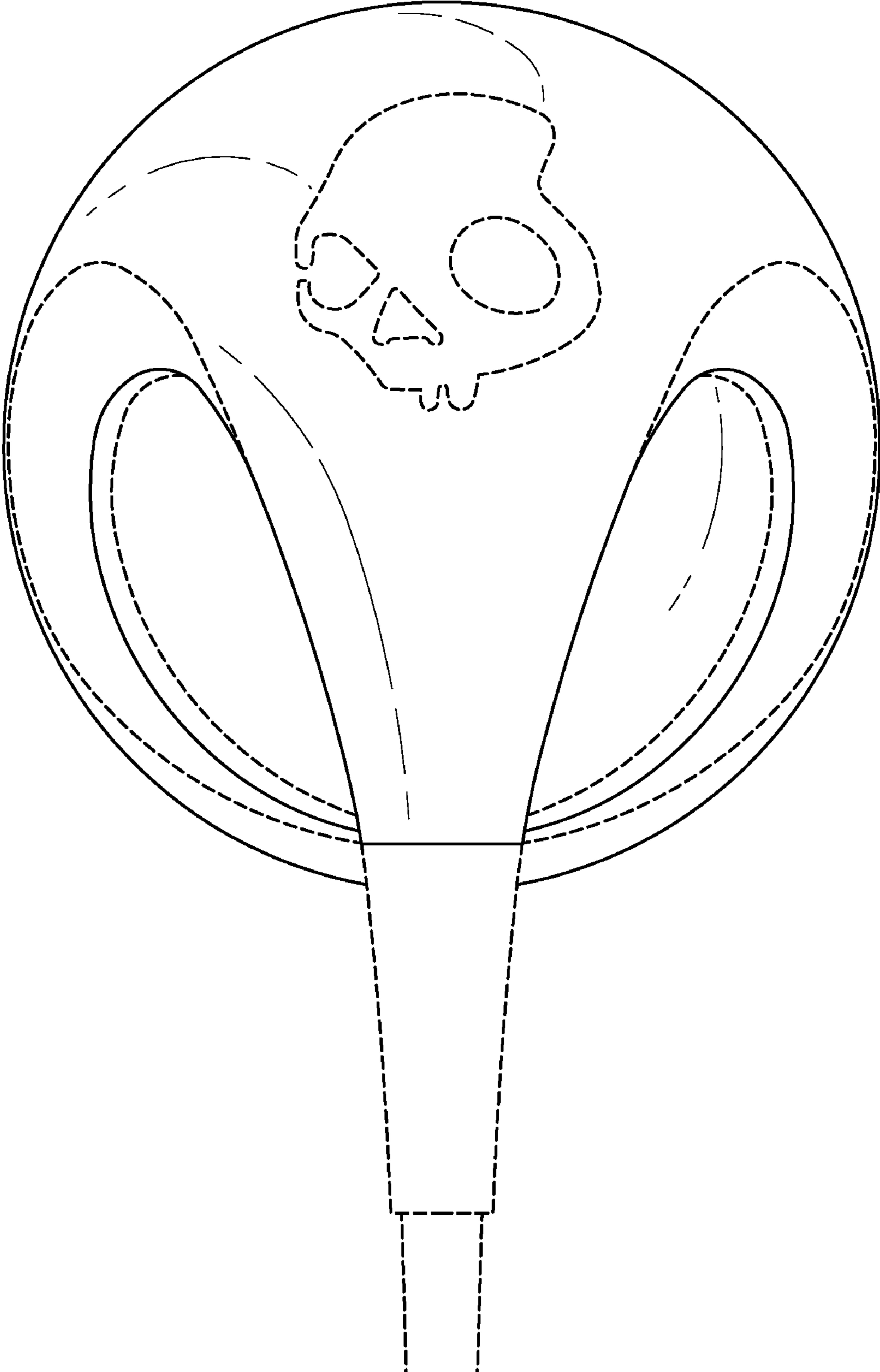

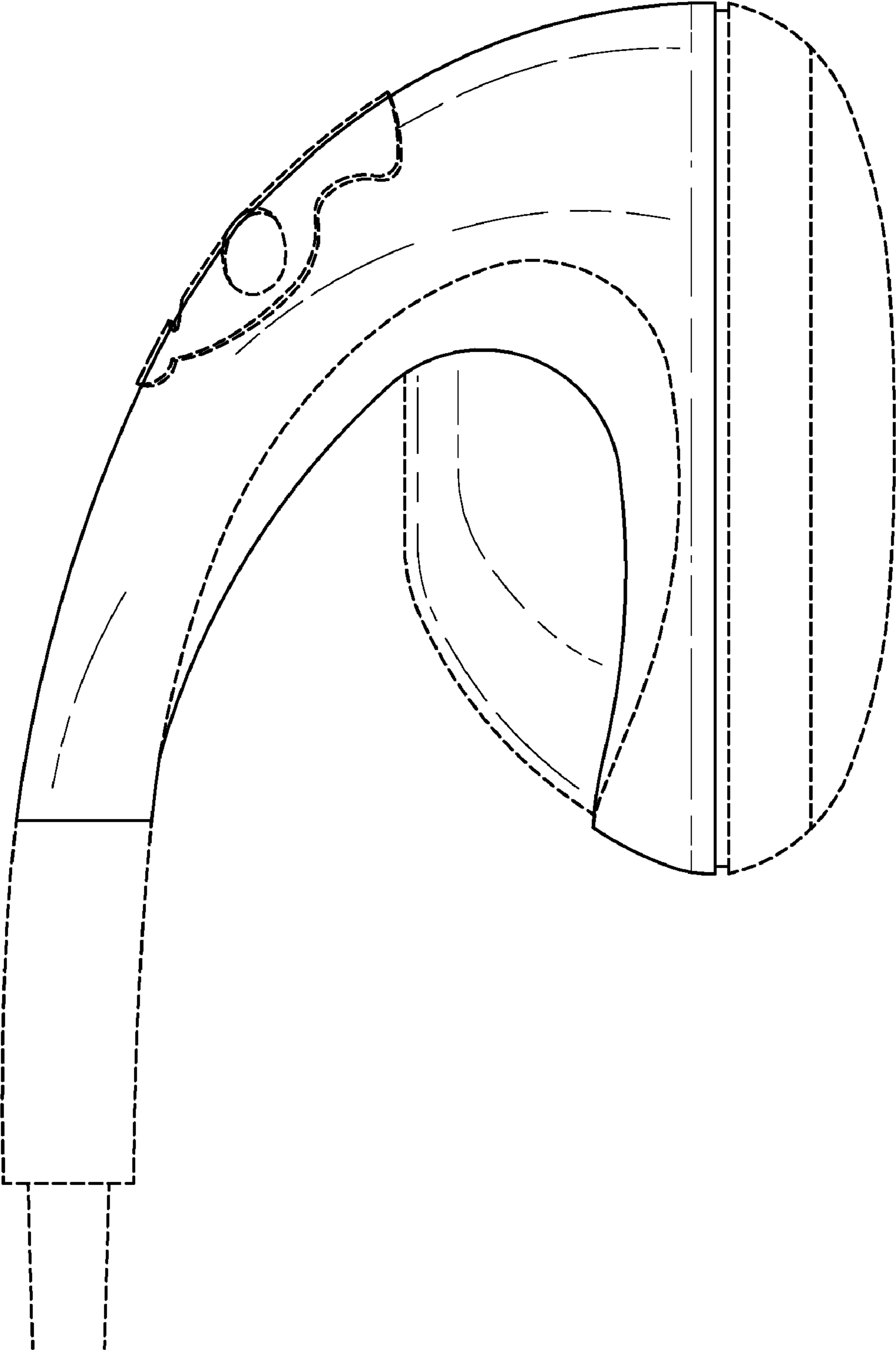

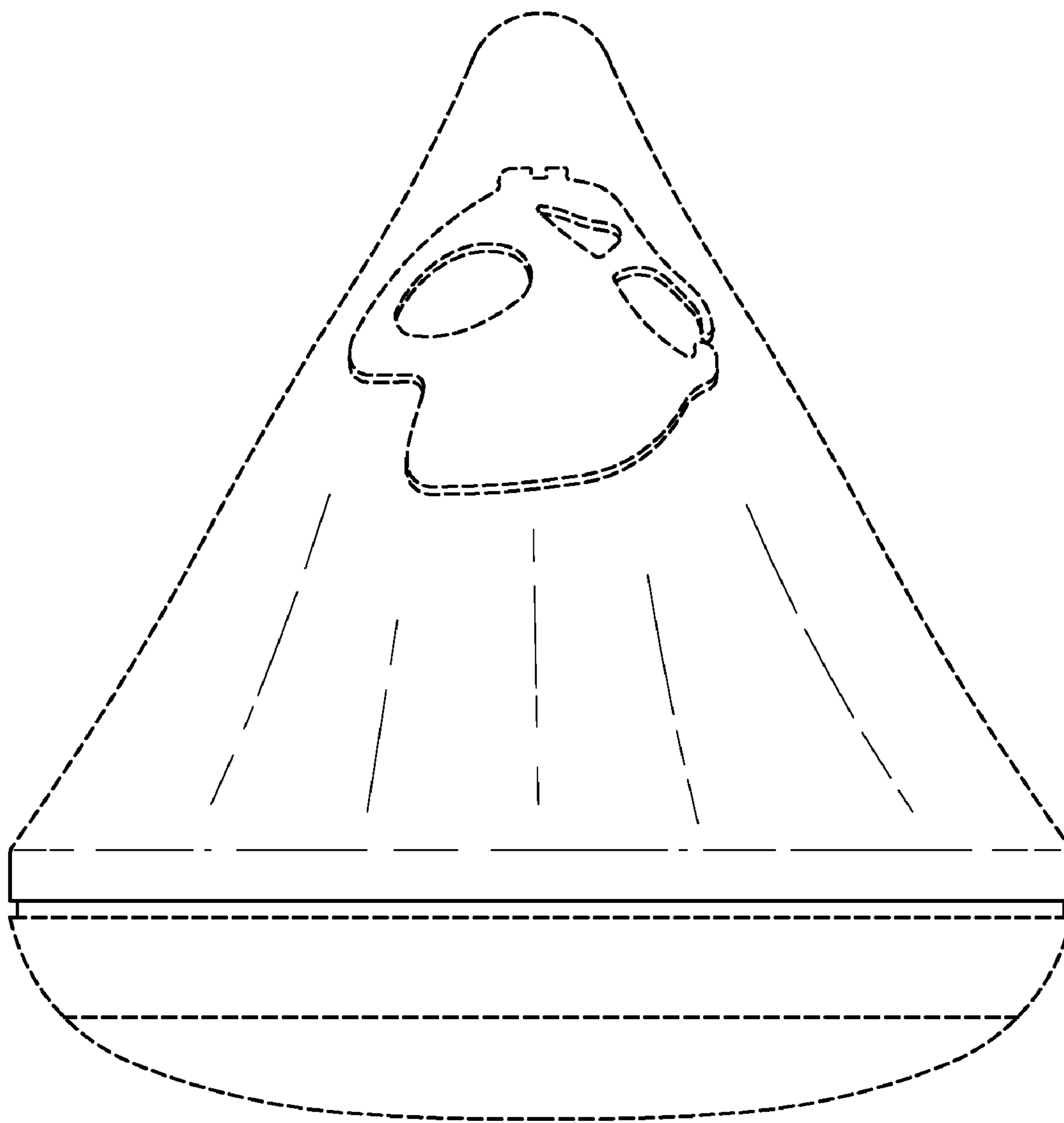

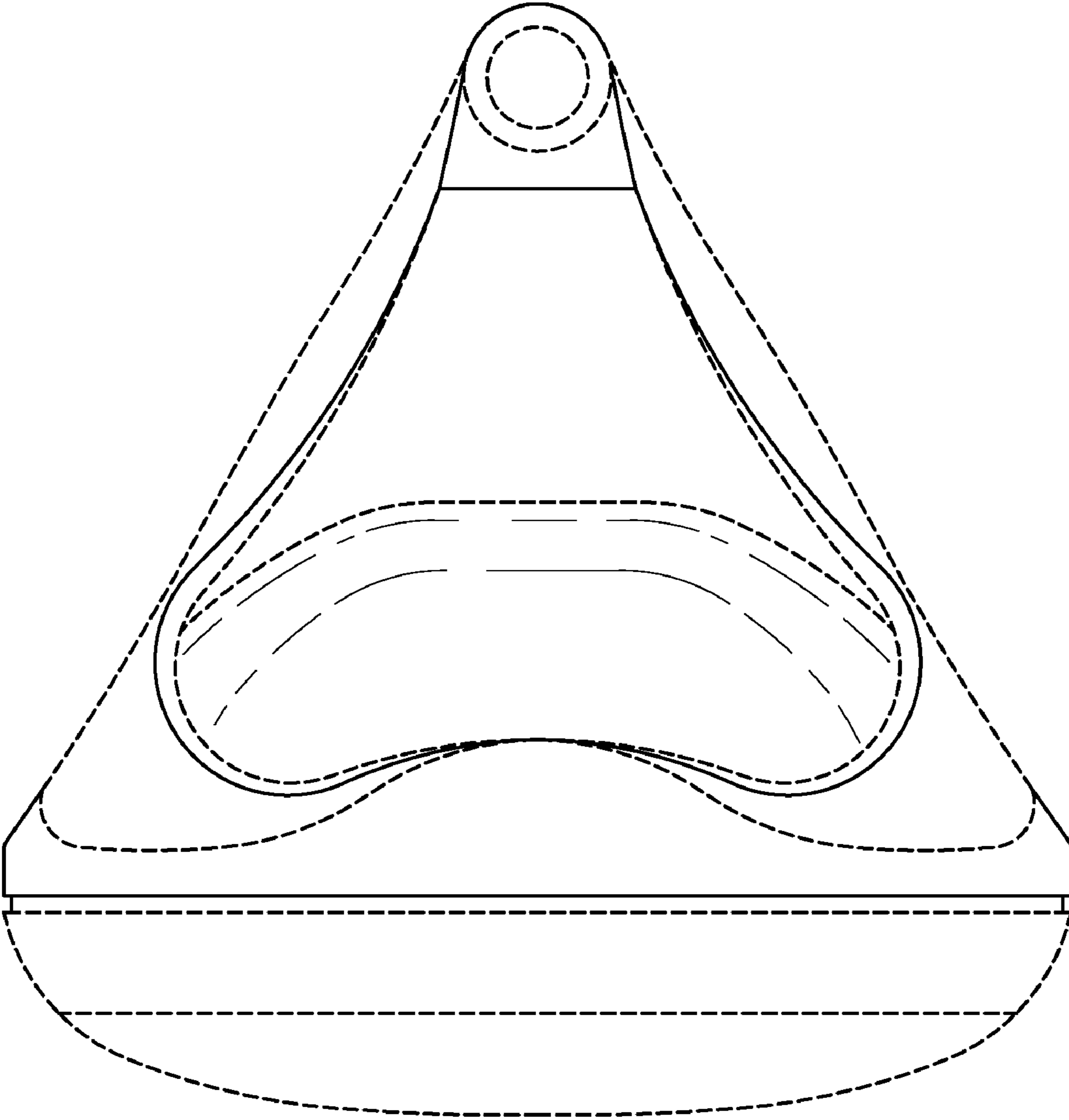

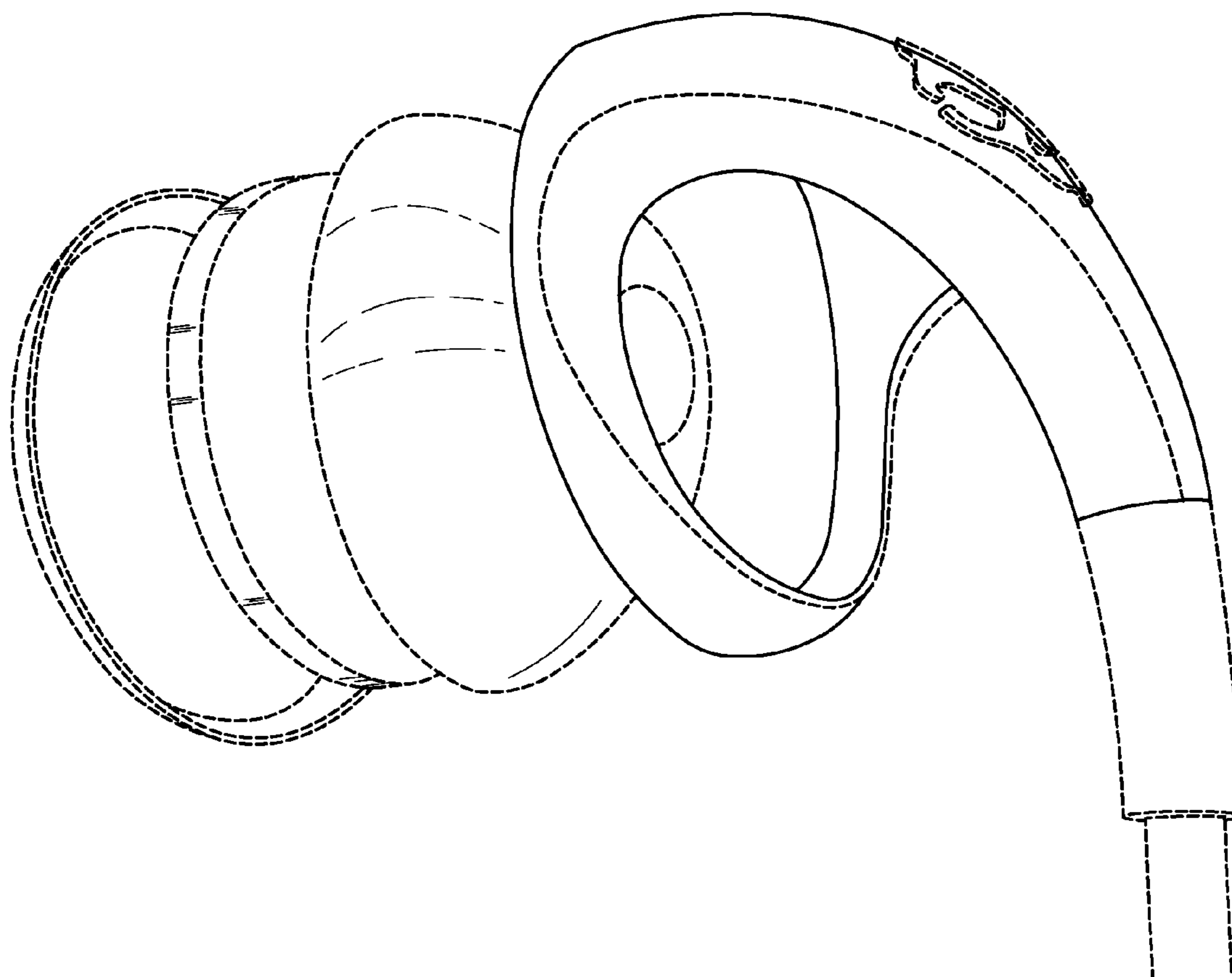
