**DESCRIPTION**

FIG. 1 is a front perspective view of a case for electronic device, showing our new design;

FIG. 2 is a front elevational view thereof;

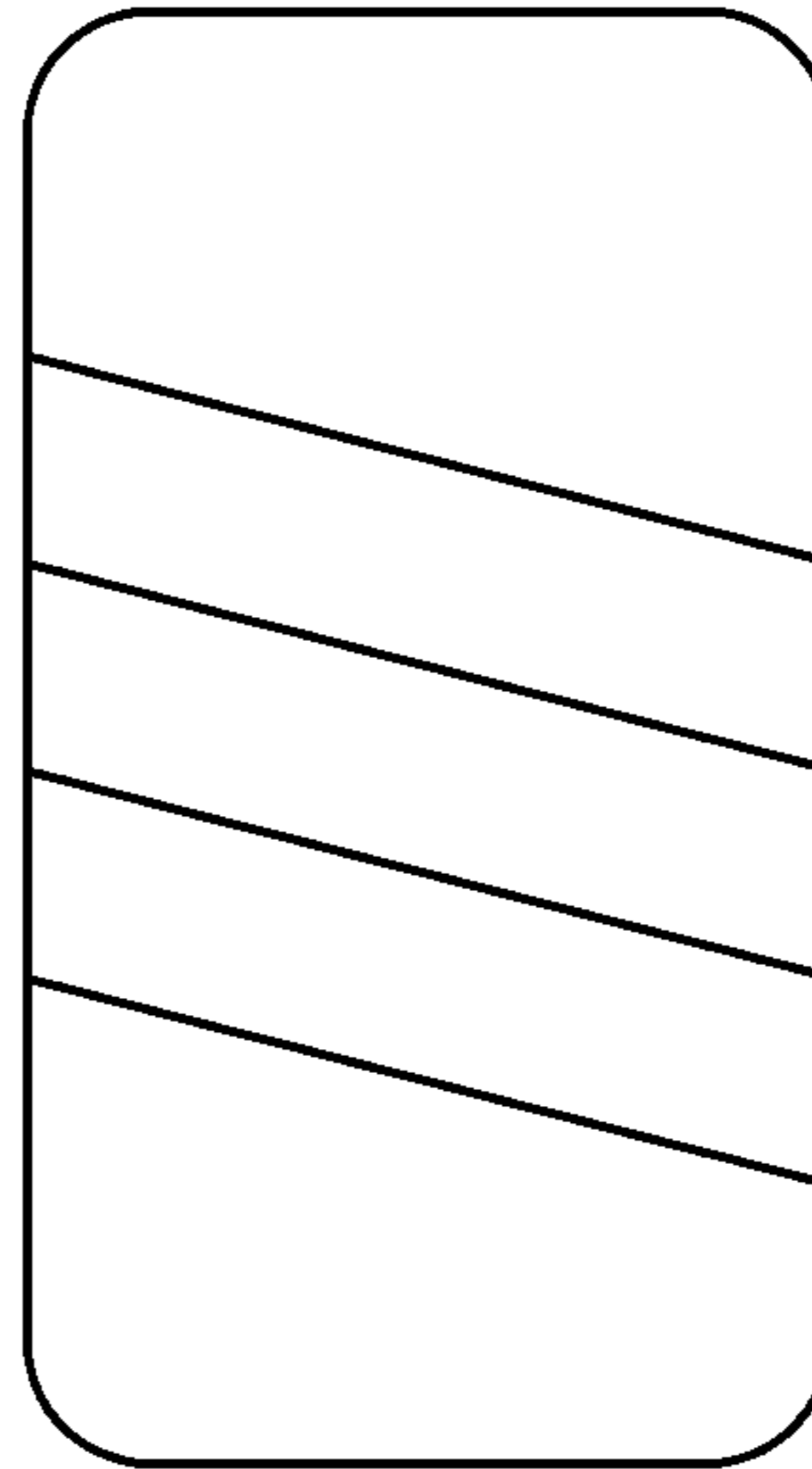
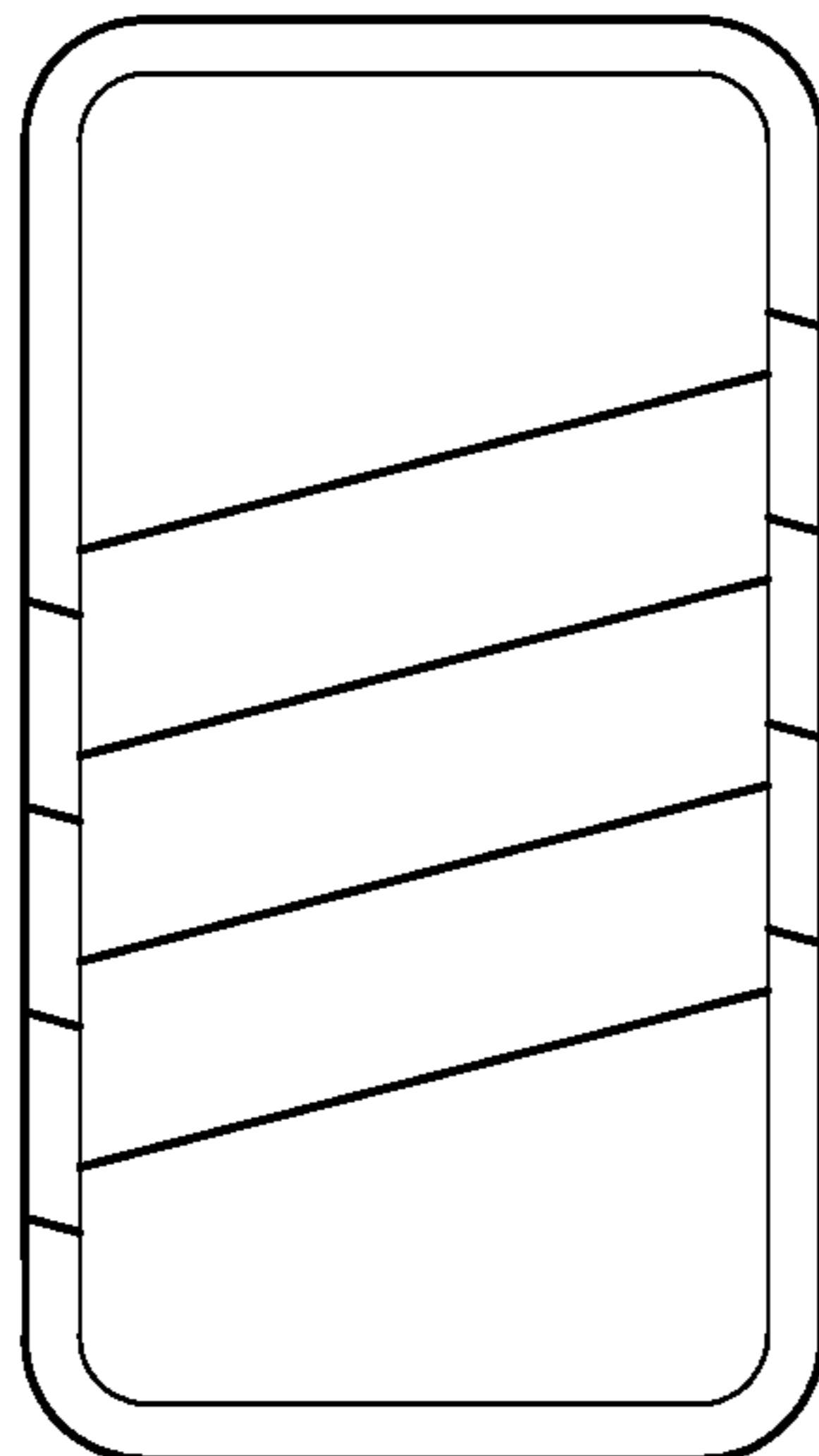
FIG. 3 is a right side elevational view thereof;

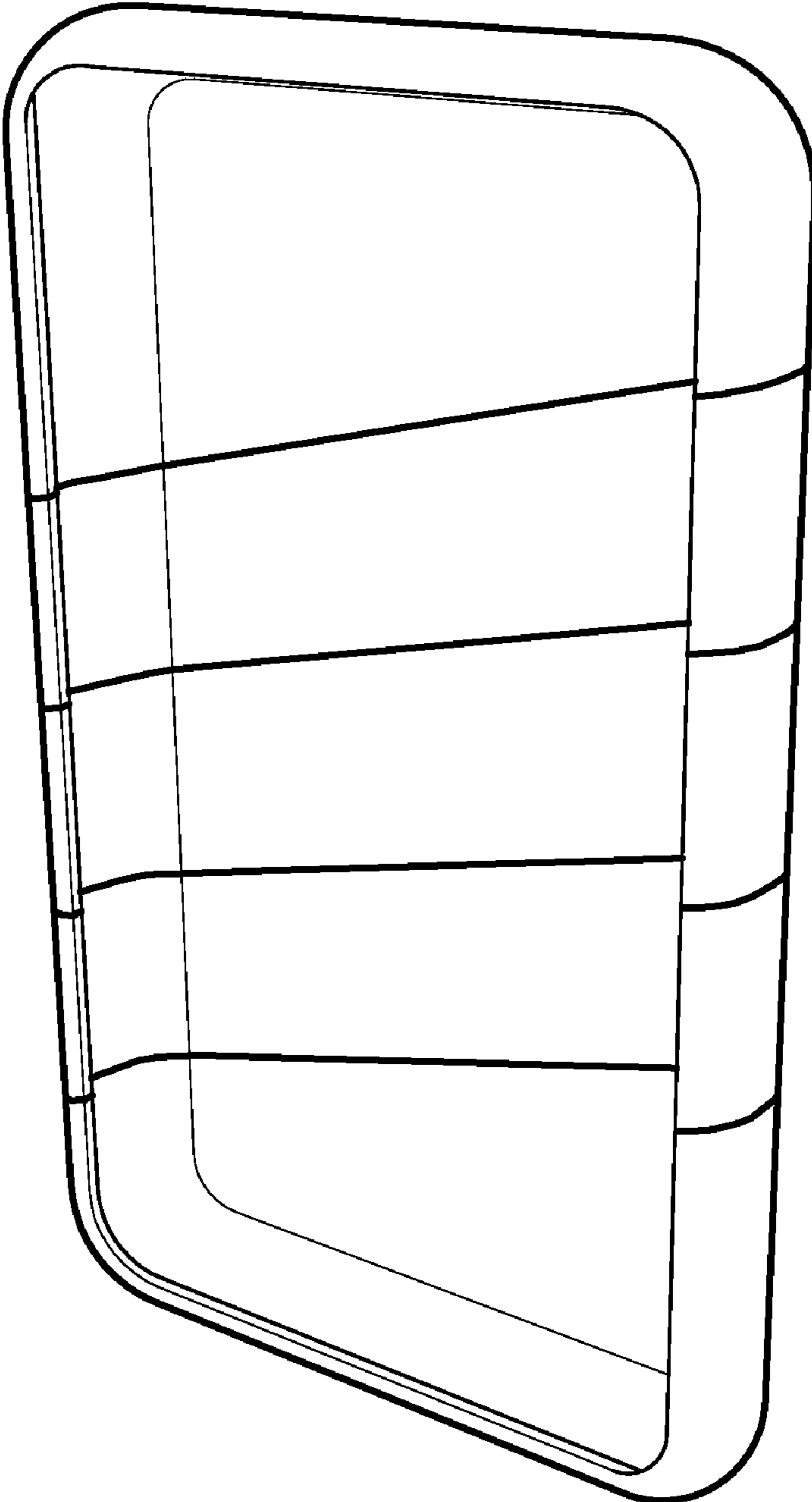

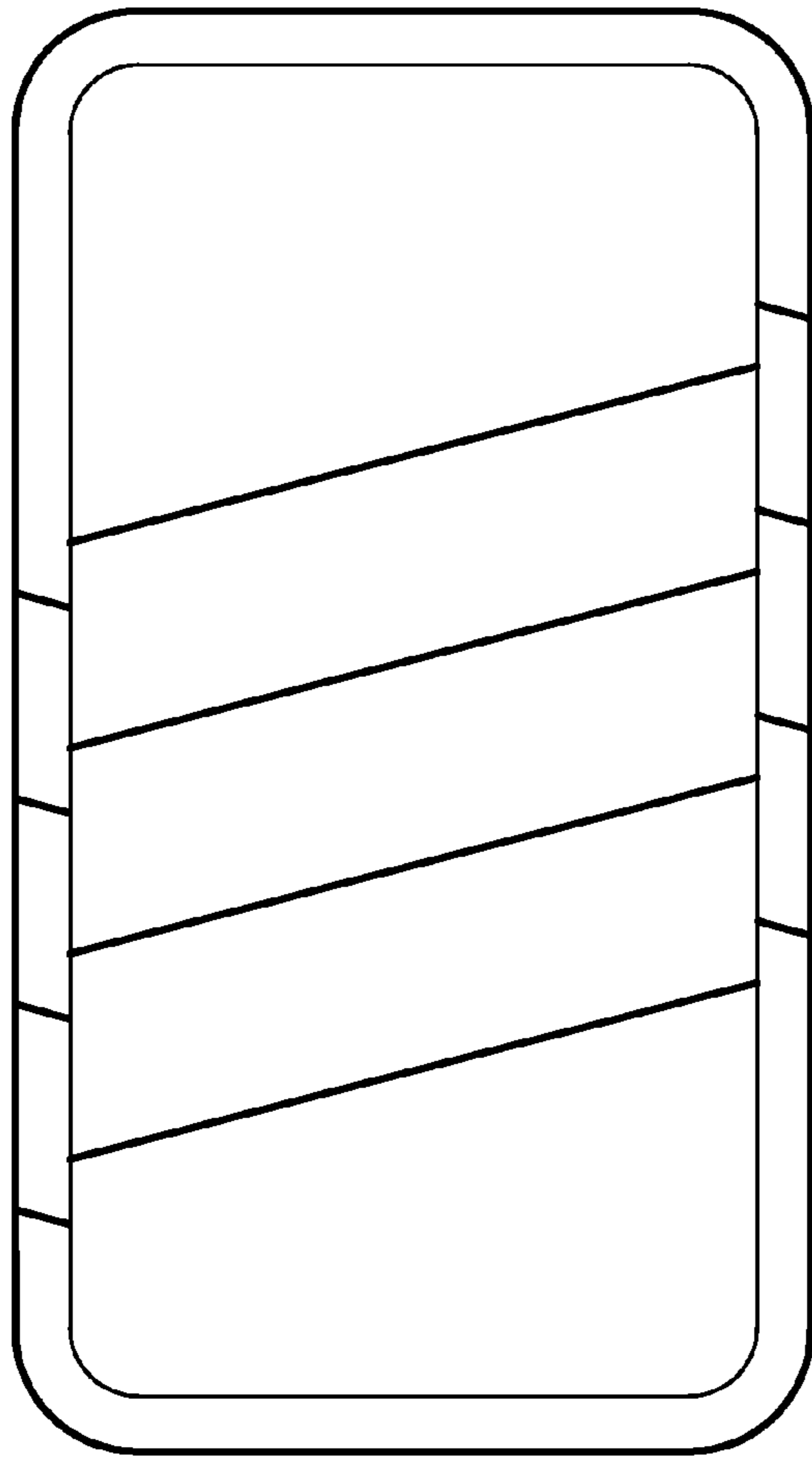

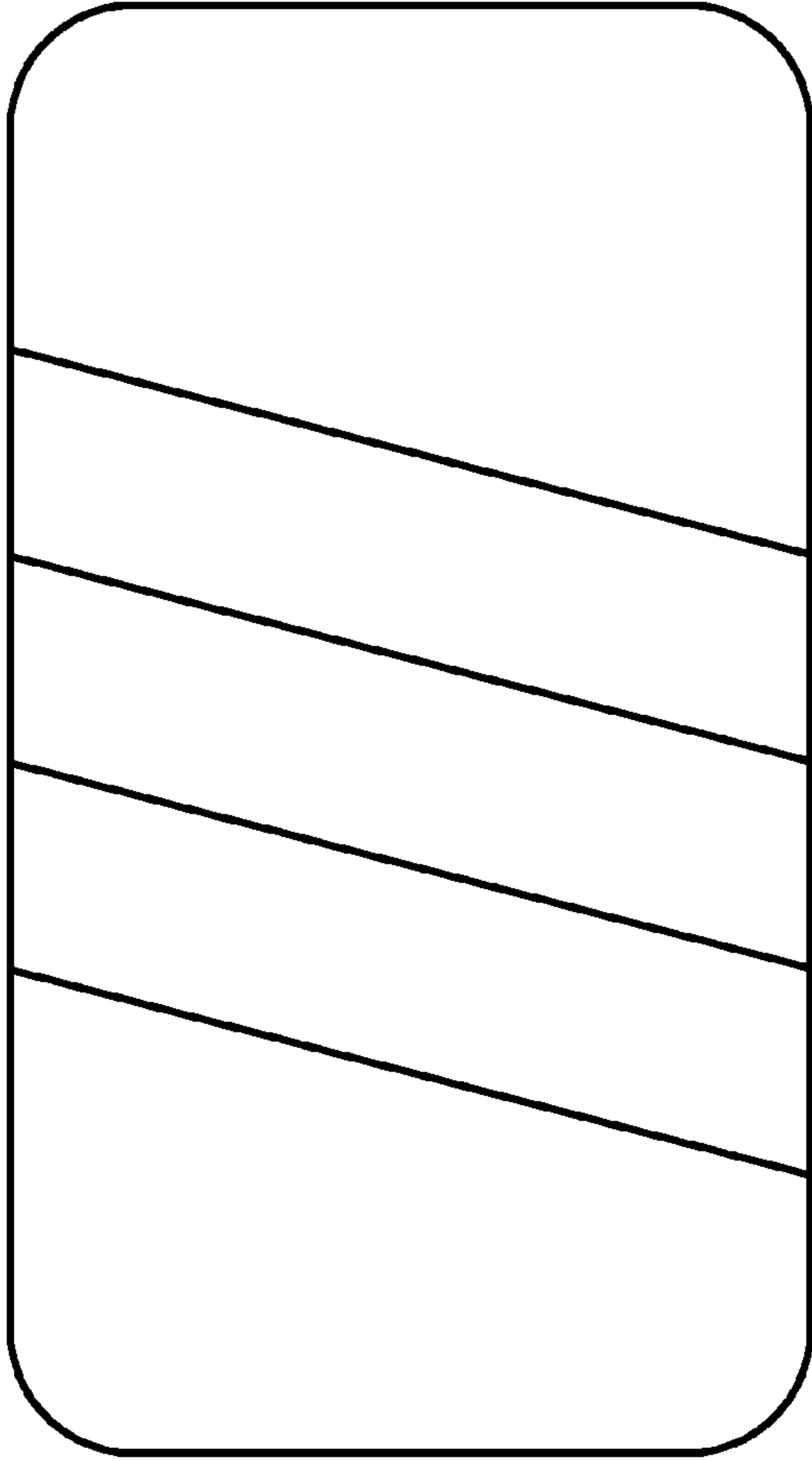

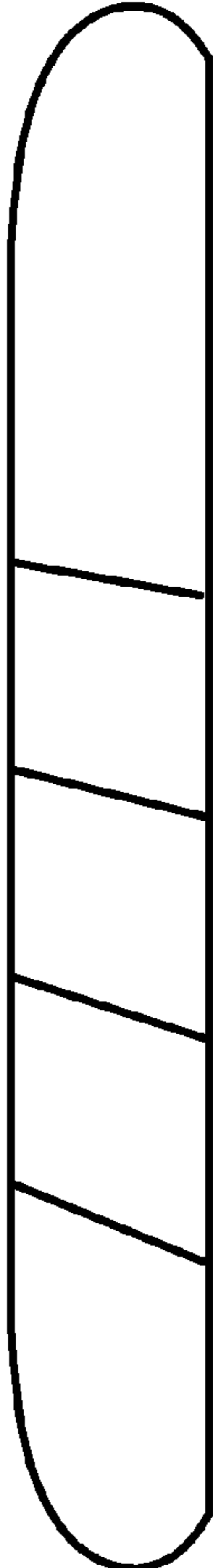
