I claim the ornamental design for a transparent engine cover, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a transparent engine cover, showing my new design;

FIG. 2 is a front elevational view thereof;

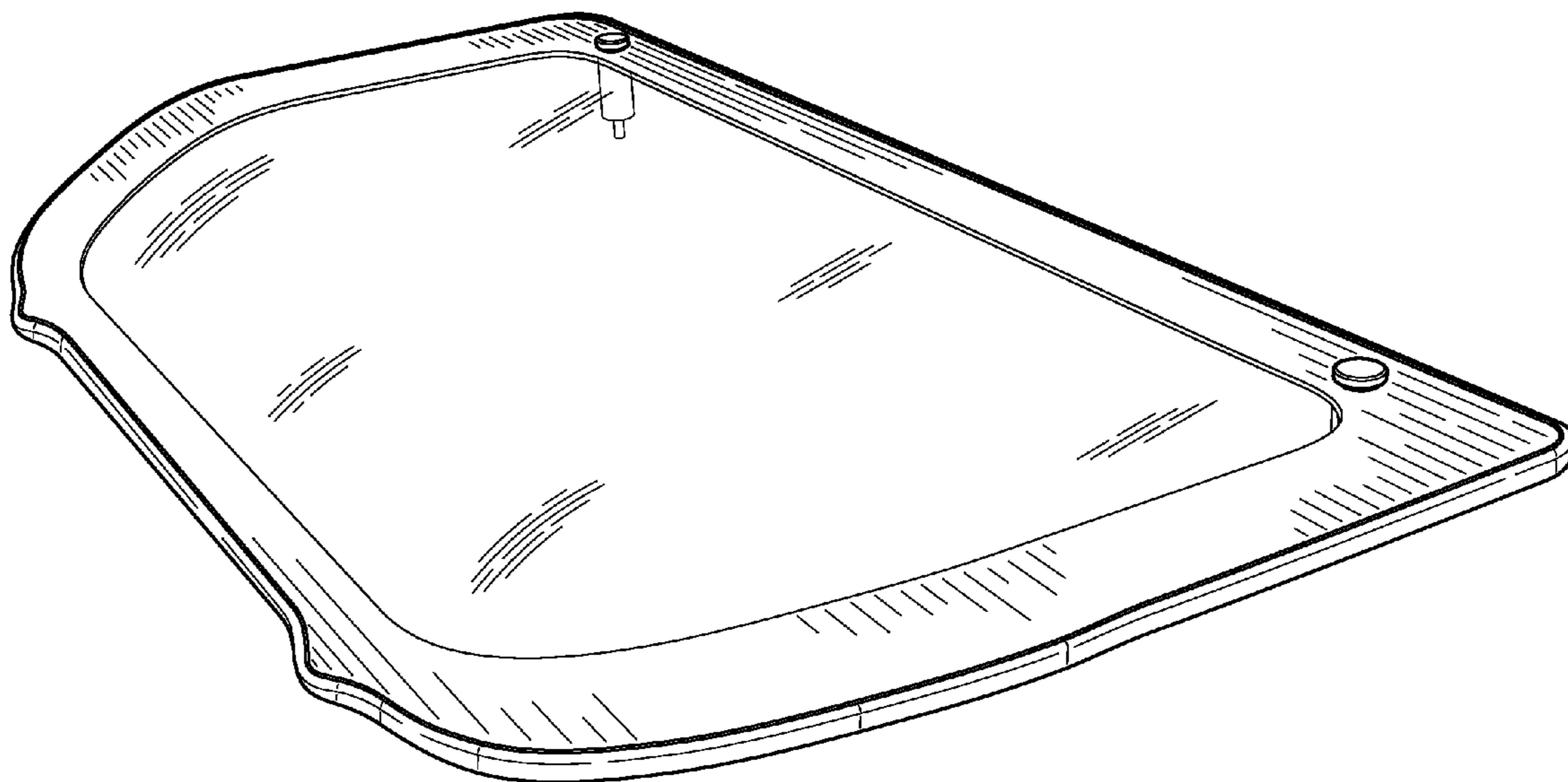
FIG. 3 is a rear elevational view thereof;

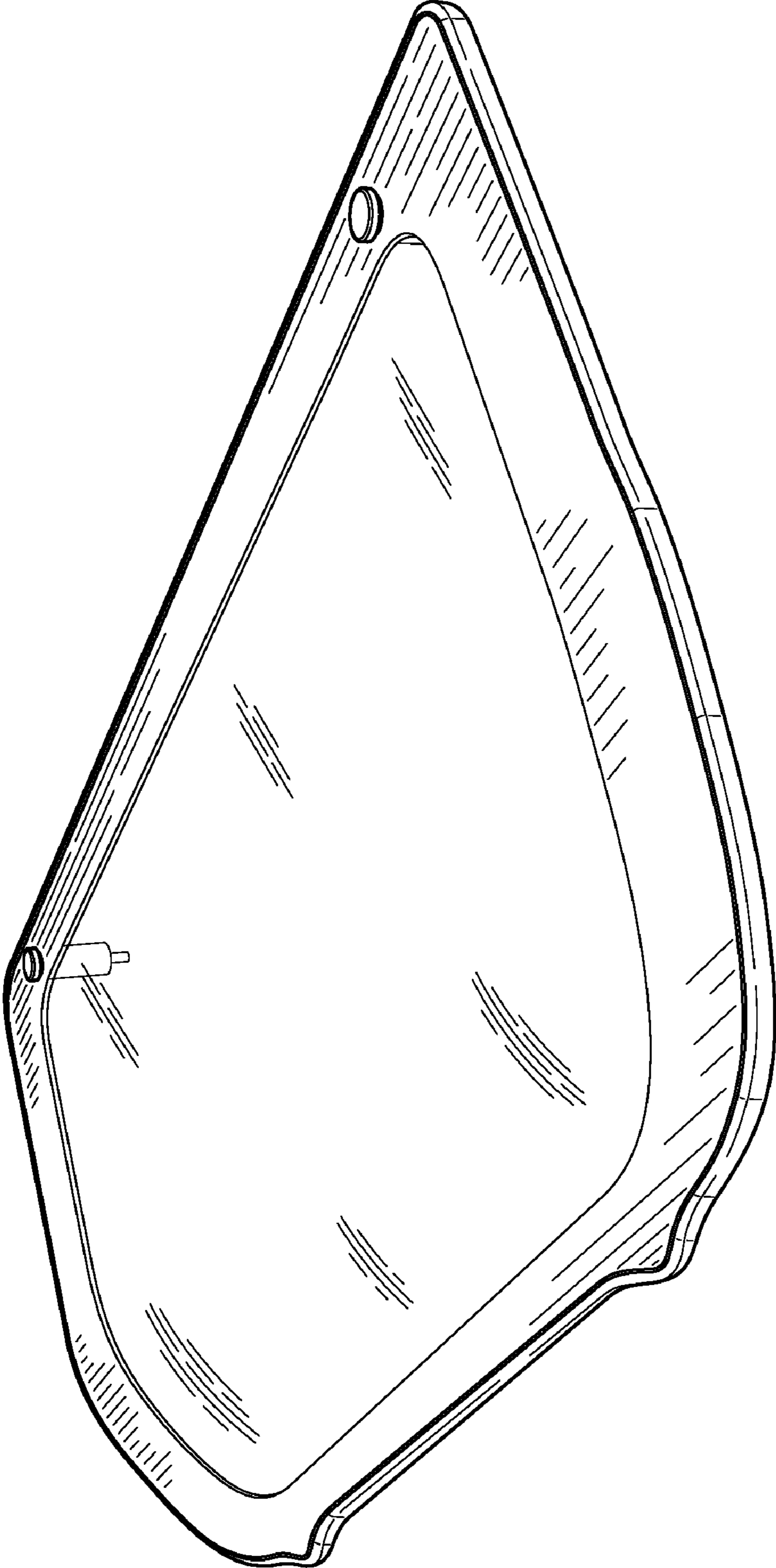

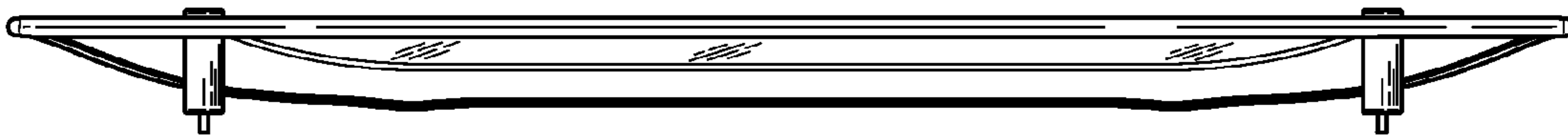

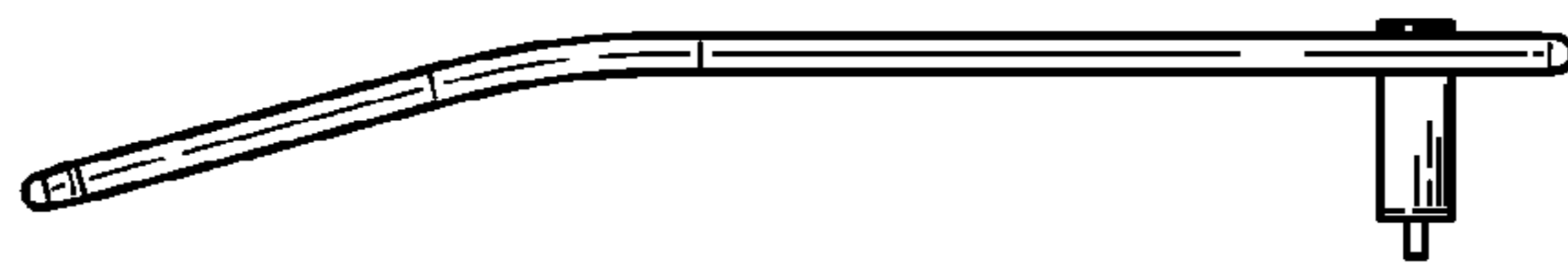

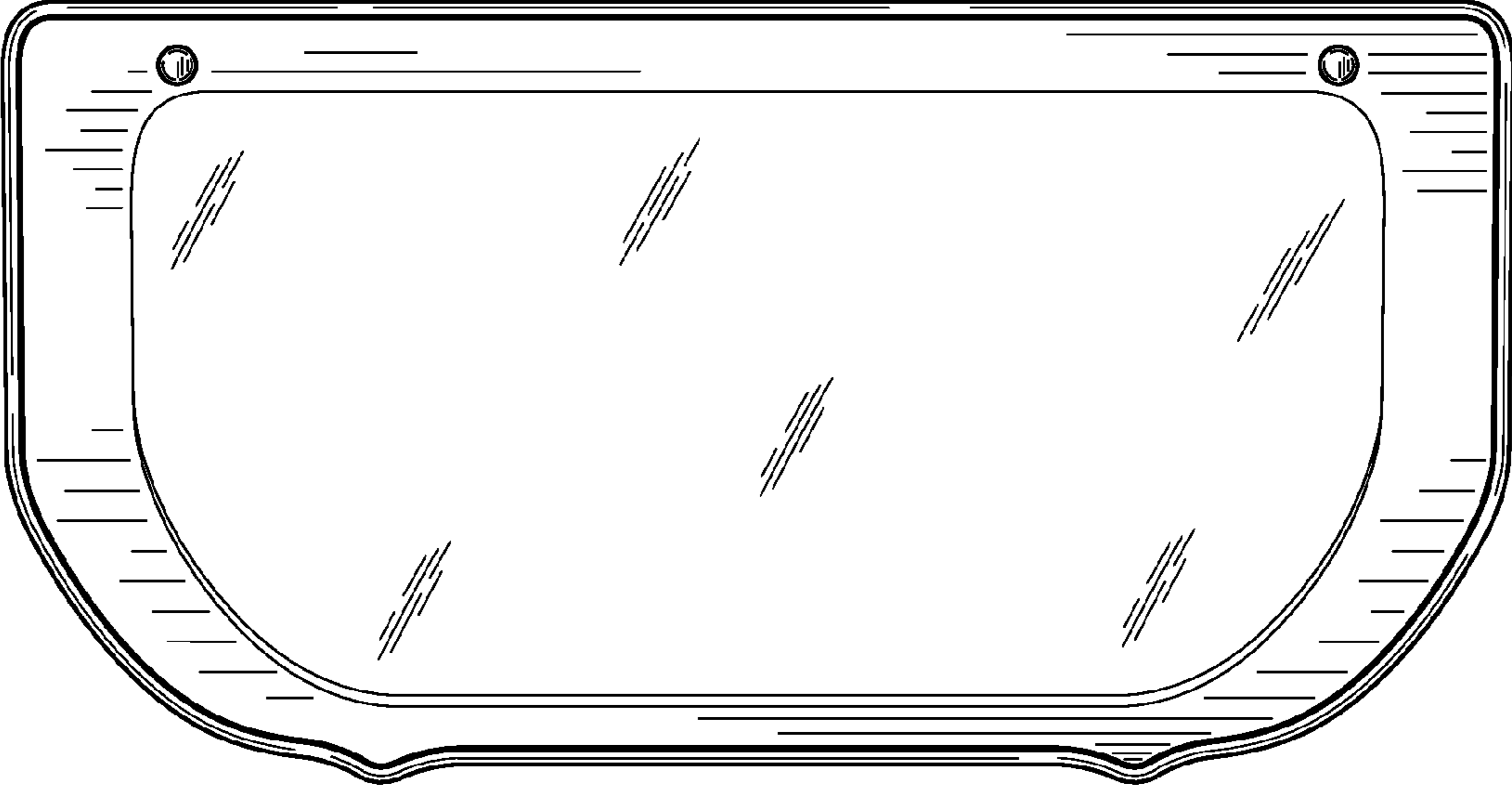

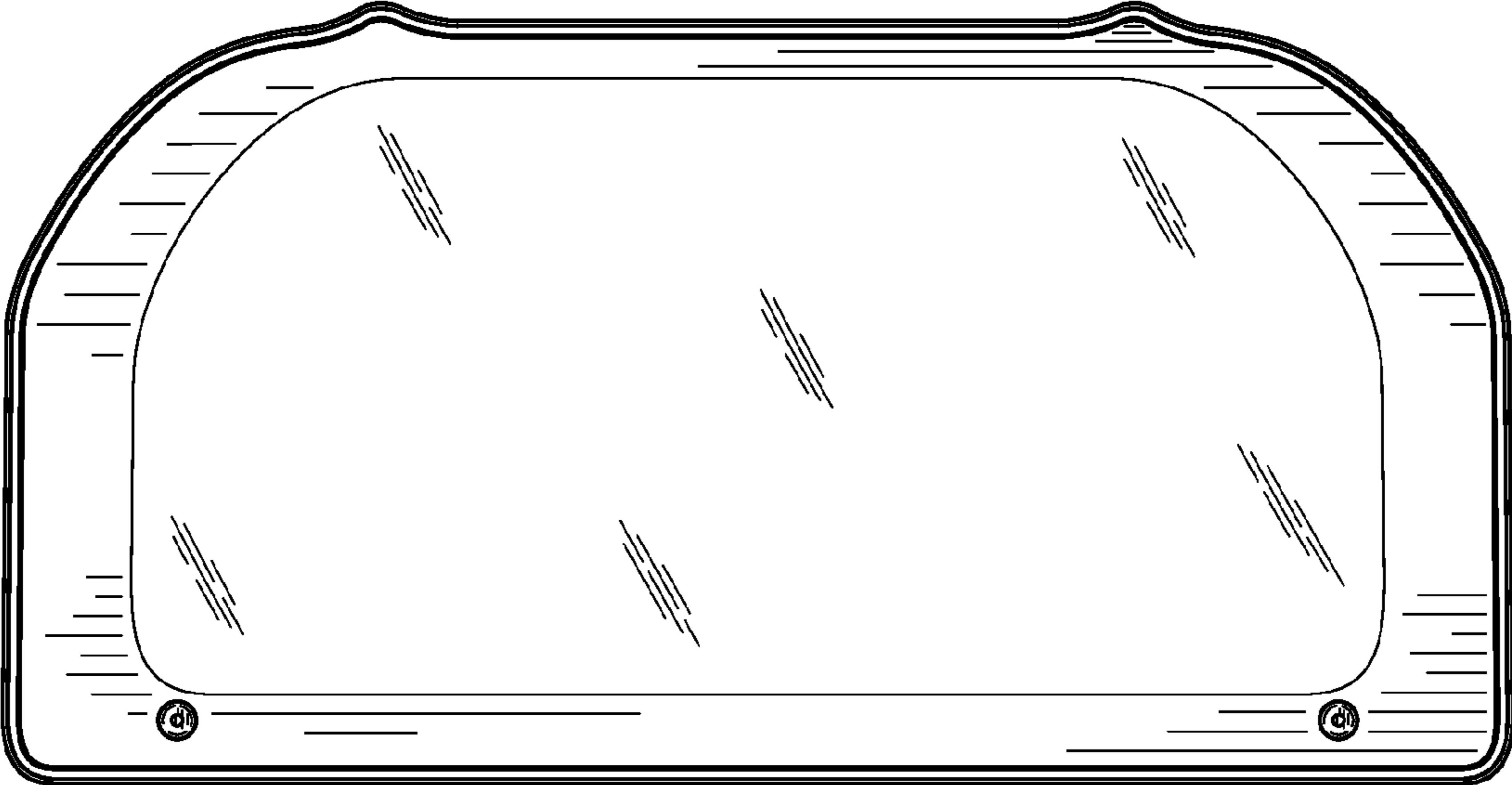
