(57) **CLAIM**

The ornamental design for a motive toy hamster, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the motive toy hamster; FIG. 2 is a right side elevational view of the motive toy hamster of FIG. 1;

FIG. 3 is a left side elevational view of the motive toy hamster of FIG. 1;

FIG. 4 is a top plan view of the motive toy hamster of FIG. 1;

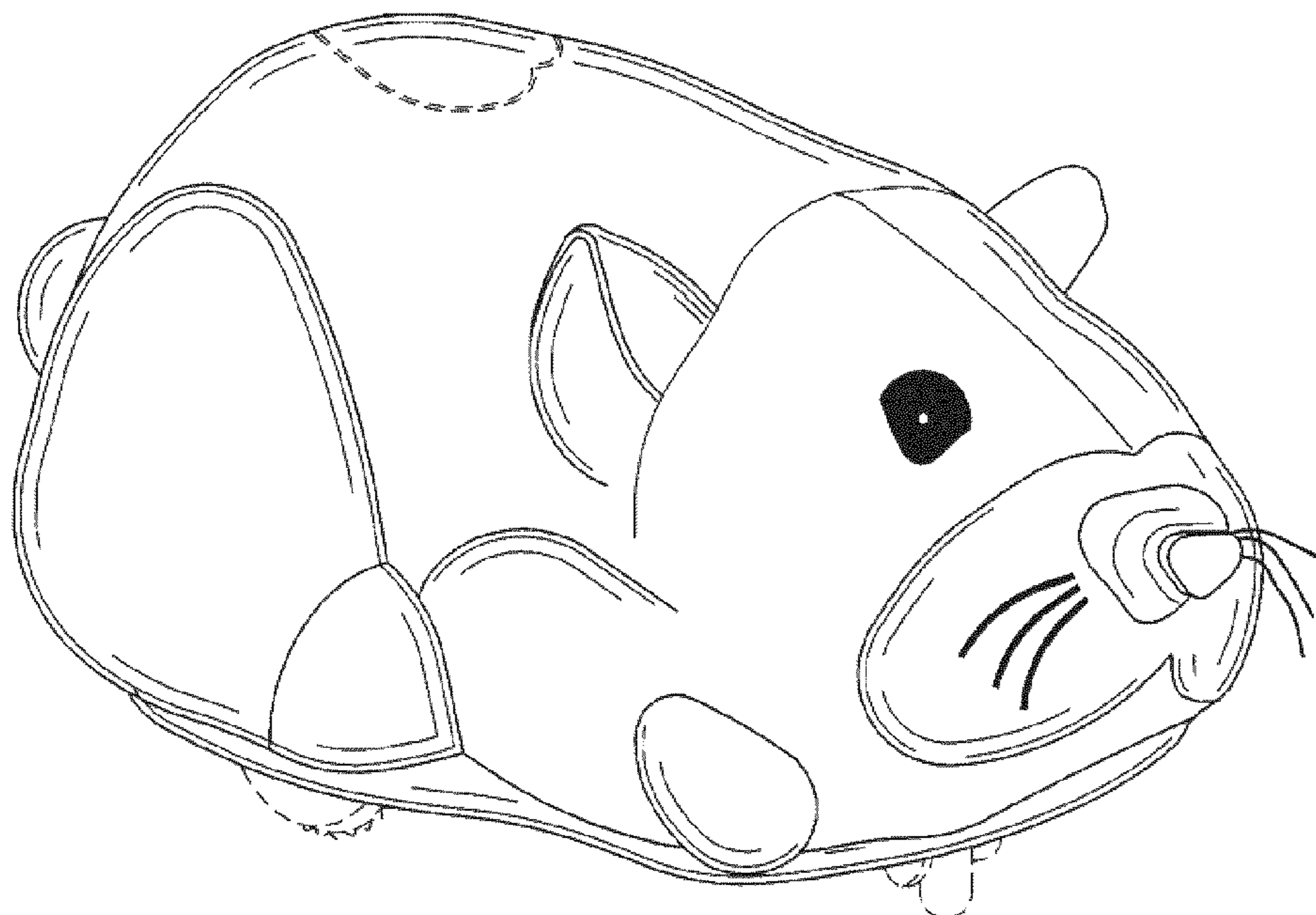
FIG. 5 is a bottom plan view of the motive toy hamster of FIG. 1;

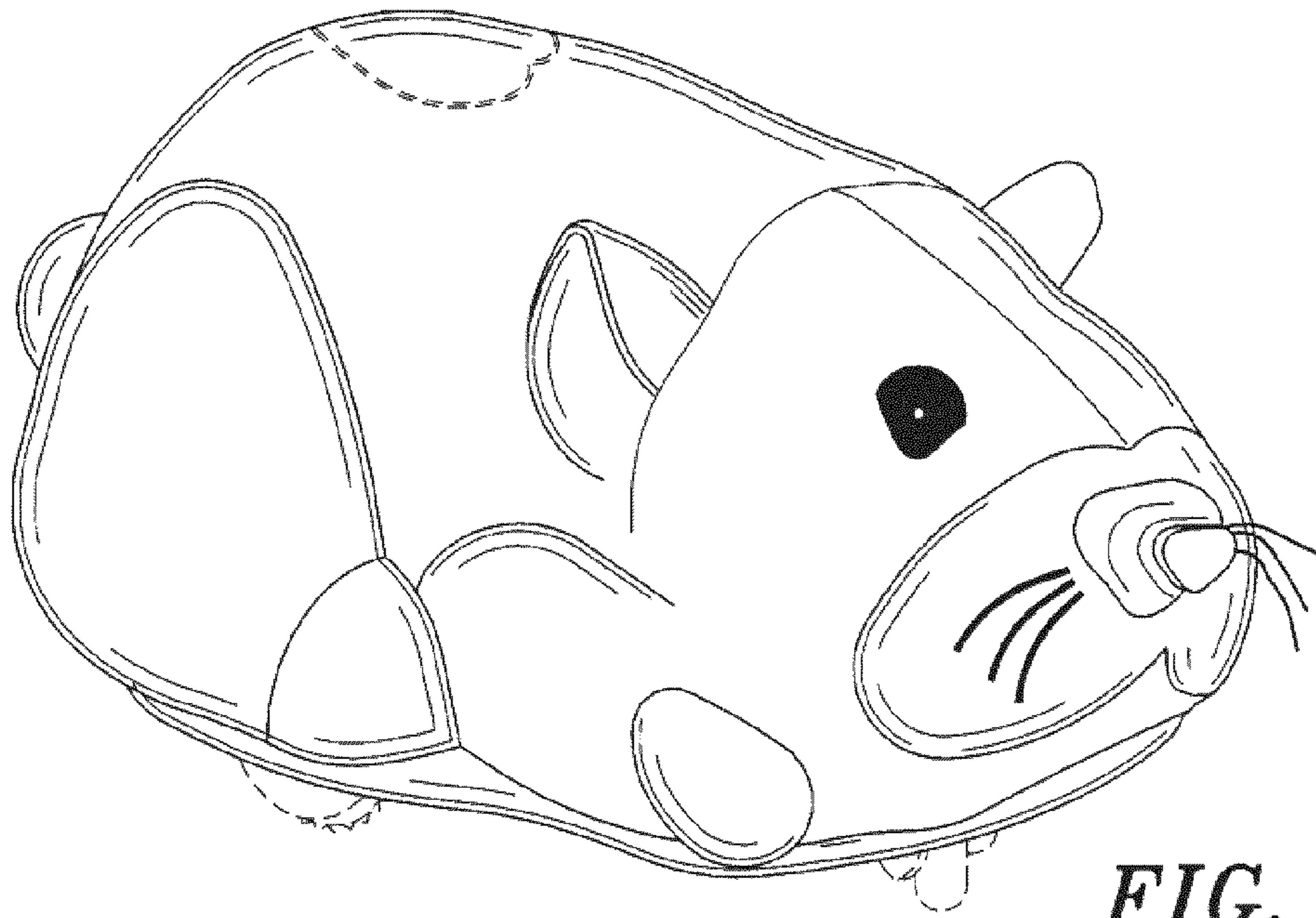

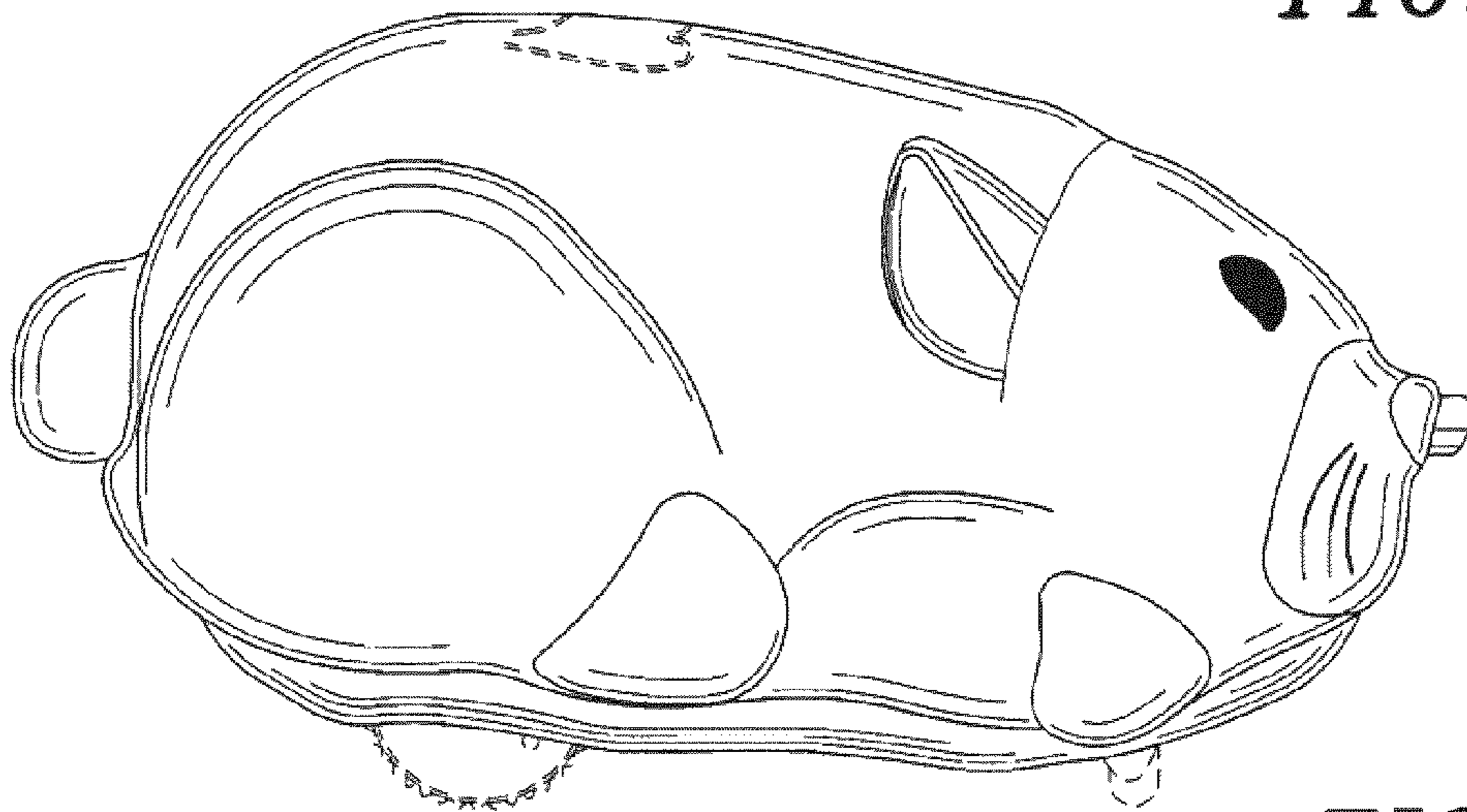

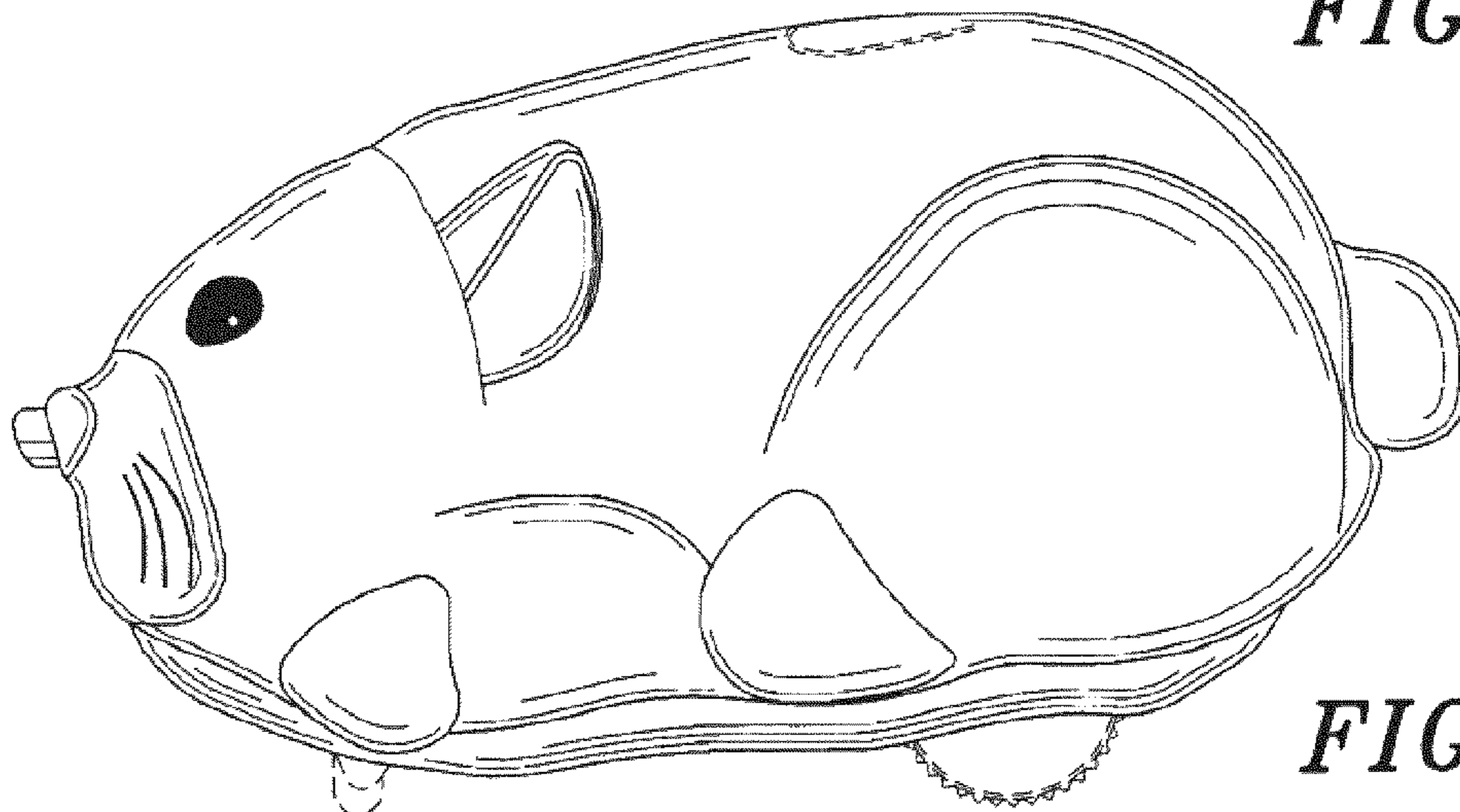

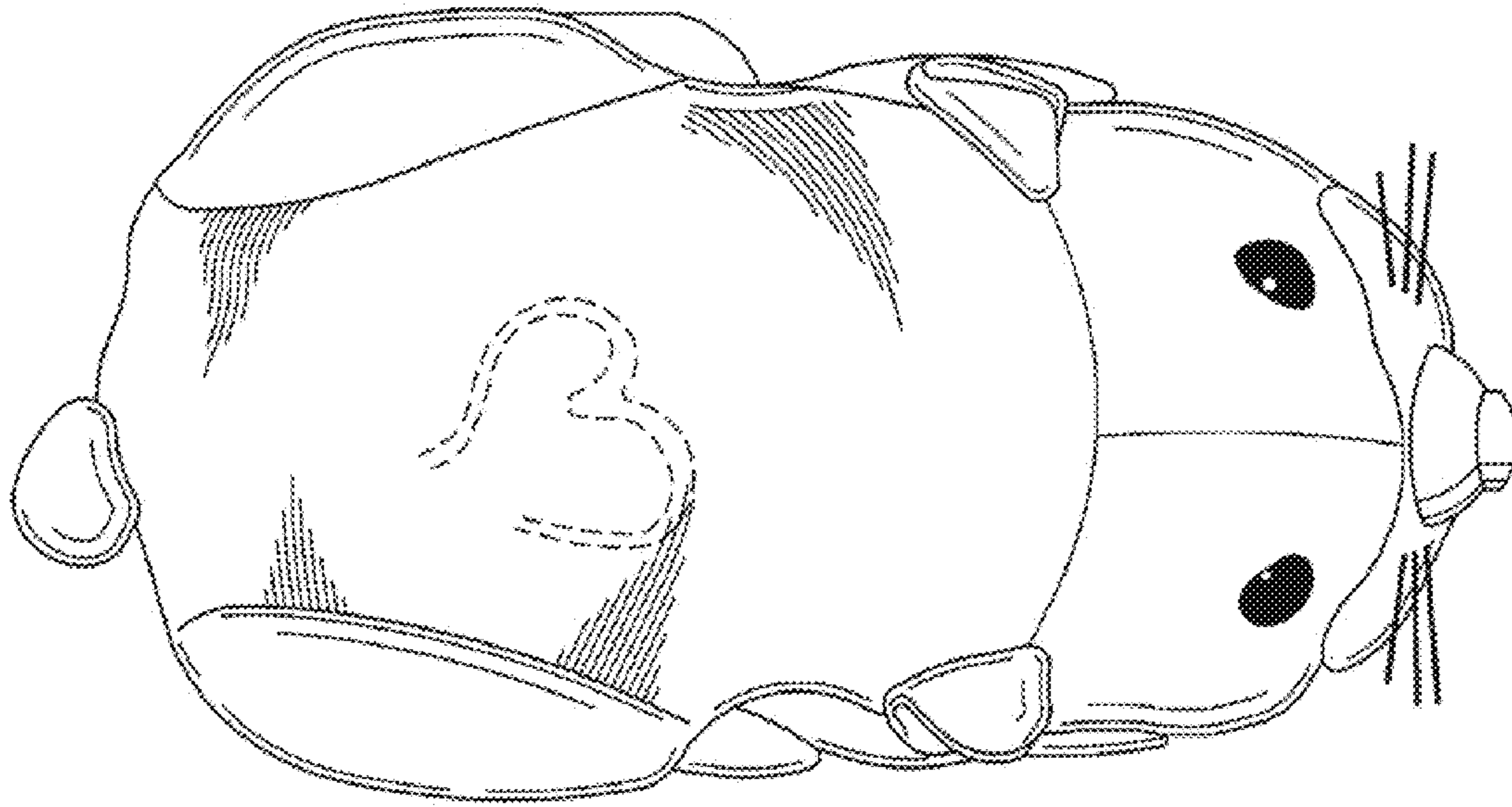

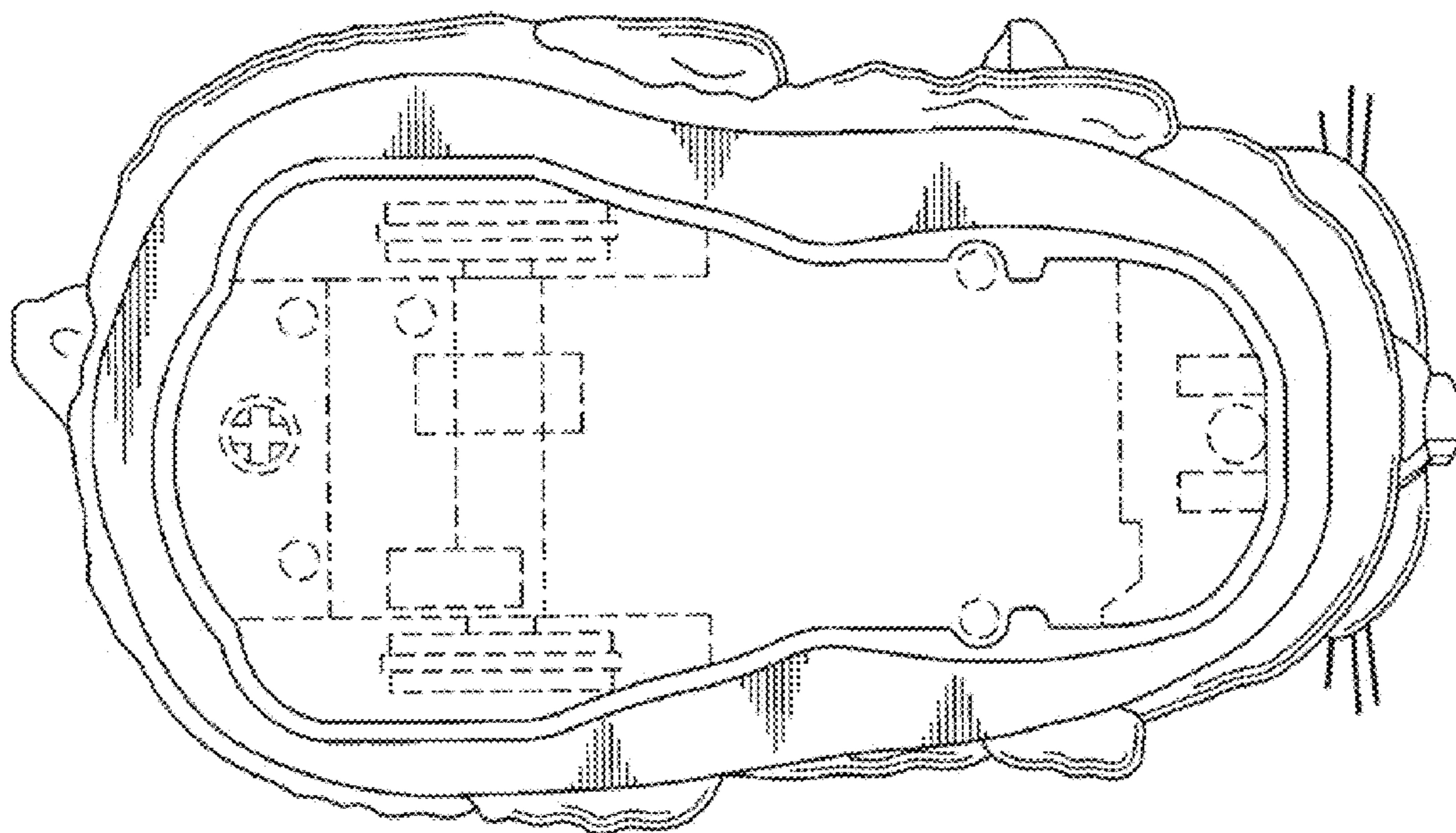

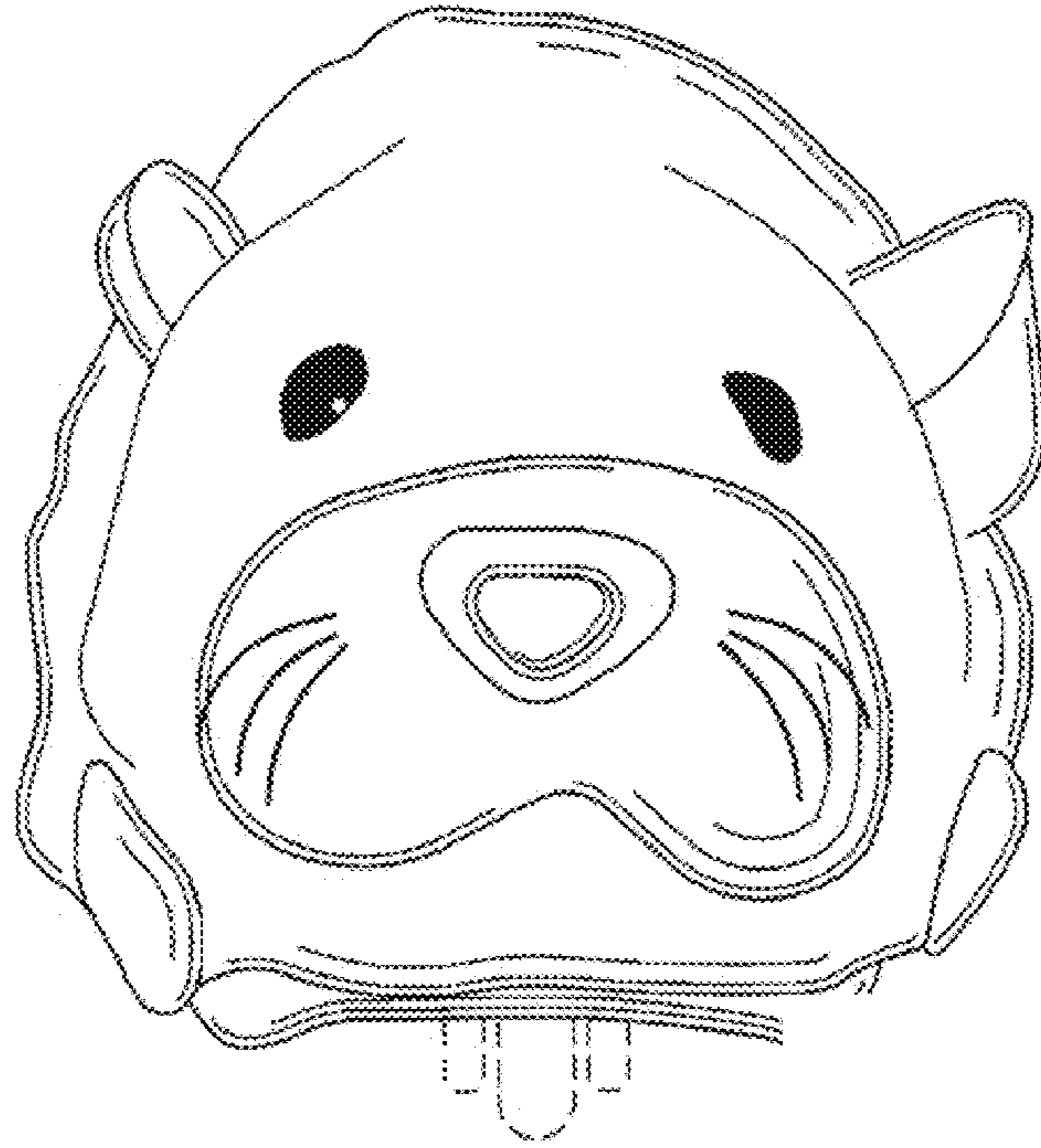

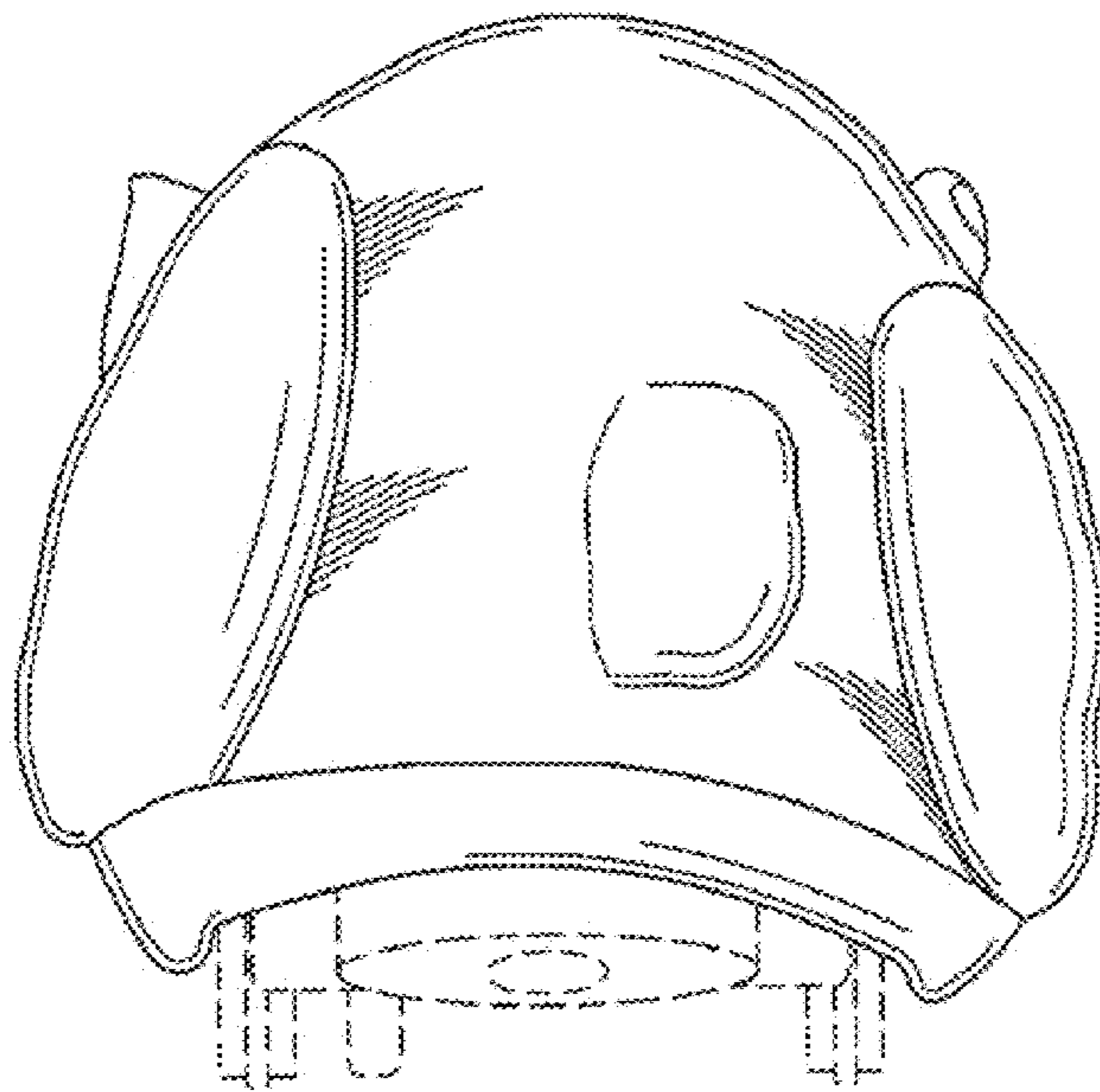
