(57) **CLAIM**

We claim the ornamental design for a Nordic ski binding, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view of a Nordic ski binding;

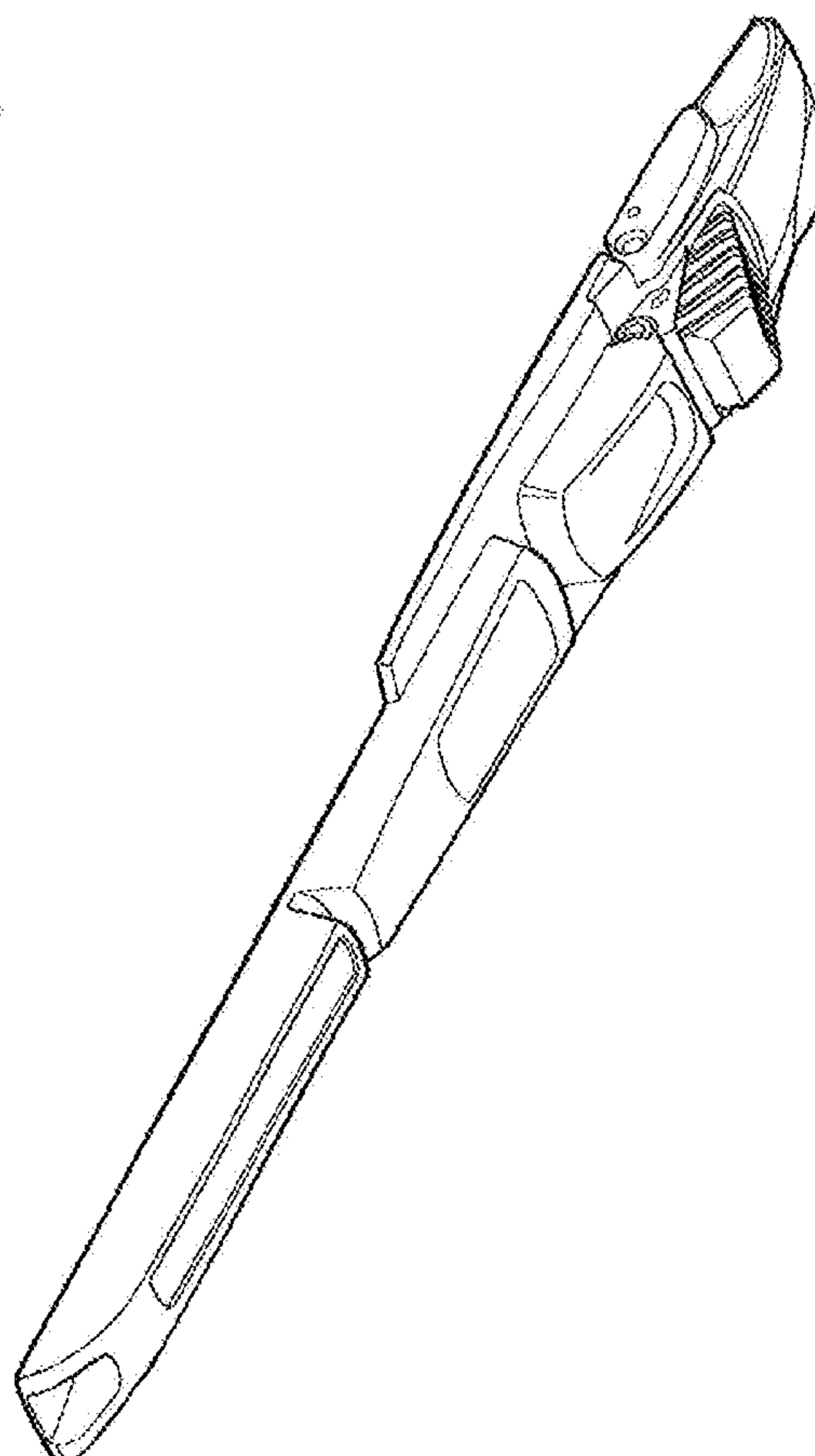
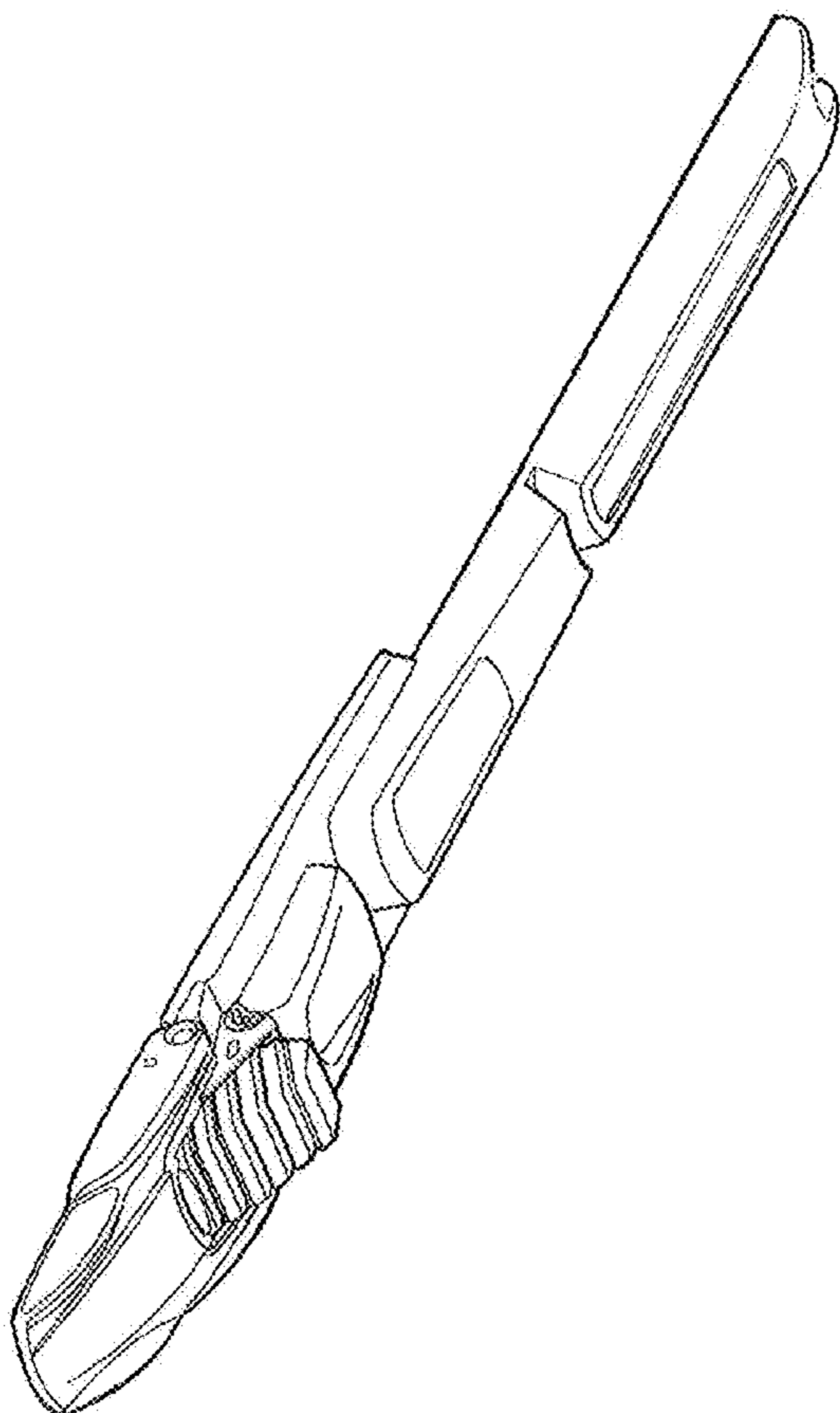

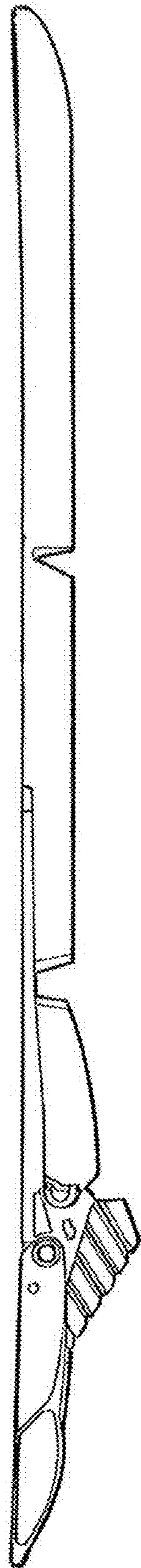

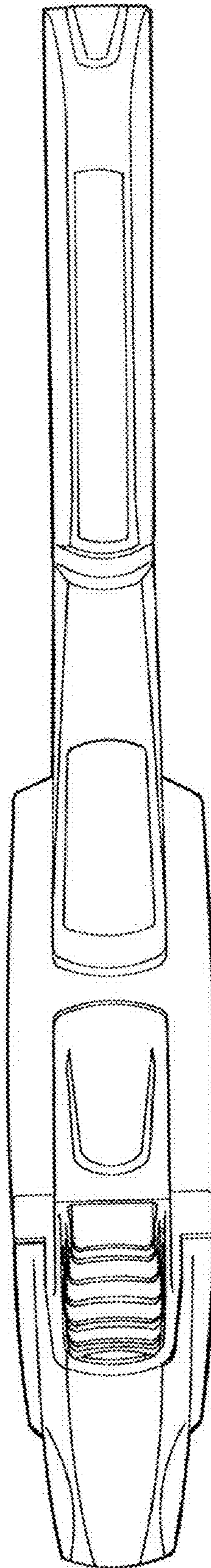
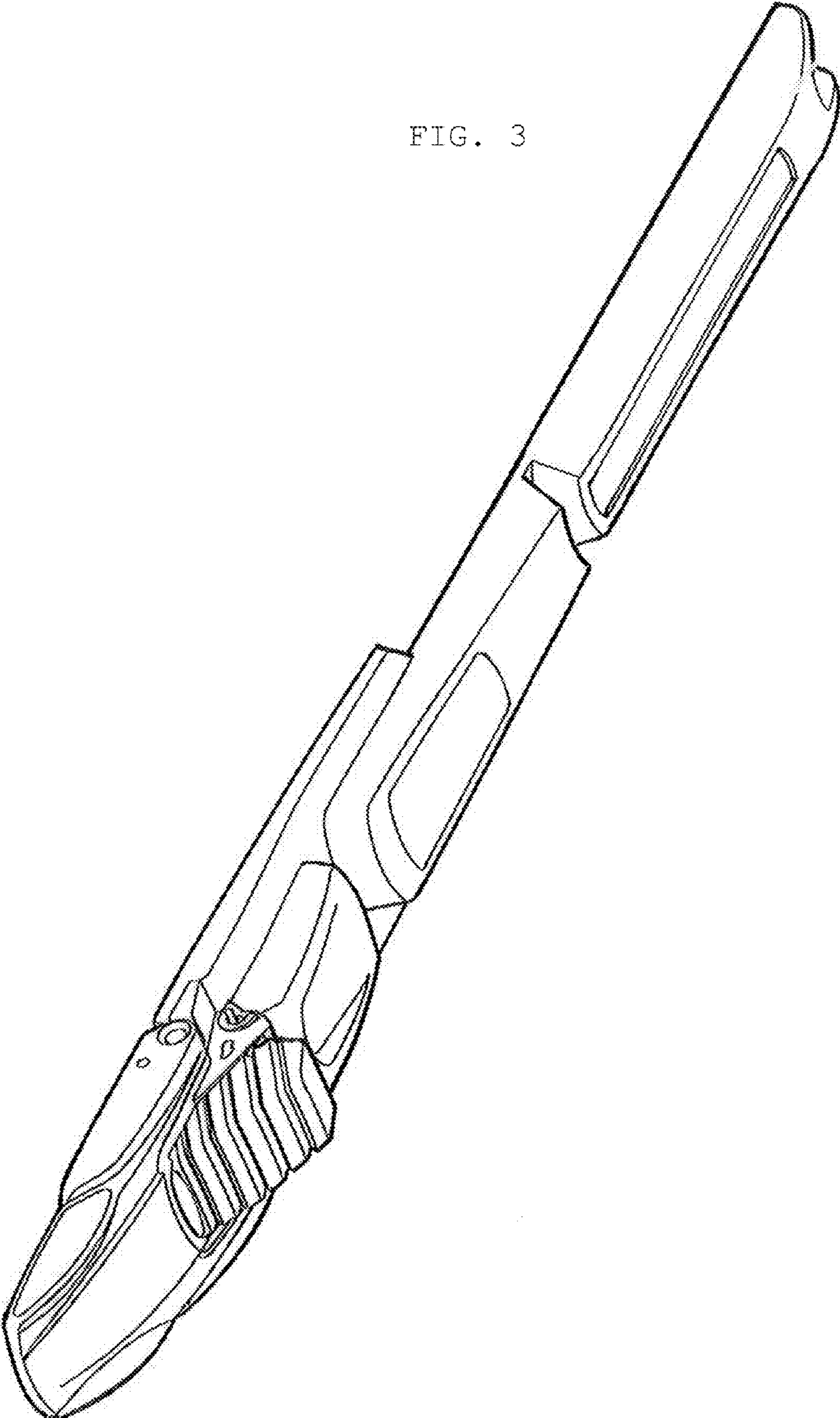

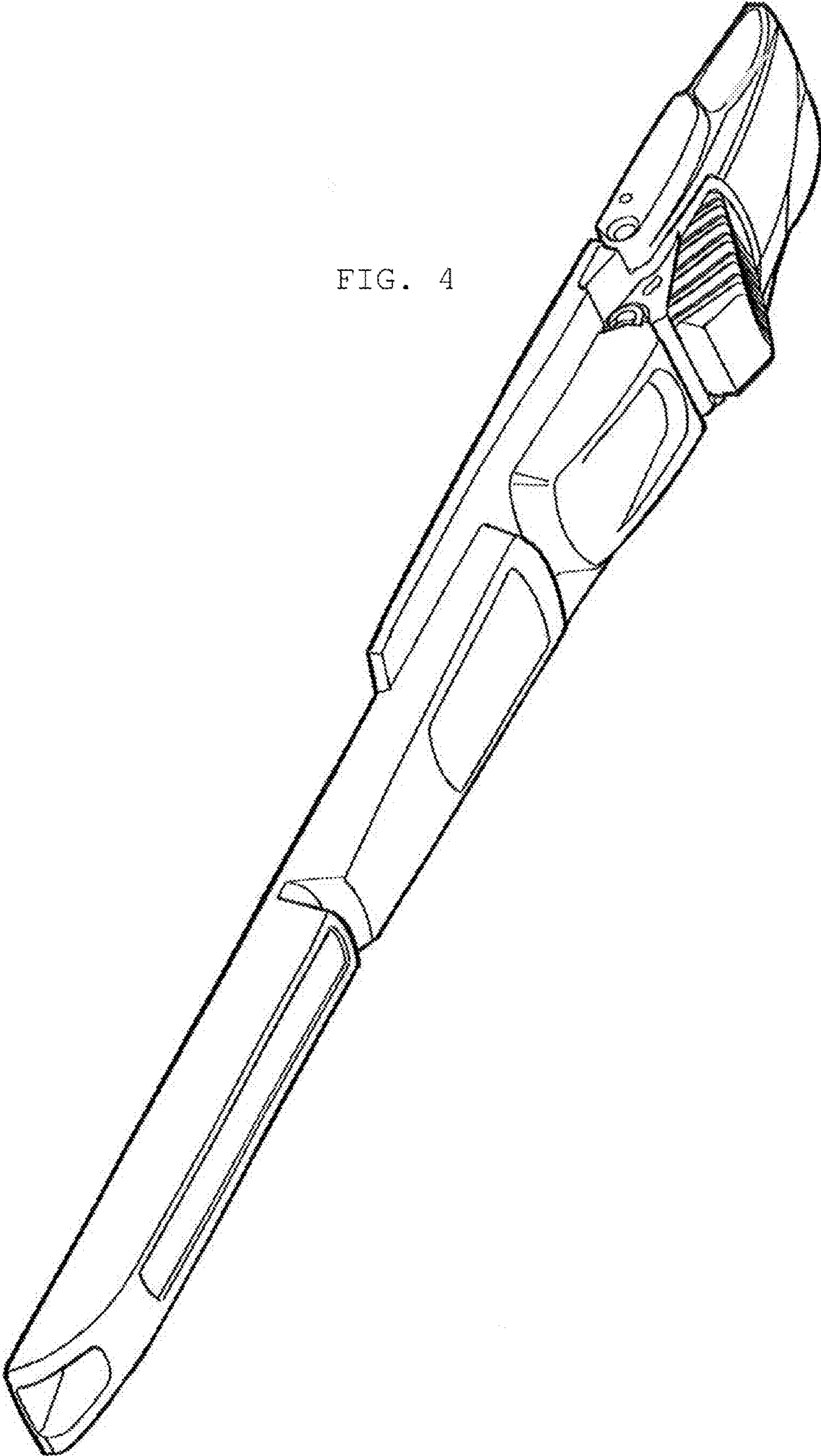
