(57) **CLAIM**

The ornamental design for a golf ball location marker, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a golf ball location marker showing my new design;

FIG. 2 is a top view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a front view thereof, the rear view, right side view, and left side view being mirror images thereof;

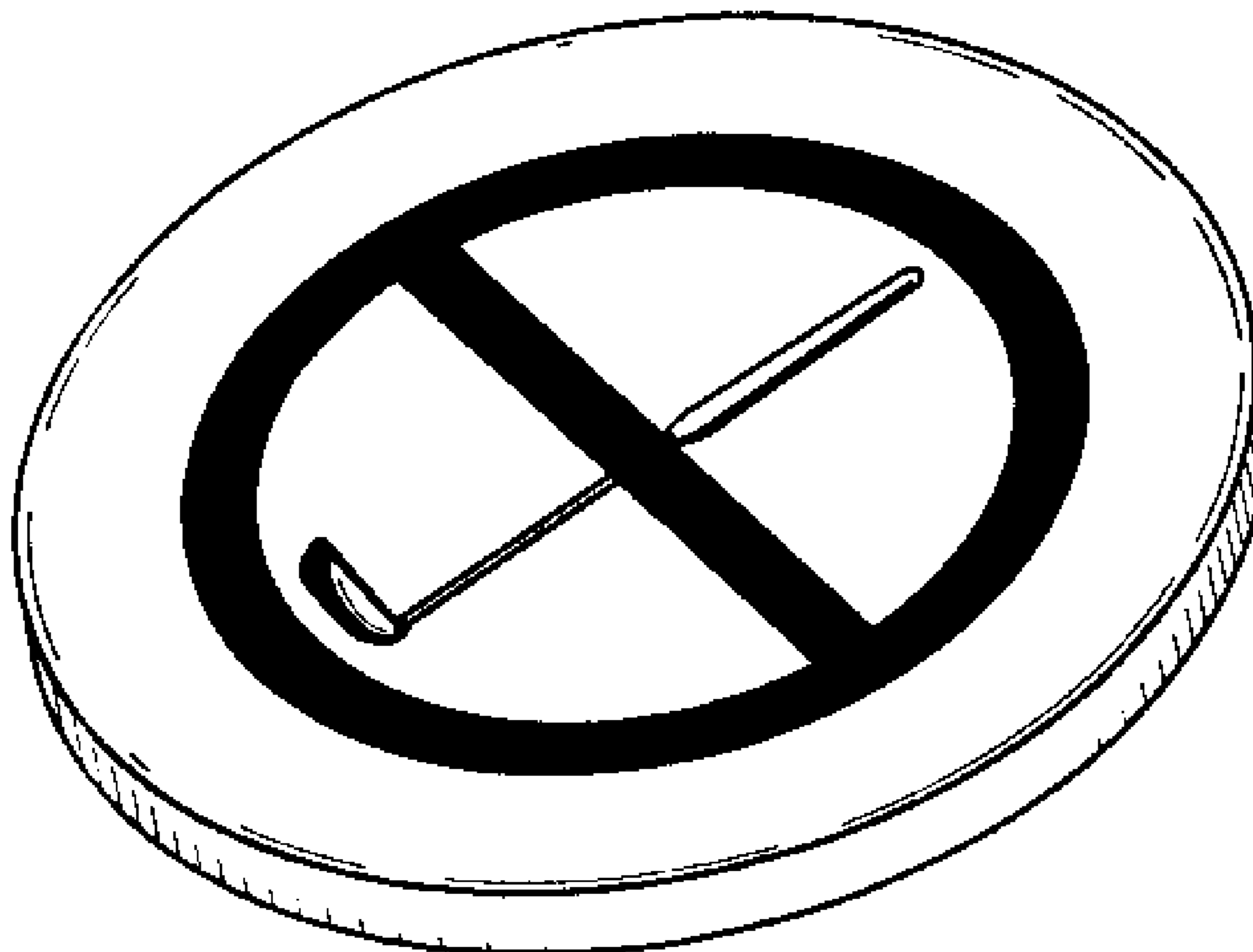
FIG. 5 is a front perspective view of a second embodiment of a golf ball location marker showing my new design;

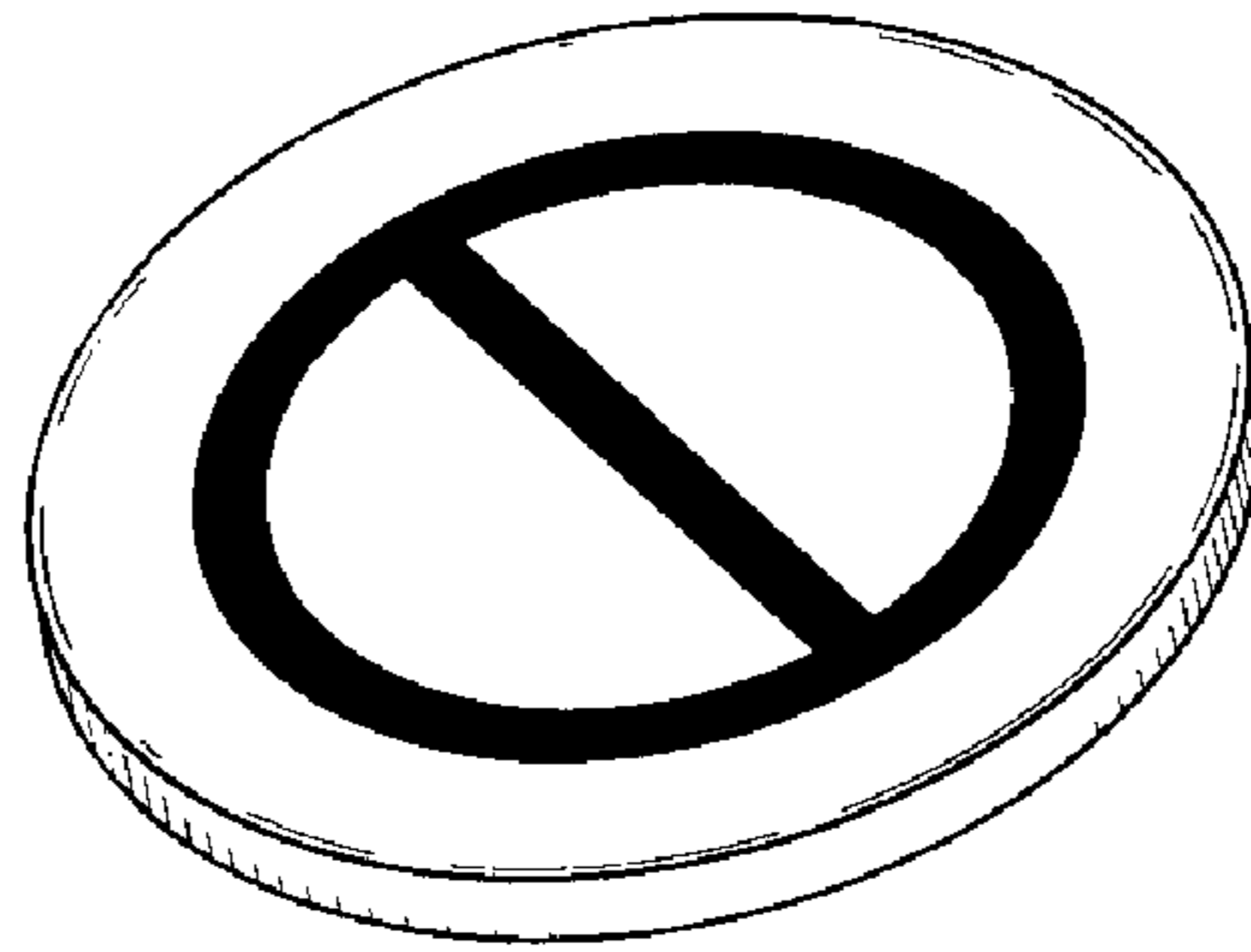

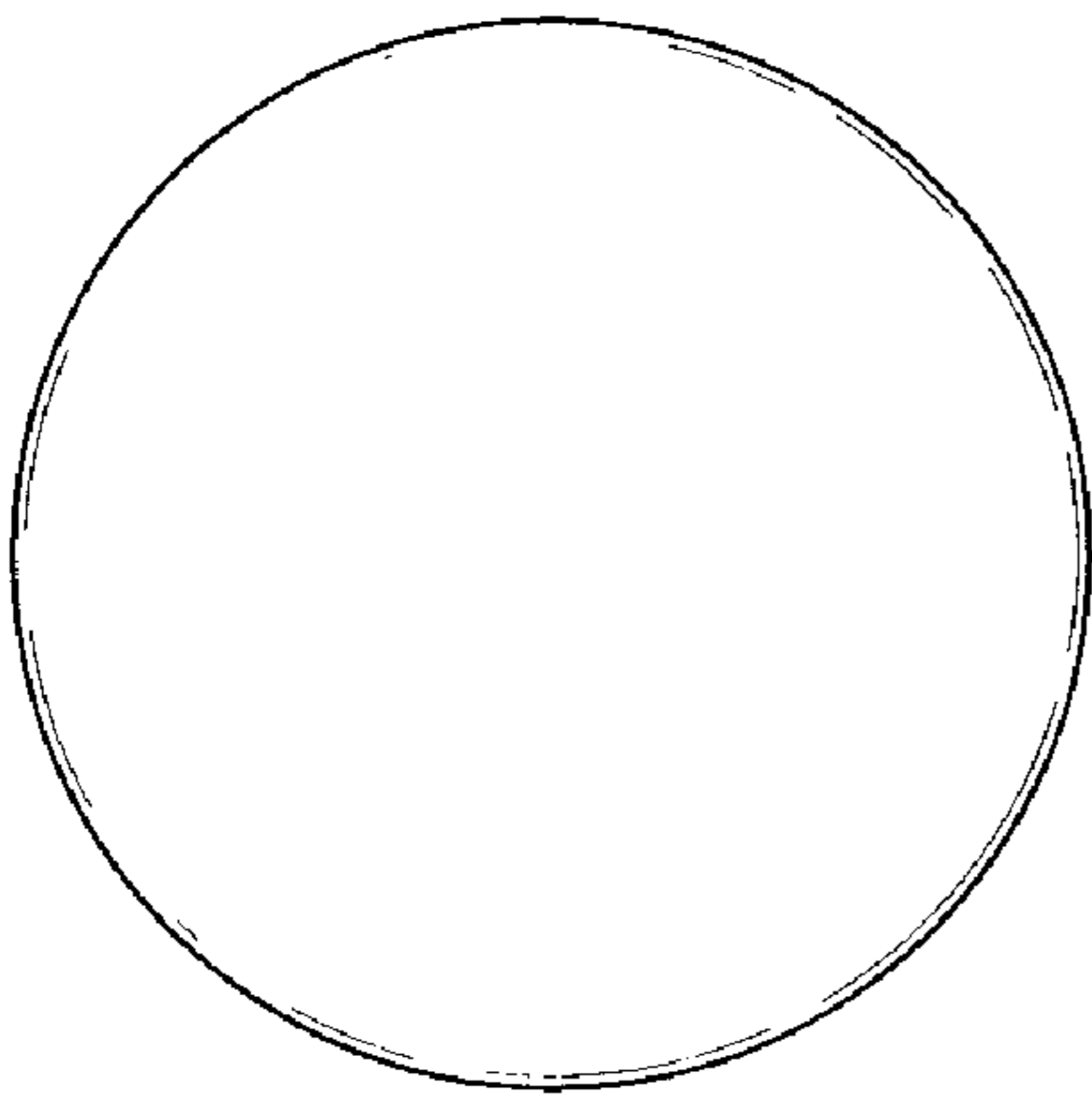

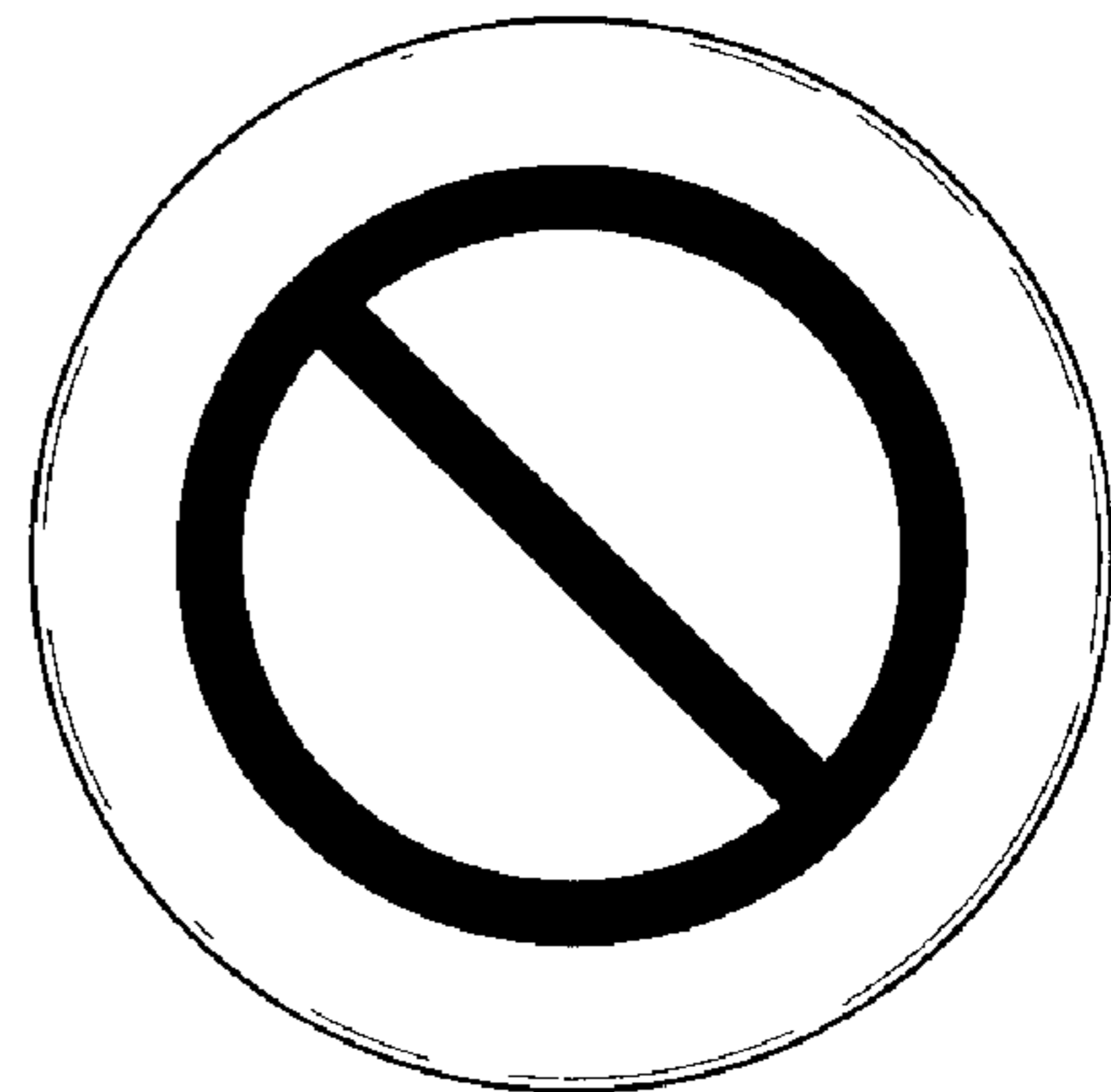

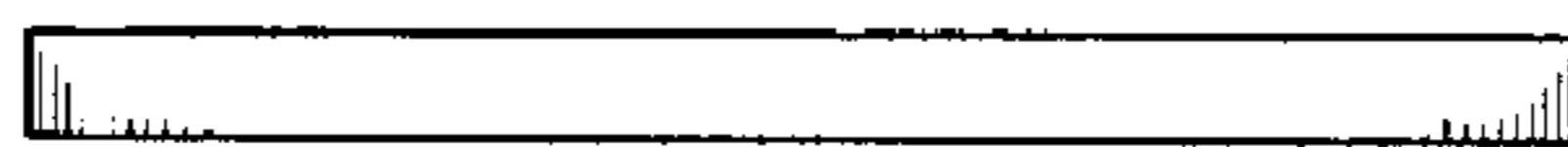

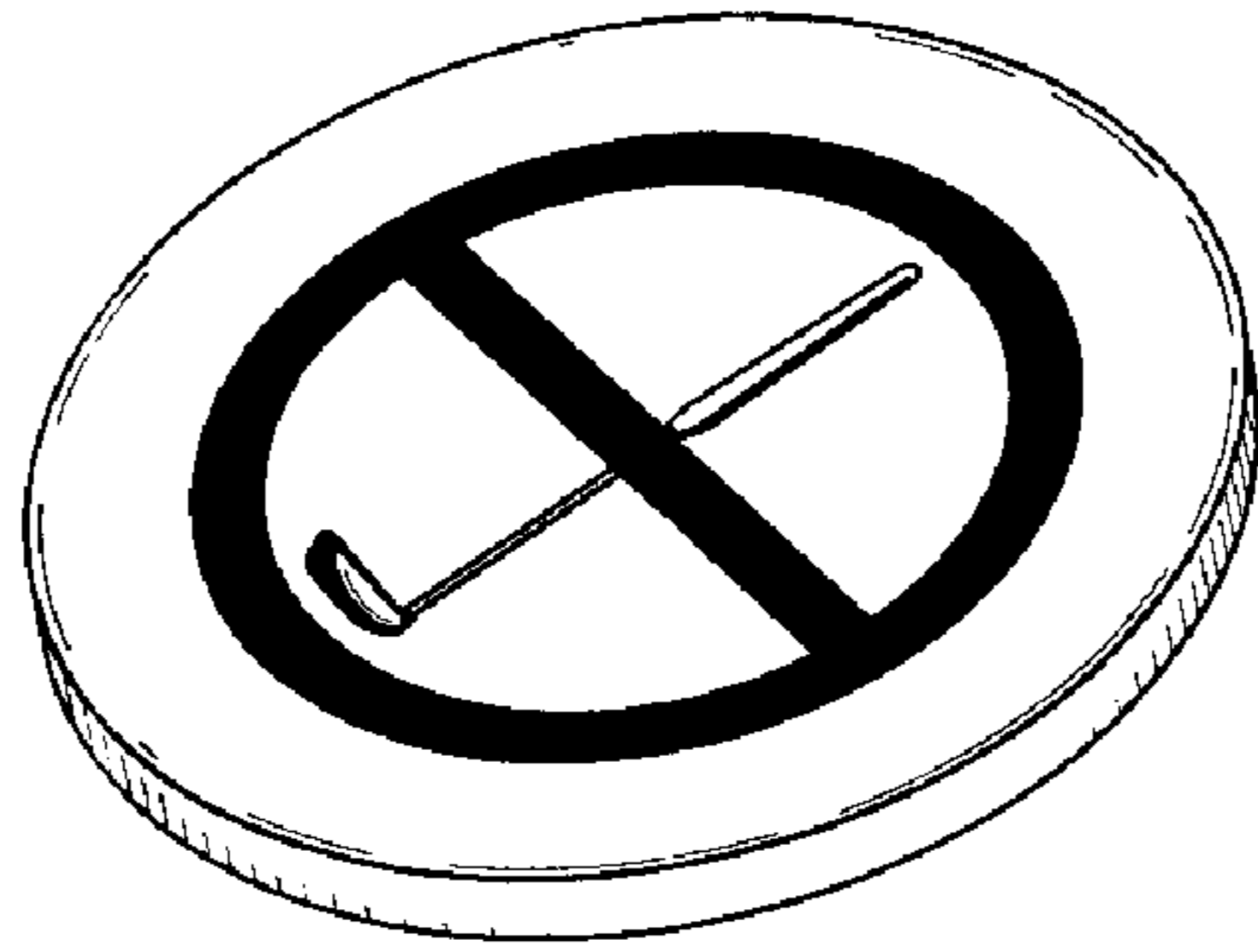

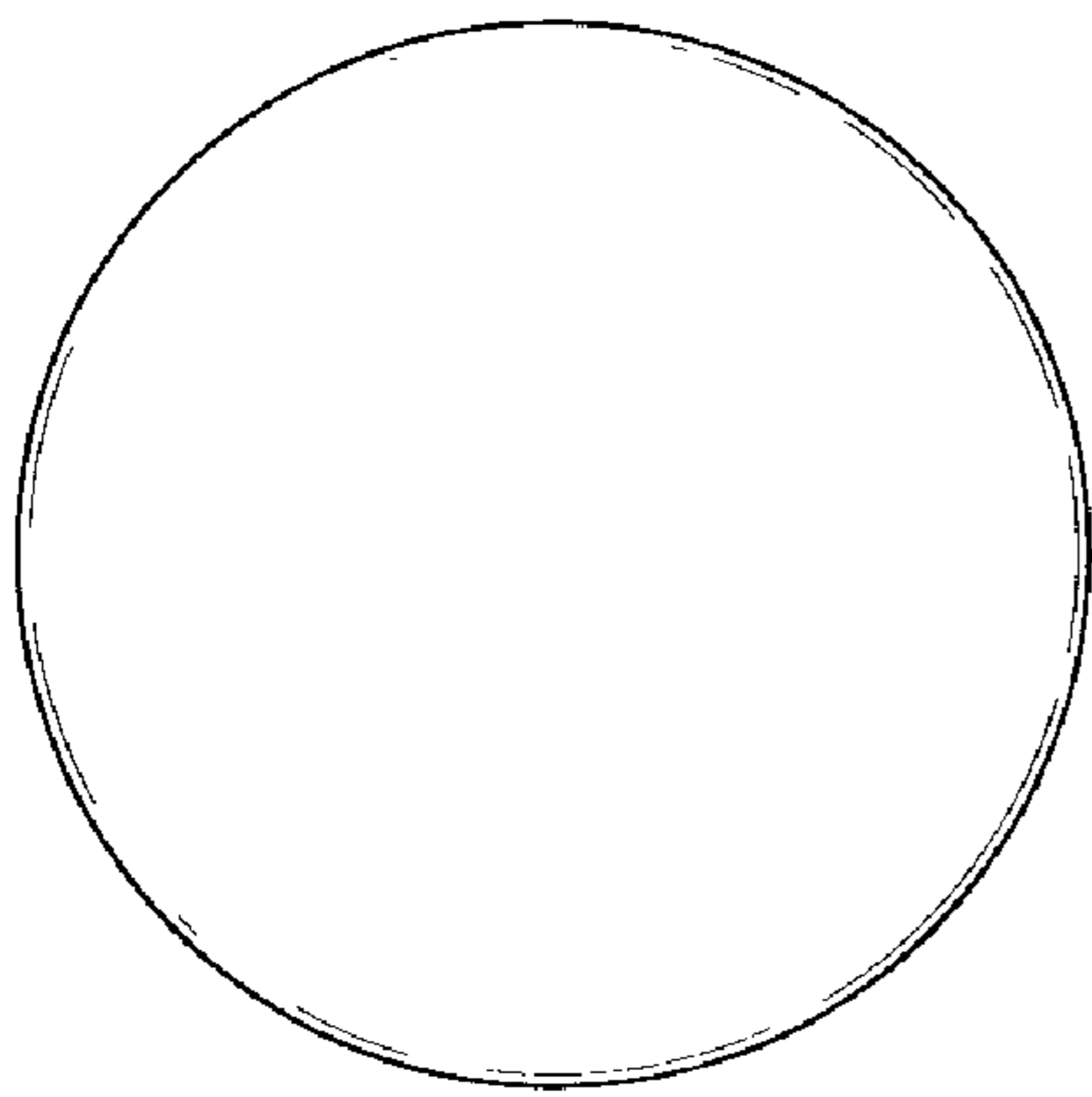

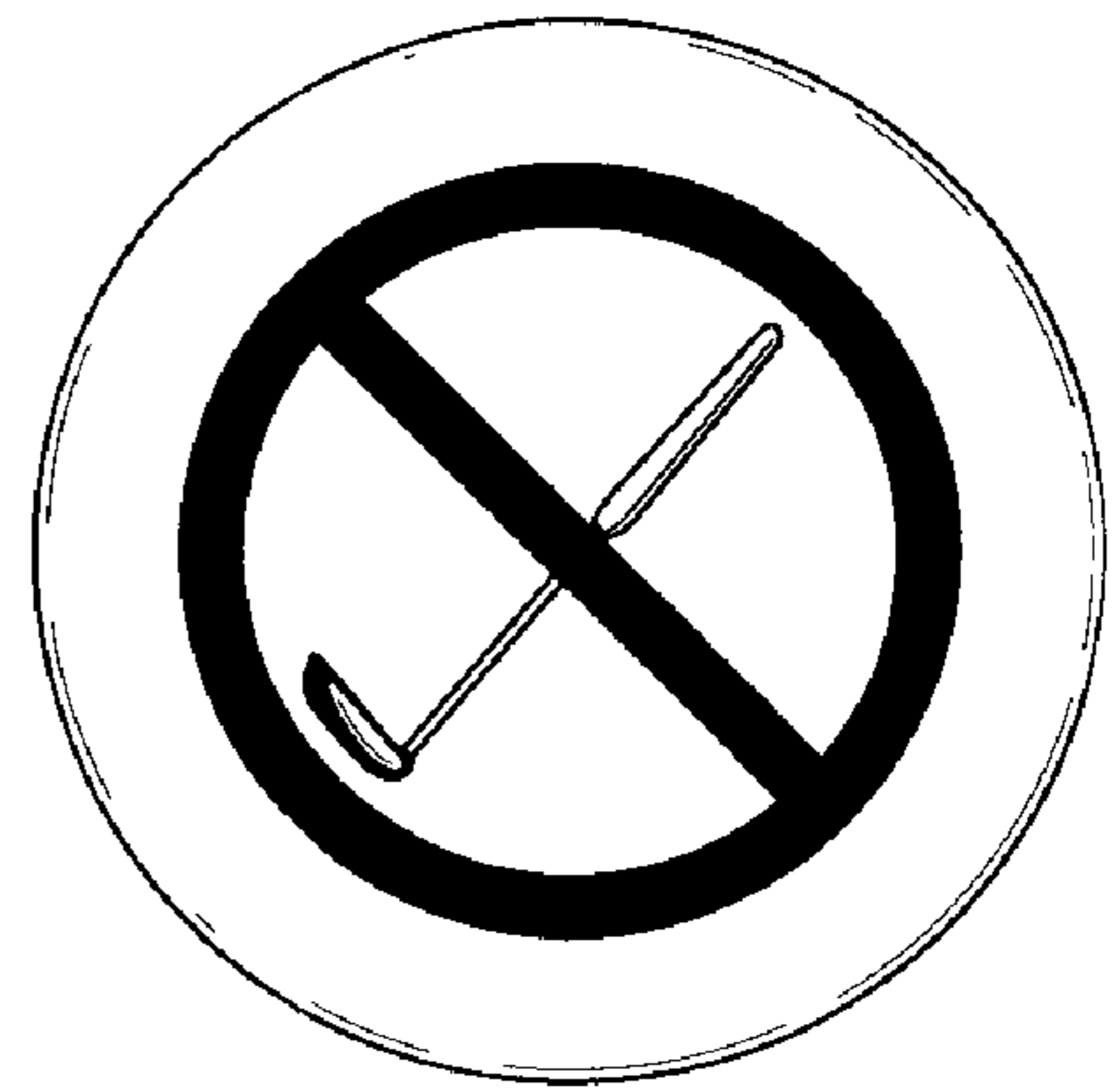

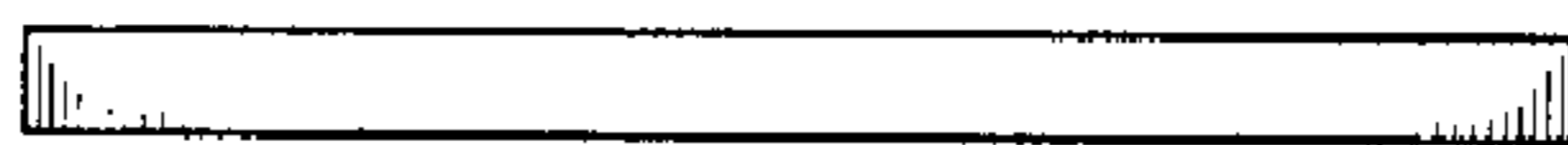
