FIG. 1 is a side elevational view of a fluid container showing my new design;

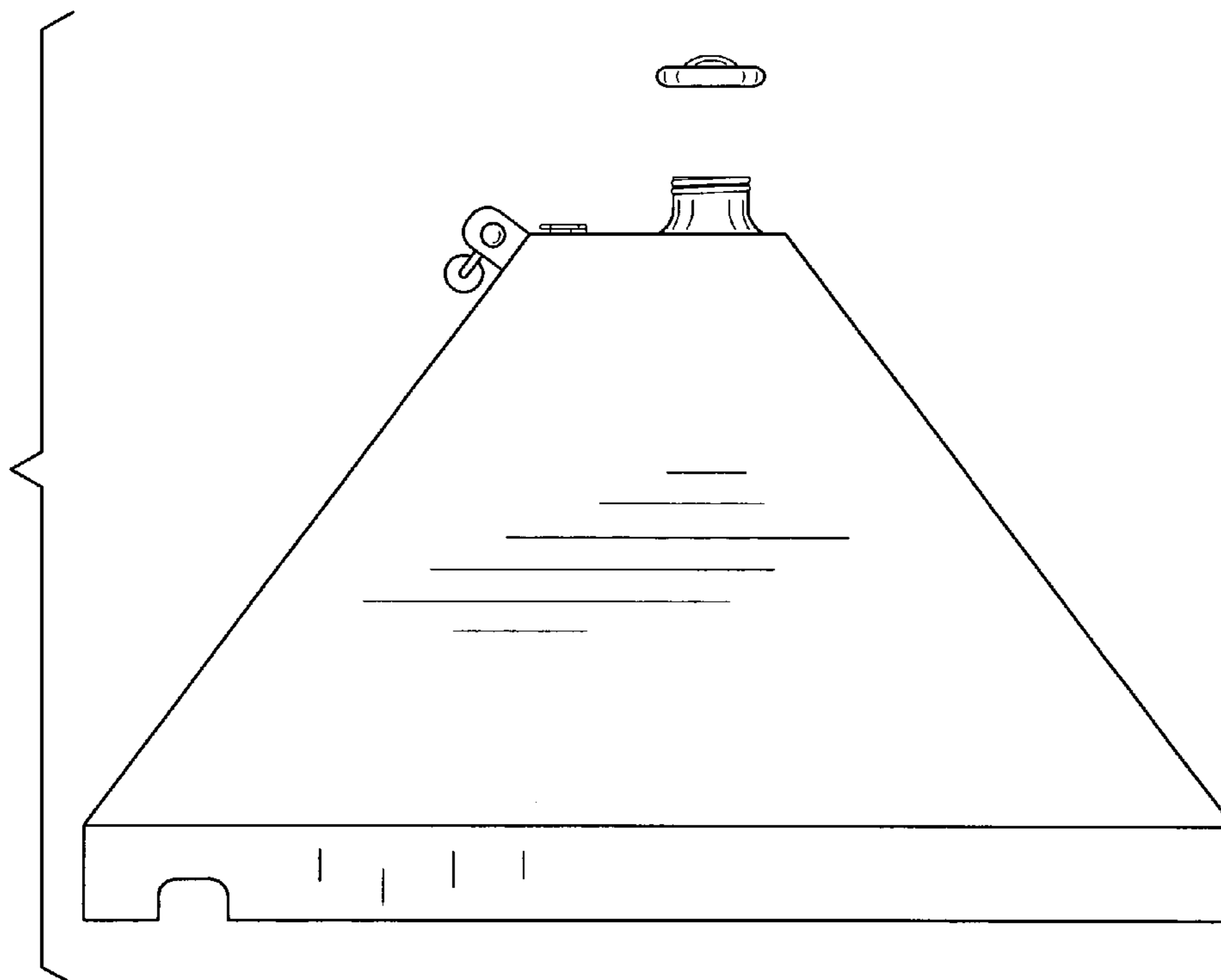
FIG. 2 is a rear elevational view thereof;

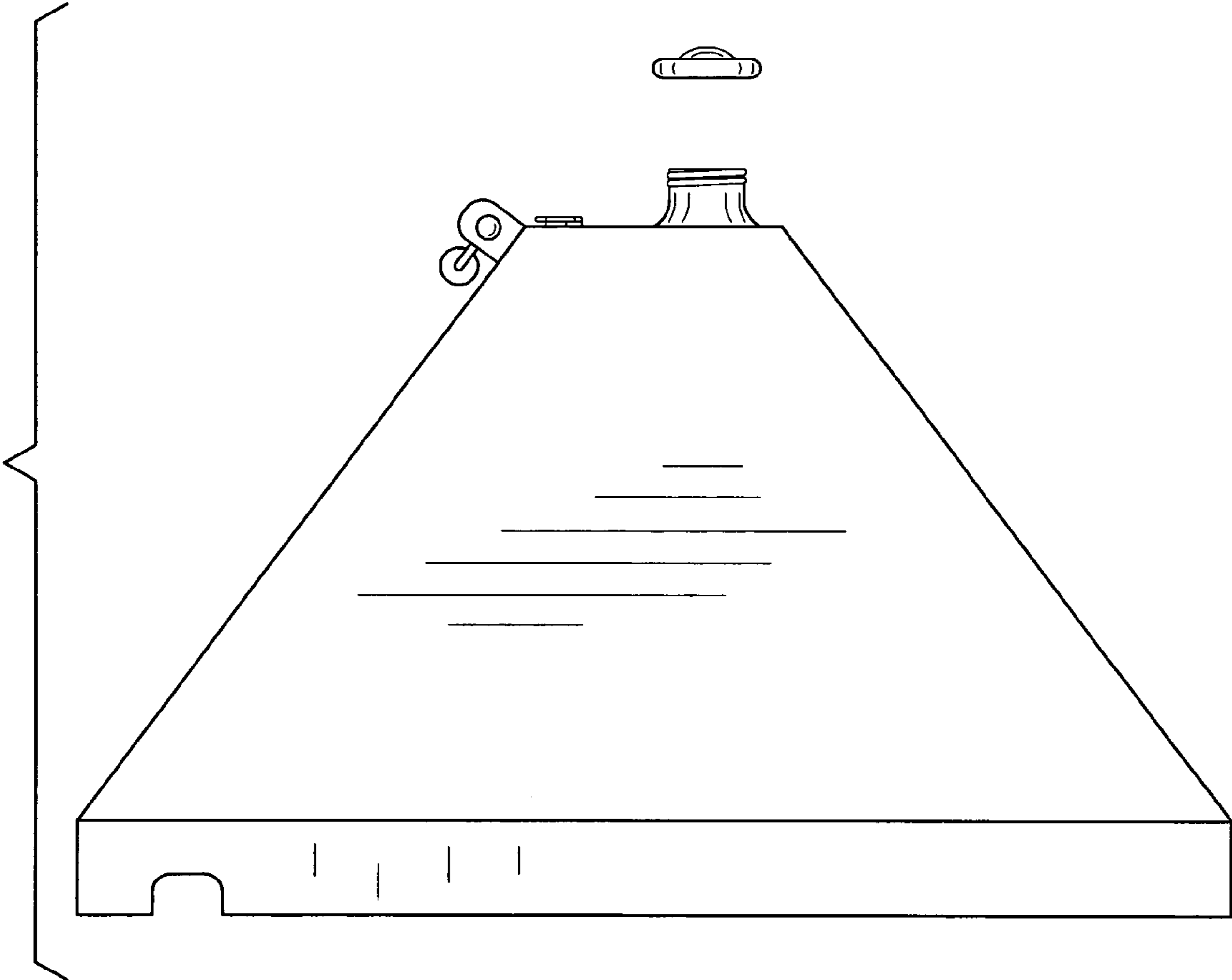

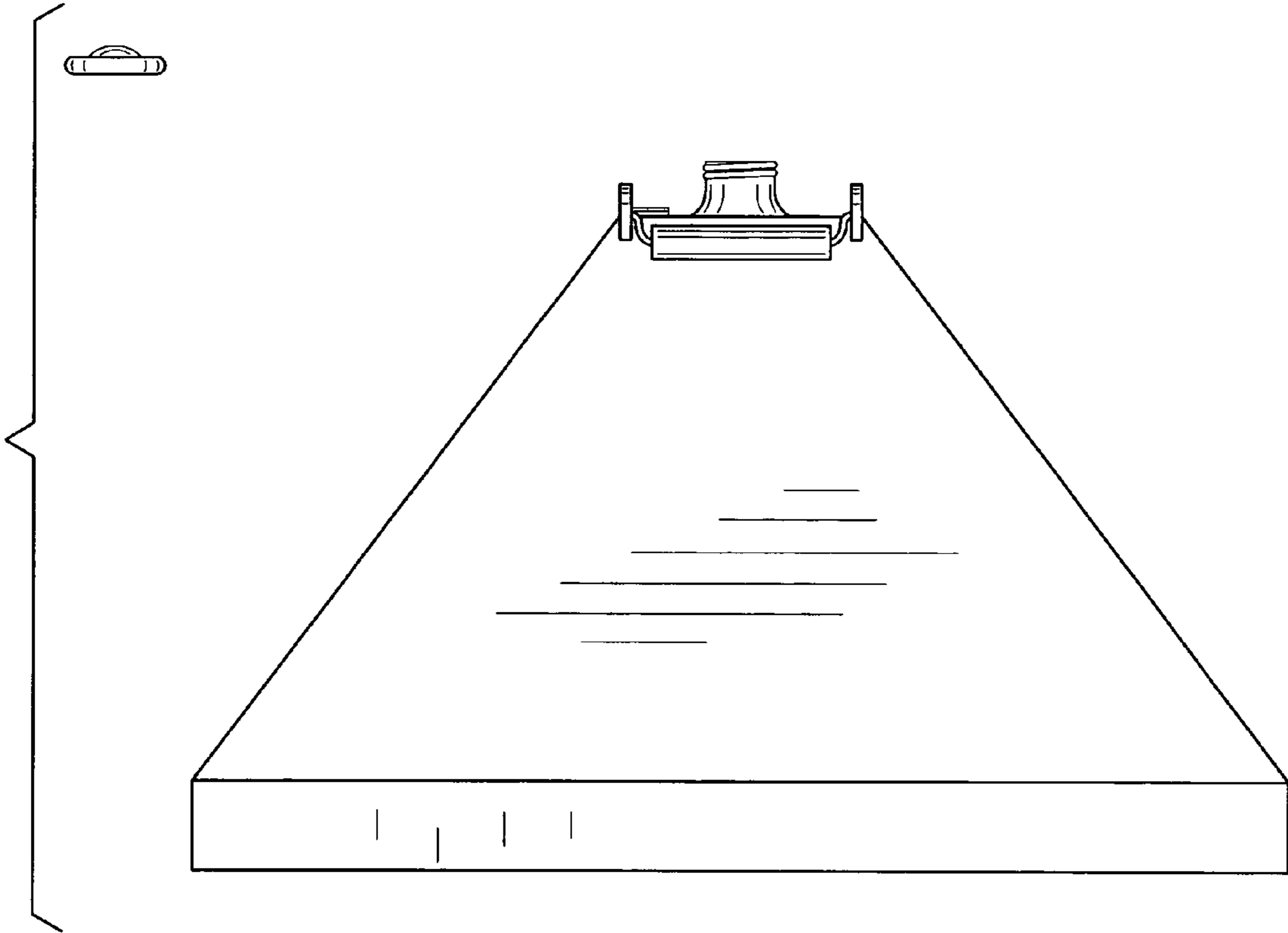

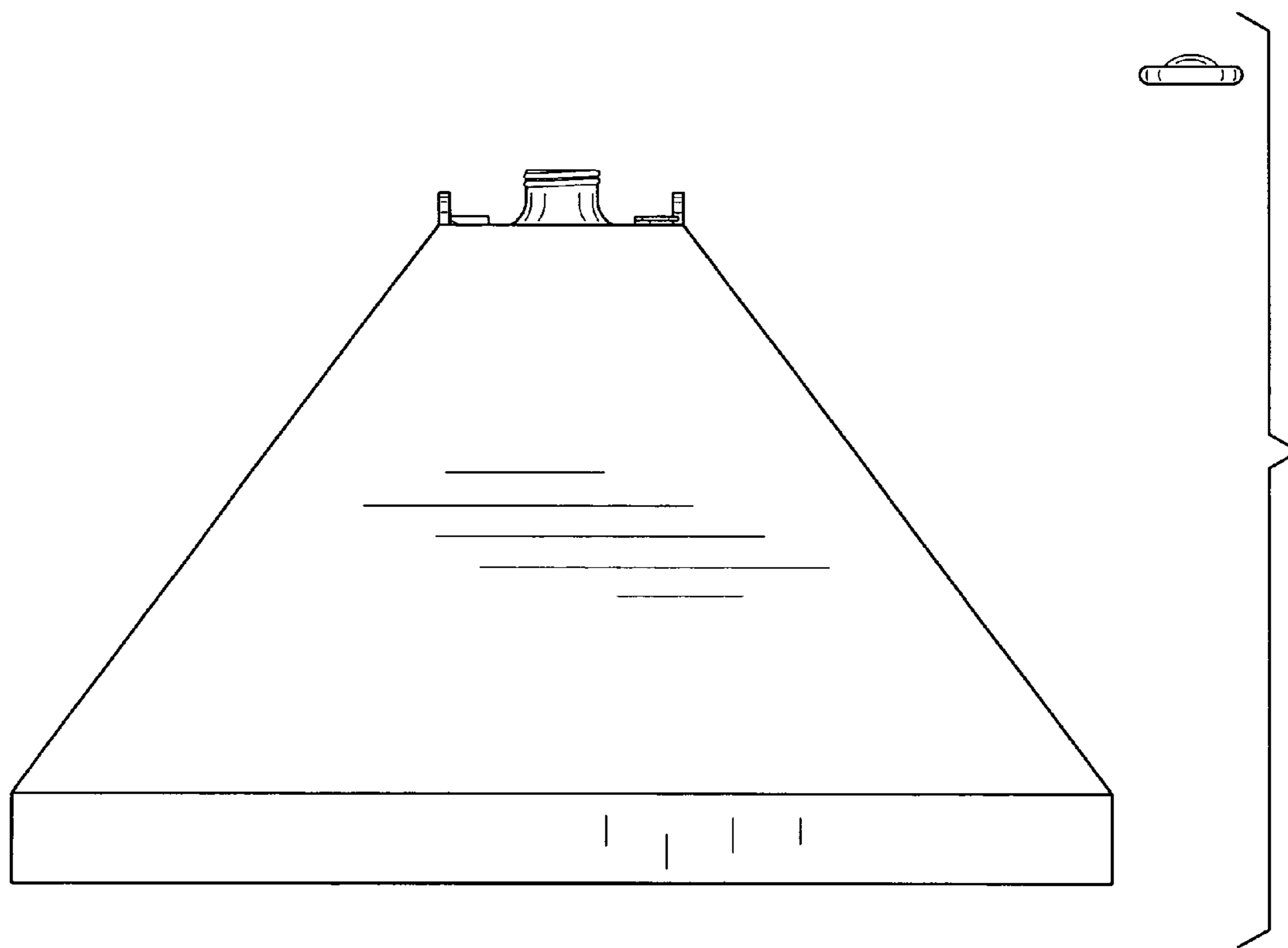

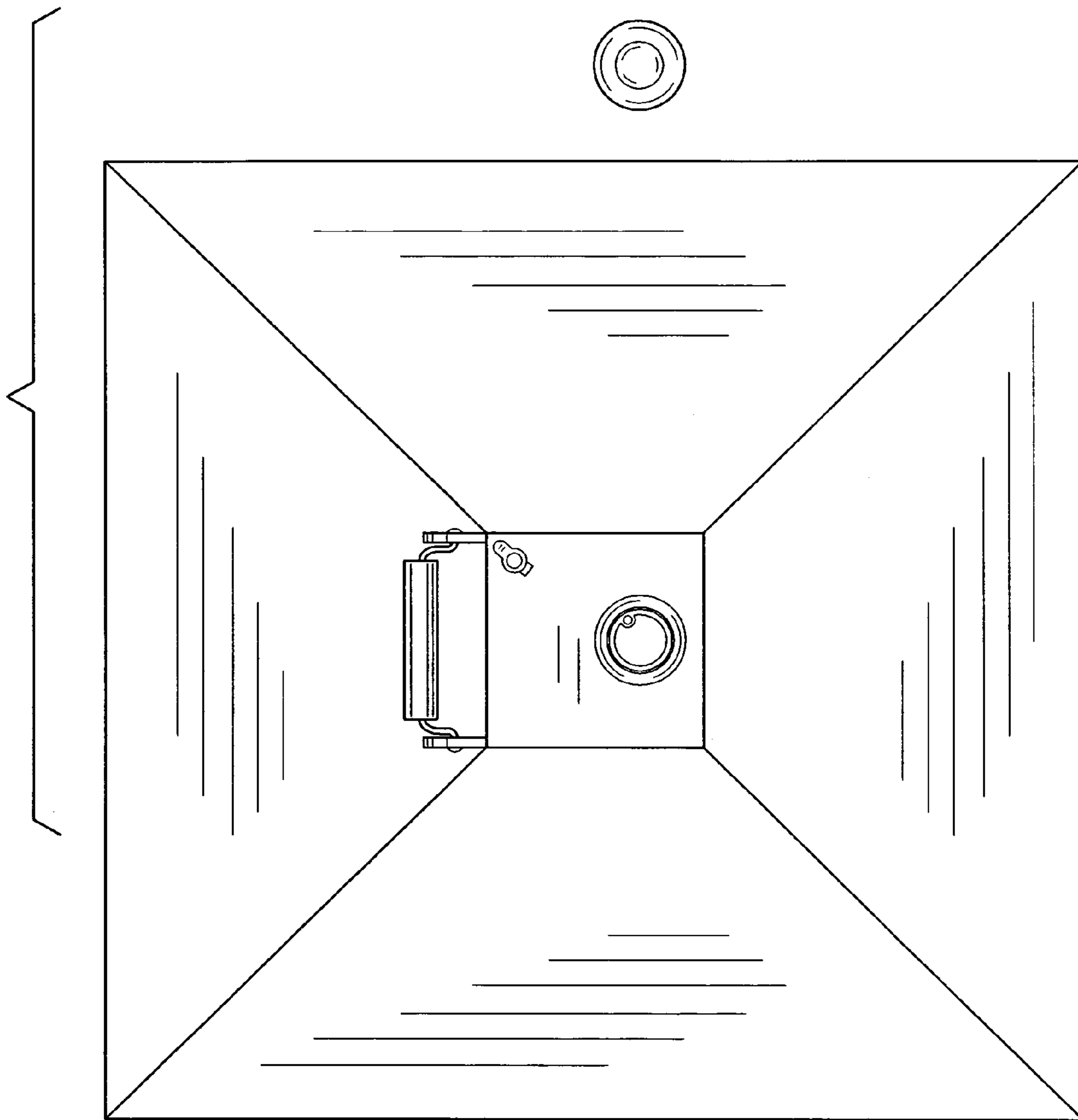

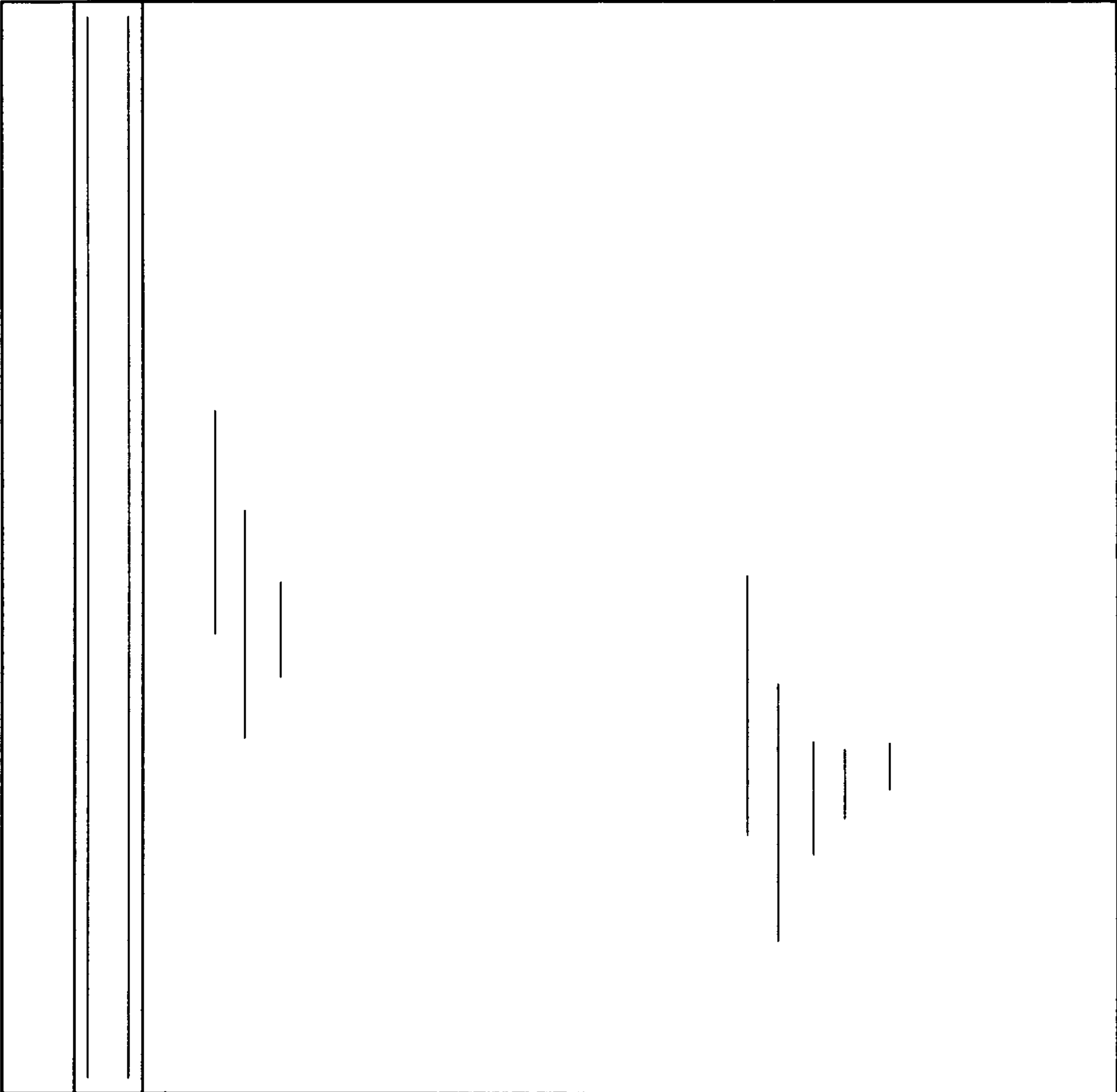
