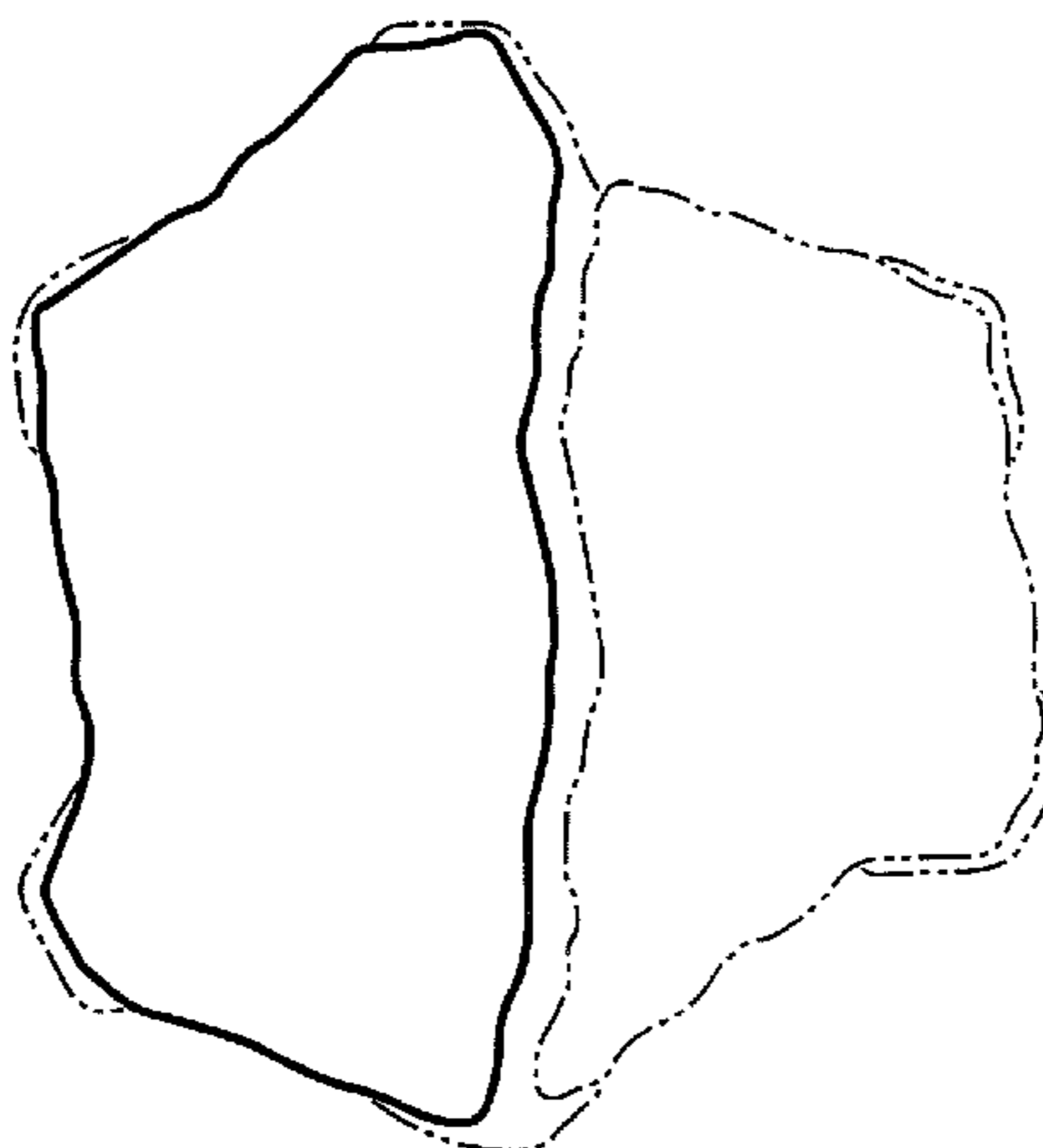
The ornamental design for a top edge portion of a mini random look paver, as shown and described.
