(57) **CLAIM**

We claim, the ornamental design for a cosmetic applicator, as shown and described.

**DESCRIPTION**

FIG. 1 is a side view of the cosmetic applicator of the present invention.

FIG. 2 is a side view of the cosmetic applicator of the present invention rotated 90°.

FIG. 3 is a perspective view of the cosmetic applicator of FIG. 1.

FIG. 4 is a top view of the cosmetic applicator of FIG. 1.

FIG. 5 is a bottom view of the cosmetic applicator fo FIG. 1.

FIG. 6 is an exploded view of the applicator of FIG. 2.

FIG. 7 is a side view of the cosmetic applicator of the present invention with a knurled base.

FIG. 8 is a side view of the cosmetic applicator of FIG. 7 rotated 90°.

FIG. 9 is a perspective view of the cosmetic applicator of FIG. 7.

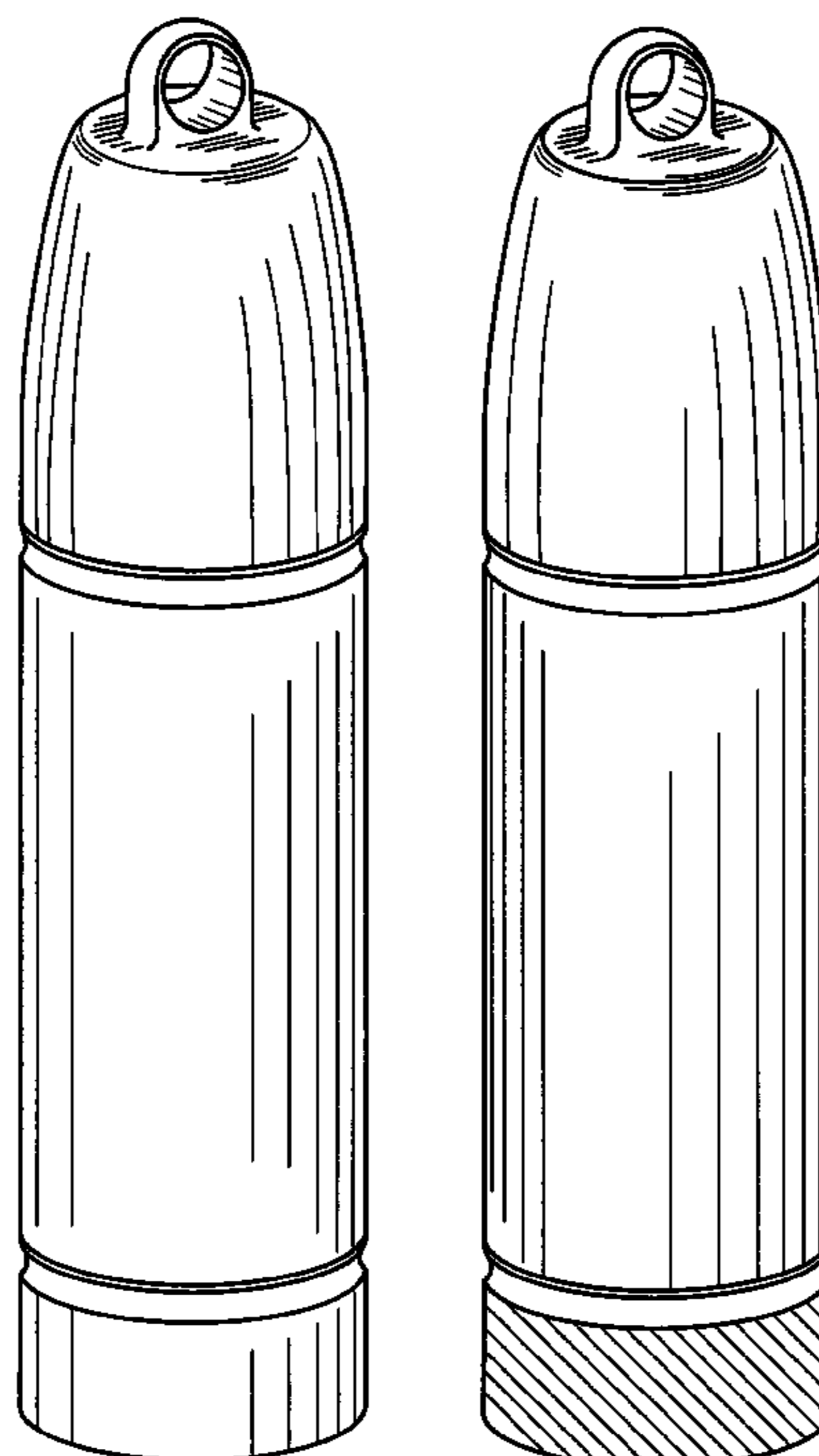
FIG. 10 is a top view of the cosmetic applicator of FIG. 7.

FIG. 11 is a bottom view of the cosmetic applicator fo FIG. 7; and,

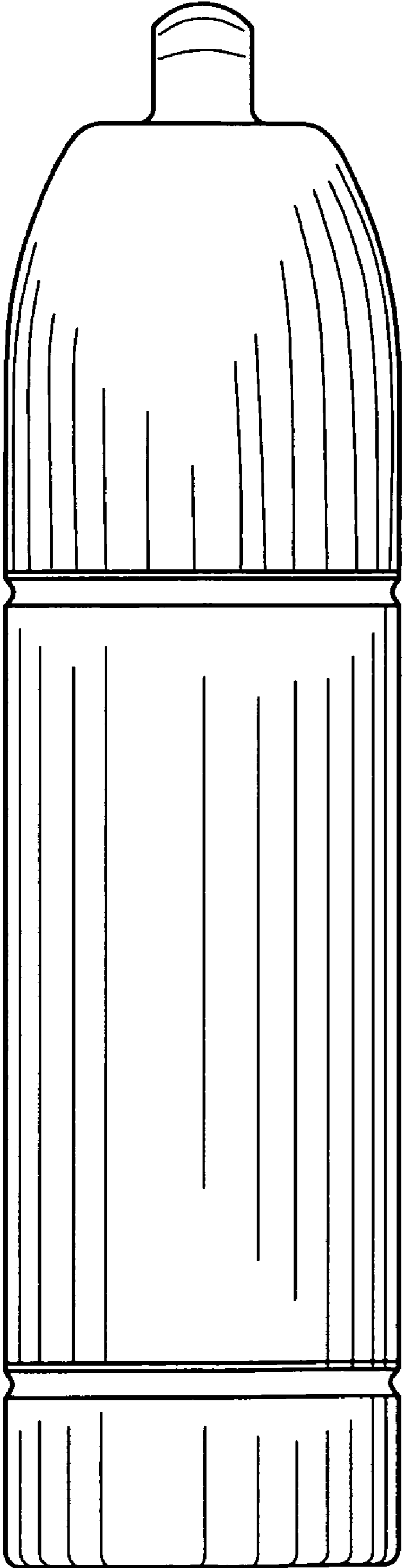
FIG. 12 is an exploded view of the applicator of FIG. 7.

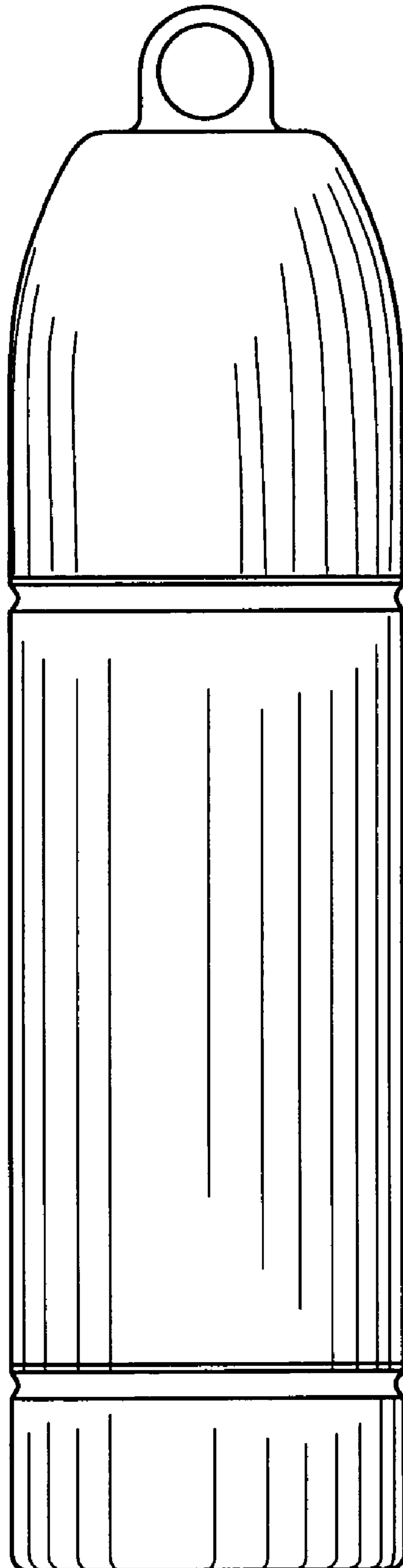

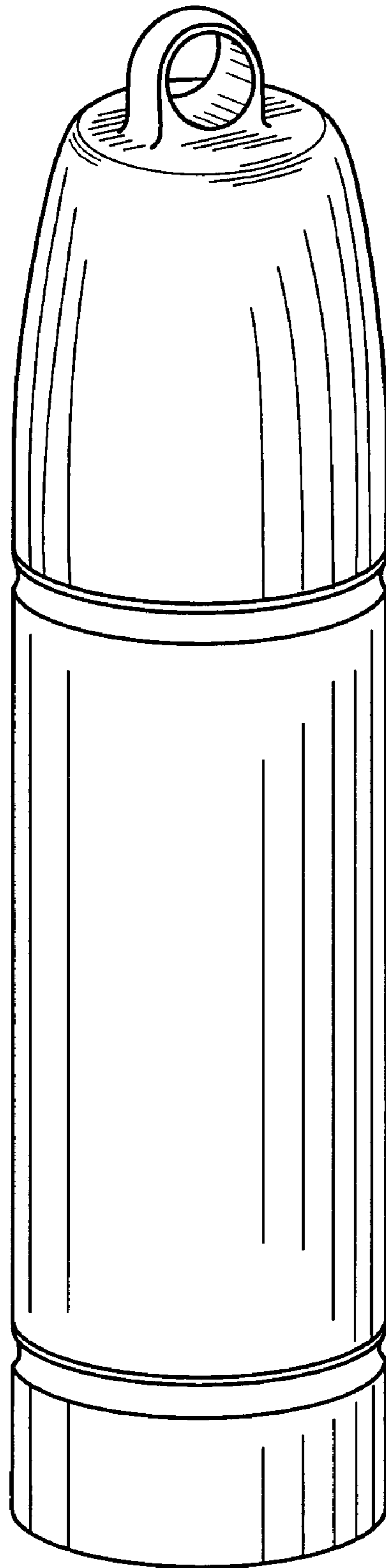

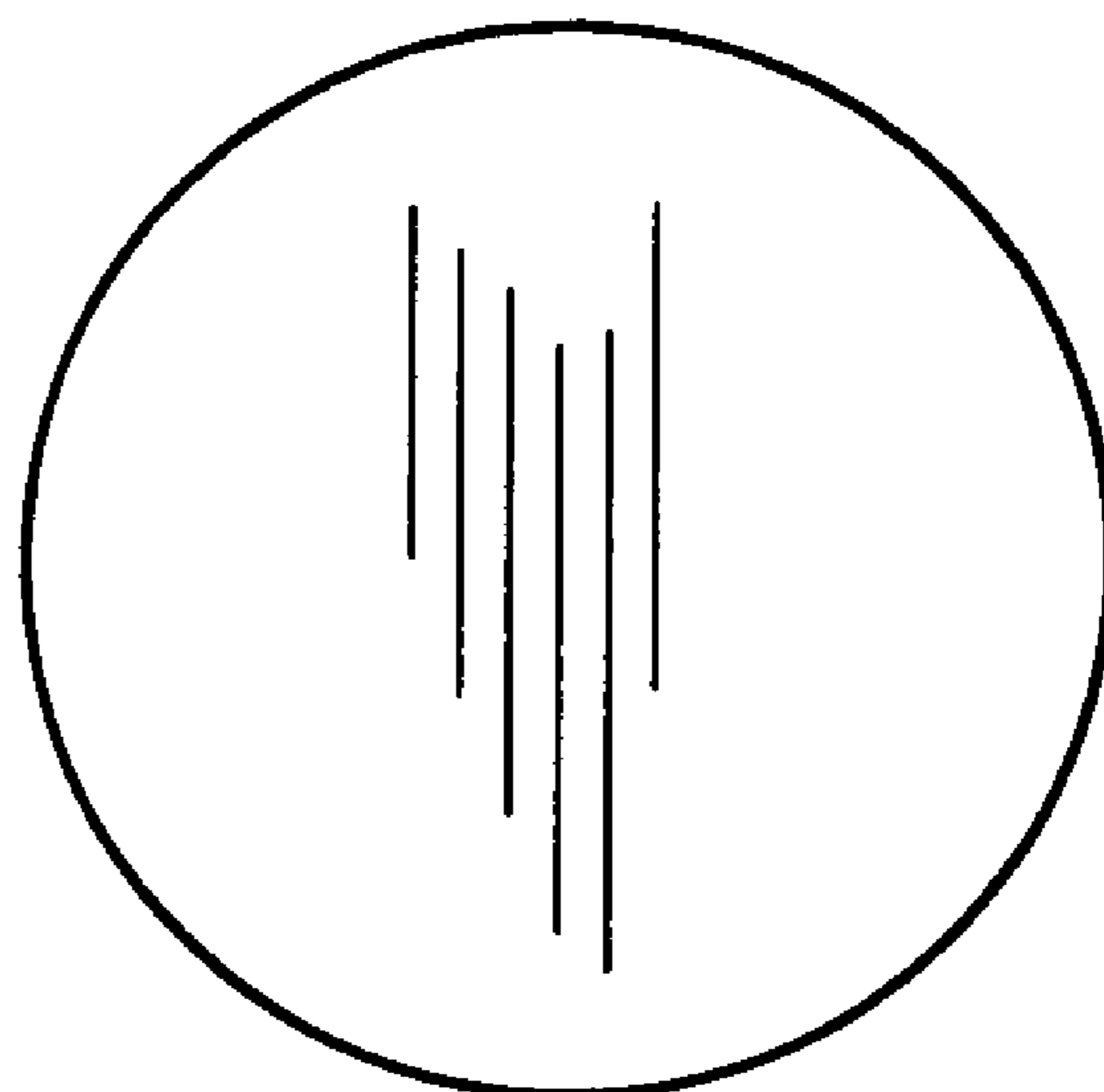
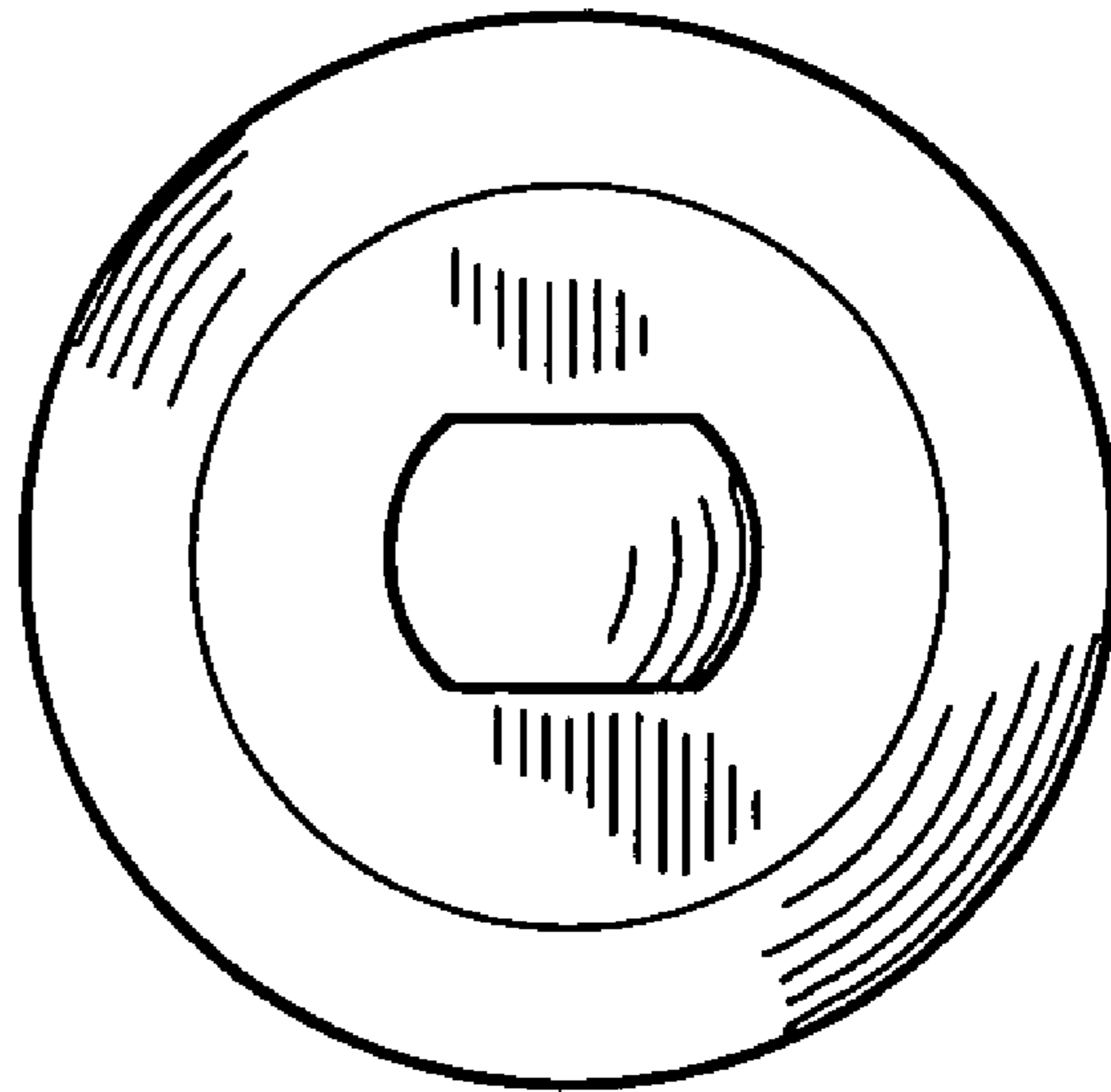

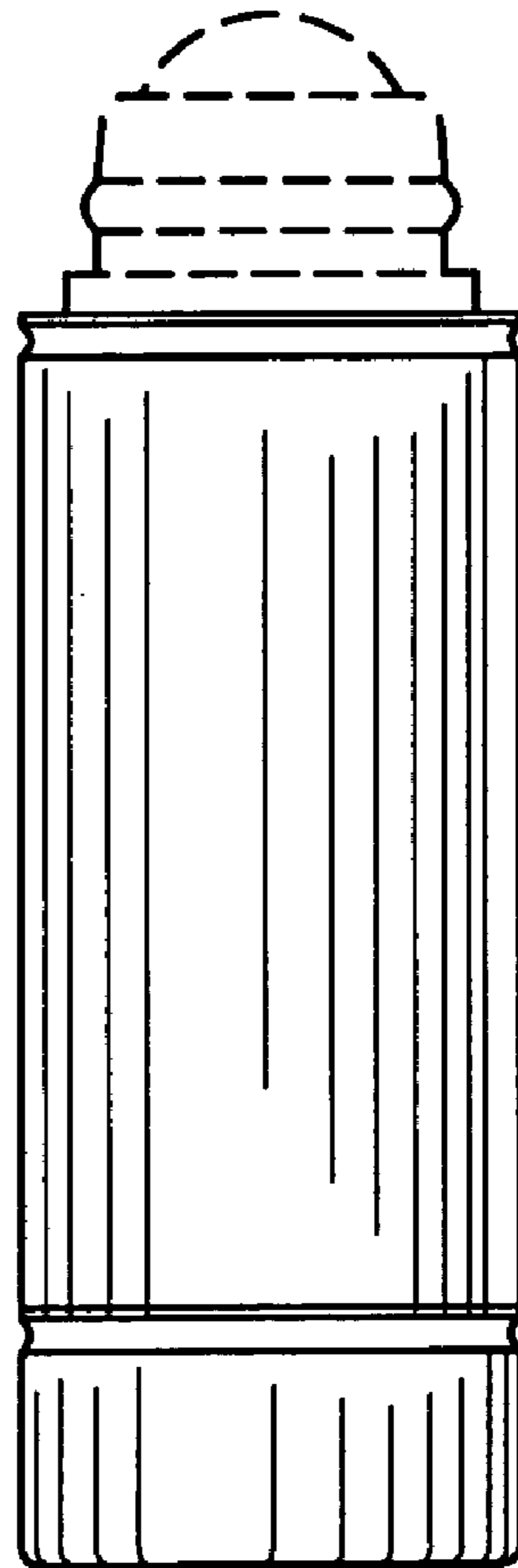
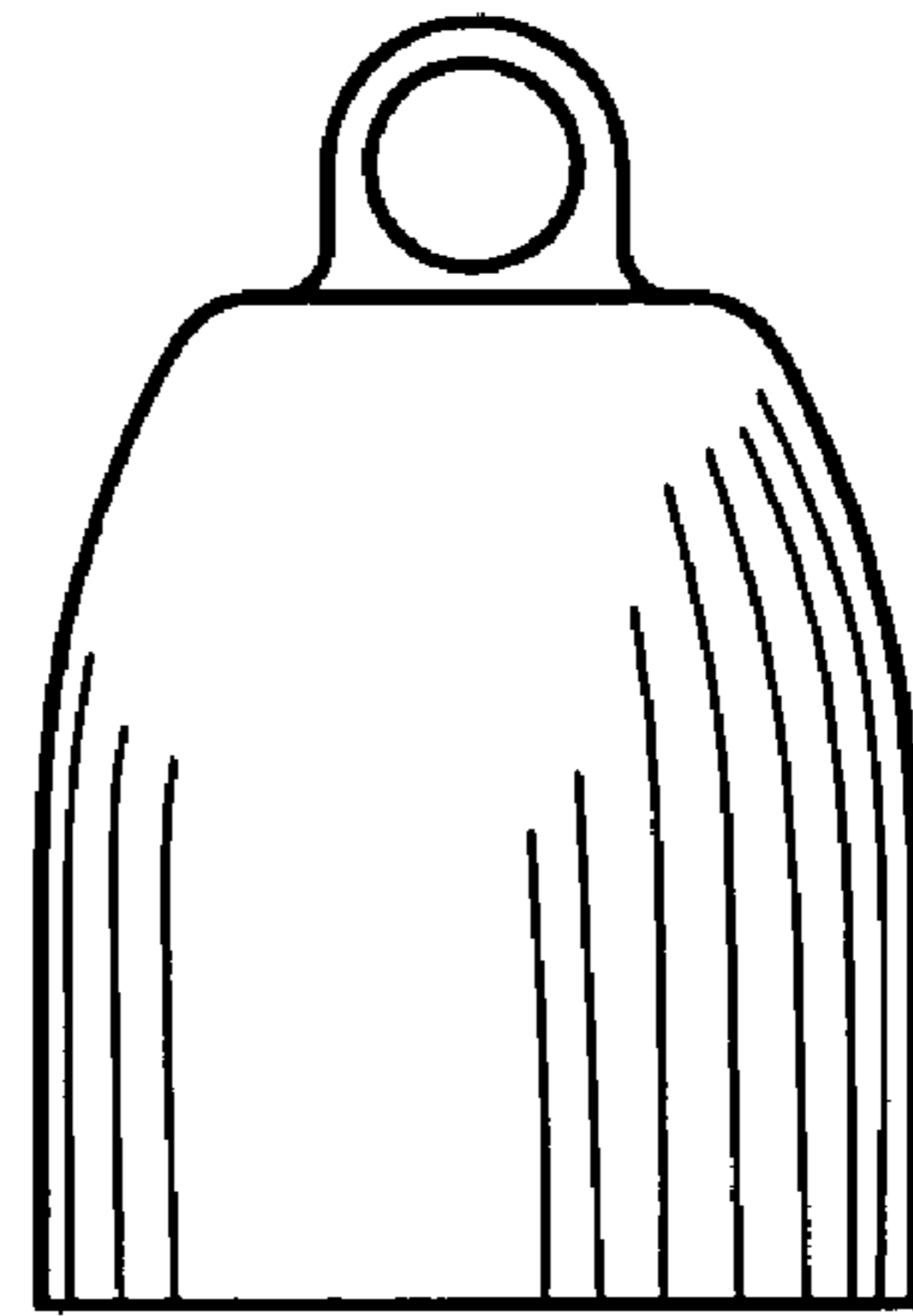

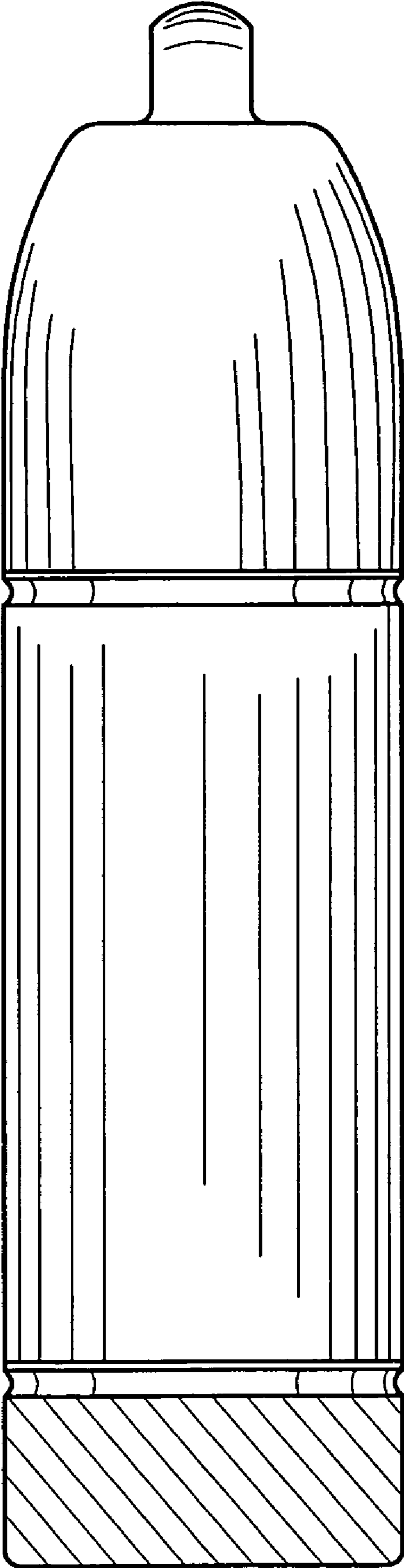

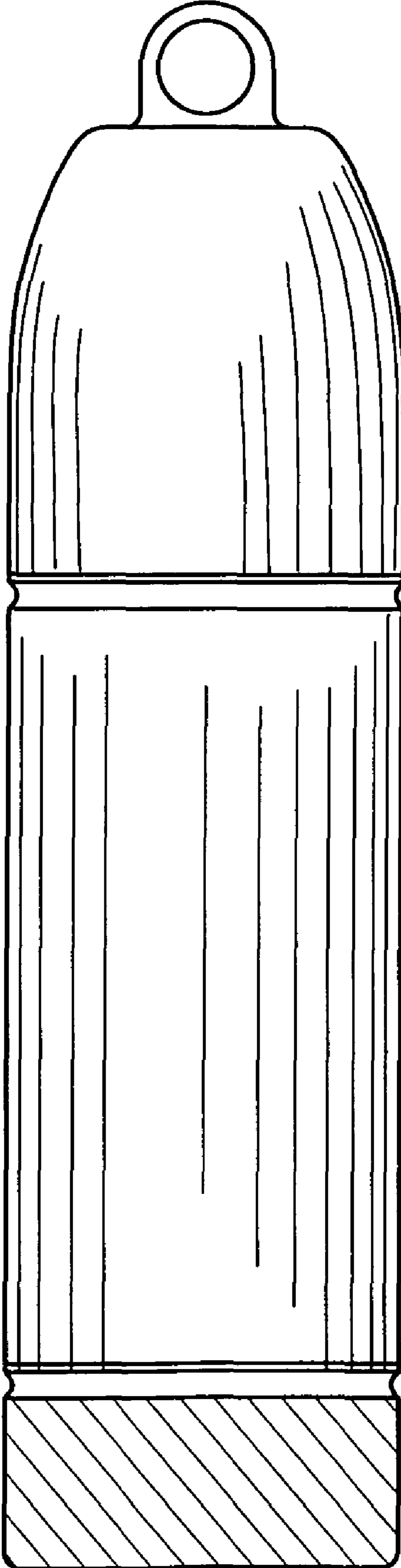

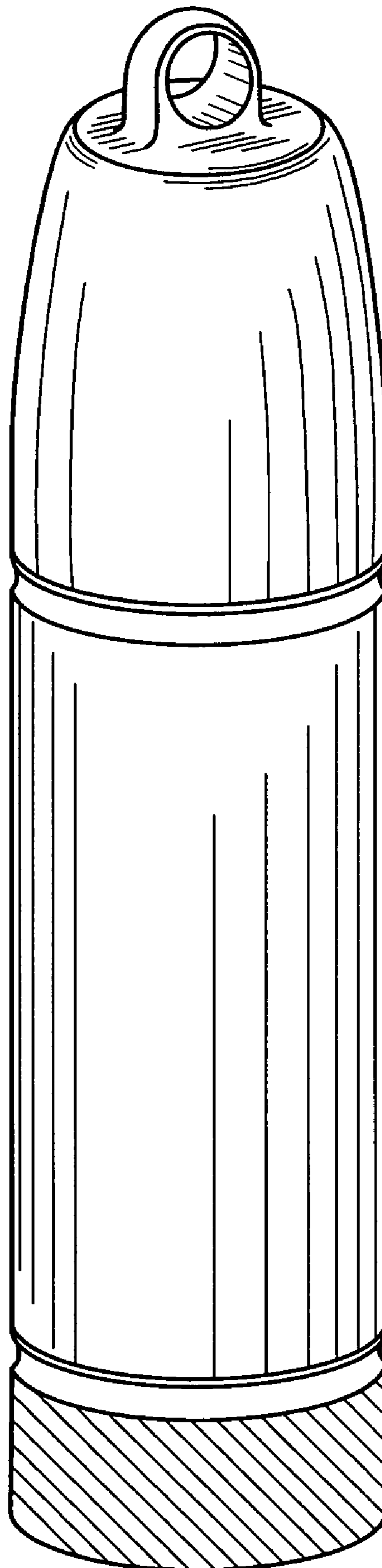

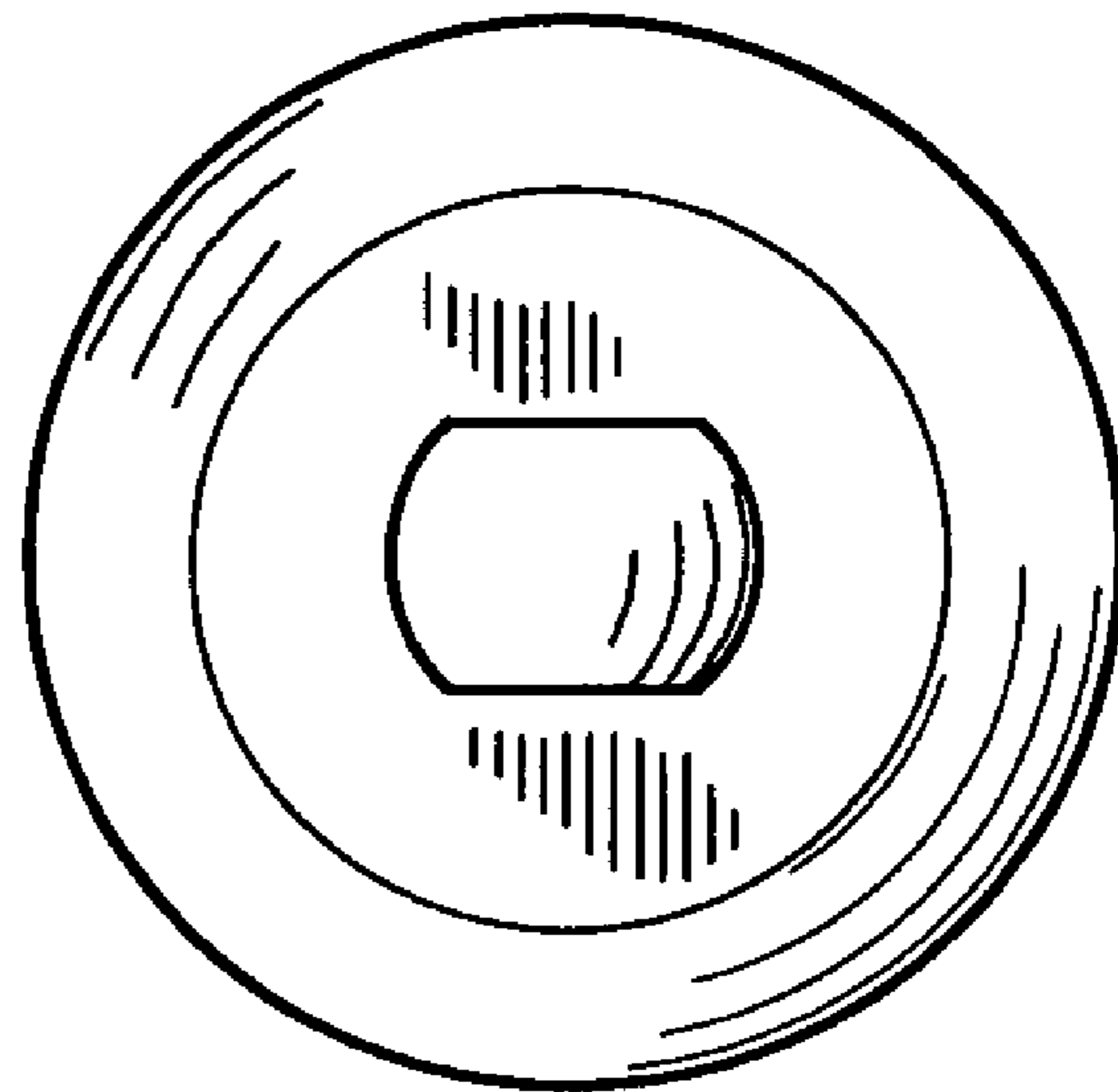




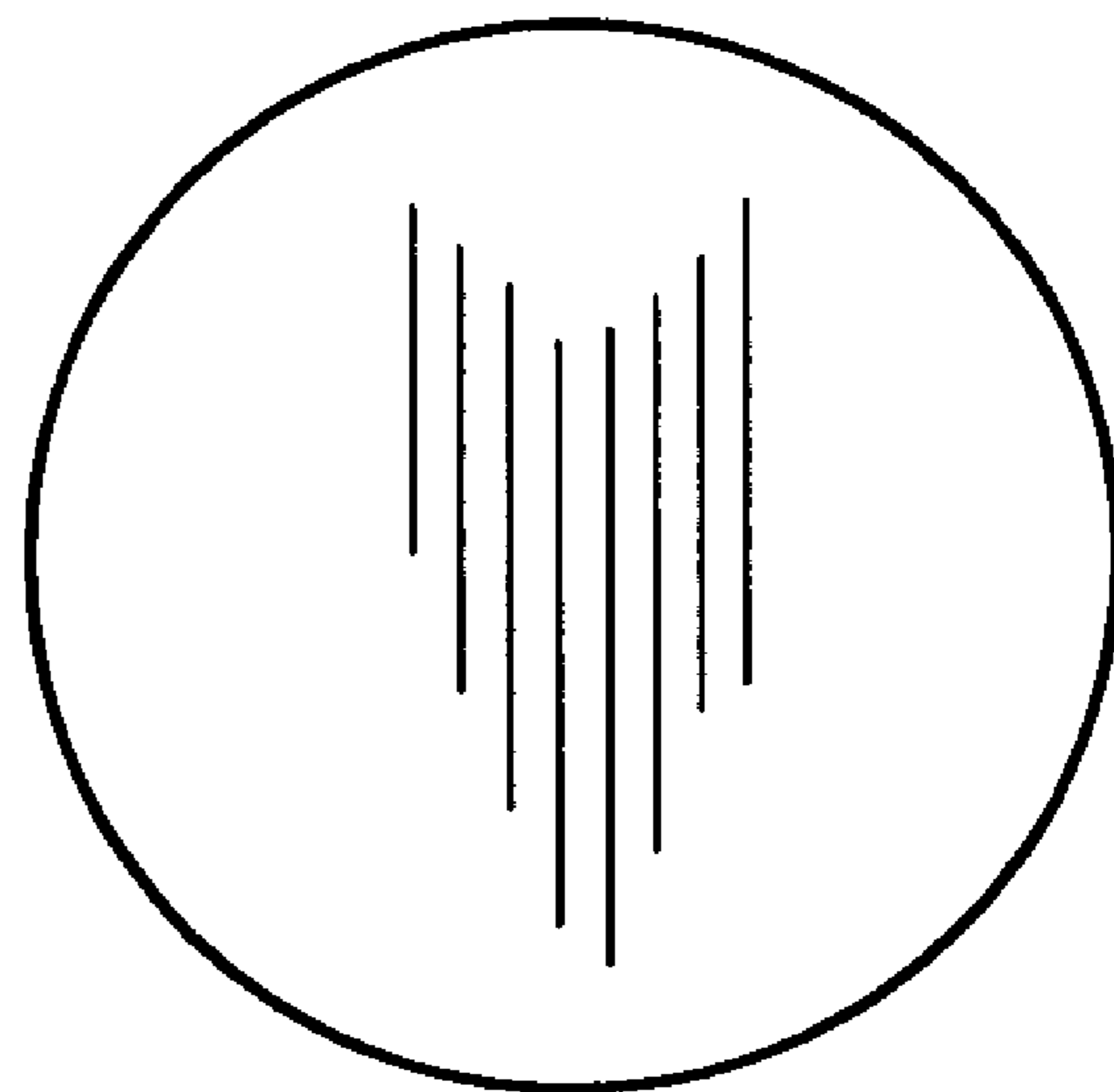
