FIG. 1 is a right front perspective view of the animal collar in its open position;

FIG. 2 is a top view of the animal collar in its open position;

FIG. 3 is a front view of the animal collar in its open position; the back view being a mirror image thereof;

FIG. 4 is a bottom view of the animal collar in its open position;

FIG. 5 is a right side view of the animal collar in its open position;

FIG. 6 is a left side view of the animal collar in its open position;

FIG. 7 is a top view of the animal collar in its closed position;

FIG. 8 is a front view of the animal collar in its closed position;

FIG. 9 is a right front perspective view of the animal collar in its closed position;

FIG. 10 is a right side view of the animal collar in its closed position; and,

FIG. 11 is a left front perspective view of the animal collar in its closed position shown in use around a dog's neck.

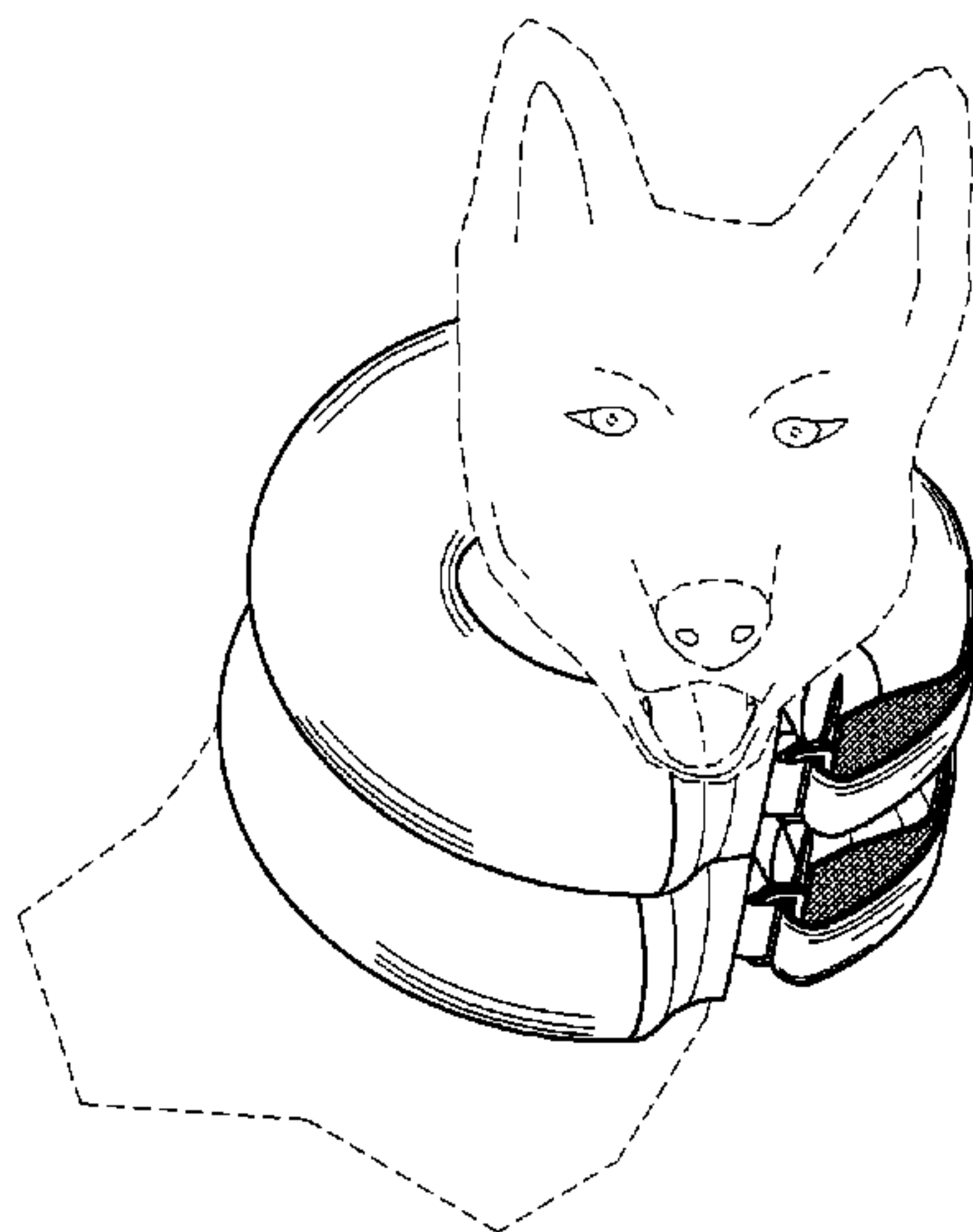
The broken line showing of a dog is for environmental illustration only and is not part of the claimed design.

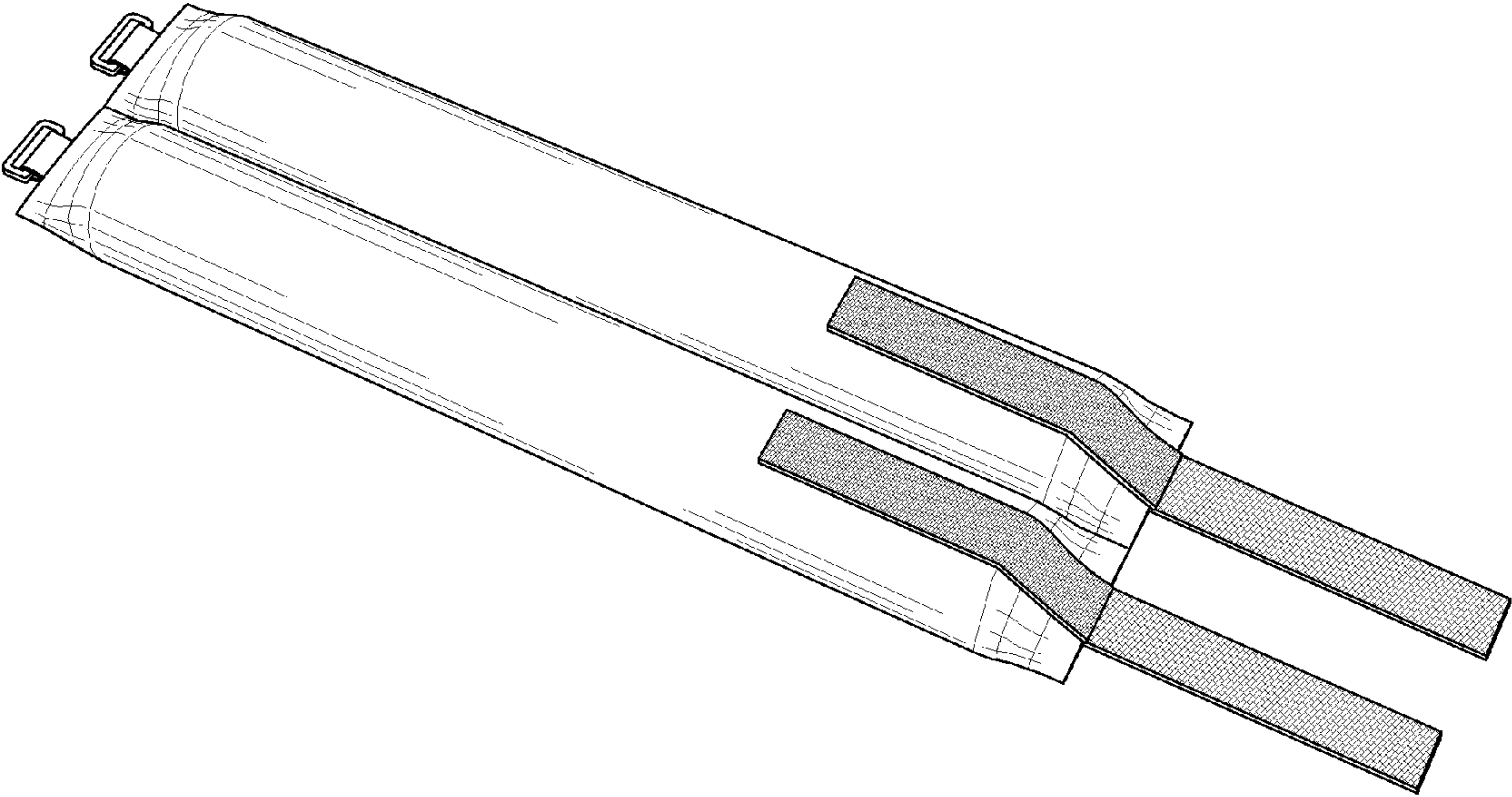

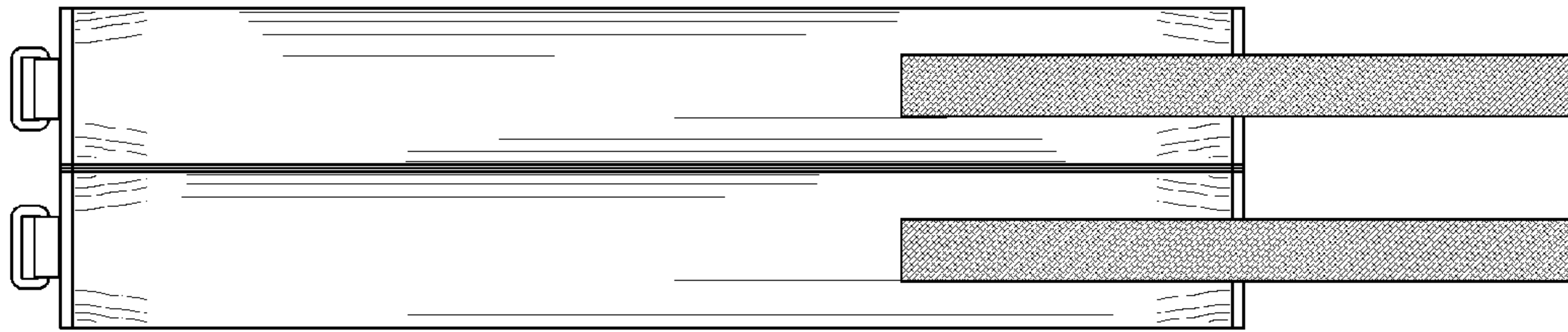

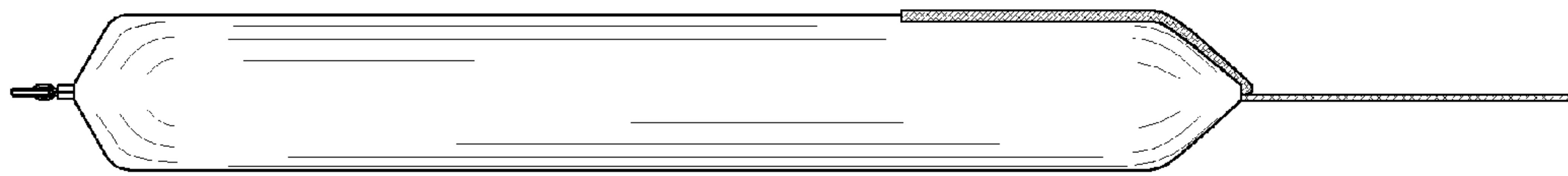

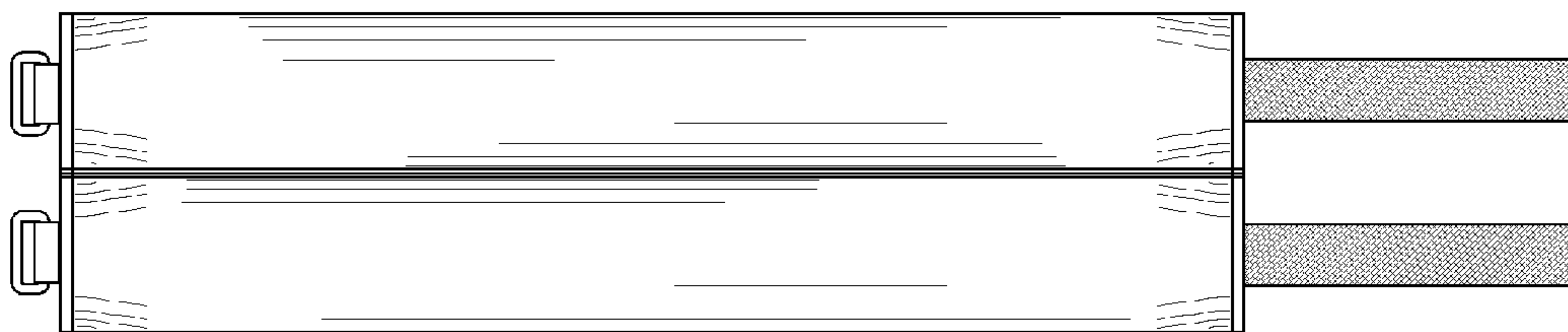

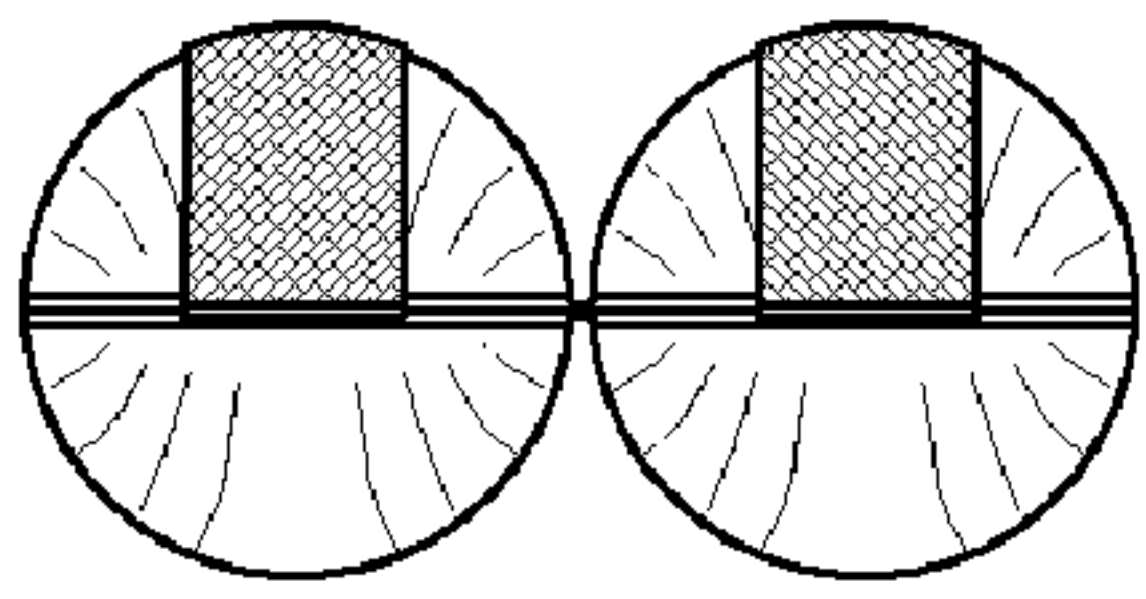

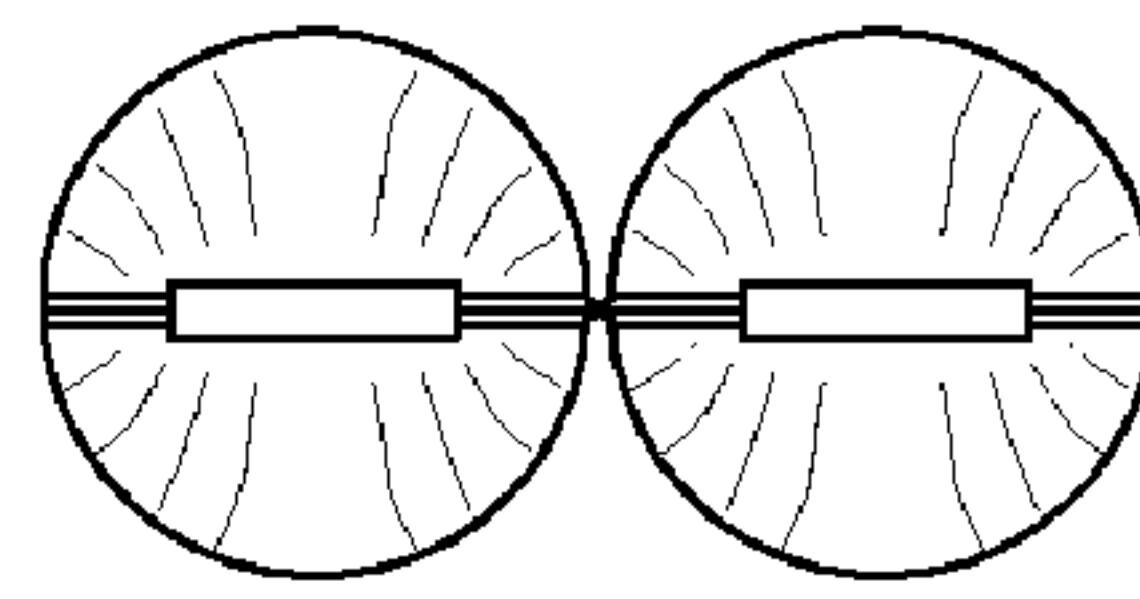

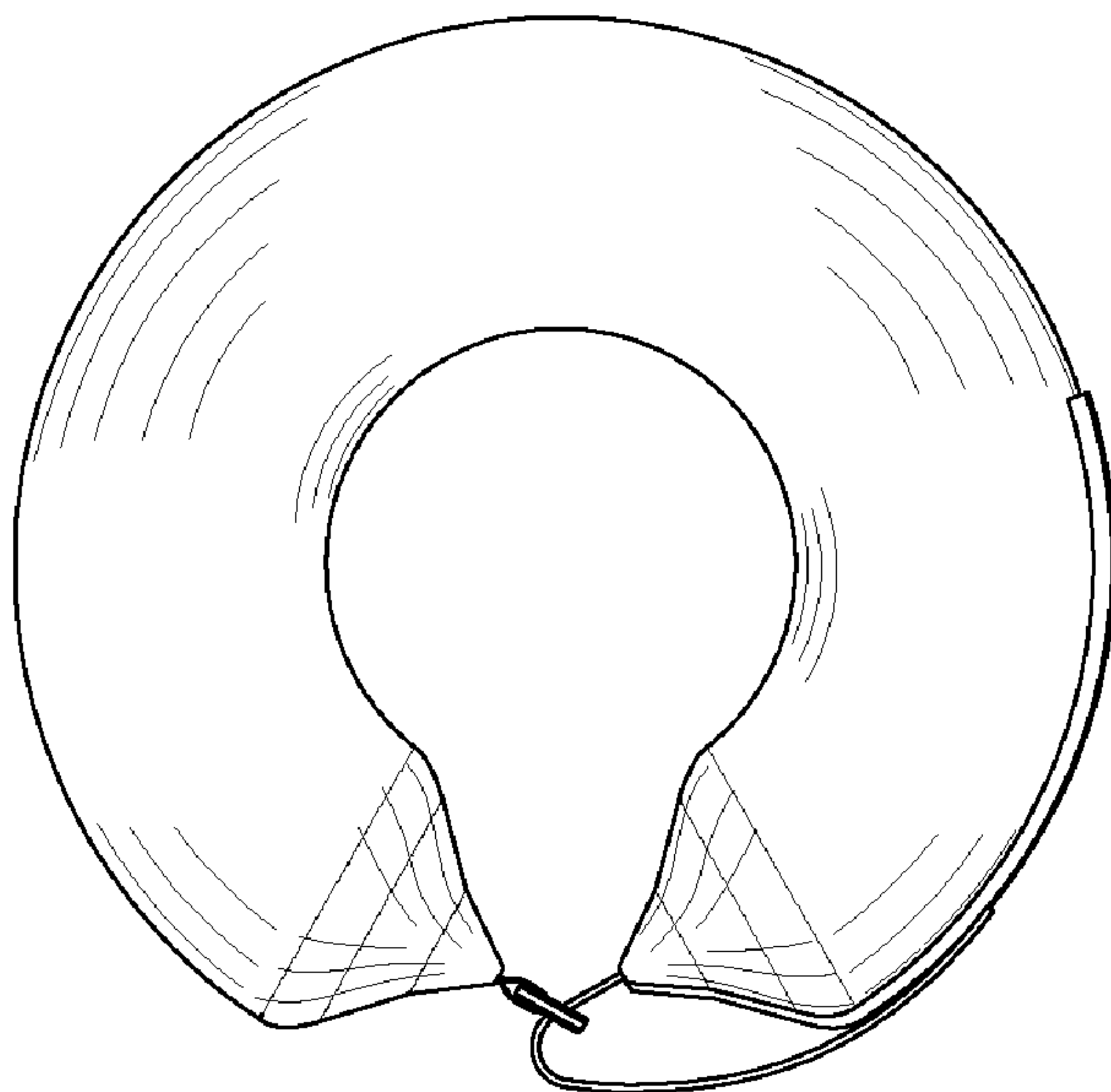

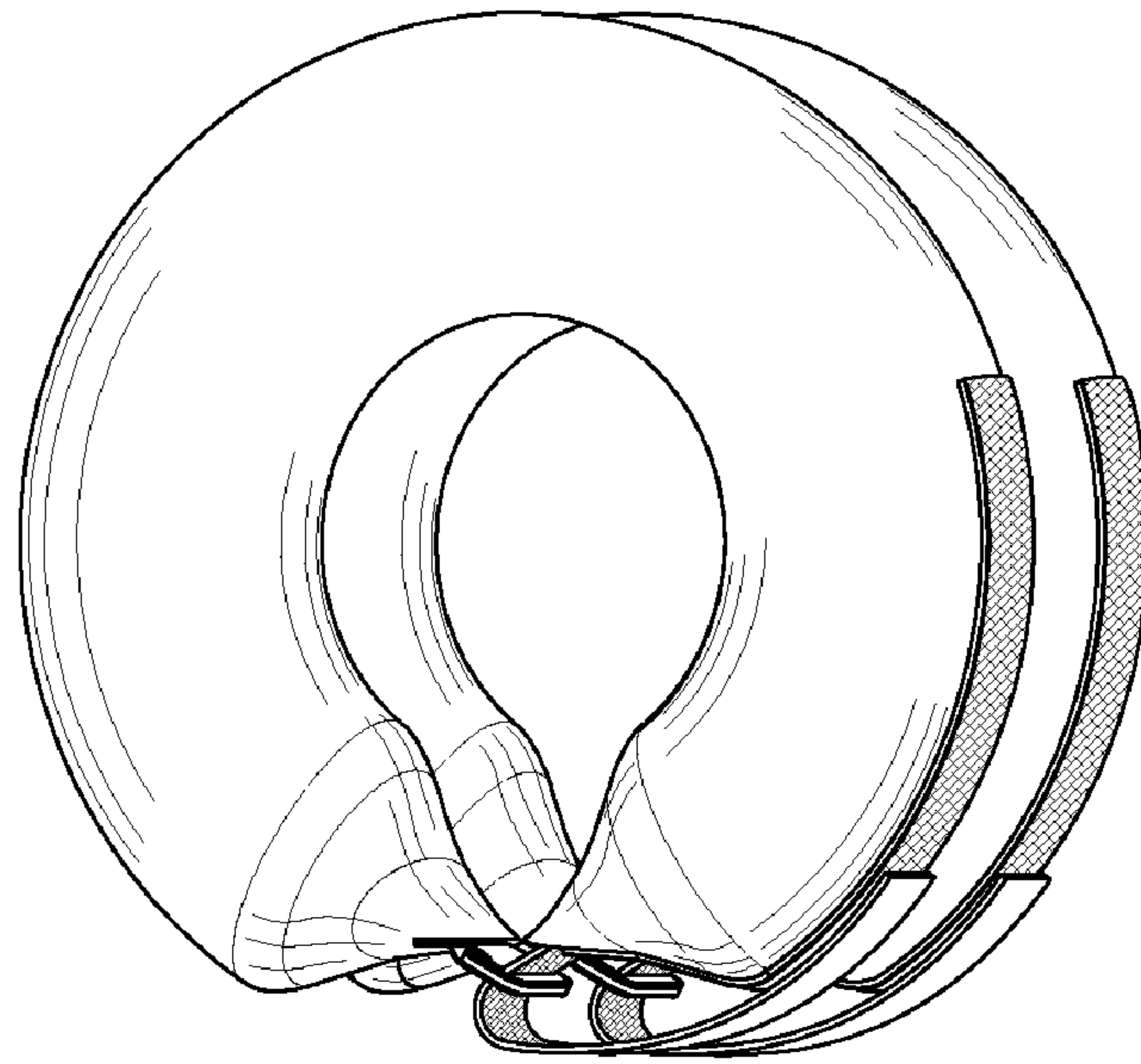

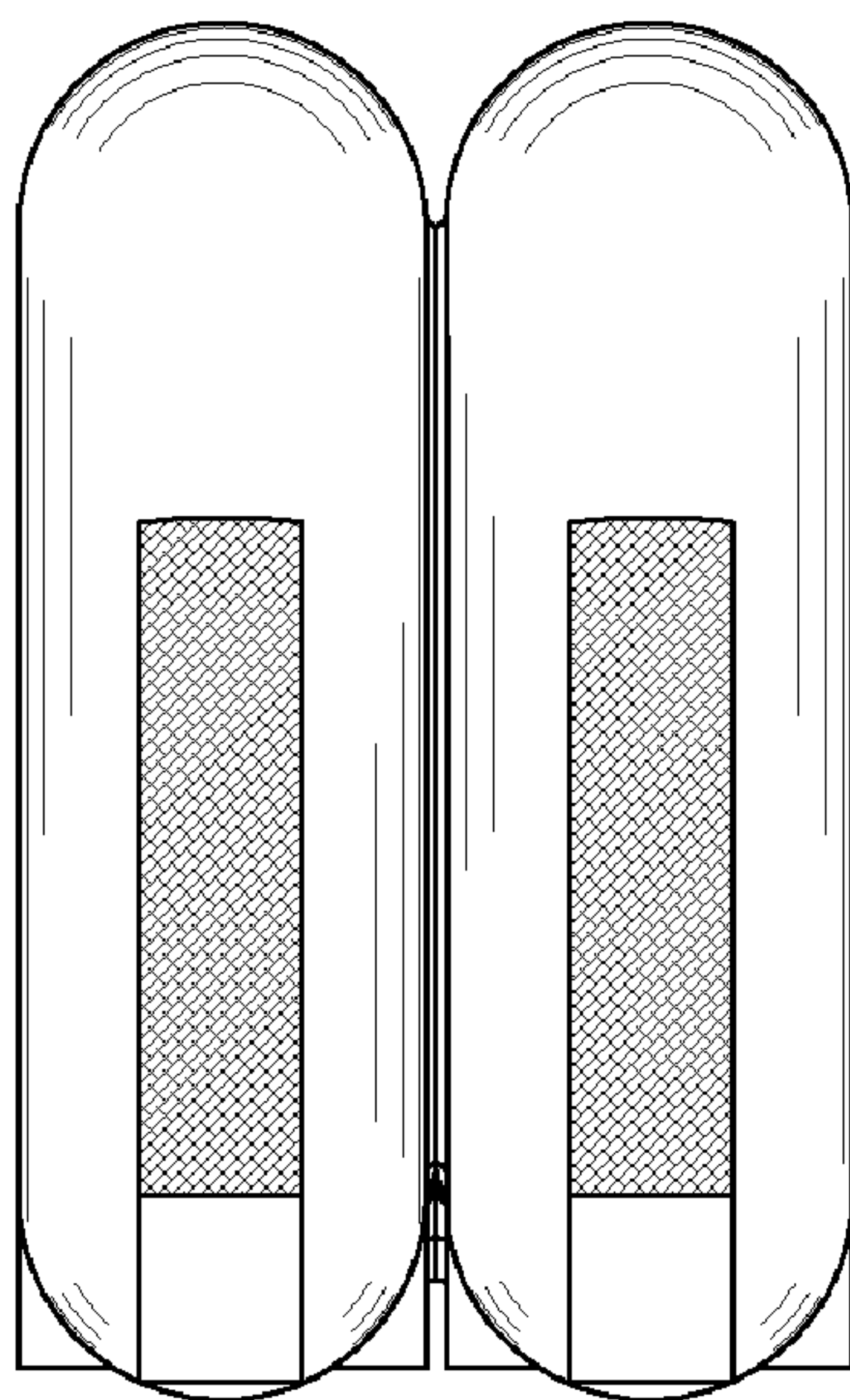

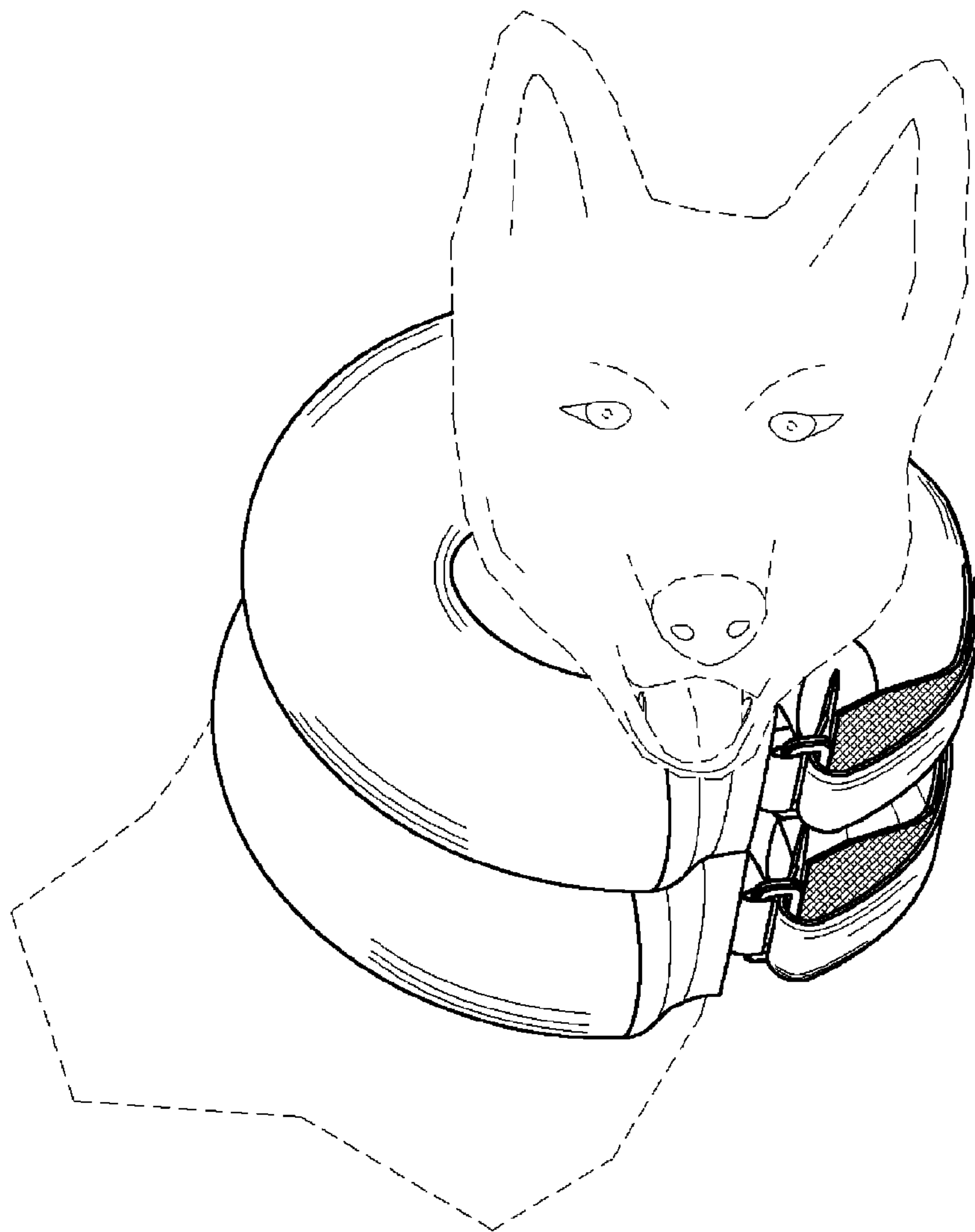
