(57) **CLAIM**

The ornamental design for a grip for cleaning utensil, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a grip for cleaning utensil showing my new design;

FIG. 2 is a front elevational view of the grip for cleaning utensil of FIG. 1;

FIG. 3 is a rear elevational view of the grip for cleaning utensil of FIG. 1;

FIG. 4 is a left side elevational view of the grip for cleaning utensil of FIG. 1;

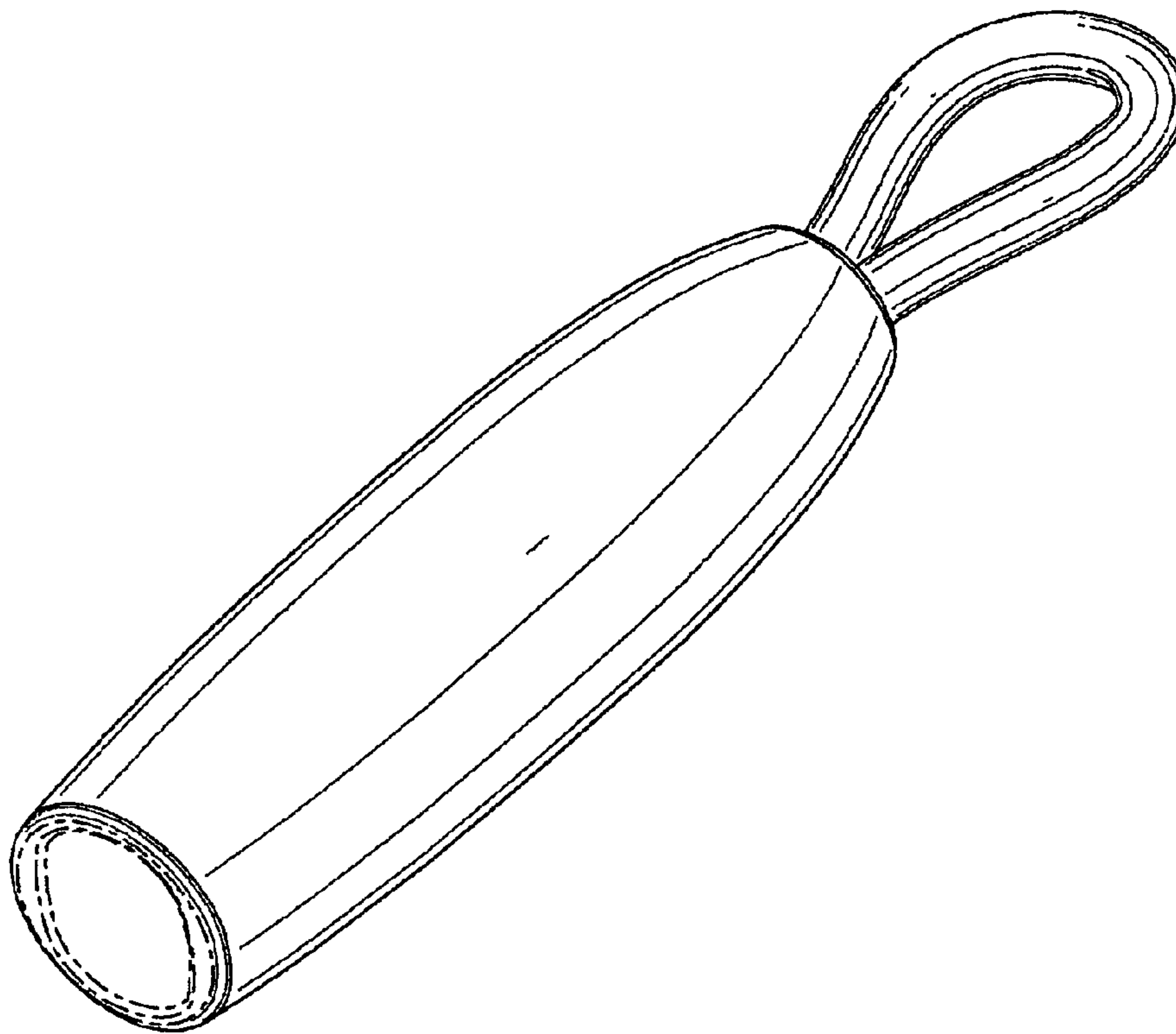
FIG. 5 is a right side elevational view of the grip for cleaning utensil of FIG. 1;

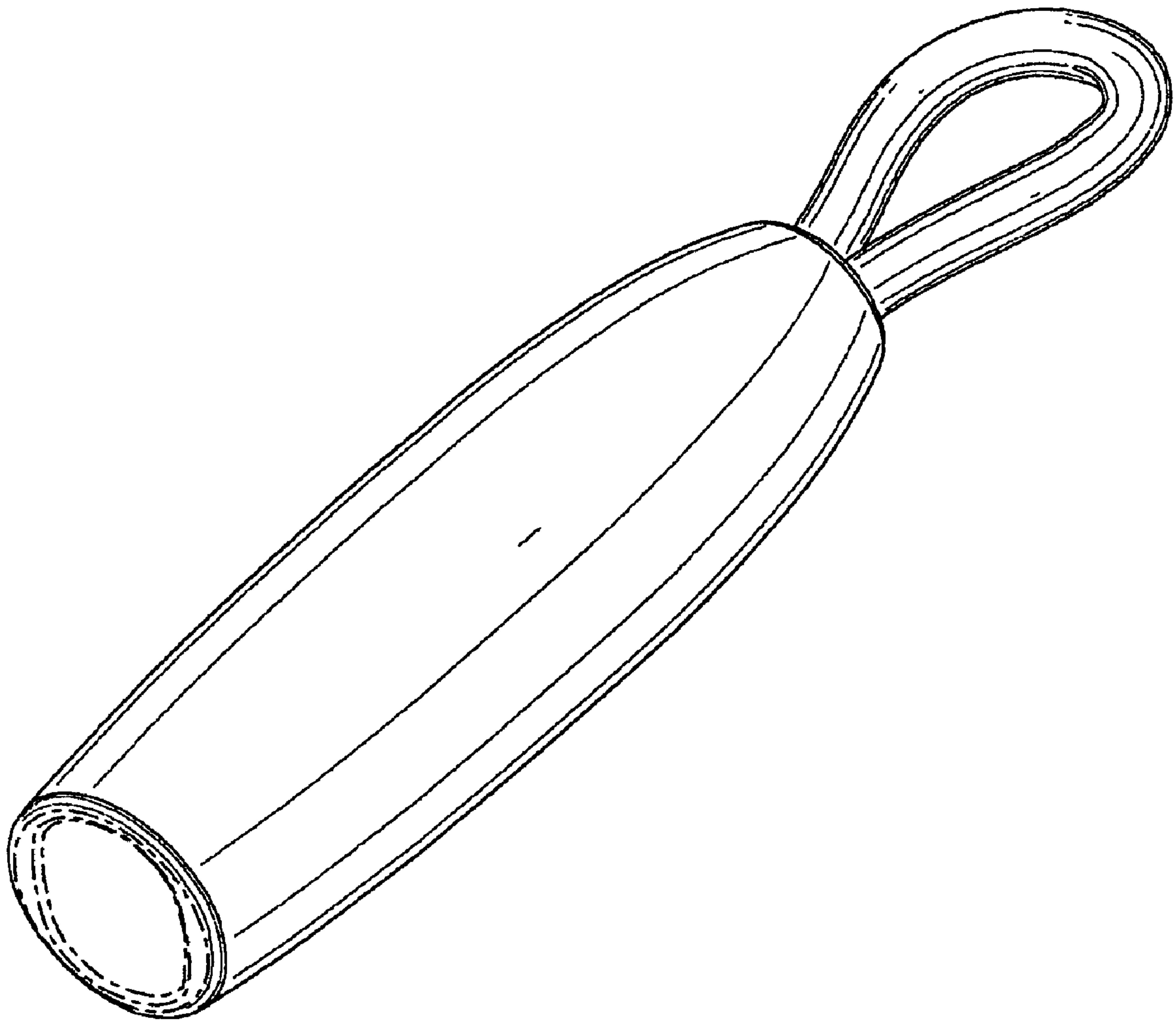

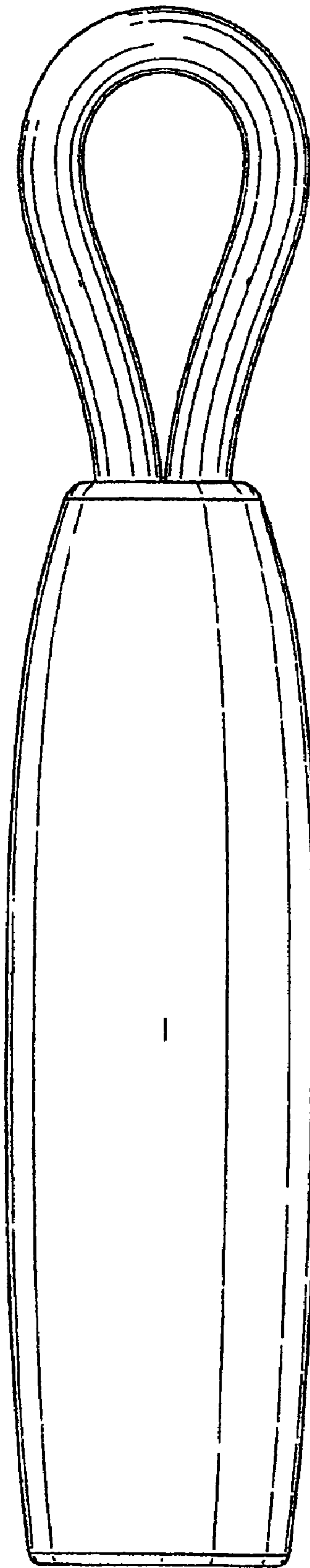

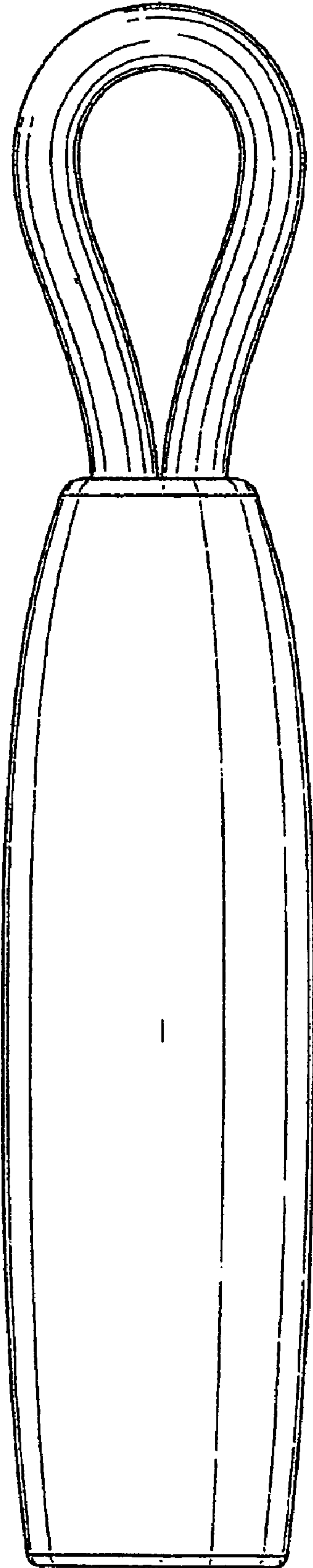

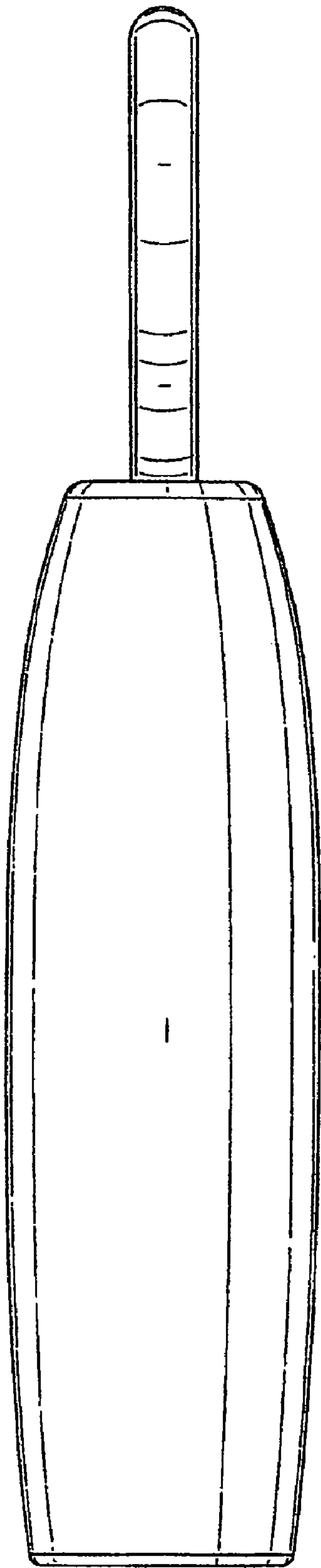

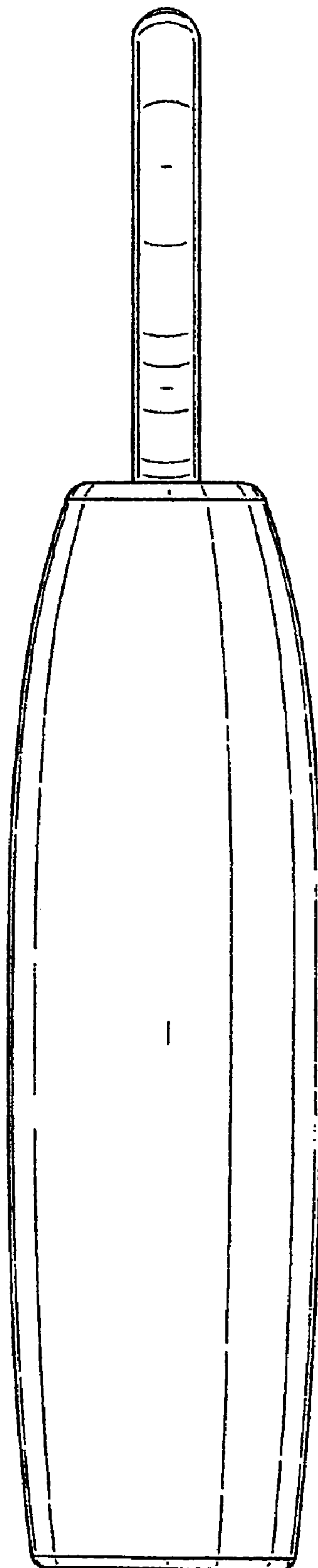

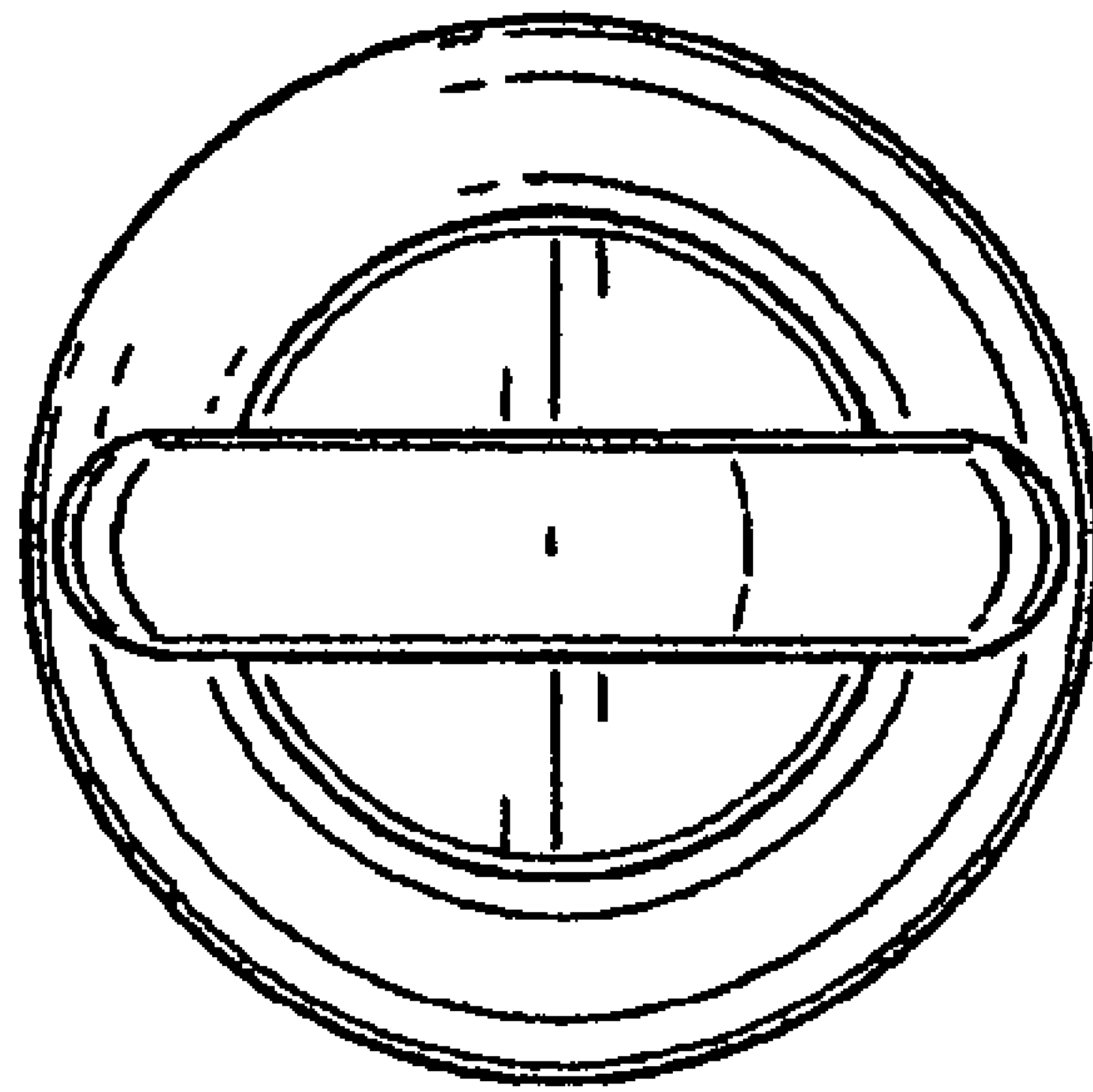

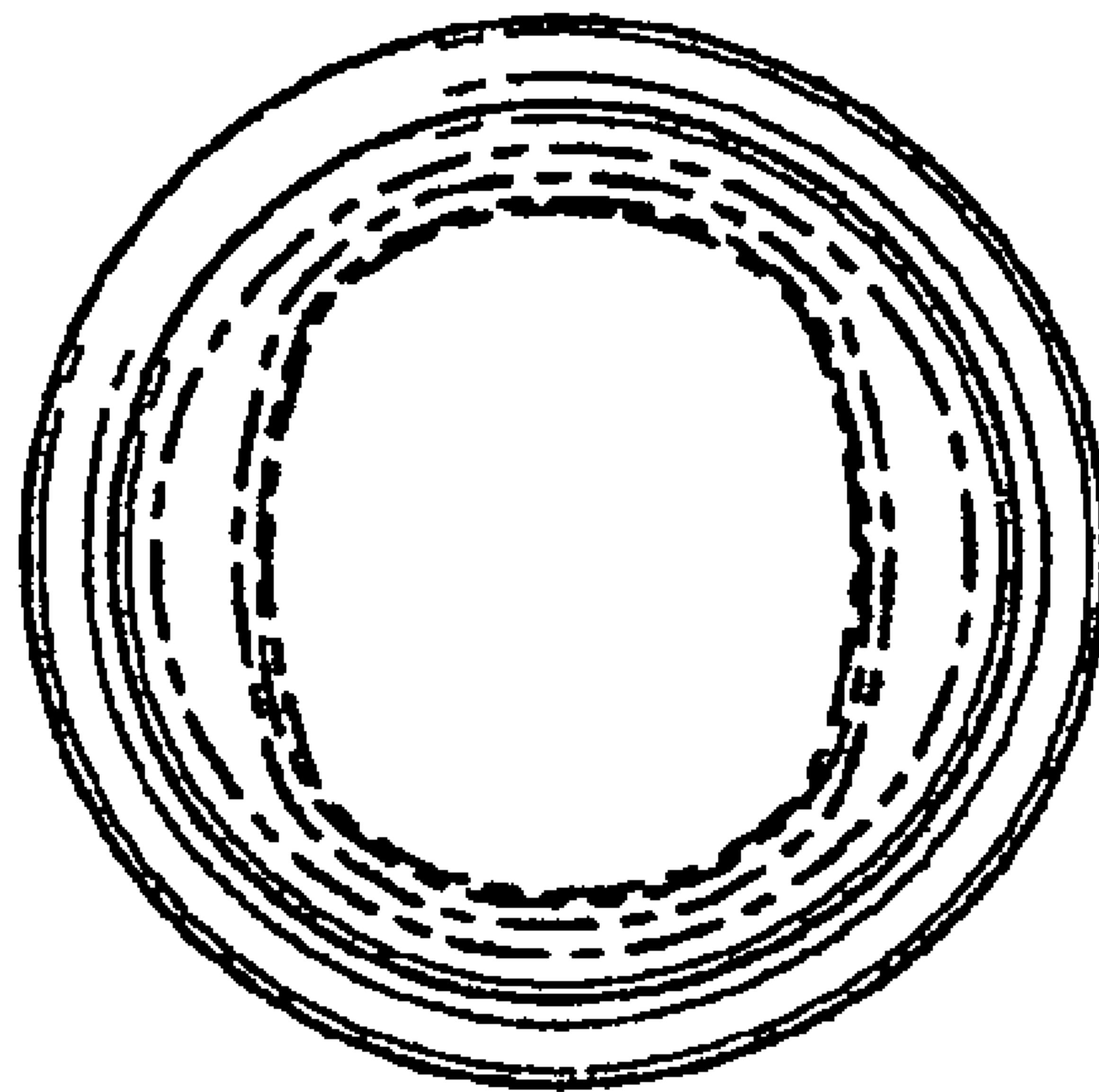
