(57) **CLAIM**

The ornamental design for a safe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a safe according to an embodiment of the present design.

FIG. 2 is a front elevation view of the safe of FIG. 1 with the bottom portion of a safe body, the bottom portion of a protrusion in which a door is located, the bottom portion of the door, door hinges, a combination entry keypad, a handle assembly, and an external shelf support shown in broken lines.

FIG. 3 is a rear elevation view of the safe of FIG. 1 with the bottom portion of the safe body and the external shelf support shown in broken lines.

FIG. 4 is a right side elevation view of the safe of FIG. 1 with the bottom portion of the safe body, the bottom portion of the protrusion, the door hinges, the handle assembly, and the external shelf support shown in broken lines.

FIG. 5 is a left side elevation view of the safe of FIG. 1 with the bottom portion of the safe body, the bottom portion of the protrusion, the door hinges, the combination entry keypad, and the handle assembly shown in broken lines.

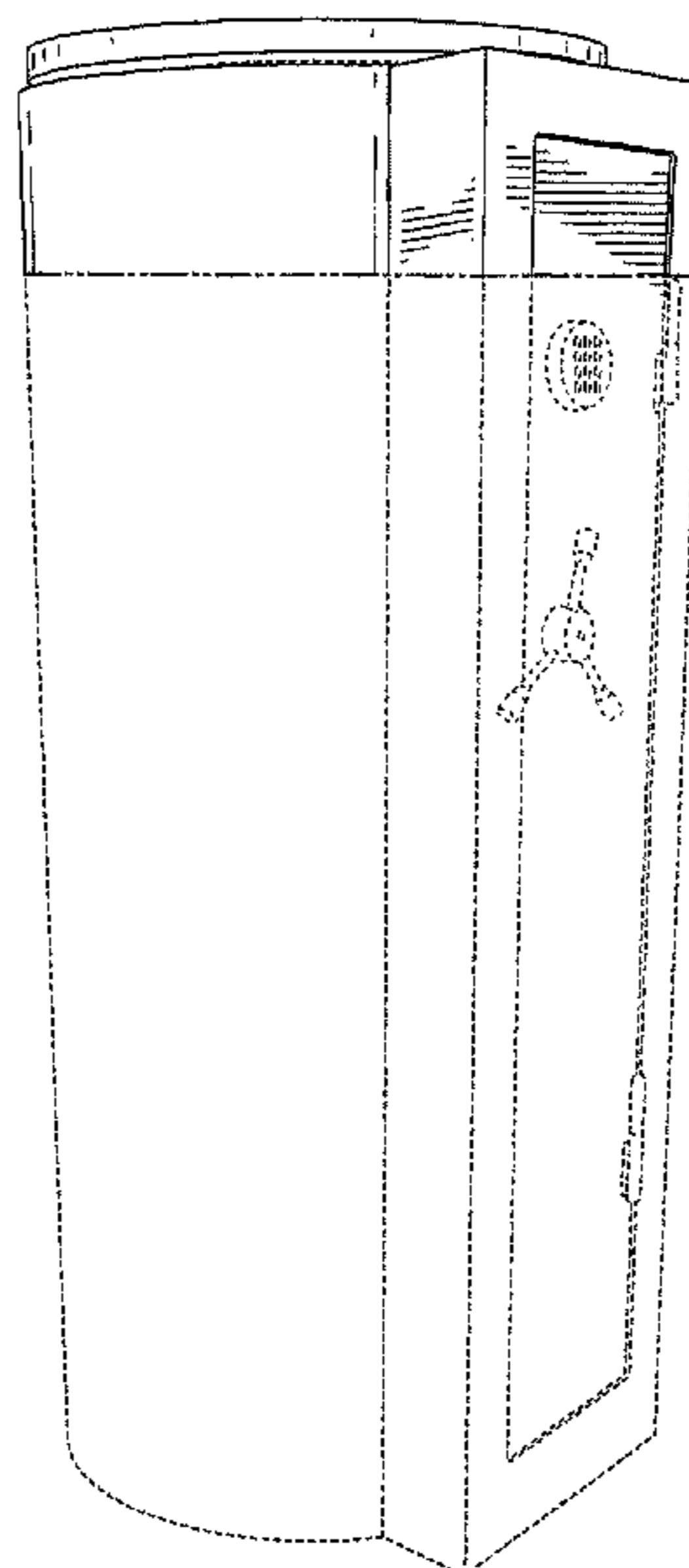
FIG. 6 is a top plan view of the safe of FIG. 1 with the handle assembly, the door hinges, the combination entry keypad, and the external shelf support shown in broken lines; and,

FIG. 7 is a bottom plan view of the safe of FIG. 1 with the bottom portion of the safe body, the bottom portion of the protrusion, the handle assembly, the door hinges, and the combination entry keypad shown in broken lines.

The broken lines shown in FIGS. 1 through 7 illustrate portions of the safe which form no part of the claimed design.

The broken lines which define the bounds of the claimed design form no part thereof.

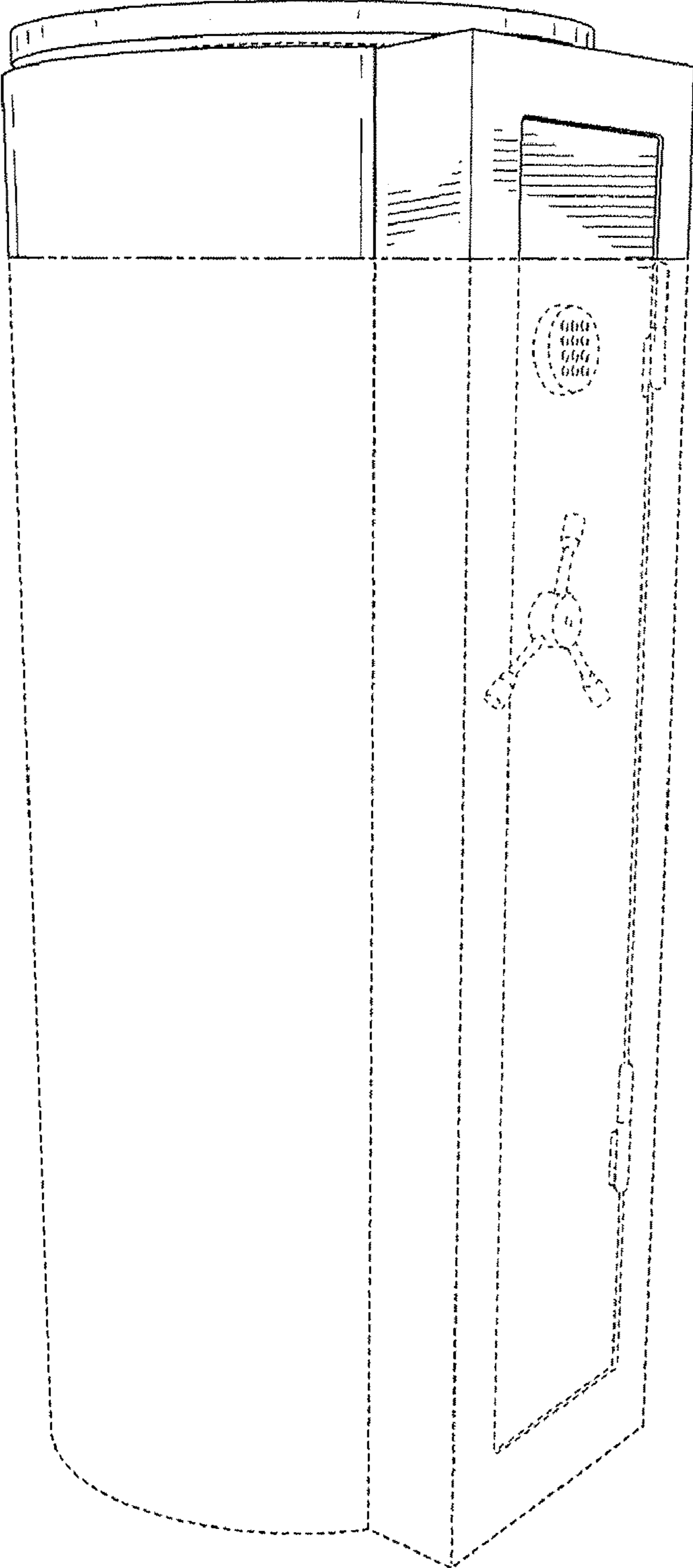

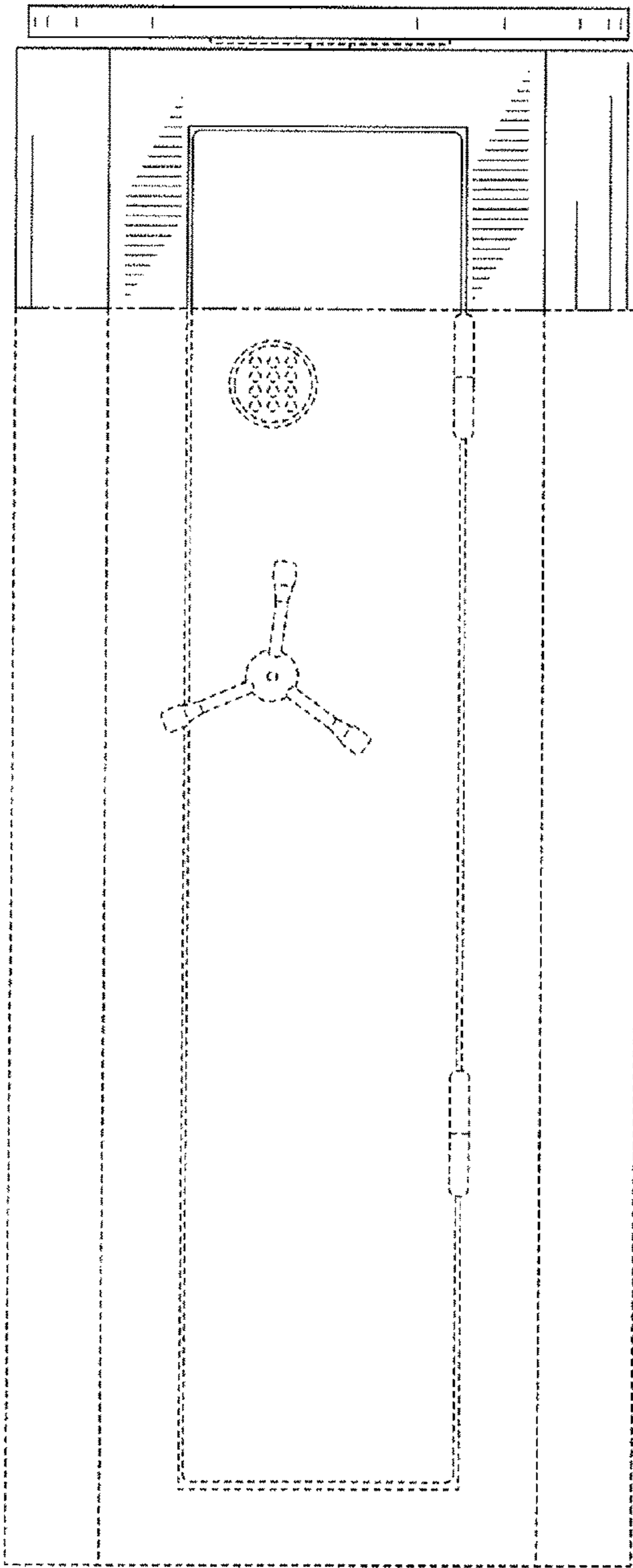

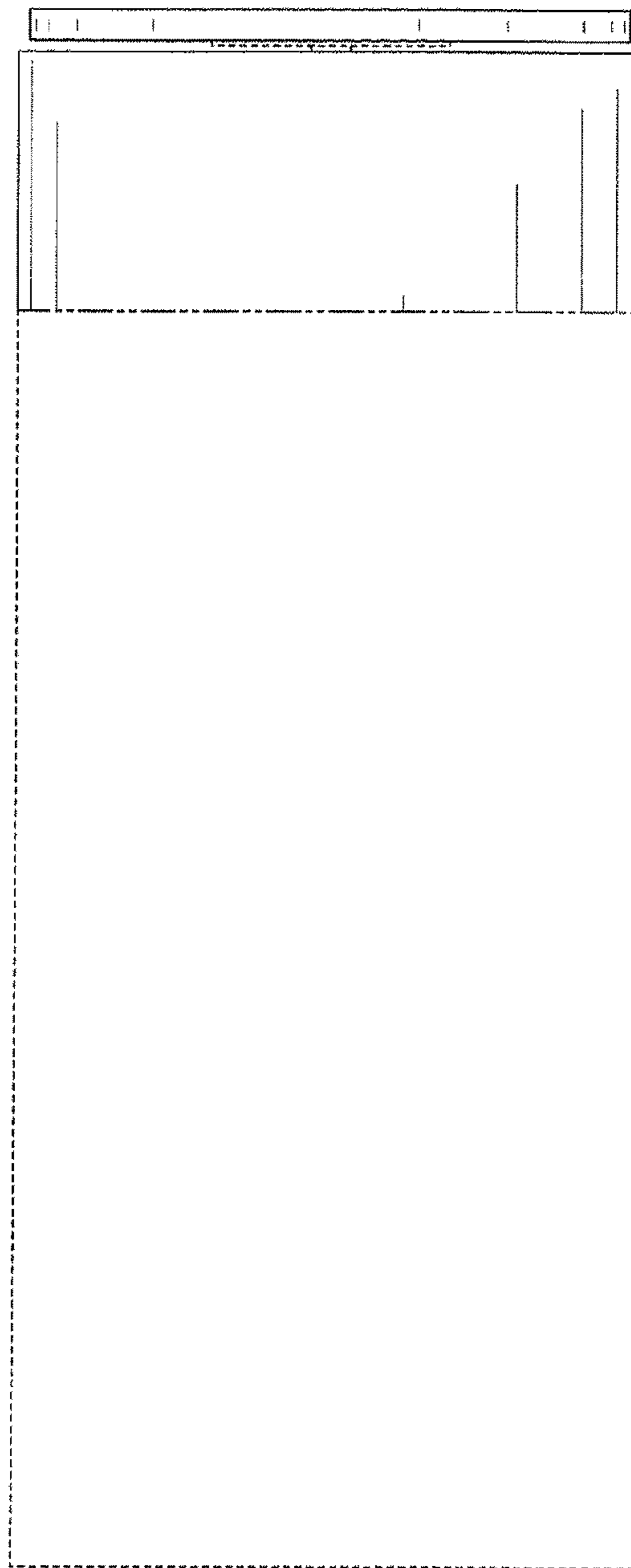

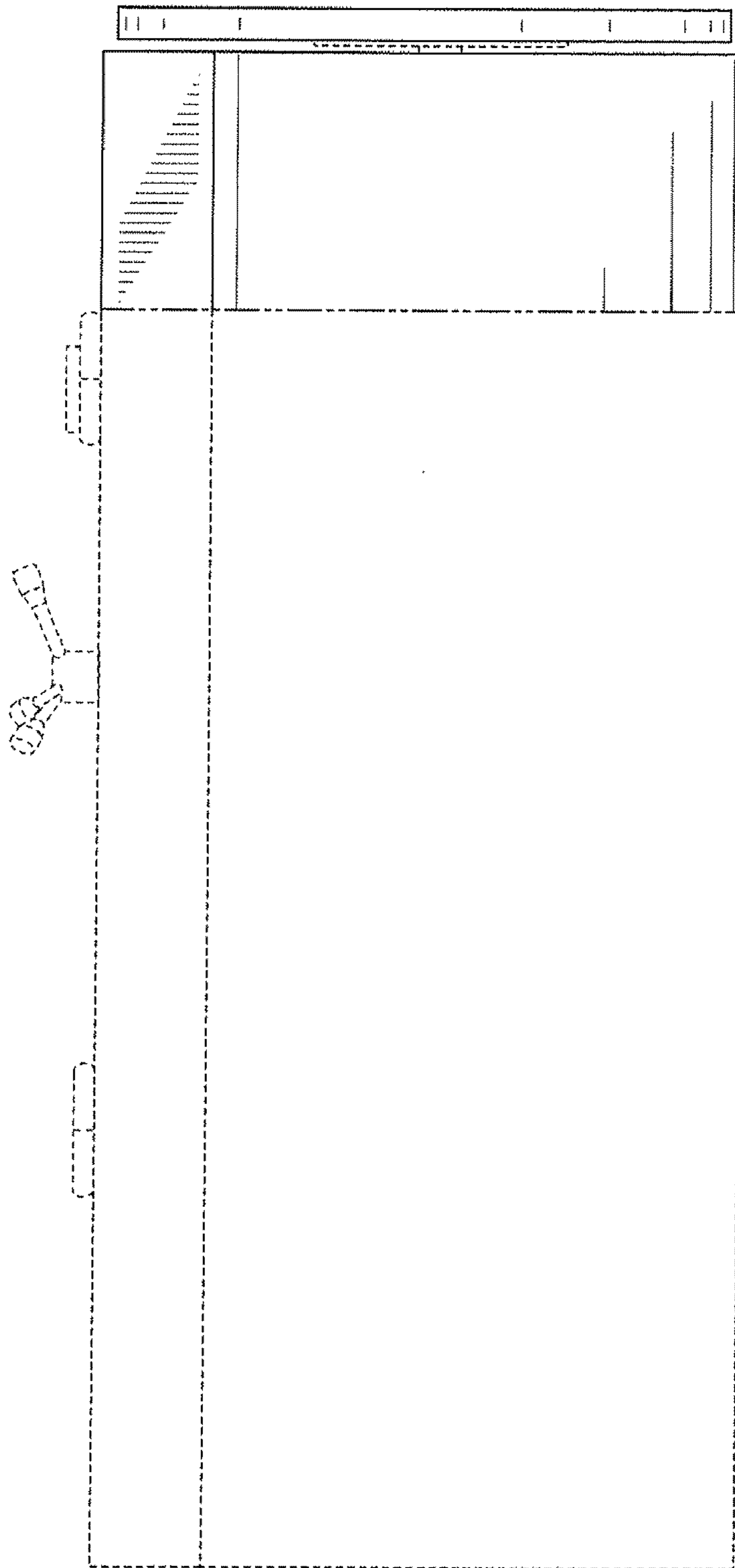

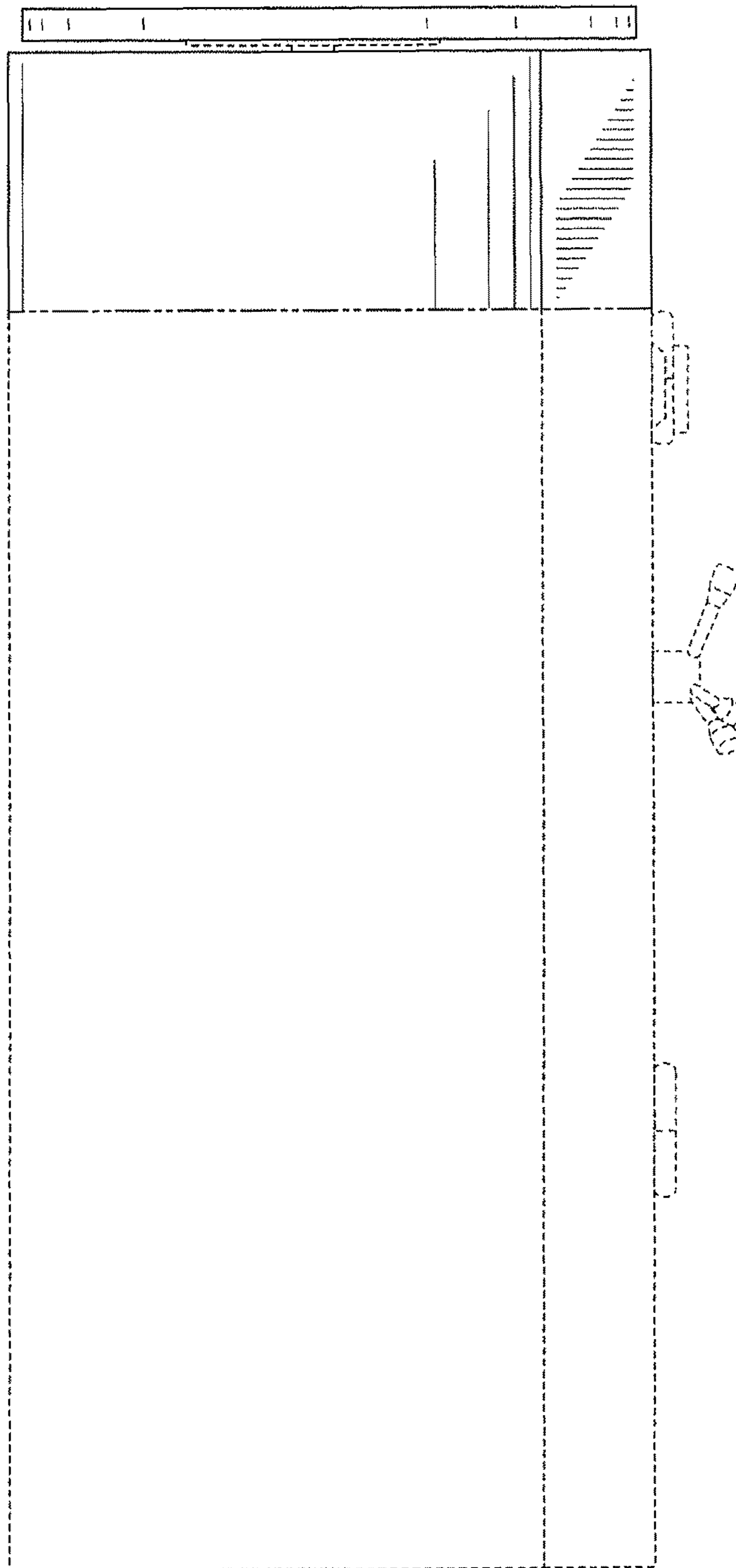

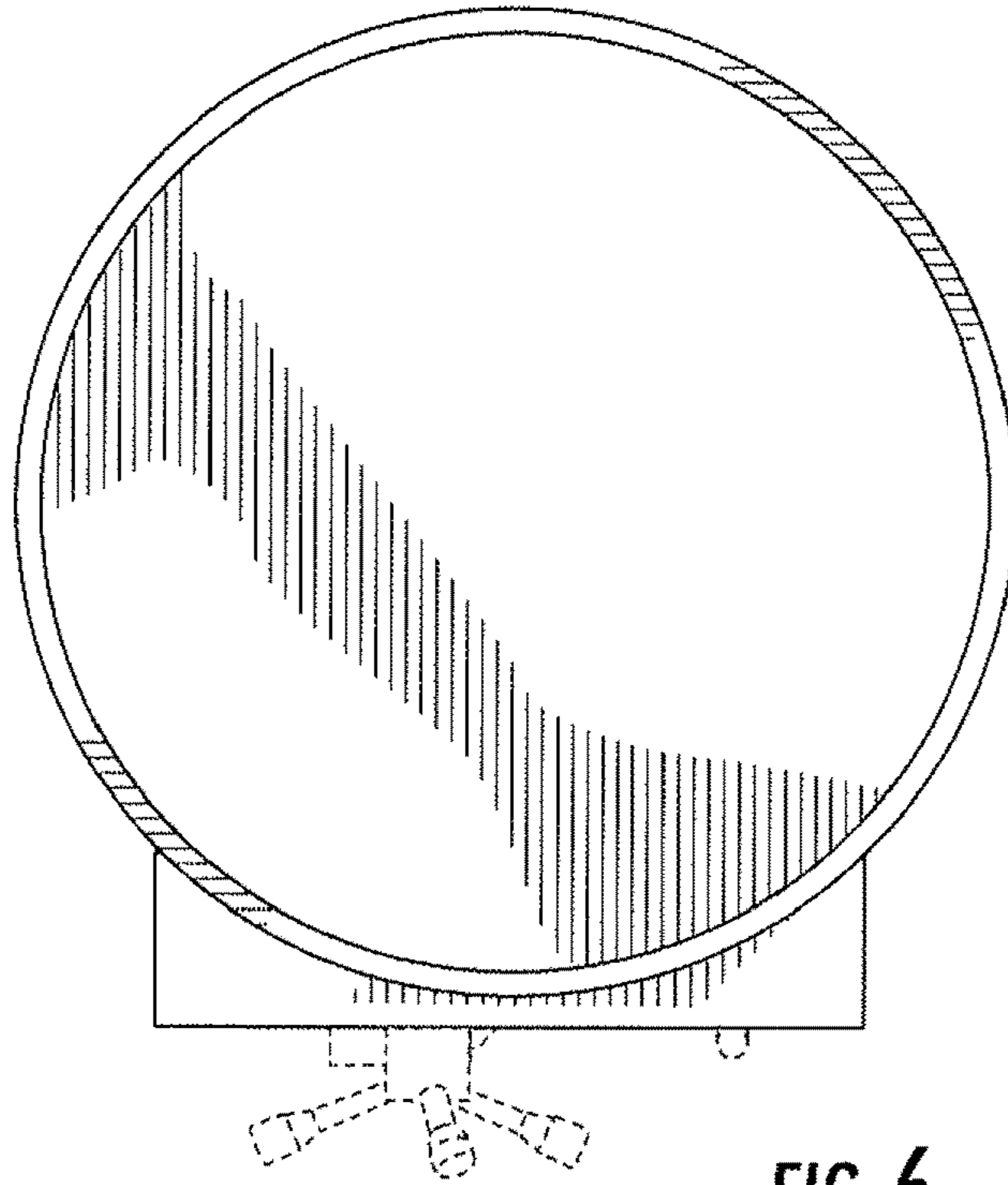

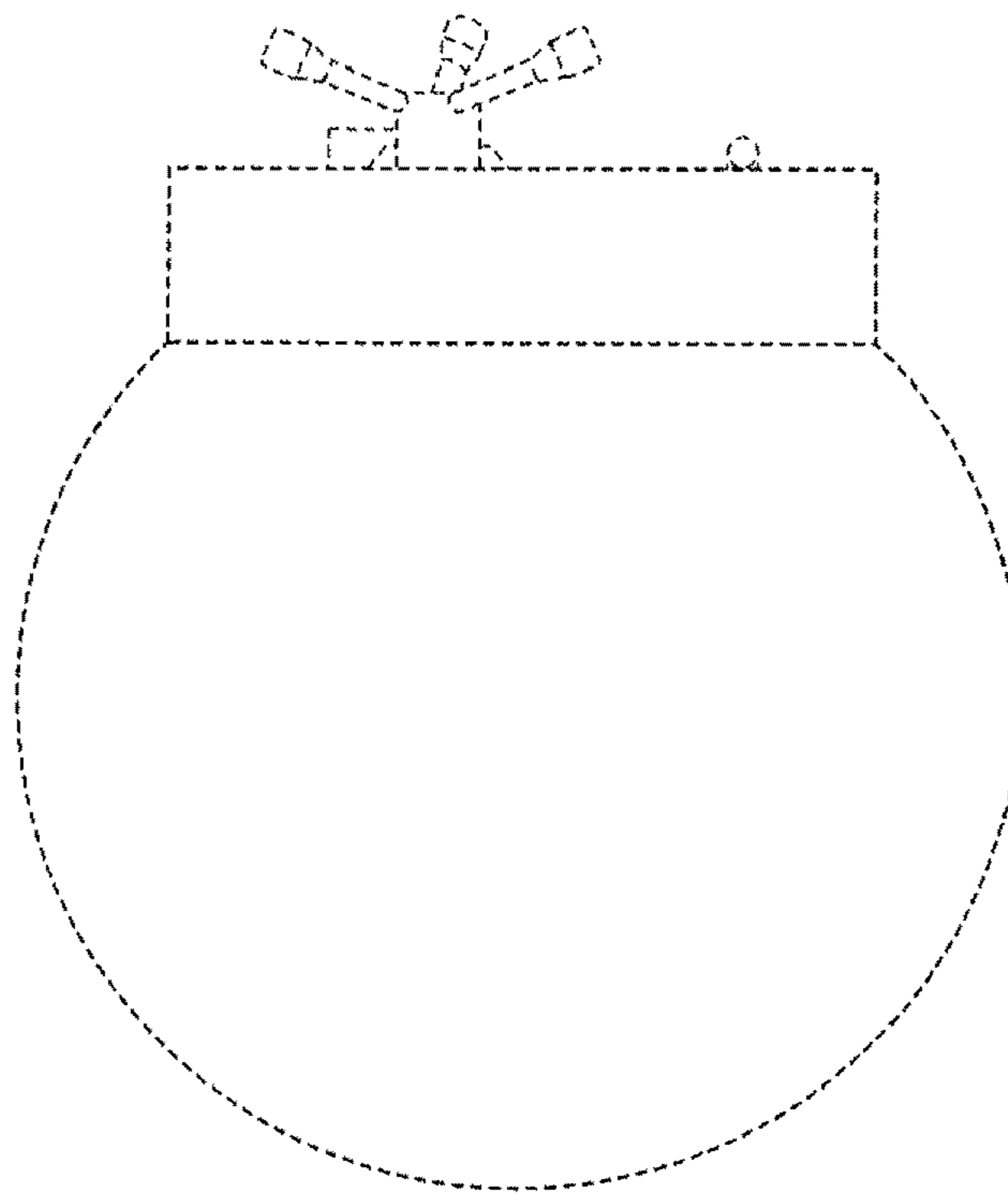
