FIG. 2 is a rear view of the claimed design.

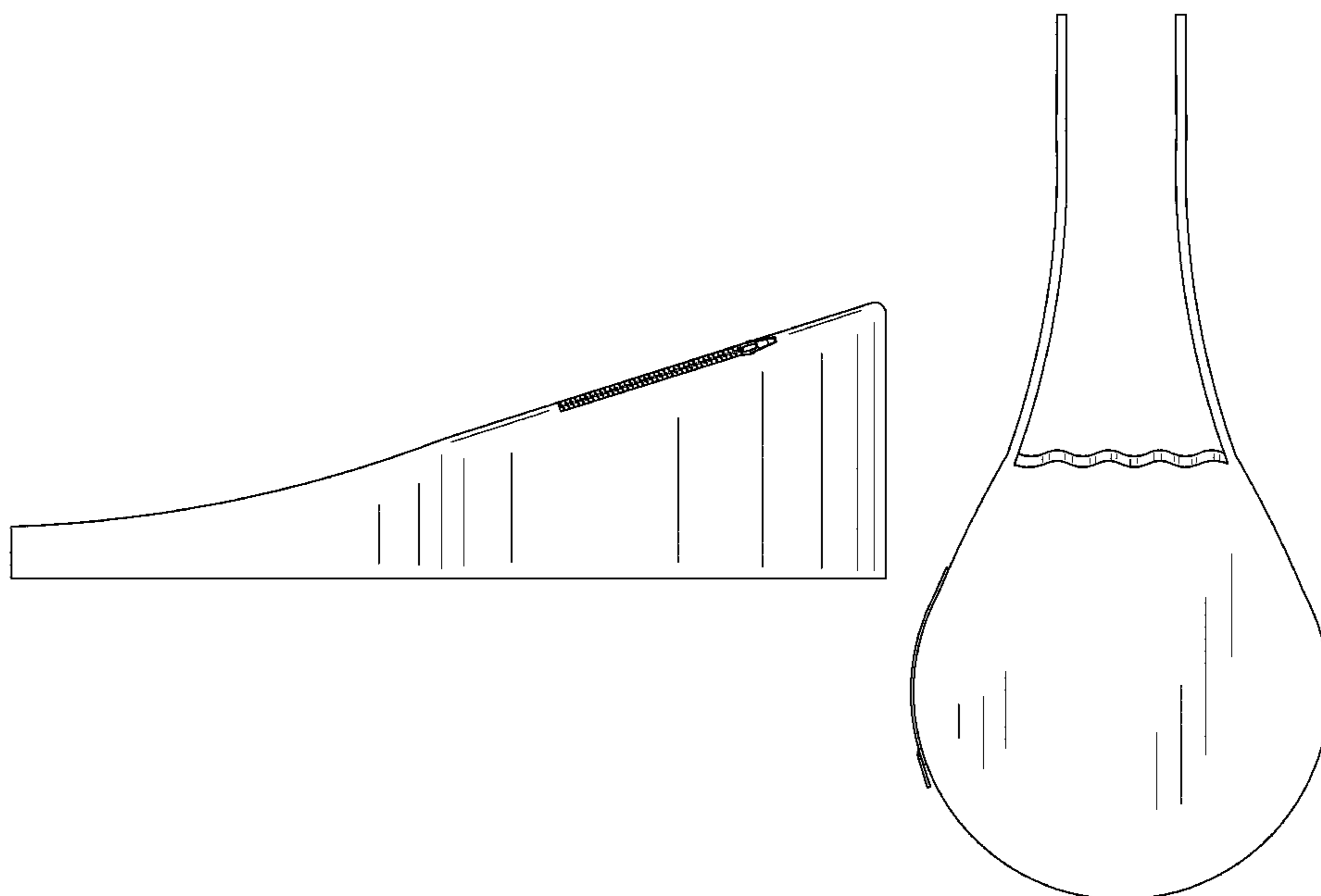
FIG. 3 is a right view of the claimed design.

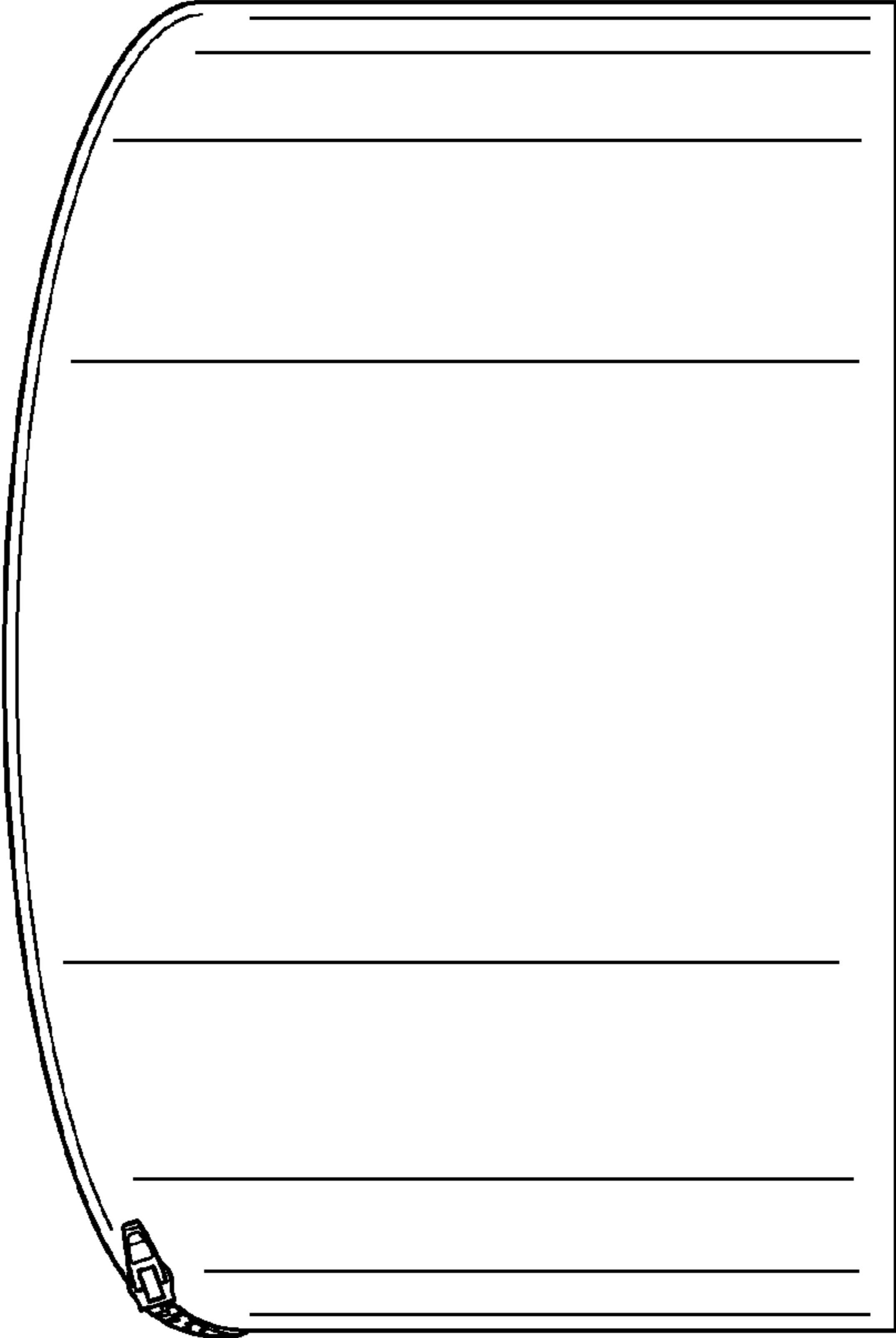

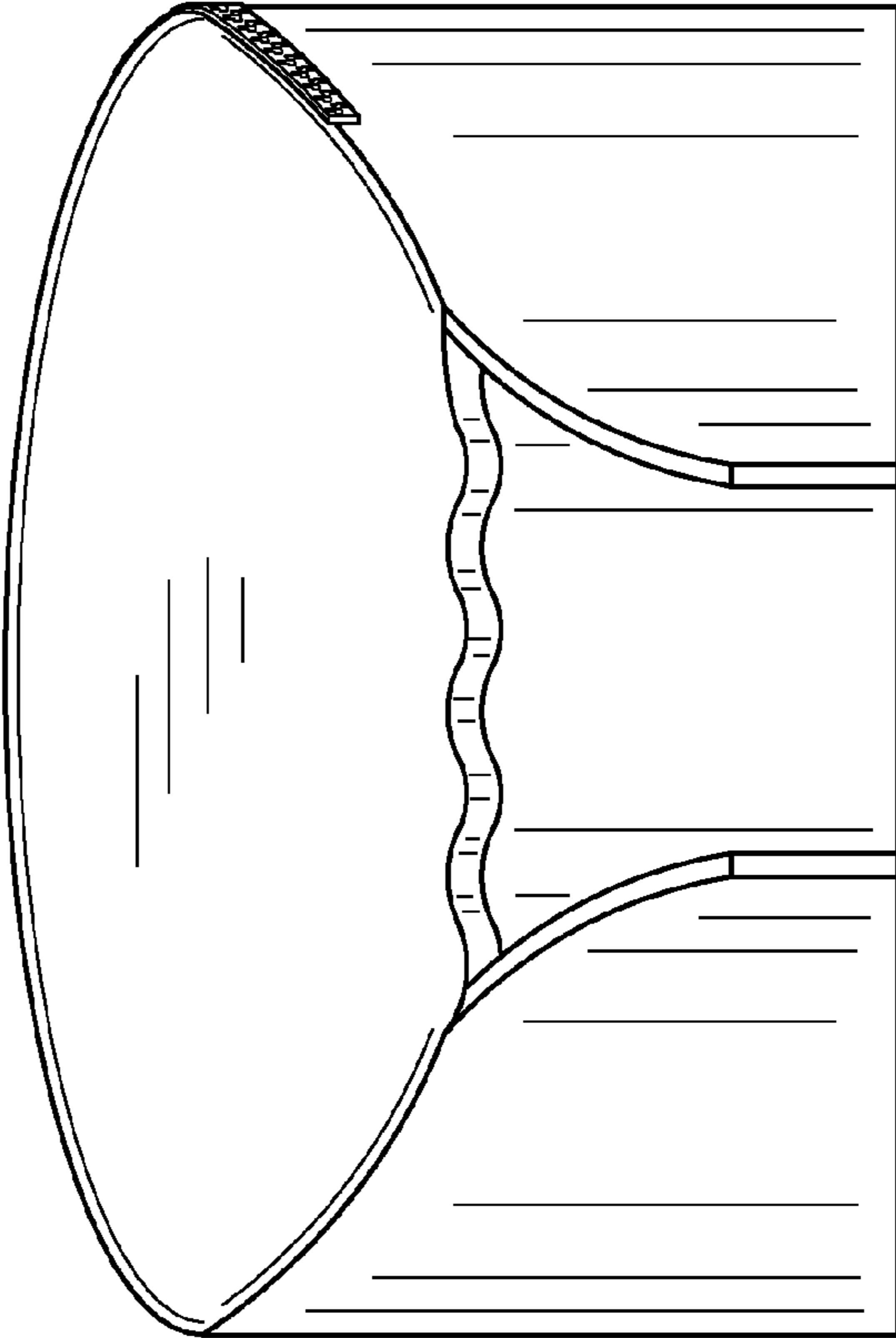

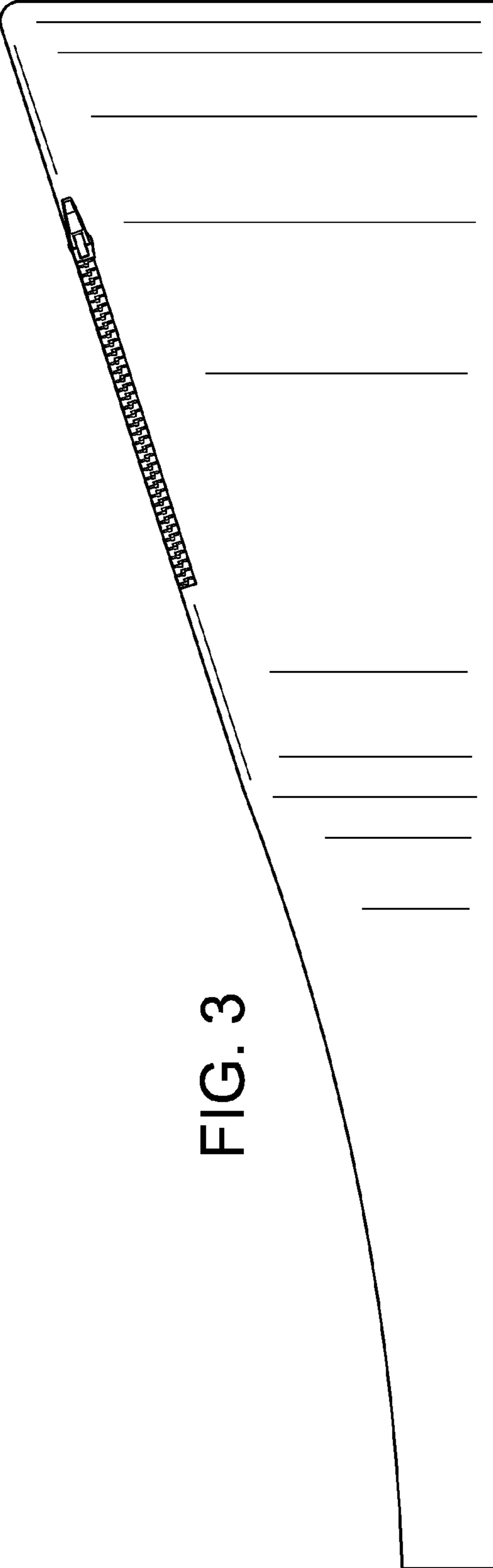

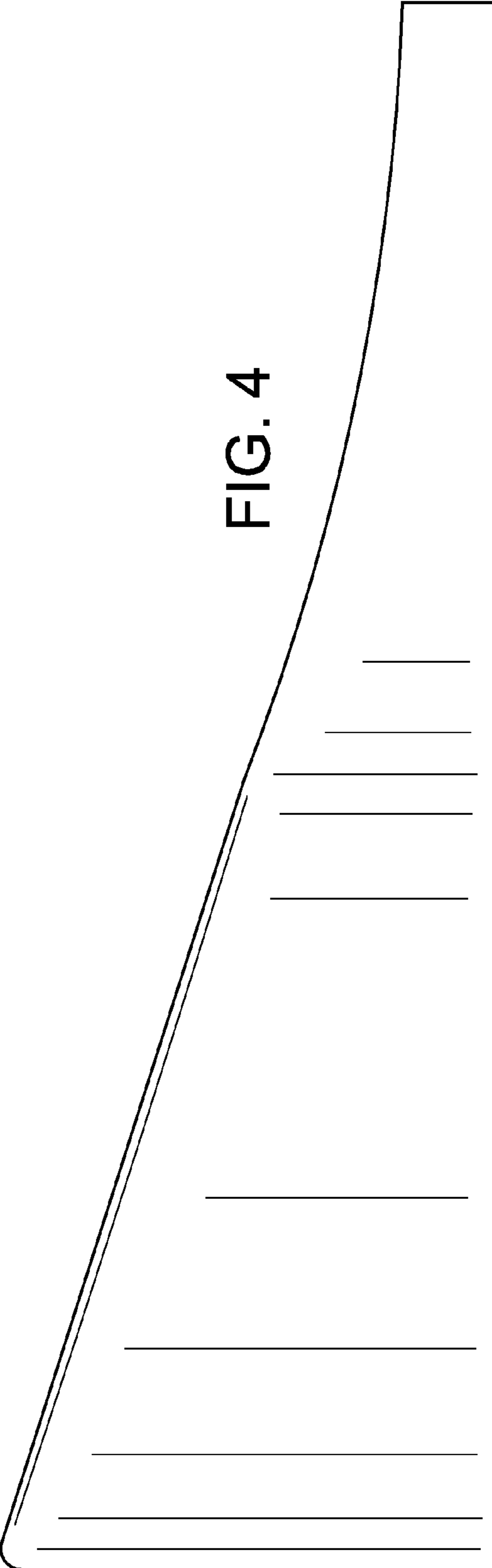

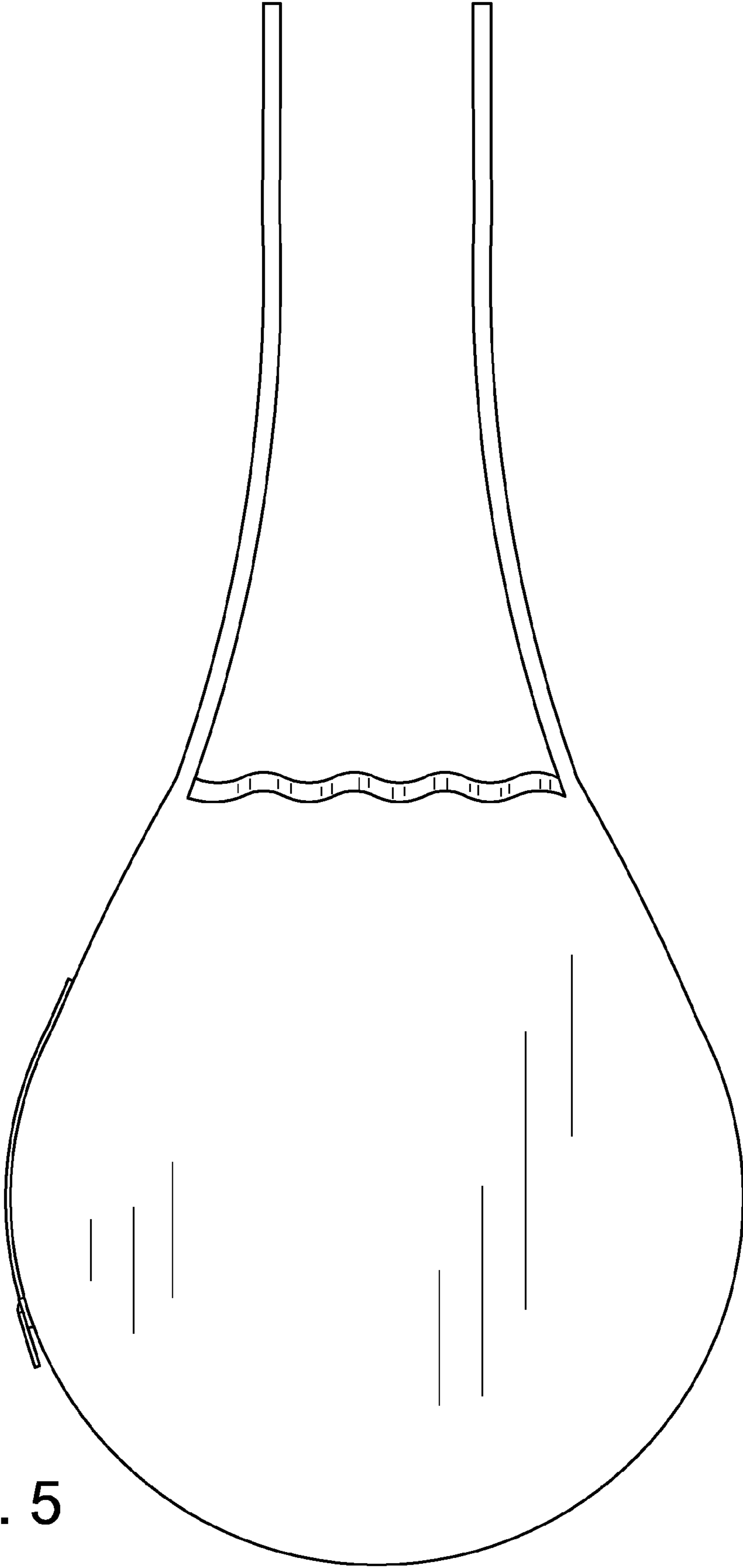

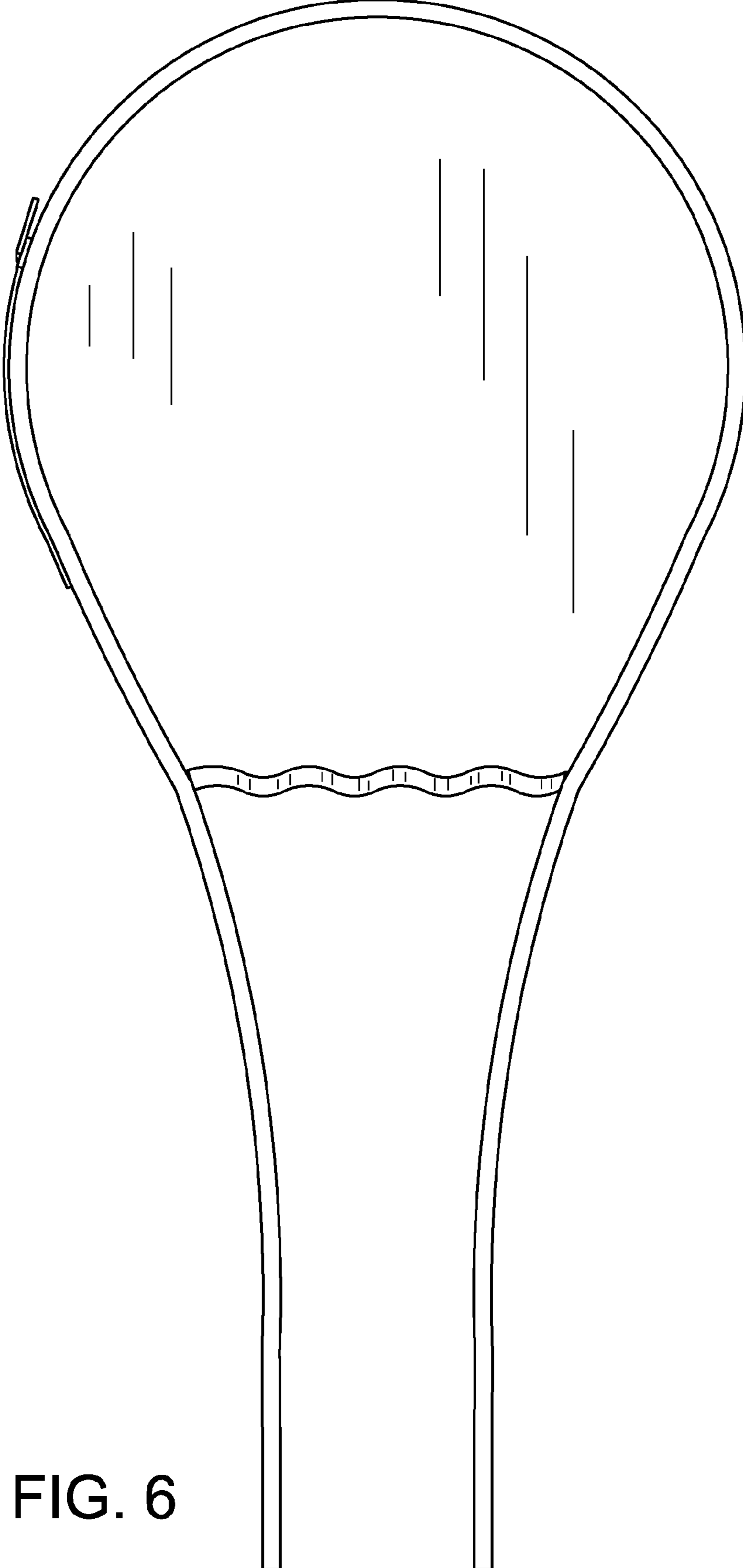
