FIG. 2 is a left side elevated view thereof;

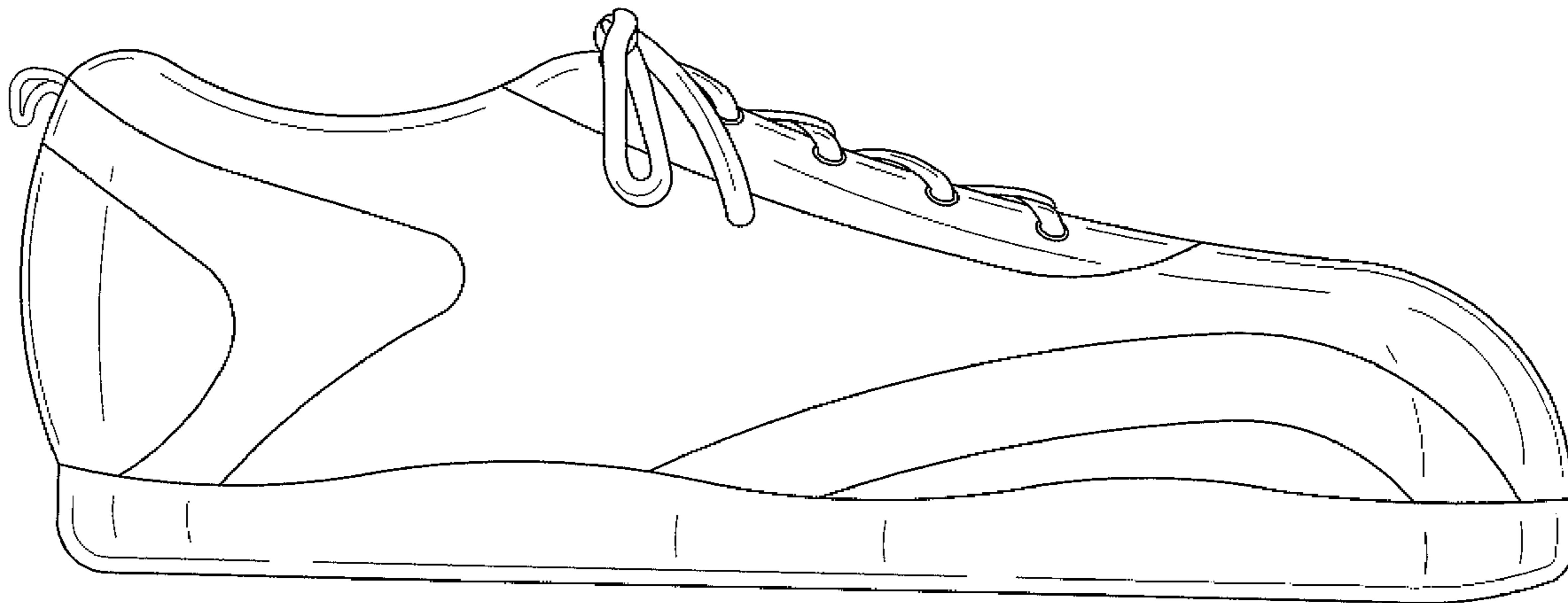
FIG. 3 is a rear elevated view thereof;

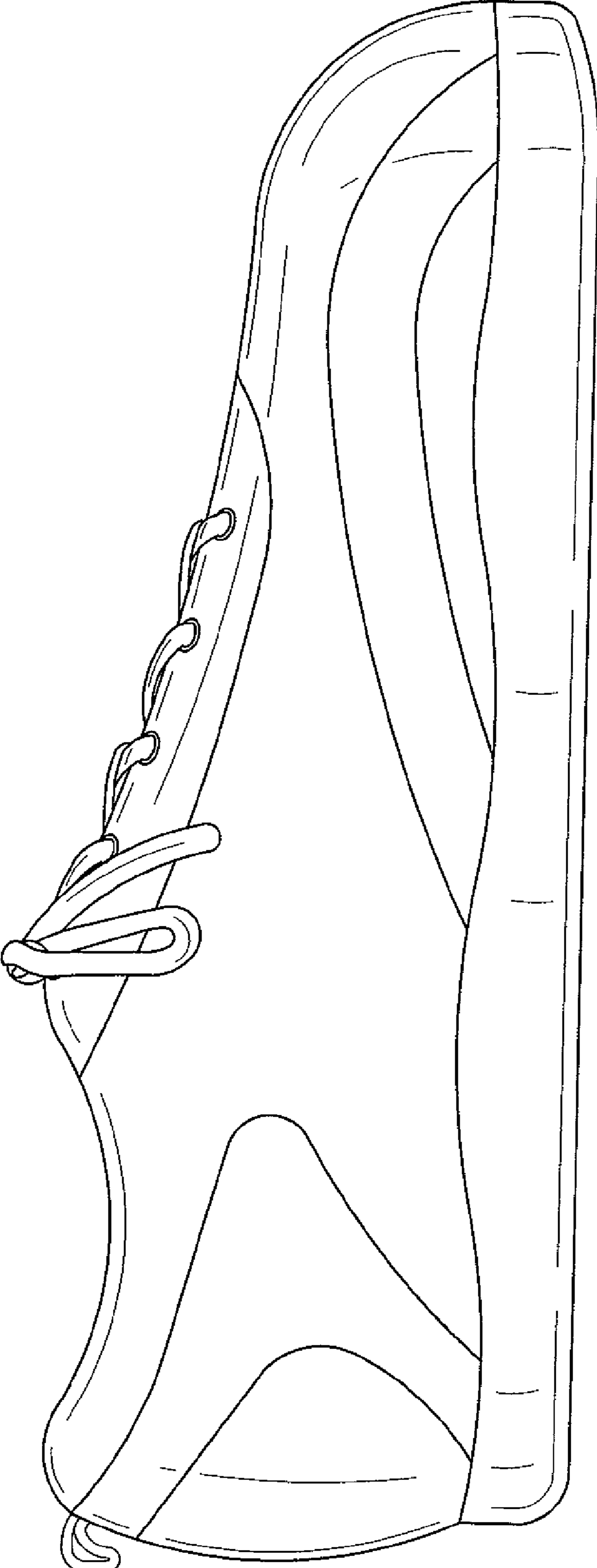

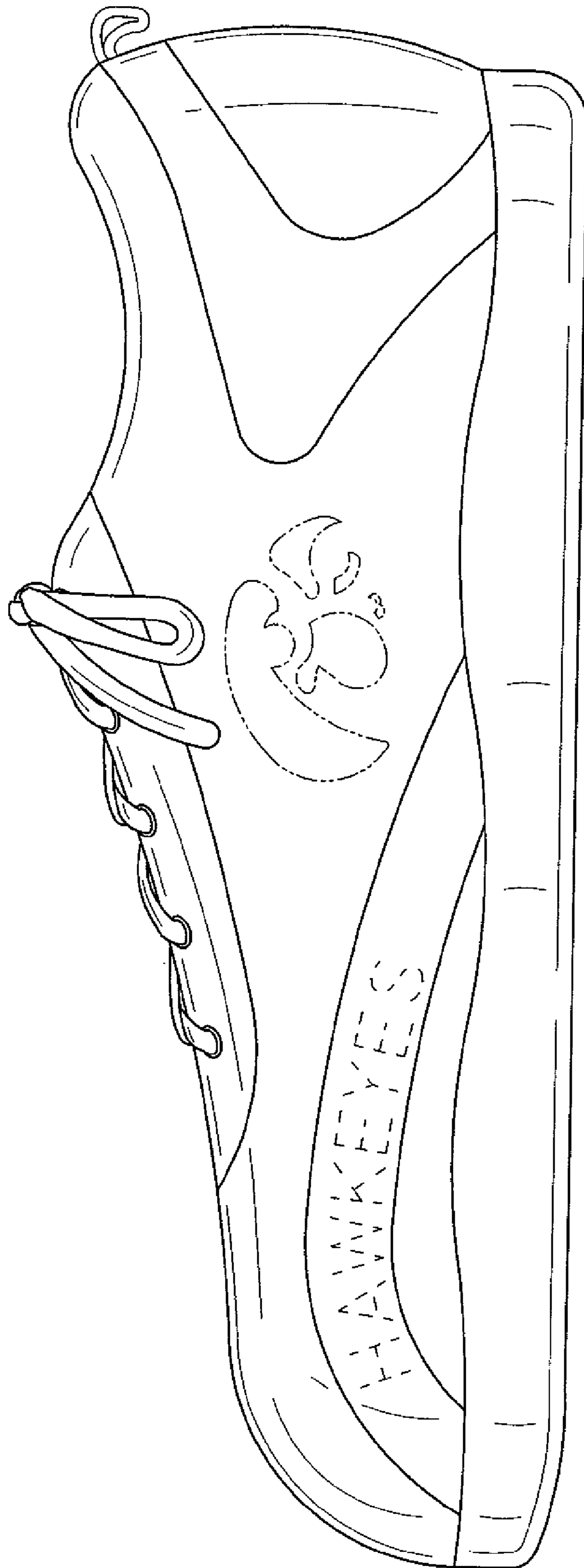

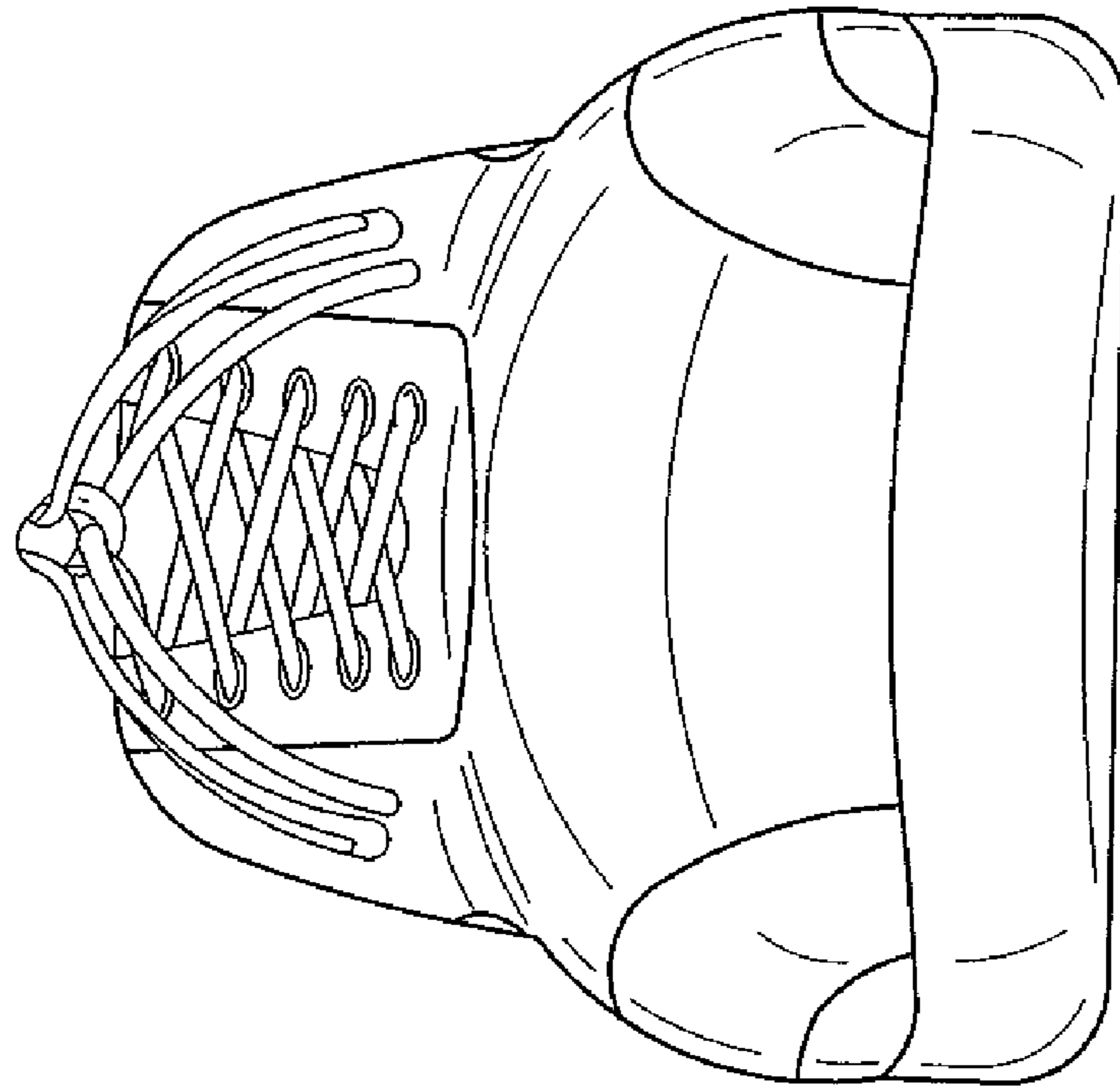

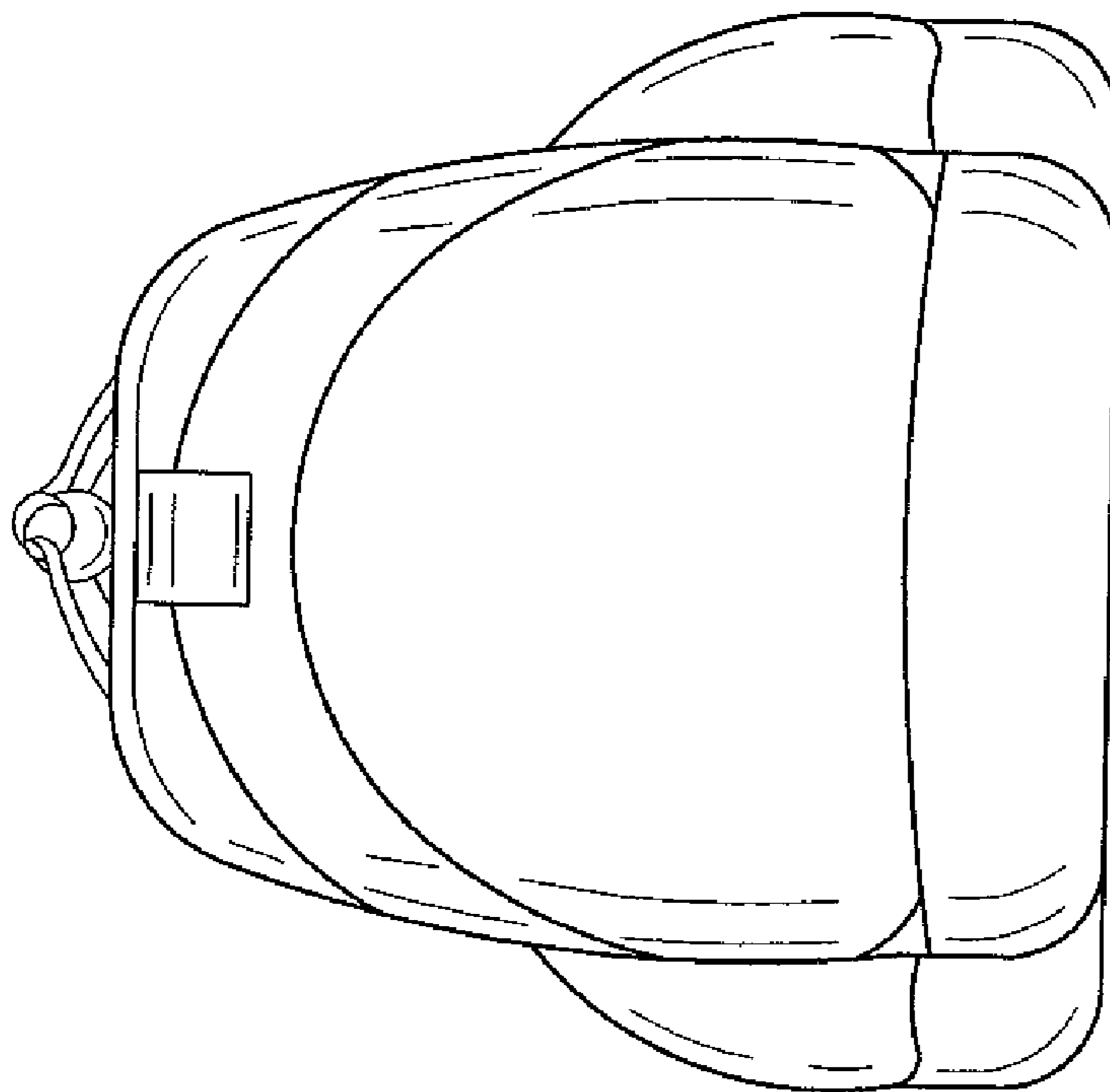

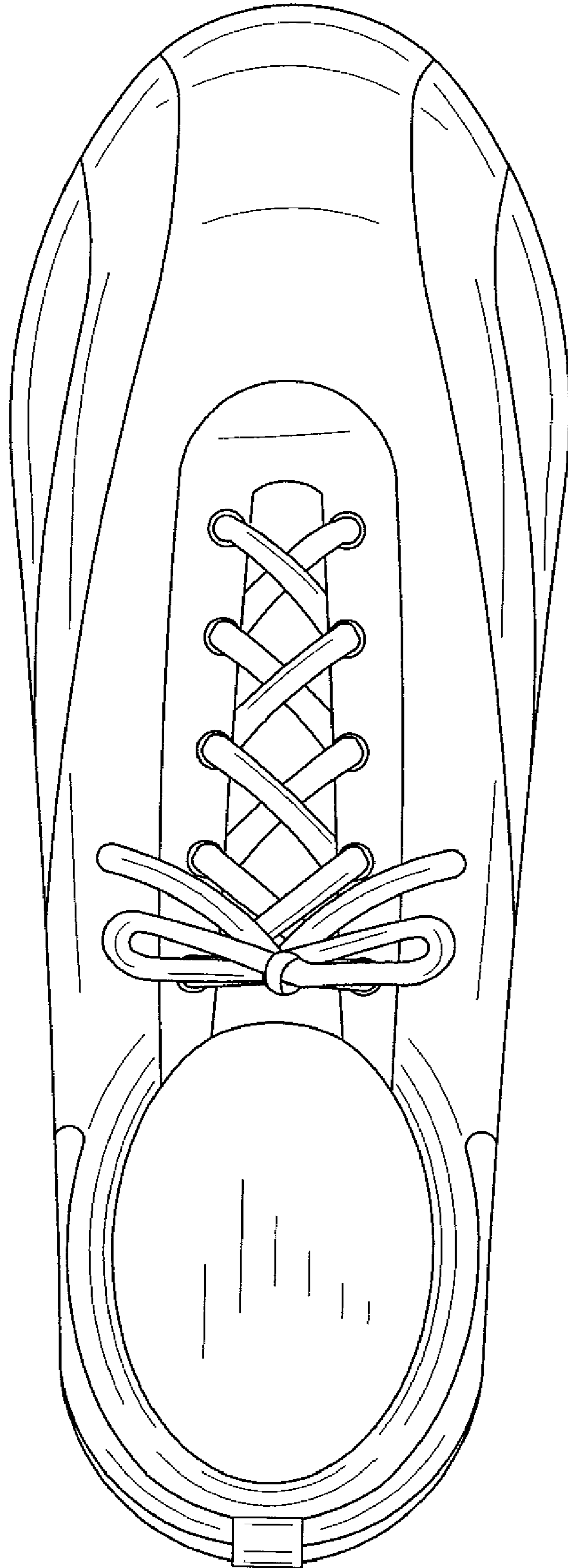
