(57) **CLAIM**

I claim the ornamental design for a footwear upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a footwear upper showing the new design.

FIG. 2 is a right side perspective view of a footwear upper showing the new design.

FIG. 3 is a front perspective view of a footwear upper showing the new design.

FIG. 4 is a rear perspective view of a footwear upper showing the new design; and,

FIG. 5 is a left side perspective view of a footwear upper showing the new design.

The broken lines shown in the drawings are to illustrate environment and form no part of the presently claimed design. The bottom and internal surface of the footwear upper form no part of the presently claimed design.

The shading lines shown in the drawings represent the approximate three-dimensional contour of the design, and are not intended to indicate surface decoration.

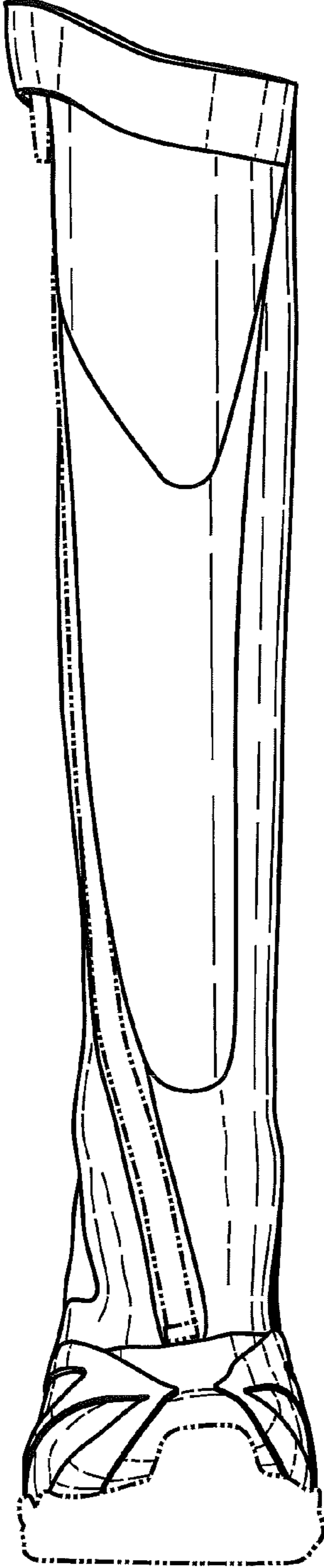

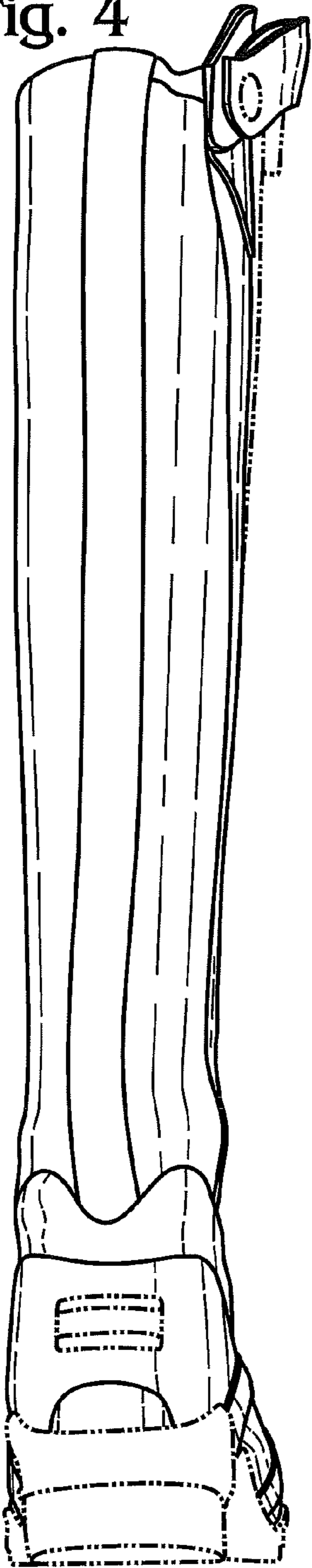
