FIG. 4 is a rear view of the LED key rack of FIG. 1;

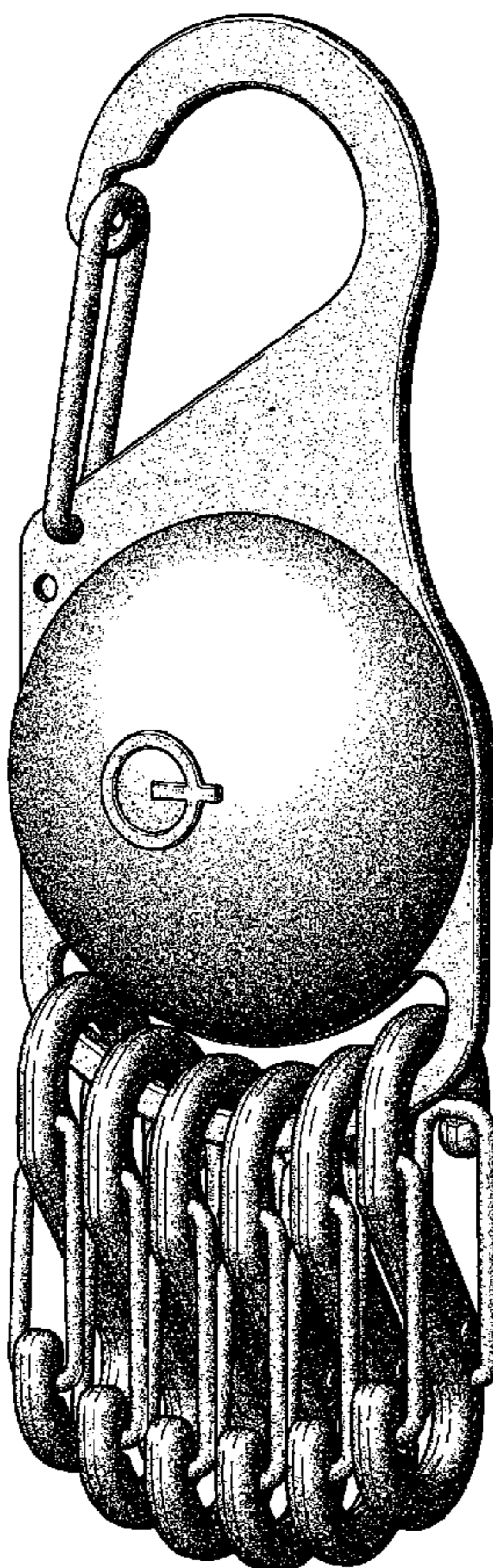
FIG. 5 is a left side view of the LED key rack of FIG. 1;

FIG. 6 is a right side view of the LED key rack of FIG. 1;

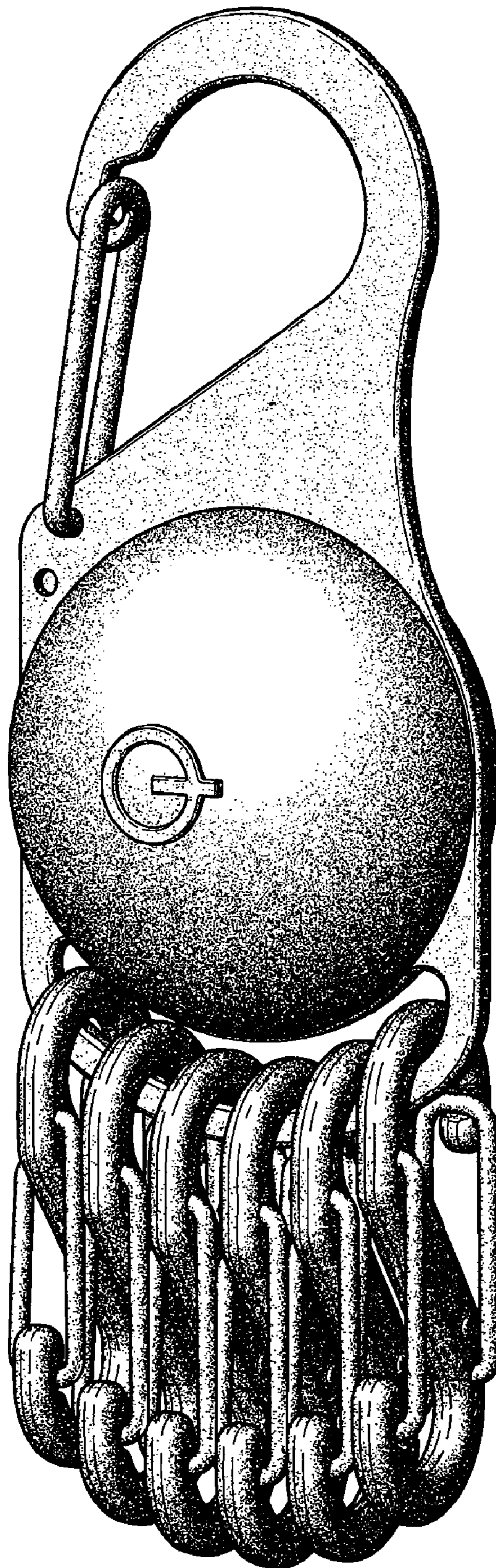
FIG. 7 is a top view of the LED key rack of FIG. 1; and,

FIG. 8 is a bottom view of the LED key rack of FIG. 1.

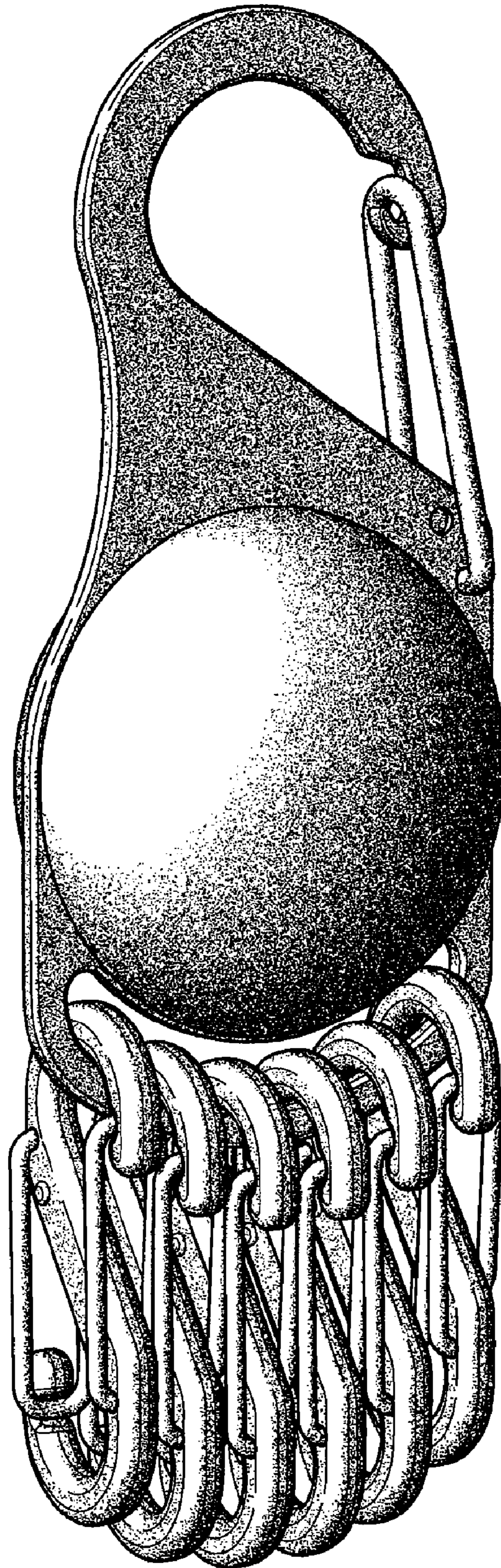

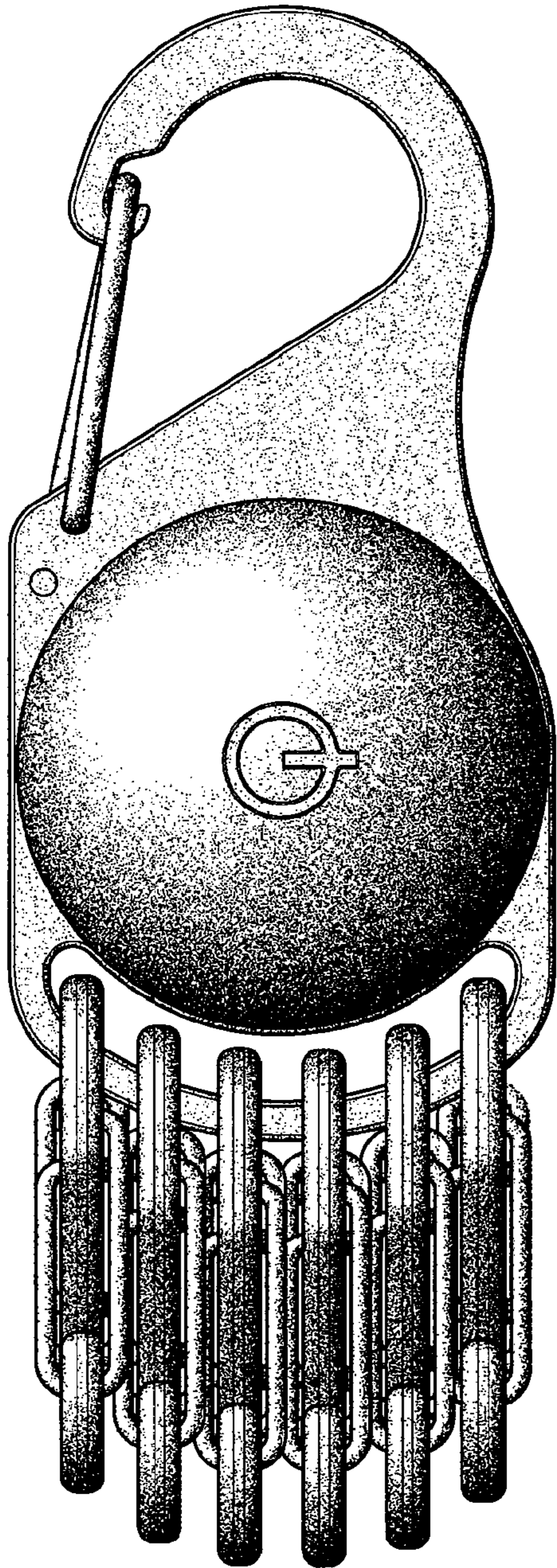

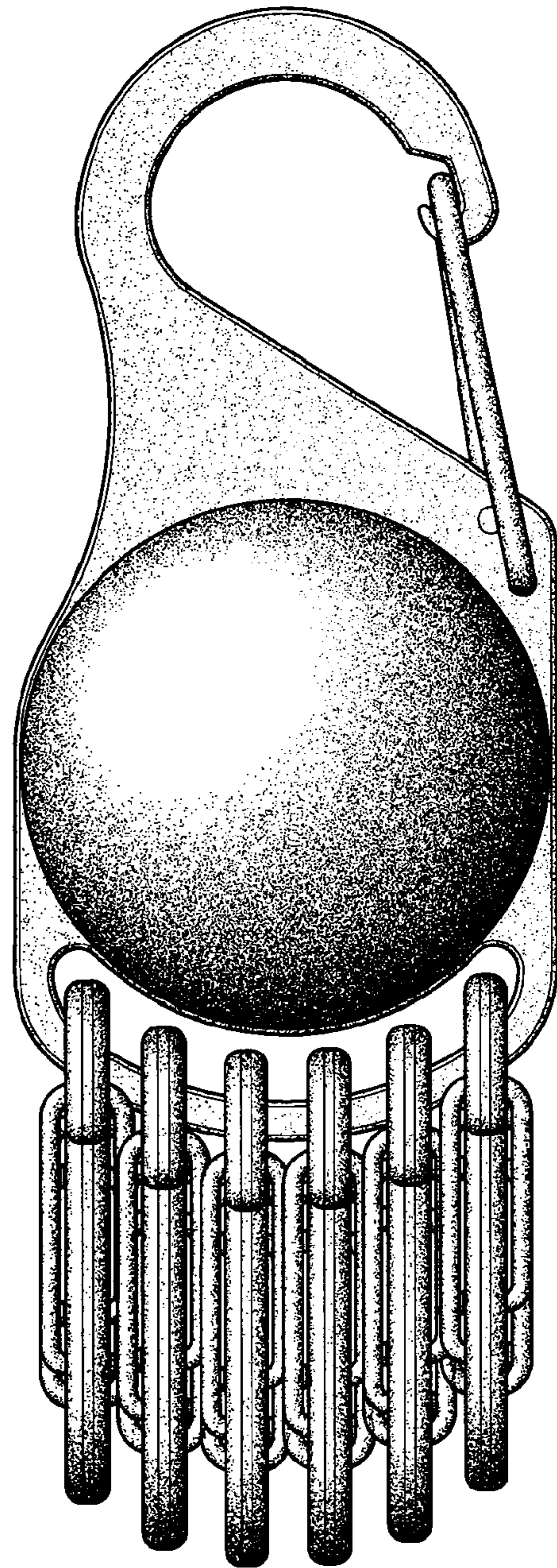

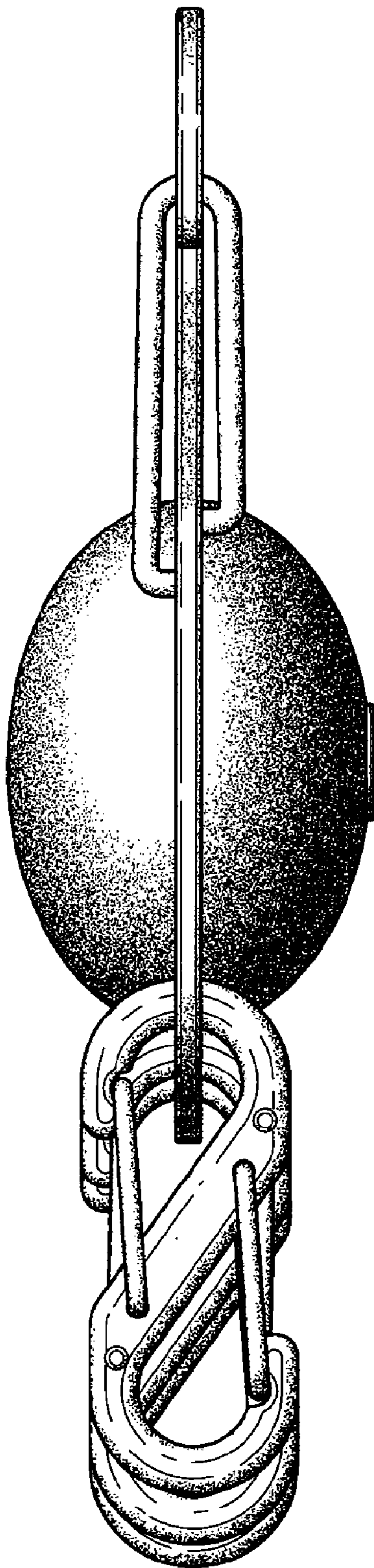

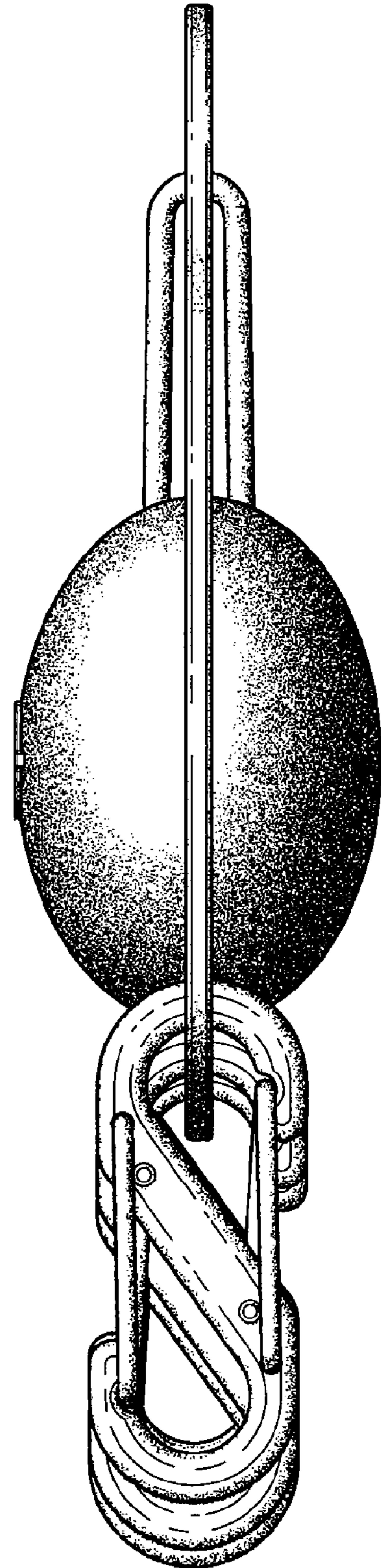

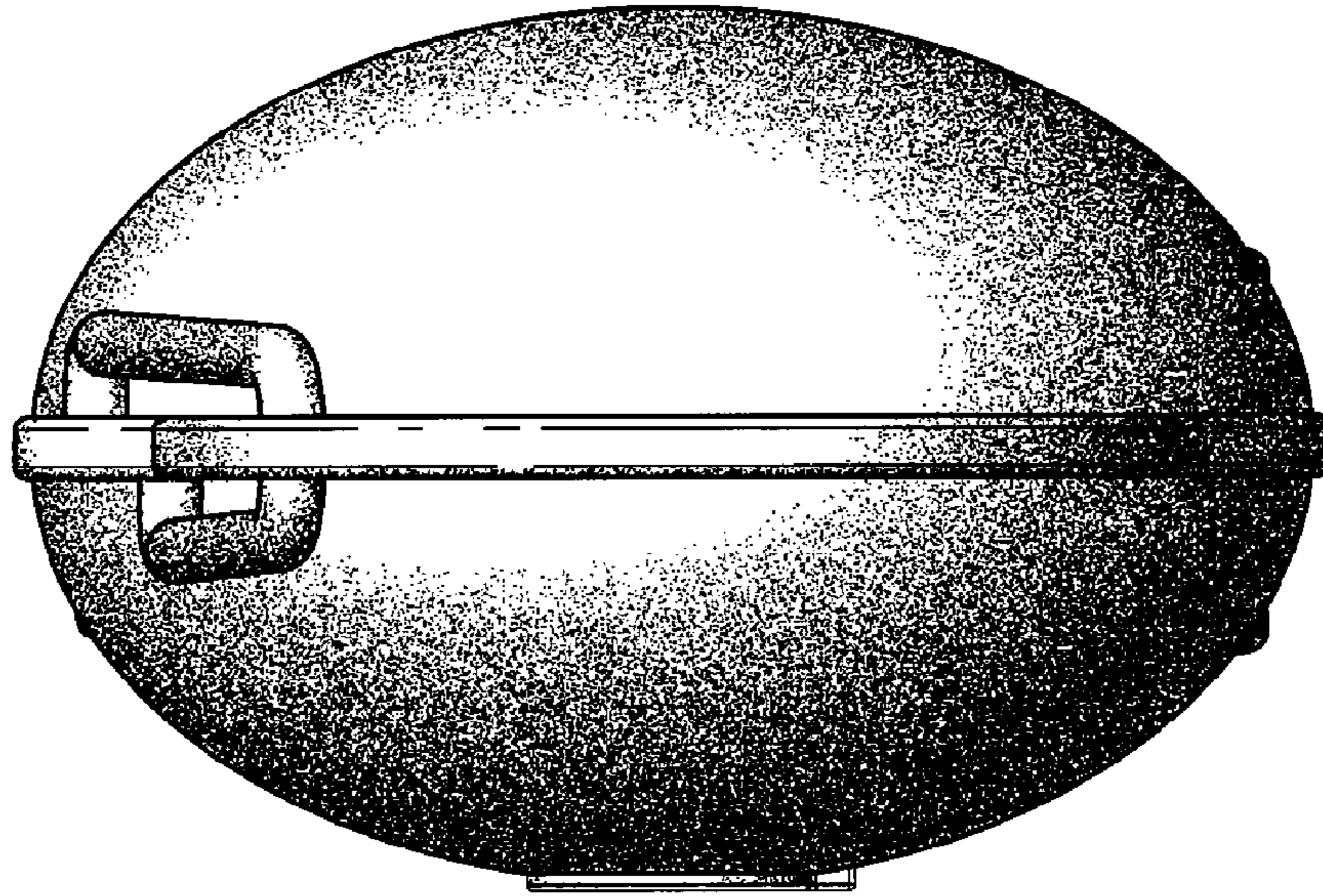
