The ornamental design for a flexible sheet material, as shown and described.

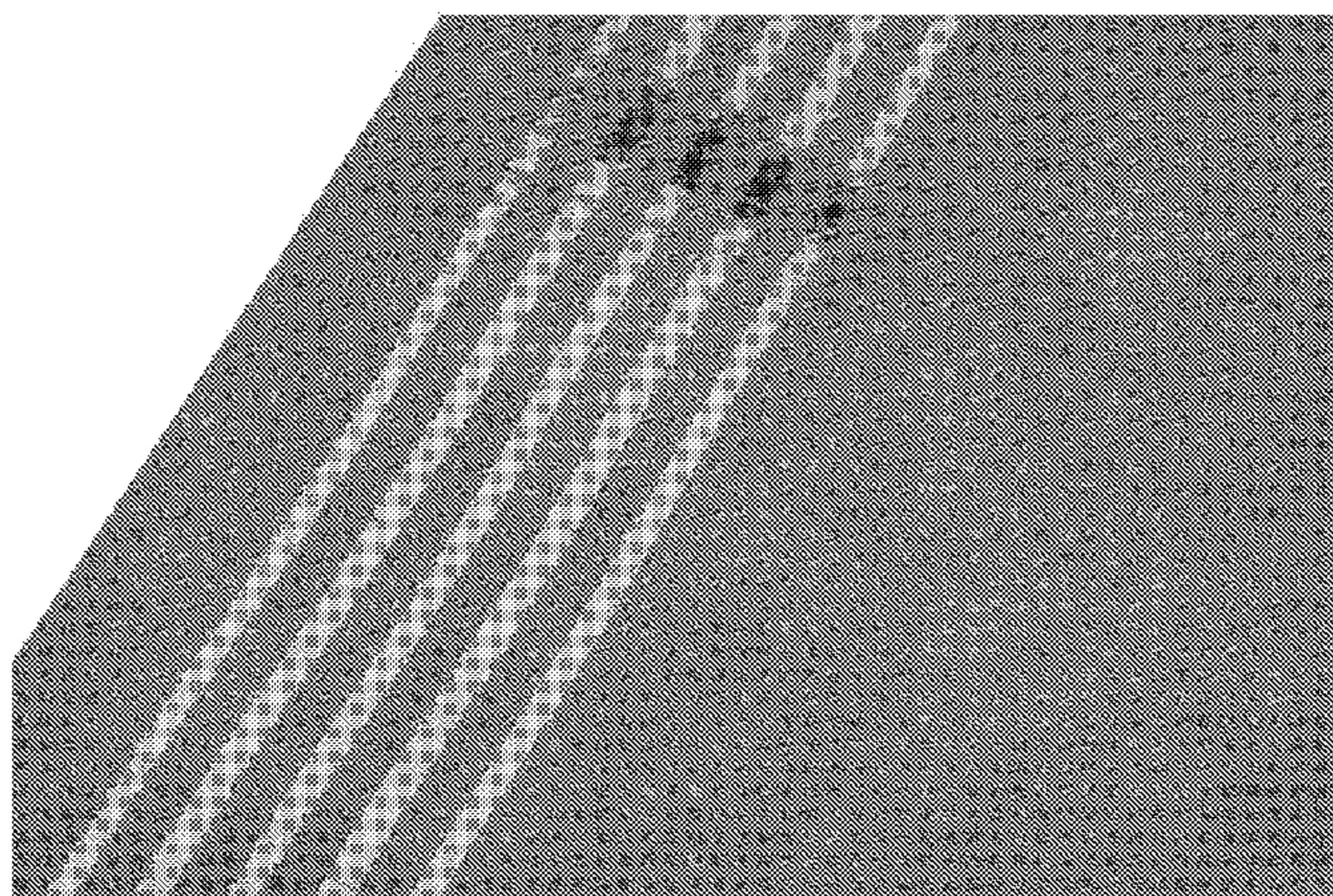
**DESCRIPTION**

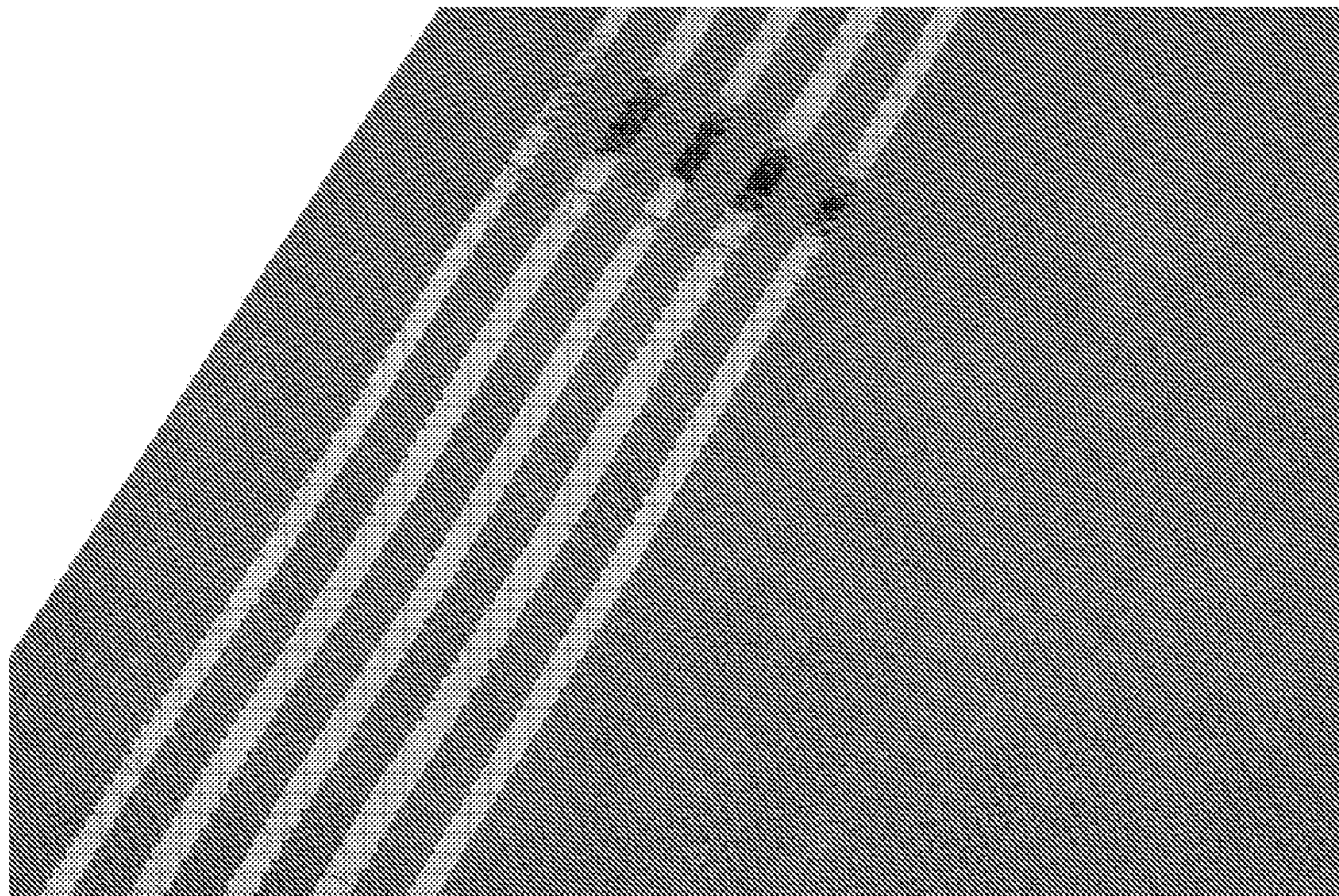

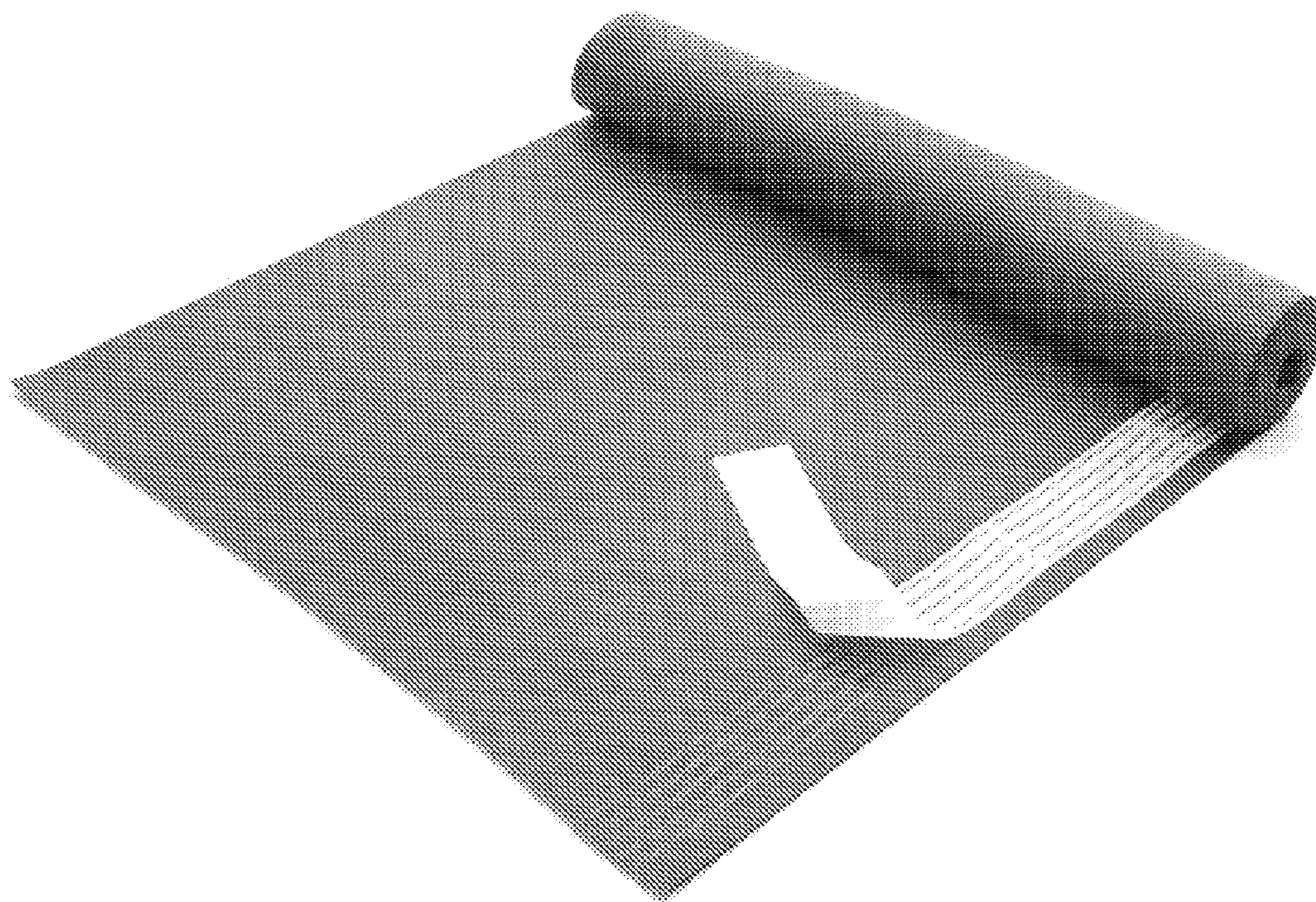
