(57) **CLAIM**

I claim the ornamental design for a bed sheet with words denoting proper positioning, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom perspective view of bed sheet with words denoting proper positioning, showing my new design;

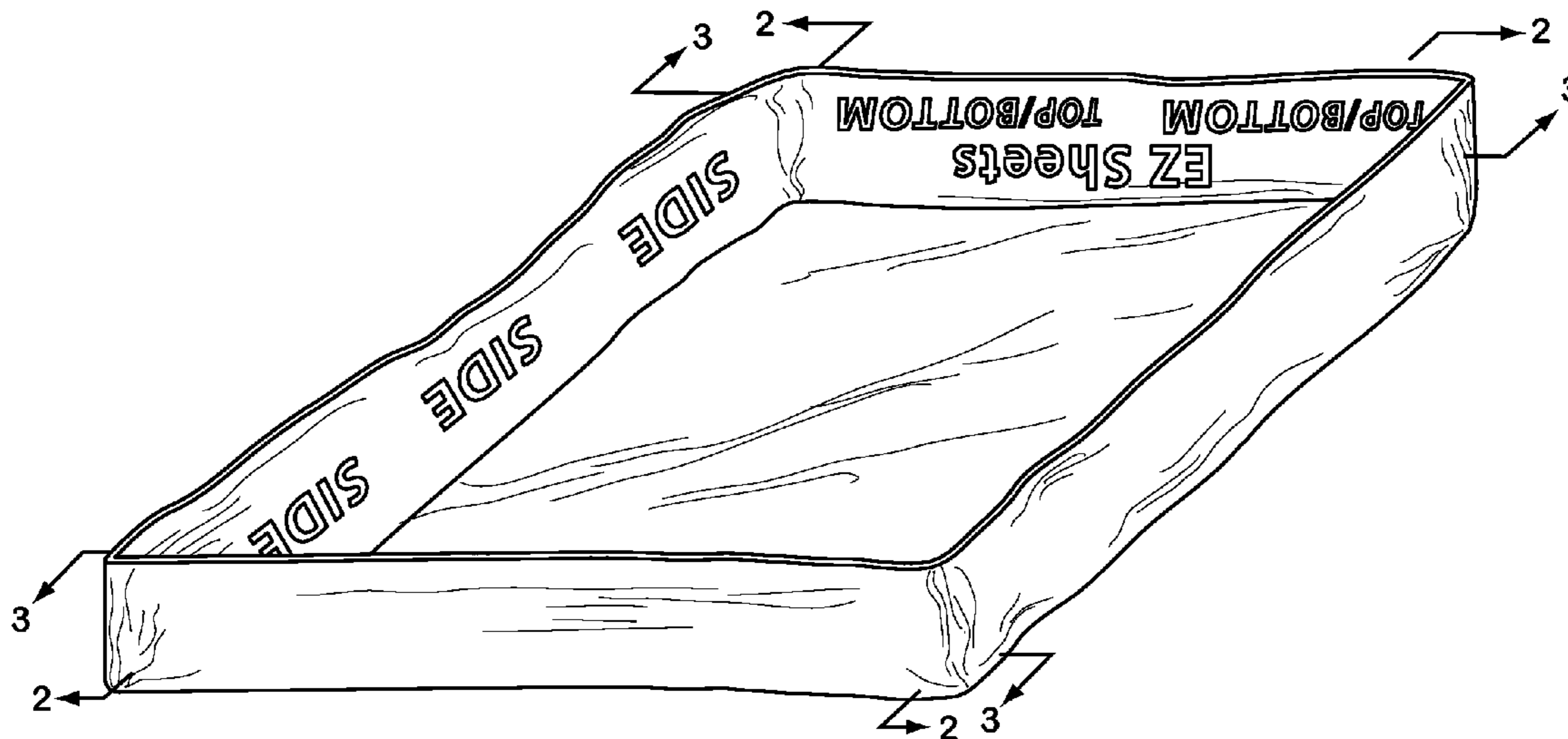
FIG. 2 is a cross-sectional view of either side thereof, taken generally along lines 2—2 of FIG. 1;

FIG. 3 is a cross-sectional view of either the front or rear end thereof, taken generally along lines 3—3 of FIG. 1;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a bottom plan view thereof.

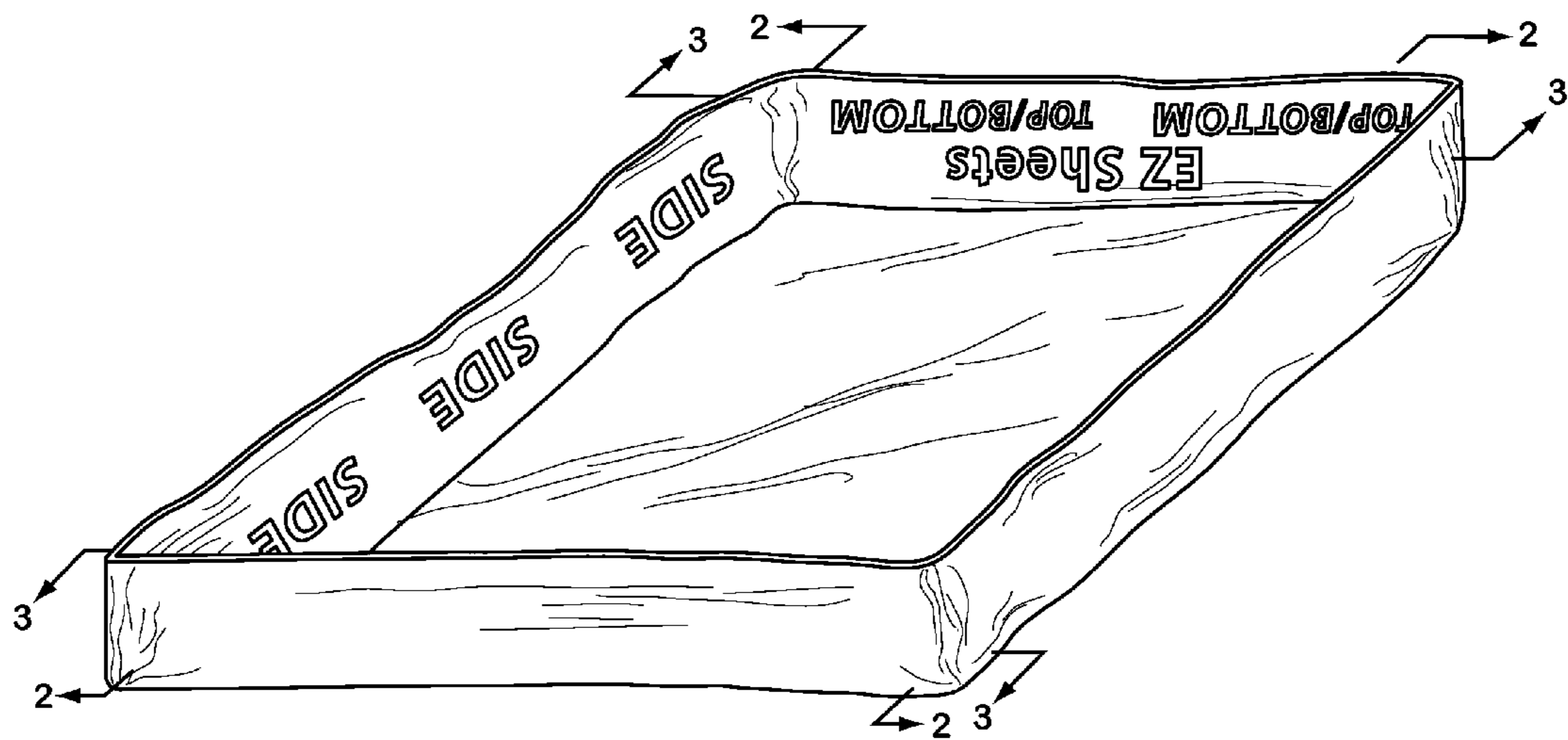

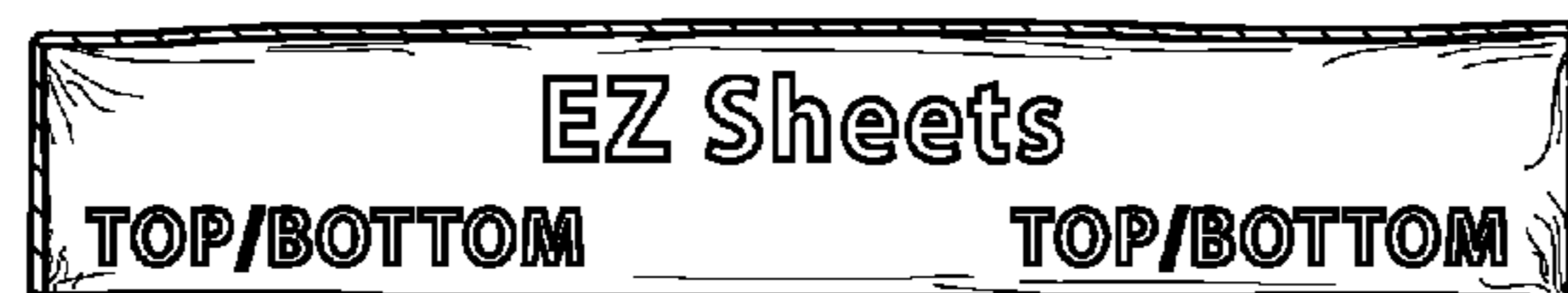

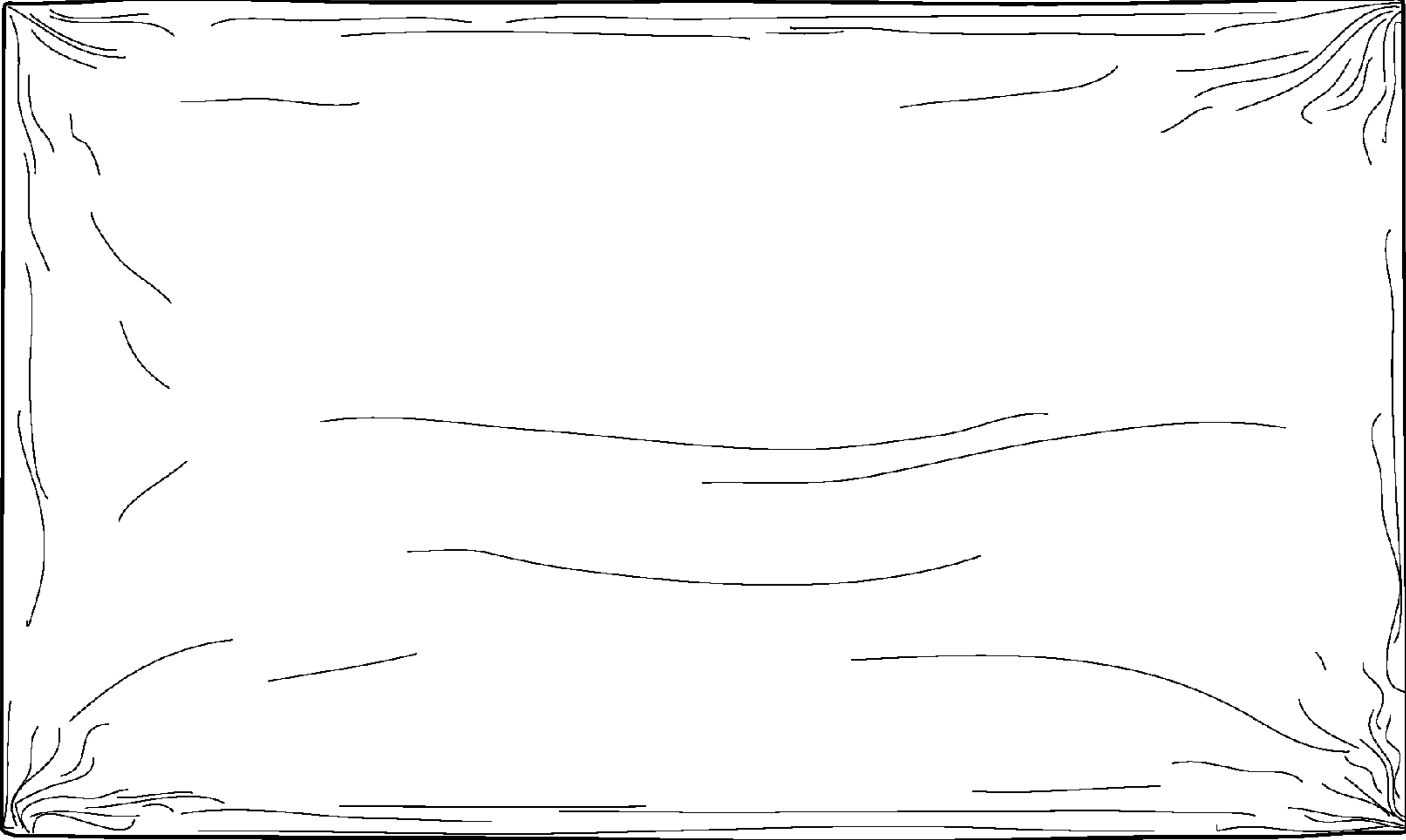

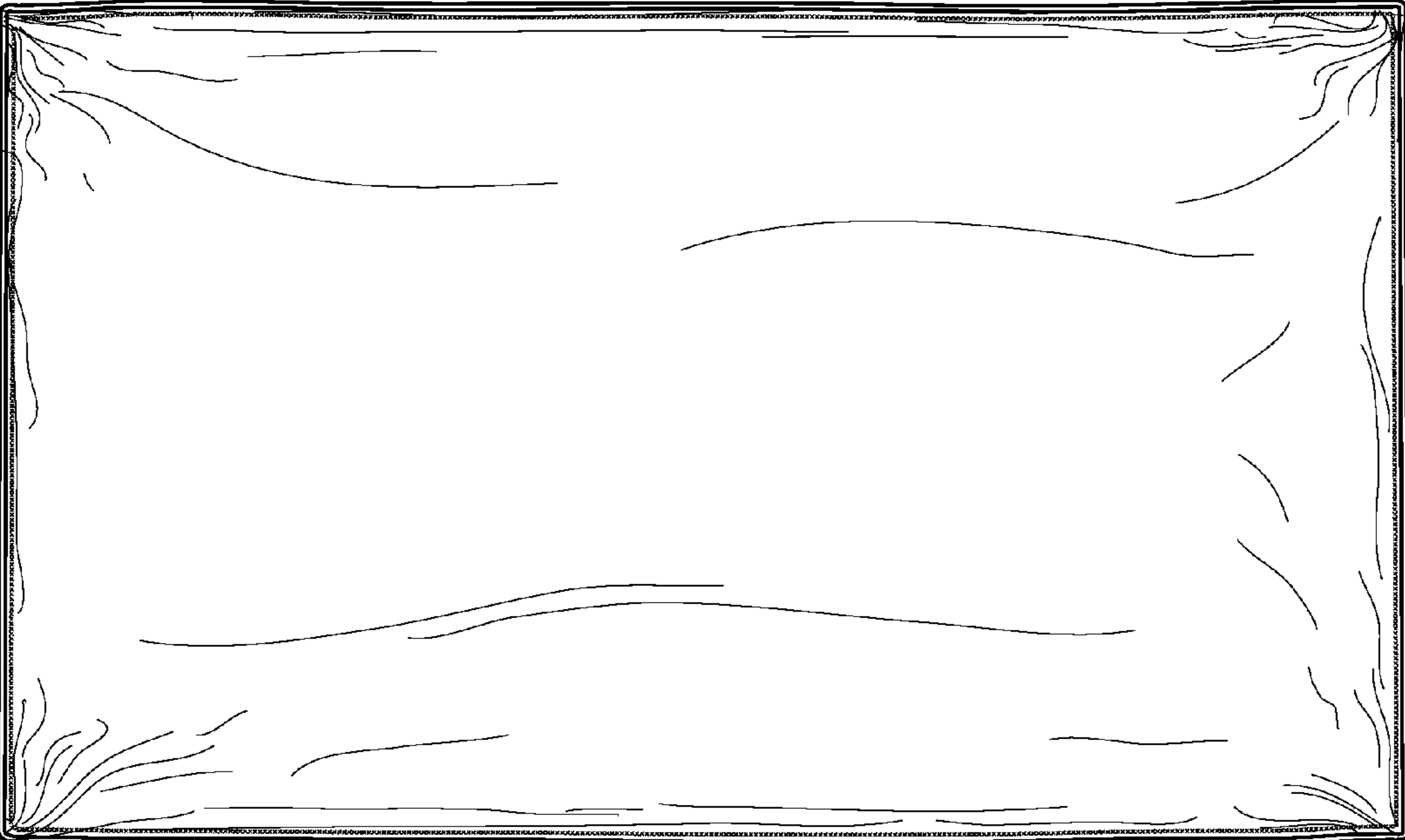
