The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing a first embodiment of our new design;

FIG. 14 is a left side elevational view thereof;

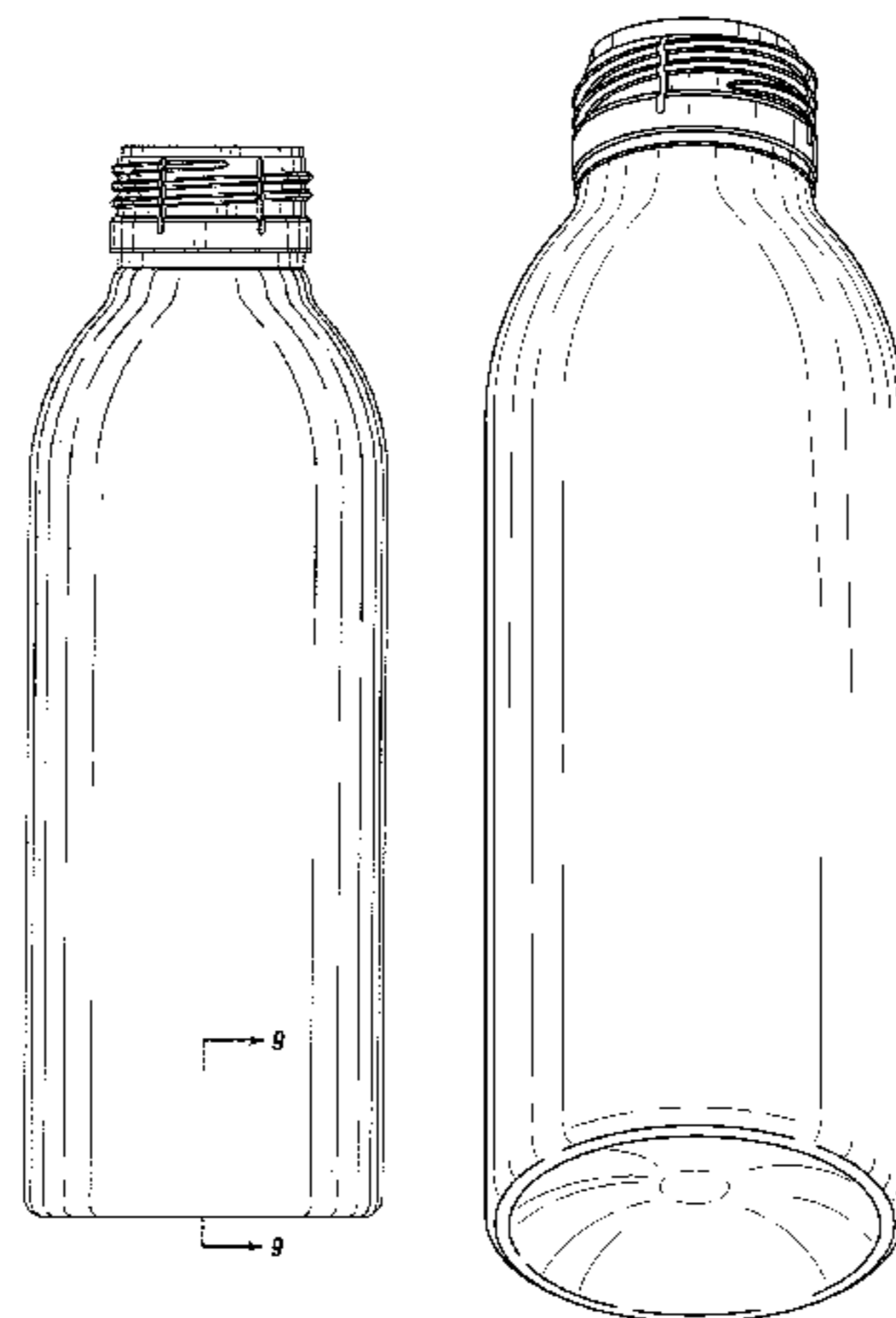
FIG. 15 is a top plan view thereof;

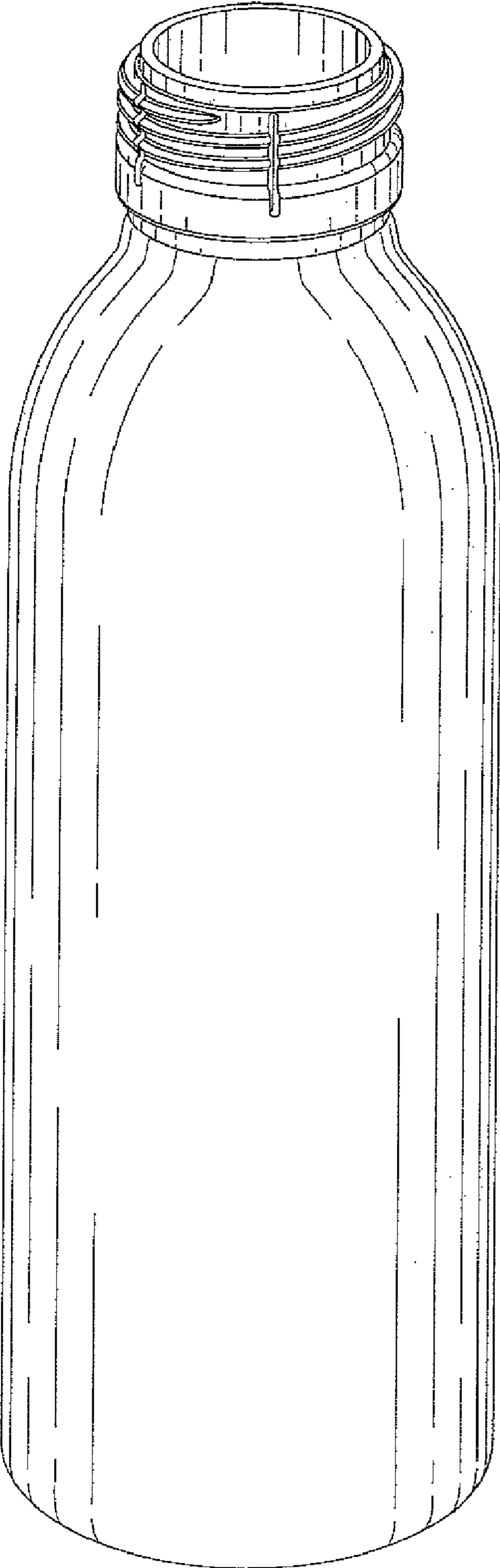

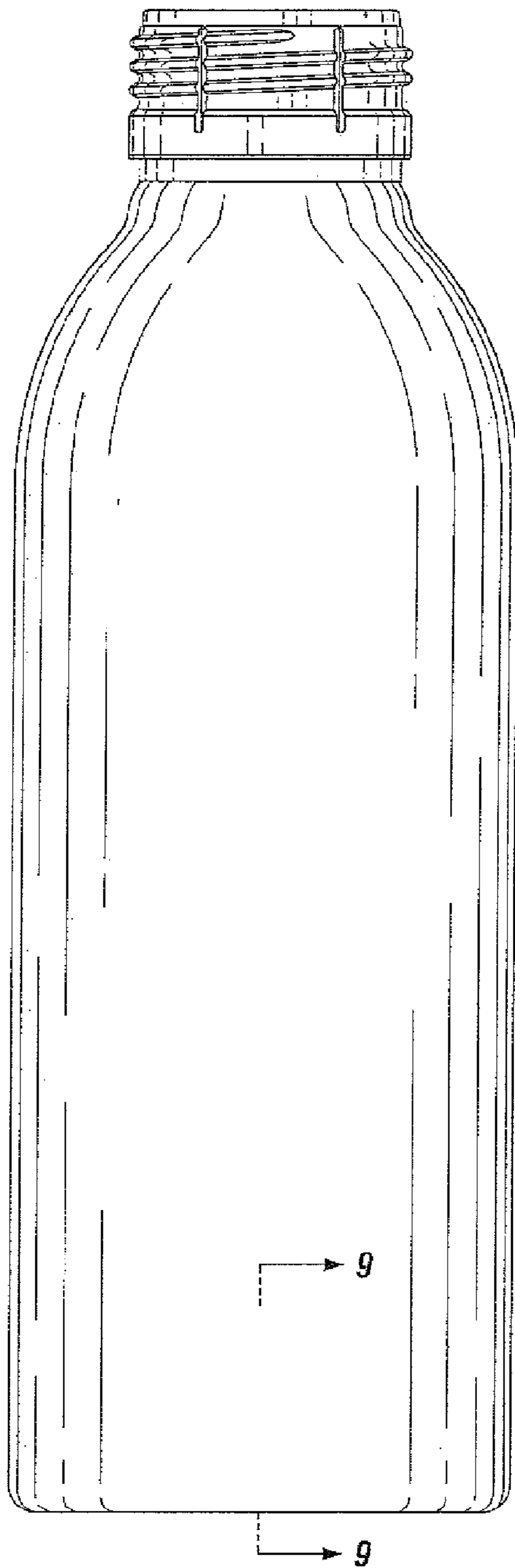

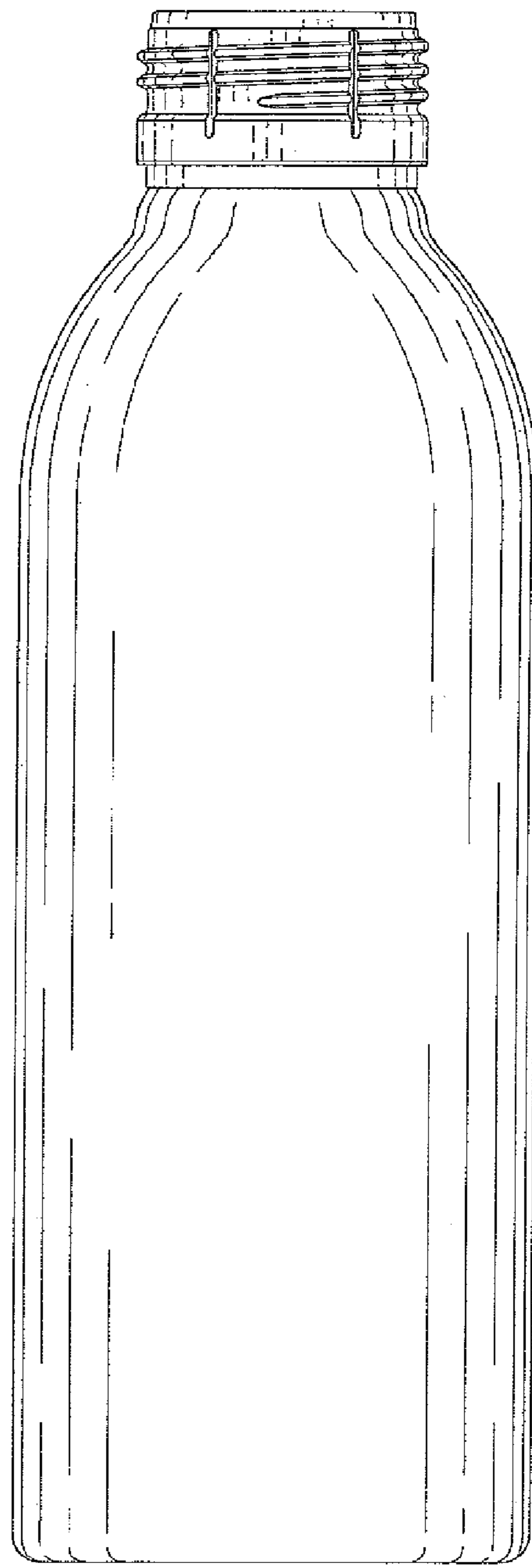

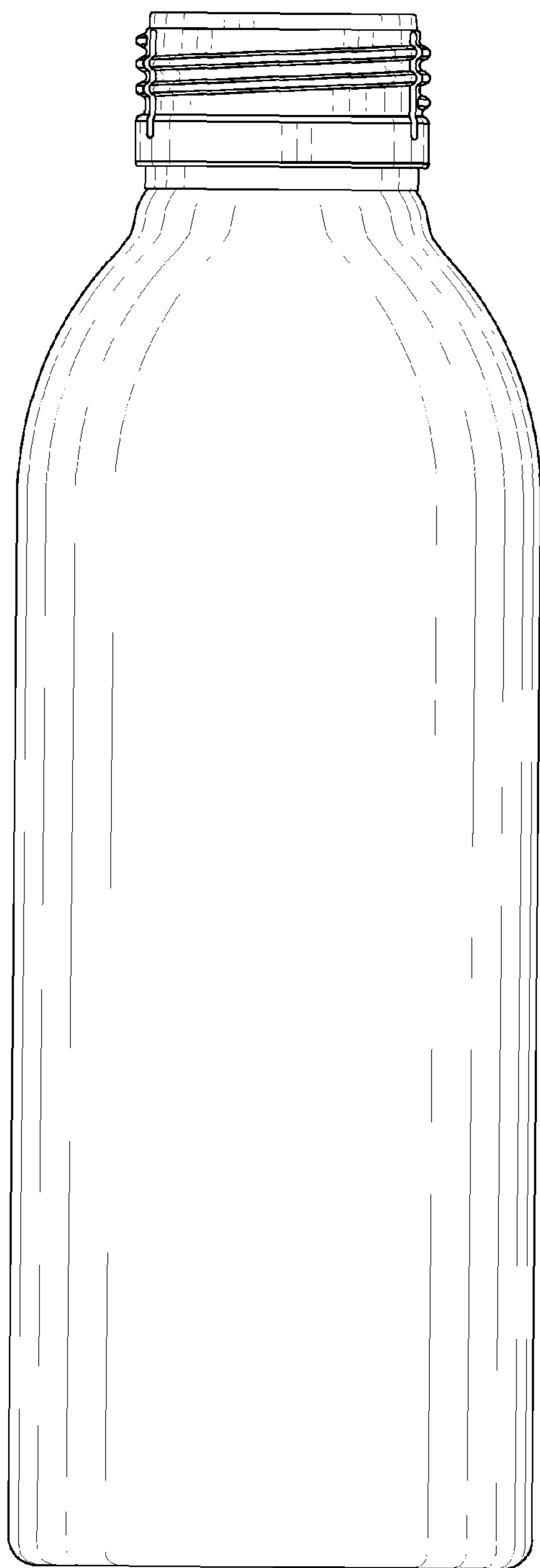

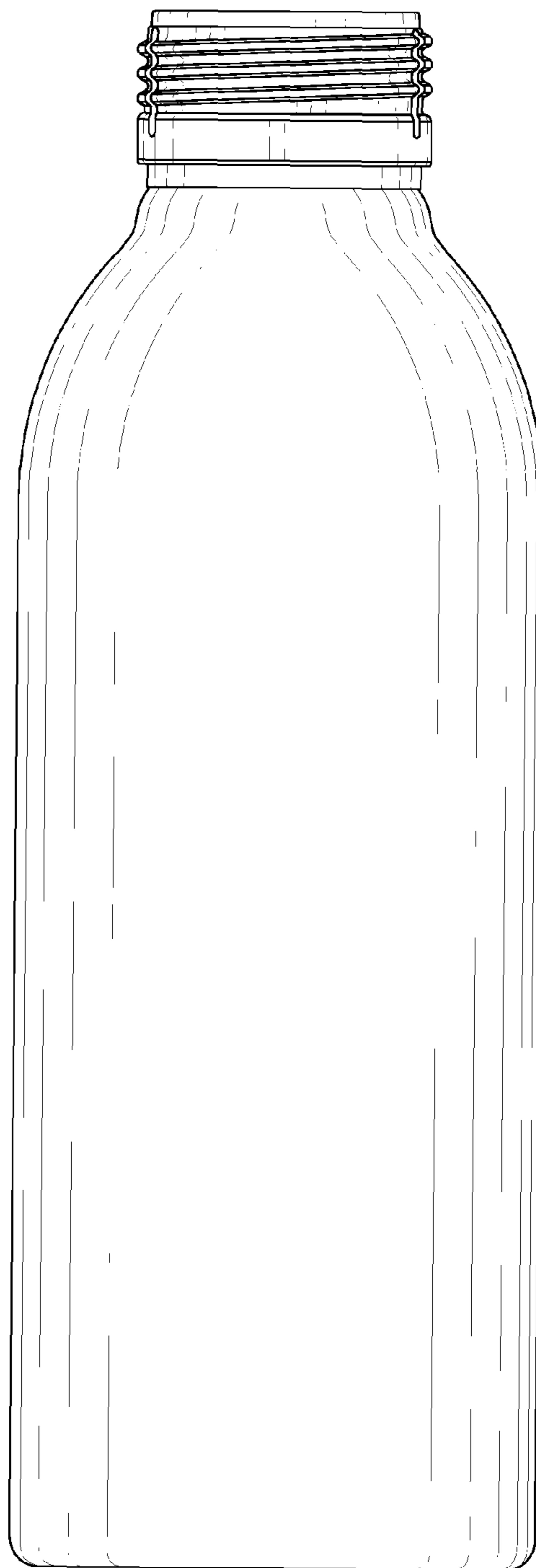

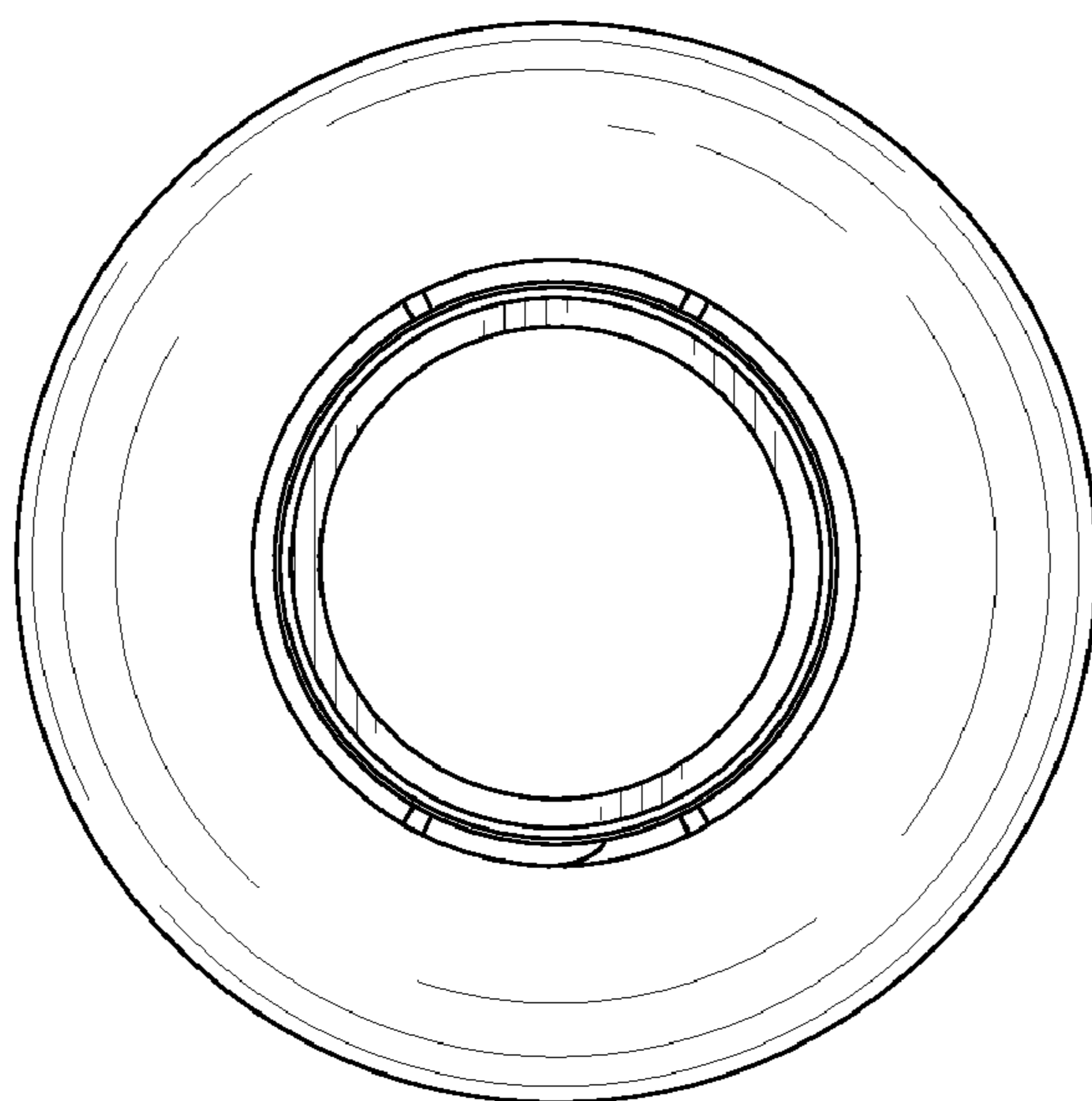

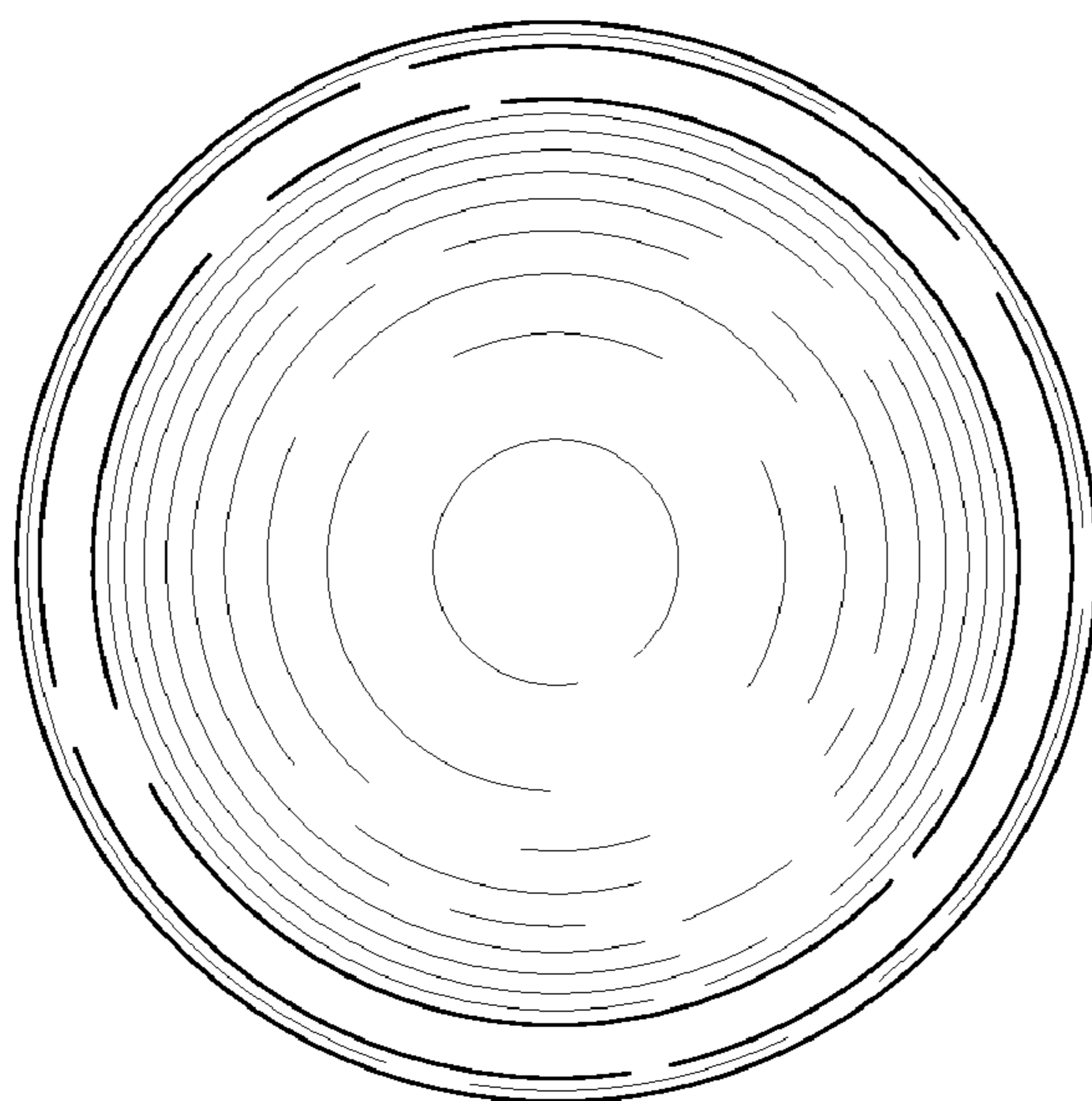

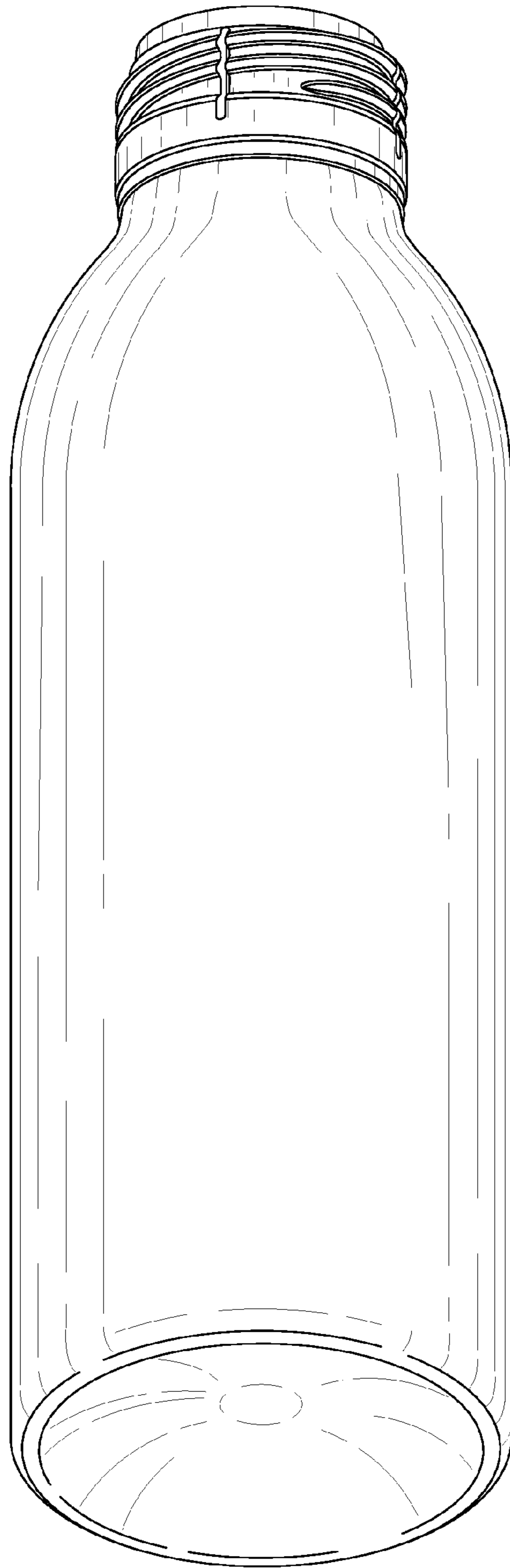

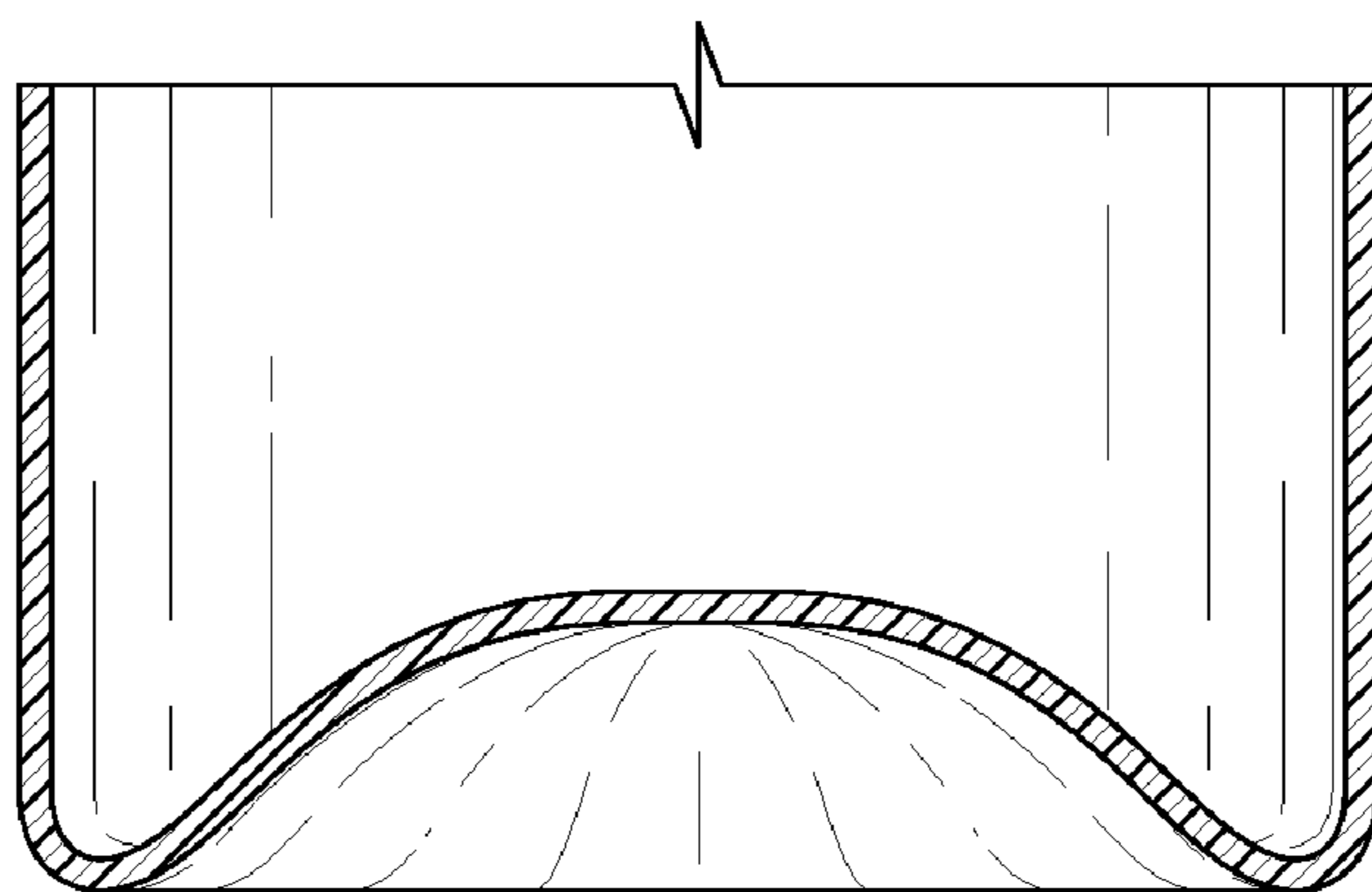

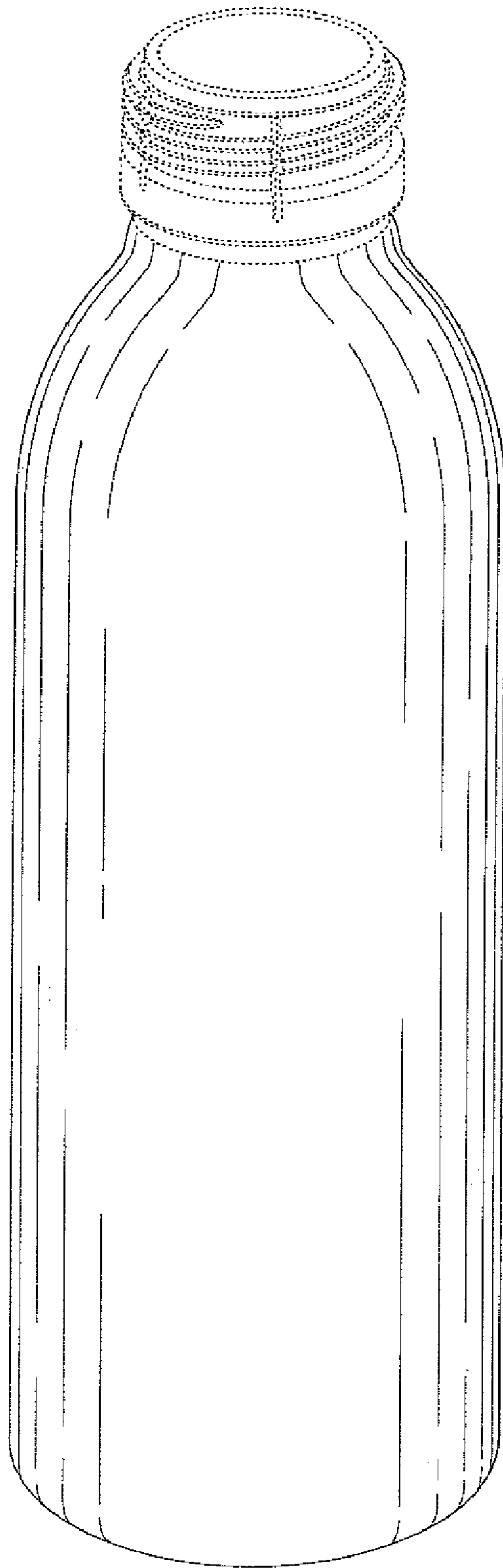

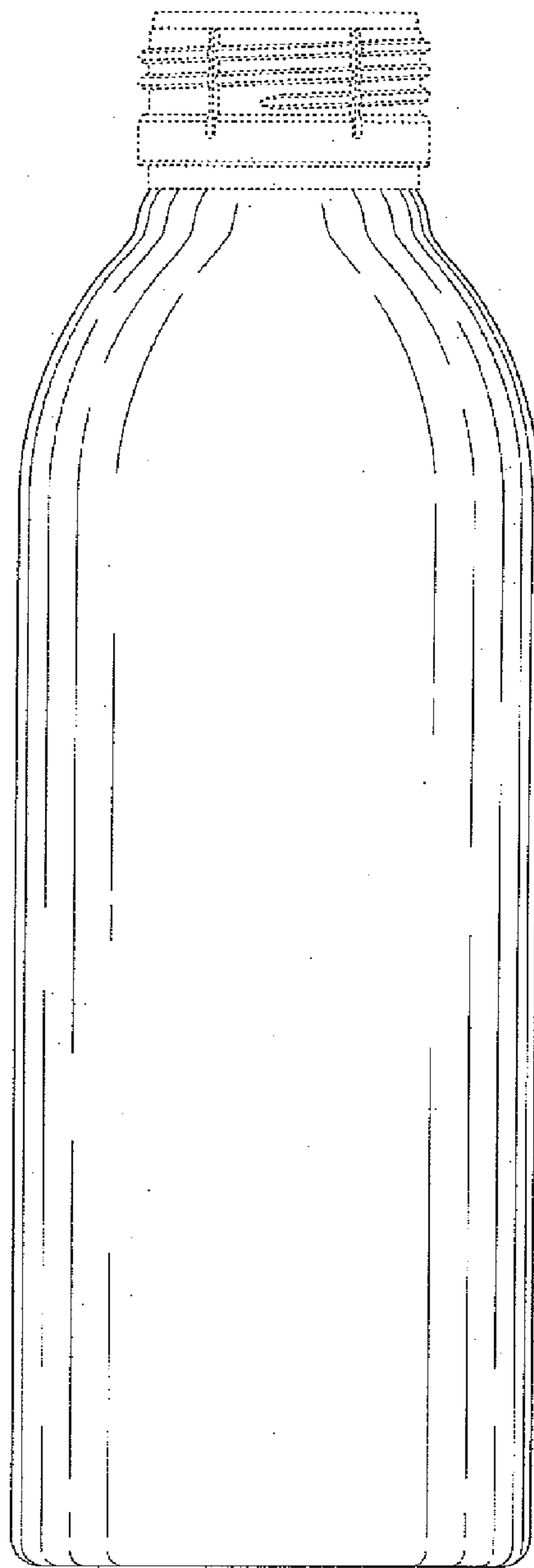

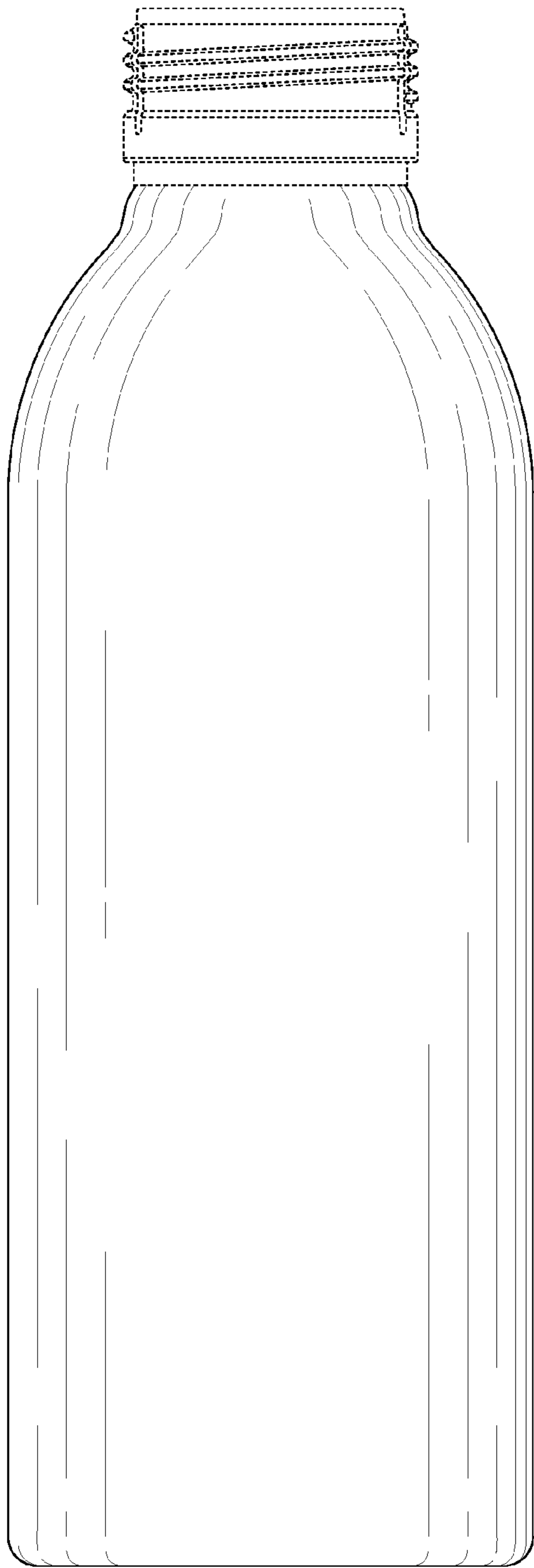

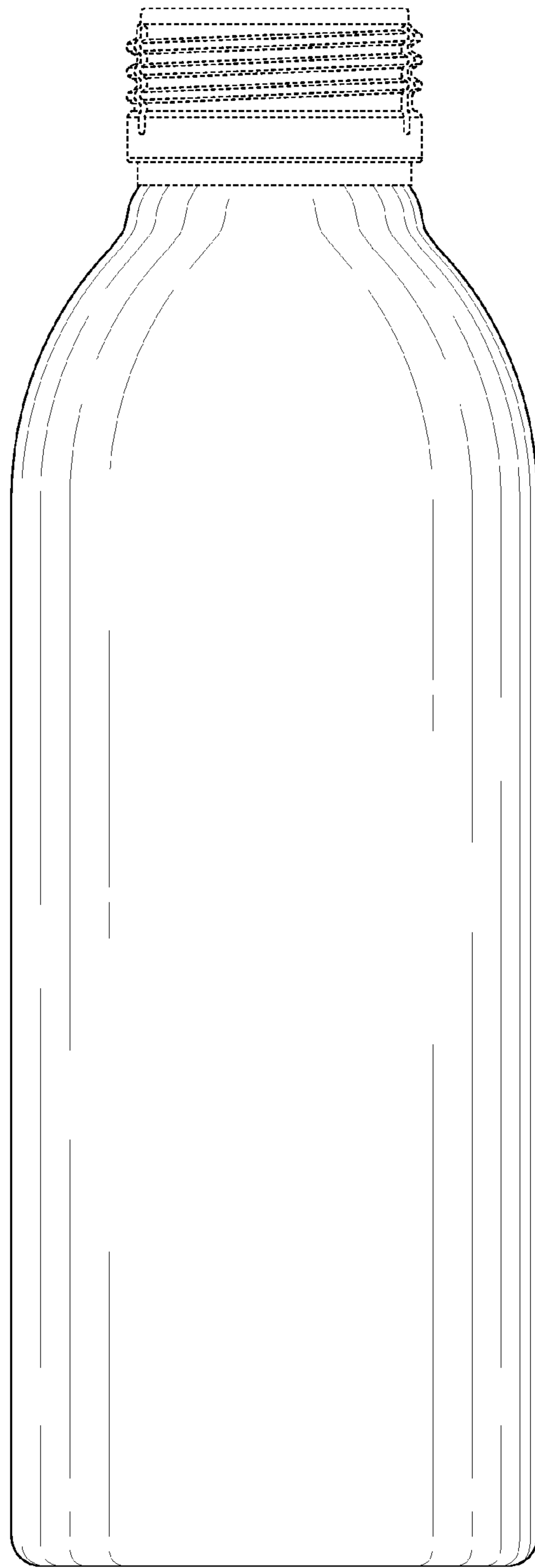

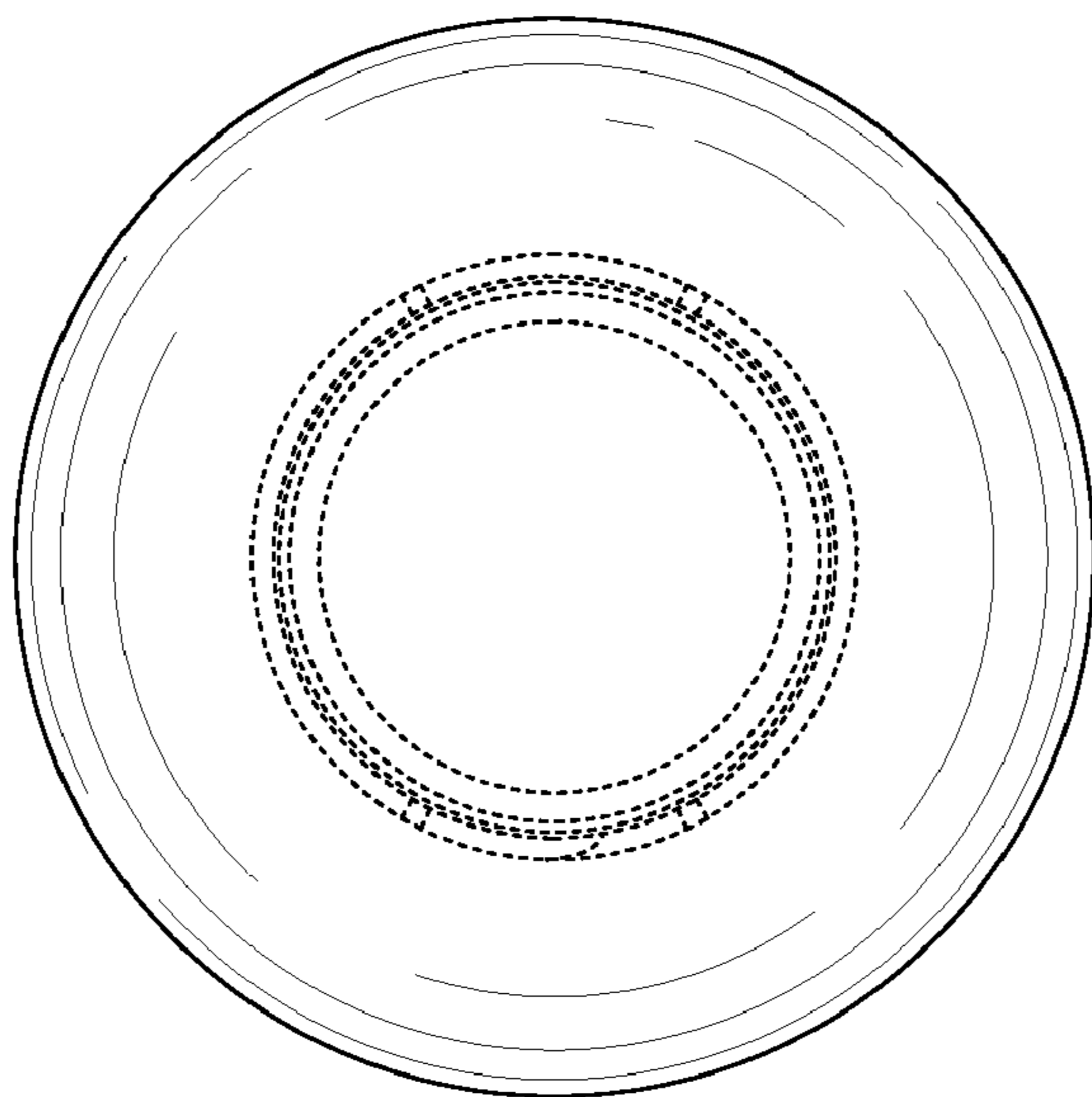

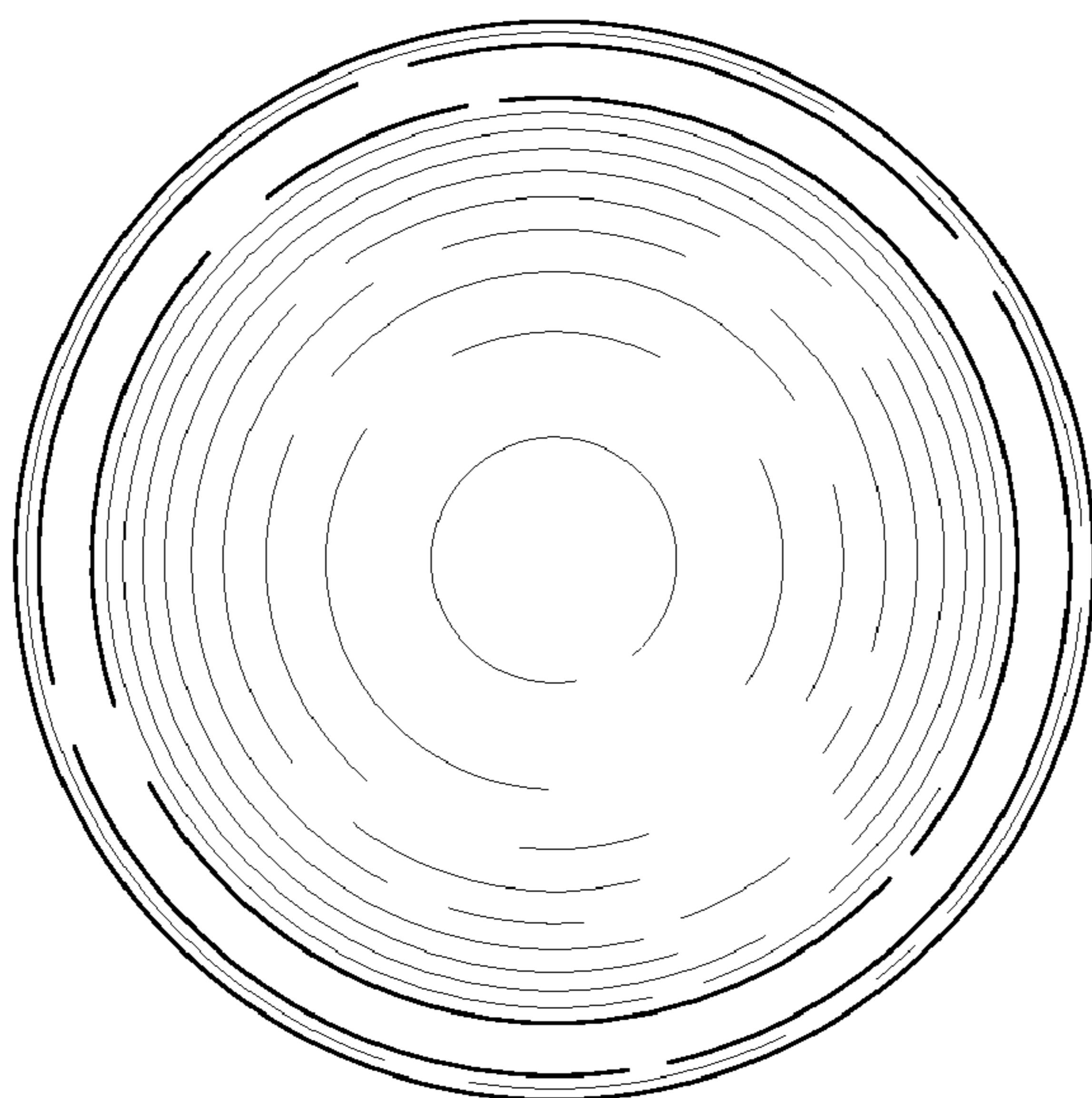

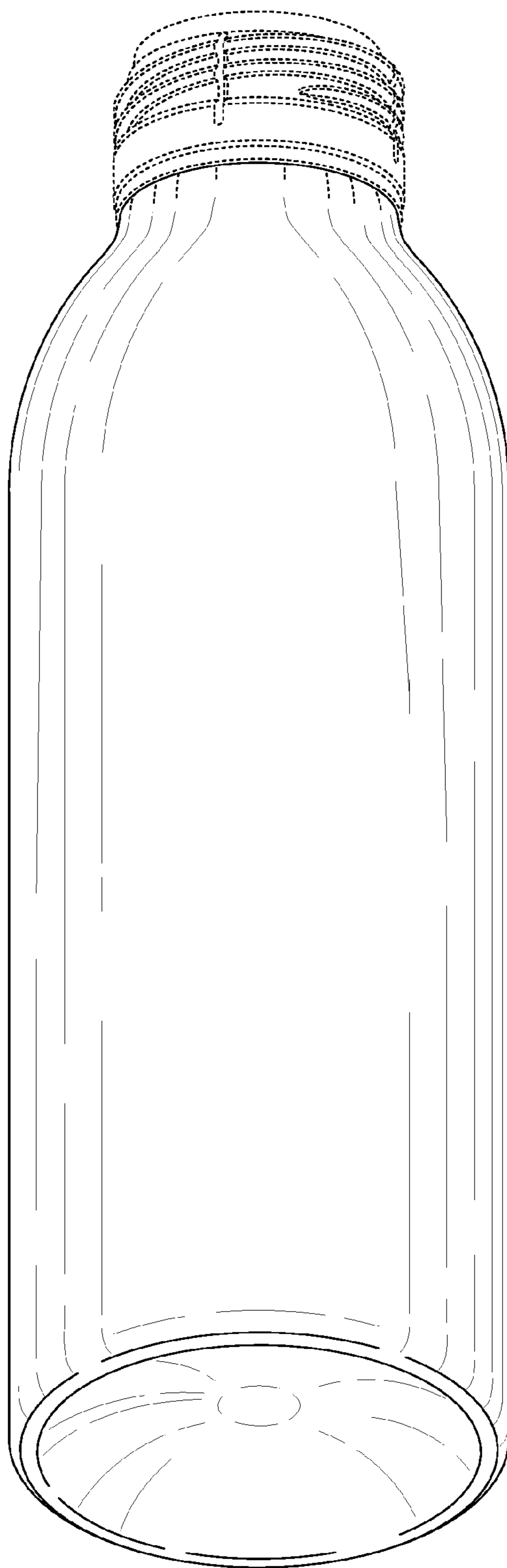
