I claim the ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a container embodying my new design;

FIG. 2 is a front view thereof, and a rear view thereof is symmetrical to the front view;

FIG. 5 is a left side view thereof;

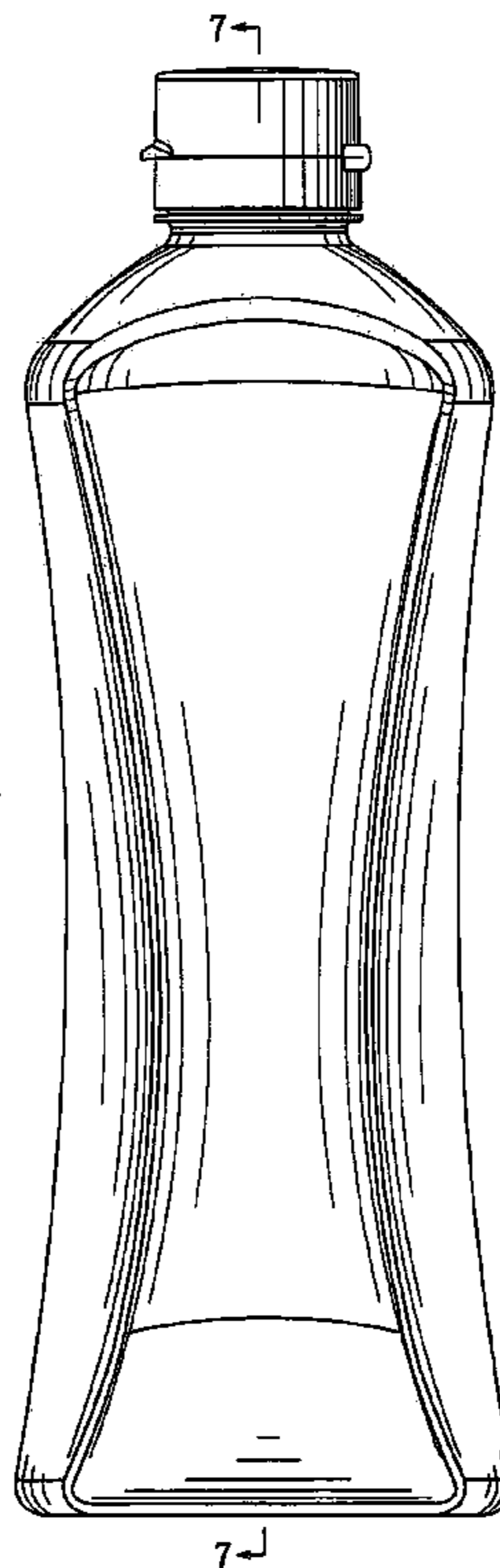
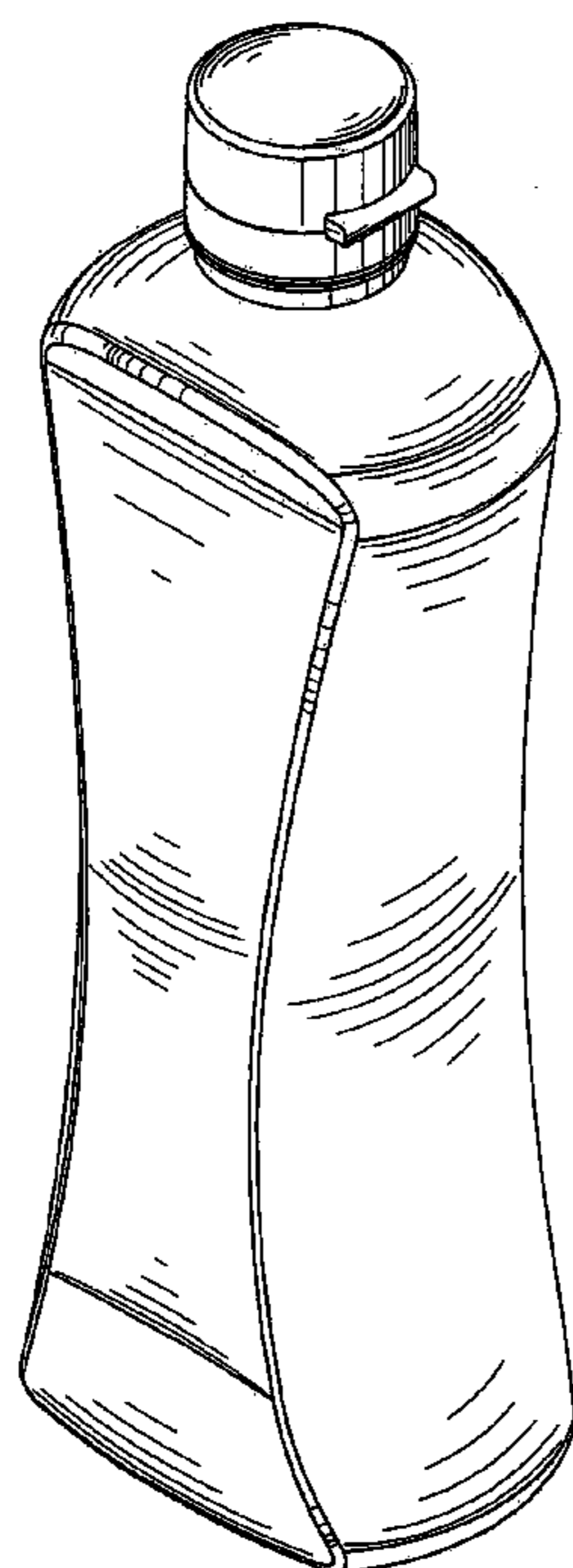
FIG. 6 is a right side view thereof;

FIG. 7 is a cross sectional view thereof taken along line 7—7 in FIG. 2; and,

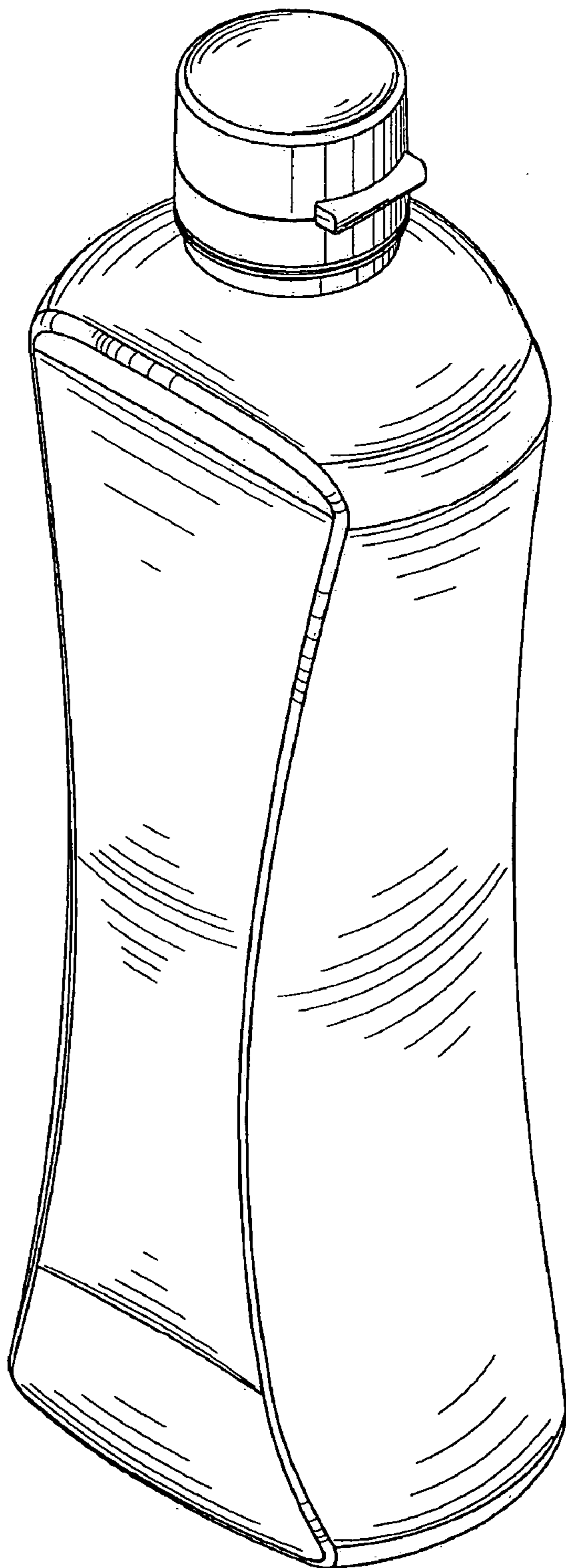
FIG. 8 is a cross sectional view thereof taken along line 8—8 in FIG. 5.

The broken lines are included for the purpose of illustrating a portion of the bottle that forms no part of the claimed design.

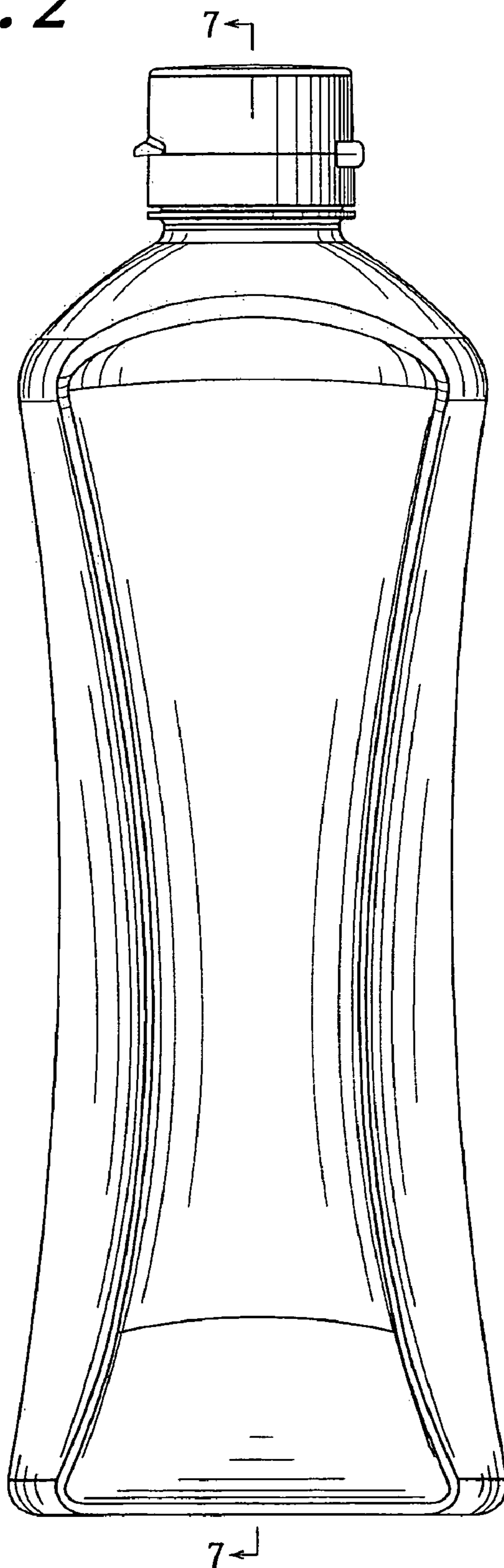

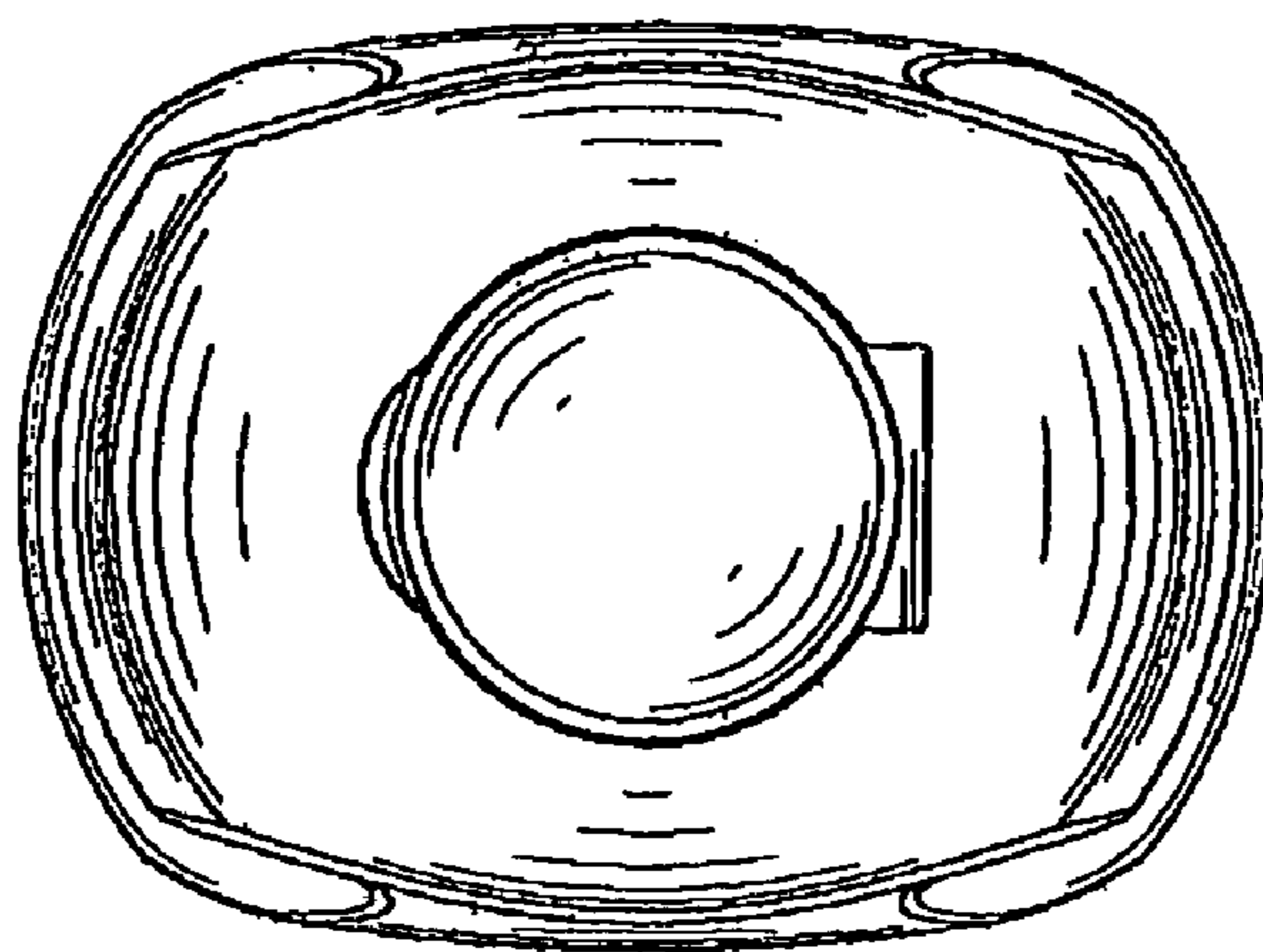

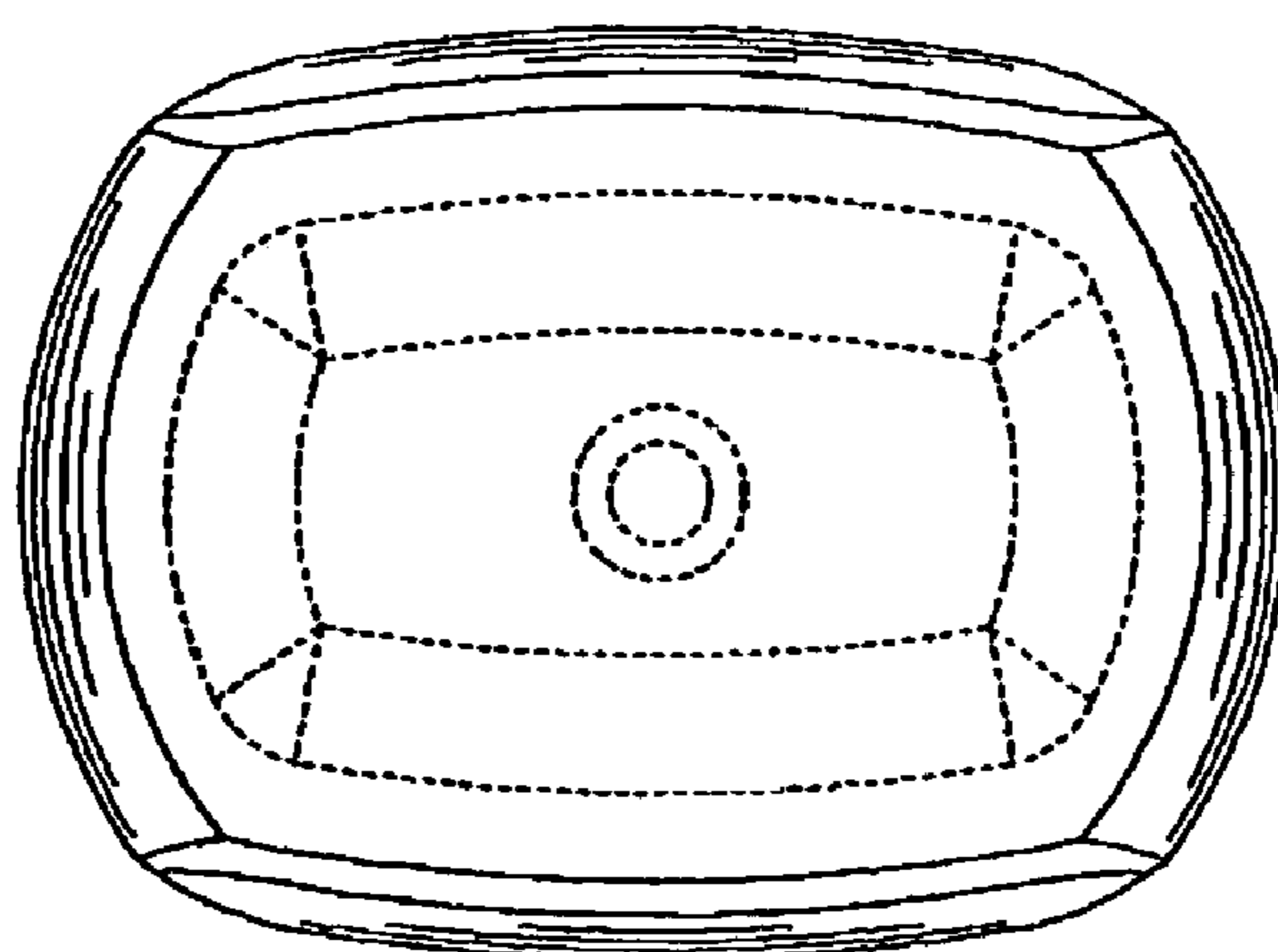

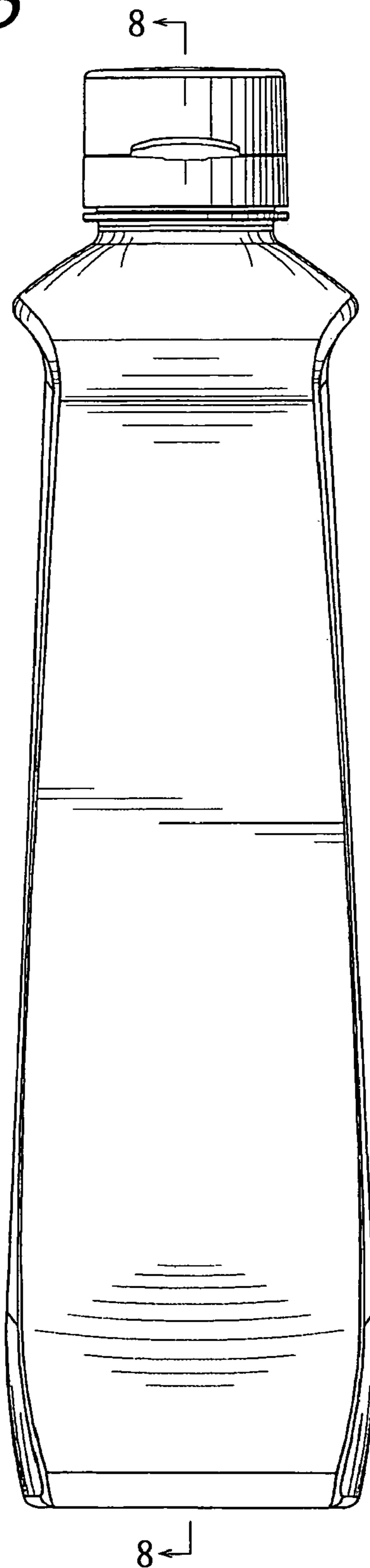

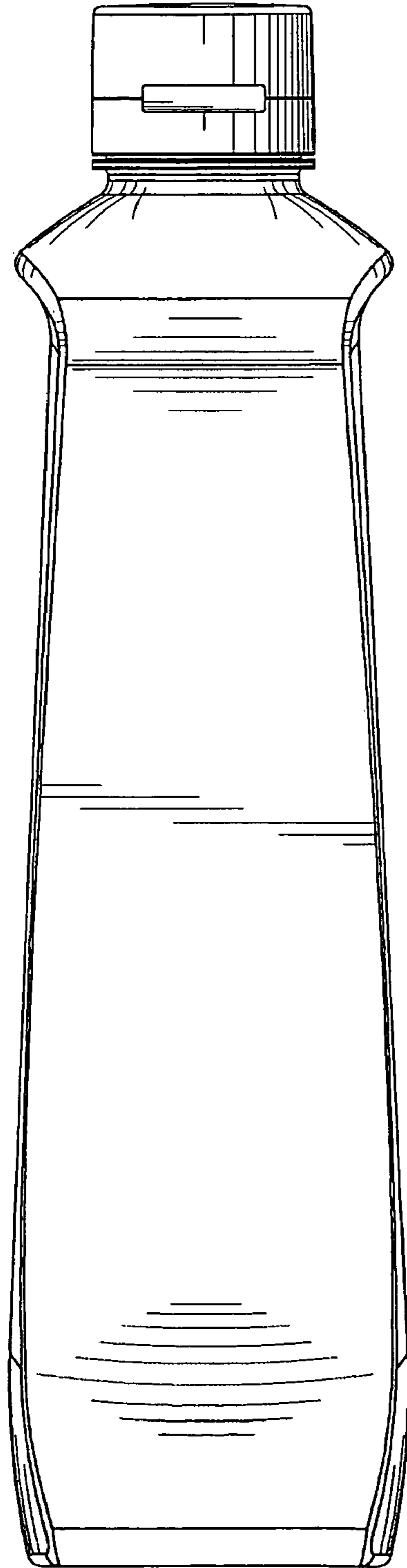

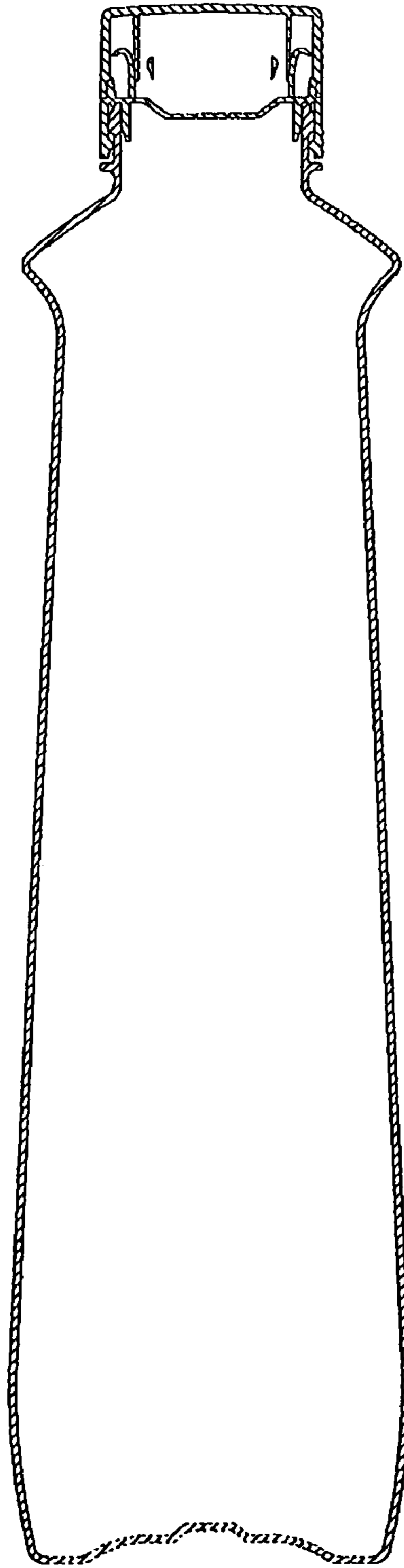
