**DESCRIPTION**

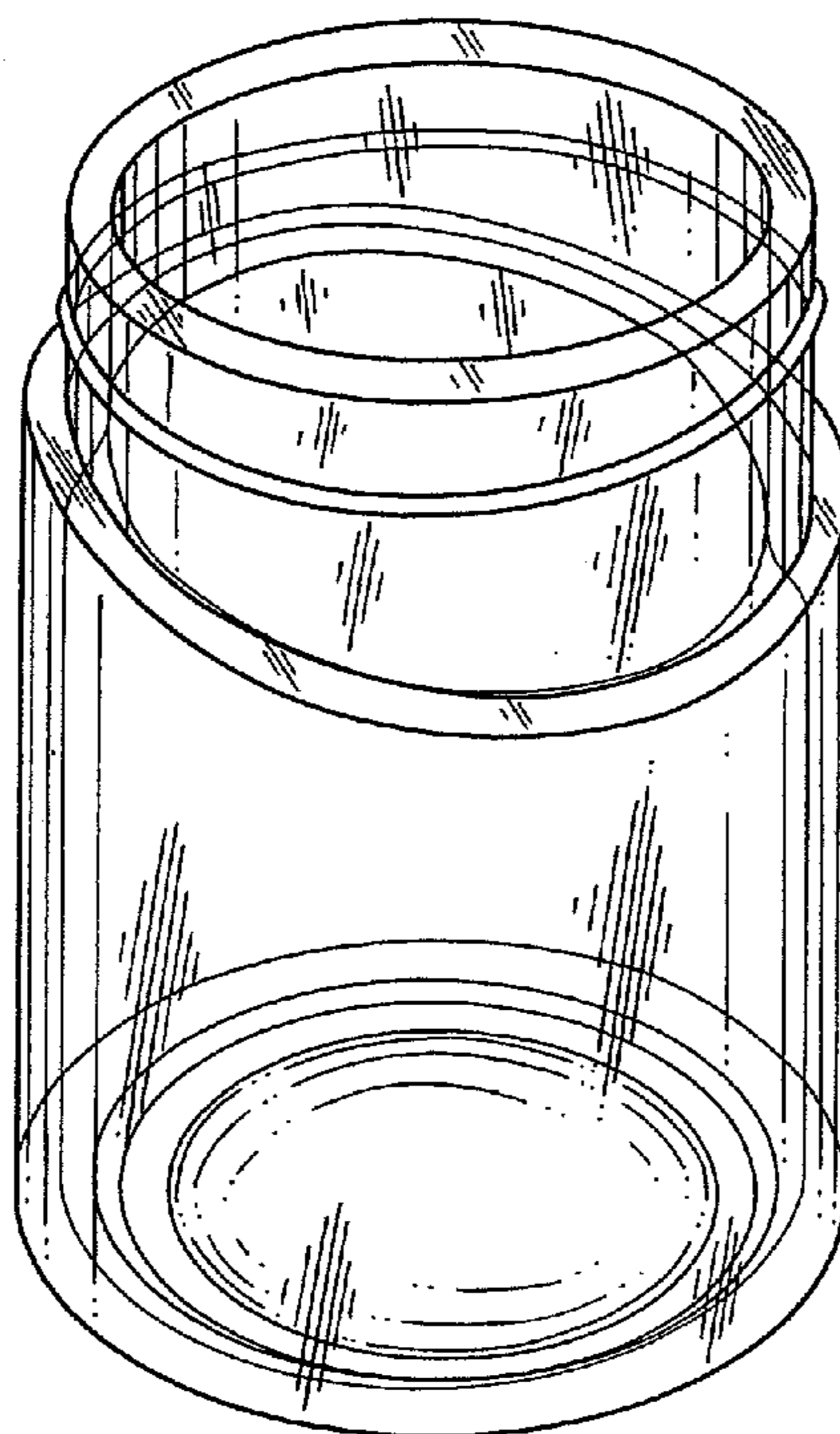

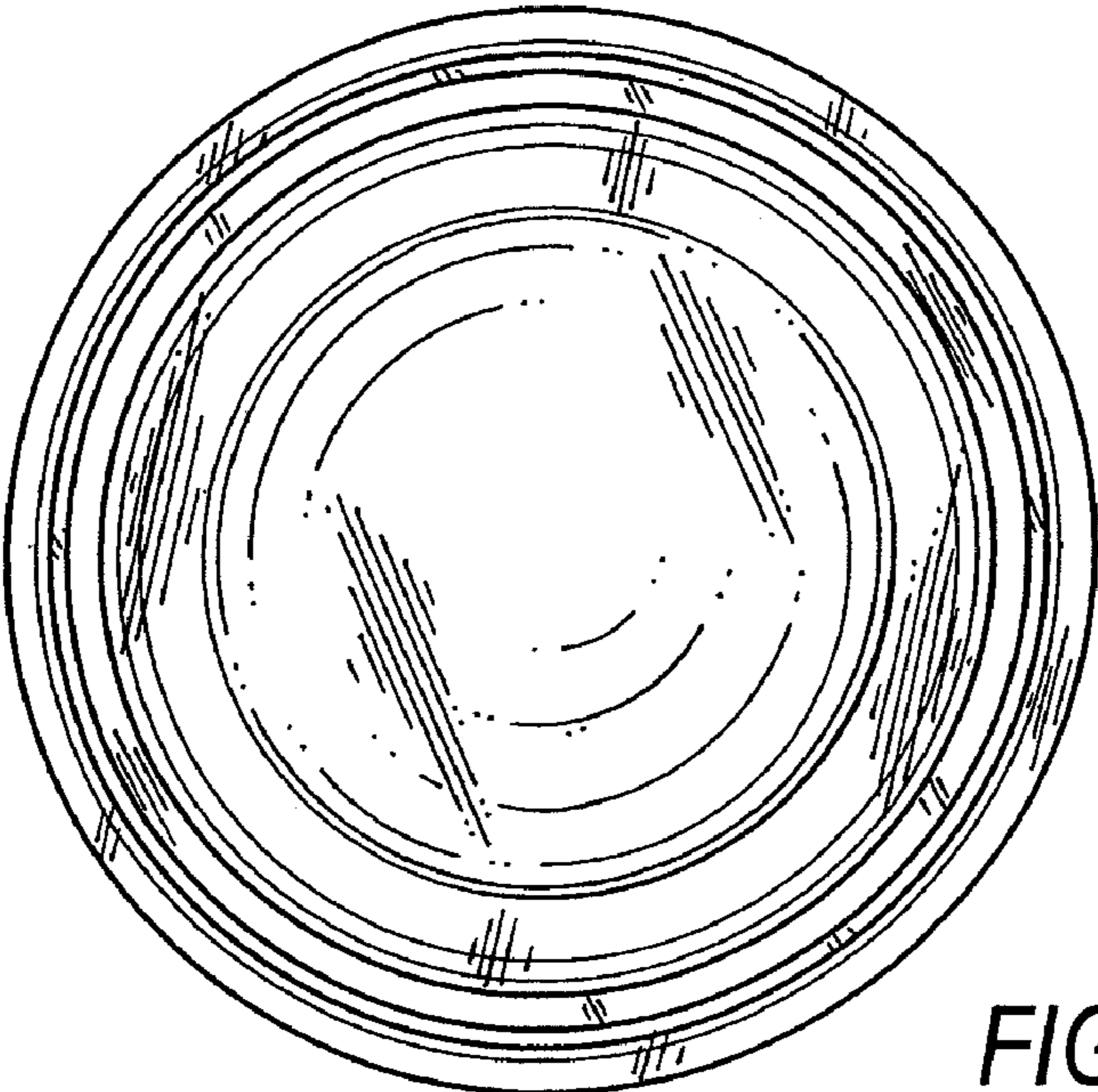
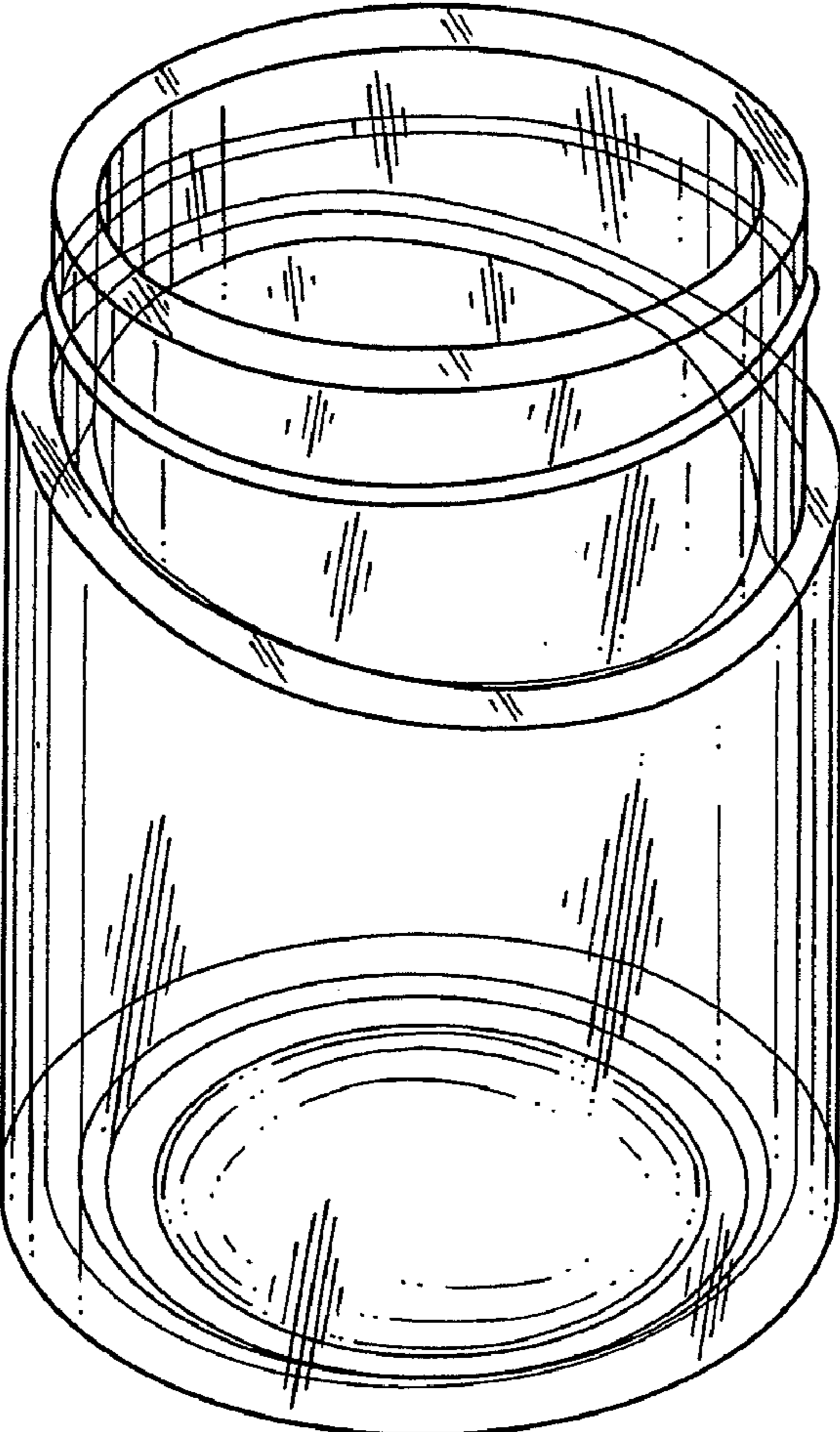

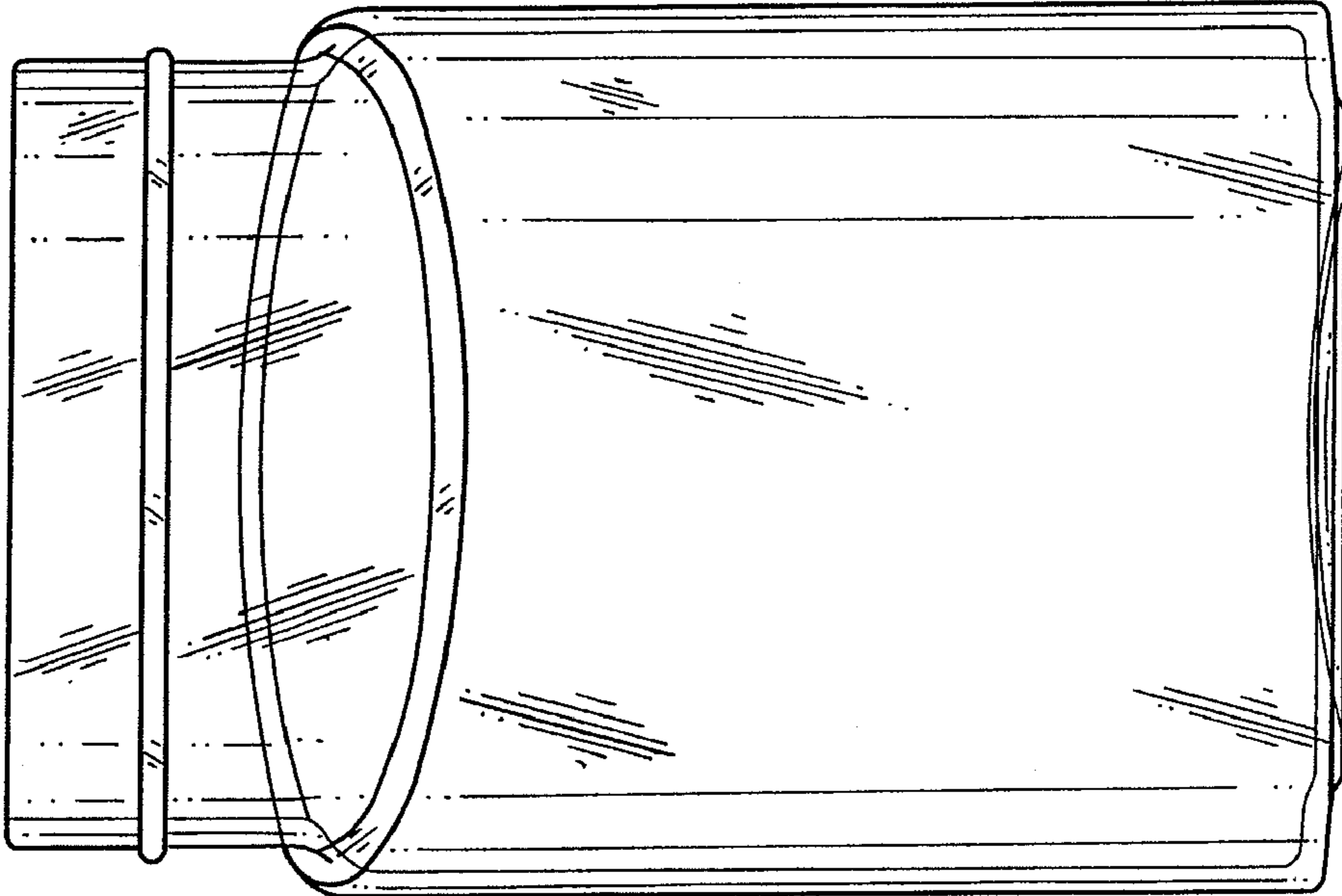

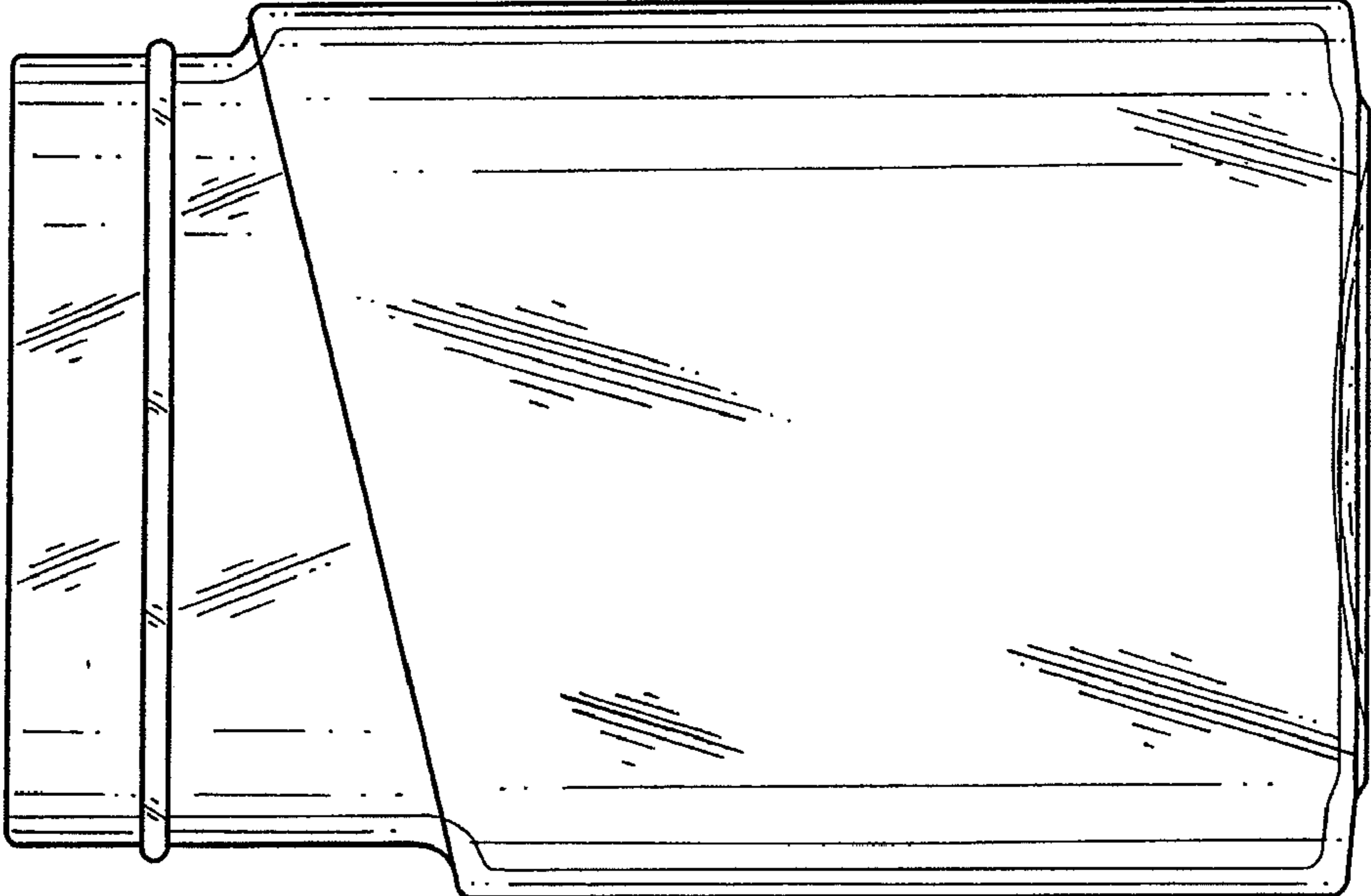

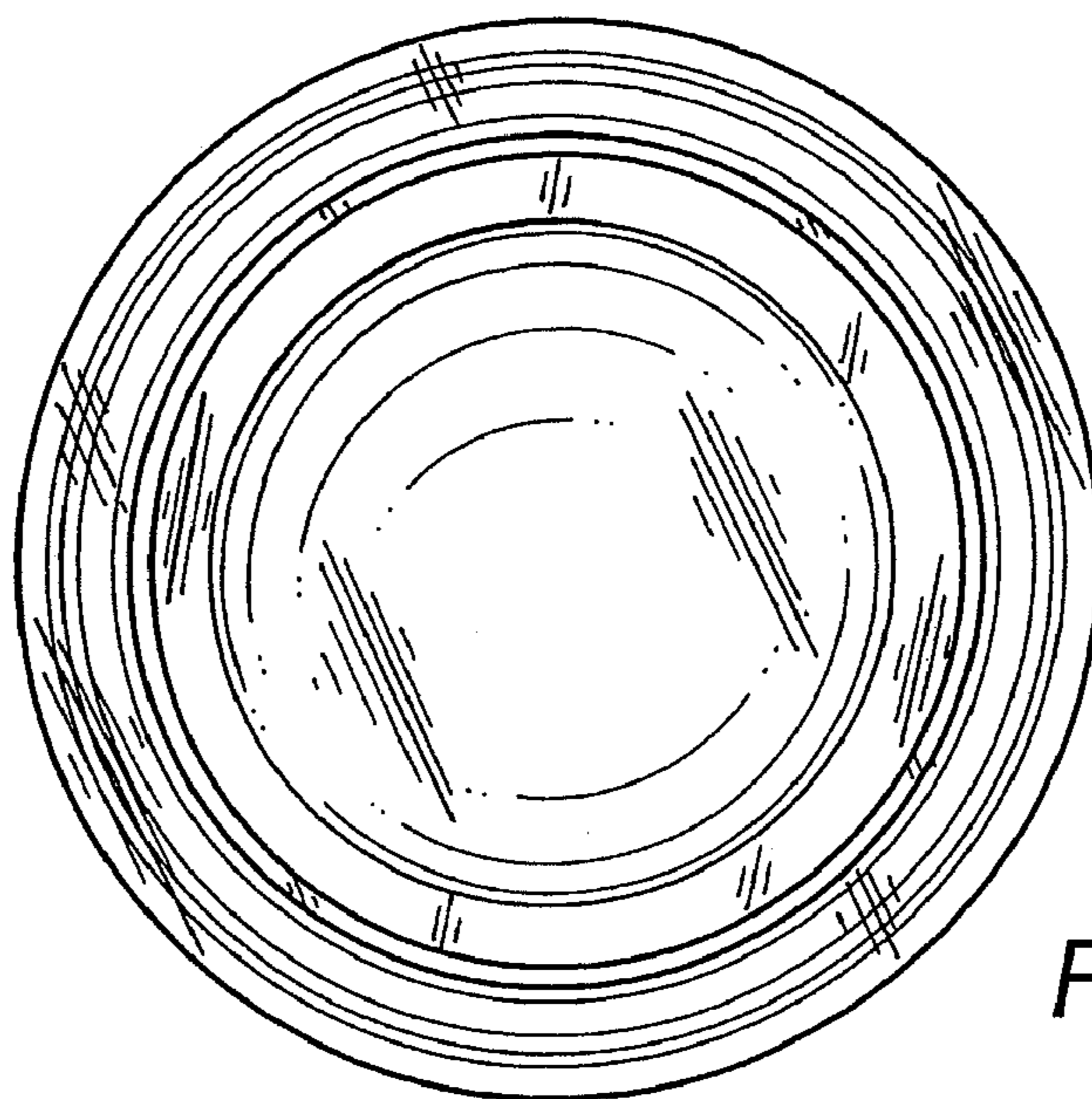
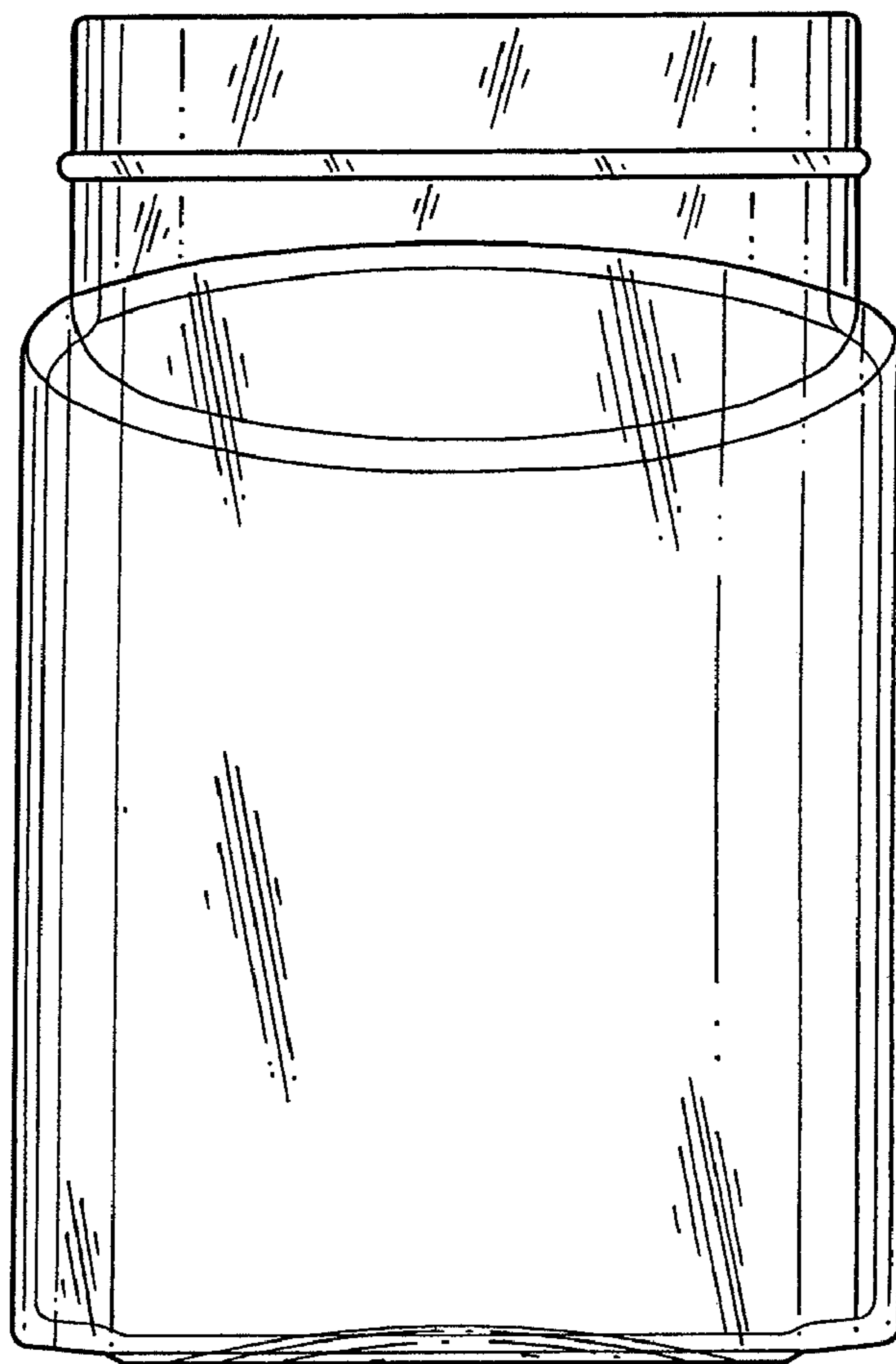
