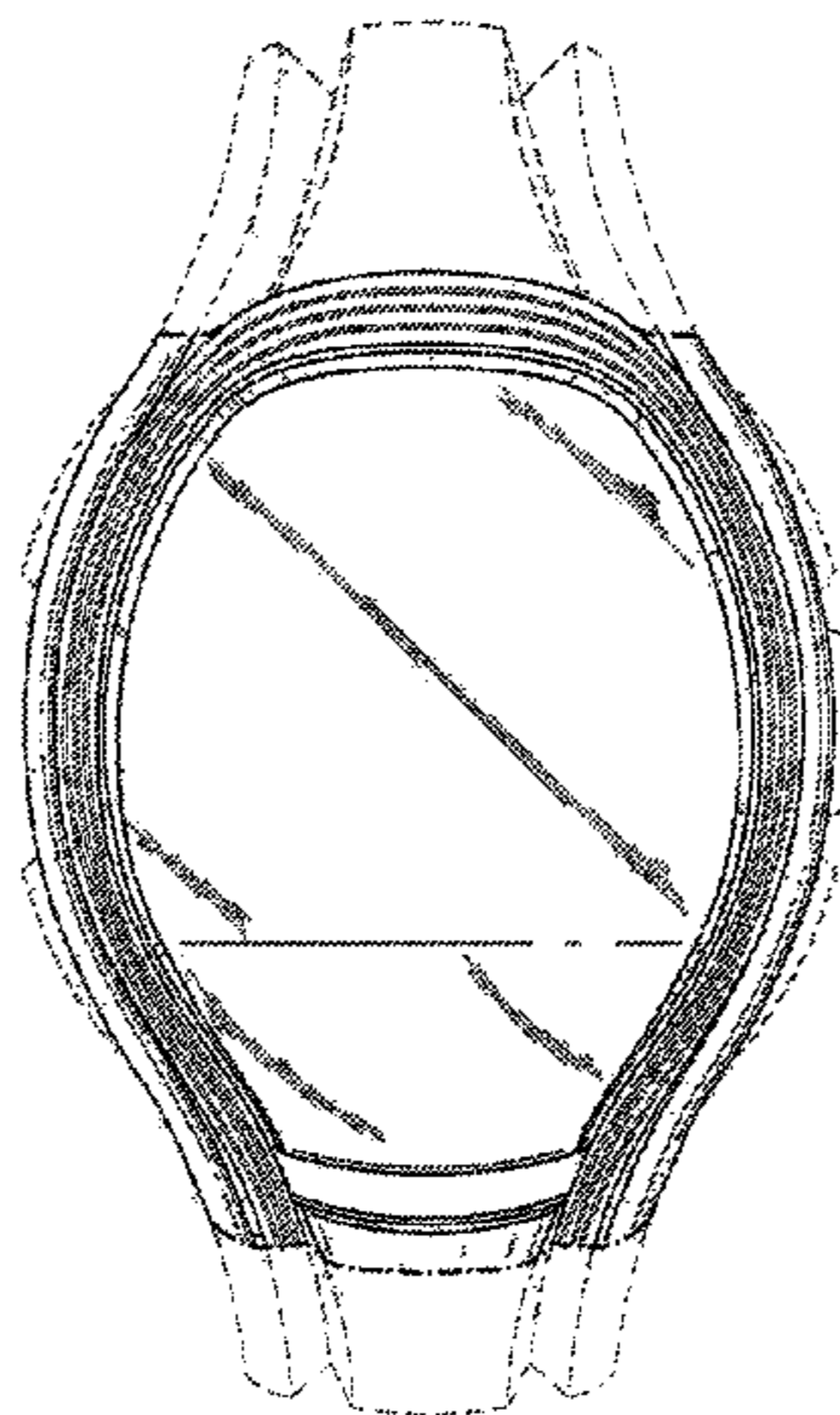
The ornamental design for a watch casing and portion of a strap, as shown and described.

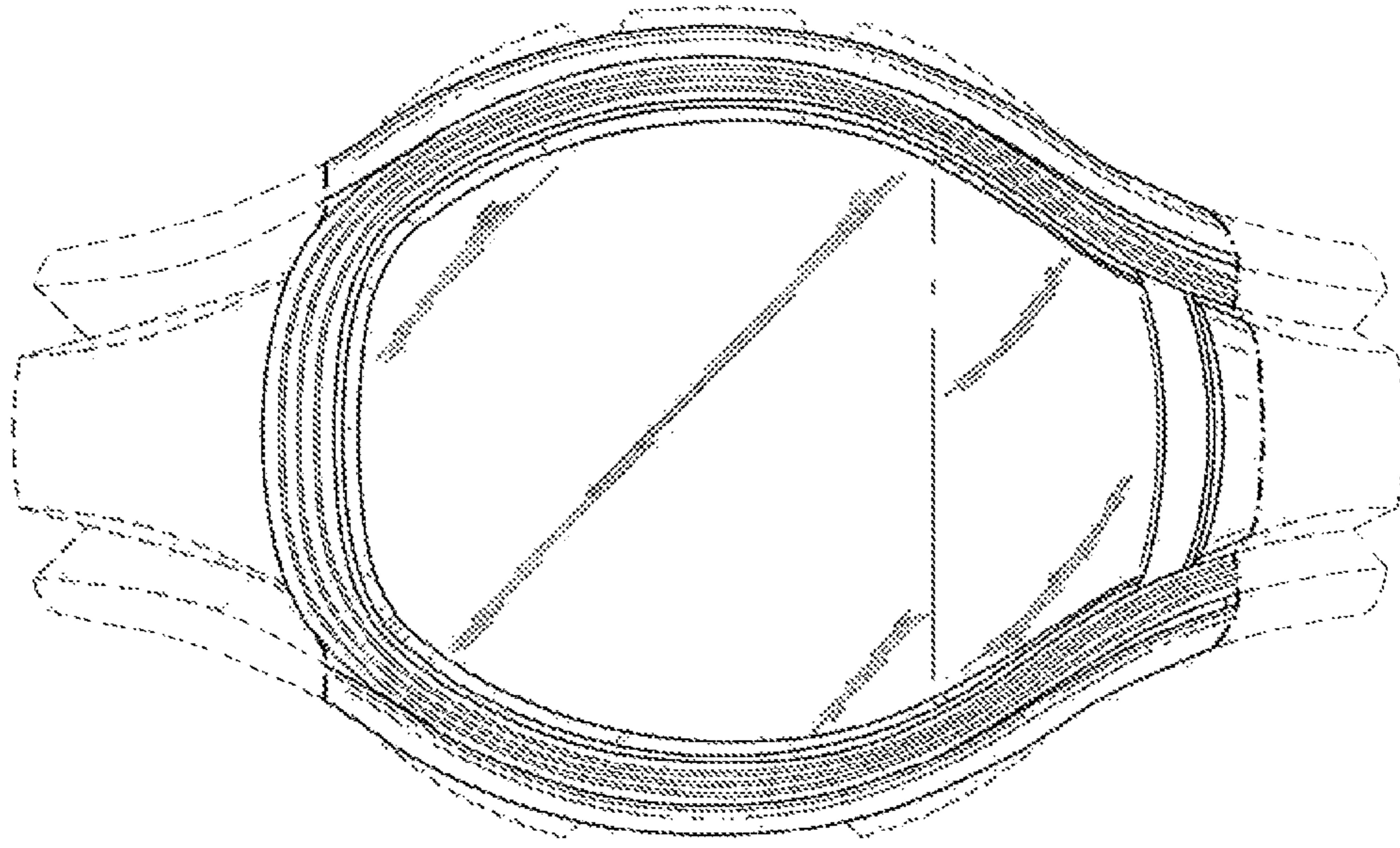

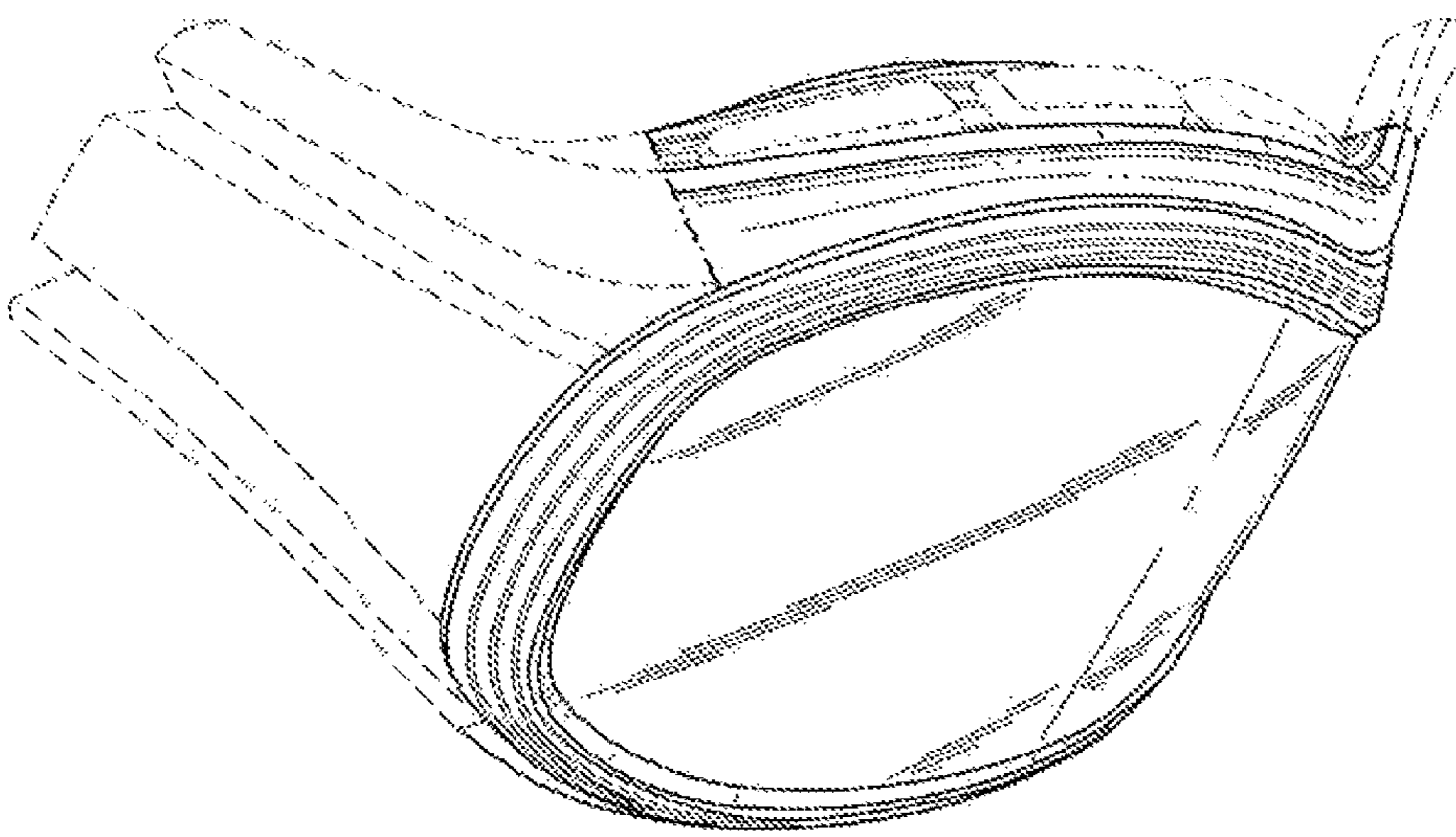

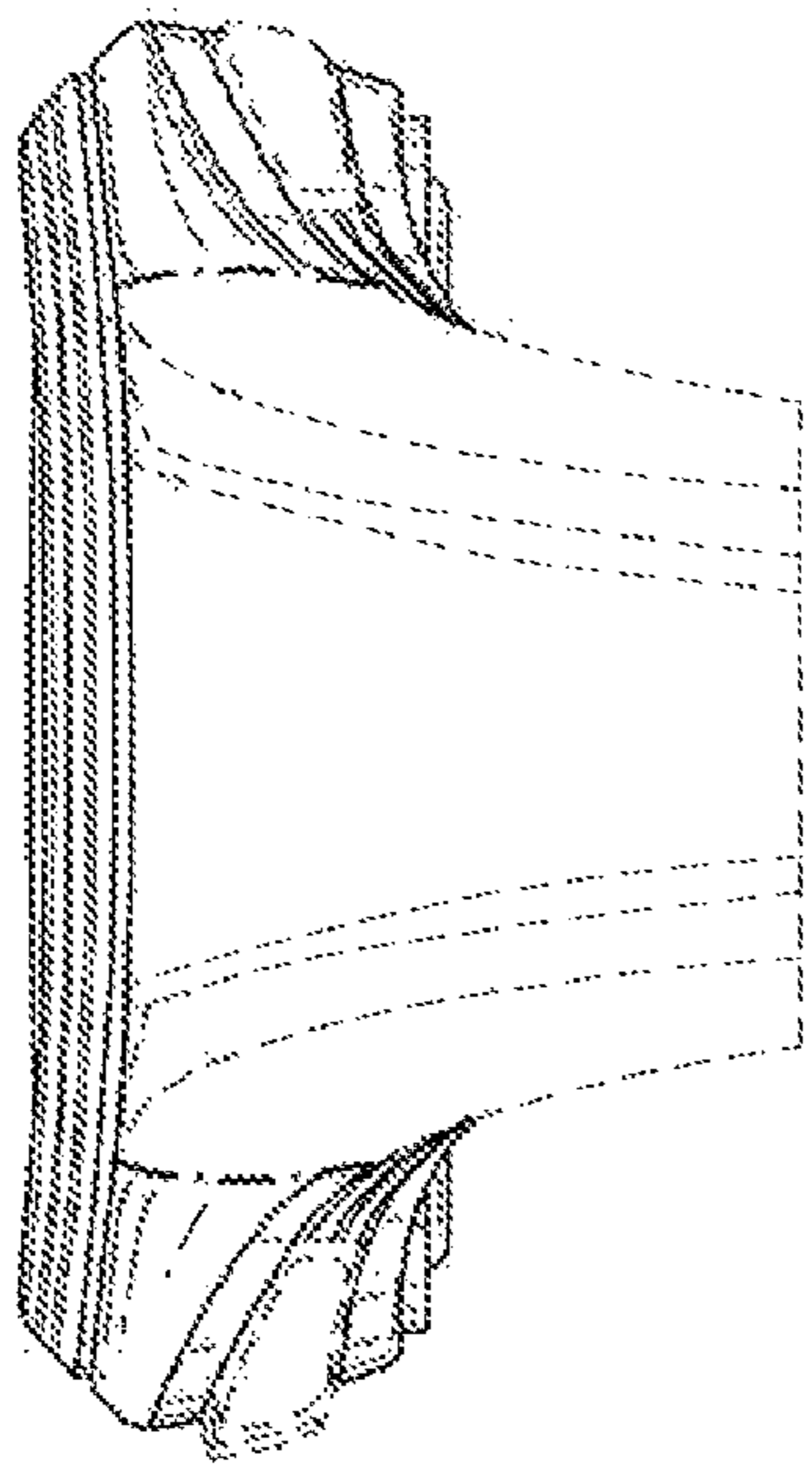

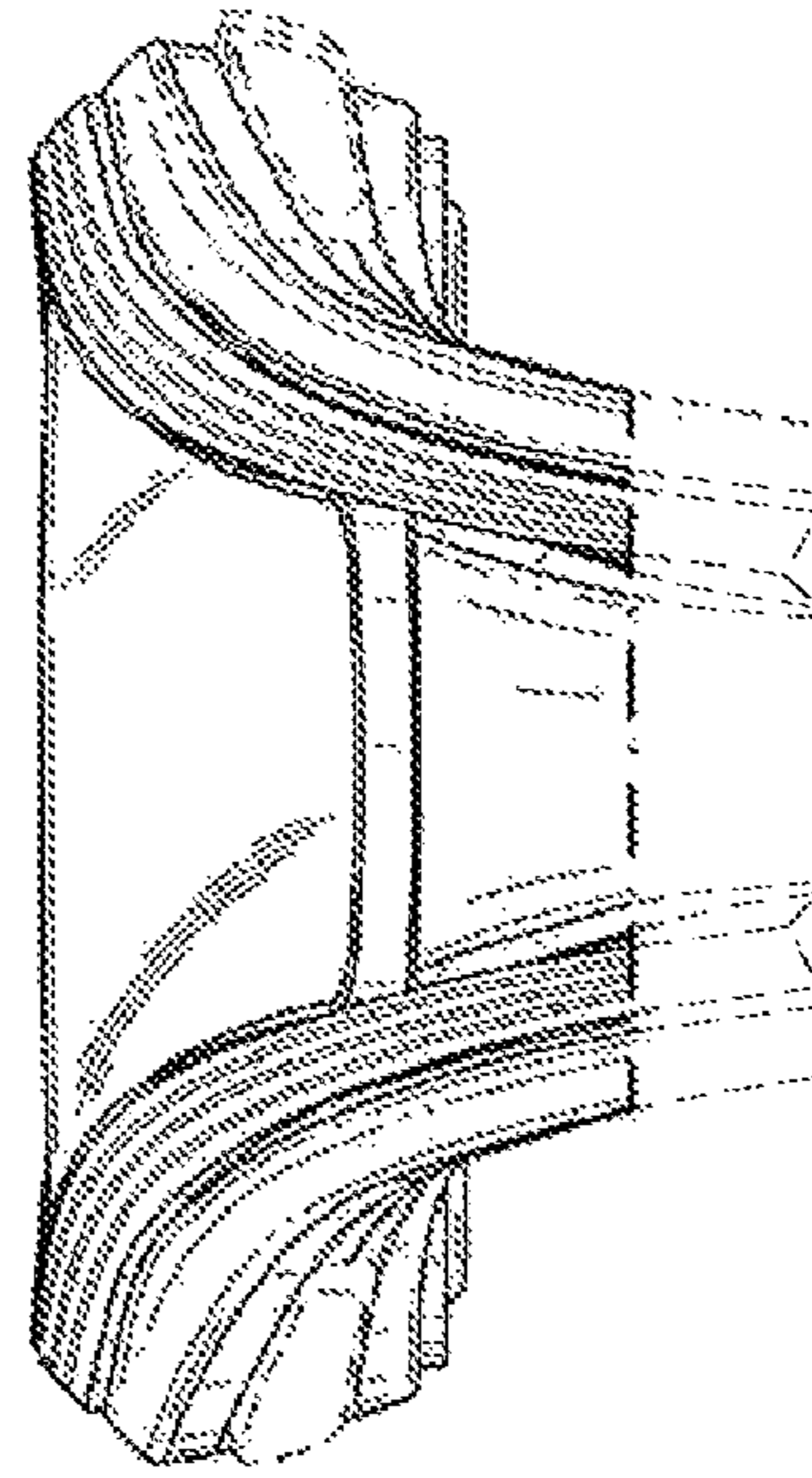

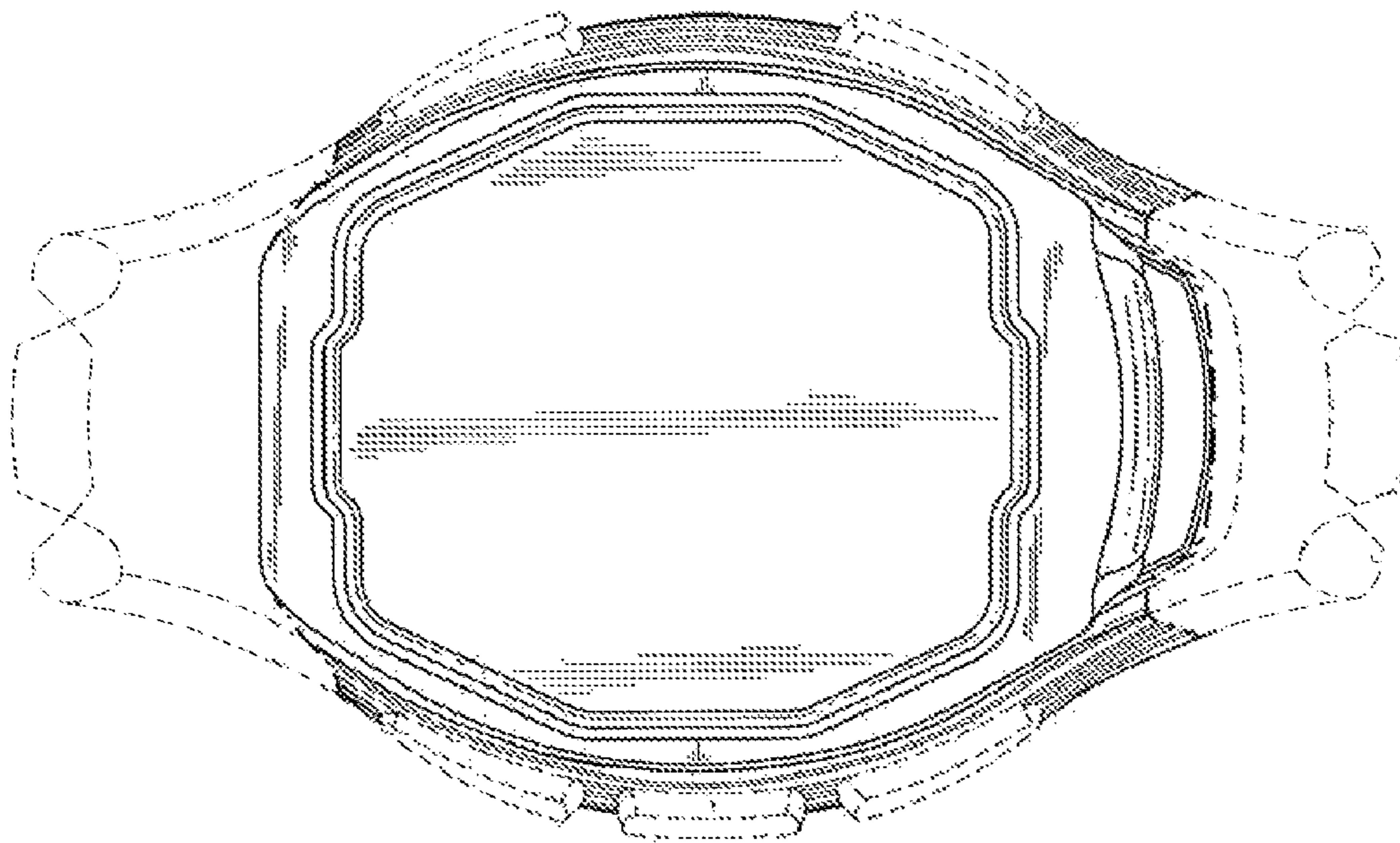

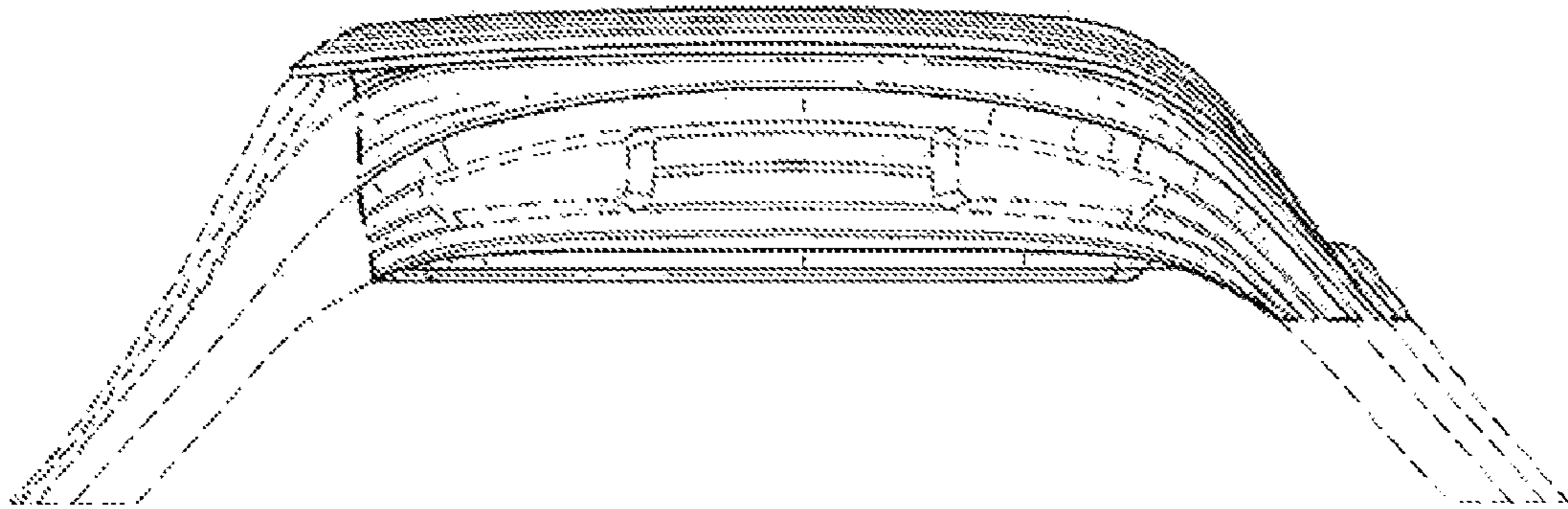

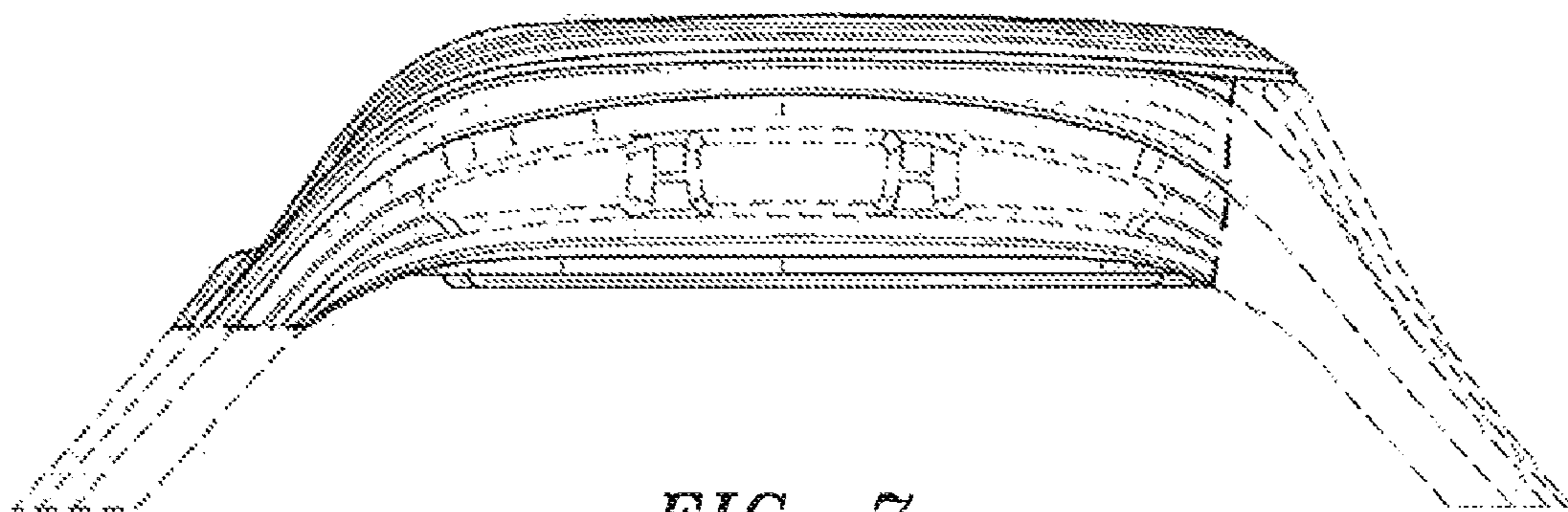
