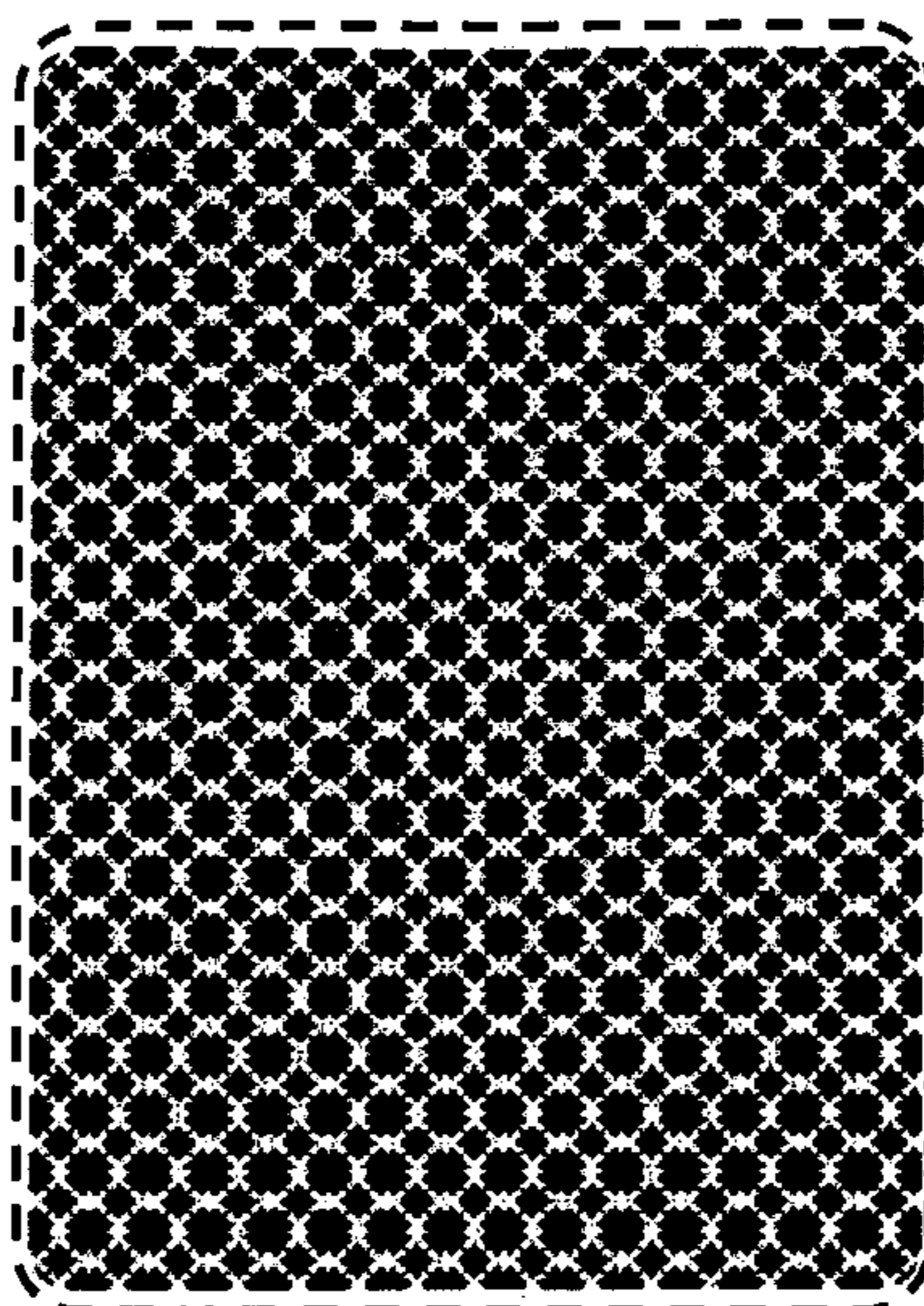
CLAIM

The sole FIGURE is a front view of the playing card showing my new design, the broken line showing of the edge is for illustrative purposes only, and forms no part of the claimed design.

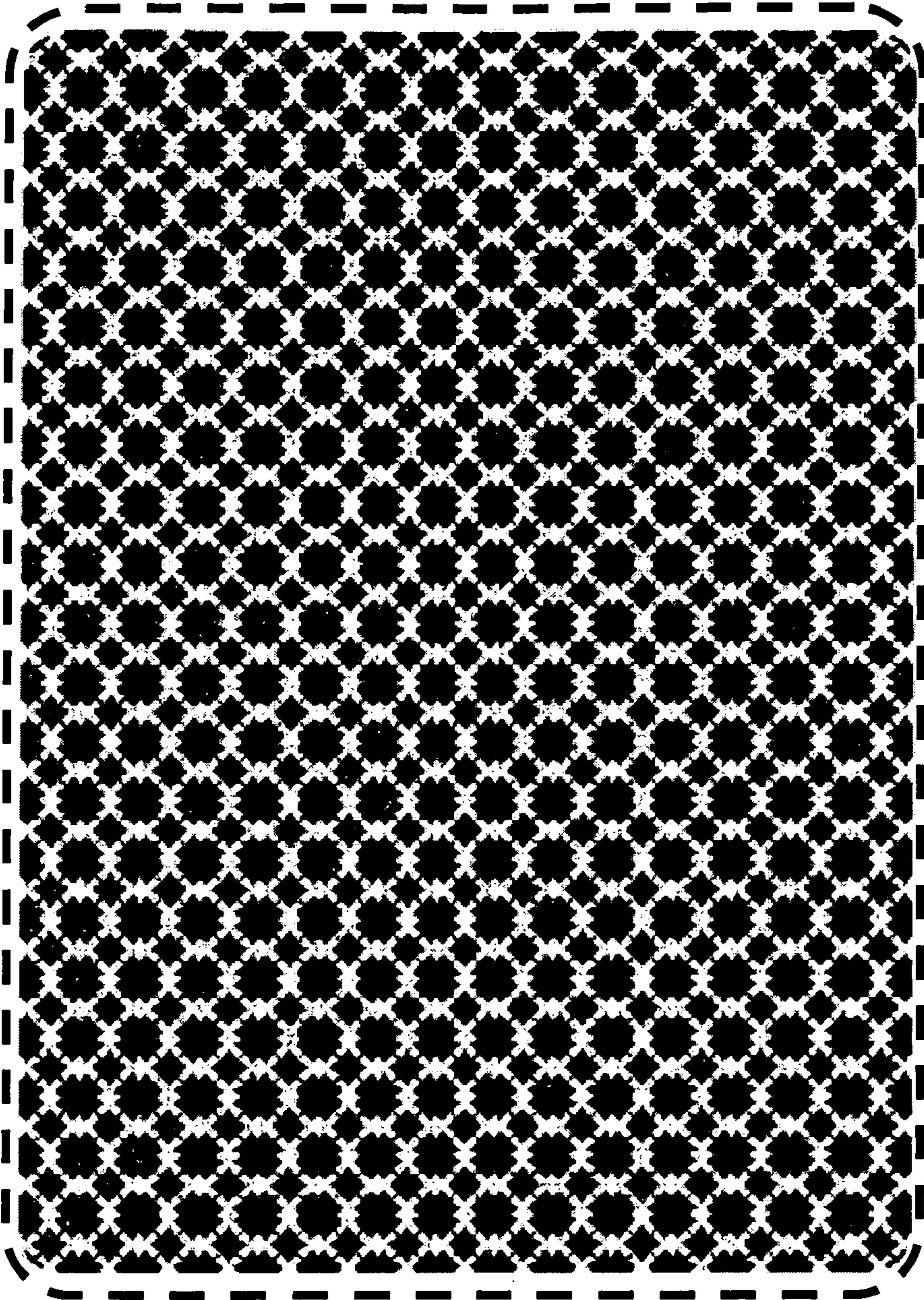
