FIG. 1 is a perspective view of a toy car racing track embodying my is new design;

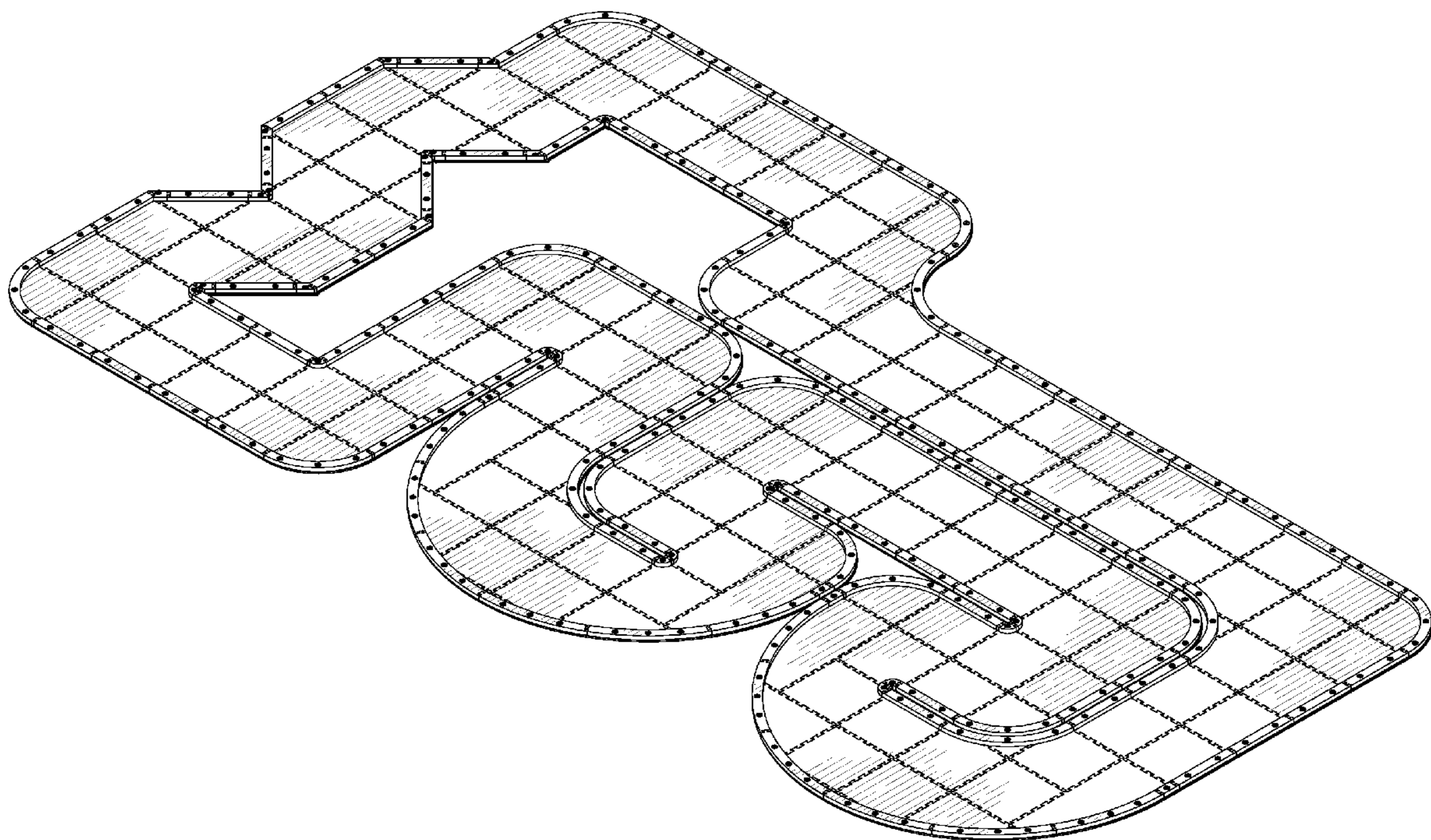
FIG. 2 is a top plan view thereof;

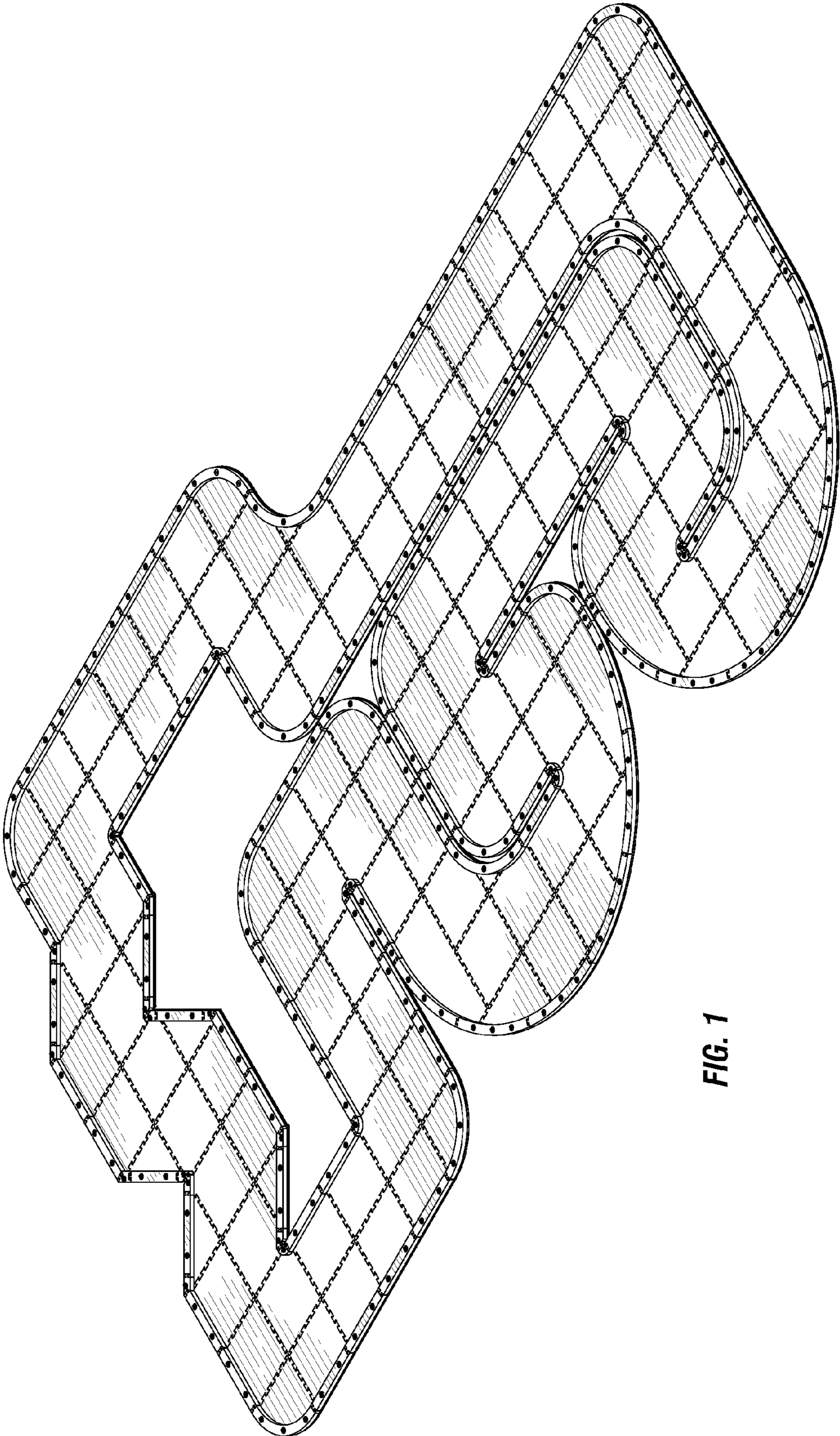

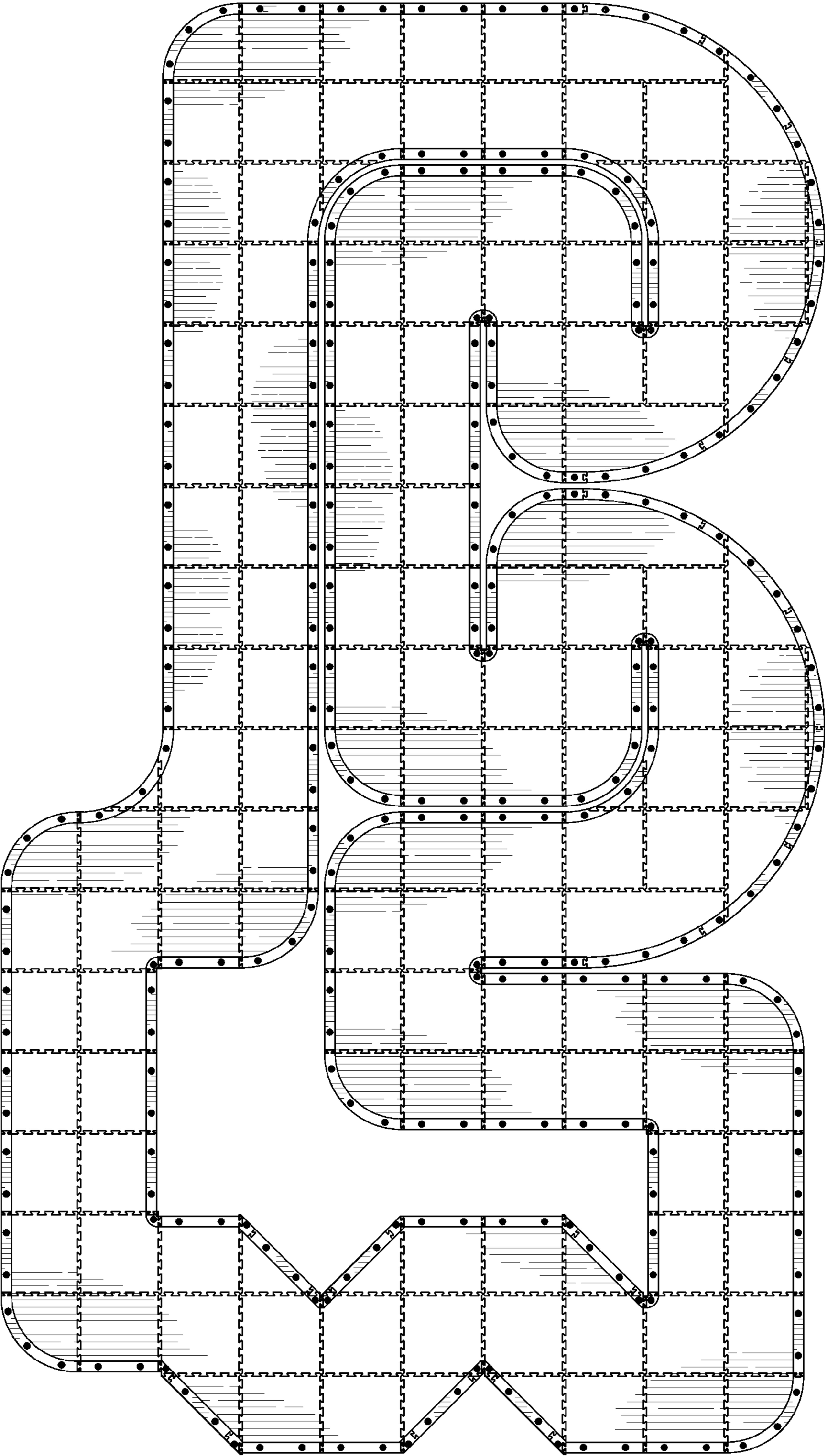

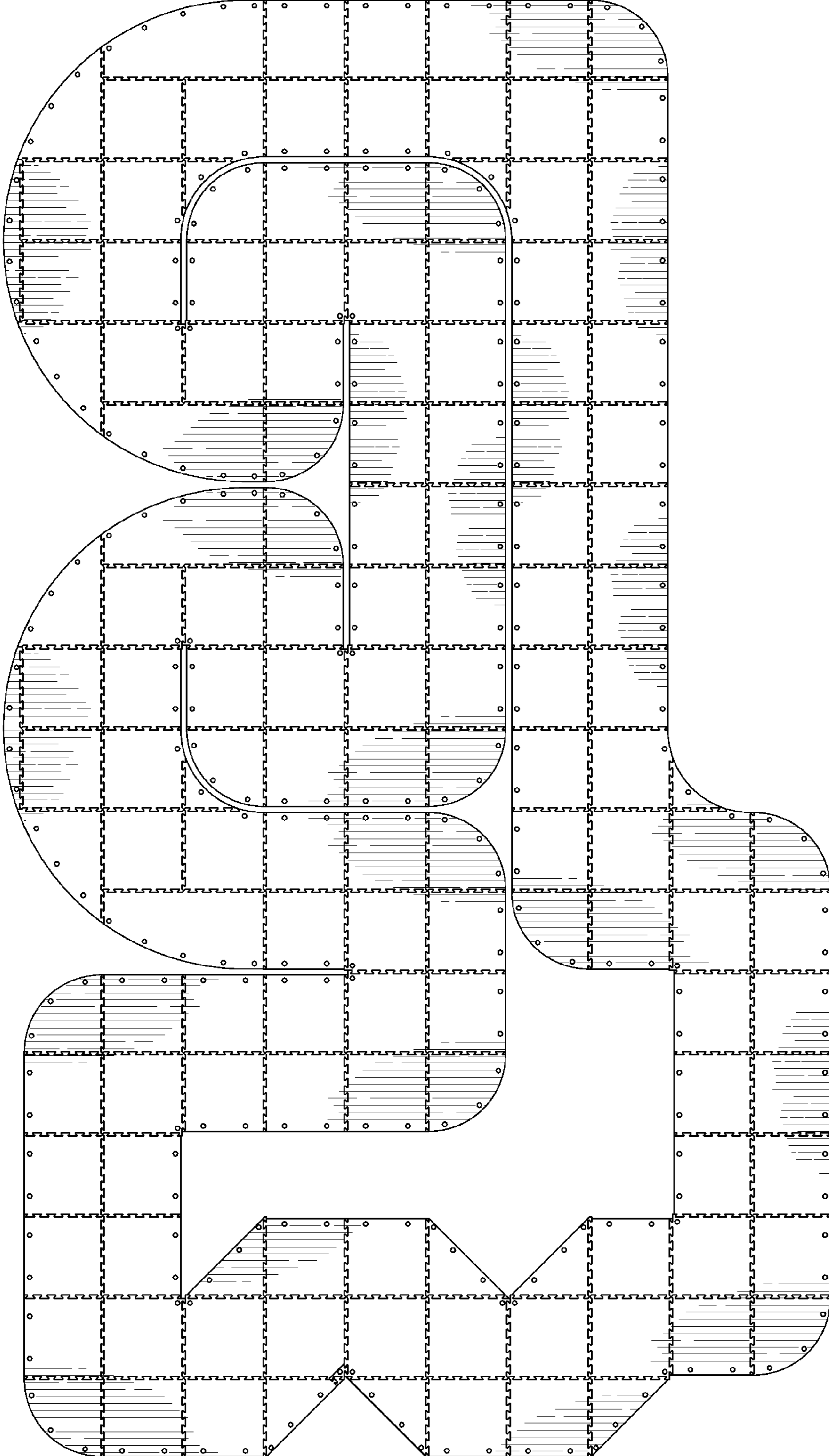
