What is claimed is the ornamental design for a filter frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a filter frame, showing the new design;

FIG. 4 is a rear elevational view thereof;

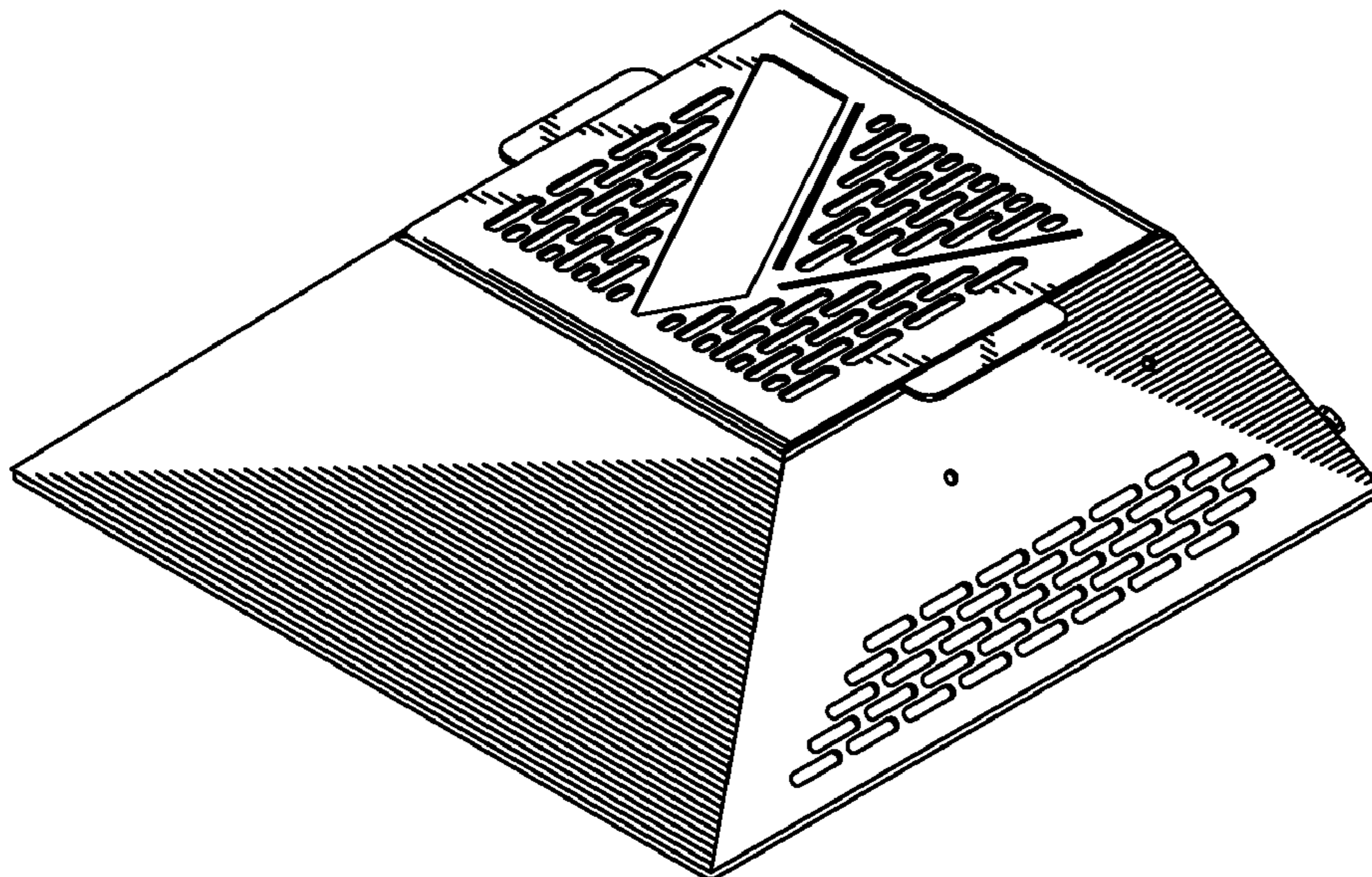
FIG. 5 is a right-side elevational view thereof;

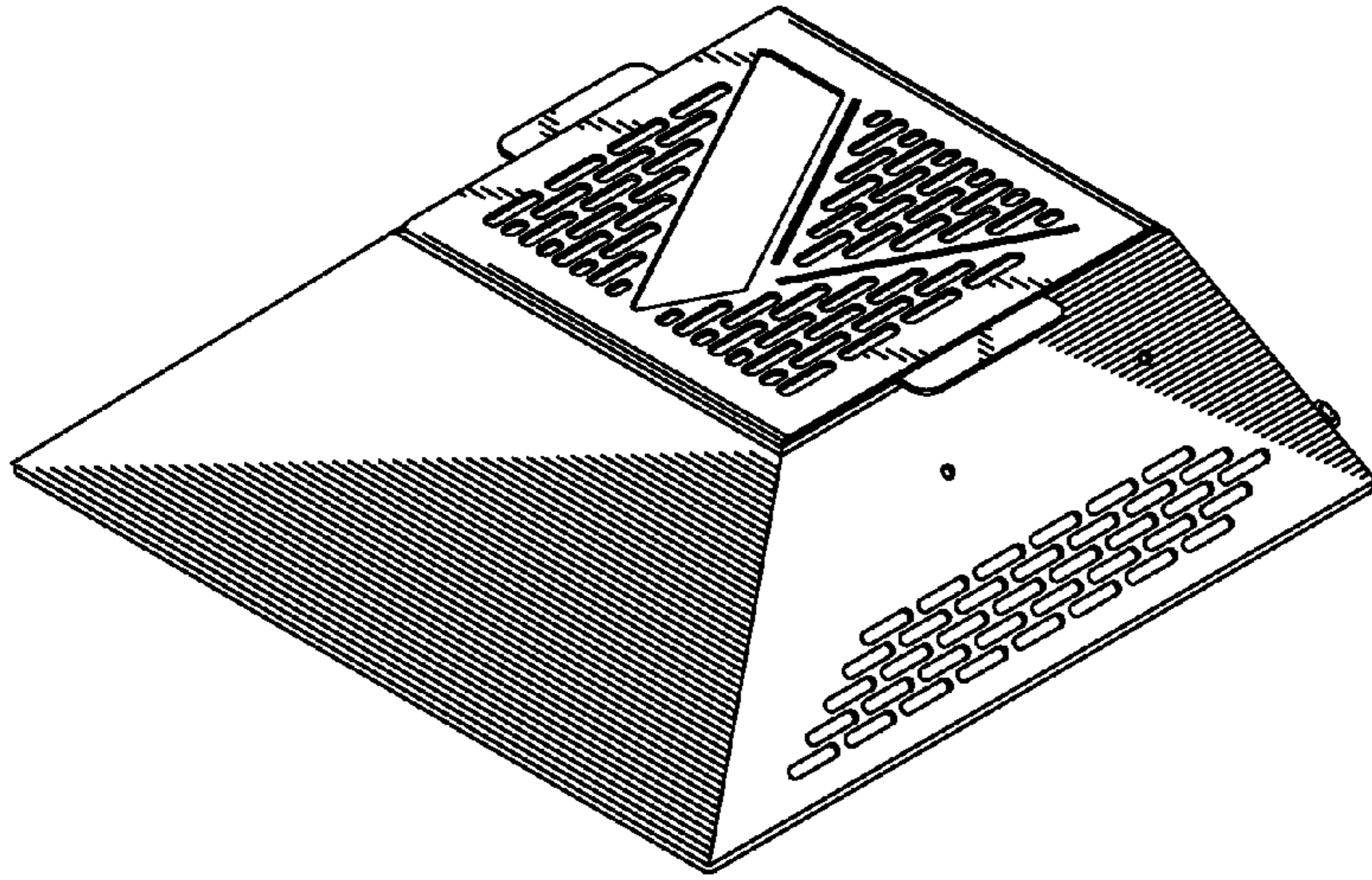
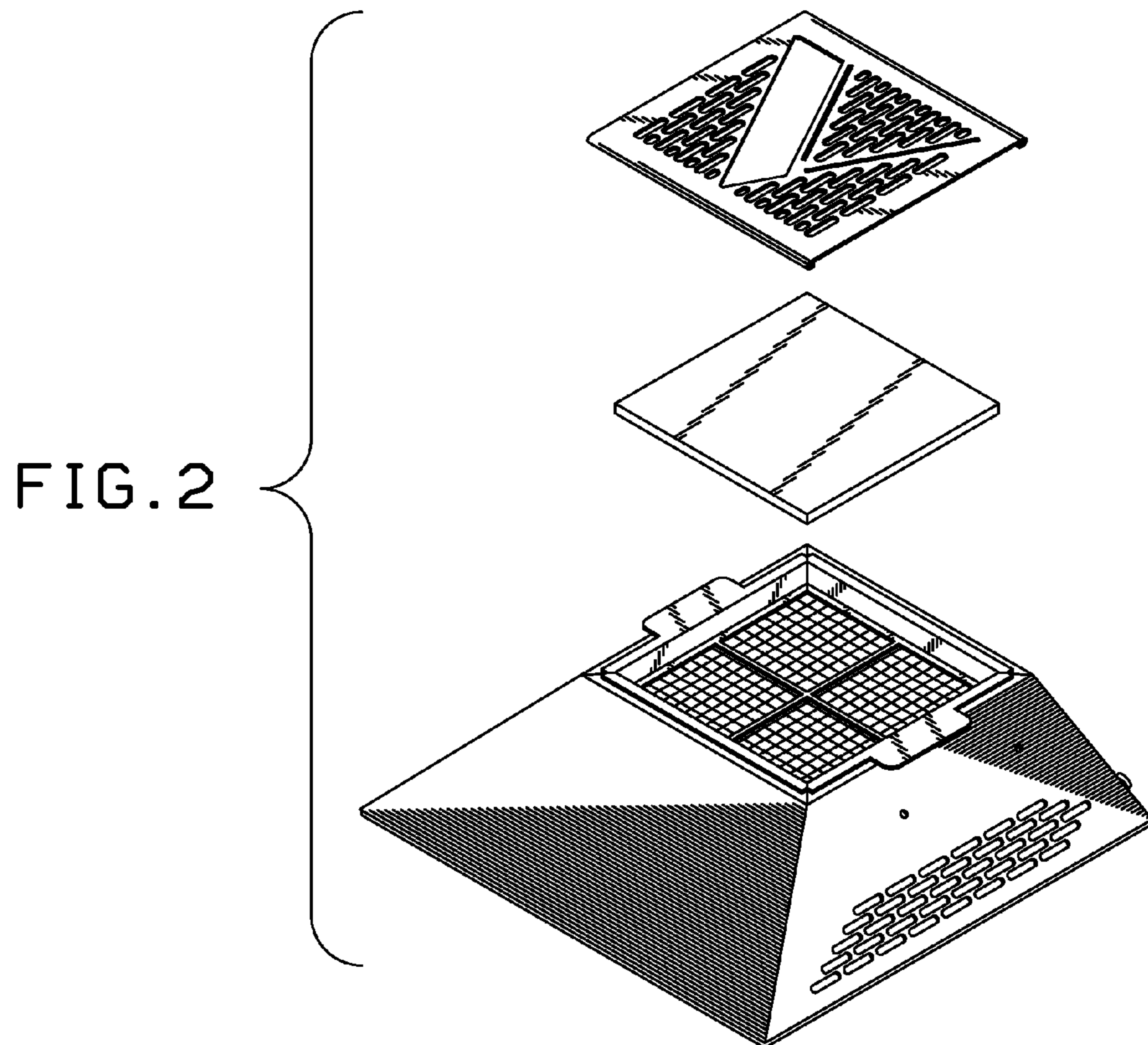

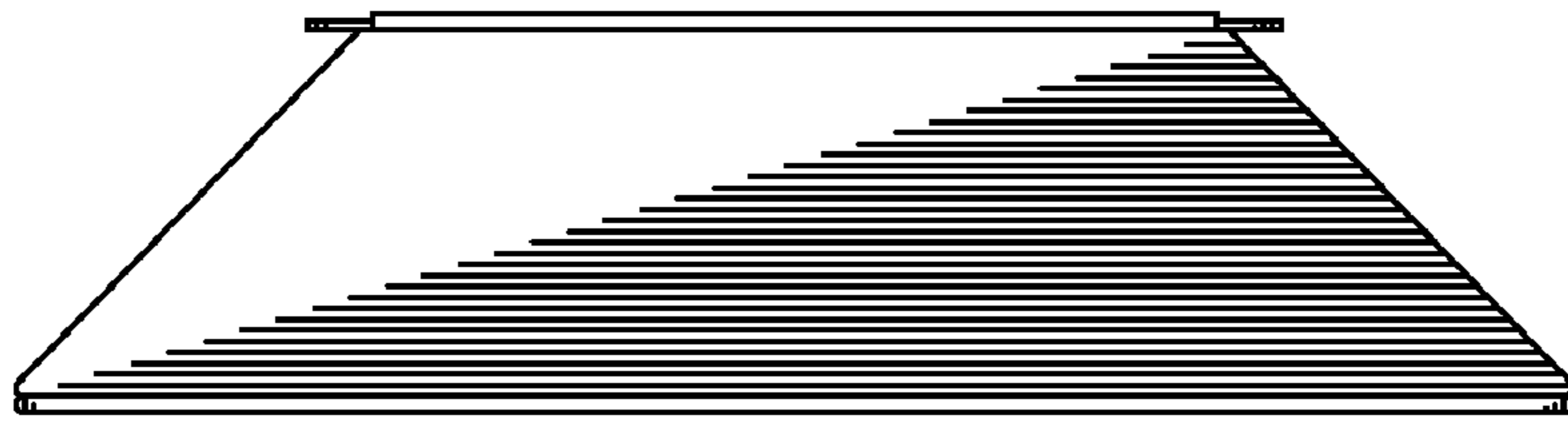

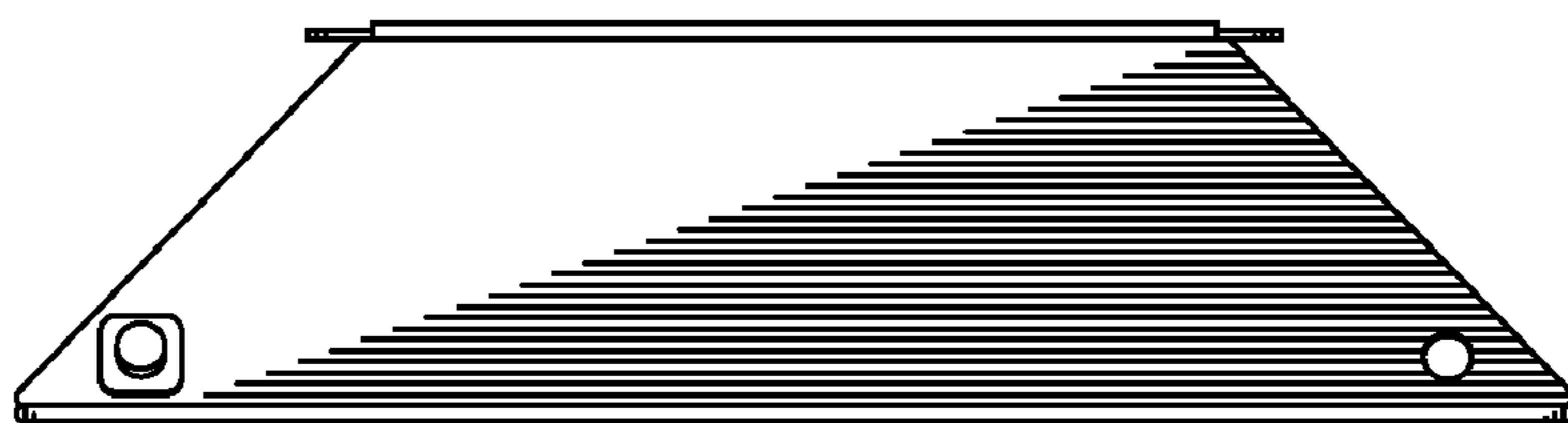

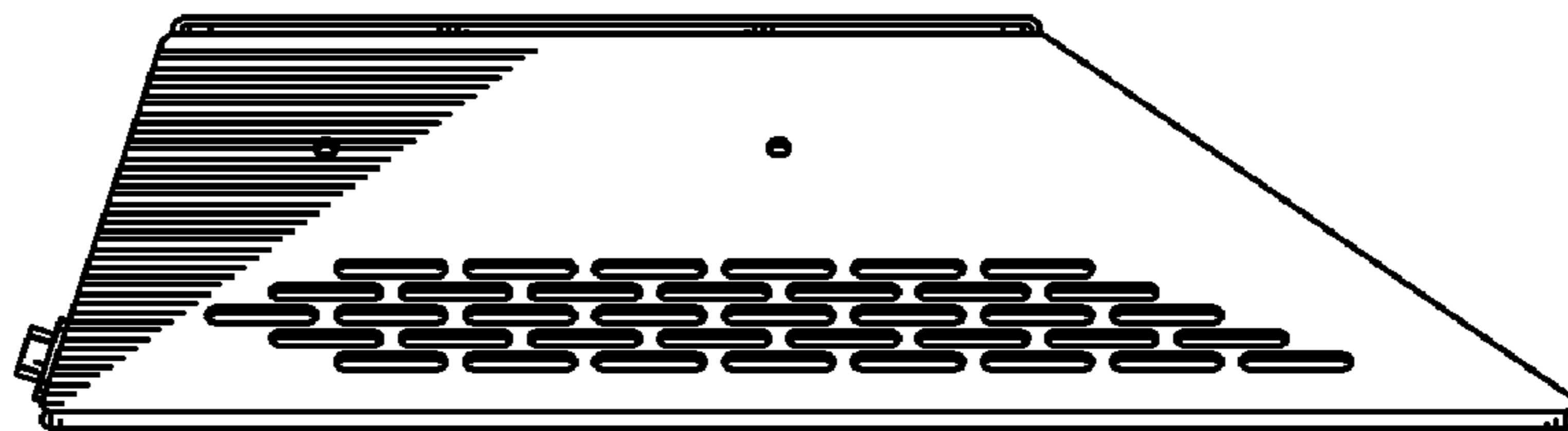

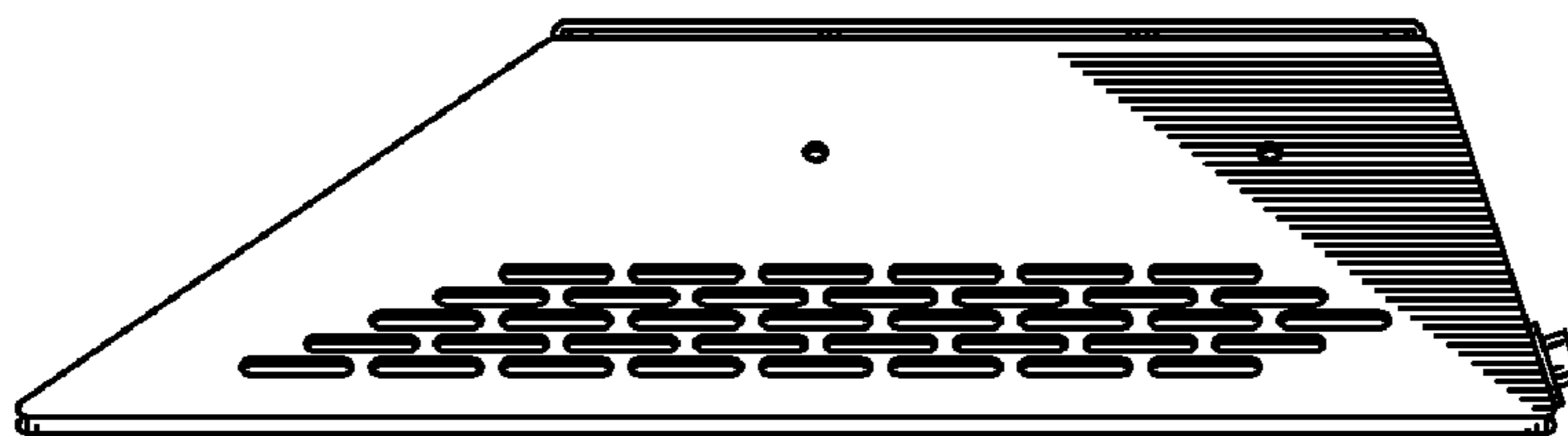

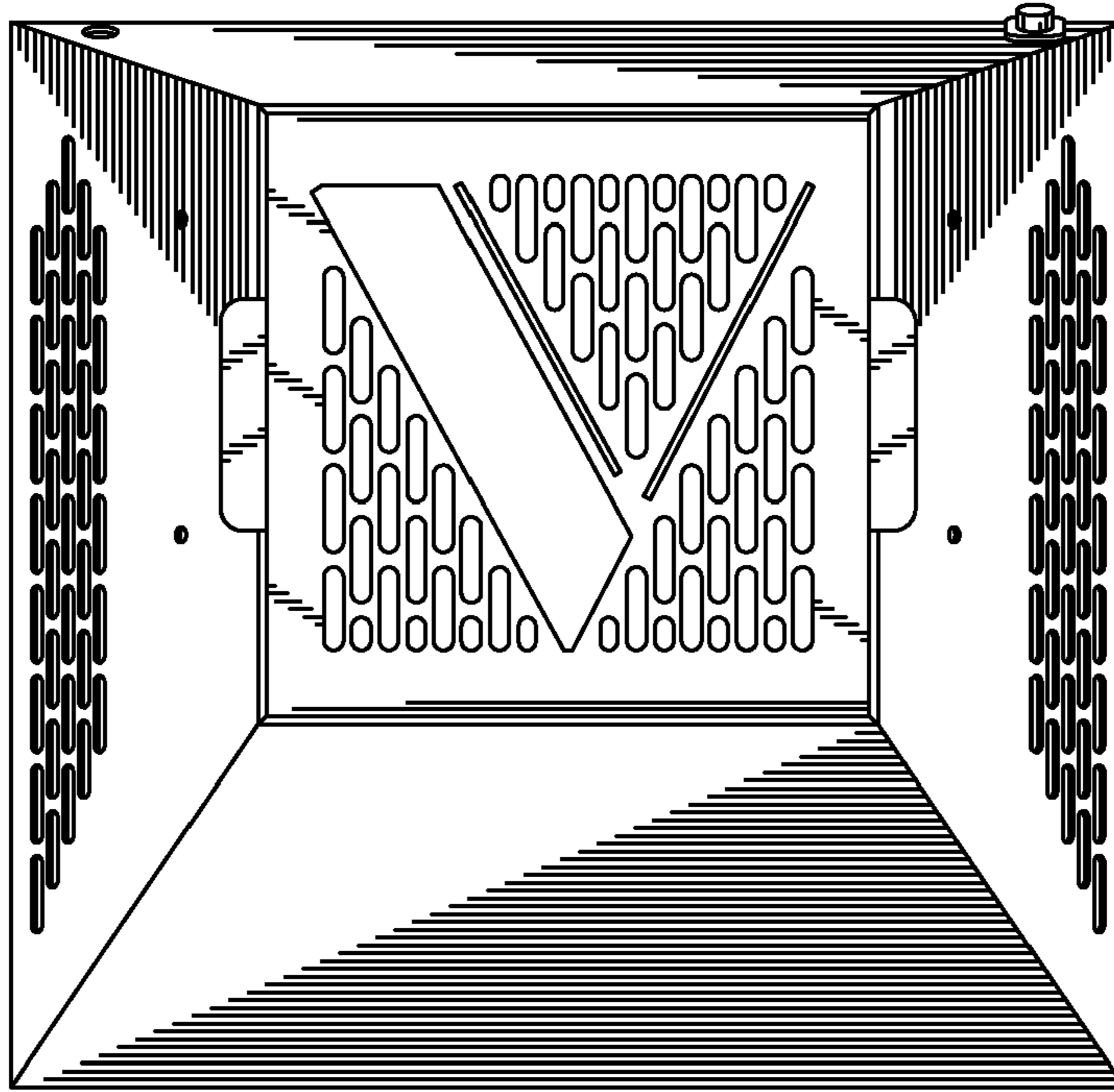

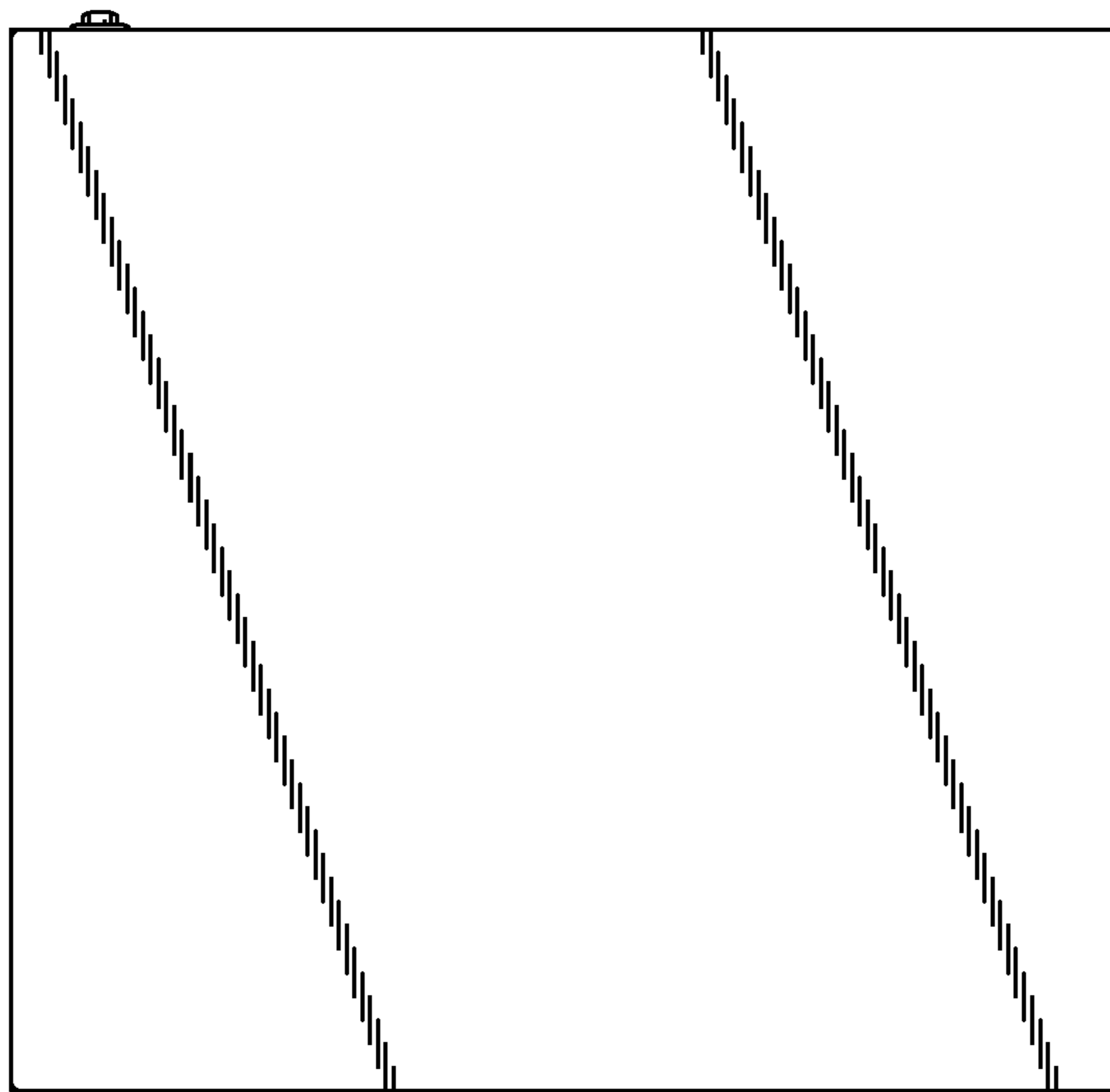
