FIG. 10 is a rear view of the second embodiment.

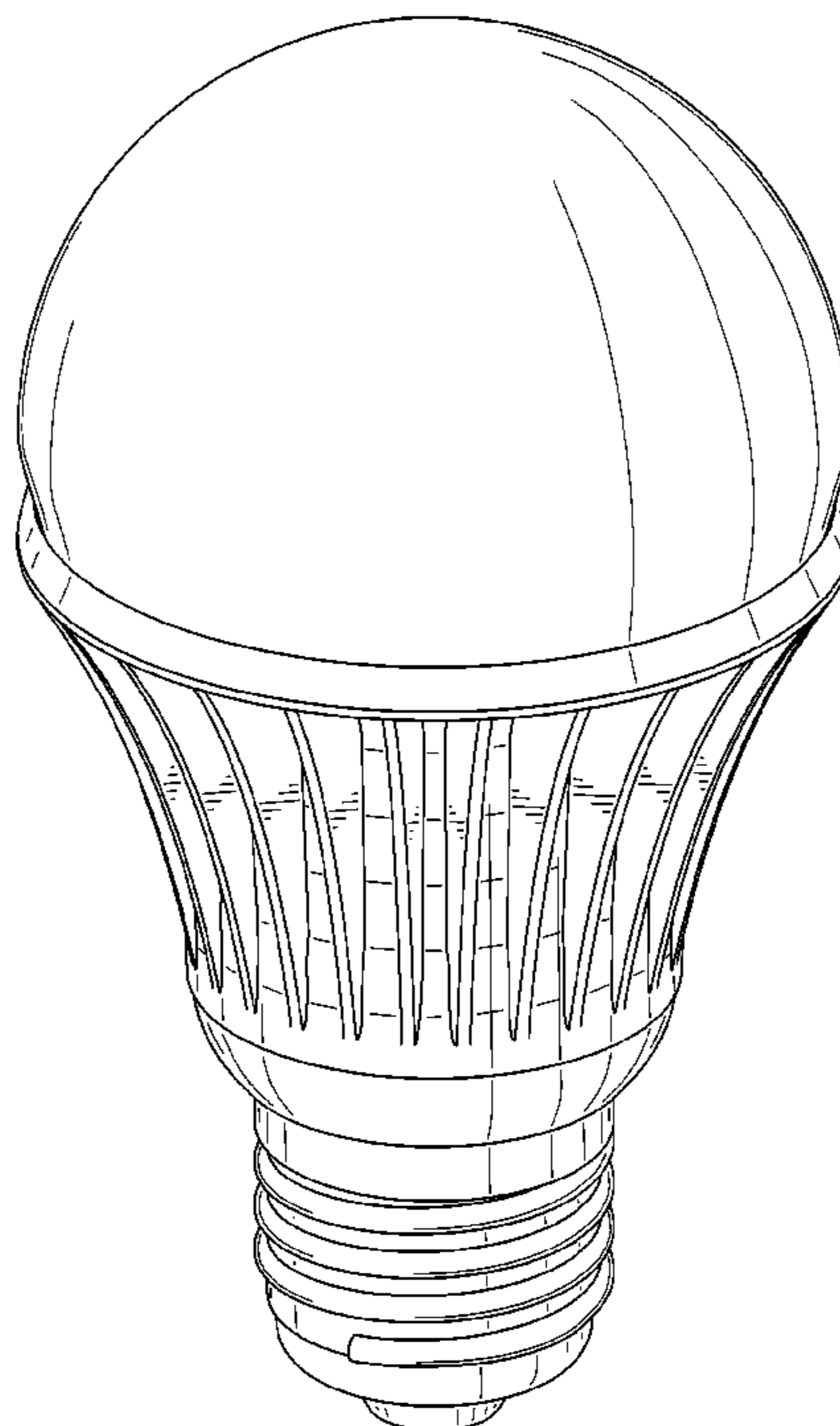
FIG. 11 is a left side view of the second embodiment.

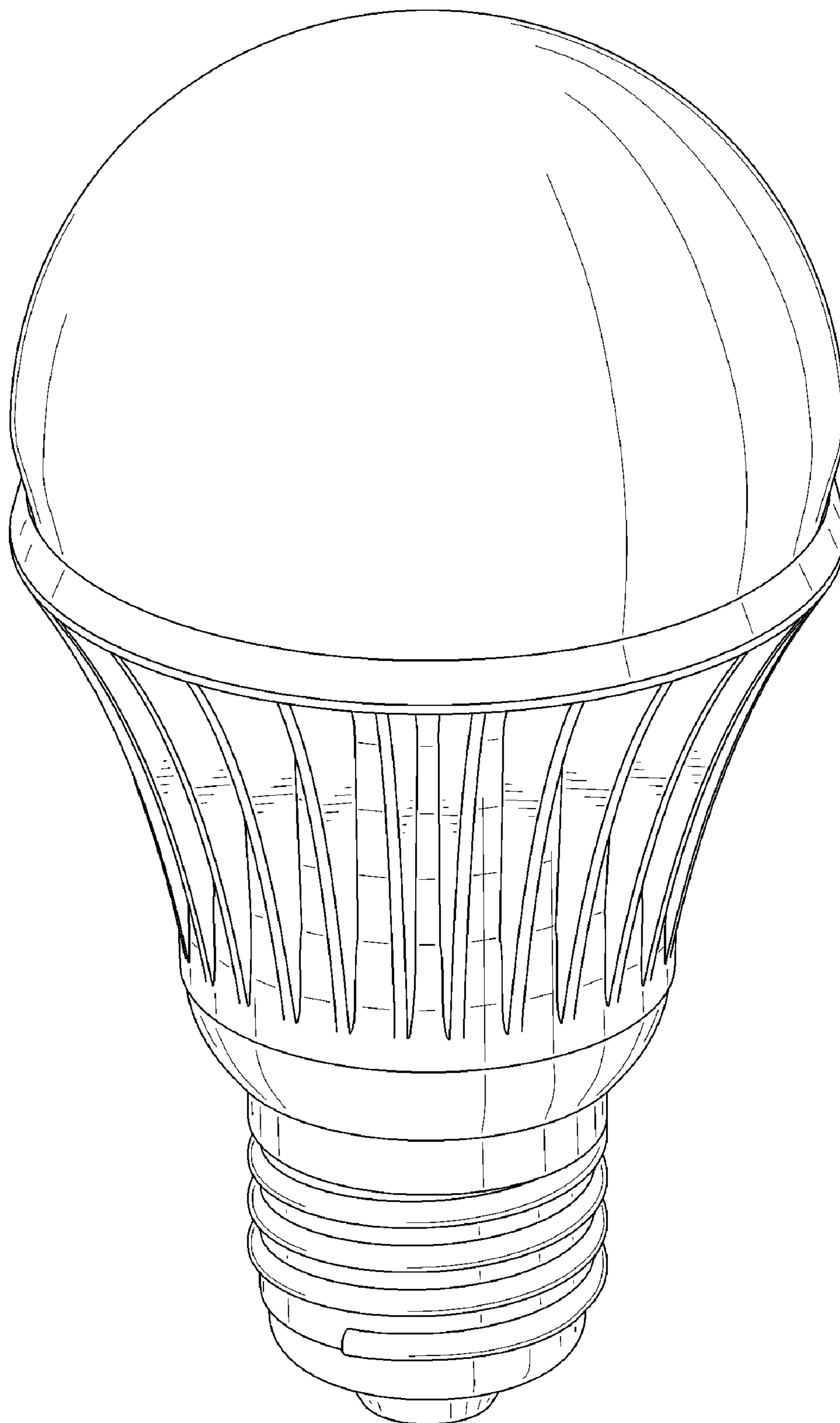

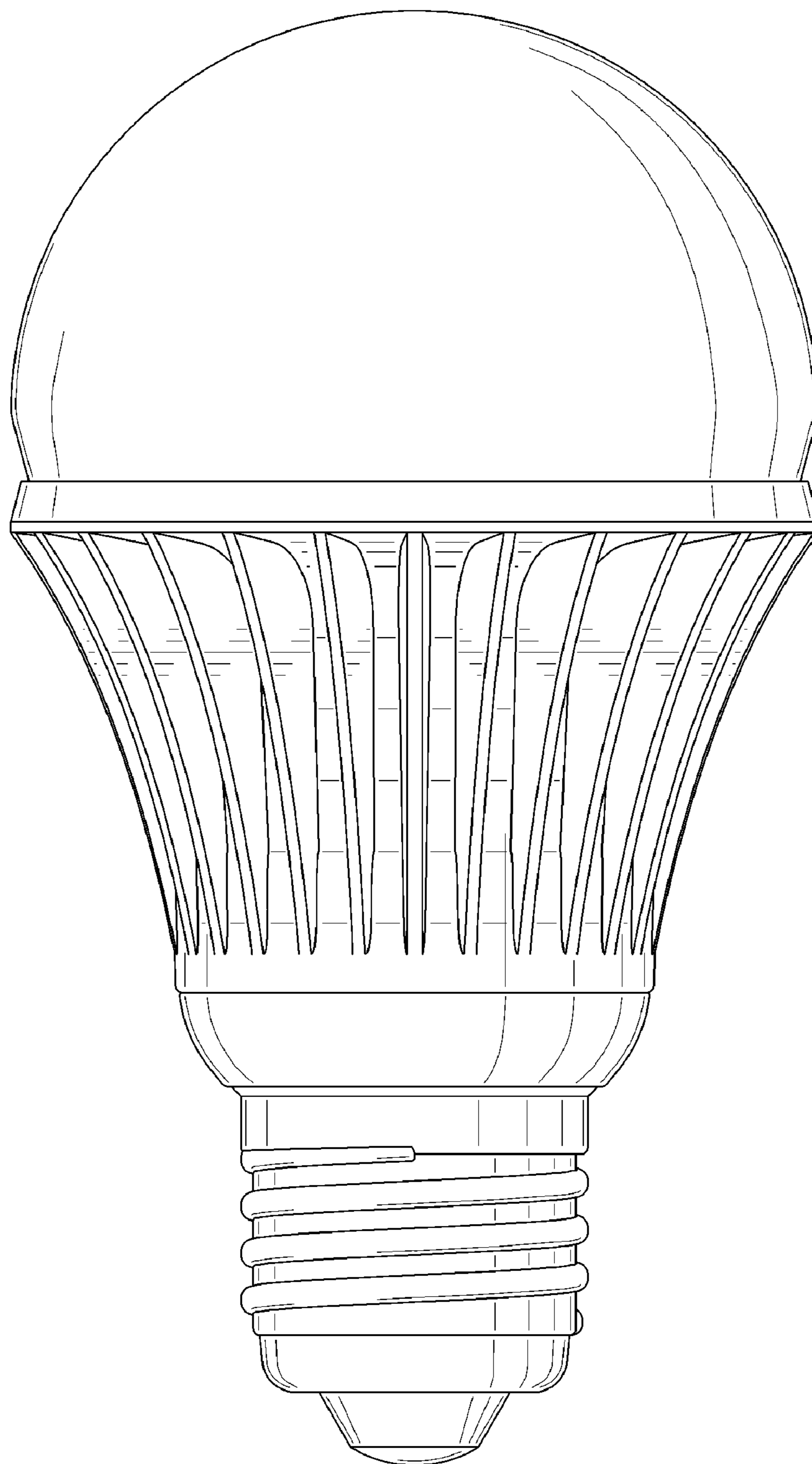

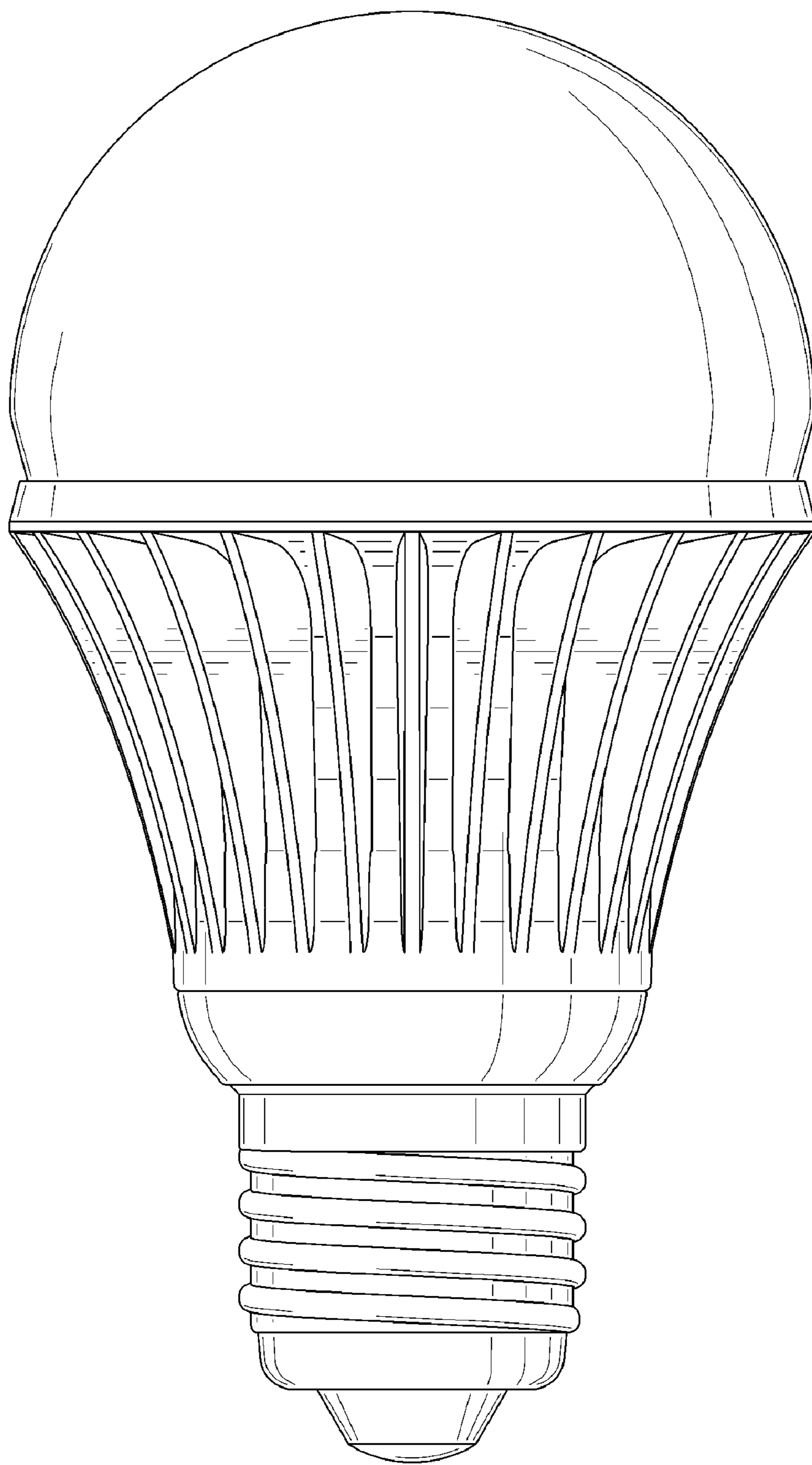

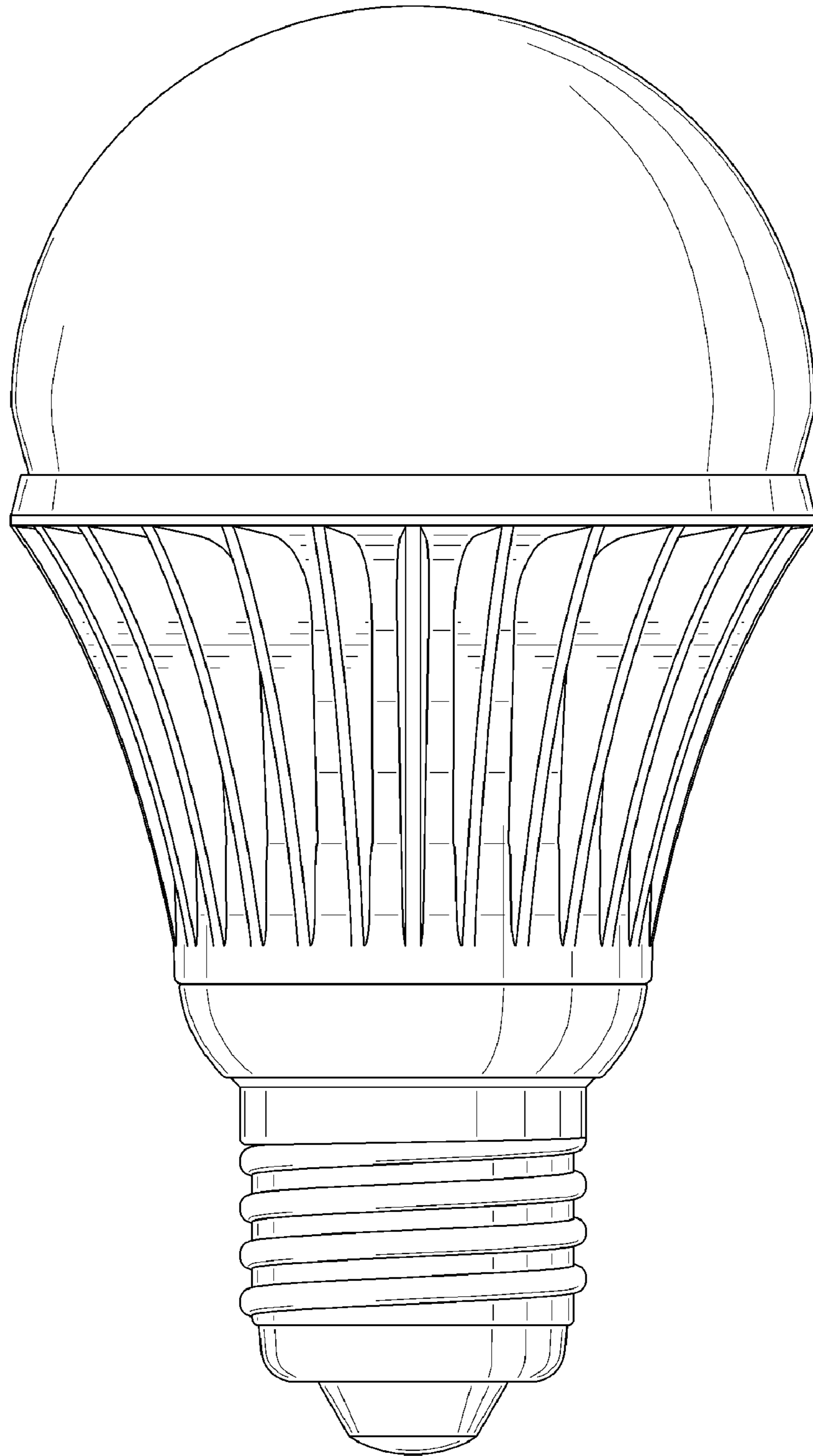

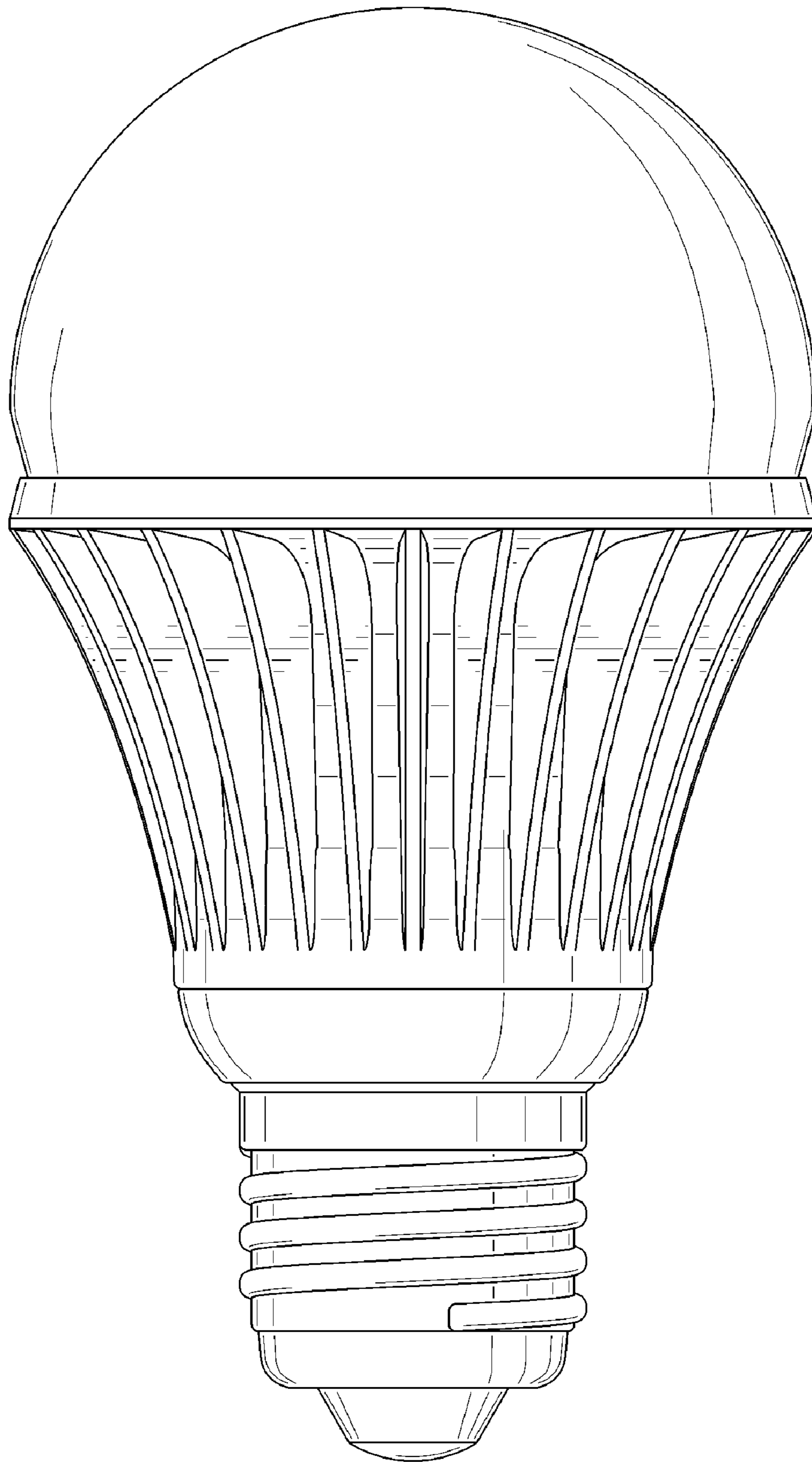

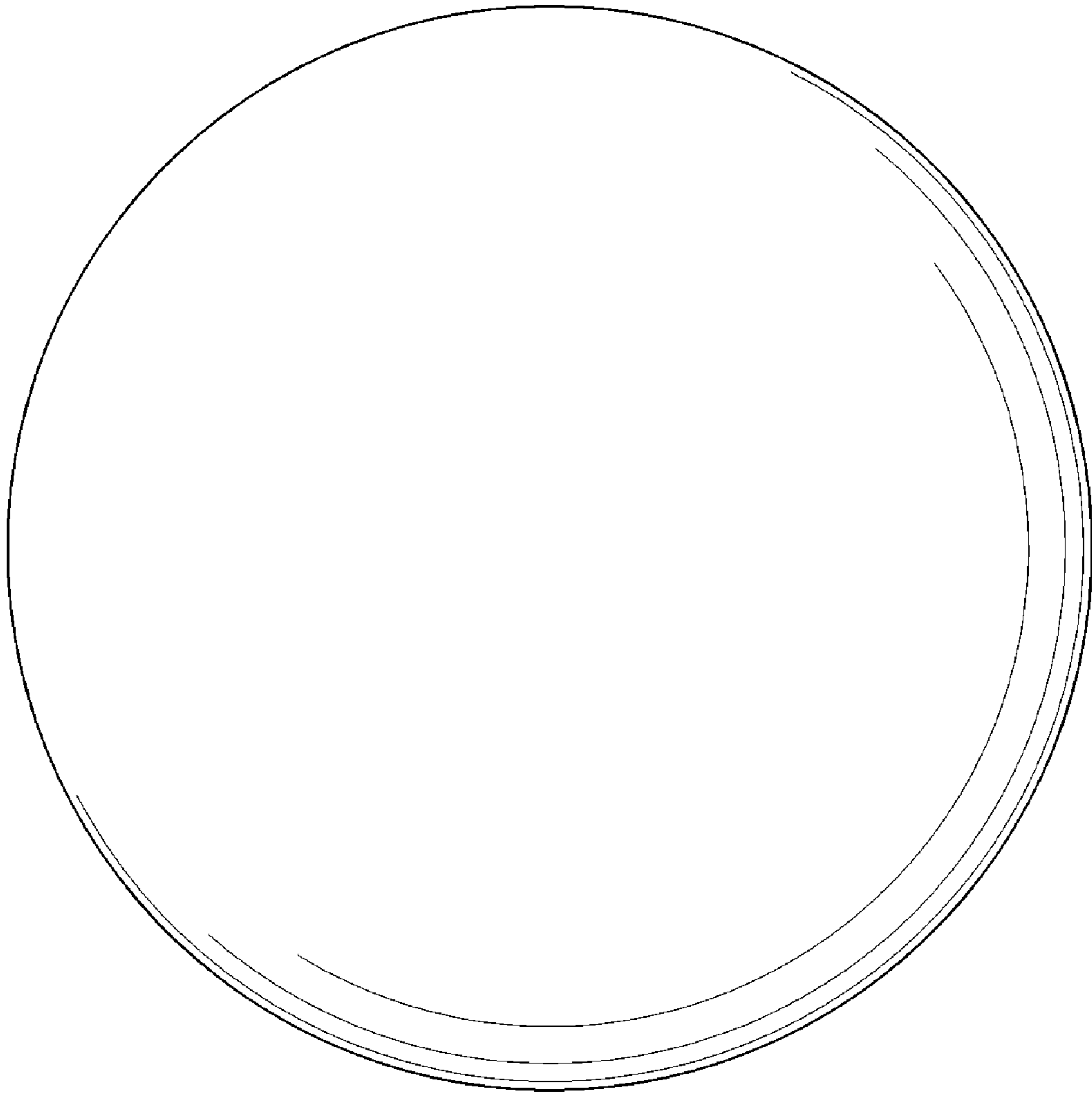

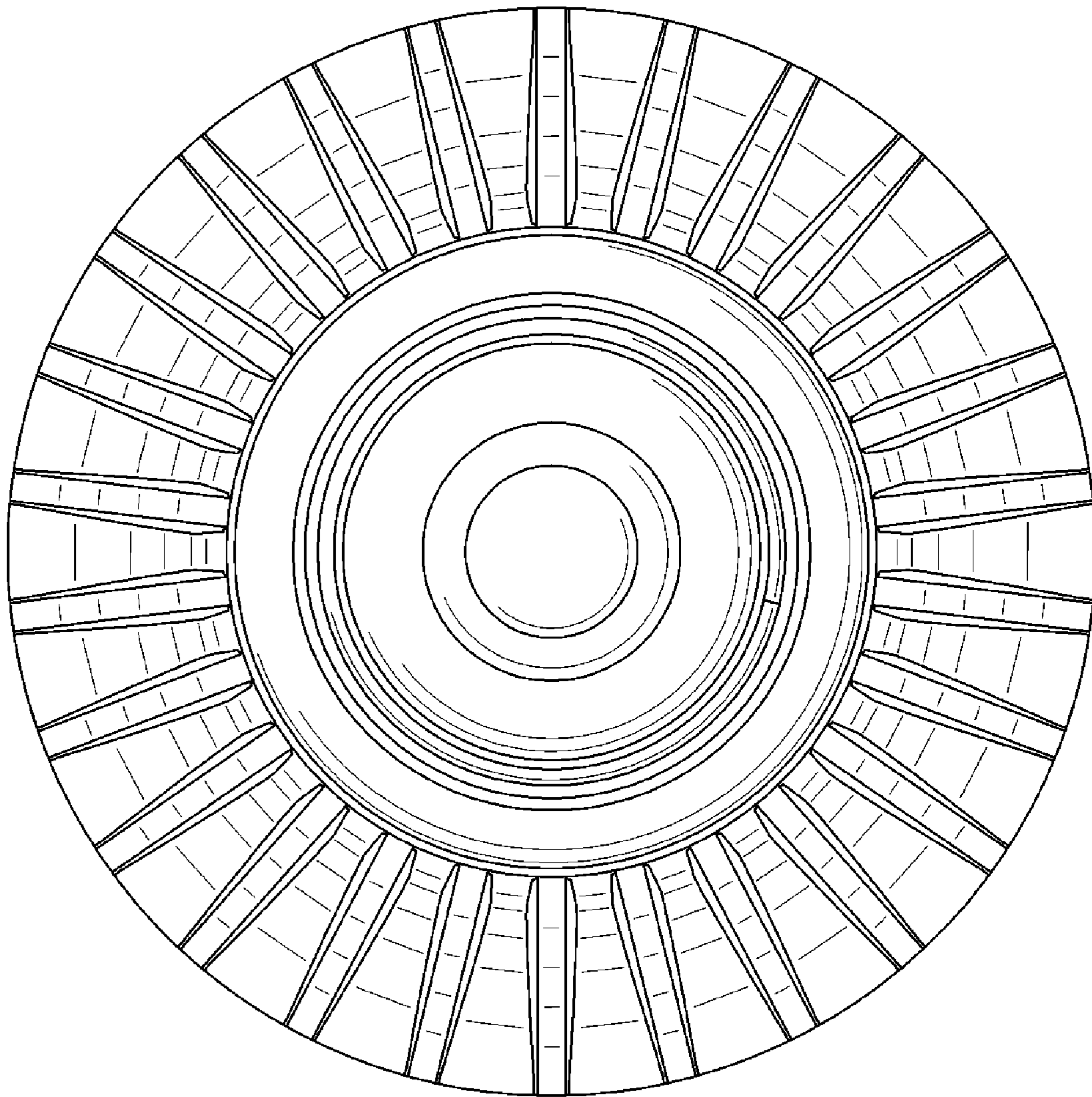

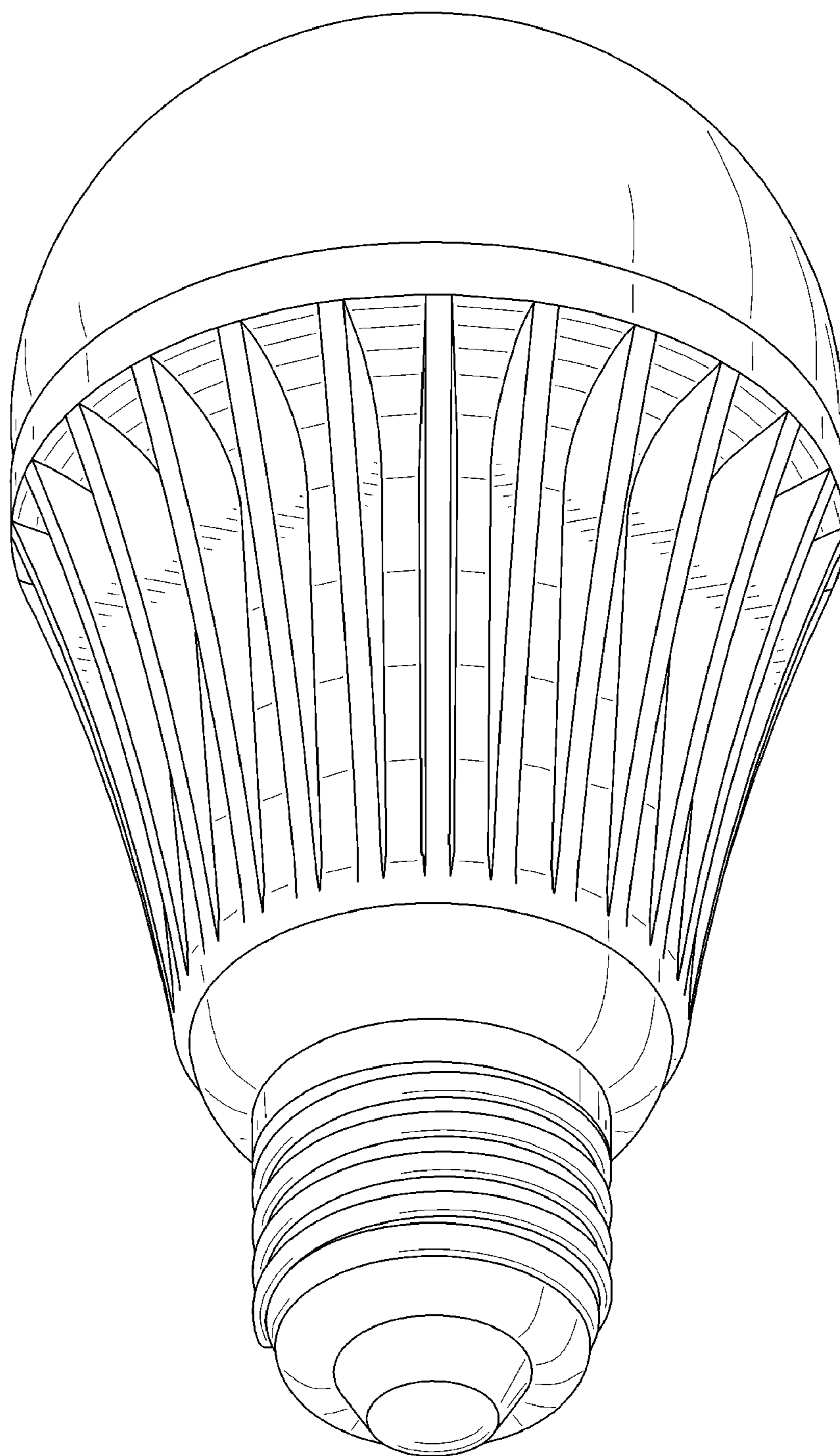

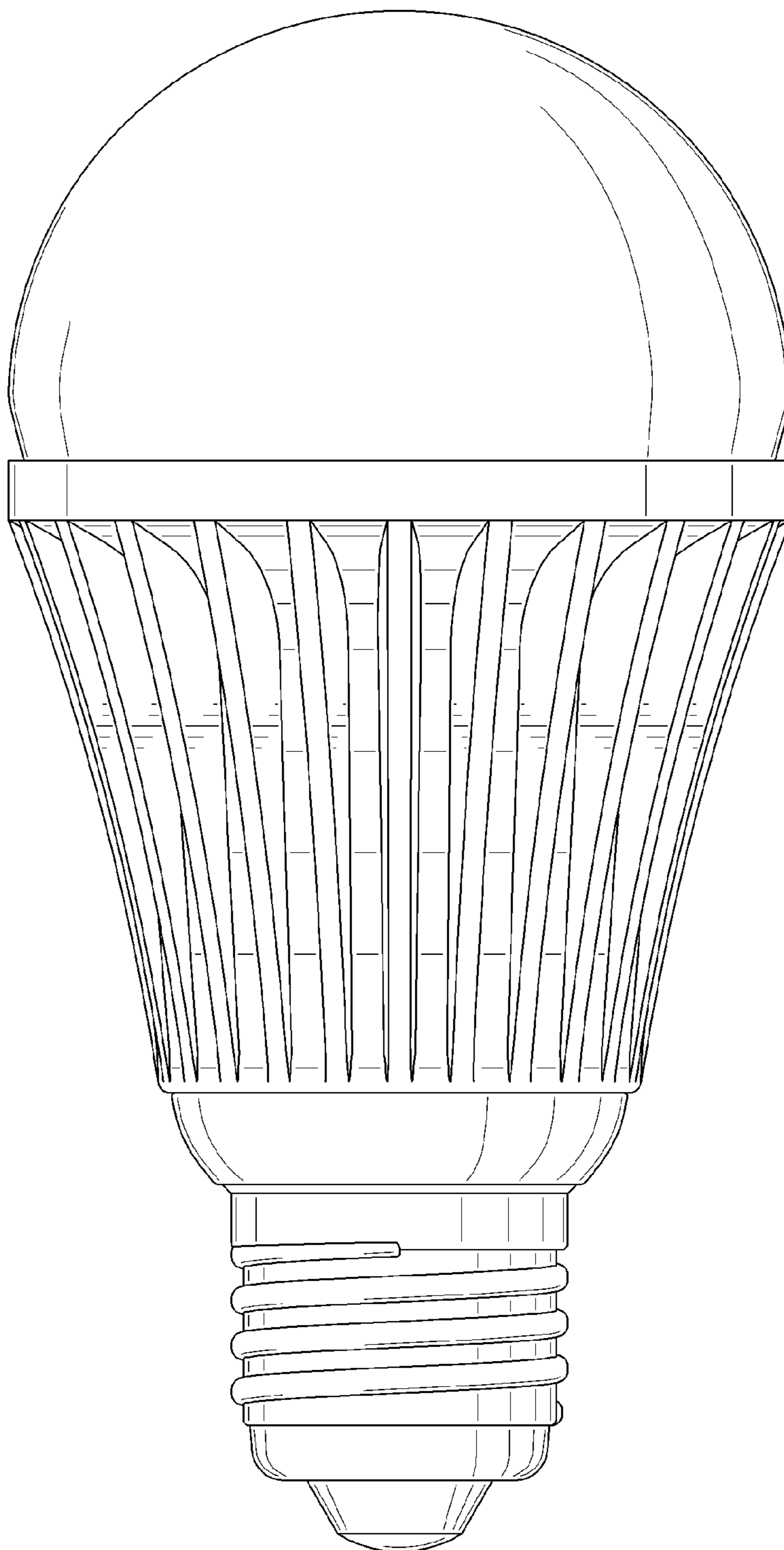

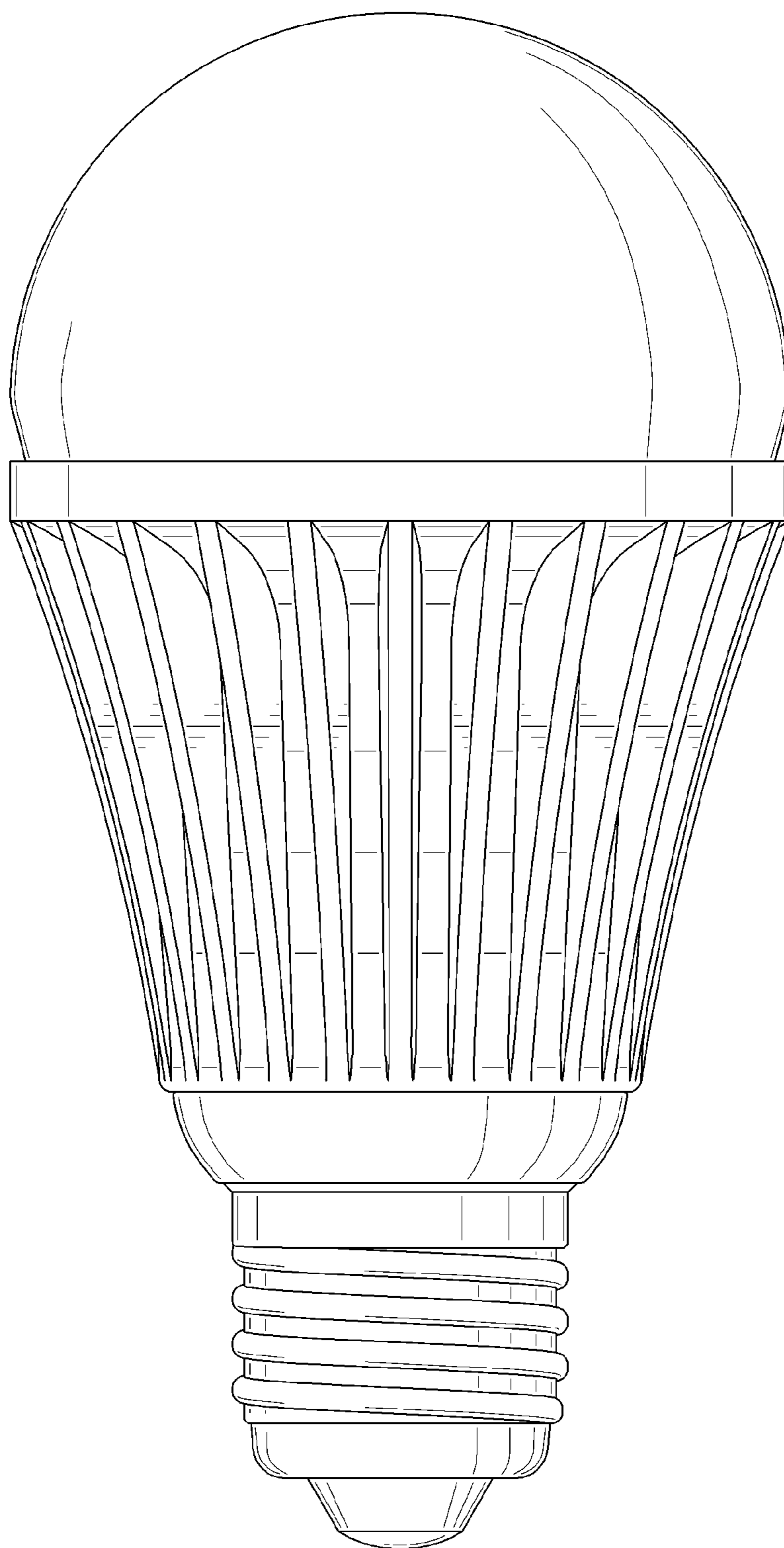

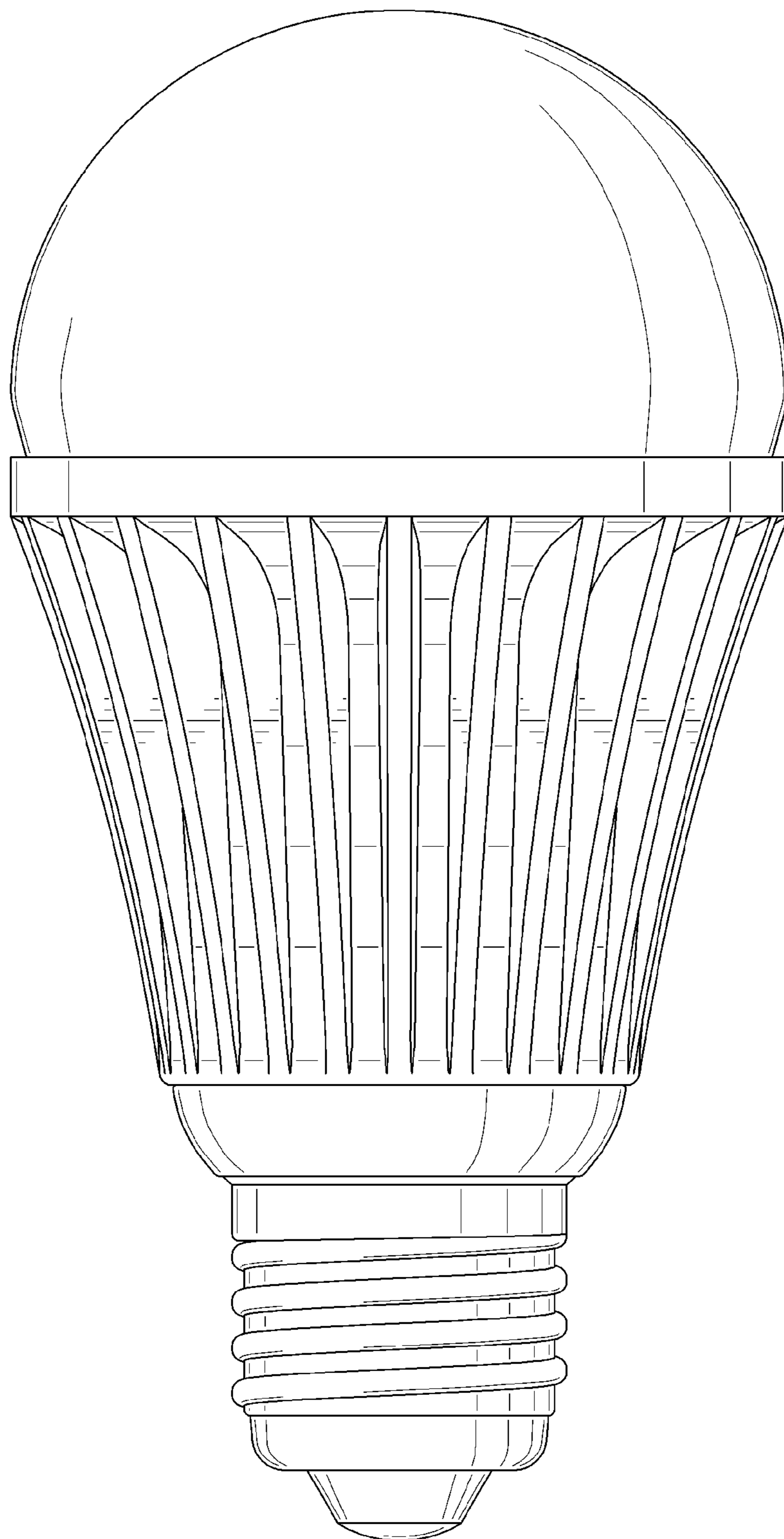

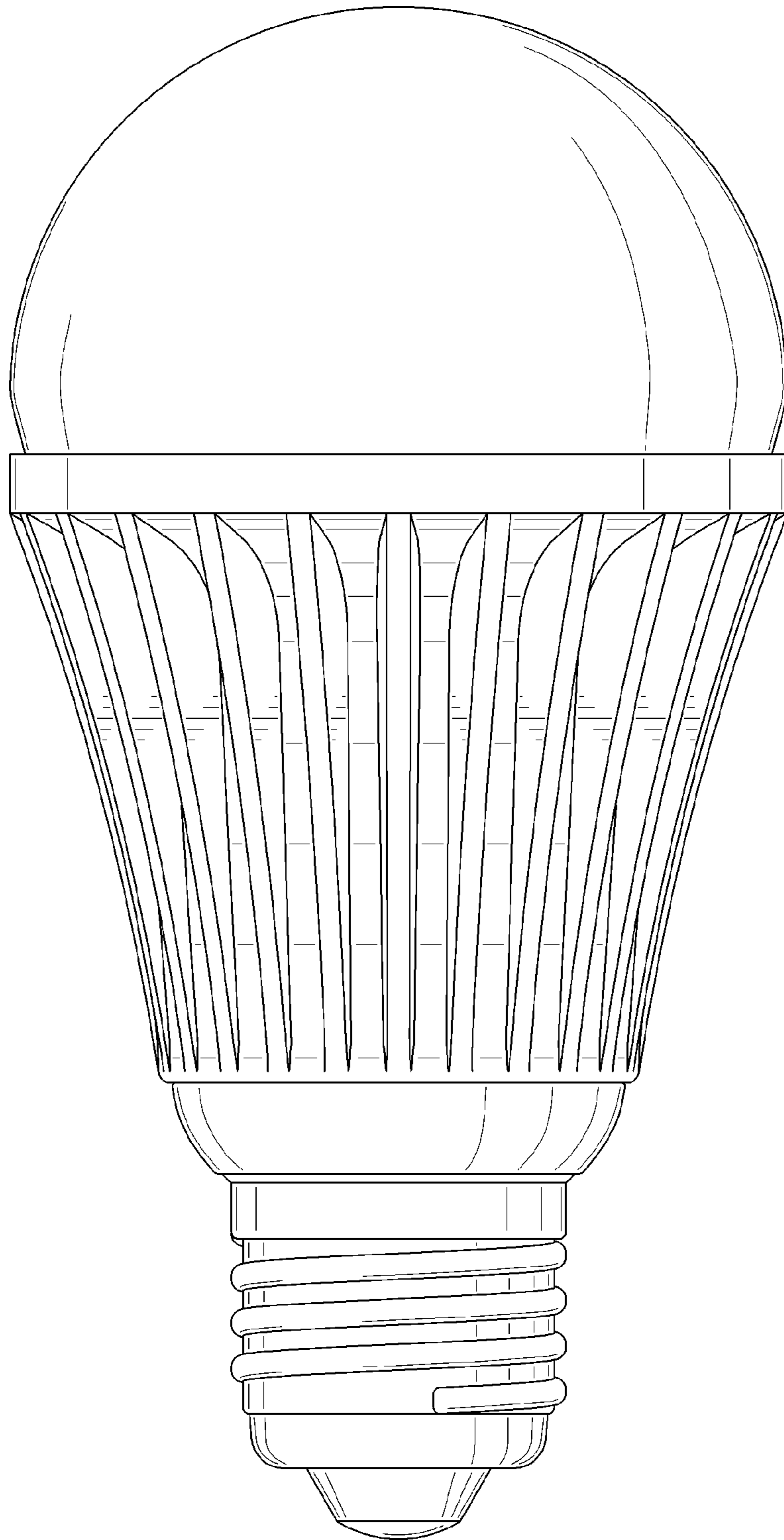

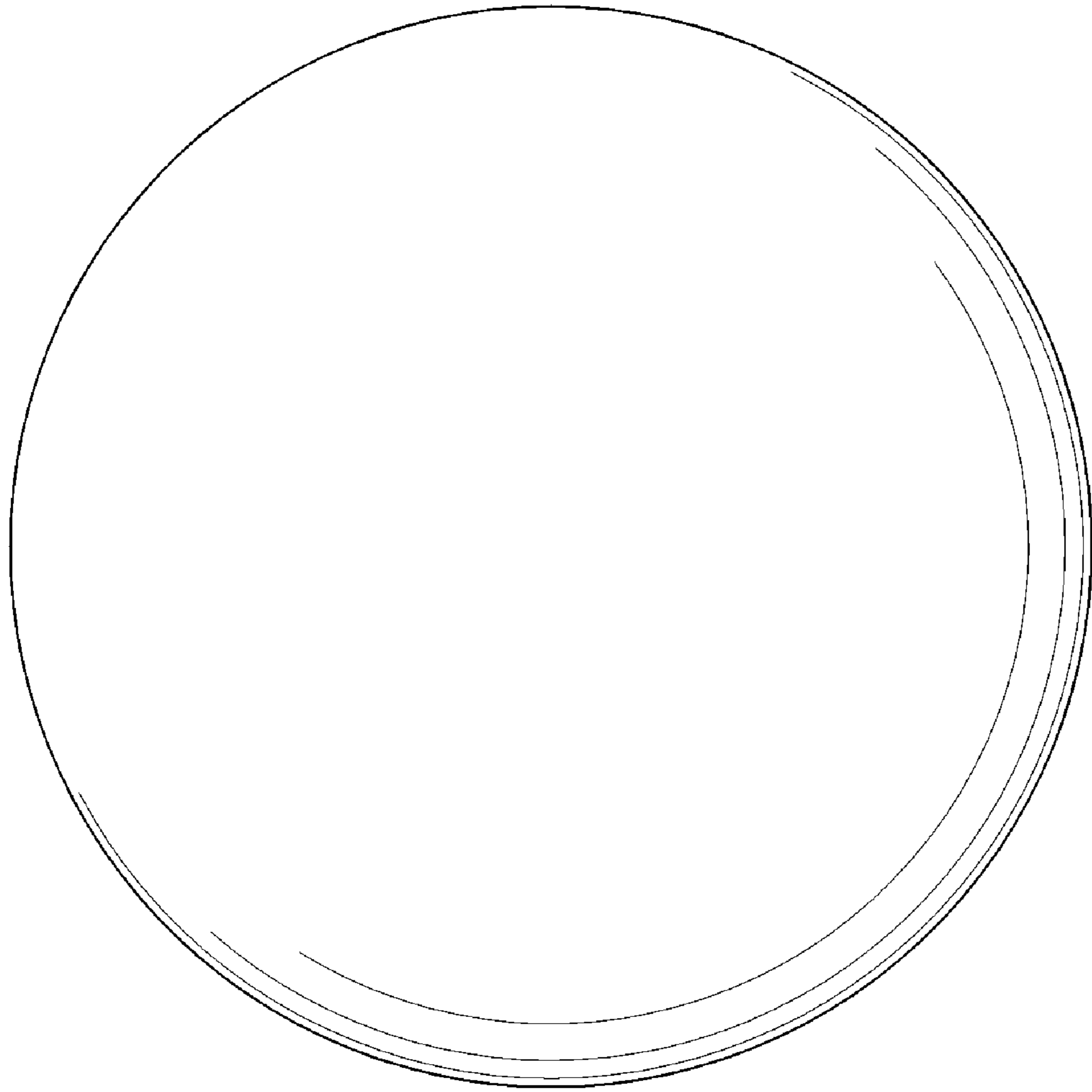

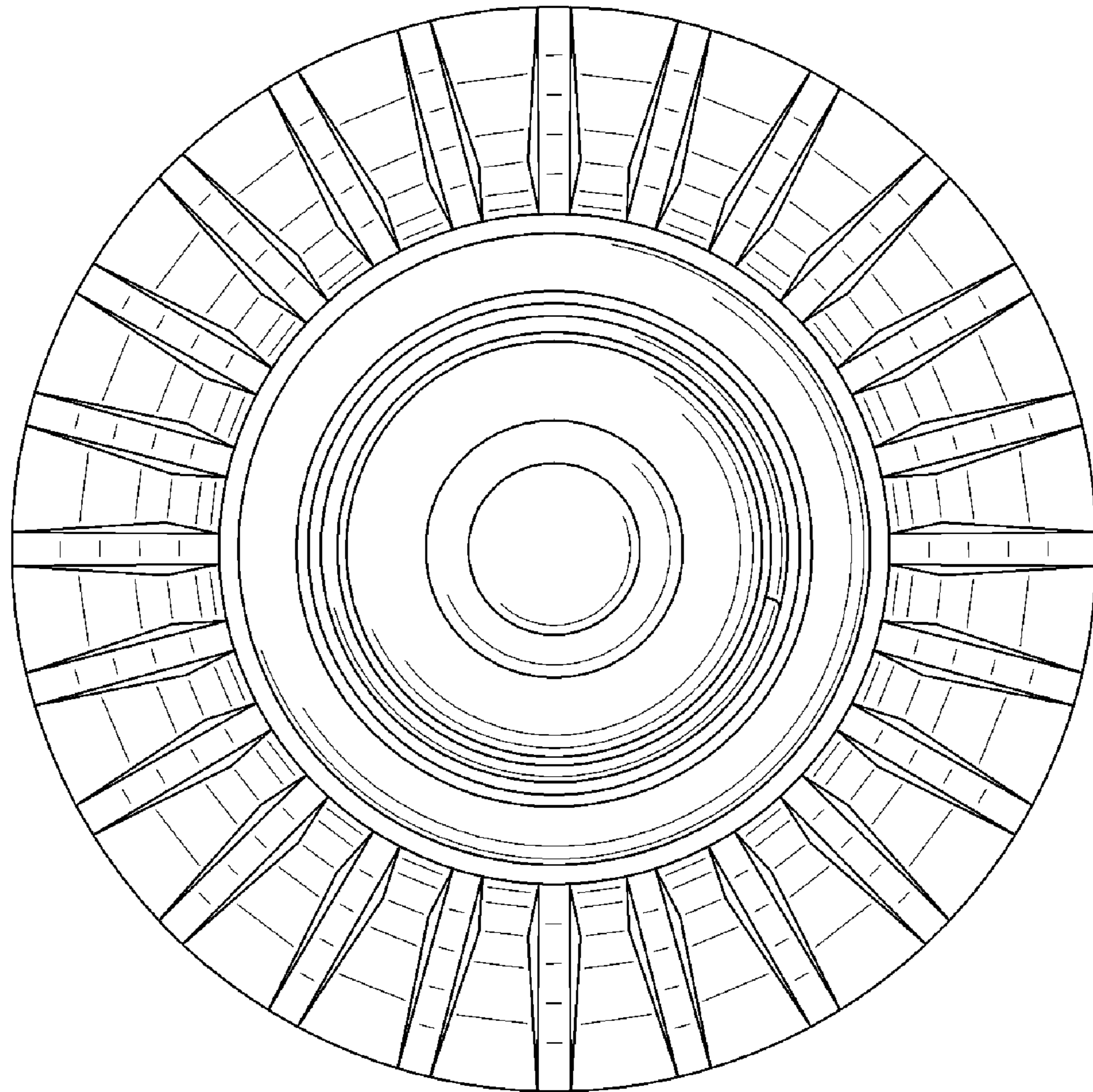
