DESCRIPTION

FIG. 1 is a front perspective view of a lighting device showing my new design;

FIG. 7 is a front side elevational view thereof;

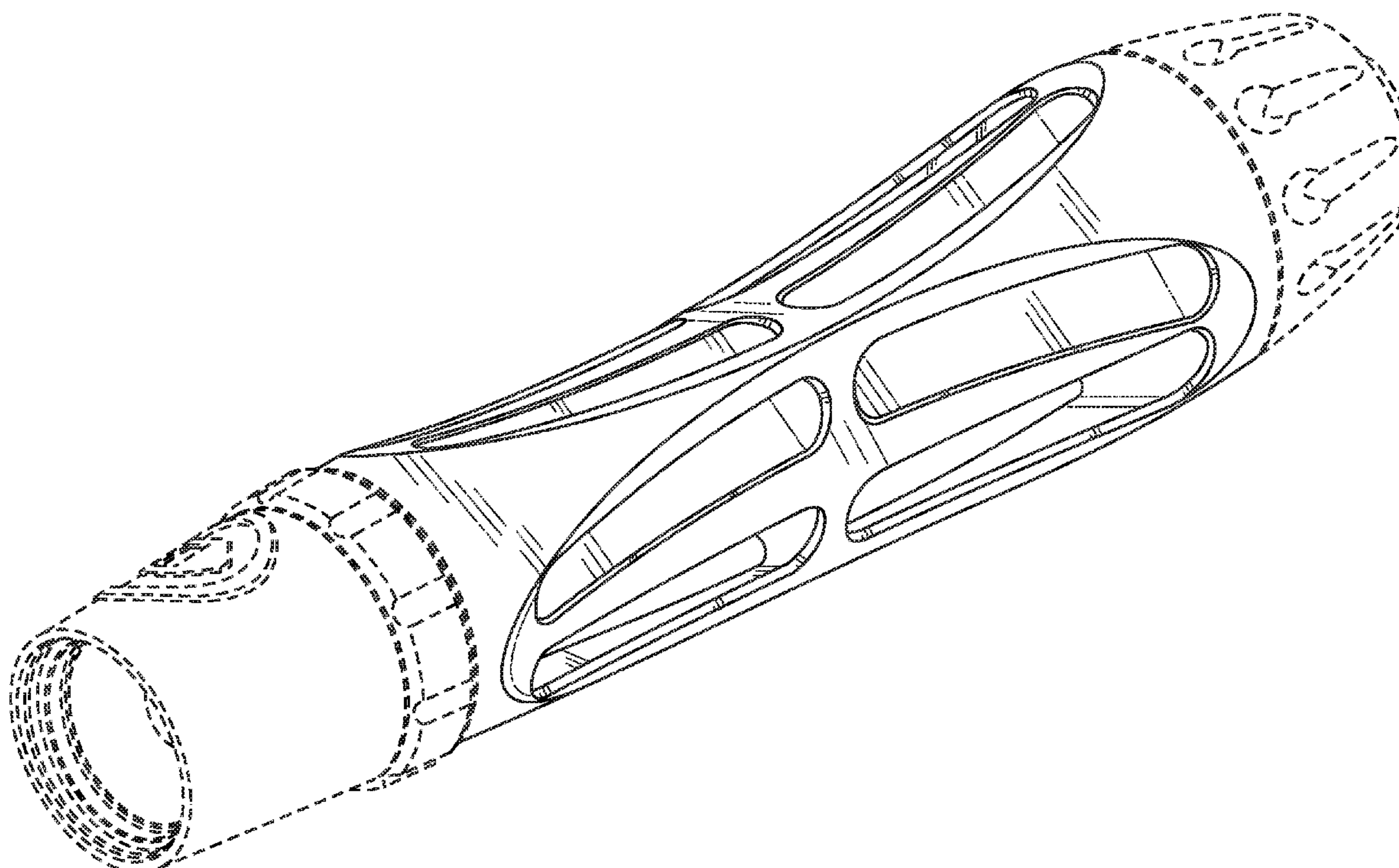
FIG. 8 is a rear side elevational view thereof;

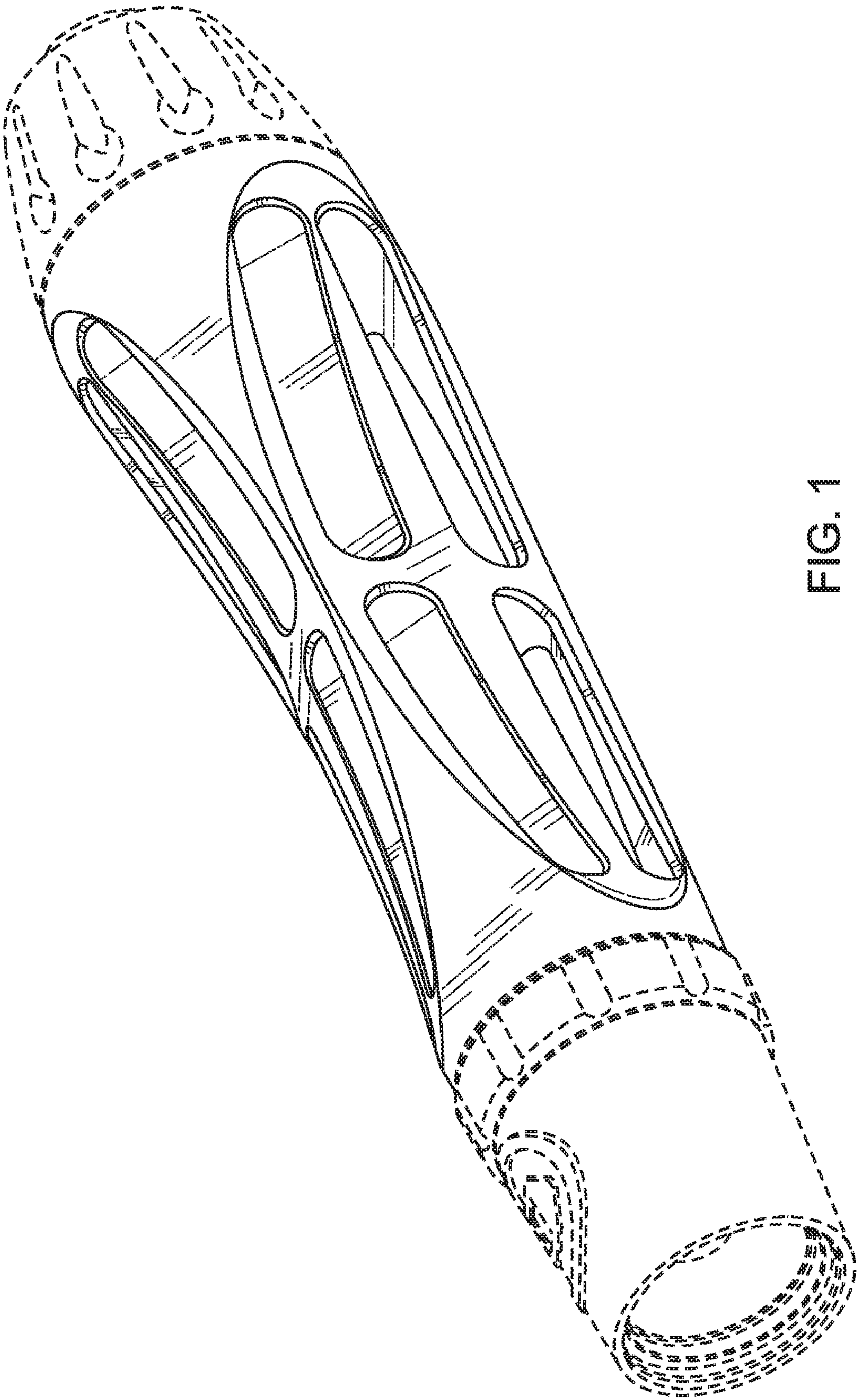

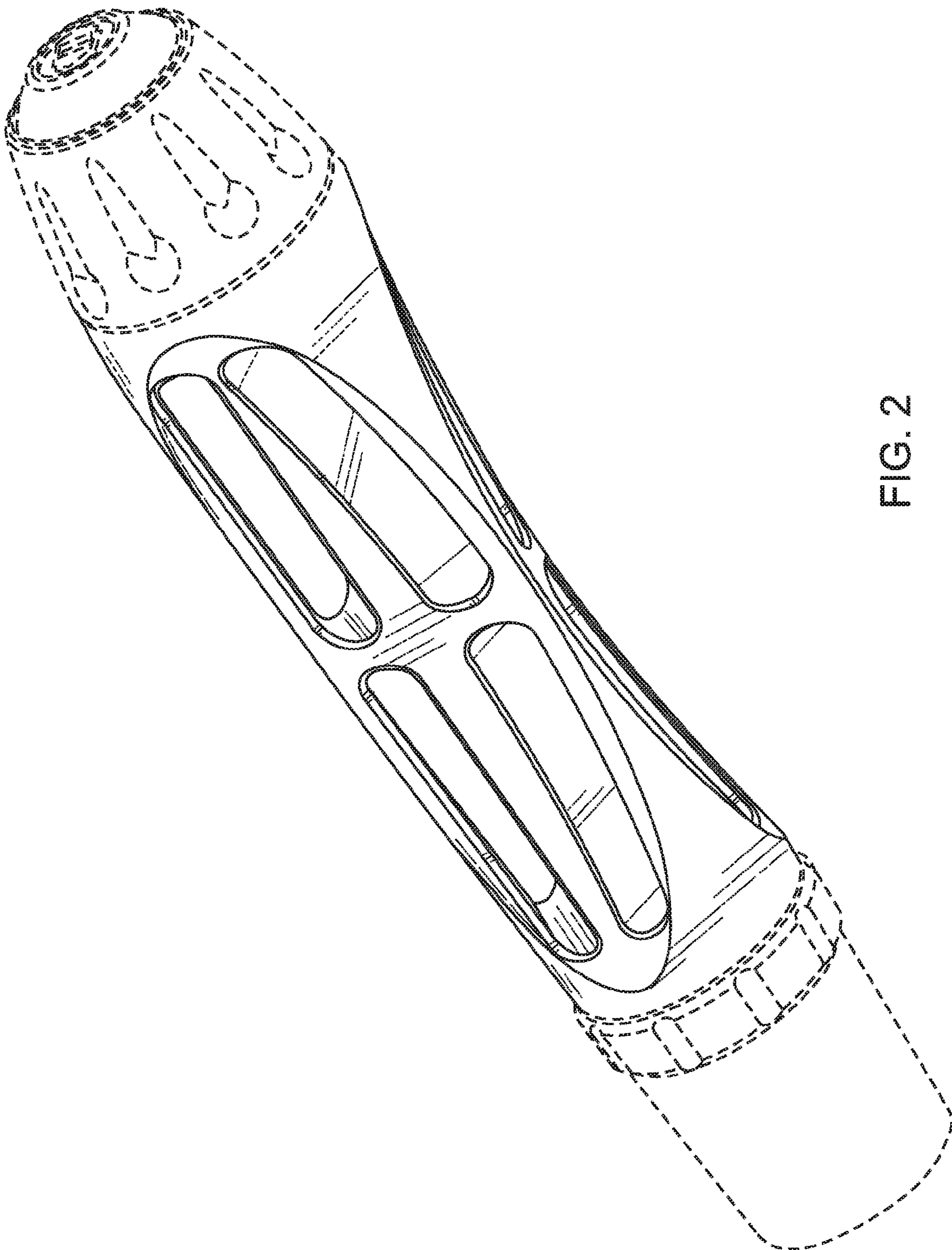

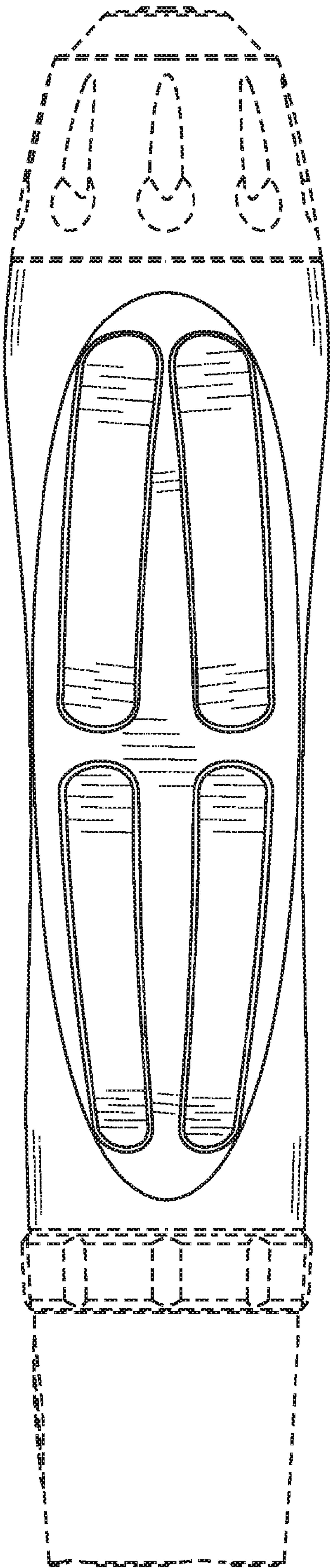

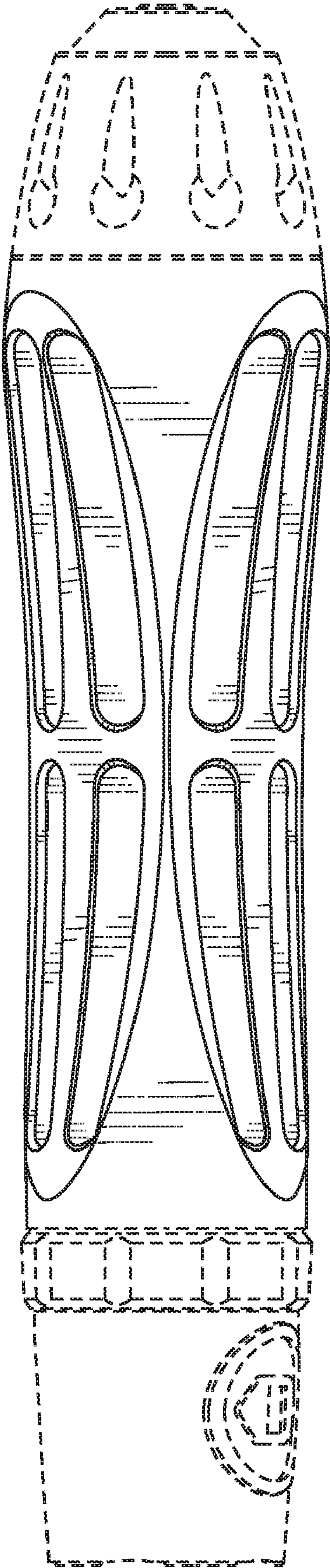

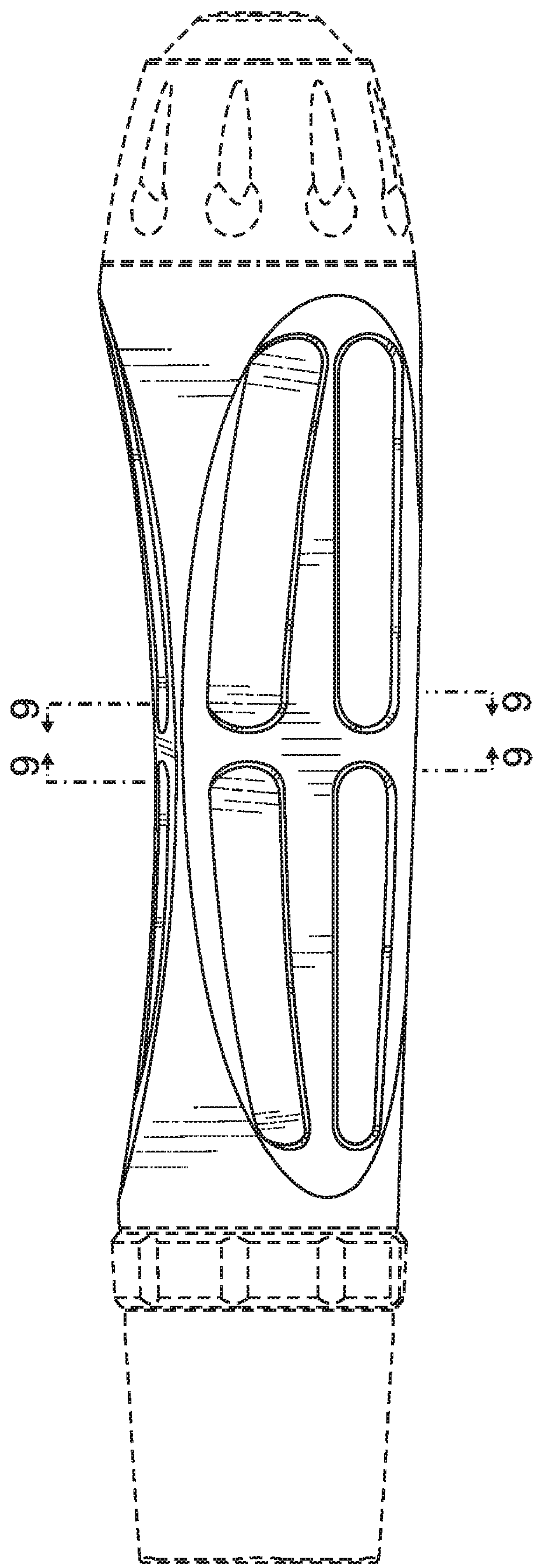

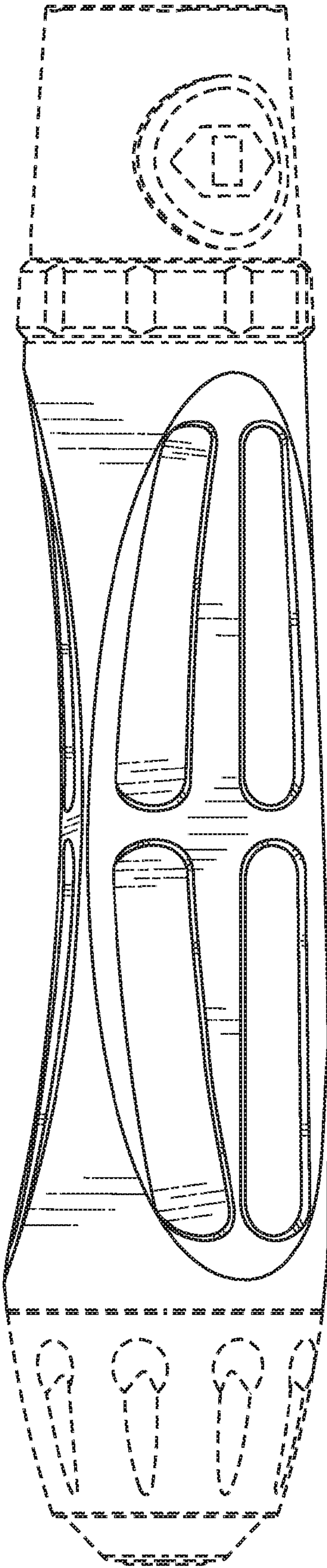

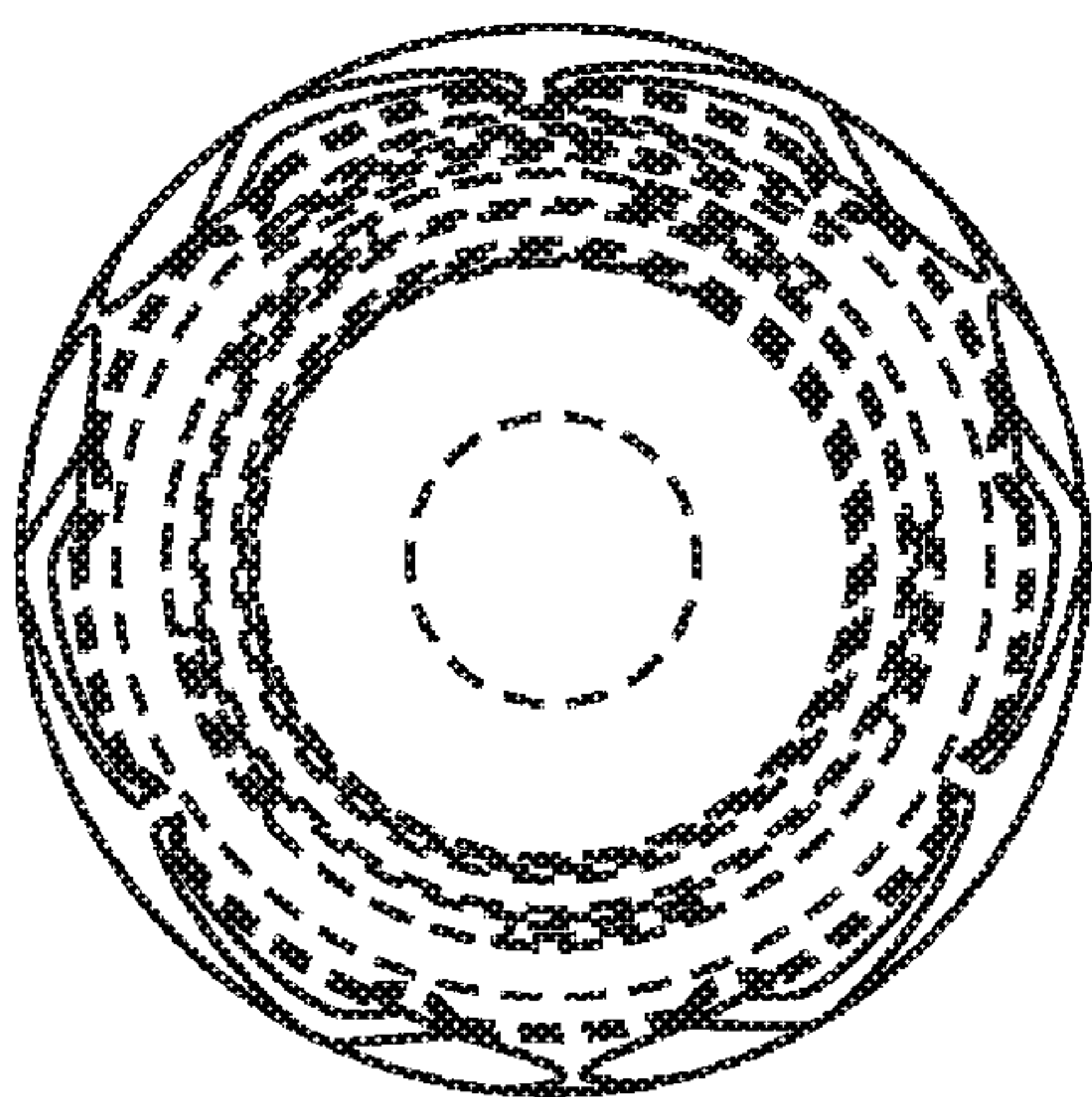

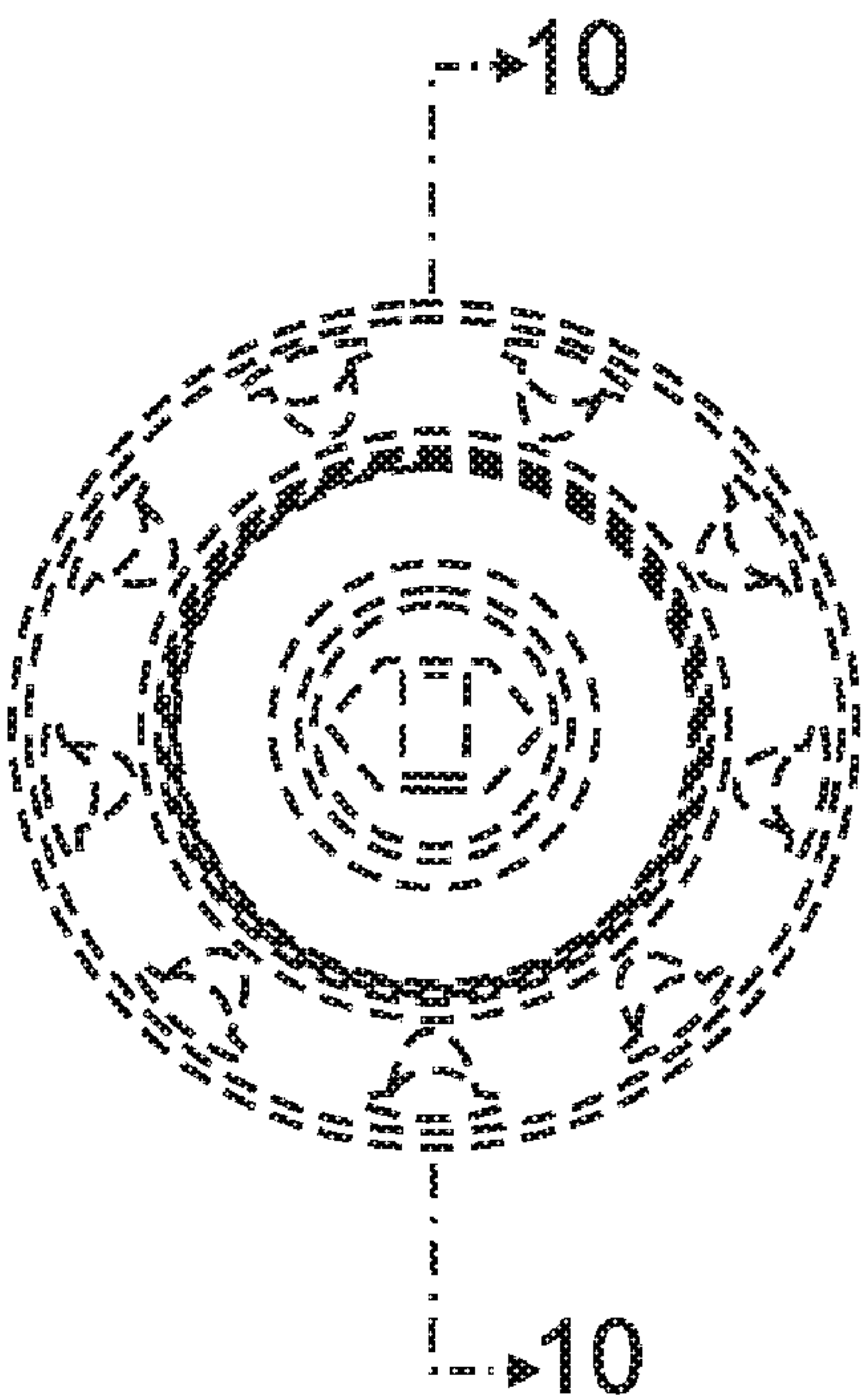

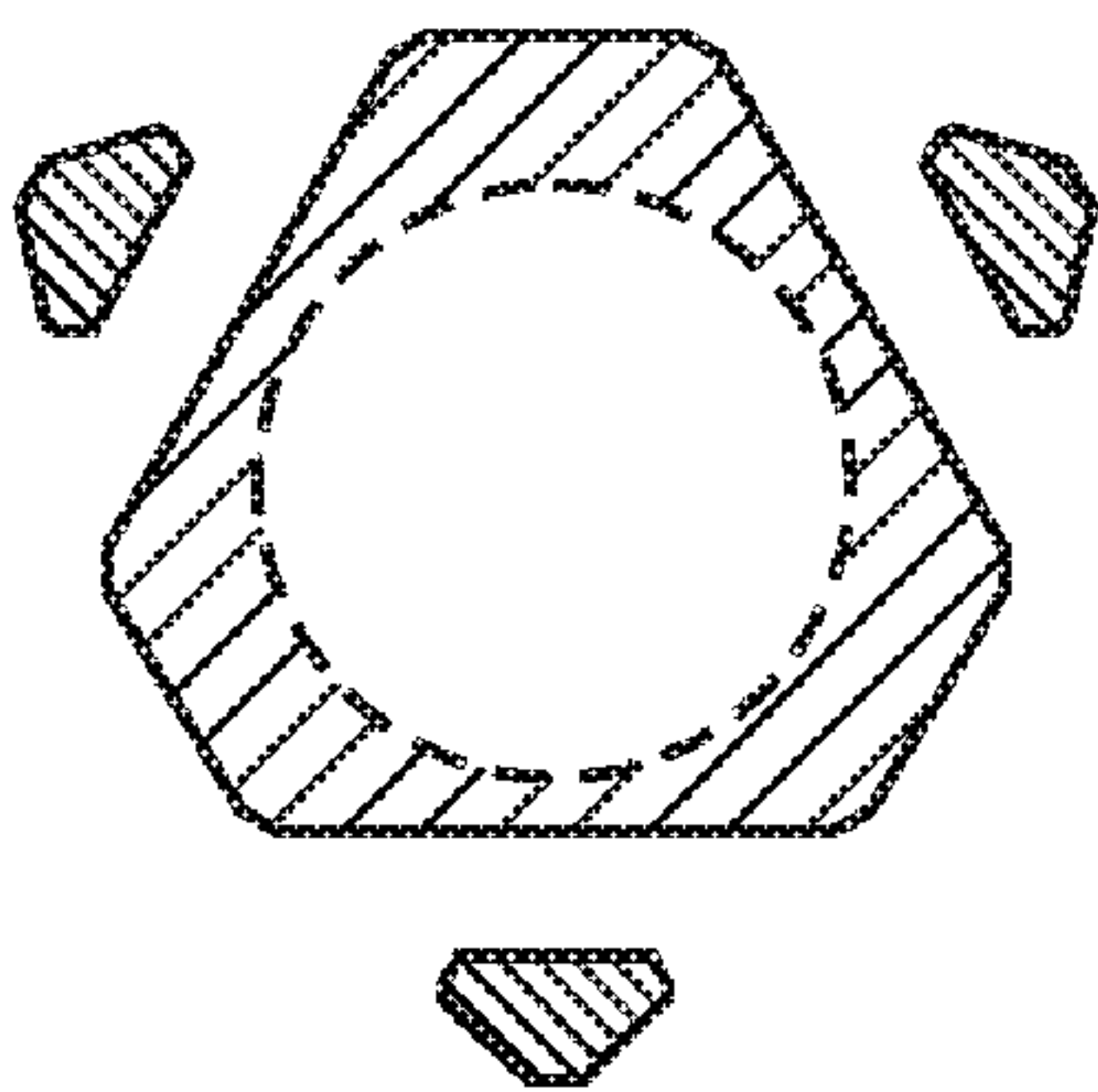

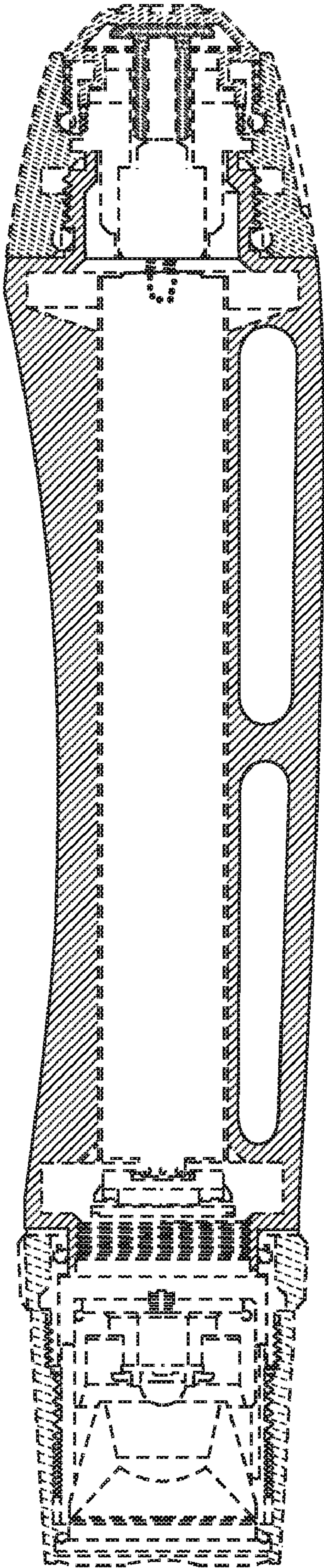
