(57) **CLAIM**

The ornamental design for a trash receptacle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of a trash receptacle showing a first embodiment of our new design;

FIG. 2 is a rear elevation view of a trash receptacle showing the first embodiment of our new design;

FIG. 3 is a left side elevation view of a trash receptacle showing the first embodiment and a third embodiment of our new design, a right side elevation view of the trash receptacle according to the first embodiment and the third embodiment being a mirror image thereof;

FIG. 4 is a top view of a trash receptacle showing the first embodiment and a second embodiment of our new design;

FIG. 5 is a bottom view of a trash receptacle showing the first embodiment of our new design;

FIG. 6 is a front elevation view of a trash receptacle showing the second embodiment of our new design;

FIG. 7 is a rear elevation view of a trash receptacle showing the second embodiment of our new design;

FIG. 8 is a left side elevation view of a trash receptacle showing the second embodiment and a fourth embodiment of our new design, a right side elevation view of the trash receptacle according to the second embodiment and the fourth embodiment being a mirror image thereof;

FIG. 9 is a bottom view of a trash receptacle showing the second embodiment of our new design;

FIG. 10 is a front elevation view of a trash receptacle showing the third embodiment of our new design;

FIG. 11 is a rear elevation view of a trash receptacle showing the third embodiment of our new design;

FIG. 12 is a top view of a trash receptacle showing the third embodiment and the fourth embodiment of our new design;

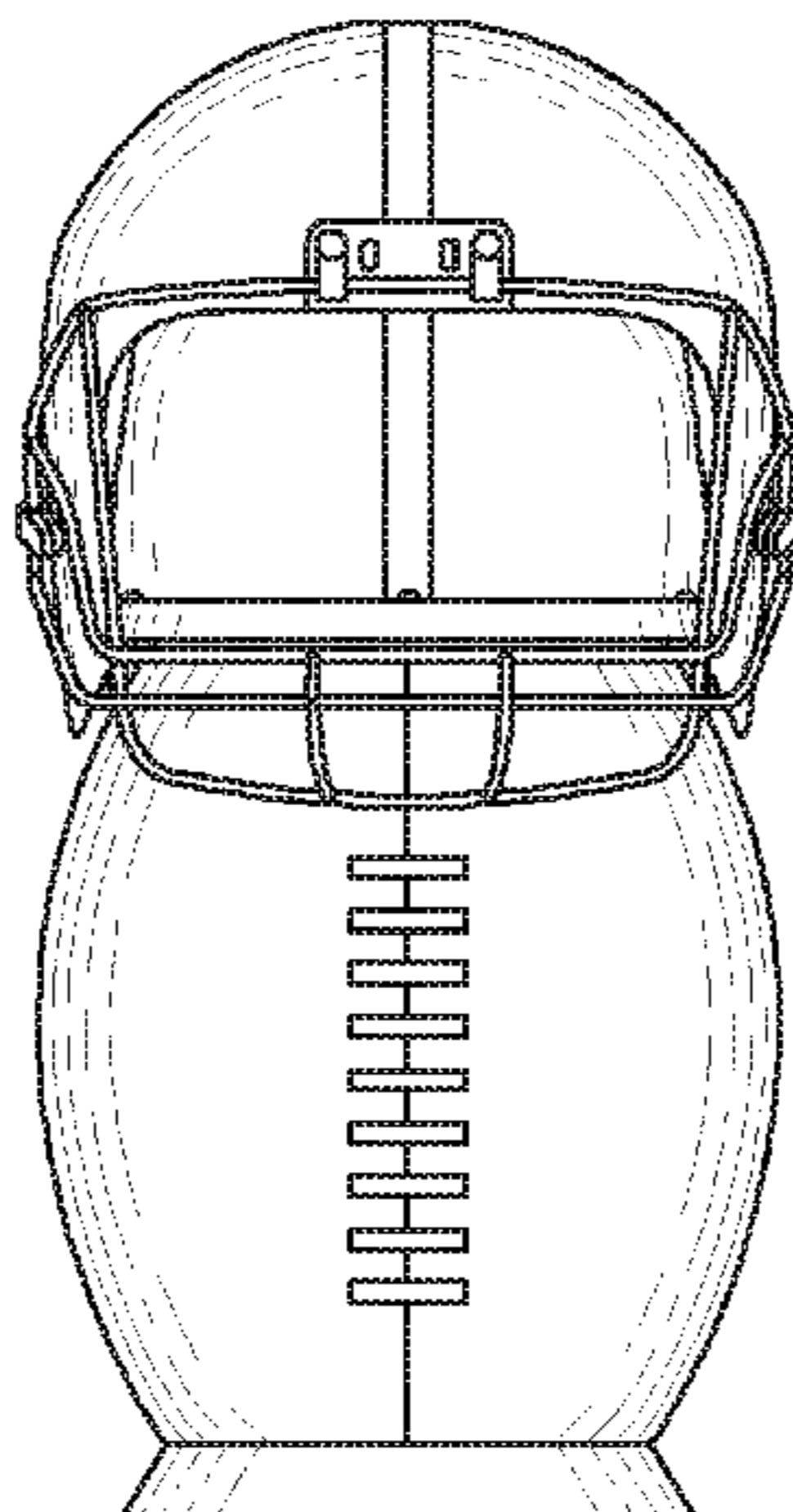
FIG. 13 is a bottom view of a trash receptacle showing the third embodiment of our new design;

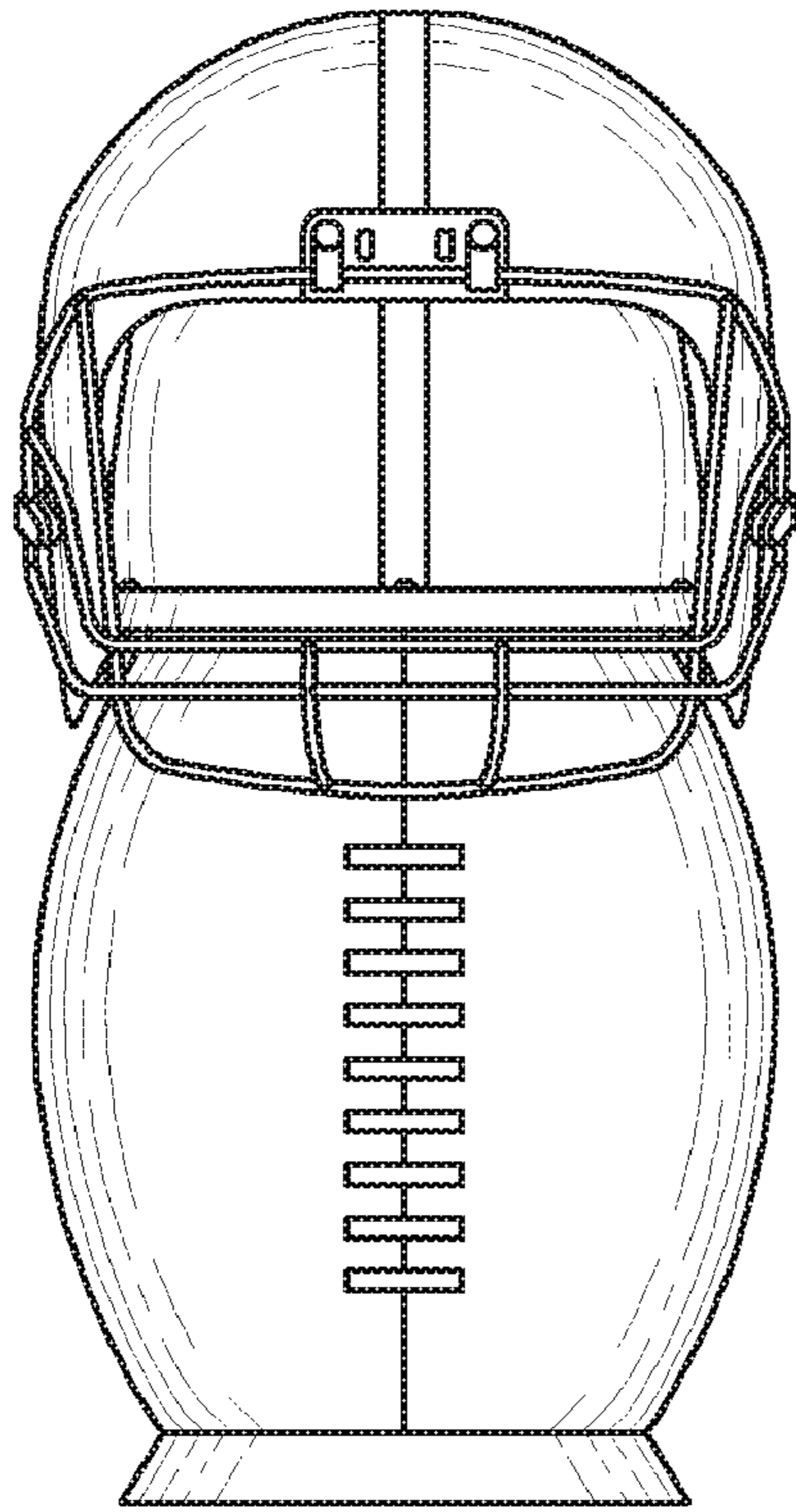

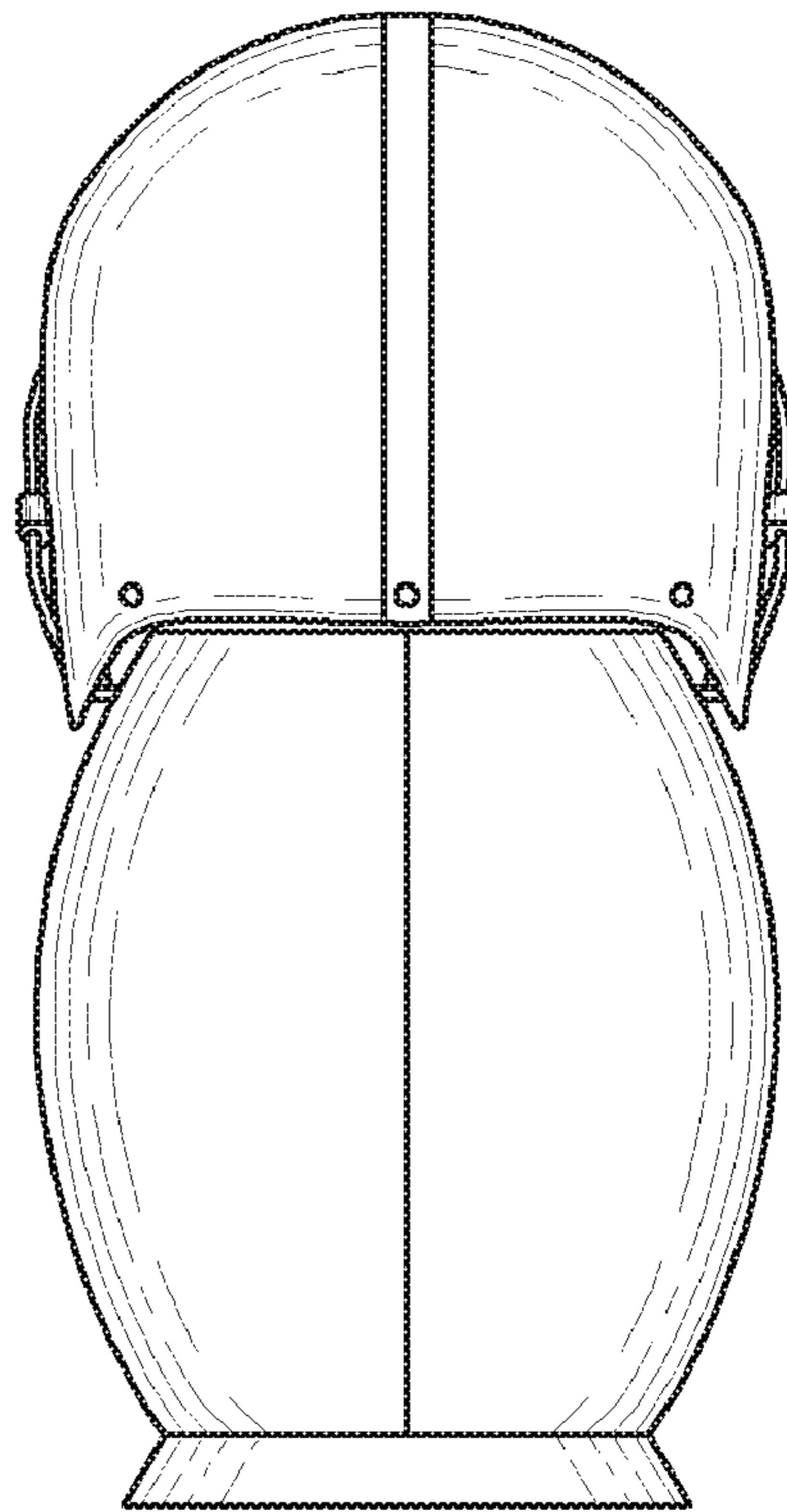

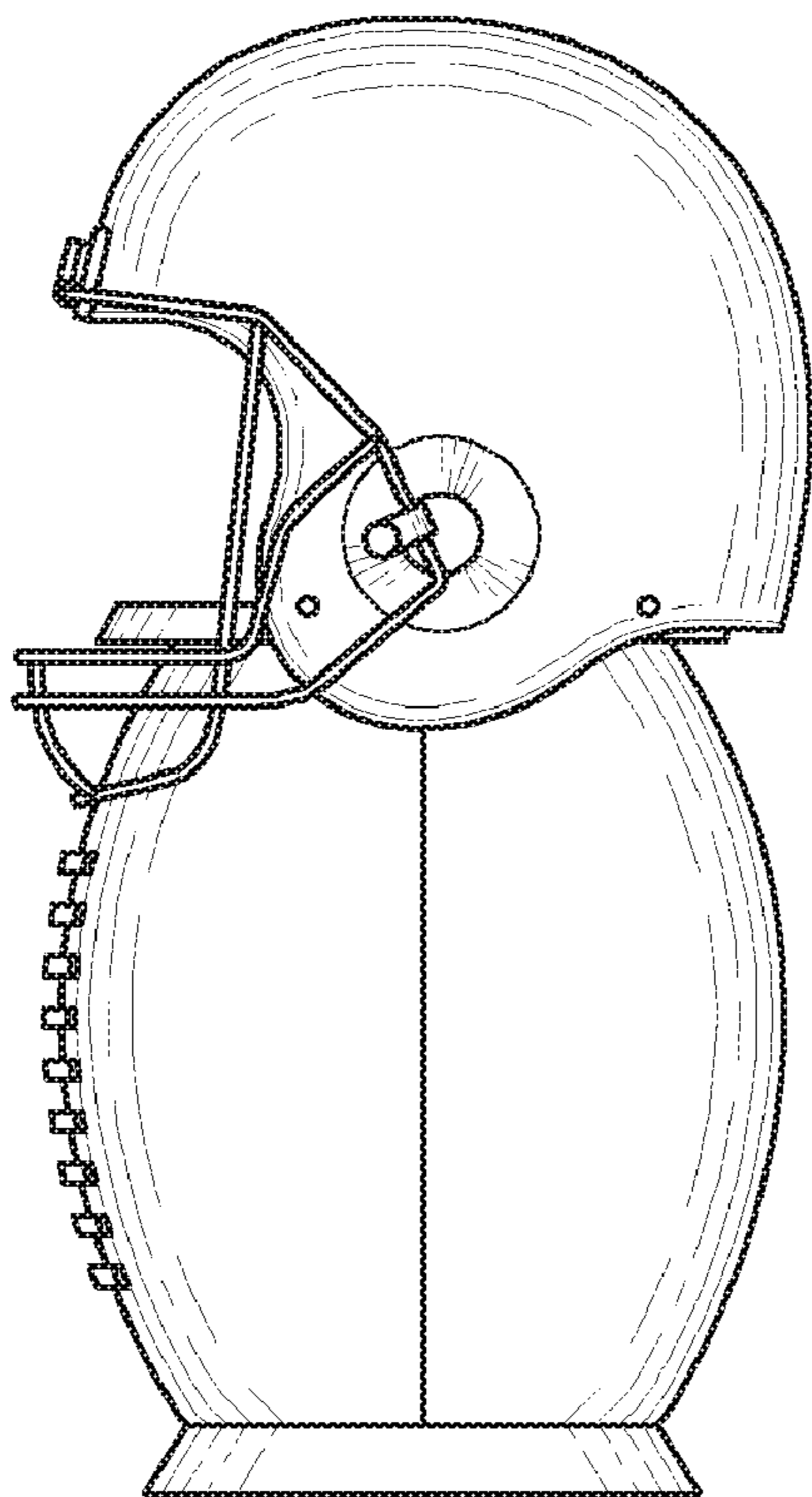

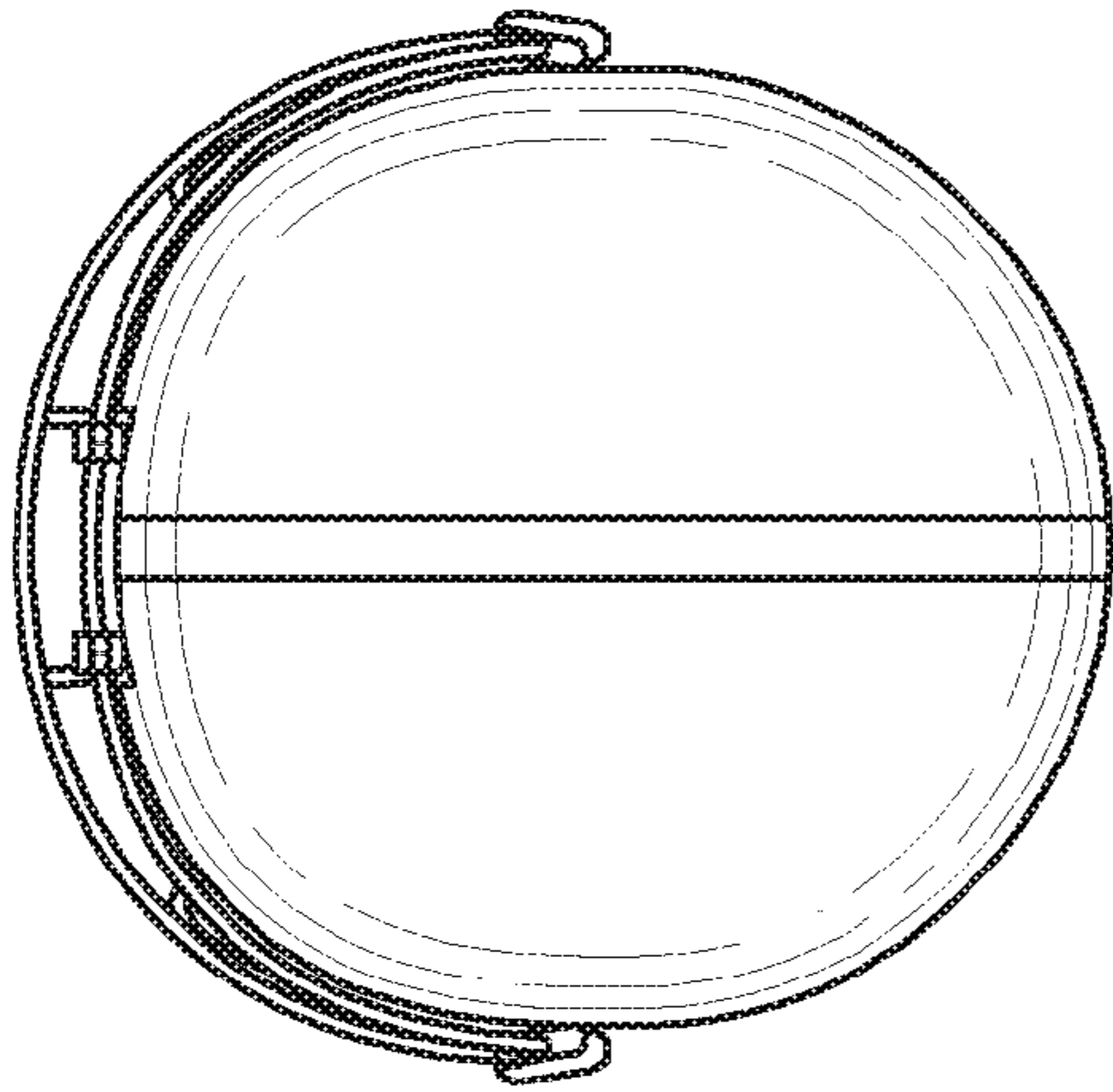

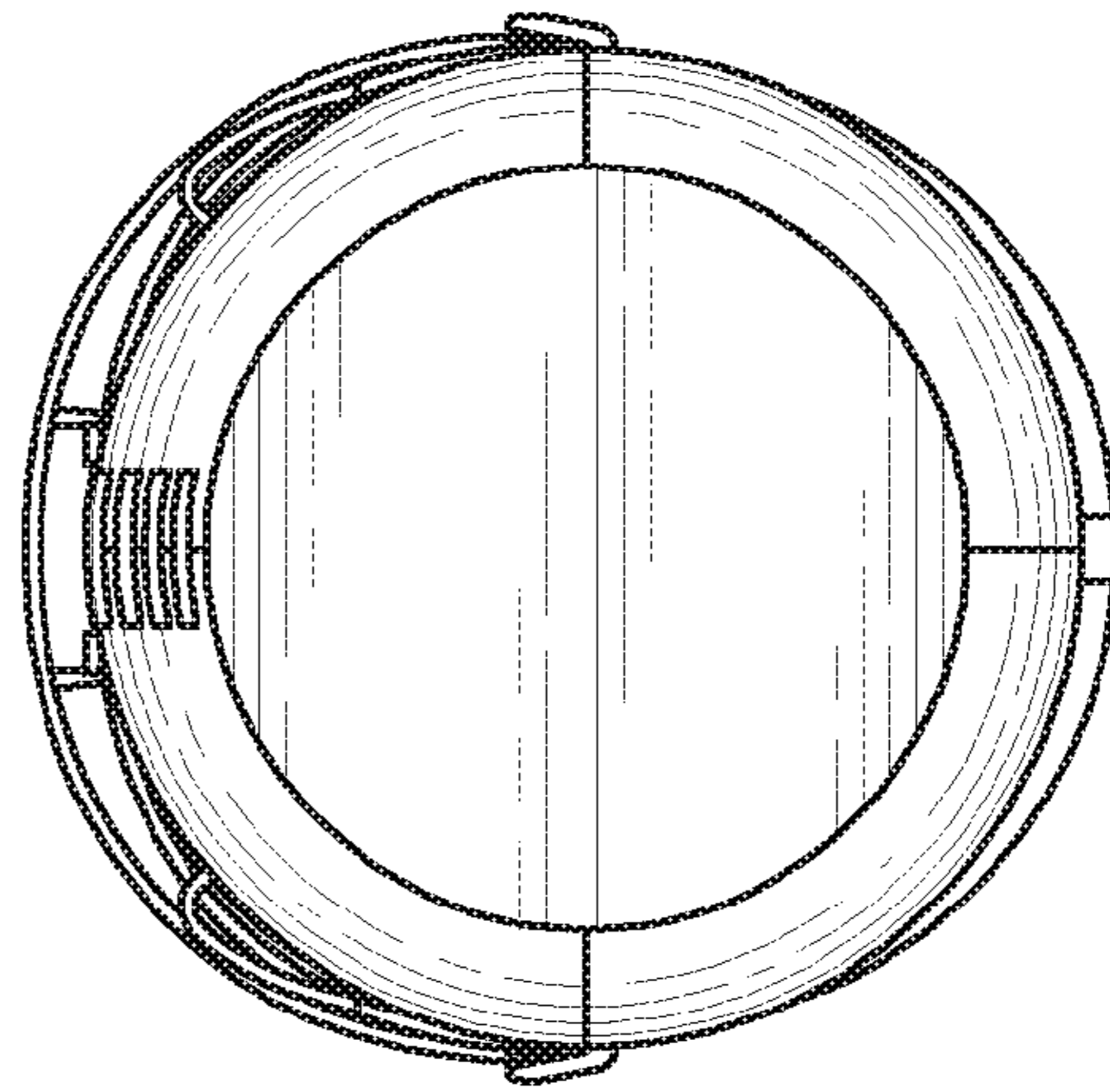

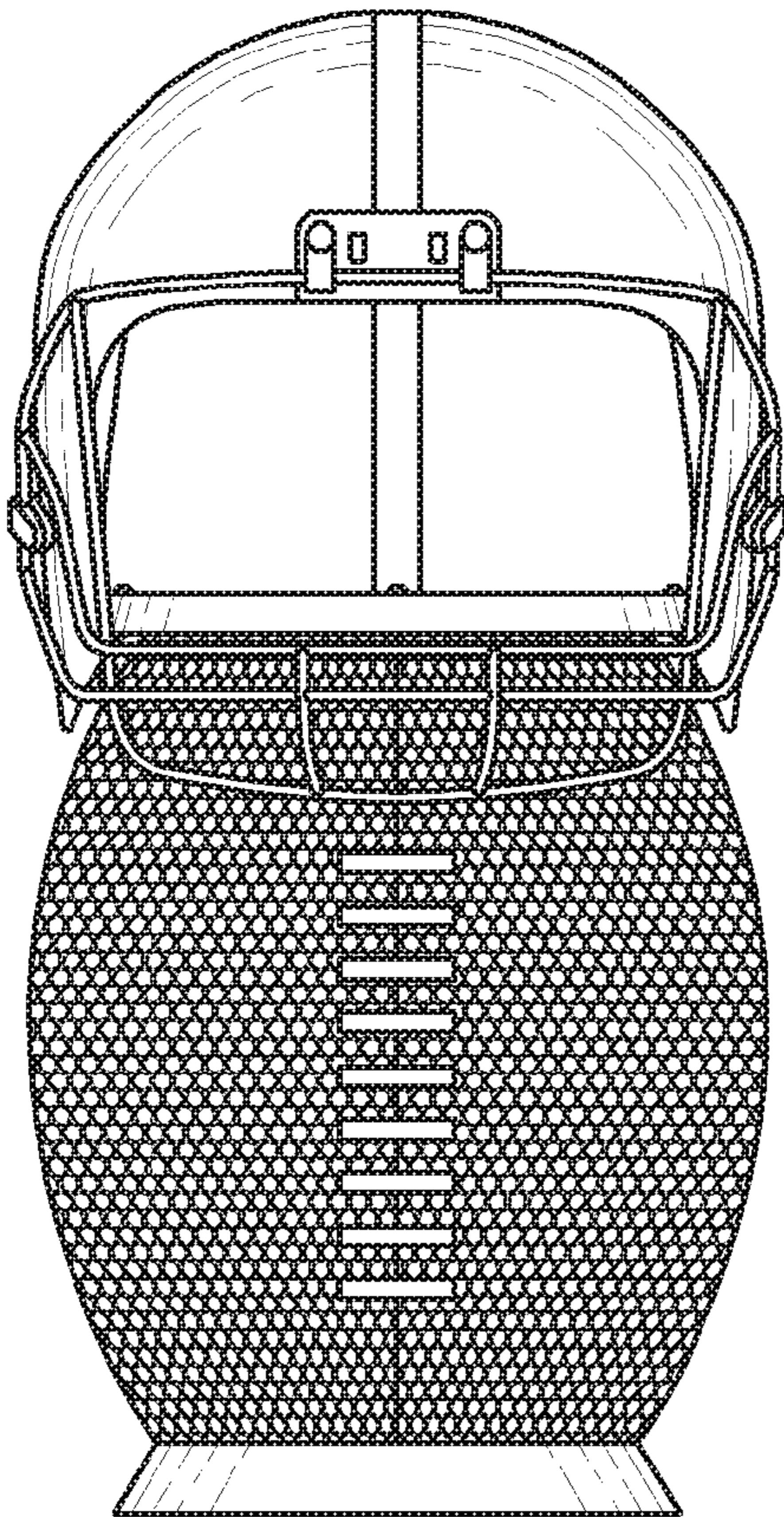

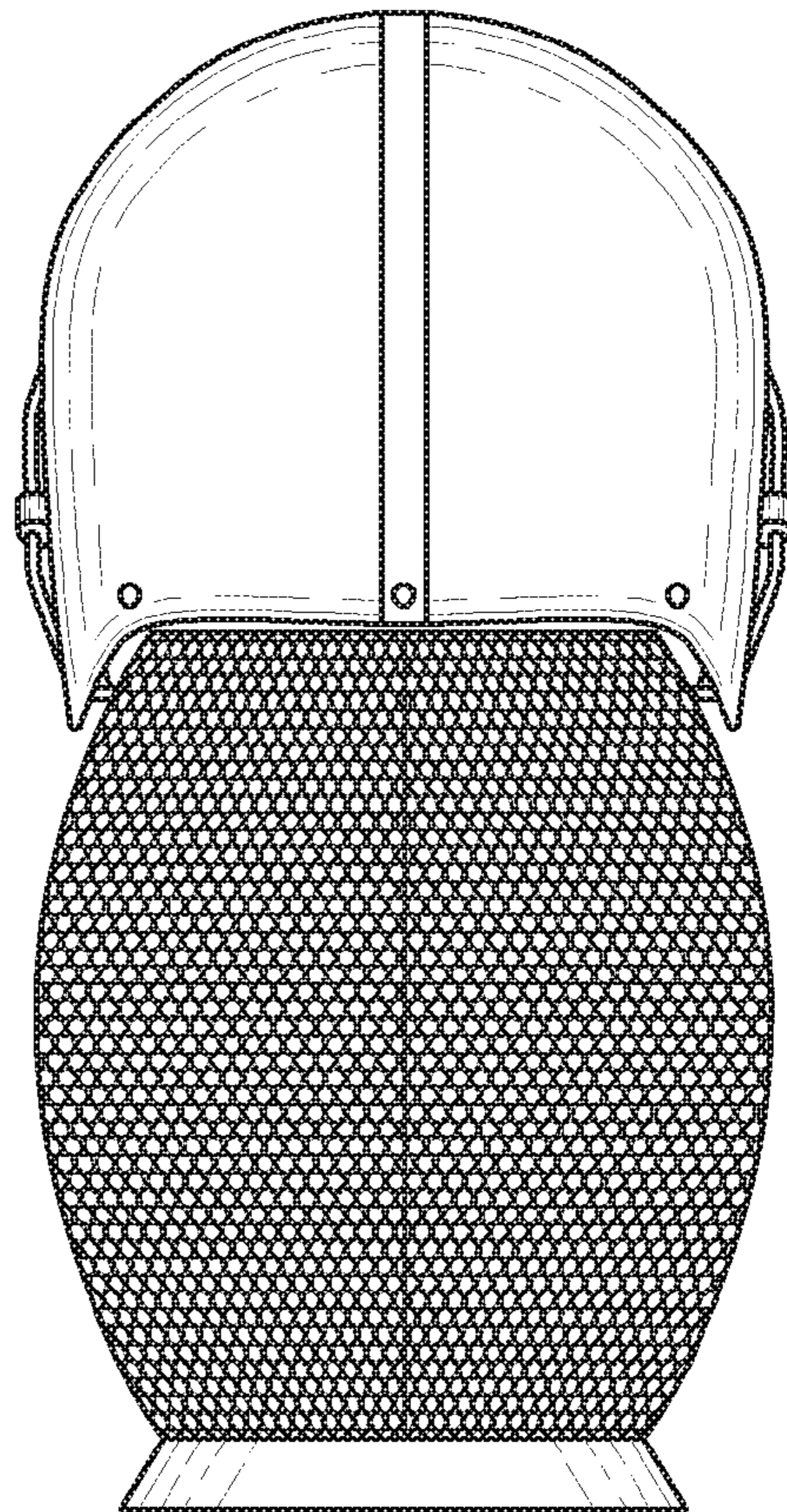

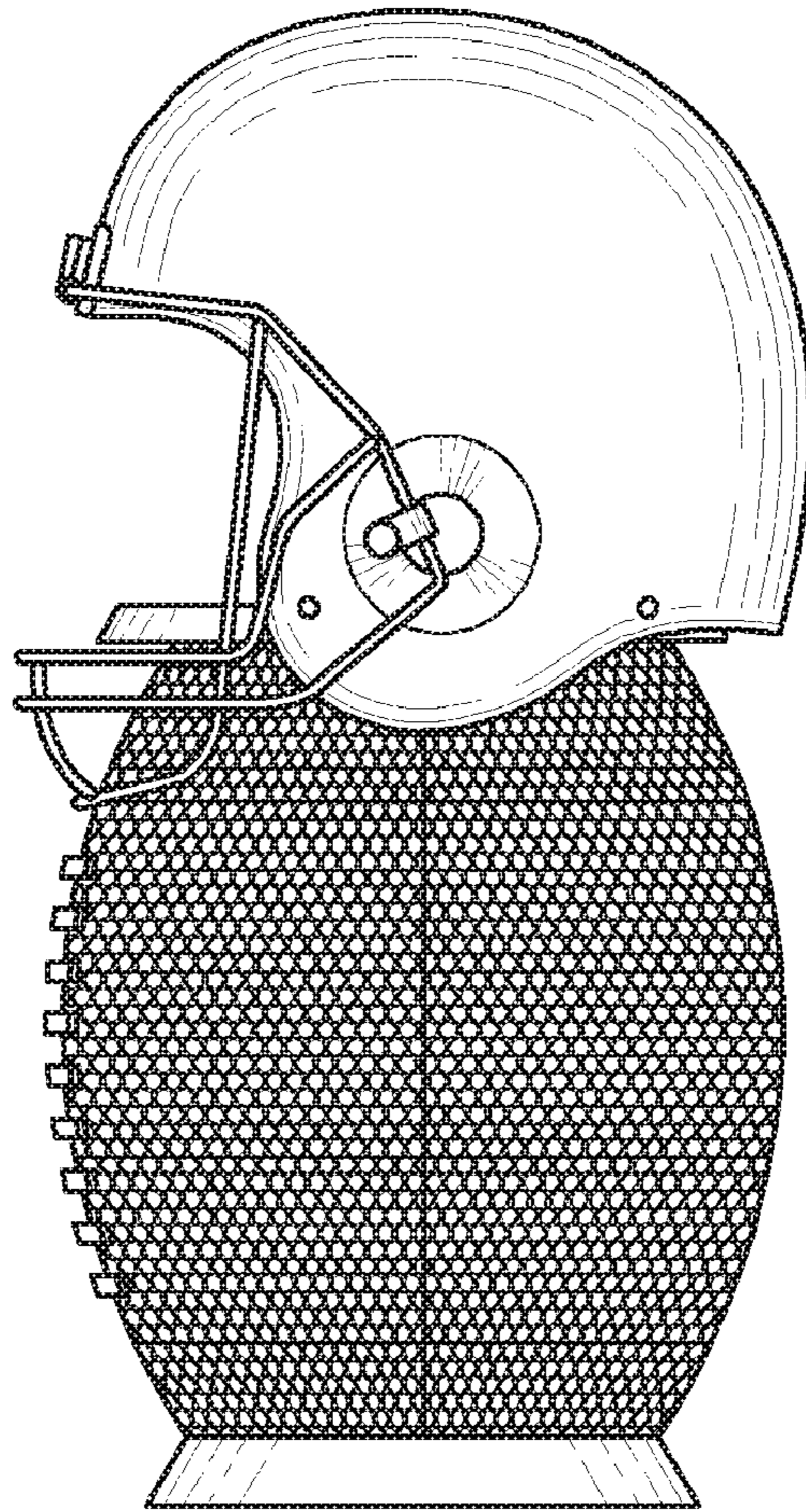

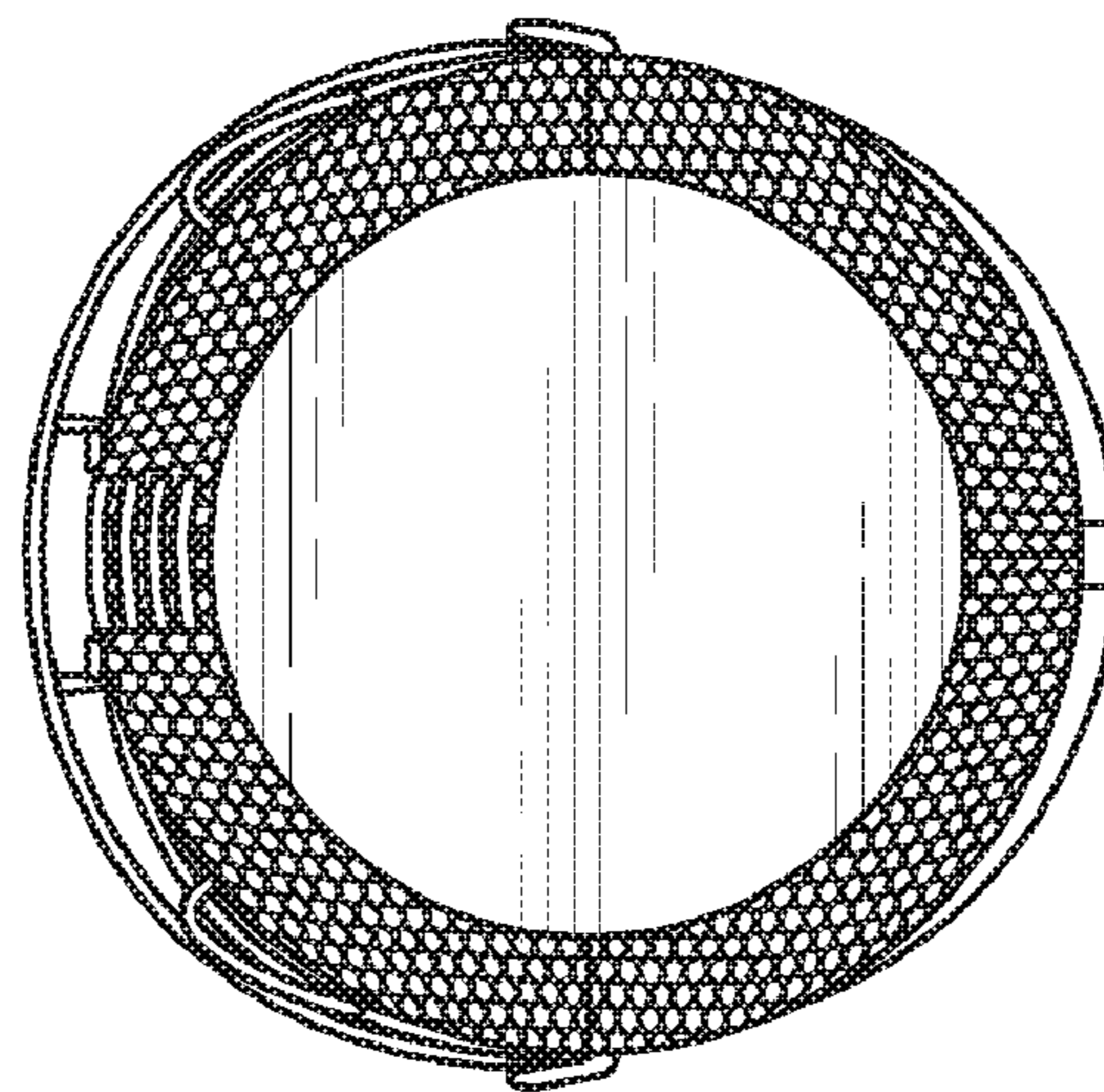

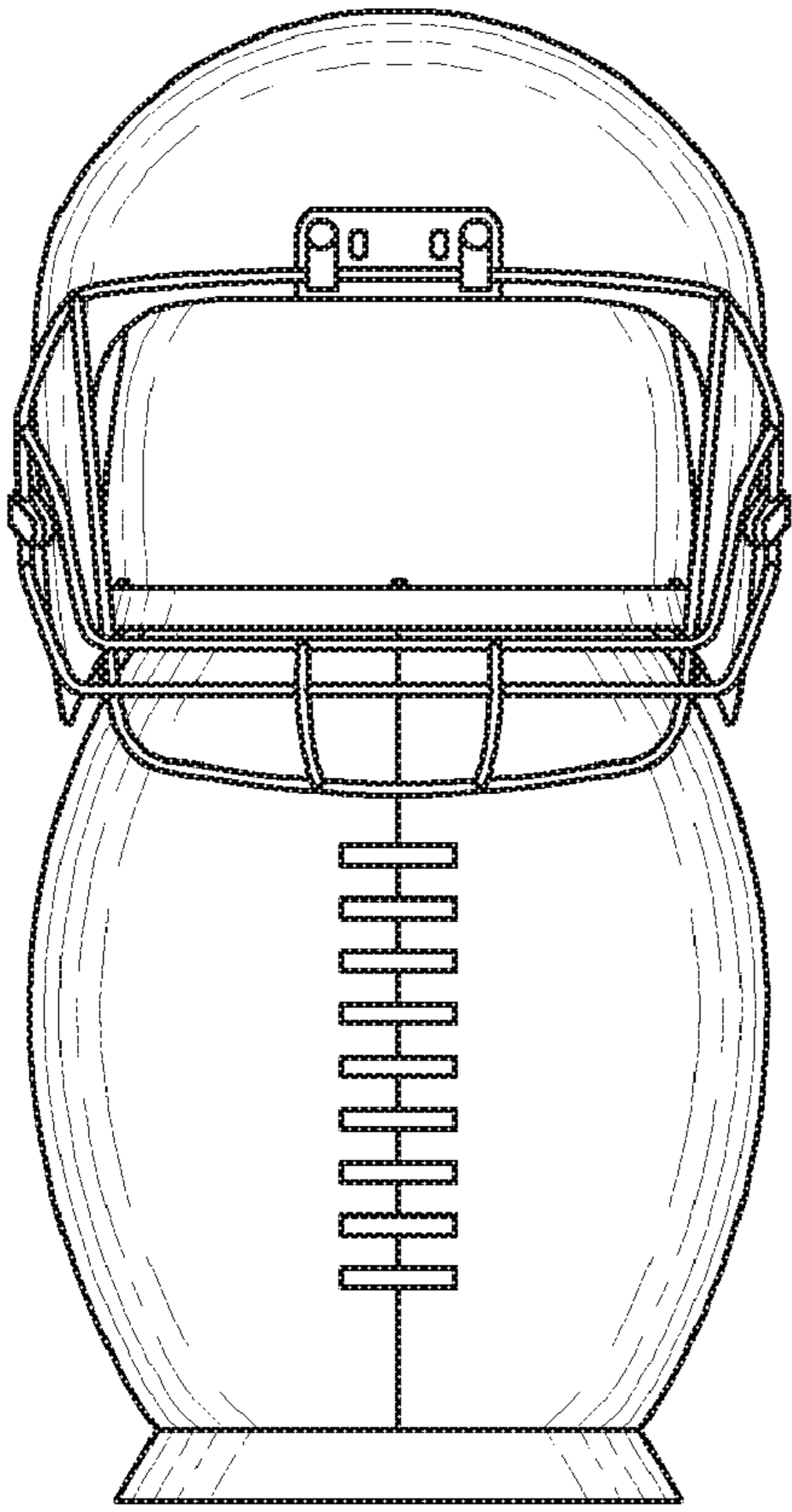

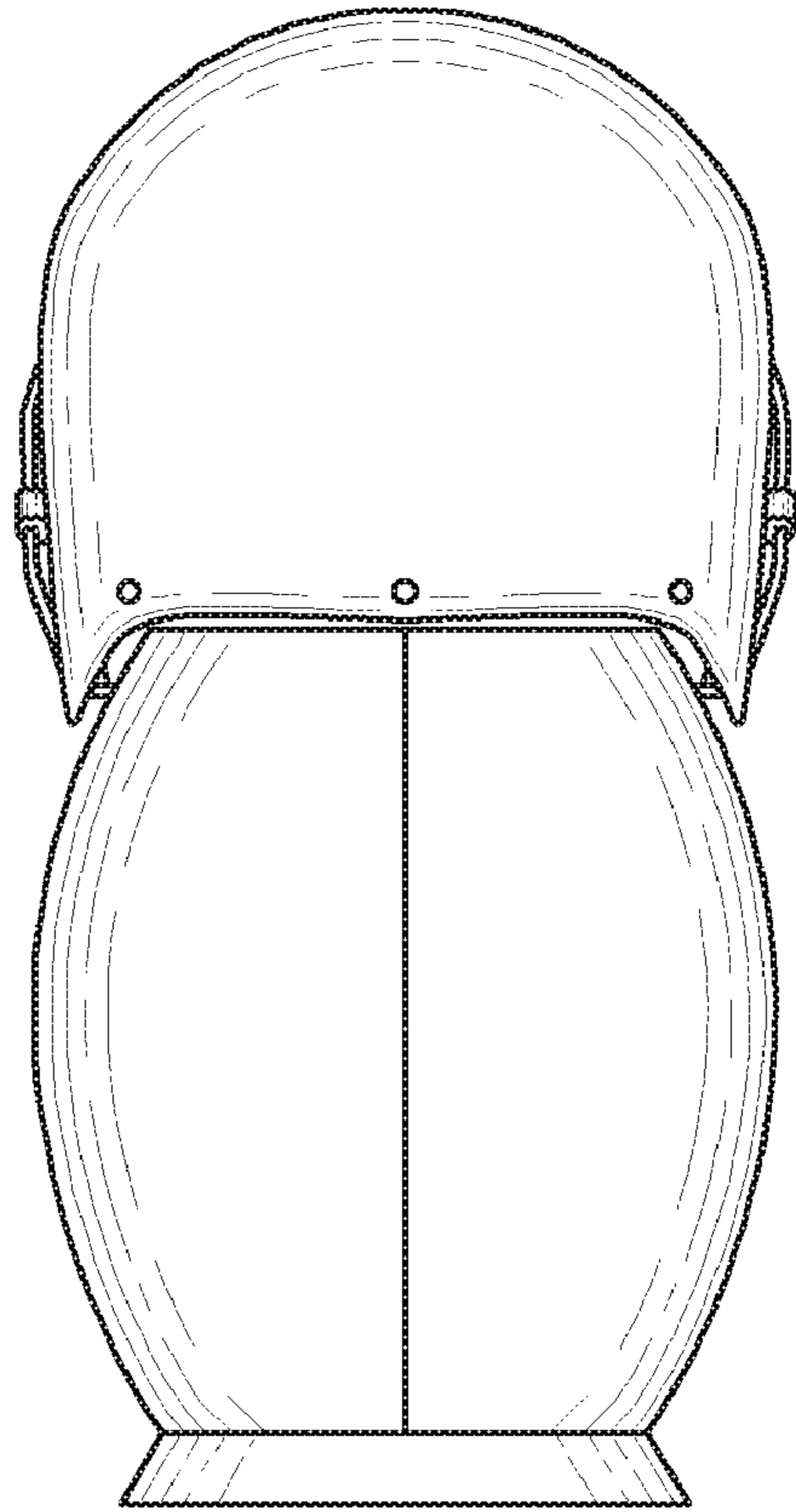

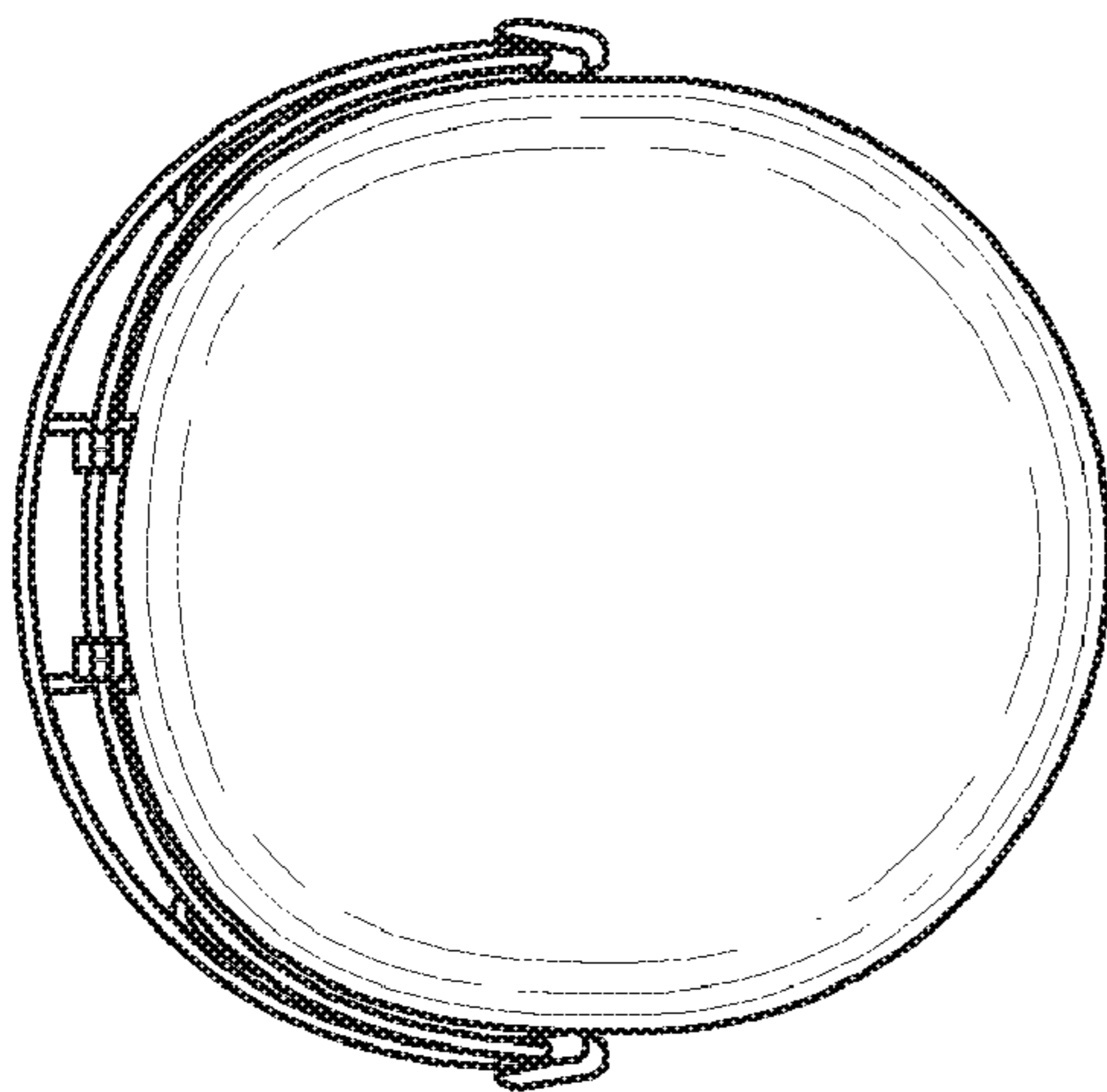

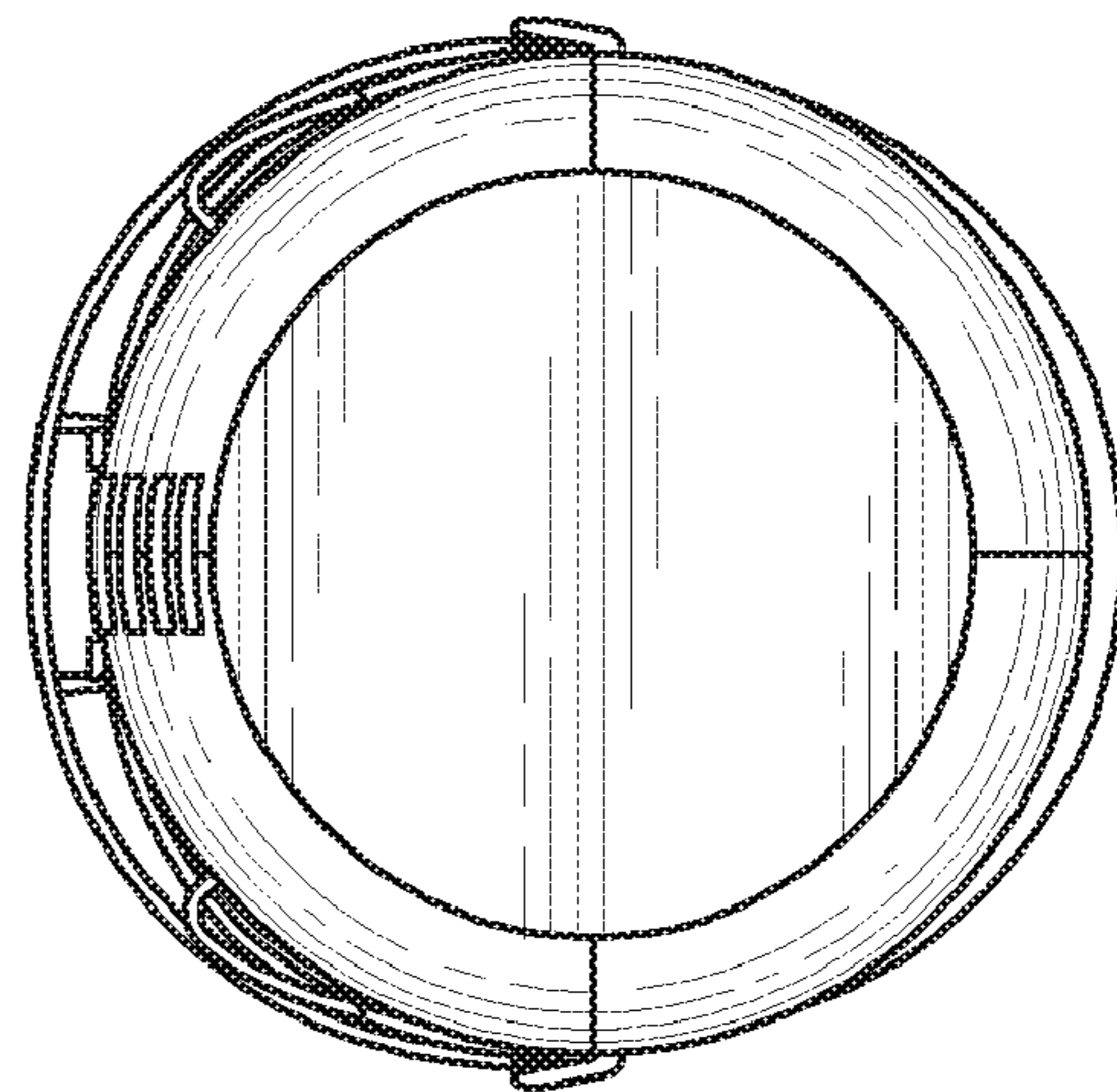

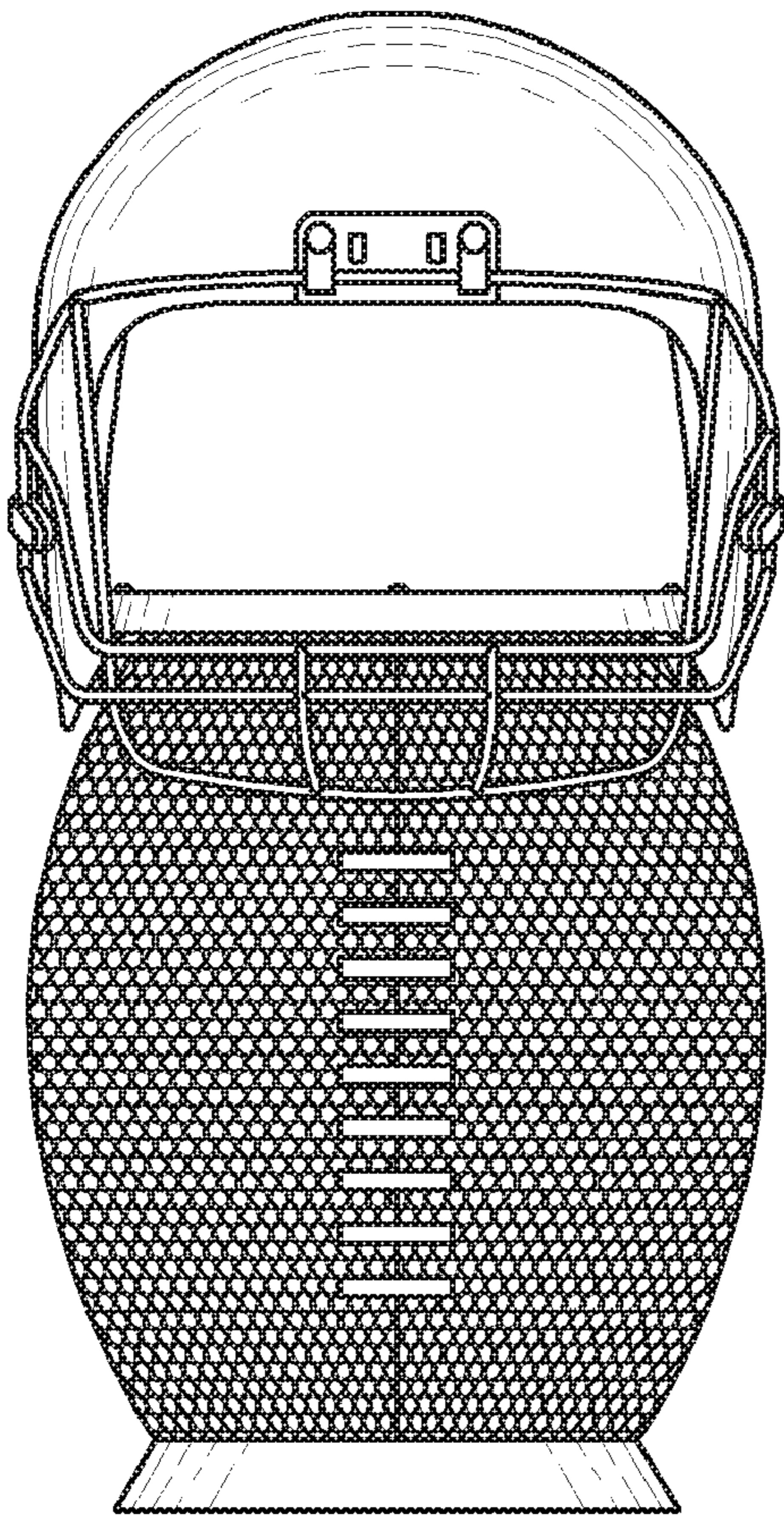

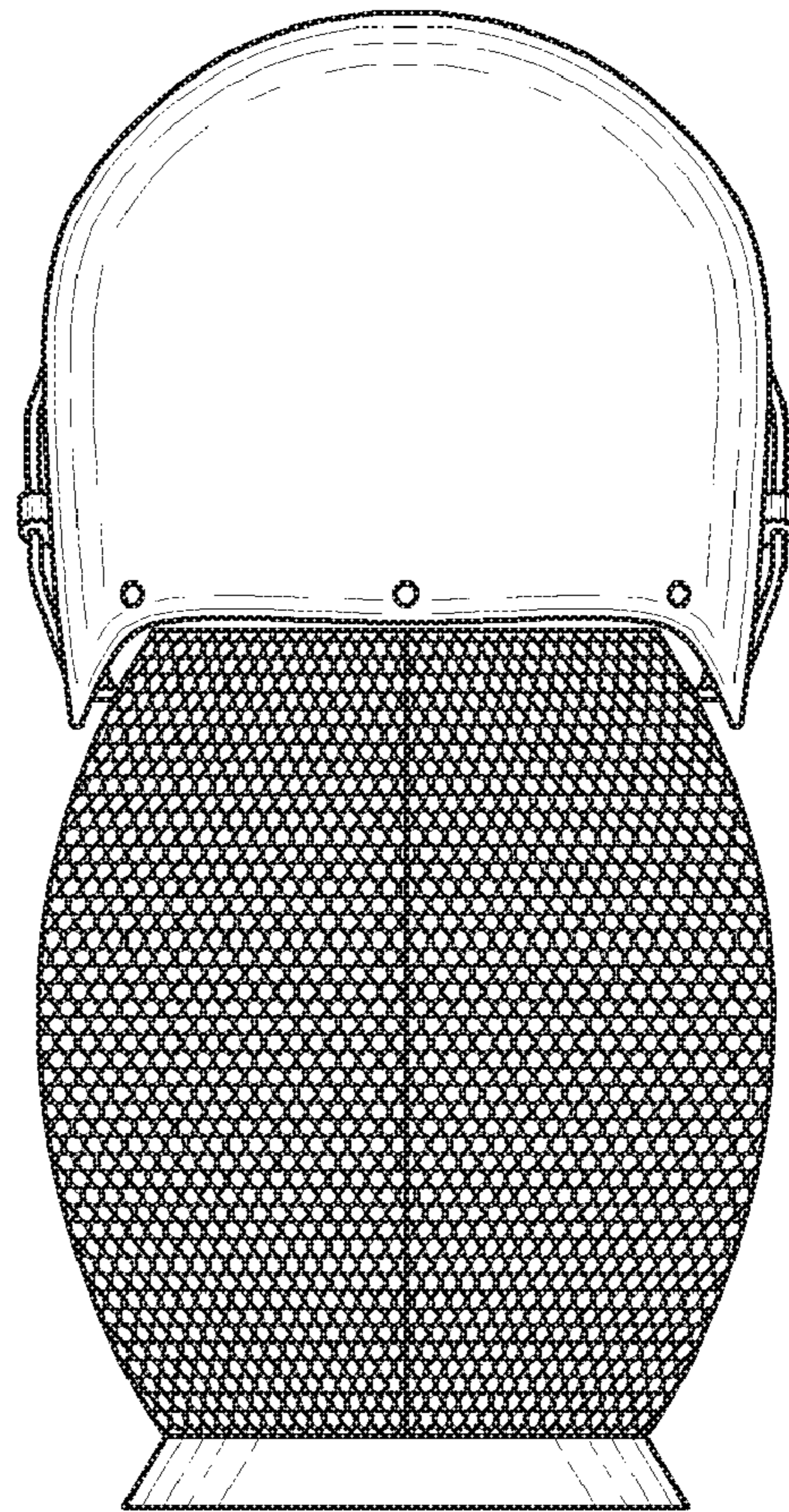

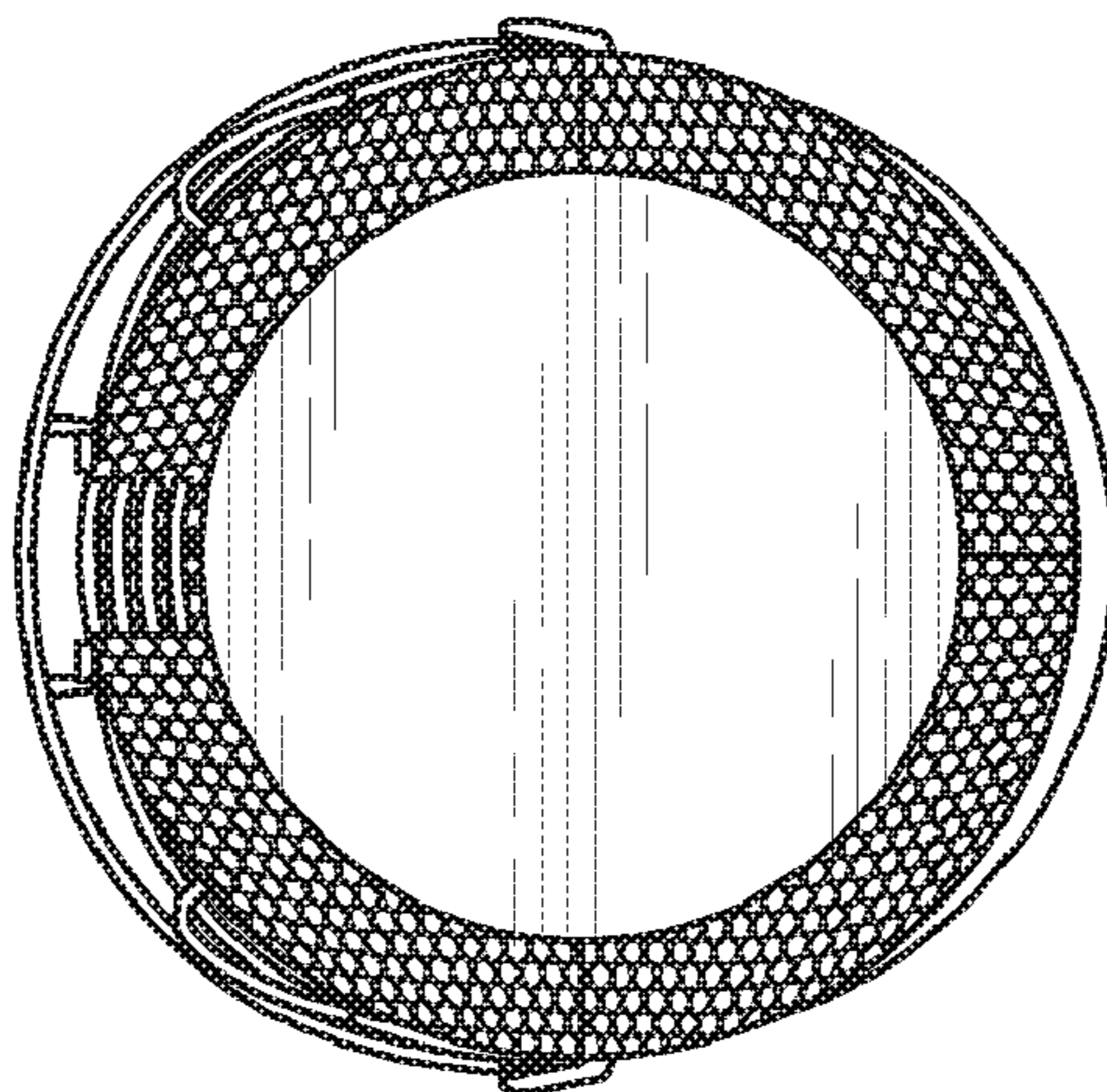
