The ornamental design for a periphery of an outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a periphery of an outsole in accordance with my new design.

FIG. 2 is a left side view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a rear elevation view thereof; and,

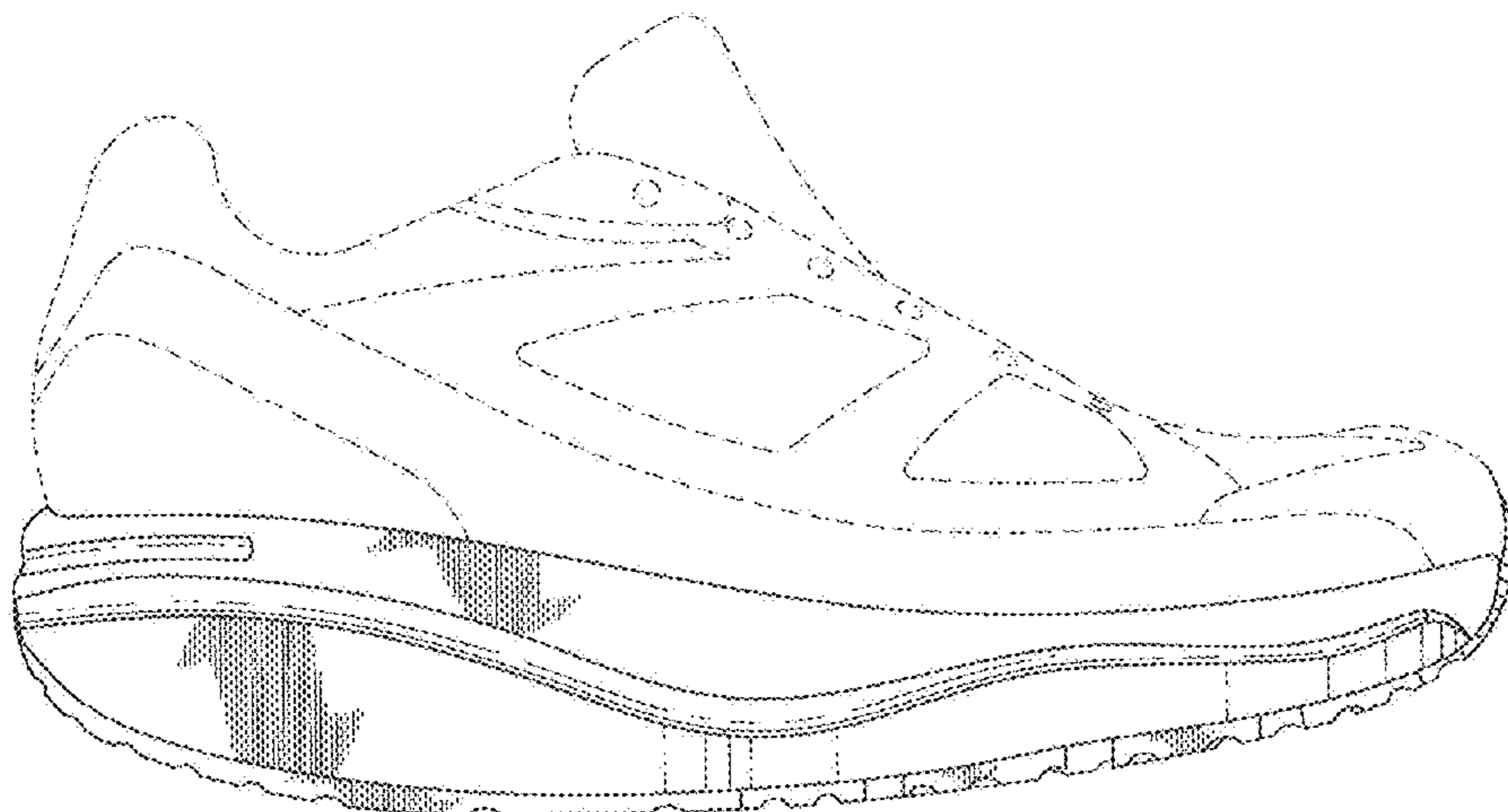

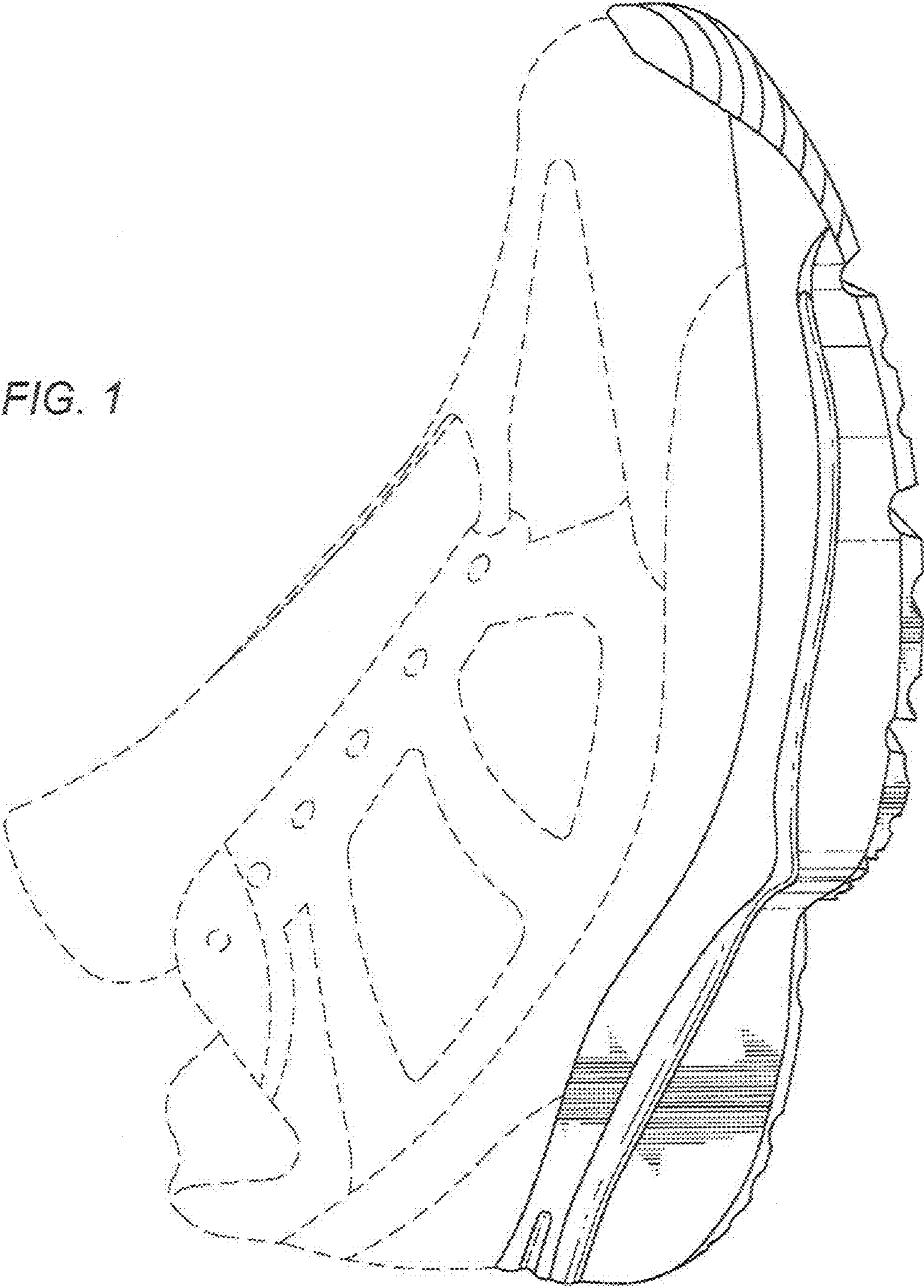

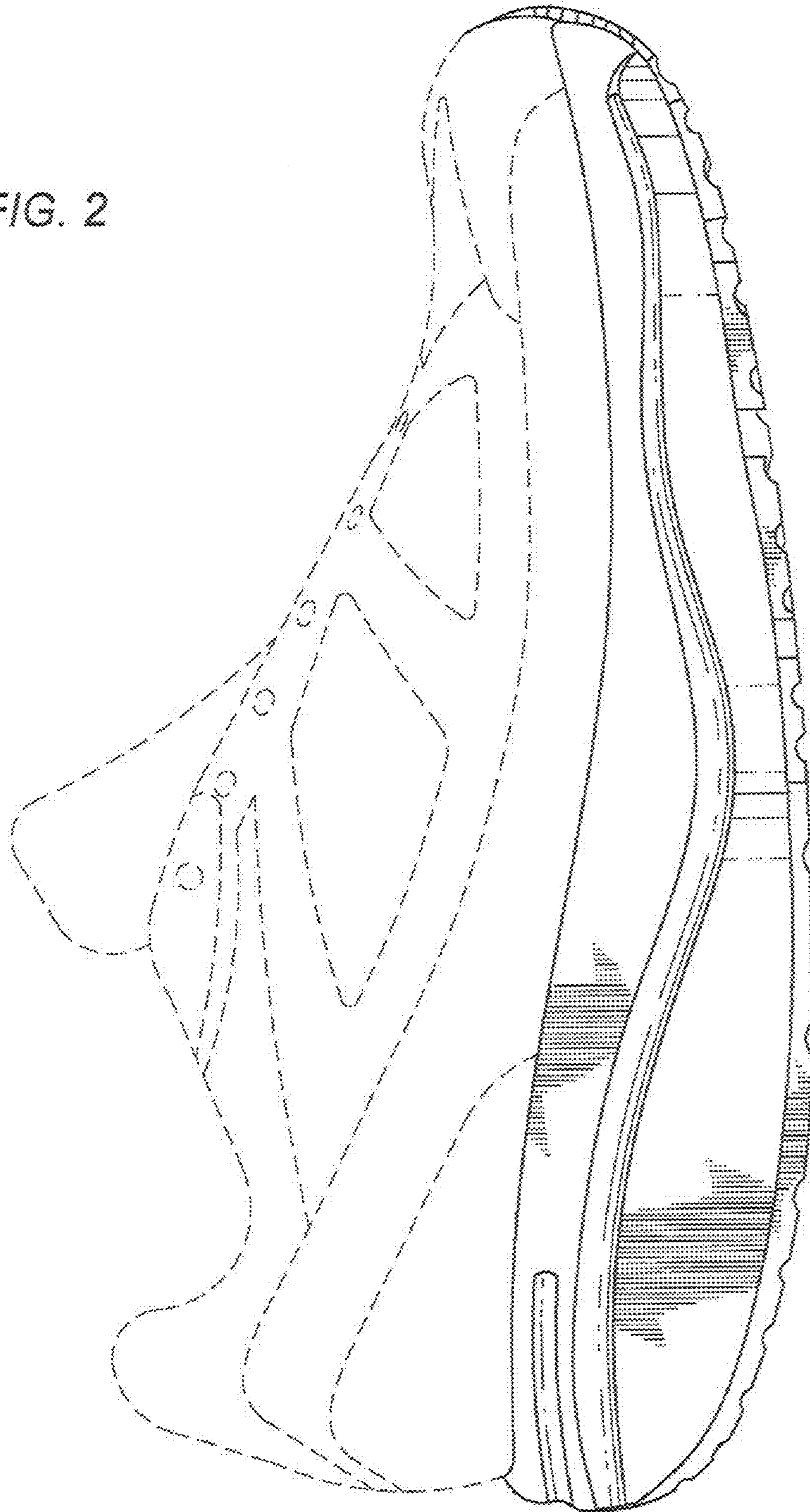

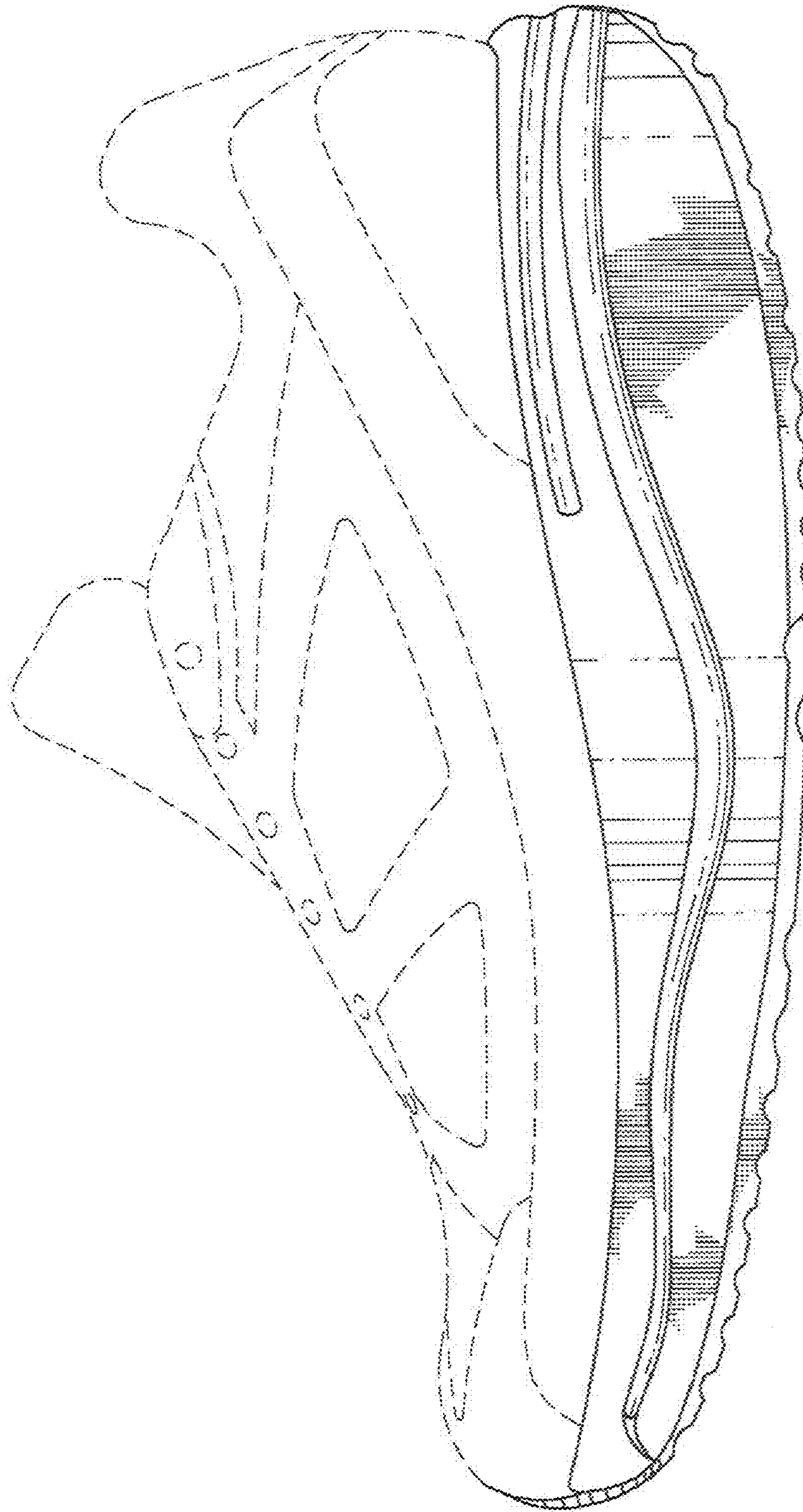

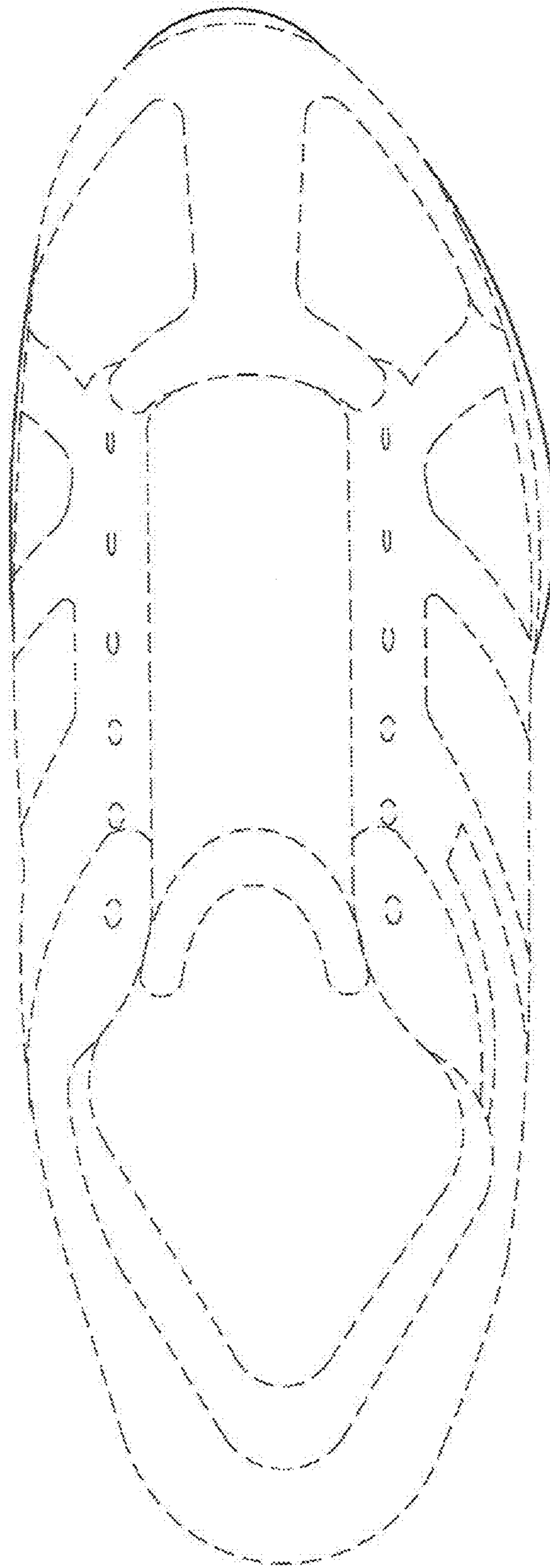

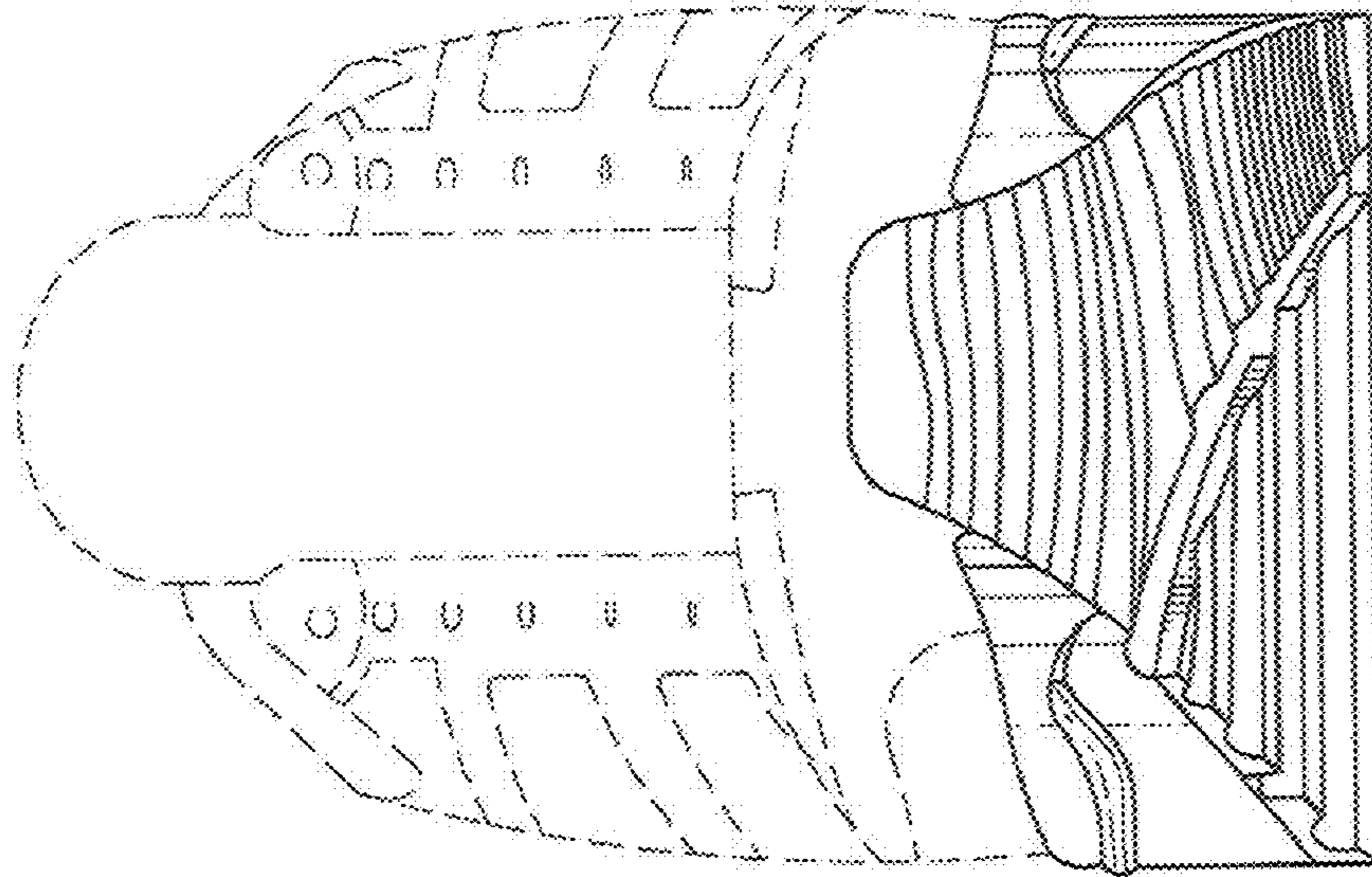
