DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of seating with a cushion thereon, according to the principles of the present invention;

FIG. 2 is a rear elevational view thereof without a cushion;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a right side elevational view thereof, a left side elevational view not being shown as it is a mirror image of the right side elevational view;

FIG. 7 is a perspective view of a second embodiment of seating having a cushion thereon;

FIG. 8 is a rear elevational view thereof without a cushion;

FIG. 19 is a perspective view of a fourth embodiment of seating with cushions thereon;

FIG. 20 is a rear elevational view thereof without cushions;

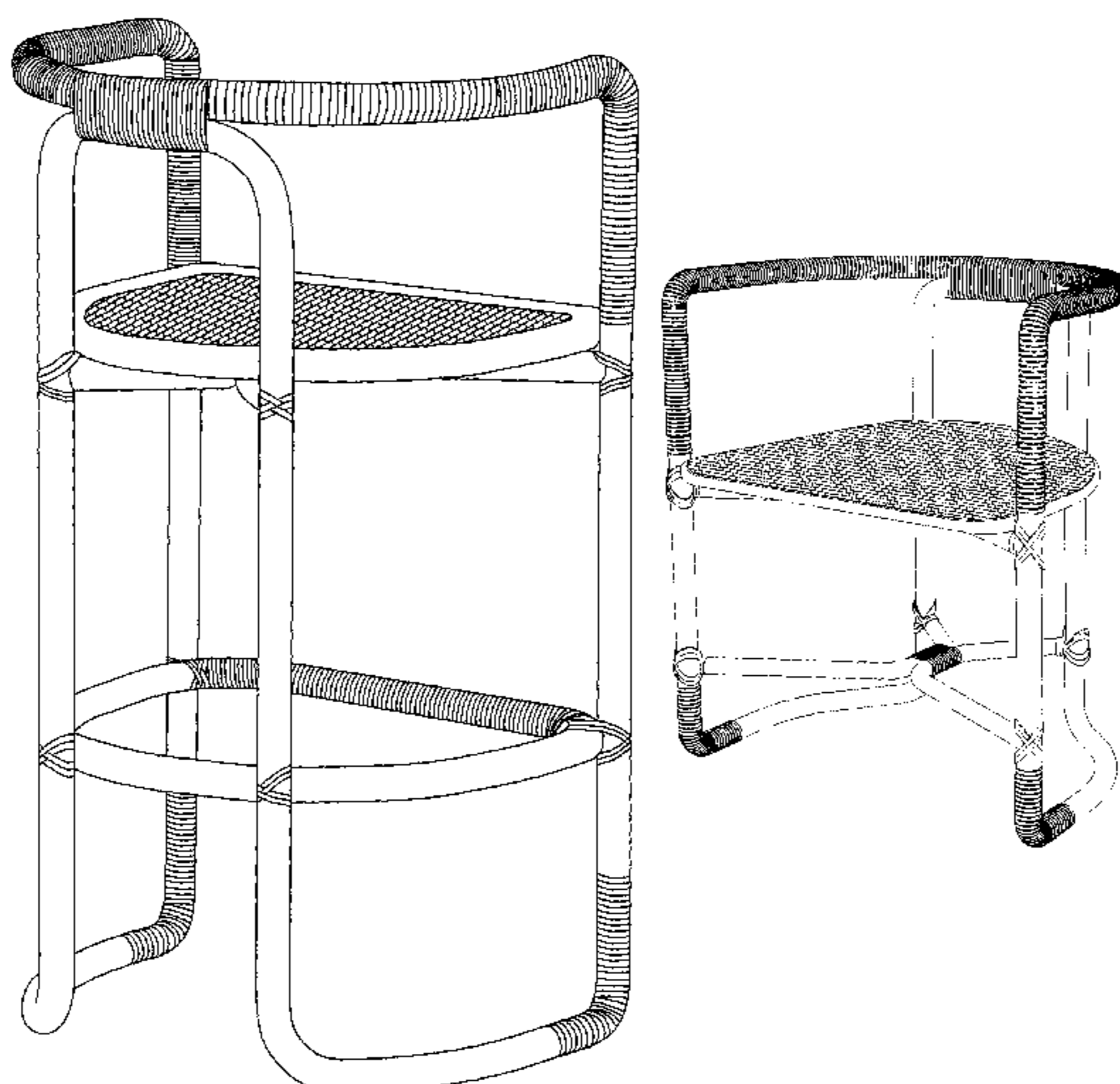
FIG. 21 is a front elevational view thereof;

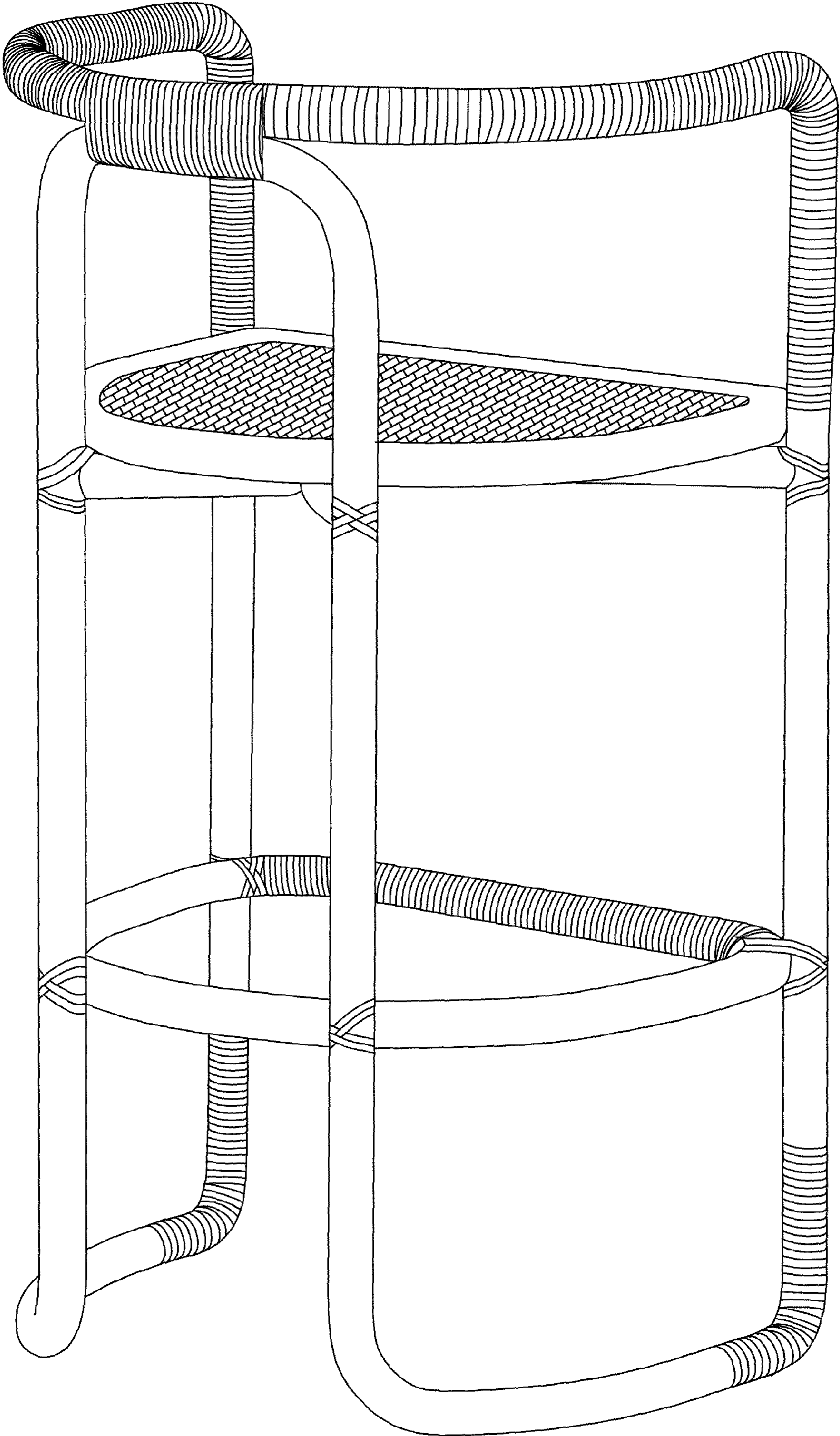

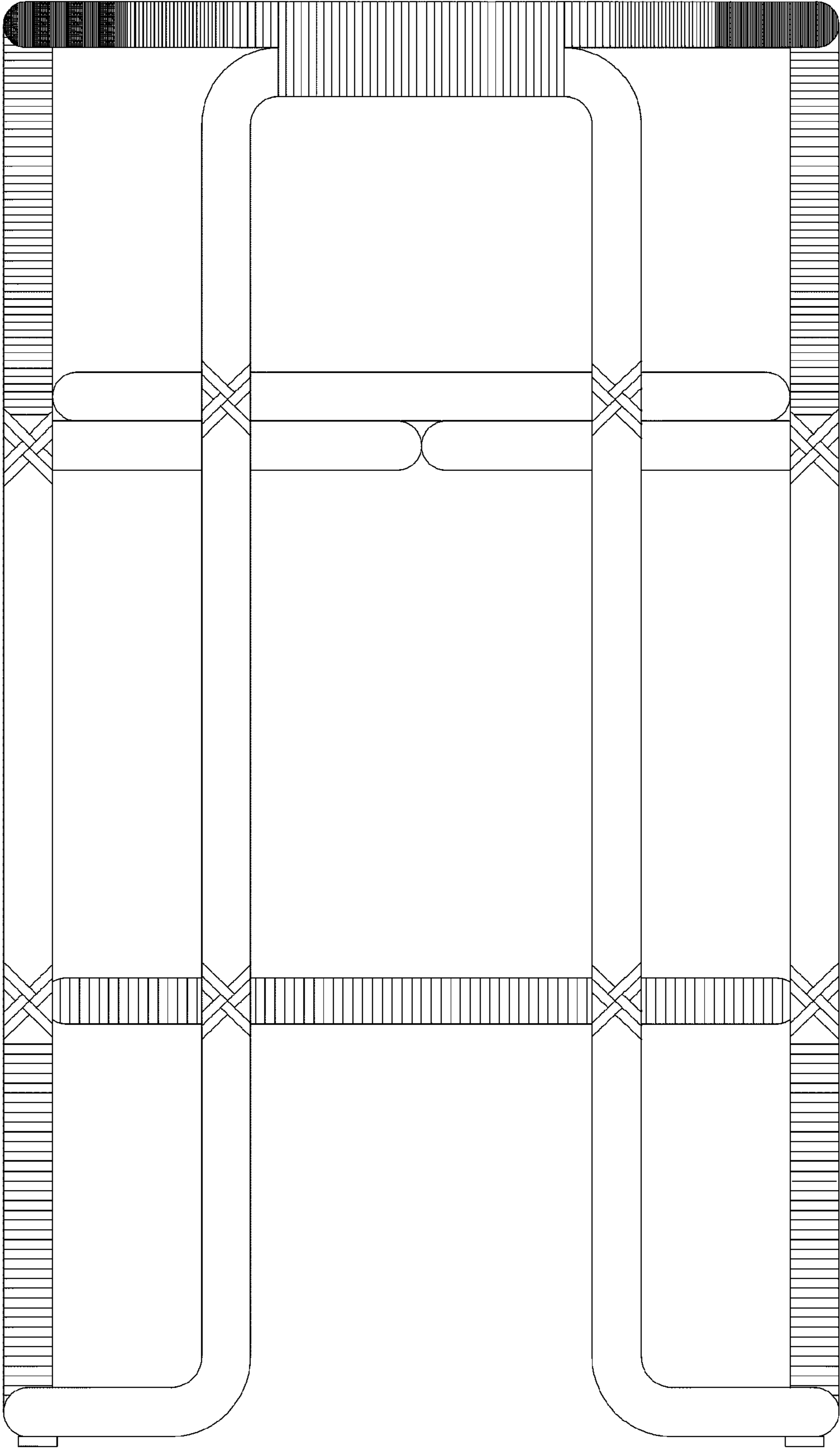

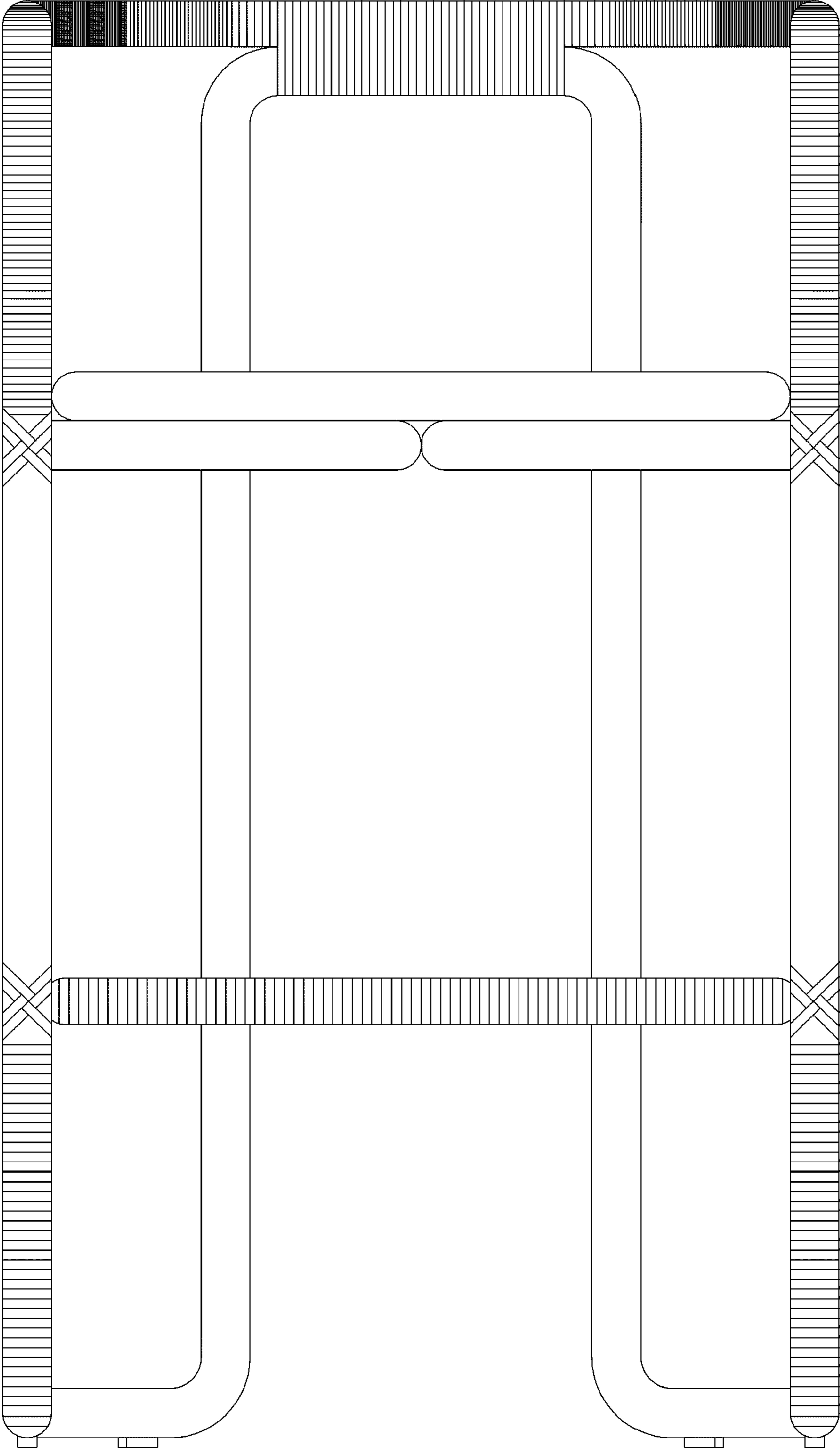

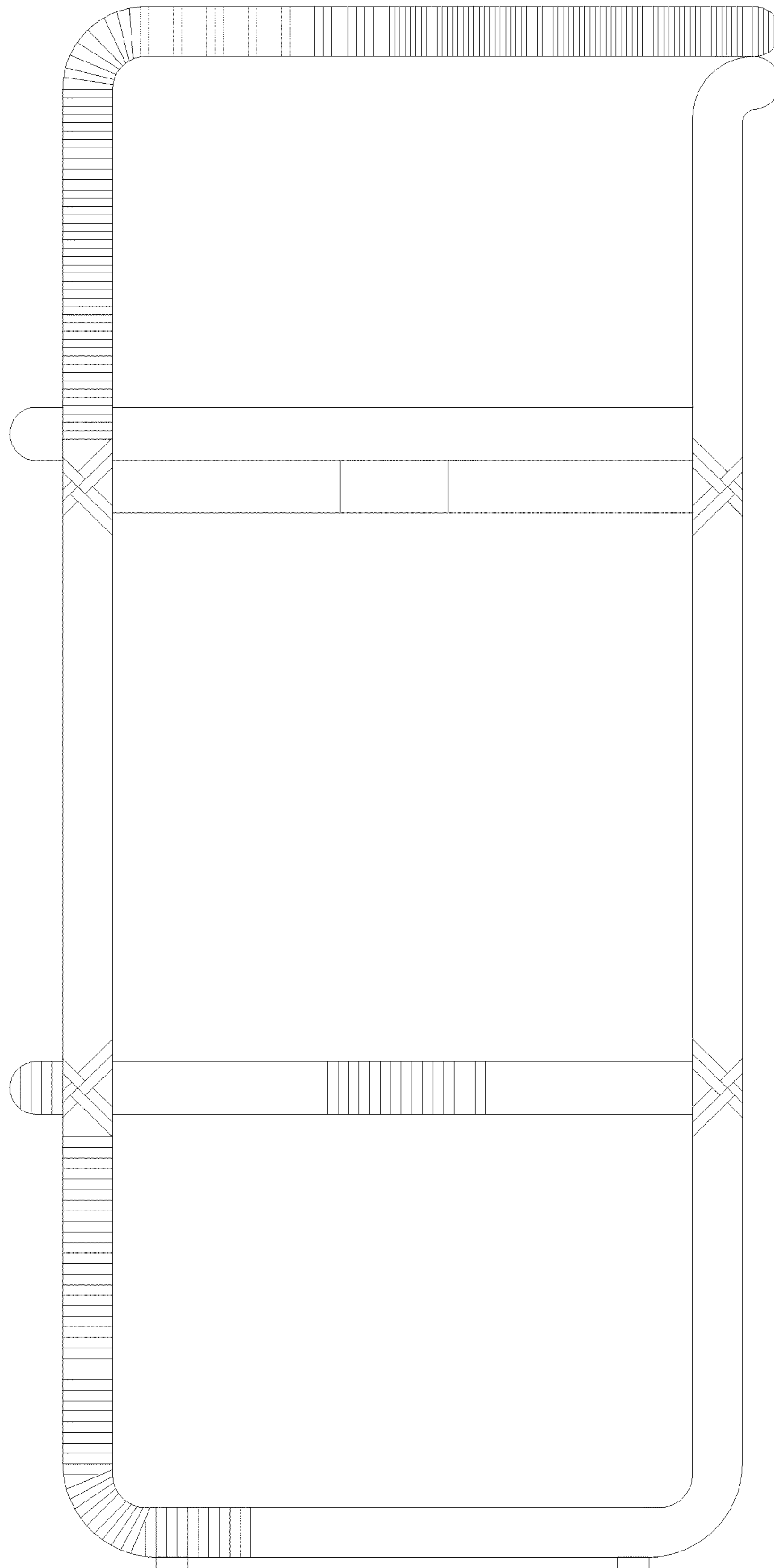

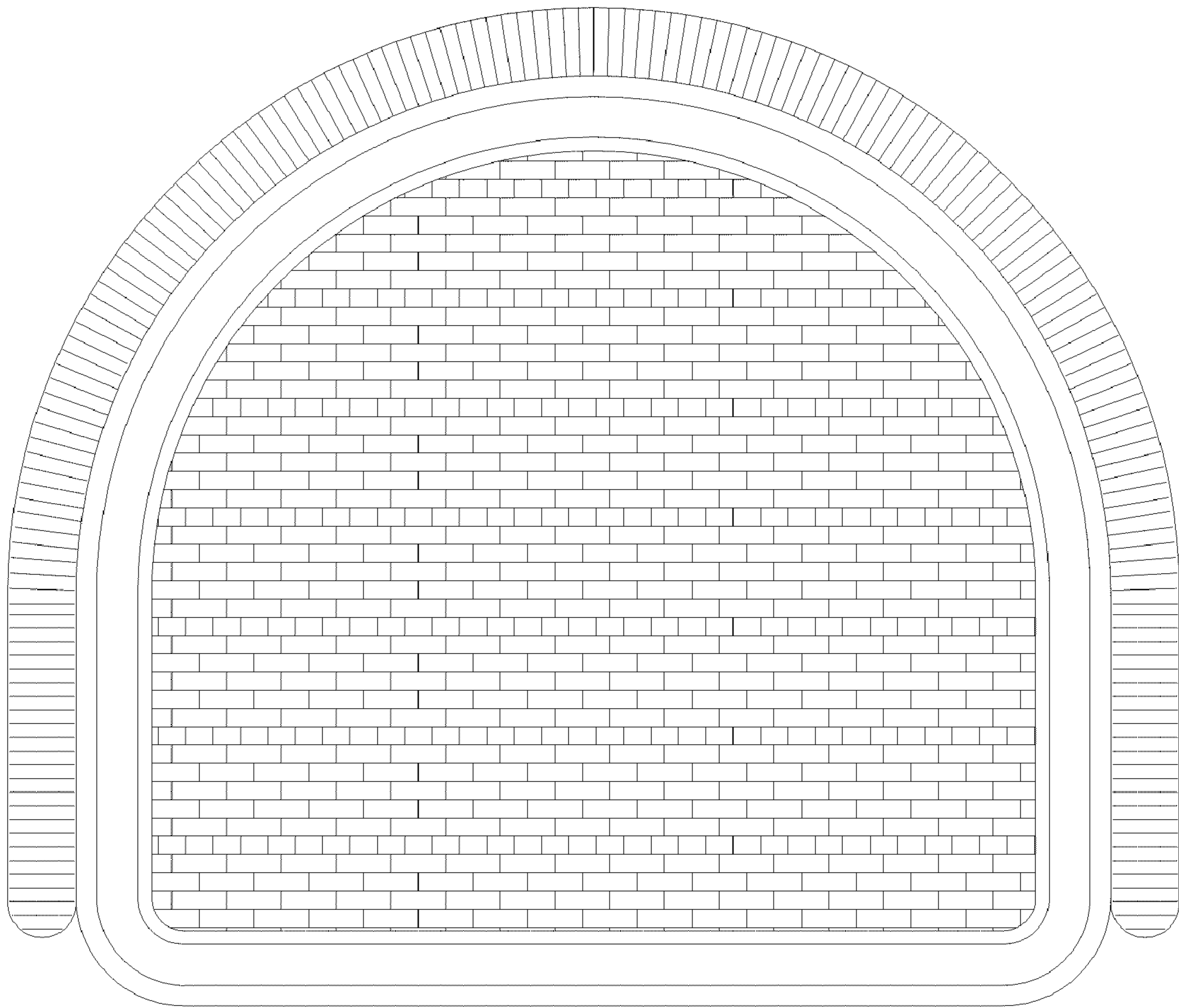

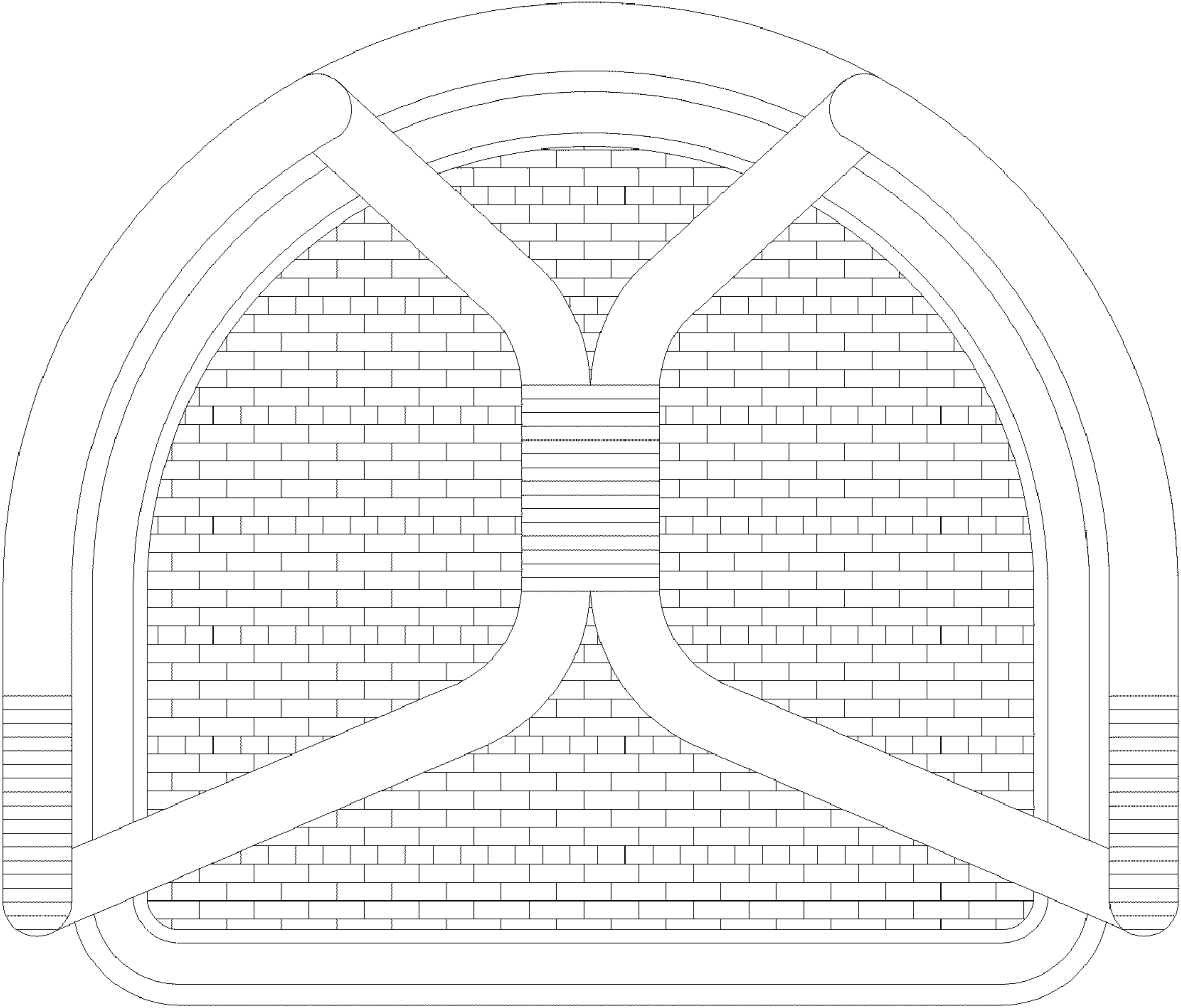

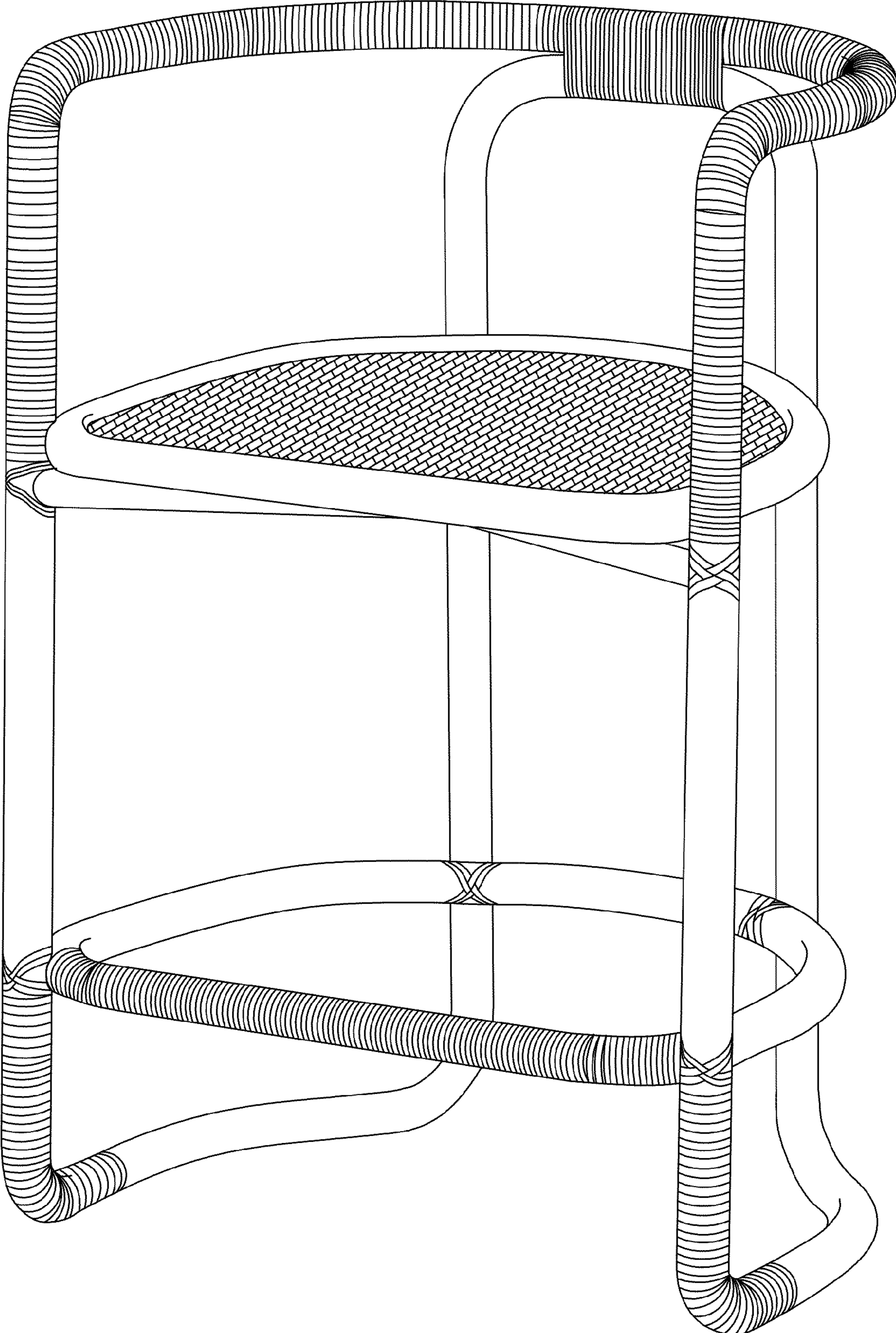

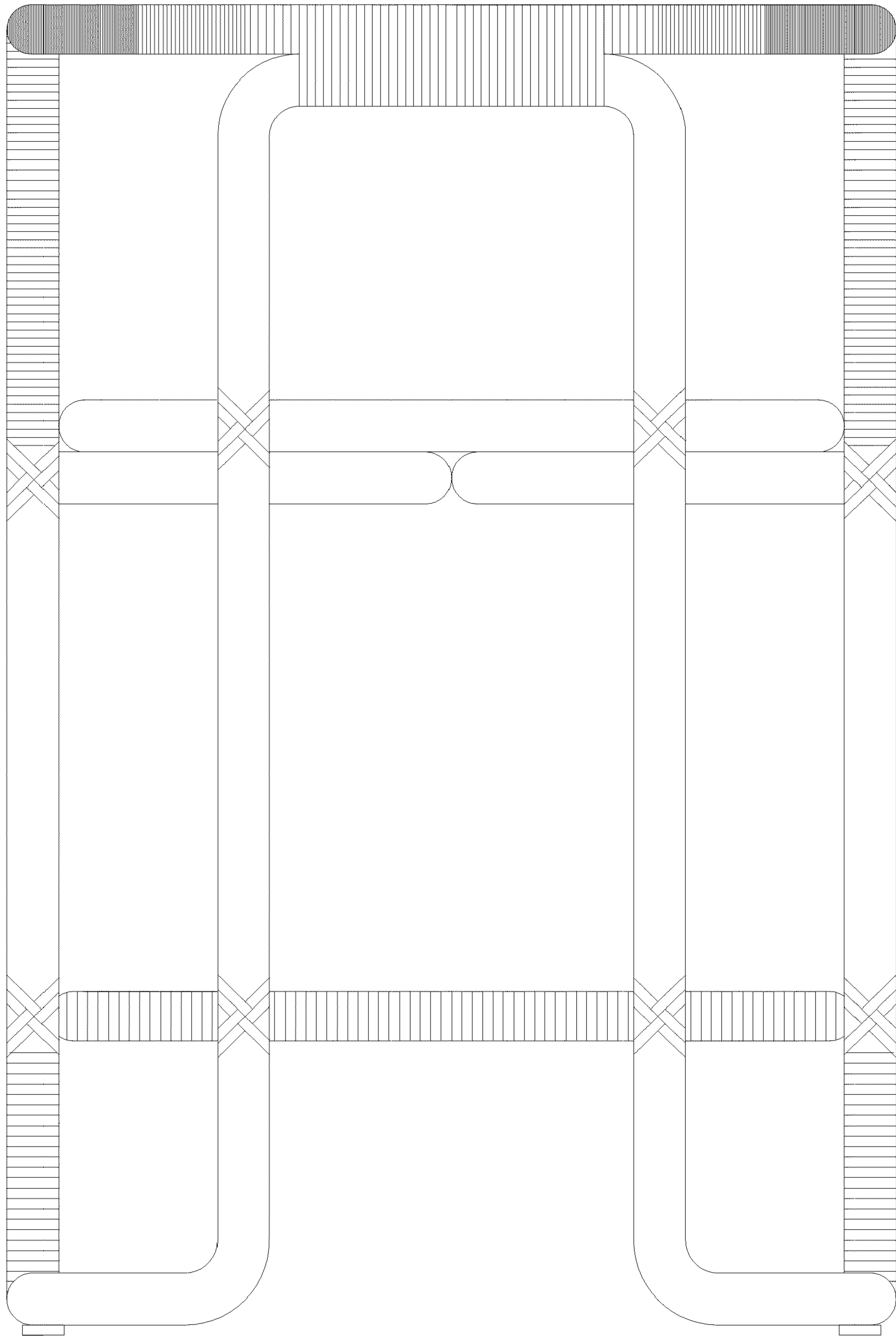

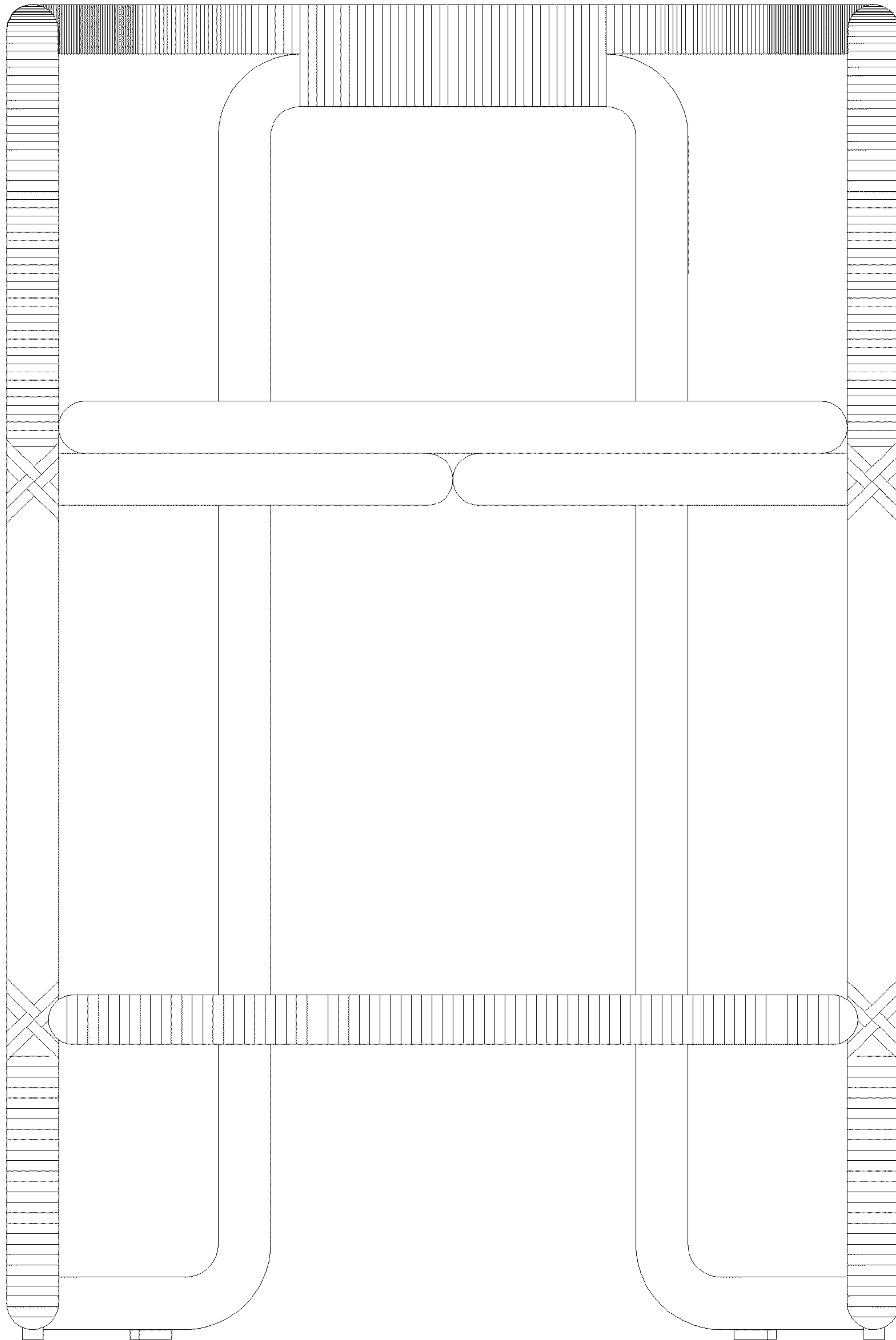

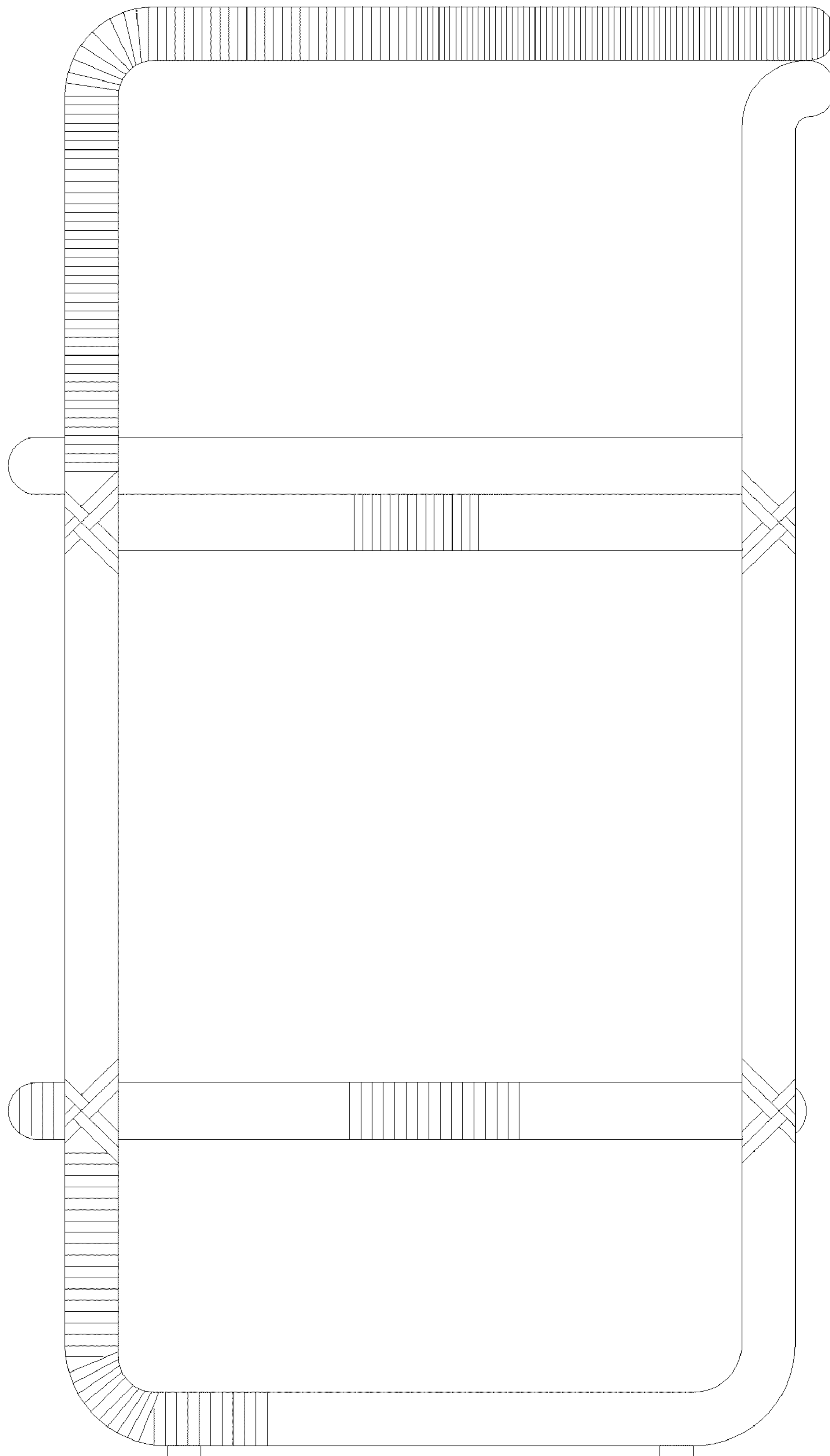

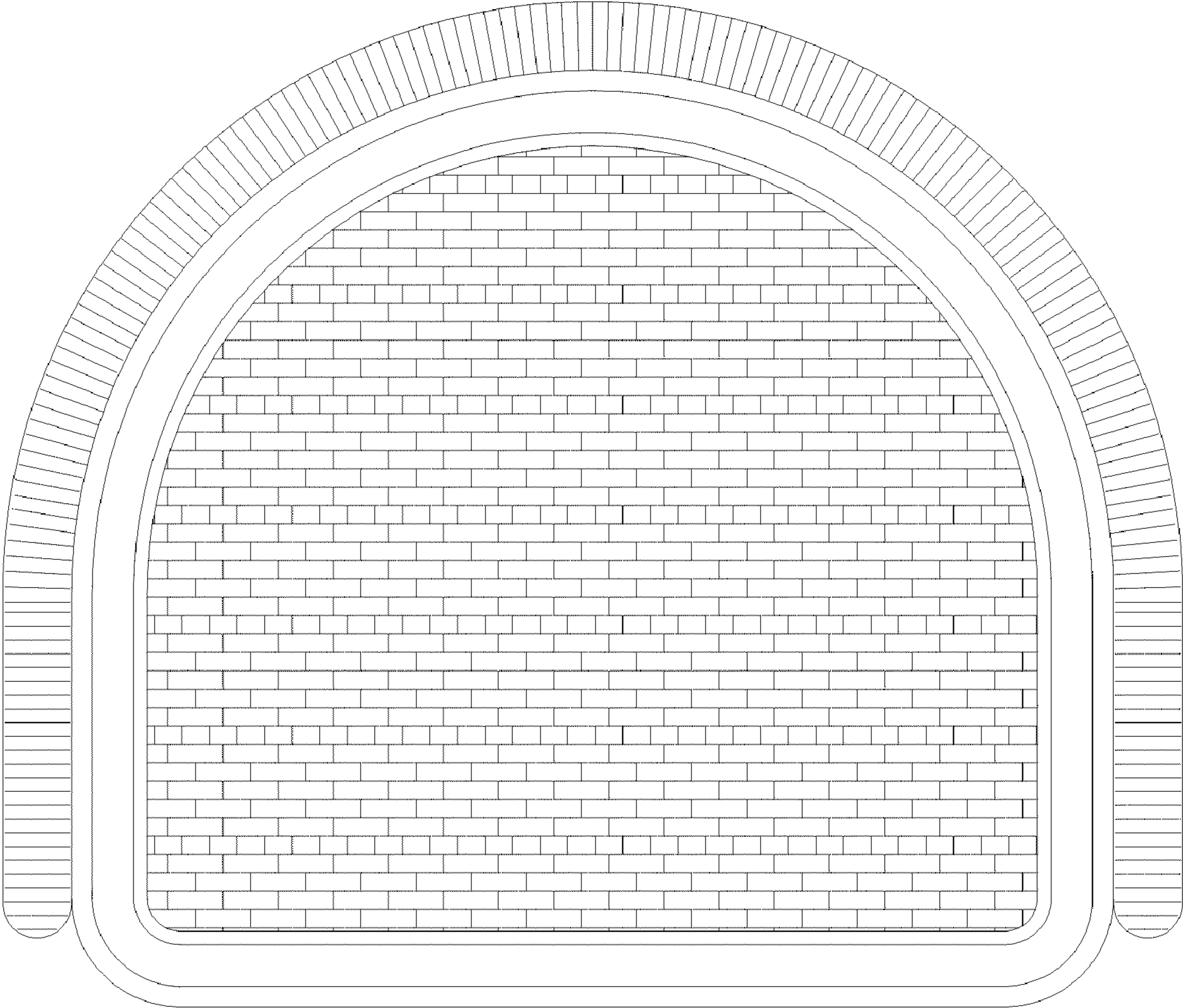

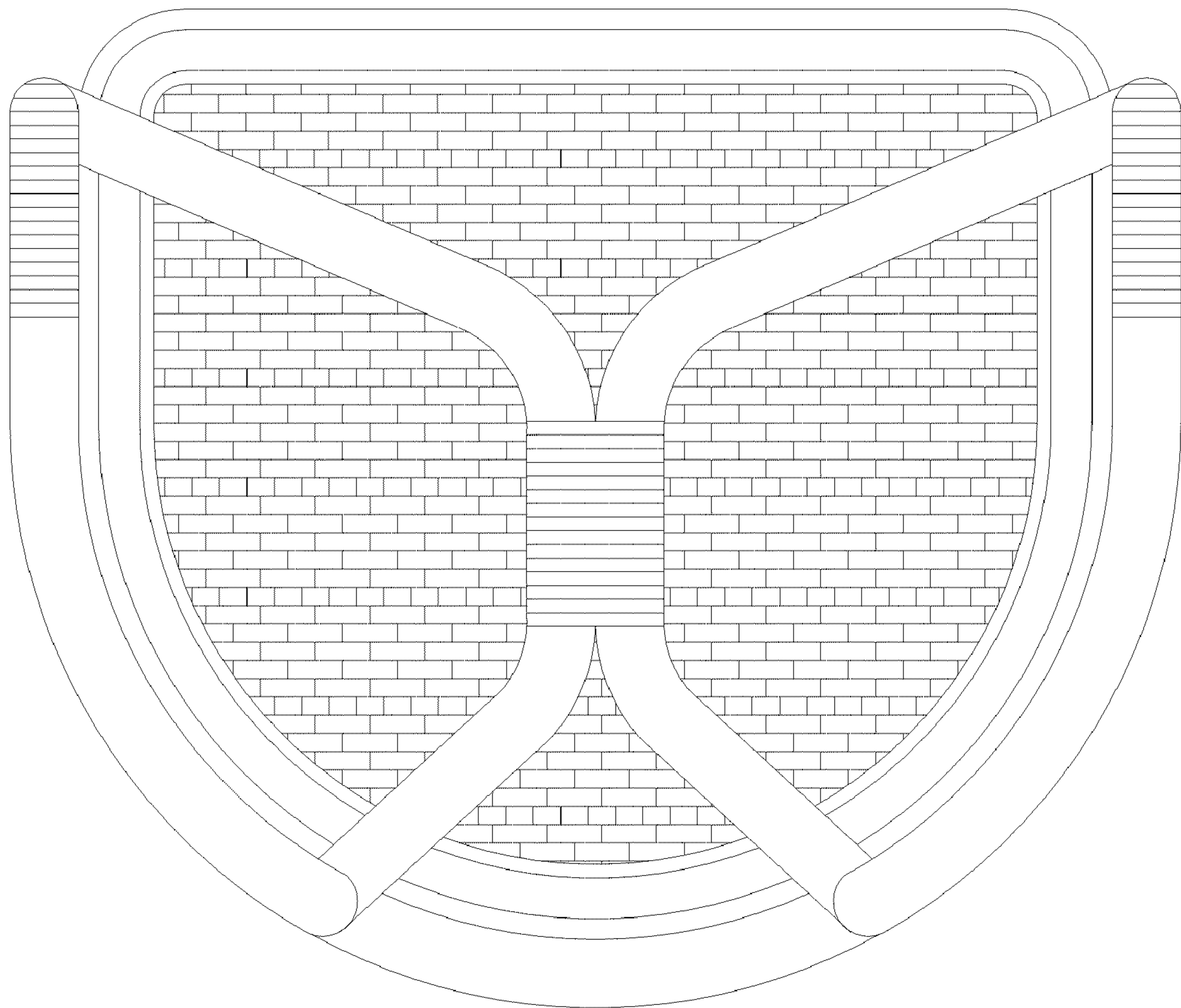

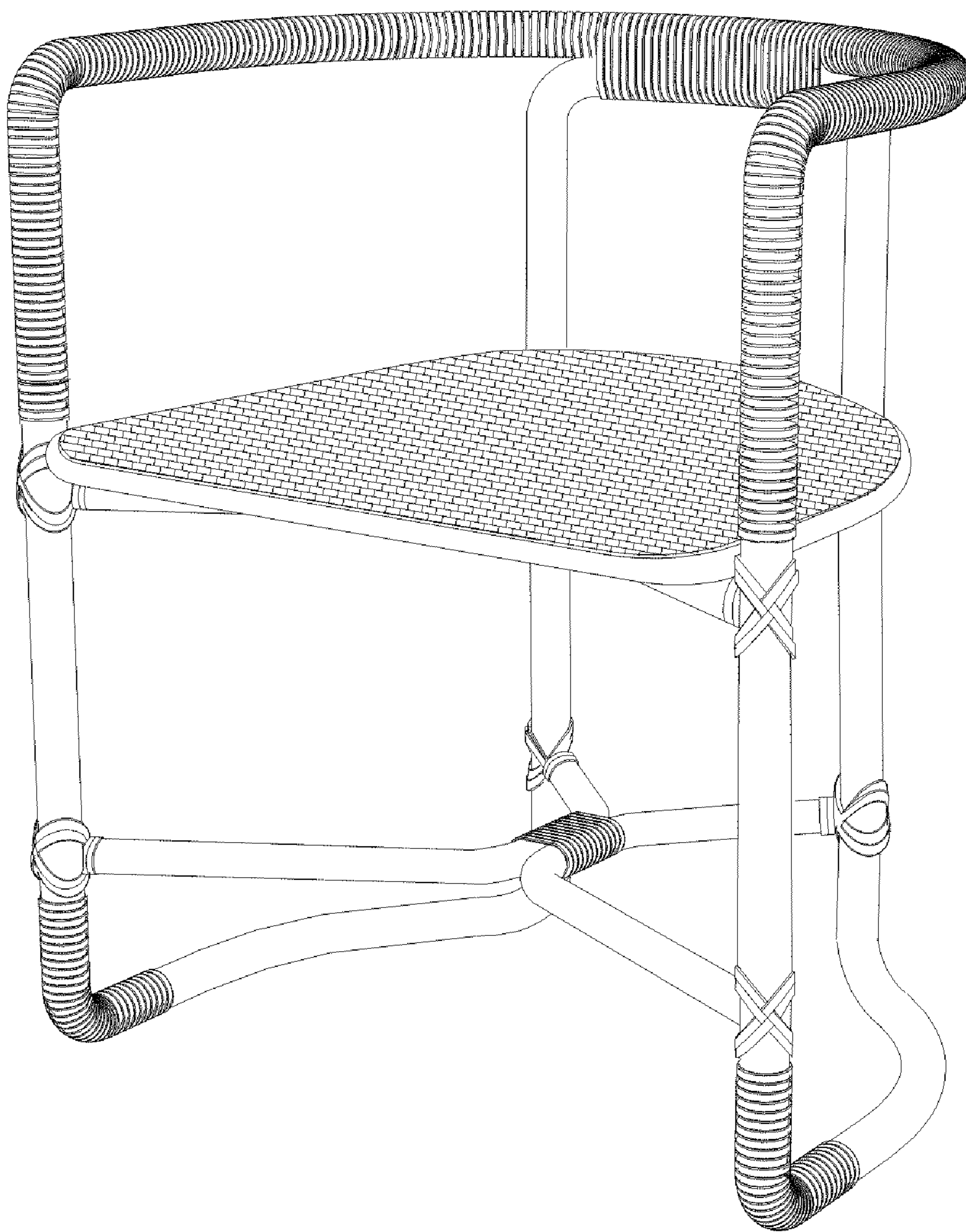

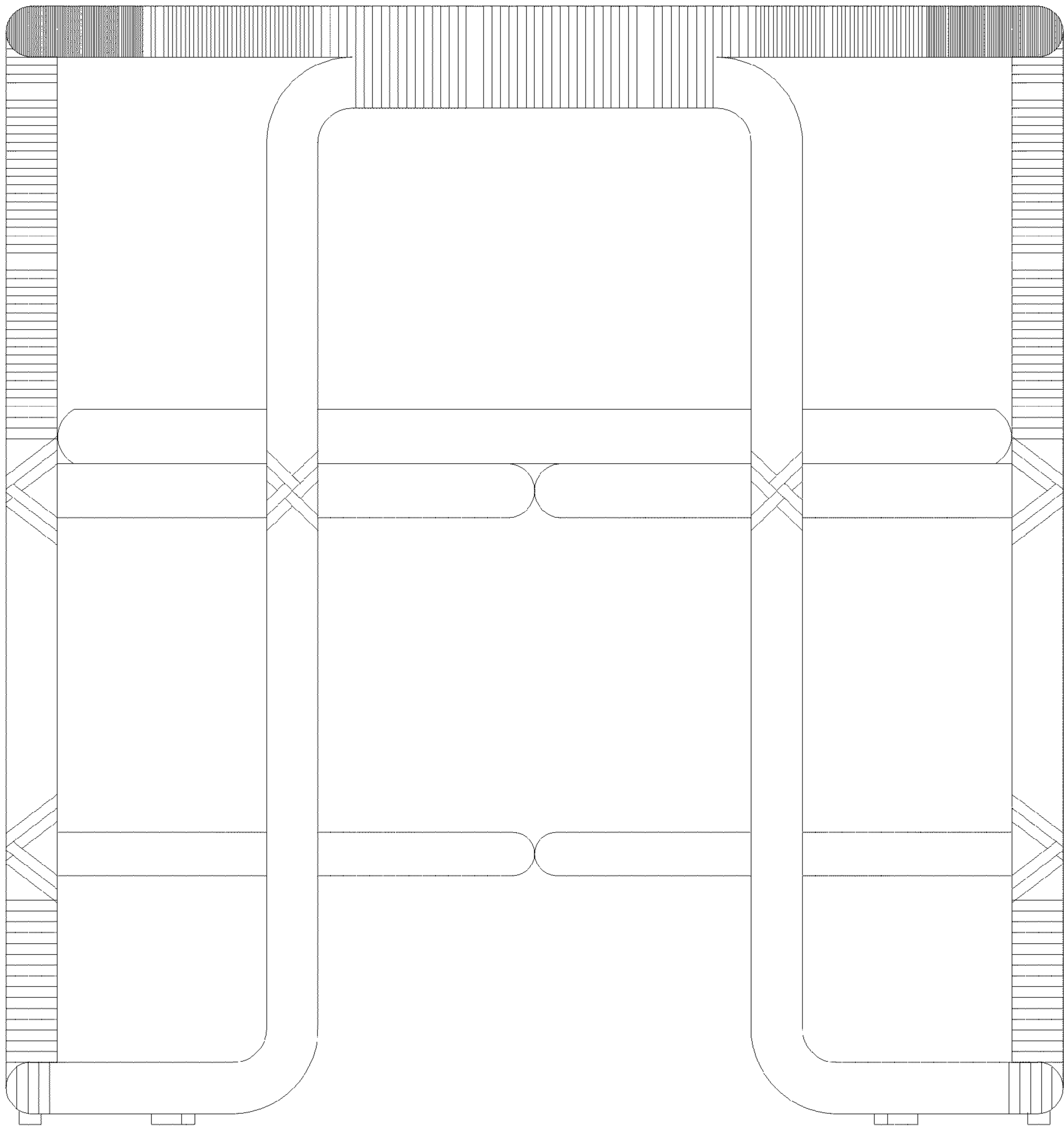

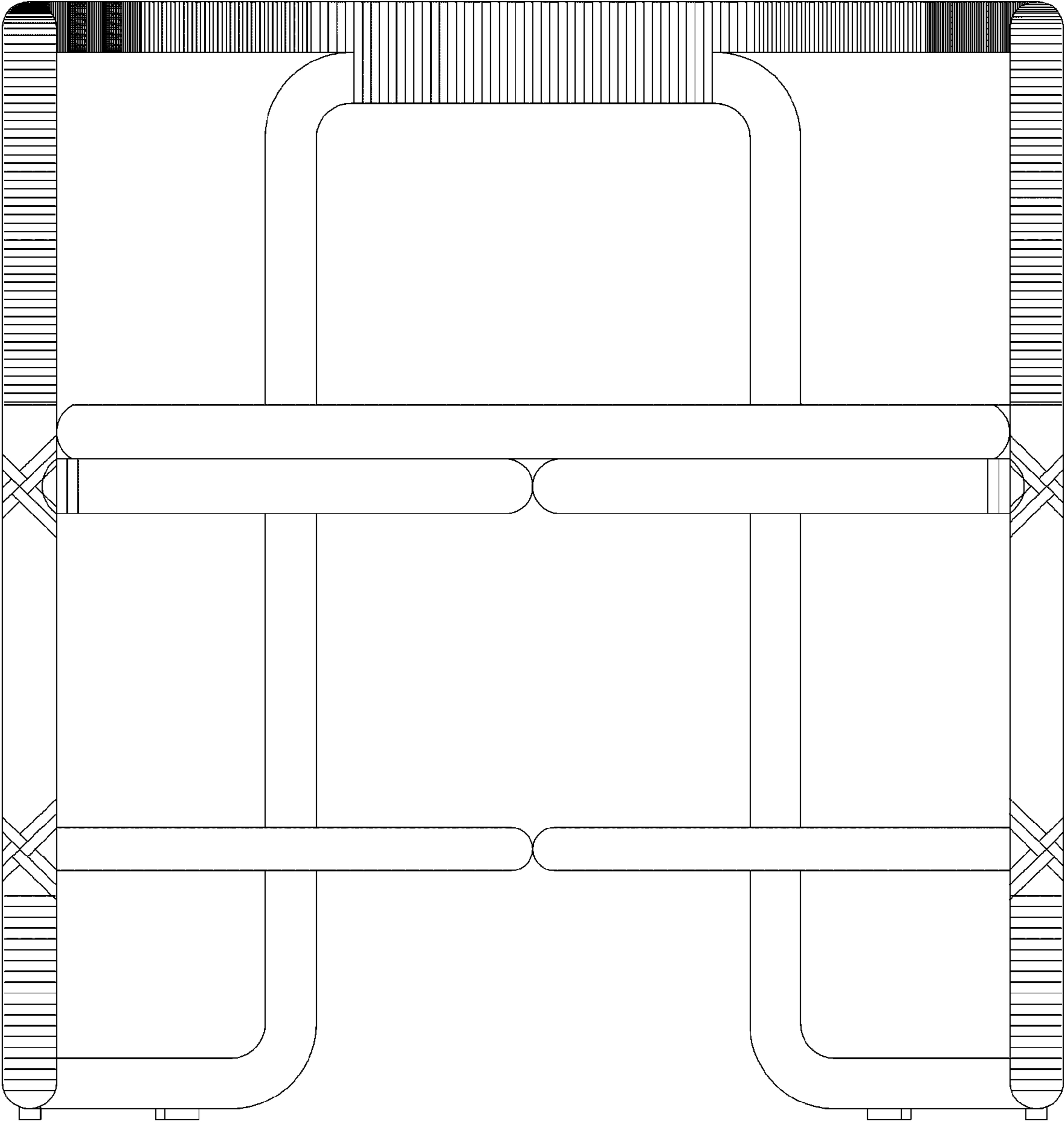

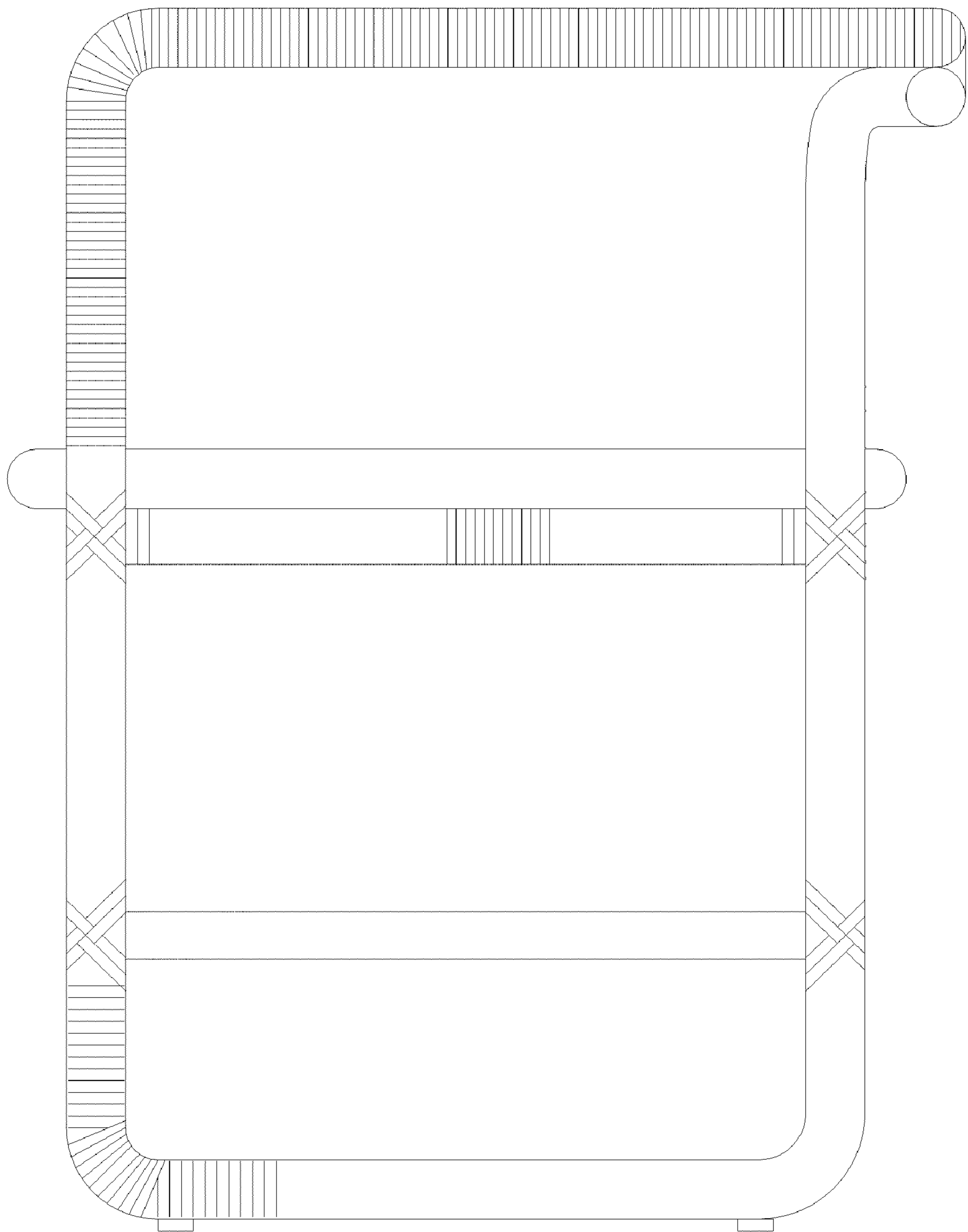

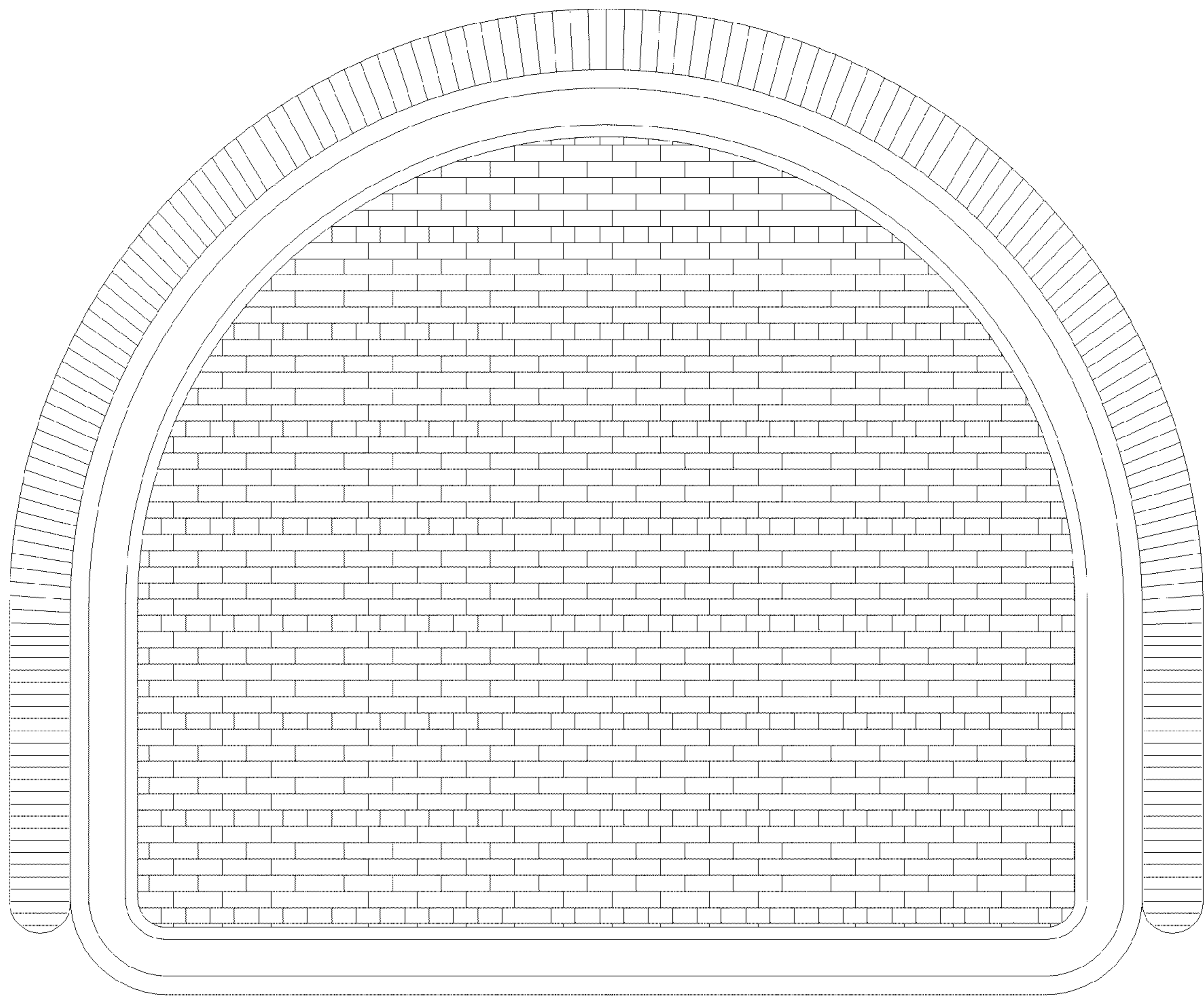

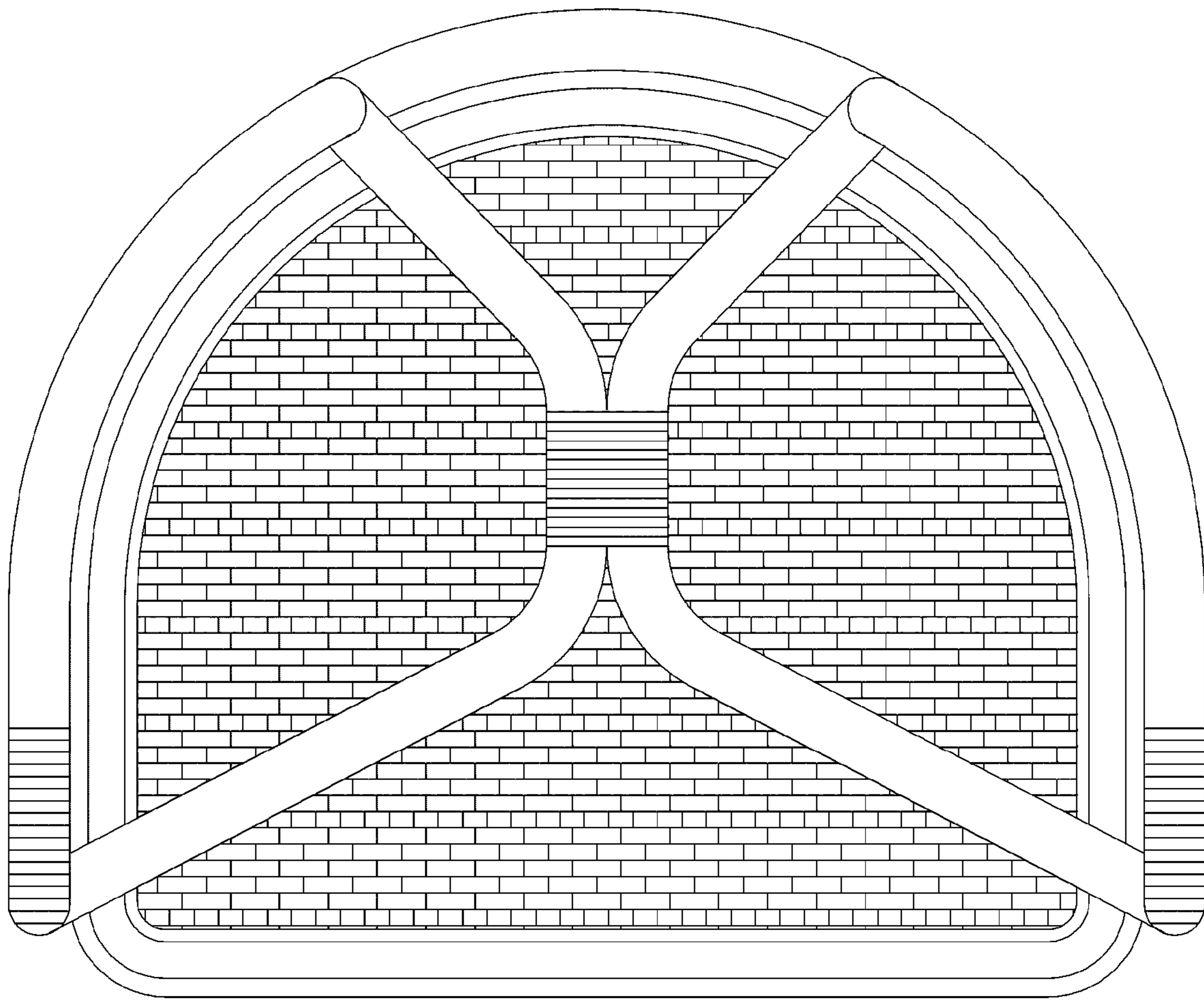

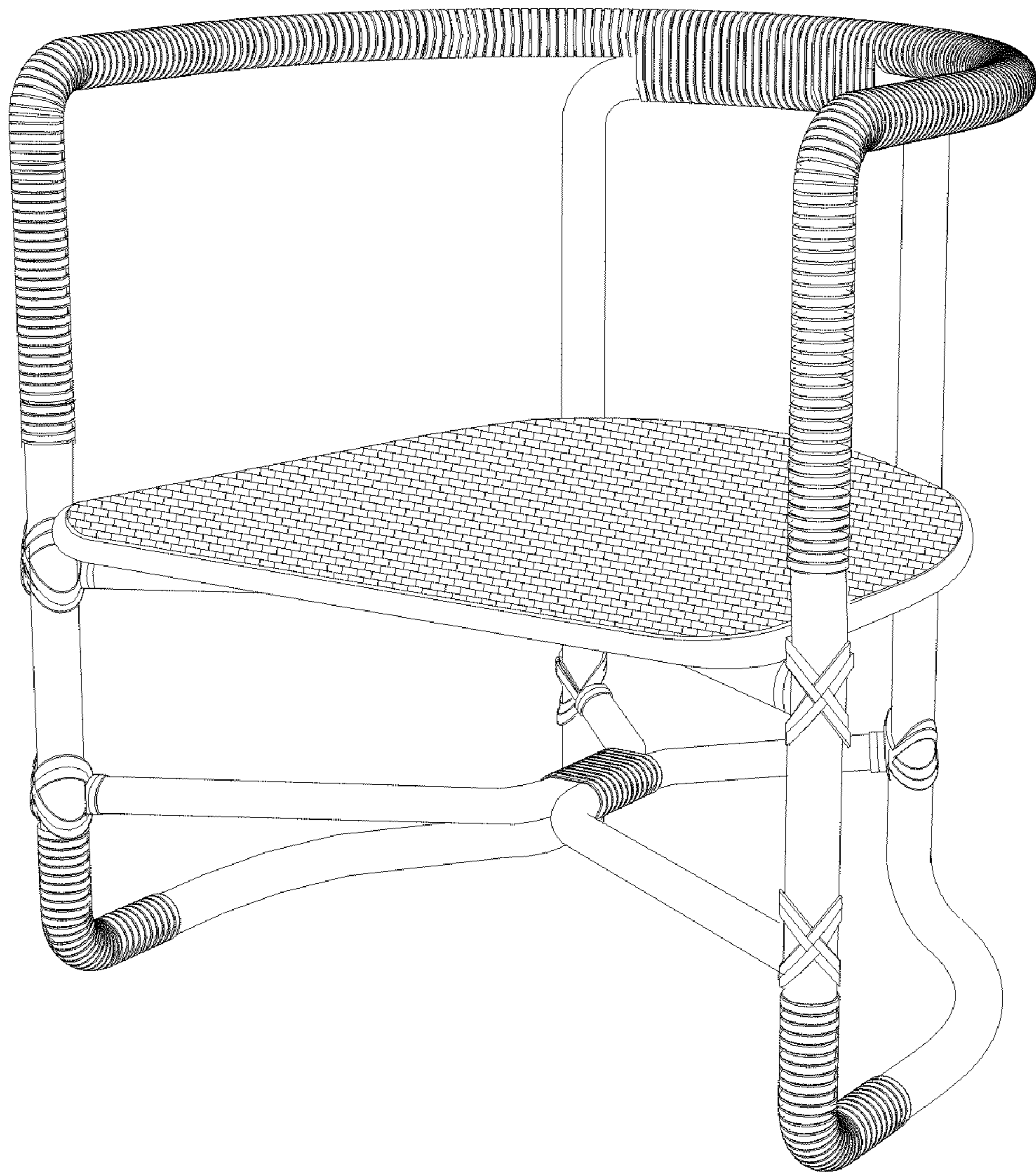

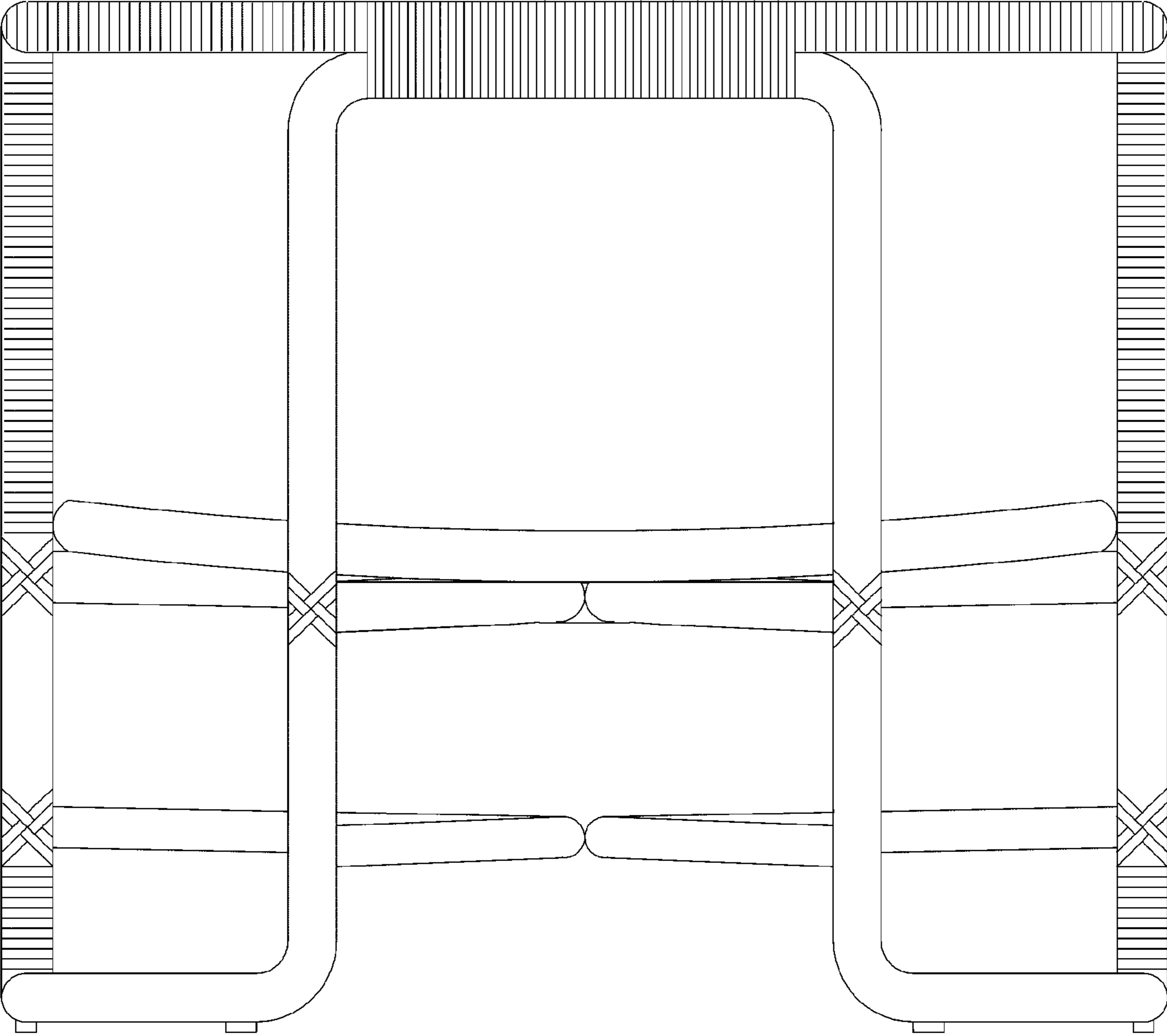

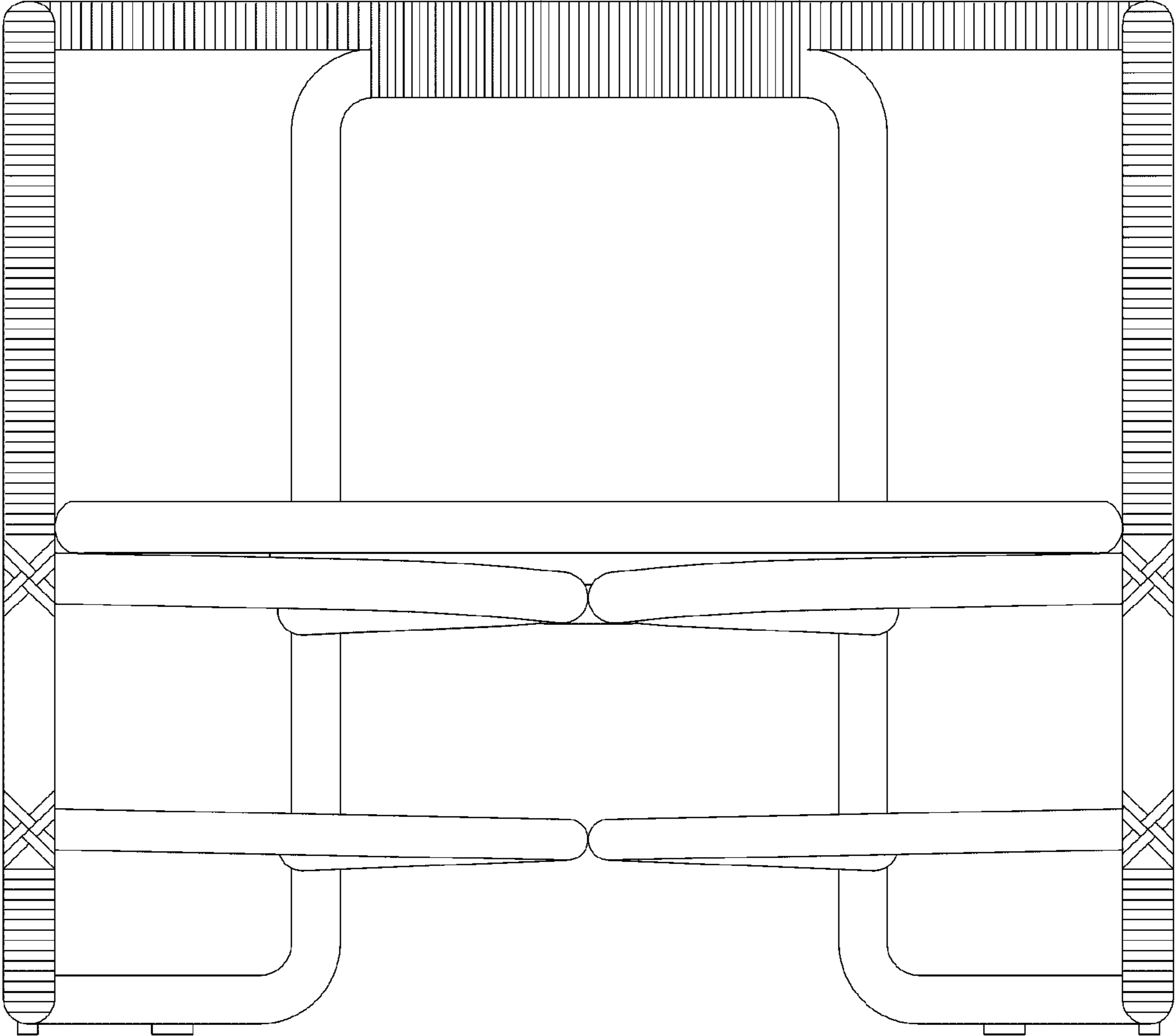

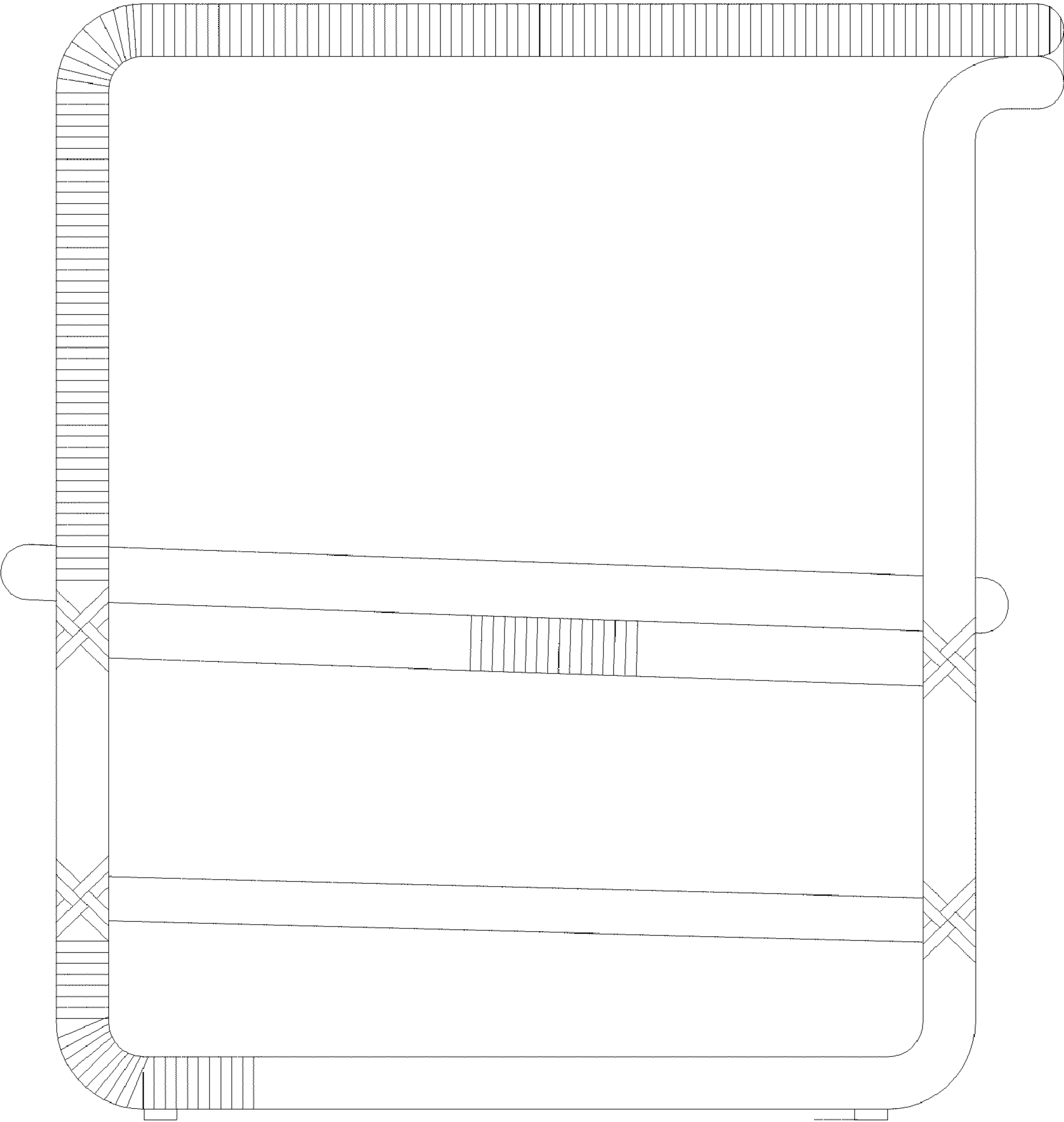

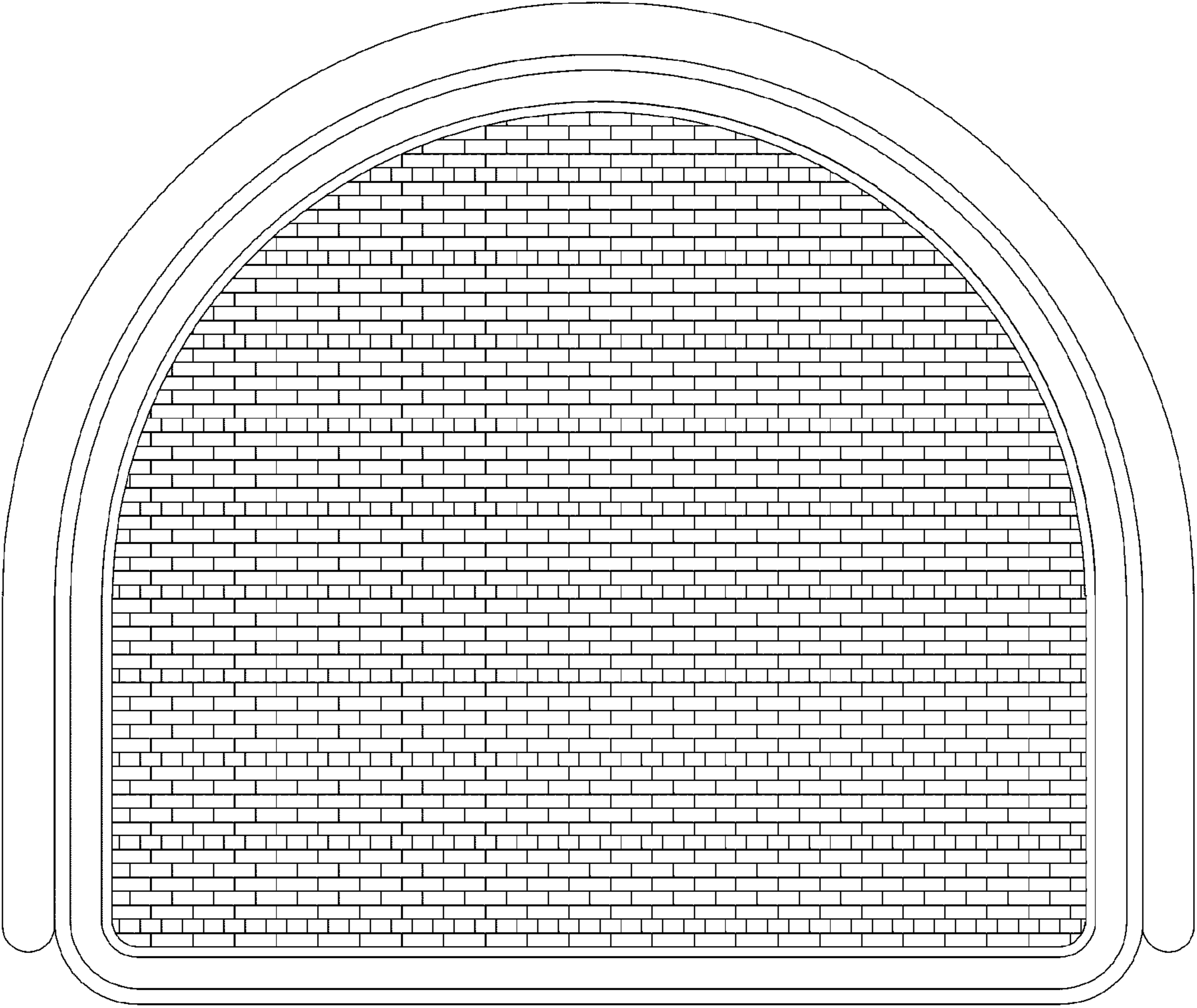
